ABOUT THIS REPORT

This is the first year for Luxey International (Holdings) Limited and its subsidiaries (referred to as the "Group") to prepare the Environmental, Social, and Governance Report ("ESG Report") to highlight its environmental, social and governance performance. This ESG report is published under the recommendations of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") for the performance reporting on relevant aspects (the "ESG Guidelines").

SCOPE, MATERIALITY, AND REPORTING PERIOD OF THIS REPORT

During the reporting period for the year ended 30 June 2017 (the "Reporting Period"), the Group is mainly engaged in the manufacturing and trading of high-end swimwear and garment products, the principal places of business of which are located in the People's Republic of China (the "PRC") and Kingdom of Cambodia ("Cambodia"), while the Hong Kong office is mainly responsible for the relevant compliance matters regarding to the Company's listing on the Growth Enterprise Market (the "GEM") of the Stock Exchange and as the office of garment factory for processing orders, customer service and general logistical matters. The Group has decided to include in this ESG Report the performance of the Group's subsidiaries at different levels in the PRC and Cambodia and Hong Kong office in the three areas of environmental, social and governance during the Reporting Period. All information below is derived from the official documents or internal statistical reports of the Company.

Environmental Protection

The Group sets up plants in the PRC and Cambodia to manufacture swimwear and garment products. There is a set of stringent production guidelines in our plants, including energy conservation, control and disposition of pollutants and exhaust gas. The production activities in our plants meet the Environmental Protection Law of PRC, Law on Environmental Protection and Natural Resources Management of Cambodia and other environmental protection related laws.

The major resources and energy consumed during our production process include water, electricity, coal, etc. The pollutants produced during the production process mainly include wastewater, exhaust gas, waste materials and waste papers.

Environmental protection is also a prerequisite in our business process. We inspect every business process, reduce direct or indirect emission. We improve proactively our operating efficiency and implement environmental measures, so as to reduce the negative impact on the environment during the operation process of our business. During the Reporting Period, our energy conservation and emissions reduction measures include electrical machinery improvement, recycling paper products such as waste carton boxes, adopting digital printing to reduce the utilisation of water, electricity, screen films and other resources.

The Group also provides in-house training or guidelines for every employee when joining the Group, so as to enhance their environmental consciousness. We encourage and require employees to economise and protect environment and reduce resources consumption. Meanwhile, the Group reviews the implementation of the abovementioned measures from time to time, carries out improving measures when needed, strives to enhance resource's utilisation rate to achieve energy conservation and emission reduction, pollutant reduction and environment protection.

環保

本集團分別於中國及柬埔寨設有廠房生產泳衣 及服裝。我們的廠房均有一套嚴格的生產指引, 當中包括節約能源、控制及處理污染物及廢氣 等。廠房生產活動均符合中國《環境保護法》、 柬埔寨《環境保護及自然資源管理法》等相關 環保法例。

本集團生產過程中主要耗用的資源及能源包括水、電、煤等。生產過程中產生的污染物主要為廢水、廢氣、廢料、廢紙等。

本集團在業務過程中亦以環保為前提,檢視每一個業務流程,減少直接或間接排放。我們積極透過提升營運效率及實施環保措施,以減少業務運作過程中對環境的負面影響。報告期間,我們的節能減排措施包括電機改善;回收及循環利用廢紙盒等紙製品;利用數碼印花,減少對水、電、網板菲林和其他資源的使用。

本集團亦於每位員工入職時,均提供相關內部培訓或指引,提升員工的環保意識,鼓勵及要求員工節約環保、減少資源消耗。同時,本集團不定期檢視上述措施的實行情況,並於需要時實行改善措施,致力提高能源資源利用效率,達到節能減排、減少污染、保護環境。

The Group confirmed that during the year ended 30 June 2017, our business operation had not encountered any punishment by respective governmental authorities due to violation of the above laws and regulations.

Employees Profile

Employee is one of the key stakeholders affecting the sustainability of our business, their contribution and support are valuable at all times. As such, the Group formulated and implemented a set of comprehensive human resource management system, which is prepared in accordance with Hong Kong Employment Ordinance, the PRC Labour Law, the PRC Labour Contract Law, the Labour Law of Cambodia and other prevailing laws and regulations, and according to the industrial benchmarks.

The Group provides all employees relevant work guideline documents according to the human resources management system, which clearly conveyed messages to employees at all levels regarding the employment policy, work ethics, and occupational safety and health guidelines of the Company in which our business is operating. We also ensure employees know clearly their rights and welfare while working for the Group in compliance with relevant laws and regulations according to the system and thus protect the rights of both parties.

人力資源

僱員概況

本集團人力資源管理制度,給予所有僱員相關的工作指引文件,清晰向不同業務經營地的所有級別員工傳達有關公司僱傭政策、工作職業道德,以及職安健指引等訊息。我們亦確保僱員清晰瞭解其權利及福利的同時,根據此制度合規合法地工作,保障雙方權益。

The Group determines a reasonable employee remuneration and welfare package according to their job nature, qualifications and performance as well as market conditions, with reference to their performance appraisal. We also encourage internal promotion. We would provide support for employees in participating on-job and professional trainings offered by the Group, or other external trainings as well. The Group encourages its employees to participate in external seminars to keep abreast of changes and updates on areas of legal, compliance and financial accounting and reporting. The Group also encourages our Directors and senior management to develop and refresh their knowledge and skills by continuous professional development training, which includes seminars and training, updates on regulatory requirements and development and corporate governance practices.

本集團按照員工的工作性質、資歷、工作表現及市場情況,並經過績效評估而釐訂合理的僱員薪酬及福利。我們鼓勵內部晉升,支持僱員參與由本集團提供的在職及專業培訓、或其他外部培訓。本集團鼓勵僱員參與外部研討會,以緊貼法律、以及財務會計及申報知識領域的變動及最新資料。本集團亦鼓勵董事及高級管理層進行持續專業發展培訓(其中包括研討會及培訓、法規要求及發展以及企業管治常規之最新資料)以發展及更新彼等之知識及技能。

1. Employment

Through the comprehensive human resources management system, the Group ensures equal treatment to employees and no employee will suffer from any discrimination or be deprived of any treatment due to gender, race, religion, age, marital and family status, disability or any other reasons. During the Reporting Period, the Group had not involved in any event of breach of laws and regulations relating to employment, which had a significant impact on the Group.

The Group has formulated a competitive package of remuneration and welfare system, which includes basic remuneration, over-time salary, employees welfare and rights (such as mandatory provident fund, insurance, statutory and additional annual leave, sick leave, various allowances, severance payments and provision of dormitories). The Group also provides additional remuneration and welfare such as evaluation bonus with reference to the employees' performance, financial results, market situation and other factors to attract and retain talented employees.

1. 僱傭

透過全面的人力資源管理制度,本集團確保僱員獲得平等待遇,不會因性別、種族背景、宗教、年齡、婚姻及家庭狀況、殘疾或任何其他原因而遭受歧視或遭剝奪任何待遇。報告期間,本集團並無牽涉任何有關僱傭、且對本集團有重大影響的違法違規事件。

本集團已制訂一套具競爭力的薪酬及福利 待遇制度,包括基本薪酬及加班工資、員工 福利及權益(如強制性公積金、保險、法定 及額外年假、病假、各種津貼、遺散費及提 供宿舍等)。本集團亦因應員工工作表現、 財務業績、市場情況等因素,給予員工考核 獎金等額外薪酬及福利,以吸引及挽留人 才。

The Group also pays social insurance for employees, provide commercial insurance, supplementary medical benefits in accordance with applicable laws and industrial practice of the region.

Although there is no relevant statutory requirement, the Group requires individual employee to possess relevant professional qualifications for providing professional services to its customers and ensure corporate governance standard (such as accounting staff should possess the professional accounting qualification of the Hong Kong Institute of Certified Public Accountants).

本集團亦會因應所在地區法例及行業慣例,為員工繳納社會保險,提供商業保險、 補充醫療福利等。

儘管沒有相關法定要求,但本集團要求個別員工擁有專業資格,為客戶提供專業服務及確保企業管治水平如會計人員(如香港會計師公會的會計專業資格)。

2. Employee Health and Safety

The Group puts employee health and safety as first priority. We provide a safe working environment to our staff (including inviting third party testing organisations to conduct test at the workplace, equip offices and plants with sufficient first-aid appliances and fire prevention equipment).

We established the Health and Safety Committee to formulate a series of detailed work health and safety guidelines and they are under stringent supervision and implementation. With reference to industrial practices and regulations, these guidelines standardise the processes at all levels and through many years of improvements and revisions, and ensure that the health and safety of all staff are being protected. We identify and assess the safety and health risks annually on each position of the Company, strictly monitor and evaluate all the risks exposed due to use of new materials and mechanical equipment.

2. 僱員健康及安全

僱員的健康及安全為本集團的最優先考慮。我們為員工提供安全的工作環境(包括邀請第三方檢測機構對職場環境進行檢測、於辦公室及廠房內配備足夠的急救用品及防火設備等)。

我們已成立健康及安全委員會,制訂一系列詳細的工作健康及安全指引,並嚴格監督及執行。該等指引參考行業慣例及監管規定,將各級工序規範化,並經過長年累月的改進及修改,以確保所有員工的健康及安全得到保障。我們每年對全公司各崗位進行安全及健康風險鑒別及評估,嚴格監控及評估所有新物料、機械設備等的使用風險。

In order to enhance staff to attach more importance on occupational health and safety, the Group offers staff the training and safety meetings, and participating in fire drills held by respective departments and institutions on a regular basis. The benefits provided by the Group to its long-term employees include medical, pension and other conventional insurances.

In order to enrich the employees' leisure life and enhance their physical and mental health, the Group organises and arranges all kinds of cultural, sports and social activities to enhance interaction and understanding among employees, maintain work and life balance and strengthen their sense of belongings.

We also organise Christmas party, annual dinner or corporate meeting during Christmas, New Year and other special occasions to share the happiness with employees and reward staffs with excellent performance.

During the Reporting Period, the Group had no significant incident of safety and work-related injury, and it had not been involved in any event of breach of laws and regulations relating to safe working environment and protection of employees from occupational hazards, which had a significant impact on the Group.

3. Employee Development and Training

In view of the fact that talent resources are key assets to corporate success, the Group provides professional training to improve quality, qualification and skills of the employees for their growth through a series of training programs. The Group also encourages staff to discuss with management regarding their promotion and career objectives. The Group encourages the Directors and senior management to participate in training regarding Rules Governing the Listing of Securities on the Growth Enterprise Market of the Stock Exchange (the "Listing Rules") and corporate governance from time to time, so as to improve the internal control of the Company, and at the same time, we also encourage accounting staff and company secretary to conduct a periodic update on relevant professional knowledge.

為加強員工對職業健康及安全的重視,本 集團為僱員提供相關培訓及安全會議,定 期參加相關部門或機構舉辦的消防演習。 本集團在長期員工的福利中包含醫療、養 老等常規保險。

為豐富員工業餘生活,促進員工身心健康, 本集團組織及安排各類型文化、體育及社 交活動,藉此加強僱員之間的互動交流及 瞭解,保持工作及生活平衡,加強員工歸屬 感。

我們亦會於聖誕、新年等節日或特別日子 組織聖誕派對、年度晚宴、企業年會等,與 僱員分享節日喜悦及表彰優秀員工。

報告期間,本集團沒有發生重大安全事故 以及工傷;亦無任何有關安全工作環境及 保障僱員避免職業性危害、且對本集團有 重大影響的違法違規事件。

3. 僱員發展及培訓

鑑於人才資源是企業發展賴以成功的重要資產,本集團透過一系列的培訓計劃,為員工提供專業訓練,提高員工質素、資格及技能,協助員工成長。本集團亦鼓勵員工成長、本集團亦鼓勵員工成長、本集團亦鼓勵員工作晉升及事業發展目標與管理人員討論。本集團鼓勵董事及高級管理層不定財論。本集團鼓勵董事及高級管理層不定財命,有關聯交所創業板證券上市規則(「上市規則」)及企業管治的培訓,以提升本司的內部監控,同時亦鼓勵會計及公司的內部監控,同時亦鼓勵會計及公司人員等定期更新相關的專業知識。

The professional training and development programs including but not limited to:

- Professional knowledge of swimwear and garment production;
- Occupational safety and health seminars;
- Seminars/guidance on regulations relating to human resources, anti-corruption; and
- Knowledge relating to Listing Rules and corporate governance

In addition, the Group also provides various trainings on those areas such as enterprise management, project management, communication skills and presentation skills in relation to the occupational development of staff.

4. Labour Standards

The Group believes that provision of safe, efficient and appropriate working environment and labour policies is essential to employees, our most valuable assets. The Group's internal rules and labour system are made in strict adherence to the Employment Ordinance (Chapter 57 of the Laws of Hong Kong), the Regulation on Labour Security Supervision issued by the State Council of the PRC and the Labour Law of Cambodia and by reference to international standards. All recruitment processes and promotion activities are stringently implemented and supervised according to the human resource management system of the Group.

專業培訓及發展計劃包括但不限於:

- 泳衣及服裝生產專業知識;
- 職業安全及健康講座;
- 人力資源、反貪污等相關法規講座/ 指引;及
- 上市條例及企業管治相關知識

此外,本集團亦就員工的職業發展提供在 企業管理、項目管理、溝通技巧、演講技巧 等範疇上提供各類型培訓。

4. 勞工標準

本集團深信,提供安全、高效及合適的工作環境及勞工政策能保障我們最大的資產一員工。本集團嚴格遵守香港法例第57章《僱傭條例》以及中國國務院的《勞動保障監察條例》、柬埔寨《勞工法》並參考國際勞工標準,從而制訂內部守則指引及勞工制度。所有招聘程序及晉升活動均根據本集團人力資源管理制度嚴格執行及監督。

The codes of conducts are clearly set out in all employment contracts and staff codes of the Group. The conducts of all employees (including Directors and staffs at all levels) are under a strict supervision to avoid any non-compliance incident. The Group will conduct investigations, punishment or dismissal to relevant employees immediately when any illegal behavior is being discovered. If necessary, the Group will further improve the labour mechanism against illegal behaviors.

During the Reporting Period, the Group had no significant safety issue. There was no child or forced labour in the Group's operations, nor any discriminating incident involving race, religion, age and disability.

Supply Chain Management

The Group is engaged in the manufacturing swimwear and garment sectors for many years and has established a good reputation in the industry. The Group develops a set of comprehensive internal purchasing system in accordance with the applicable laws and standards in the PRC, Hong Kong as well as Cambodia. During the Reporting Period, the suppliers of the Group are mainly raw materials (mainly fabrics) suppliers and production equipment suppliers from the PRC, Europe, Cambodia and Hong Kong.

The Group pays great attention to suppliers' integrity and conduct due diligence on suppliers to ensure that suppliers are having good operational record in the past without any material violation or any breach of commercial morality. Currently, we mainly rely on individual suppliers to provide raw materials. Those suppliers have undergone fair and rigorous supplier selection process, possess reliable operation records and are able to continuously provide us materials at a price which are competitive to the Group. Although these suppliers have good past performance, the Group looks for appropriate new suppliers regularly for risk control purpose.

本集團在所有僱傭合約及員工守則上清晰列明對僱員行為操守的規範,對所有僱員(包括董事及各級員工)的行為操守作嚴格監督,杜絕違規情況。當發現任何違規行為,本集團會即時作出調查、處分或解僱有關員工。如有需要,本集團會針對違規行為進一步完善勞工機制。

報告期間,本集團未發生重大安全事故,本 集團並無童工或強迫勞役,亦無任何涉及 種族、宗教、年齡、殘疾等歧視案件。

供應鏈管理

本集團從事泳衣及服裝生產多年,已經於業內建立良好的信譽。本集團已根據中國、香港及柬埔寨的適用法律及基準,發展一套全面的內部採購系統。報告期間,本集團的供應商主要包括原材料(主要為布料)供應商及生產設備供應商,主要來自中國、歐洲、柬埔寨及香港。

本集團非常重視供應商的誠信,對供應商進行 盡職審查,確保供應商過去的營商紀錄良好,未 曾出現嚴重違規或任何違反商業道德的行為。 我們現時主要依賴個別供應商提供原材料,他 們均經過公平嚴謹供應商甄選程序,擁有可靠 的營商紀錄,並可持續以本集團認為之具競爭 力之價格向我們提供原材料。儘管該等供應商 往績良好,但為控制風險,本集團定期物色合適 的新供應商。

After providing raw materials to the Group, regardless of whether they are new or old suppliers, the Group will conduct assessment on suppliers in terms of contract fulfilment according to internal guidelines and check if our suppliers have fulfilled their responsibilities under the procurement contracts, provide relevant information reports timely and ensure that the raw materials supplied have met the Group's requirements. If any material issue occurs or exists, the Group will change suppliers.

不論新舊供應商,在彼等為本集團開始提供原材料後,本集團按照內部指引進行履約評估,檢查供應商有否履行採購合約項下的責任,及時提供有關訊息匯報,確保其提供之原材料符合本集團之要求。如出現或有潛在重大問題,本集團會更換供應商。

The Group believes maintaining a good relationship with suppliers will facilitate corporate development. The Group offers fair and reasonable contract terms to suppliers when entering into procurement contracts with them. We firmly refuse depriving suppliers in any ways for profitability. We will achieve sustainable development operation pattern under mutual and friendly cooperation.

本集團相信與供應商保持良好關係,有助推動 企業發展。本集團與供應商訂立採購合約時,給 予供應商公平合理的合約條款,堅拒為了提升 盈利而以任何方式剝削供應商,在雙方友好合 作的同時,達致可持續發展的經營模式。

Product Liability

The customers of the Group are mainly branded swimwear and garment enterprises in the European markets. The Group attaches great importance to products' quality and reputation, and actively assures products and services quality through internal control. The Group has already set up comprehensive internal quality inspection system to ensure products are meeting the quality requirements.

產品責任

本集團的客戶主要為歐洲等地市場的泳衣及服裝品牌企業。本集團十分重視產品的質量和信譽,積極透過內部監控確保產品及服務質素。本集團已設立完善的內部品質檢測機制,確保產品符合質量要求。

The quality inspection system of the Group mainly includes as follow:

本集團的品質檢測機制主要包括以下程序:

- Periodic workplace inspection, check documentations and inspect raw materials quality to ensure they meet documentation requirements and provide inspection reports;
- 1. 定期進行車間巡查,核對製單資料、檢查原 材料質量是否符合製單要求,並匯報查貨 報告;
- 2. Check production process and ensure technology used is accurate with sound operation of production equipment;
- 2. 檢查生產工序,確保工藝正確、生產設備運 作良好;
- Check whether packaging such as carton boxes, plastic bags and price tags are correct according to documentations and ensure meeting customers' requirements upon delivery;
- 3. 根據製單資料核對紙箱、膠袋、價錢牌等包 裝是否正確,確保交付時符合客戶要求;
- Conduct product quality inspection to ensure that size, wordings, colour and printing of the finished products are manufactured exactly according to the customers' requirements;
- 4. 進行產品質量檢測,確保成品尺寸、文字、 顏色、印花等均按照客戶要求準確製造;
- 5. It is subject to signatory and stamping by supplier's executives after the aforementioned inspection.
- 5. 完成上述檢測後,由廠方主管級人員簽名 及蓋印作實。

The Group requires its staff to observe the above quality inspection system as well as all other working guidelines to ensure products meet the quality requirements. Save as guidelines and handbooks, we also arrange relevant trainings for staff to improve their professional technological skills from time to time.

本集團規定員工遵從上述品質檢測機制及所有 其他工作指引,確保產品符合質量要求。除指引 及手冊外,我們亦不定期為員工安排相關培訓, 以提升員工的專業技術水平。

The Group maintains and reviews different communication channels with customers to obtain customer feedback and handle customer complaints timely, whereby investigation on customer complaints and services will be conducted and improve our customer service system.

本集團維持及審視與客戶的各種溝通渠道,以 獲得客戶的意見反饋,及時處理客戶投訴,從而 對客戶投訴及服務作調查,並完善客戶服務制 度。

During the Reporting Period, the Group has complied with all the laws and regulations relating to health and safety, advertising, labeling and privacy matters in respect of the products and services provided, which had a significant impact on the Group, nor suffered any loss of customer arising from products problems.

報告期間,本集團已遵守所有有關所提供產品和服務的健康與安全、廣告、標籤及私隱事宜、 且對本集團有重大影響的法律法規;亦未有出 現因產品問題而造成的客戶損失。

Anti-Corruption

The Group strictly complies with applicable anti-corruption laws and moral standards. During the Reporting Period, there was no case of corruption, bribery, extortion, fraud and money laundering lodged against the Group or our employees.

At the entity's business and capital market operation level, the Board of Directors of the Group adopts a "zero tolerance" attitude for corruption and fraudulent acts, which has already been reflected in our business and staff policies as well as in our operating procedures. The Group adheres to the philosophy of "integrity and accountality" and eradicates corruption acts resolutely. The Group maintains sound corporate governance and risk management to protect the interests of stakeholders and facilitate our sustainable development.

Regarding the corporate governance structure of the Group and other relevant information, please refer to pages 56 to 72 of this annual report.

The Group has formulated the convention against corruption and a set of comprehensive anti-corruption and fraudulent mechanism pinpointing at the whole supply chain from upstream suppliers to downstream end-customers, as well as the capital market operation of investors, shareholders and institutions. The Group provides periodic anti-corruption training and information to employees to raise their anti-corruption awareness, thereby ensuring every employee is in compliance with local rules and has good professional conduct.

The above measures are reinforced by internal independent audit. We carry out whistle-blowing system to allow anonymous reporting. If any corruption or fraud event is discovered, we will conduct immediate investigation and report to the audit committee and senior management.

反貪污

本集團已制訂廉政公約及一套完善的反貪污及 詐騙機制,針對從上游供應商至下游最終客戶 的整條供應鏈,以及面對投資者、股東及機構的 資本市場運作。本集團定期向員工提供有關反 貪污的培訓及資訊,增加員工的反貪意識,確保 所有員工均遵守營業地的法規,並擁有良好的 專業操守。

上述措施已經過內部獨立審核而有所加強。我們實施舉報人制度,容許匿名舉報。如發現任何 貪污或詐騙事件,我們會即時進行調查,並向審 核委員會及高級管理層匯報。

ENVIRONMENTAL, SOCIAL AND GOVERNANCE REPORT

環境、社會及管治報告

During the Reporting Period, we had not identified any illegal event involving in corruption, bribery, extortion, fraud and money laundering, which had a significant impact on the Group. The Group will review the implementation of respective systems periodically and devote more resources to improve the mechanism if necessary.

Community

The Group places importance on social responsibility of an enterprise, upholds the philosophy of "giving back to society where we take from", and encourages employees' awareness of caring for the community and helping each other.

During the Reporting Period, the Group actively repays to society, and participates in various community activities such as flag-selling day and also provides leave for voluntary services. We hope to raise employees' community awareness through organising or participating in such kind of community activities to let them contributing back the community practically, promote their care and help the needed. We also encourage employees to share proactively after the activities, influence others to participate more volunteer activities and establish proper values.

The Group will continue to cooperate with more organisations and institutions and offer them more support to make greater contributions to the society.

社區

本集團重視企業社會責任,秉持「取之社會,用 之社會」的原則,倡導員工對社區關懷、人人互 助的意識。

報告期間,本集團積極回饋社會,組織參與各類 社區活動,如賣旗等不同範疇的活動,亦提供義 工假。我們希望透過組織或參與此類社區活動, 讓員工身體力行回饋社區,從而提升員工的社 區意識,推動員工關懷、幫助有需要人士。我們 亦鼓勵員工於活動後多作交流分享,感染其他 員工參與更多公益活動,樹立正確的價值觀。

本集團會繼續與更多組織及機構合作,向它們 提供更多支援,為社會作出更大貢獻。

BONUS ISSUE OF SHARES AND WARRANTS

On 18 May 2015, (i) the Board of Directors (the "Board") proposed a bonus share issue to the qualifying shareholders on the basis of four bonus shares for every one existing share held on 3 July 2015 (the "Record Date"); and (ii) the Board also proposed the bonus warrant issue to the qualifying shareholders on the basis of one warrant for every one existing share held on the Record Date.

By an ordinary resolution passed on 24 June 2015, a bonus share was issued to shareholders on the basis of four bonus shares for every one existing share held on the Record Date. The bonus shares were credited as fully paid at par by way of capitalisation of an amount equal to the total par value of bonus shares standing to the credit of the share premium account of the Company. On the same day, another ordinary resolution passed for an issuance of bonus warrant to shareholders on the basis of one warrant for every one existing share held on the Record Date. Each warrant entitled the holder to subscribe in cash for one share at an initial subscription price of HK\$0.18 per warrant share, on the date falling 12 months from the date of issuance of the warrants (the "Warrants"). Issuance of bonus shares and bonus warrants were completed on 13 July 2015. On 28 July 2016, an aggregate of 4,978,523 ordinary shares were issued as a result of the exercise of the subscription rights attaching to 4,978,523 Warrants. The subscription rights attaching to the remaining 981,380,235 Warrants expired on 12 July 2016. The premium on the issue of shares, amounting to approximately HK\$846,000 was credited to the Company's share premium account.

Pursuant to the terms of convertible non-voting preference shares ("CPS") and Series B convertible non-voting preference shares ("Series B CPS"), the conversion price of the outstanding CPS and Series B CPS were adjusted from HK\$0.65 per share to HK\$0.13 per share and HK\$0.16 per share to HK\$0.032 per share respectively as a result of the bonus share issue. The said adjustments took effect immediately after 3 July 2015. No adjustment was required to be made as a result of the Warrants issue.

發行紅股及紅利認股權證

於二零一五年五月十八日,(i)董事會(「董事會」) 建議向合資格股東作出紅股發行,基準為於二 零一五年七月三日(「記錄日期」)每持有一股現 有股份獲發四股紅股;及(ii)董事會亦建議向合資 格股東作出紅利認股權證發行,基準為於記錄 日期每持有一股現有股份獲發一份認股權證。

根據於二零一五年六月二十四日通過之一項普 通決議案,本公司向股東發行紅股,基準為於記 錄日期每持有一股現有股份獲發四股紅股。紅 股透過資本化相等於紅股總面值之本公司股份 溢價賬之進賬額方式按面值入賬列為繳足。於 同日,另一項普通決議案亦獲通過,以向股東發 行紅利認股權證,基準為於記錄日期每持有一 股現有股份獲發一份認股權證。每份認股權證 賦予持有人權利於認股權證(「認股權證」)發行 日期起計滿十二個月當日按初步認購價每股認 股權證股份港幣0.18元以現金認購一股股份。 發行紅股及紅利認股權證已於二零一五年七月 十三日完成。於二零一六年七月二十八日,本公 司因行使4,978,523份認股權證附帶之認購權而 發行合共4,978,523股普通股。餘下981,380,235 份認股權證附帶之認購權已於二零一六年七月 十二日到期。發行股份之溢價約港幣846,000元 已計入本公司之股份溢價賬。

根據可換股無投票權優先股(「可換股無投票權優先股」)及B系列可換股無投票權優先股(「B系列可換股無投票權優先股」)之條款,尚未行使可換股無投票權優先股及B系列可換股無投票權優先股之轉換價因紅股發行分別由每股港幣0.65元調整至每股港幣0.13元及由每股港幣0.16元調整至每股港幣0.032元。上述調整於緊隨二零一五年七月三日後生效。毋需因發行認股權證再作出任何調整。

On 18 July 2016, the Company and the placing agent entered into issue an aggregate of 300,000,000 shares at subscription price of HK\$0.10 per share (the "Subscription").

a placing agreement, pursuant to which the placing agent agreed to procure not less than six placees to purchase up to 300,000,000 shares at placing price of HK\$0.10 per share (the "Placing"). The Placing and Subscription were approved by the shareholders at the extraordinary general meeting of the Company held on 7 September 2016. The Placing and Subscription were completed and shares were issued on 14 October 2016. The premium on the issue of shares, amounting to approximately HK\$52,813,000, net of share issue expenses, was credited to the Company's share premium account. The shares will rank pari passu in all respects with the ordinary shares of the Company in issue on the date of allotment.

DEREGISTRATION OF CHARMSTON (HOLDINGS) LIMITED

傑軒(集團)有限公司之註銷

On 28 June 2017, a resolution was passed by the shareholders of Charmston (Holdings) Limited ("Charmston") to cease its operations and deregister the company. The Group holds 13% equity interests in Charmston and is classified as available-forsale financial assets. The investment in Charmston was thus considered as non-recoverable and an impairment of approximately HK\$2,998,000 was made against the available-for-sale financial assets during the year ended 30 June 2017. It is the Directors' opinion that the deregistration of Charmston will not have a material impact on the Group's result of operations and financial position. The deregistration process is yet to complete at the date of the Report.

FINANCIAL PERFORMANCE

For the year ended 30 June 2017 (the "Year"), loss attributable to owners of the Company was approximately HK\$46,075,000. Comparing to loss attributable to owners of the Company for year ended 30 June 2016 of approximately HK\$47,251,000, the decrease in loss attributable to the owners of the Company was mainly attributable to decrease of impairment of goodwill to approximately HK\$23,000,000 (2016: HK\$37,900,000) made for garment and swimwear cash-generating unit (2016: swimwear cash-generating unit) and partially set off by (i) decrease in gross profit to approximately HK\$556,000 (2016: HK\$5,848,000); (ii) impairment of available-for-sale financial assets of approximately HK\$2,998,000 (2016: HK\$Nil) was made during the Year; (iii) decrease of other income to approximately HK\$4,326,000 (2016: HK\$8,848,000); (iv) increase in selling expenses to approximately HK\$6,541,000 (2016: HK\$782,000), mainly for sale of swimwear and garment products in the Kingdom of Cambodia ("Cambodia"); and (v) increase in finance costs to approximately HK\$976,000 (2016: HK\$525,000).

Revenue and Gross Profit

For the Year, the Group's total revenue and gross profit were approximately HK\$152,696,000 and HK\$556,000 respectively, as comparing to approximately HK\$139,981,000 and HK5,848,000 respectively for the year ended 30 June 2016.

Details of the increase in total revenue but decrease in gross profit are discussed below:

財務表現

截至二零一七年六月三十日止年度(「本 年度」),本公司擁有人應佔虧損約為港幣 46,075,000元。與截至二零一六年六月三十 日止年度之本公司擁有人應佔虧損約港幣 47,251,000元比較,本公司擁有人應佔虧損減 少乃主要由於就服裝及泳裝現金產生單位(二 零一六年:泳裝現金產生單位)作出之商譽減值 減少至約港幣23,000,000元(二零一六年:港幣 37,900,000元)以及部分被(i)毛利減少至約港幣 556,000元(二零一六年:港幣5,848,000元); (ii)本年度就可供出售金融資產作出減值約港幣 2,998,000元(二零一六年:無);(iii)其他收入 減少至約港幣4,326,000元(二零一六年:港幣 8,848,000元); (iv)於柬埔寨王國(「柬埔寨」) 主要銷售泳裝及服裝產品之銷售開支增加至約 港幣6,541,000元(二零一六年:港幣782,000 元);及(v)財務成本增加至約港幣976,000元(二 零一六年:港幣525,000元)抵銷所致。

收入及毛利

於本年度,本集團之總收入及毛利分別約為港幣152,696,000元及港幣556,000元,而截至二零一六年六月三十日止年度分別約為港幣139,981,000元及港幣5,848,000元。

總收入增加但毛利減少之詳情論述如下:

Manufacturing and trading of high-end swimwear and garment products ("Swimwear and garment segment")

The revenue generated from Swimwear and garment segment for the Year was approximately HK\$152,073,000 (2016: HK\$136,981,000). Gross profit for the Year was approximately HK\$550,000 (2016: HK\$3,147,000). Gross profit ratio for the Year was 0.36% (2016: 2.30%). Increase in revenue was mainly due to the increase in garment products orders of lower gross profit margin in Ricotex Industrial Company Limited ("Ricotex") with its factories located in Cambodia. However, it was offset by the decrease in revenue for high-end swimwear products as the orders for high-end swimwear products has substantially dropped. These customers were affected by the economic downturn of European market and the effect of the withdrawal of the United Kingdom from the European Union. Decrease in gross profit for the Year was mainly due to (i) substantially decrease in orders, together with drop of gross profit margin as compared with the corresponding period in 2016, for high-end swimwear products; (ii) continuous increase in portion of garment products of lower gross profit margin; and (iii) increase in factory overhead for the expansion in Cambodia of which the operation had not been fully utilised during the Year.

Trading and provision of media related services ("Trading and media related segment")

The revenue generated from Trading and media related segment for the Year was approximately HK\$623,000 (2016: HK\$3,000,000). Gross profit for the Year was approximately HK\$6,000 (2016: HK\$2,701,000). Gross profit ratio for the Year was 0.96% (2016: 90.03%). The decrease of revenue and gross profit was due to the revenue for this segment was generated from trading of second-hand mobile phones which was just started in June 2017. The revenue and gross profit generated for the year ended 30 June 2016 represented provision of information technology services.

生產及買賣高檔泳裝及服裝產品(「泳裝及服裝分部」)

本年度泳裝及服裝分部產生之收入約為港幣 152,073,000元(二零一六年:港幣136,981,000元)。本年度之毛利約為港幣550,000元(二零一六年:港幣3,147,000元)。本年度之毛利率為 0.36%(二零一六年:2.30%)。收入增加乃主要由於利高達製衣有限公司(「利高達」)位於柬埔寨工廠之毛利率較低之服裝產品訂單增加所致。然而,由於高檔泳裝產品訂單大幅減少,收入增加已被高檔泳裝產品即對大幅減少所抵銷。該等客戶受歐洲市場經濟下滑及英國脱歐影響。本年度之毛利減少乃主要由於(i)高檔泳裝產品訂單大幅減少連同毛利率較二零一六年同期減少;(ii)毛利率較低之服裝產品之比重持續增加及(iii)於本年度內,因拓展柬埔寨業務導致其營運並未悉數投入使用而導致工廠開支增加所致。

貿易及提供媒體相關服務(「貿易及媒體相關分 部」)

本年度貿易及媒體相關分部產生之收入約為港幣623,000元(二零一六年:港幣3,000,000元)。本年度之毛利約為港幣6,000元(二零一六年:港幣2,701,000元)。本年度之毛利率為0.96%(二零一六年:90.03%)。收入及毛利減少乃由於本分部收入產生於買賣二手手機且僅於二零一七年六月開始所致。截至二零一六年六月三十日止年度產生之收入及毛利指提供資訊技術服務。

Impairment of Goodwill

For the Year, impairment of goodwill was approximately HK\$23,000,000, comparing to approximately HK\$37,900,000 for the year ended 30 June 2016.

(i) The impairment of goodwill relates to the swimwear cash-generating unit ("Swimwear CGU")

No impairment of goodwill relates to Swimwear CGU was made for the Year (2016: HK\$37,900,000).

The recoverable amount of the Swimwear CGU is determined from value in use calculation (2016: value in use calculation). The key assumptions are those regarding the discount rate, growth rate and budgeted gross margin and revenue during the period. The Group estimates discount rate using pretax rate that reflects current market assessments of the time value of money and the risks specific to the CGU. The growth rate is based on long-term average economic growth rate of the geographical area in which the business of the CGU operates. Budgeted gross margin and revenue are based on past practices and expectations on market development.

During the Year, the Group prepares cash flow forecasts derived from the most recent financial budgets approved by the Directors for the next five (2016: five) years with residual period using the growth rate of 3.00% (2016: 3.99%). This rate does not exceed the average long-term growth rate for the relevant markets. The rate used to discount the forecast cash flows from the Group's activities of manufacturing and trading of high-end swimwear and related garment products is 15.00% (2016: 14.57%). No impairment of goodwill related to Swimwear CGU was made during the Year (2016: HK37,900,000).

商譽減值

本年度,商譽減值約為港幣23,000,000元,而 截至二零一六年六月三十日止年度約為港幣 37,900,000元。

(i) 與泳裝現金產生單位(「泳裝現金產生單位」)有關之商譽減值

本年度並無作出與泳裝現金產生單位有關 之商譽減值(二零一六年:港幣37,900,000 元)。

泳裝現金產生單位之可收回金額乃根據使用價值計算(二零一六年:使用價值計算)而釐定。主要假設與期內之貼現率、增長率及預算毛利率及收入有關。本集團採用可反映目前市場對貨幣時間價值及現金產生單位特定風險之評估之稅前比率以估計貼現率。增長率乃以現金產生單位經營業務所在之地區之長期平均經濟增長率為基準。預算毛利及收入乃根據過往慣例及市場發展預期得出。

An impairment of goodwill relates to Garment and swimwear CGU of approximately HK\$23,000,000 (2016: HK\$Nil) was made for the Year.

The recoverable amount of the Garment and swimwear CGU is determined from value in use calculation (2016: value in use calculation). The key assumptions for the value in use calculation are those regarding the discount rate, growth rate and budgeted gross margin and revenue during the period. The Group estimates discount rate using pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the CGU. The growth rate is based on long-term average economic growth rate of the geographical area in which the business of the CGU operates. Budgeted gross margin and revenue are based on past practices and expectations on market development.

During the Year, the Group prepares cash flow forecasts derived from the most recent financial budgets approved by the Directors for the next five (2016: five) years with residual period using the growth rate of 3.00% (2016: 3.99%). This rate does not exceed the average long-term growth rate for the relevant markets. The rate used to discount the forecast cash flows from the Group's activities of manufacturing and trading of garment and swimwear is 14.60% (2016: 14.60%).

Due to the unsatisfactory performance and the uncertainties arising from its possible restructuring, the Group has revised its cash flow forecasts for this CGU for the nine months ended 31 March 2017. The recoverable amount of this CGU is approximately HK\$105,000,000 as at 31 March 2017, which is lower than the carrying amount of this CGU. The goodwill has therefore been reduced to its recoverable amount through recognition of an impairment loss against goodwill of approximately HK\$23,000,000 during the nine months ended 31 March 2017 and the Year.

Key unobservable inputs used in the fair value measurements are disclosed in note 7 to the consolidated financial statements.

Impairment of available-for-sale financial assets

On 28 June 2017, a resolution was passed by the shareholders of Charmston to cease its operations and apply for deregistration of the company. The Group holds 13% equity interests in Charmston and is classified as available-for-sale financial assets. As Charmston was in net liabilities position, the investment thus considered as non-recoverable and an impairment of approximately HK\$2,998,000 was made against the available-for-sale financial assets during the Year.

OPERATIONS

During the Year, the Group maintained an effective cost measures in controlling the cost structure of its operations. Besides, the Group will be extremely prudent in the expansion of its operations in an organic manner. We also believe that it is of the Group's best interest to explore different sources of income while still maintains an effective and efficient overhead structure for our supporting departments in each of the business segments under operation.

LIQUIDITY AND FINANCIAL RESOURCES

As at 30 June 2017, the Group had total assets of approximately HK\$231,224,000 (2016: HK\$220,495,000). As at 30 June 2017, the Group had short term borrowings of approximately HK\$30,000,000 (2016: HK\$19,500,000). The increase of total borrowings was mainly due to the further borrowing from a noncontrolling shareholder of Ricotex during the Year. As at 30 June 2017, the Group had bank and cash balances of approximately HK\$71,092,000 (2016: HK\$48,556,000). The Group has a current ratio of approximately 1.96 comparing to that of 1.32 as at 30 June 2016. As at 30 June 2017, the Group's gearing ratio of -4% (2016: 11%) was calculated as net debt divided by total equity. Net debt is calculated as total liabilities (including current and non-current liabilities as shown in the consolidated statement of financial position) less cash and cash equivalents. Total equity represents the equity as shown in the consolidated statement of financial position.

可供出售金融資產減值

業務

於本年度,本集團於控制其業務成本架構方面 繼續採取有效成本措施。此外,本集團將於以自 然增長方式拓展其業務方面持極其審慎態度。 本集團亦認為,尋求不同之收入來源,同時對本 集團所營運之各業務分部之支援部門維持有效 及具效率之開支架構,乃符合本集團之最佳利 益。

流動資金及財務資源

於二零一七年六月三十日,本集團之資產總 值約為港幣231,224,000元(二零一六年:港幣 220,495,000元)。於二零一七年六月三十日,本 集團擁有短期借貸約港幣30,000,000元(二零 一六年:港幣19,500,000元)。借貸總額之增加 乃主要由於本年度內來自利高達非控股股東之 進一步借貸所致。於二零一七年六月三十日,本 集團之銀行及現金結存約為港幣71,092,000元 (二零一六年:港幣48,556,000元)。本集團之流 動比率約為1.96,而於二零一六年六月三十日 之流動比率則為1.32。於二零一七年六月三十 日,按負債淨值除以權益總額計算,本集團之資 本負債比率為-4%(二零一六年:11%)。負債 淨值按負債總額(包括綜合財務狀況表所示之 流動及非流動負債)減現金及現金等值項目計 算。權益總額為綜合財務狀況表所示之權益。

USE OF PROCEEDS

The Placing and Subscription were completed and shares were issued on 14 October 2016. The premium on the issue of shares, amounting to approximately HK\$52,813,000, net of share issue expenses, was credited to the Company's share premium account. The Company planned to apply the net proceeds from the Placing and Subscription as to (i) up to approximately HK\$31,000,000 for expansion of the Group's swimwear and garment production facilities in Cambodia; (ii) up to approximately HK\$20,000,000 for general working capital for the Group's existing principal business; and (iii) the balance for future investment opportunities. The net proceeds of approximately HK\$23,500,000 have been utilised by the Group as to (i) approximately HK\$7,500,000 for expansion of the Group's swimwear and garment production in Cambodia including additional labour force for second production plant and purchase of raw materials for the expanded capacity; (ii) approximately HK\$6,000,000 for purchase of raw materials for its existing swimwear and garment business; and (iii) approximately HK\$10,000,000 for salaries, professional fees and other administrative expenses for Group's existing principal business. The remaining unutilised net proceeds are held in banks for future use as intended.

Save as disclosed above, the Company has not conducted any equity fund raising activities during the Year.

KEY RISKS AND UNCERTAINTIES

Our Group's financial condition, results of operations and business prospects may be affected by a number of risks and uncertainties directly or indirectly pertaining to our Group's businesses. The following are the key risks and uncertainties identified by our Group. There may be other risks and uncertainties in addition to those shown below which are not known to our Group or which may not be material now but could be material in the future:

1. Reliance on a small number of key suppliers

The Group's five largest suppliers, which accounted for 49% (2016: 68%) of the Group's total purchase, are mainly related to the purchase of fabric. There is no assurance that these major suppliers shall continue to provide the fabric to us at price acceptable to our Group. In the event that our Group were unable to retain these suppliers, or procure replacement suppliers, our business, results of operations, profitability and liquidity might be adversely affected. However, the Group has established strong business relationship with these major suppliers.

2. Reliance on a small number of key customers

The Group's five largest customers, which accounted for 87% (2016: 70%) of the Group's total revenue. There is no assurance that major customers will continue to conduct business with us. In the event that major customers materially reduce their purchase orders with the Group or cease to conduct business with the Group and the Group fails to obtain a comparable level of purchase orders from new customers, the Group's business, result of operations and financial condition may be adversely affected. Customer satisfaction with our products has a profound effects on our profitability. To provide good quality services to our customers, our Group is in constant communication with our customers and potential customers to uncover and create customer needs and help customers make informed decision.

主要風險及不明朗因素

本集團之財務狀況、營運業績及業務前景可能 受到與本集團業務直接或間接相關之多項風險 及不明朗因素影響。以下為本集團識別出之主 要風險及不明朗因素。除下文所列者外,或會存 在本集團並未知悉或目前可能不重大但日後可 能屬重大之其他風險及不明朗因素:

1. 依賴少數主要供應商

本集團之五大供應商(佔本集團總採購額之49%(二零一六年:68%))主要與布料採購相關。概不保證該等主要供應商將持續按本集團可接受之價格向我們提供布料。倘本集團無法與該等供應商維持合作或覓得代替供應商,則我們之業務、營運業績、盈利能力及流動資金或會受到不利影響。然而,本集團已與該等主要供應商建立穩固業務關係。

2. 依賴少數主要客戶

本集團之五大客戶佔本集團總收入額之 87%(二零一六年:70%)。概不保證主要 客戶將繼續與我們進行業務。倘主要客戶 大幅削減彼等對本集團之採購訂單或終止 與本集團進行業務,而本集團無法向新客 戶獲得相若水平之採購訂單,則本集團 業務、營運業績及財務狀況或會受到我們 影響。客戶對我們產品之滿意度會對我們 盈利能力有深遠影響。為向客戶提供優質 服務,本集團與客戶及潛在客戶不斷溝通, 以發現及創造客戶需求並協助客戶作出知 情決策。

3. Foreign exchange rate risk

The Group business transactions, assets and liabilities are mainly denominated in Hong Kong dollars, Renminbi and United States dollars, of which the Group's exposure to foreign exchange risk is considered as limited. During the Year, the Group did not carry out any hedging activity against foreign currency risk. Any substantial exchange rate fluctuation of foreign currencies against Renminbi may have a financial impact on the Group. The Group will continue to monitor its foreign exchange position and, if necessary, utilise hedging tools, if available, to manage its foreign currency exposure.

4. Investment risk

Investment risk can be defined as the likelihood of occurrence of losses relative to the expected return on any particular investment. Key concern of investment framework will be balancing risk and return across different investments, and thus risk assessment is a core aspect of the investment decision process. Proper authorisation system has been set up and detailed analysis will be made before approving investments. Regular updates on the progress of the investments of our Group would be submitted to the Board.

CAPITAL STRUCTURE

By an ordinary resolution passed on 24 June 2015, 3,945,435,032 bonus shares were issued to shareholders on the basis of four bonus shares for every one existing share held on the Record Date. The bonus shares were credited as fully paid at par by way of capitalisation of an amount equal to the total par value of bonus shares standing to the credit of the share premium account of the Company. On the same day, another ordinary resolution passed for an issuance of bonus warrant to shareholders on the basis of one warrant for every one existing share held on the Record Date. Each warrant entitled the holder to subscribe in cash for one share at an initial subscription price of HK\$0.18 per warrant share, on the date falling 12 months from the date of issues of the warrant. Issuance of bonus shares and bonus warrant were completed on 13 July 2015. Subsequently, 4,978,523 ordinary shares were issued from the exercise of bonus warrants on 28 July 2016. The proceeds from the exercise of warrants in the sum of approximately HK\$896,000 has been used as administrative expenses of the Group.

3. 外匯風險

Subsequent to the issuance of bonus share, the conversion price of the outstanding CPS had been adjusted from HK\$0.65 per share to HK\$0.13 per share; and the conversion price of 312,500,000 Series B CPS had been adjusted from HK\$0.16 per share to HK\$0.032 per share. These said adjustments took effect immediately after 3 July 2015. No adjustment was required to make as a result of the bonus warrant issue for both CPS and Series B CPS.

On 18 July 2016, the Company and the placing agent entered into a placing agreement, pursuant to which the placing agent agreed to procure not less than six placees to purchase up to 300,000,000 shares at placing price of HK\$0.10 per share. On the same date, the Company and Subscriber, entered into a subscription agreement, pursuant to which the Subscriber agreed to subscribe for and the Company agreed to allot and issue an aggregate of 300,000,000 shares at subscription price of HK\$0.10 per share.

The Placing and Subscription were approved by the shareholders at the extraordinary general meeting of the Company held on 7 September 2016. The Placing and Subscription were completed and shares were issued on 14 October 2016. The premium on the issue of shares, amounting to approximately HK\$52,813,000, net of share issue expenses, was credited to the Company's share premium account. The shares will rank pari passu in all respects with the ordinary shares of the Company in issue on the date of allotment.

Pursuant to the terms of CPS and Series B CPS, the conversion price of the outstanding CPS and Series B CPS were adjusted from HK\$0.13 per share to HK\$0.12 per share and HK\$0.032 per share to HK\$0.030 per share respectively as a result of the Placing and Subscription. The said adjustments took effect immediately after 15 July 2016.

The staff costs, including directors' remuneration, were approximately HK\$67,919,000 (2016: HK\$58,672,000). The Group offers a comprehensive remuneration package and benefits to its full time employees in compliance with the regulations in Hong Kong, the PRC and the Cambodia respectively, including medical scheme, provident fund or retirement fund. In addition, the Group adopts a share option scheme for eligible employees (including Directors) and consultants to provide incentives to participants for their contributions and continuing efforts to promote the interests of the Group.

CONTINGENT LIABILITIES

As at 30 June 2017, the Group did not have any material contingent liabilities (2016: Nil).

CHARGE ON ASSETS

The Group has pledged bank deposits of approximately HK\$5,560,000 (2016: HK\$613,000) to secure banking facilities granted to the Group.

PROSPECT

For the Swimwear and garment segment, due to the recent economic downturn of European market and effect of the withdrawal of the United Kingdom from the European Union, the orders for high-end swimwear for the factory located in the PRC continuously decrease in current year and the coming years. In order to seek new business opportunities, a non-wholly owned subsidiary, Ricotex, has established and is operating a factory in the Cambodia to manufacture Swimwear and garment products. Due to the import tariff tax benefit offer to European customers, the operation in Ricotex can attract more European customers and therefore Ricotex can stimulate and increase revenue for swimwear and garment segment in the future. Furthermore, in order to diversify our products, we are developing new products other than swimwear with our new/existing business partners during the Year, and we expect there would be new orders received in coming years. Also, our Group continues to closely monitor and control cost in order to push up the gross profit margin of Swimwear and garment segment.

Code Provision A.2.1

Under the code provision A.2.1 of the CG Code, the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. Mr. Lau Chi Yuen, Joseph, the chairman of the Company, took up the role of Chief Executive Officer ("CEO") since the position became vacant on 30 June 2014, and thus there has been no segregation of duties during the Year. The Board has evaluated the current situation of the Group and taken into account of the experience and past performance of Mr. Lau Chi Yuen, Joseph, the Board was of the opinion that it was appropriate and in the best interest of the Company at the present stage for vesting the roles of the Chairman and the CEO of the Company in the same person as it helps to facilitates the execution of the Group's business strategies and maximises the effectiveness of its operation. The Board will nevertheless review this structure from time to time and will consider the segregation of the two roles at the appropriate time.

CORPORATE GOVERNANCE PRACTICES

The Board of Directors (the "Board") is committed to maintain high standards of corporate governance for the Company. During the year ended 30 June 2017 (the "Year"), the Company is in compliance with the Corporate Governance Code (the "CG Code") as set out in Appendix 15 to the Rules Governing the Listing of Securities on the Growth Enterprise Market of the Stock Exchange of Hong Kong Limited (the "GEM Listing Rules") except provisions A.2.1 and A.4.1 of the CG Code as detailed below:

Code Provision A.2.1

Under the code provision A.2.1 of the CG Code, the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. Mr. Lau Chi Yuen, Joseph, the chairman of the Company, took up the role of Chief Executive Officer ("CEO") since the position became vacant on 30 June 2014, and thus there has been no segregation of duties during the Year. The Board has evaluated the current situation of the Group and taken into account of the experience and past performance of Mr. Lau Chi Yuen, Joseph, the Board was of the opinion that it was appropriate and in the best interest of the Company at the present stage for vesting the roles of the Chairman and the CEO of the Company in the same person as it helps to facilitates the execution of the Group's business strategies and maximises the effectiveness of its operation. The Board will nevertheless review this structure from time to time and will consider the segregation of the two roles at the appropriate time.

Code Provision A.4.1

Under the code provision A.4.1 of the CG Code, Non-executive Directors should be appointed for a specific term, subject to reelection. The current Independent Non-executive Directors are not appointed for specific terms, but are subject to retirement and reelection at Annual General Meeting ("AGM") of the Company in line with the Company's Articles of Association ("Articles"). As such, the Company considers that sufficient measures have been taken to ensure the Company's corporate governance practices are no less exacting than those in the CG Code.

THE BOARD

The Board is responsible for the leadership and control of the Company and oversees the Group's businesses, strategic decisions and performances. Daily operations and execution are delegated to management. The Board is also responsible for performing the corporate governance duties set out below:

- (a) to develop and review the Company's policies and practices on corporate governance;
- (b) to review and monitor the training and continuous professional development of Directors and senior management;
- to develop, review and monitor the code of conduct and compliance manual (if any) applicable to Directors and employees;
- (d) to review and monitor the Company's policies and practices on compliance with legal and regulatory requirements; and
- (e) to review the Company's compliance with the CG Code and disclosure in the corporate governance report.

The Executive Directors are responsible for running the Group and executing the strategies adopted by the Board. The Independent Non-executive Directors provide the Group with a wide range of expertise and experience, to ensure that the Board accounts for the interests of all shareholders and that all issues are considered in an objective manner.

All Directors give sufficient time and attention to the Group's affairs. The Company considers that the Board has the necessary skills and experience appropriate for discharging their duties as Directors act in the best interest of the Company and that the current Board size is adequate for its present operations.

During the selection process, the Nomination Committee may consider referrals or engage external recruitments professionals when necessary.

The Board has adopted a Policy in August 2013 which sets out the approach to achieve diversity on the Board. The Company recognises and embraces the benefits of having a diverse Board to enhance the quality of its performance. In designing the Board's composition, Board diversity has been considered from a number of aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. All Board appointments will be based on meritocracy, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the Board.

Selection of candidates will be based on a range of diversity perspectives, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. The ultimate decision will be based on merit and contribution that the selected candidates will bring to the Board.

The Nomination Committee of the Company will monitor the implementation of this Policy and will from time to time review this Policy, as appropriate, to ensure the effectiveness of this Policy.

The Nomination Committee comprises at least three members, the majority of whom shall be Independent Non-executive Directors. The current members of the Nomination Committee are Mr. Lau Chi Yuen, Joseph, Dr. Lee Chung Mong, John, Mr. Tam Wing Kin and Mr. Fung Chan Man, Alex. Mr. Fung Chan Man, Alex is the Chairman of the Committee. Meetings of the Nomination Committee shall be held at least once a year.

As at 30 June 2017, included in the Group's consolidated statement of financial position was goodwill of approximately HK\$78,064,000 attributable to the swimwear cash-generating unit ("CGU") and garment and swimwear CGU. Management is required to test goodwill for impairment at least annually. The financial performance of these CGUs deteriorated for the year ended 30 June 2017, which increases the risk that the carrying amount of goodwill may be impaired.

1. GENERAL INFORMATION

Luxey International (Holdings) Limited (the "Company") was incorporated in the Cayman Islands with limited liability. The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands. The address of its principal place of business is Unit B, 5th Floor, Hang Cheong Factory Building, 1 Wing Ming Street, Cheung Sha Wan, Kowloon, Hong Kong. The Company's shares are listed on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

The Company is an investment holding company. The principal activities of its subsidiaries are set out in note 21 to the consolidated financial statements.

2. BASIS OF PREPARATION

These consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA"). HKFRSs comprise Hong Kong Financial Reporting Standards ("HKFRS"); Hong Kong Accounting Standards ("HKAS"); and Interpretations. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the Growth Enterprise Market of the Stock Exchange and with the disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622). Significant accounting policies adopted by the Group are disclosed below.

The HKICPA has issued certain new and revised HKFRSs that are first effective or available for early adoption for the current accounting period of the Group. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these consolidated financial statements.

1. 一般資料

薈萃國際(控股)有限公司(「本公司」)乃於開曼群島註冊成立之有限公司,註冊辦事處之地址為Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands。本公司主要營業地點為香港九龍長沙灣永明街1號恆昌工廠大廈5樓B室。本公司股份於香港聯合交易所有限公司(「聯交所」)創業板上市。

本公司為一間投資控股公司。其附屬公司 之主要業務載於綜合財務報表附註21。

2. 編製基準

該等綜合財務報表已按照香港會計師公會 (「香港會計師公會」)頒佈之所有適用香港 財務報告準則(「香港財務報告準則」)而編 製。香港財務報告準則包括香港財務報告準 則(「香港財務報告準則」)、香港會計準則 (「香港會計準則」)及詮釋。該等綜合財務 報表亦遵守聯交所創業板證券上市規則之 適用披露條文及香港公司條例(第622章) 之披露規定。本集團採納之重大會計政策 披露如下。

香港會計師公會已頒佈若干本集團於本會計期間首次生效或可供提早採納之新訂及經修訂香港財務報告準則。附註3提供首次應用該等與本集團有關的發展所引致並反映於本綜合財務報表內的當前及過往會計期間任何會計政策變動的資料。

If there has been a significant increase in credit risk since initial recognition, an entity will recognise lifetime expected credit losses. HKFRS 16 Leases

HKFRS 16 replaces HKAS 17 Leases and related interpretations. The new standard introduces a single accounting model for lessees. For lessees the distinction between operating and finance leases is removed and lessees will recognise right-of-use assets and lease liabilities for all leases (with optional exemptions for short-term leases and leases of low value assets). HKFRS 16 carries forward the accounting requirements for lessors in HKAS 17 substantially unchanged. Lessors will therefore continue to classify leases as operating or financing leases.

The Group's offices, warehouses, director's quarter and car parking spaces are currently classified as operating leases and the lease payments (net of any incentives received from the lessor) are recognised as an expense on a straight-line basis over the lease term. Under HKFRS 16 the Group may need to recognise and measure a liability at the present value of the future minimum lease payments and recognise a corresponding right-of-use asset for these leases. The interest expense on the lease liability and depreciation on the right-of-use asset will be recognised in profit or loss. The Group's assets and liabilities will increase and the timing of expense recognition will also be impacted as a result.

The significant accounting policies applied in the preparation of these consolidated financial statements are set out below.

(a) Consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries made up to 30 June. Subsidiaries are entities over which the Group has control. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group has power over an entity when the Group has existing rights that give it the current ability to direct the relevant activities, i.e. activities that significantly affect the entity's returns.

When assessing control, the Group considers its potential voting rights as well as potential voting rights held by other parties. A potential voting right is considered only if the holder has the practical ability to exercise that right.

Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date the control ceases.

Intragroup transactions, balances and unrealised profits are eliminated. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests ("NCI") represent the equity in subsidiaries not attributable, directly or indirectly, to the Company. NCI are presented in the consolidated statement of financial position and consolidated statement of changes in equity within equity. NCI are presented in the consolidated statement of profit or loss and consolidated statement of profit or loss and consolidated statement of profit or loss and other comprehensive income as an allocation of profit or loss and total comprehensive income for the year between the non-controlling shareholders and owners of the Company.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling shareholders even if this results in the NCI having a deficit balance.

Changes in the Company's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions (i.e. transactions with owners in their capacity as owners). The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the NCI are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

In the Company's statement of financial position, investments in subsidiaries are stated at cost less impairment loss, unless the investment is classified as held for sale (or included in a disposal group that is classified as held for sale).

The acquisition method is used to account for the acquisition of a subsidiary in a business combination. The consideration transferred in a business combination is measured at the acquisition-date fair value of the assets given, equity instruments issued, liabilities incurred and any contingent consideration. Acquisition-related costs are recognised as expenses in the periods in which the costs are incurred and the services are received. Identifiable assets and liabilities of the subsidiary in the acquisition are measured at their acquisition-date fair values.

The excess of the sum of the consideration transferred over the Group's share of the net fair value of the subsidiary's identifiable assets and liabilities is recorded as goodwill. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the sum of the consideration transferred is recognised in consolidated profit or loss as a gain on bargain purchase which is attributed to the Group.

In a business combination achieved in stages, the previously held equity interest in the subsidiary is remeasured at its acquisition-date fair value and the resulting gain or loss is recognised in consolidated profit or loss. The fair value is added to the sum of the consideration transferred in a business combination to calculate the goodwill.

The non-controlling interests in the subsidiary are initially measured at the non-controlling shareholders' proportionate share of the net fair value of the subsidiary's identifiable assets and liabilities at the acquisition date.

After initial recognition, goodwill is measured at cost less accumulated impairment losses. For the purpose of impairment testing, goodwill acquired in a business combination is allocated to each of the cash-generating units ("CGUs") or groups of CGUs that is expected to benefit from the synergies of the combination. Each unit or group of units to which the goodwill is allocated represents the lowest level within the Group at which the goodwill is monitored for internal management purposes. Goodwill impairment reviews are undertaken annually, or more frequently if events or changes in circumstances indicate a potential impairment. The carrying value of the CGU containing the goodwill is compared to its recoverable amount, which is the higher of value in use and the fair value less costs of disposal. Any impairment is recognised immediately as an expense and is not subsequently reversed.

(i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in Hong Kong dollars, which is the Company's functional and presentation currency.

(ii) Transactions and balances in each entity's financial statements

Transactions in foreign currencies are translated into the functional currency on initial recognition using the exchange rates prevailing on the transaction dates. Monetary assets and liabilities in foreign currencies are translated at the exchange rates at the end of each reporting period. Gains and losses resulting from this translation policy are recognised in profit or loss.

Non-monetary items that are measured at fair value in foreign currencies are translated using the exchange rates at the dates when the fair values are determined.

When a gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is recognised in other comprehensive income. When a gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is recognised in profit or loss.

Leases that do not substantially transfer to the Group all the risks and rewards of ownership of assets are accounted for as operating leases. Lease payments (net of any incentives received from the lessor) are recognised as an expense on a straight-line basis over the lease term.

(f) Club debenture

Club debenture with indefinite useful life is stated at cost less any impairment losses. Impairment is reviewed annually or when there is any indication that the club debenture has suffered an impairment loss.

(g) Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out basis. The cost of finished goods and work in progress comprises raw materials, direct labour and an appropriate proportion of all production overhead expenditure, and where appropriate, subcontracting charges. Net realisable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

Financial assets are derecognised when the contractual rights to receive cash flows from the assets expire; the Group transfers substantially all the risks and rewards of ownership of the assets; or the Group neither transfers nor retains substantially all the risks and rewards of ownership of the assets but has not retained control on the assets. On derecognition of a financial asset, the difference between the asset's carrying amount and the sum of the consideration received and the cumulative gain or loss that had been recognised in other comprehensive income is recognised in profit or loss.

Financial liabilities are derecognised when the obligation specified in the relevant contract is discharged, cancelled or expires. The difference between the carrying amount of the financial liability derecognised and the consideration paid is recognised in profit or loss.

The Group classifies its financial assets in the following categories: loans and receivables and available-forsale. The classification depends on the purpose for which the financial assets were acquired. Management determines the classification of its financial assets at initial recognition.

(i) Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. These assets are carried at amortised cost using the effective interest method (except for short-term receivables where interest is immaterial) minus any reduction for impairment or uncollectibility. Typically trade and other receivables, bank and cash balances are classified in this category.

(j) Trade and other receivables

Trade receivables are amounts due from customers for merchandise sold or services performed in the ordinary course of business. If collection of trade and other receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If not, they are presented as non-current assets.

Trade and other receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less allowance for impairment.

(k) Cash and cash equivalents

For the purpose of the statement of cash flows, cash and cash equivalents represent cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term highly liquid investments which are readily convertible into known amounts of cash and subject to an insignificant risk of change in value. Bank overdrafts which are repayable on demand and form an integral part of the Group's cash management are also included as a component of cash and cash equivalents.

The accounting policies adopted for specific financial liabilities and equity instruments are set out below.

(m) Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred, and subsequently measured at amortised cost using the effective interest method.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the reporting period.

(n) Trade and other payables

Trade and other payables are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method unless the effect of discounting would be immaterial, in which case they are stated at cost.

(p) Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable and is recognised when it is probable that the economic benefits will flow to the Group and the amount of revenue can be measured reliably.

Revenue from the sales of goods is recognised on the transfer of significant risks and rewards of ownership, which generally coincides with the time when the goods are delivered and the title has passed to the customers.

Media related service income is recognised when the service is rendered.

Subcontracting fee income is recognised when the services are rendered.

Interest income is recognised on a time-proportion basis using the effective interest method.

(i) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave and long service leave as a result of services rendered by employees up to the end of the reporting period.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(ii) Pension obligations

The Group operates a mandatory provident fund scheme (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for all qualifying employees in Hong Kong. The Group's contributions to the MPF Scheme are calculated at 5% of the salaries and wages subject to a monthly maximum amount of HK\$1,500 per employee and vest fully with employees when contributed into the MPF Scheme.

The employees of the Group in the People's Republic of China (the "PRC") and Kingdom of Cambodia (the "Cambodia") are members of central pension schemes operated by the local municipal governments. The Group is required to contribute certain percentage of the employees' basic salaries and wages to the central pension schemes to fund the retirement benefits. The local municipal governments undertake to assume the retirement benefits obligations of all existing and future retired employees of the Group. The only obligation of the Group with respect to the central pension schemes is to meet the required contributions under the schemes.

(iii) Termination benefits

Termination benefits are recognised at the earlier of the dates when the Group can no longer withdraw the offer of those benefits, and when the Group recognises restructuring costs and involves the payment of termination benefits.

(r) Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets, until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

To the extent that funds are borrowed generally and used for the purpose of obtaining a qualifying asset, the amount of borrowing costs eligible for capitalisation is determined by applying a capitalisation rate to the expenditures on that asset. The capitalisation rate is the weighted average of the borrowing costs applicable to the borrowings of the Group that are outstanding during the period, other than borrowings made specifically for the purpose of obtaining a qualifying asset.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

A government grant is recognised when there is reasonable assurance that the Group will comply with the conditions attaching to it and that the grant will be received.

Government grants that become receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss in the period in which they become receivable.

(t) Taxation

Income tax represents the sum of the current tax and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit recognised in profit or loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Intangible assets that have an indefinite useful life or that are not yet available for use are reviewed for impairment annually and whenever events or changes in circumstances indicate the carrying amount may not be recoverable.

The carrying amounts of other non-financial assets are reviewed at each reporting date for indications of impairment and where an asset is impaired, it is written down as an expense through the consolidated statement of profit or loss to its estimated recoverable amount unless the relevant asset is carried at a revalued amount, in which case the impairment loss is treated as a revaluation decrease. The recoverable amount is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets. If this is the case, recoverable amount is determined for the CGU to which the asset belongs. Recoverable amount is the higher of value in use and the fair value less costs of disposal of the individual asset or the CGU.

Value in use is the present value of the estimated future cash flows of the asset/CGU. Present values are computed using pre-tax discount rates that reflect the time value of money and the risks specific to the asset/CGU whose impairment is being measured.

Impairment losses for CGU are allocated first against the goodwill of the unit and then pro rata amongst the other assets of the CGU. Subsequent increases in the recoverable amount caused by changes in estimates are credited to profit or loss to the extent that they reverse the impairment unless the relevant asset is carried at a revalued amount, in which case the reversal of the impairment loss is treated as a revaluation increase.

For available-for-sale equity instruments, a significant or prolonged decline in the fair value of the investment below its cost is considered also to be objective evidence of impairment.

In addition, for trade receivables that are assessed not to be impaired individually, the Group assesses them collectively for impairment, based on the Group's past experience of collecting payments, an increase in the delayed payments in the portfolio, observable changes in economic conditions that correlate with default on receivables, etc.

Only for trade receivables, the carrying amount is reduced through the use of an allowance account and subsequent recoveries of amounts previously written off are credited against the allowance account. Changes in the carrying amount of the allowance account are recognised in profit or loss.

For all other financial assets, the carrying amount is directly reduced by the impairment loss.

For financial assets measured at amortised cost, if the amount of the impairment loss decreases in a subsequent period and the decrease can be related objectively to an event occurring after the impairment was recognised, the previously recognised impairment loss is reversed (either directly or by adjusting the allowance account for trade receivables) through profit or loss. However, the reversal must not result in a carrying amount that exceeds what the amortised cost of the financial asset would have been had the impairment not been recognised at the date the impairment is reversed.

(w) Provisions and contingent liabilities

Provisions are recognised for liabilities of uncertain timing or amount when the Group has a present legal or constructive obligation arising as a result of a past event, it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made. Where the time value of money is material, provisions are stated at the present value of the expenditures expected to settle the obligation.

Where it is not probable that an outflow of economic benefits will be required, or the amount cannot be estimated reliably, the obligation is disclosed as a contingent liability, unless the probability of outflow is remote. Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow is remote.

Events after the reporting period that provide additional information about the Group's position at the end of the reporting period are adjusting events and are reflected in the consolidated financial statements. Events after the reporting period that are not adjusting events are disclosed in the notes to the consolidated financial statements when material.

5. KEY SOURCES OF ESTIMATION UNCERTAINTY

The key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, are discussed below.

(a) Property, plant and equipment and depreciation

The Group determines the estimated useful lives, residual values and related depreciation charges for the Group's property, plant and equipment. This estimate is based on the historical experience of the actual useful lives and residual values of property, plant and equipment of similar nature and functions. The Group will revise the depreciation charge where useful lives and residual values are different to those previously estimated, or it will write-off or write-down technically obsolete or non-strategic assets that have been abandoned.

The carrying amount of property, plant and equipment as at 30 June 2017 was approximately HK\$27,753,000 (2016: HK\$30,590,000).

(a) 物業、廠房及設備及折舊

(b) Income taxes

The Group is subject to income taxes in several jurisdictions. Significant estimates are required in determining the provision for income taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made. During the year, income tax of approximately HK\$521,000 (2016: HK\$478,000) was credited (2016: charged) to profit or loss.

(c) Impairment of goodwill

Determining whether goodwill is impaired requires an estimation of the value in use of the CGU to which goodwill has been allocated. The value in use calculation requires the Group to estimate the future cash flows expected to arise from the CGU and a suitable discount rate in order to calculate the present value. The carrying amount of goodwill at the end of the reporting period was approximately HK\$78,064,000 (2016: HK\$101,064,000) after an impairment loss of approximately HK\$23,000,000 (2016: HK\$37,900,000) was recognised during the year. Details of the impairment loss calculation are provided in note 20 to the consolidated financial statements.

(b) 所得税

(d) Impairment loss for bad and doubtful debts

The Group makes impairment loss for bad and doubtful debts based on assessments of the recoverability of the trade and other receivables, including the current creditworthiness and the past collection history of each debtor. Impairments arise where events or changes in circumstances indicate that the balances may not be collectible. The identification of bad and doubtful debts, in particular of a loss event, requires the use of judgement and estimates. Where the actual result is different from the original estimate, such difference will impact the carrying value of the trade and other receivables and doubtful debt expenses in the year in which such estimate has been changed. If the financial conditions of the debtors were to deteriorate, resulting in an impairment of their ability to make payments, additional allowances may be required.

As at 30 June 2017, accumulated impairment loss for bad and doubtful debts amounted to approximately HK\$1,375,000 (2016: HK\$2,486,000).

(e) Allowance for slow-moving inventories

Allowance for slow-moving inventories is made based on the ageing and estimated net realisable value of inventories. The assessment of the allowance amount involves judgement and estimates. Where the actual outcome in future is different from the original estimate, such difference will impact the carrying value of inventories and allowance charge/write-back in the period in which such estimate has been changed. No allowance for slow-moving inventories was made for the year ended 30 June 2017 (2016: Nil).

(f) Fair values of plant and machinery

The Group appointed an independent professional valuer to assess the fair values of the plant and machinery. In determining the fair values, the valuer has utilised a method of valuation which involves certain estimates. The directors have exercised their judgement and are satisfied that the method of valuation is reflective of the current market conditions. The fair value of plant and machinery at the end of the reporting period was approximately HK\$16,732,000 (2016: HK\$16,765,000).

6. FINANCIAL RISK MANAGEMENT

The Group's activities expose it to a variety of financial risks: foreign currency risk, credit risk, liquidity risk and interest rate risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Foreign currency risk

The Group has minimal exposure to foreign currency risk as most of its business transactions, assets and liabilities are principally denominated in Hong Kong dollars, United States dollars and Renminbi ("RMB") which are the functional currencies of the principal operating entities of the Group. The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group monitors its foreign currency exposure closely and will consider hedging significant foreign currency exposure should the need arise.

(b) Credit risk

The Group's credit risk is primarily attributable to its trade and other receivables. In order to minimise credit risk, the directors review the recoverable amount of each individual debt regularly to ensure that adequate impairment losses are recognised for irrecoverable debts. In this regard, the directors consider that the Group's credit risk is significantly reduced.

At the end of the reporting period, the Group has certain concentration of credit risk as 78% (2016: 62%) and 91% (2016: 98%) of the total trade and bill receivables are due from the largest third party debtor and the five largest third party debtors respectively.

It has policies in place to ensure that sales are made to customers with an appropriate credit history.

The credit risk on bank and cash balances is limited because the counterparties are banks with high creditratings assigned by international credit-rating agencies.

(c) Liquidity risk

The Group's policy is to regularly monitor current and expected liquidity requirements to ensure that it maintains sufficient reserves of cash to meet its liquidity requirements in the short and longer term. The Group's financial liabilities are repayable on demand or within one year.

The Group prepares cash flow forecasts derived from the most recent financial budgets approved by the directors for the next five (2016: five) years with residual period using the growth rate of 3.00% (2016: 3.99%). This rate does not exceed the average long-term growth rate for the relevant markets. The rate used to discount the forecast cash flows from the Group's activities of manufacturing and trading of garment and swimwear is 14.60% (2016: 14.60%).

Due to the unsatisfactory performance and the uncertainties arising from its possible restructuring, the Group has revised its cash flow forecasts for this CGU for the nine months ended 31 March 2017. The recoverable amount of this CGU is approximately HK\$105,000,000 as at 31 March 2017, which is lower than the carrying amount of this CGU. The goodwill has therefore been reduced to its recoverable amount through recognition of an impairment loss against goodwill of approximately HK\$23,000,000 during the nine months ended 31 March 2017 and year ended 30 June 2017.

Under the Hong Kong Employment Ordinance, the Group is obliged to make lump sum payments on cessation of employment in certain circumstances to certain employees who have completed at least five years of services with the Group. The amount payable is dependent on the employees' final salary and years of services, and is reduced by entitlements accrued under the Group's retirement plan that are attributable to contributions made by the Group. The Group does not set aside any assets to fund any remaining obligations.

(b) PRC employee severance compensation

Pursuant to the new PRC Labour Contract Law which became effective on 1 January 2008, the Group is required to pay the severance compensation to its employees if the employment contract expires and is not renewed unless the Group has offered the employment contract on the same terms and conditions but the offer is rejected by the employee.

Under the Labour Contract Law, the severance compensation is calculated based on one month's salary for each year of employment completed by the employee and is capped at 12 months' salary or 12 times 300% of the average monthly salary of the previous year at the place where the employer is located, whichever is lower. At the end of each reporting period, the Group has made the provision for severance compensation for the existing employees in the PRC.

On the same date, the Company and JL Investments Capital Limited (the "Subscriber"), a substantial shareholder of the Company, entered into a subscription agreement, pursuant to which the Subscriber agreed to subscribe for and the Company agreed to allot and issue an aggregate of 300,000,000 shares at subscription price of HK\$0.10 per share (the "Subscription").

The Placing and Subscription were approved by the shareholders at the extraordinary general meeting of the Company held on 7 September 2016 and a total of 600,000,000 ordinary shares were issued on 14 October 2016. The premium on the issue of shares, amounting to approximately HK\$52,813,000, net of share issue expenses, was credited to the Company's share premium account.

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debt.

Consistent with others in the industry, the Group monitors capital on the basis of the gearing ratio. This ratio is calculated as net debt divided by total equity. Net debt is calculated as total liabilities (including current and non-current liabilities as shown in the consolidated statement of financial position) less cash and cash equivalents. Total equity represents the equity as shown in the consolidated statement of financial position.

Equity-settled share option scheme

The Company operates a share option scheme (the "Scheme") for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the Group's operations. Eligible participants include the full-time and part-time employees, executives, officers, directors, business consultants, suppliers, customers, legal and financial advisers of the Company and the Company's subsidiaries. The Scheme became effective on 18 March 2008 and, unless otherwise cancelled or amended, will remain in force for 10 years from that date.

The maximum number of unexercised share options currently permitted to be granted under the Scheme is an amount equivalent, upon their exercise, to 10% of the shares of the Company in issue at any time. The maximum number of shares issuable under share options to each eligible participant in the Scheme within any 12-month period, is limited to 1% of the shares of the Company in issue at any time. Any further grant of shares options in excess of this limit is subject to shareholders' approval in a general meeting.

Share options granted to a director, chief executive or substantial shareholder of the Company, or to any of their associates, are subject to approval in advance by the independent non-executive directors. In addition, any share options granted to a substantial shareholder or an independent non-executive director of the Company, or to any of their associates, in excess of 0.1% of the shares of the Company in issue at any time or with an aggregate value (based on the price of the Company's shares at the date of the grant) in excess of HK\$5 million, within any 12-month period, are subject to shareholders' approval in advance in a general meeting.

The unsettled amounts of approximately HK\$594,000 were fully accrued in trade and other payables during the year ended 30 June 2005 and remain outstanding as at 30 June 2016 and 30 June 2017 even though the case had ceased to be active since the year ended 30 June 2005.
