12. EVENTS AFTER THE REPORTING PERIOD

Legal Proceedings in the Netherlands

On 5 October 2017, the Company was informed by its Dutch legal advisers that a writ issued from the Dutch Court was served on Tri King International Limited ("Tri-King"), a wholly owned subsidiary of the Company, at its correspondence address in the Netherlands. Fore Freedom B.V. and XXLnet B.V. (collectively the "Plaintiffs") have made claims against Tri King for EUR2.8 million and EUR490,000 respectively allegedly being debt owed by Tri King to the Plaintiffs.

After the summary hearing, the Dutch Court has delivered a judgment which rejected all the claims of the Plaintiffs and ordered the Plaintiffs to pay the legal costs of Tri King amounted to EUR4,710 which payment is immediately enforceable.

As advised by the legal advisers to the Company as to the Netherlands laws, the parties may apply for an appeal in respect of the judgment within four weeks failing which the judgment shall be regarded as final. Alternatively the Plaintiffs may bring a new and separate legal proceedings on merits at the Dutch Court which will involve detail examination of evidence and arguments by both parties. As at the date hereof, the Company has not received any further document from the plaintiffs regarding the matter.

Details of the legal proceedings are set out in the announcements of the Company dated 6 October 2017 and 3 November 2017.

於簡易聆訊後,荷蘭法院頒佈判決,駁回原告之所有索償,並下令原告支付三皇之法律成本4,710歐元,有關付款須立即強制執行。

誠如本公司有關荷蘭法律之法律顧問所告知,雙方可於四星期內就判決申請上訴,如未能於指定期間申請上訴,該判決將被視為最終判決。另一方面,原告可於荷蘭法院就法律依據提出新及獨立之法律訴訟,此將牽涉雙方詳細審閱證據及論證。於本報告日期,本公司尚未接獲原告有關此事宜之任何文件。

管理層論述及分析

RESULTS

For the nine months ended 30 September 2017, the Group recorded a total revenue from continuing operations of approximately HK\$59,532,000 as compared with approximately HK\$24,399,000 for the same period in 2016. The increase in revenue from continuing operations was mainly due to contribution of the revenue of approximately HK\$33,834,000 from the new mobile game business acquired on 25 October 2016.

Loss attributable to owners of the Company decreased to approximately HK\$23,716,000 for the nine months ended 30 September 2017 as compared with that of approximately HK\$28,458,000 for the same period in 2016. The decrease in loss was mainly due to the net effect of (i) the recognition of estimated changes in fair value of consideration payable for business combination of approximately HK\$5,562,000 relating to the acquisition of 60% equity interest in First Surplus Investments Ltd. and its subsidiaries (the "acquisition of FS Group") completed on 25 October 2016; (ii) the recognition of estimated changes in fair value of contingent consideration assets for business combination of approximately HK\$5,743,000 relating to the acquisition of FS Group completed on 25 October 2016; (iii) the absence of the loss of approximately HK\$8,237,000 from the discontinued operation relating to a disposal of the entire equity interest of Native Hope Limited and its subsidiaries completed on 30 June 2016; (iv) the absence of write-off of intangible assets of approximately HK\$1,097,000 on 30 September 2016; (v) the absence of the impairment loss on goodwill of approximately HK\$1,431,000 on 30 September 2016 and (vi) the improvement of the operation resulted from the favorable performance of the mobile game business acquired on 25 October 2016.

DIVIDEND

The Directors do not recommend the payment of any interim dividend for the nine months ended 30 September 2017 (2016: HK\$Nil).

BUSINESS REVIEW AND PROSPECT

For the nine months ended 30 September 2017, the Group engaged in (i) developing and marketing of the patented server based technology and the provision of communications software platform, software related services and the custom-made software development services ("Software Platform"); (ii) money lending business ("Money Lending Business") and (iii) the mobile data solutions and mobile game related services ("Mobile Game Business").

Software Platform

The segment revenue from continuing operations for the period ended 30 September 2017 amounted to approximately HK\$14,466,000 (2016: the segment revenue from continuing operations of approximately HK\$14,463,000). Keep up with the ever-changing IT environment, the Group closely monitors the industry trend and continuously upgrades its products.

Money Lending Business

On 22 October 2015, the Group commenced its Money Lending Business through Aurum Pacific Finance Limited ("APF"), an indirect wholly-owned subsidiary of the Company, which was granted a money lenders license by the licensing court in Hong Kong pursuant to the Money Lenders Ordinance (Chapter 163 of the Laws of Hong Kong).

The Group adopted the revised money lending policy and procedure manual which provide guidelines on the handling and/or monitoring of money lending procedures according to the Money Lenders Ordinance (Chapter 163 of the Laws of the Hong Kong). The Money Lending Business made positive progress in its development and became one of the sources for the Group's profit for the period ended 30 September 2017. The interest income for the period ended 30 September 2017 amounted to approximately HK\$11,232,000 (2016: the interest income of approximately HK\$9,936,000).

As disclosed in the Company's announcements dated 21 October 2016, 25 October 2016 and 23 October 2017, APF has advanced a loan of HK\$35 million ("Loan") to Honghu Capital Co. Limited ("Borrower") which together with interest thereon shall be repaid on 20 October 2017. As at the close of business on 20 October 2017, the final interest component payment of HK\$1,750,000 was paid. However, no repayment of the Loan has yet been made. An acceptable repayment plan from the Borrower is still under negotiation process as at the date of report. For details, please refer to the announcements of the Company dated 21 October 2016, 25 October 2016 and 23 October 2017.

放債業務

二零一五年十月二十二日,本集團透過本公司間接全資附屬公司奧栢財務有限公司(「奧栢財務」)(根據香港法例第163章放債人條例獲香港牌照法庭授予放債人牌照)開展其放債業務。

本集團採納經修訂借貸政策及程序手冊,其 訂明符合香港法例第163章放債人條例有關處 理及/或監管放債程序之指引。放債業務發 展進度良好,並已成為本集團截至二零一七 年九月三十日止期間其中一項溢利來源。截 至二零一七年九月三十日止期間,利息收入 約11,232,000港元(二零一六年:利息收入約 9,936,000港元)。

如本公司日期為二零一六年十月二十一日、二零一六年十月二十五日及二零一七年十月二十五日及二零一七年十月二十三日之公告所披露,奥栢財務向鴻鵠資本有限公司(「借方」)提供貸款35百萬港元(「借方」),該貸款連同利息須於二零一七年十月二十日營還。於二零一七年十月二十五日及二零一七年十月二十三日之公告。

管理層論述及分析

Mobile Game Business

Benefiting from the acquisition of FS Group in late 2016, the Group could tap into the mobile online game industry and capture the opportunities in the mobile online game and related solution industry.

As a mobile game developer with strong self-developed capabilities in games, the FS Group is engaged in the development of mobile games to players around the world. The FS Group has also licensed our games or related intellectual properties to various well-established game operators as our licensed operations with the exclusive and/or non-exclusive right to operate, publish and distribute specific games within an agreed period and designated territories. To further enhance the competitiveness, apart from mobile games, the FS Group has also provided the innovative solution services to the customers. During the period, the segment recorded the revenue of approximately HK\$33,834,000.

OUTLOOK

We intend to continue taking efforts in developing and upgrading our products and services with a generic growth of the business in order to broaden our income sources. The Group will continue to deploy appropriate operation strategies to meet the challenges posted by the competitive market to improve the performance and maximize the returns of shareholders as a whole.

Financial Resource and Liquidity

The Group's business operations and investments are in Hong Kong, People's Republic of China (the "PRC") and the Netherlands. At 30 September 2017, the Group had cash and bank balances of approximately HK\$18,738,000 (31 December 2016: HK\$11,500,000). Most of the cash and bank balances are denominated in Hong Kong dollars. The Group will closely monitor exchange rate movement and will take appropriate activities to reduce the exchange risk.

受惠於二零一六年底收購FS集團,本集團得以 打入手機線上遊戲行業,並從手機遊戲及相關 方案行業獲得商機。

FS集團為擁有強大自主研發遊戲能力之手機遊戲研發商,從事開發針對全球玩家之手機遊戲。FS集團亦向不同信譽卓著之遊戲營運商授出我們之遊戲或相關知識產權,以作我們之持牌營運,並向彼等授出獨家及/或非獨家權利,於指定期間及指定地區營運、發佈及分銷指定遊戲。除手機遊戲外,FS集團亦向客戶提供創新方案服務,進一步提高競爭力。期內,此分部錄得收益約33,834,000港元。

展望

我們擬繼續努力發展及提升我們的產品及服務,帶動業務整體增長,擴大收入來源。本集團將繼續採取適當營運策略應付市場競爭帶來的挑戰,以改善整體業績表現,為股東帶來最大回報。

財務資源及流動資金

本集團之業務經營及投資均於香港、中華人民 共和國(「中國」)及荷蘭進行。於二零一七年 九月三十日,本集團之現金及銀行結餘約為 18,738,000港元(於二零一六年十二月三十一 日:11,500,000港元)。大部份現金及銀行結餘 均以港元計值。本集團將密切監察匯率變動及 採取適當措施降低外匯風險。

管理層論述及分析

Gearing Ratio

At 30 September 2017, total assets of the Group were approximately HK\$445,324,000 (31 December 2016: HK\$451,871,000) whereas total liabilities were approximately HK\$137,323,000 (31 December 2016: HK\$153,427,000). The gearing ratio of the Group, calculated as total liabilities over total assets, was 30.8% (31 December 2016: 34.0%) and the current ratio, calculated as current assets over current liabilities, was 19.6 (31 December 2016: 25.1). The Directors will continue to take measures to further improve the liquidity and gearing position of the Group.

Material Acquisition, Disposal and Significant Investment

On 30 March 2017, the Group entered into an agreement with the vendor pursuant to which a subsidiary of the Company as a purchaser has conditionally agreed to acquire from the vendor the entire issued share capital of Stars Ventures Limited ("Stars Ventures") at the consideration of HK\$32,400,000. The principal activities of Stars Ventures and its subsidiaries are investment holding while its associates are principally engaged in construction and management of fibre optic internet networks in the Netherlands. The acquisition was completed on 13 April 2017. Details of the completion of acquisition are set out in the announcements of the Company dated 30 March 2017 and 13 April 2017.

On 20 April 2017, the Group entered into a shareholders' agreement with independent third parties in relation to the subscription of 182,000 new ordinary shares ("Subscription") at HK\$1 each per share ("Subscription Shares") of Profit Seeker Limited ("Profit Seeker") and the shareholders' loan which was amounted to HK\$4,000,000 in total. Profit Seeker is principally engaged in catering business.

二零一七年三月三十日,本集團與賣方訂立協議,據此,本公司附屬公司為買方,有條件同意從賣方收購Stars Ventures Limited (「Stars Ventures」)全部已發行股本,代價為32,400,000港元。Stars Ventures及其附屬公司之主要活動為投資控股,而其聯營公司主要於荷蘭從事建設及管理光纖互聯網網絡。收購於二零一七年四月十三日完成。完成收購詳情載於本公司日期為二零一七年三月三十日及二零一七年四月十三日之公告。

二零一七年四月二十日,本集團與獨立第三方訂立股東協議,內容有關以每股面值1港元認購盛亨有限公司(「盛亨」)182,000股新普通股(「認購」)(「認購股份」)及股東貸款合共4,000,000港元。盛亨主要從事餐飲業務。

管理層論述及分析

On 25 April 2017, the Company entered into an agreement in relation to the acquisition of 5% of the issued share capital of Metro Rainbow Limited ("Metro") at HK\$500,000. The principal activity of Metro and its subsidiaries is digital media & e-commerce platform. The acquisition of Metro was completed on 25 April 2017.

On 5 July 2017, the Group entered into an shareholders' agreement with Mr. Lam Wai Wai to set up a company named as "Touch Fun Productions Limited" (達魂製作有限公司) to engage in development, publication and promotion of electronic games.

Apart from those disclosed in the sections headed "Material Acquisition, Disposal and Significant Investment" in this report, the Group did not have any other material acquisition, disposal and significant investment during the period ended 30 September 2017.

Capital Structure

As at 30 September 2017, the authorised share capital of the Company was HK\$120,000,000 divided into 3,000,000,000 shares of HK\$0.04 each, of which 1,088,640,000 ordinary shares were in issue and fully paid.

The completion of the Placing took place on 10 January 2017. An aggregate of 181,440,000 Placing Shares were allotted and issued pursuant to the general mandate granted to the Directors at the extraordinary general meeting held on 12 October 2016. The aggregate nominal value of the Placing Shares was HK\$7,257,600. The net proceeds from the Placing were approximately HK\$28,270,000 and the net issue price was approximately HK\$0.1558 per Placing Share. The net proceeds of approximately HK\$11,500,000 were used for Money Lending Business and the remaining proceeds were used for general working capital. Details of the Placing are set out in the Company's announcements dated 16 December 2016 and 10 January 2017.

Foreign Exchange Exposure

The Directors consider that the Group had no material foreign exchange exposure.

Pledge of Assets

At 30 September 2017, the land and buildings of the Group at carrying amount of approximately HK\$43,986,000 (31 December 2016: HK\$47,079,000) was pledged to secure interest bearing borrowings of a subsidiary of the Company.

As at 30 September 2017, the Group had approximately 101 employees (as at 30 September 2016: 86 employees) in Hong Kong and the PRC. The staff costs (including directors' remuneration) were approximately HK\$24,280,000 (30 September 2016: approximately HK\$20,476,000) for the period under review.

The Group's remuneration policy is revised periodically and determined by reference to market terms, company performance, individual qualifications and performance, and in accordance with the statutory requirements of the respective jurisdiction where the employees are employed.
