#### **FINANCIAL HIGHLIGHT**

- Recorded an unaudited revenue of approximately HK\$36.6 million for the nine months ended 31 December 2017, representing a decrease of approximately 30.1% over the same period of the previous year.
- Recorded an unaudited profit attributable to the owners of the Company of approximately HK\$18.7 million for the nine months ended 31 December 2017. The decrease in net profit as compared with the corresponding period in 2016, which was mainly attributed to the drop in placing and underwriting commission and net changes in fair value of financial assets at fair value through profit or loss.
- Basic and diluted earnings per share for the nine months ended 31 December 2017 were approximately HK0.85 cents (2016: basic and diluted earnings per share of approximately HK1.89 cents).
- The Directors do not recommend the payment of an interim dividend for the nine months ended 31 December 2017.

## NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

#### 1 Corporate information

The Company is incorporated in the Cayman Islands as an exempted company with limited liability. The Company's shares have been listed on the Growth Enterprise Market ("GEM") of The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is same as the functional currency of the Company.

The principal activities of the Company and its subsidiaries (collectively referred to as the "Group") are engaged in the provision of securities, futures and options broking and trading, loan financing service, placing and underwriting services, securities advisory service and investment holding.

#### 2 Basis of preparation and principal accounting policies

The unaudited condensed consolidated results have been prepared in accordance with accounting principles generally accepted in Hong Kong, Hong Kong Accounting Standards and Hong Kong Financial Reporting Standards ("HKFRSs") issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") and the disclosure requirements of the GEM Listing Rules. They have been prepared on the historical cost basis except for certain financial instruments that are measured at fair value.

The accounting policies and method of computation used in preparing the unaudited condensed consolidated results are consistent with those used in the audited financial statements for the year ended 31 March 2017 except in relation to the new and revised standards, amendments and interpretations ("new and revised HKFRSs") issued by the HKICPA that are adopted for the first time for the current period's financial statements. The adoption of these new and revised HKFRSs has had no material impact on the unaudited condensed consolidated financial statements. The unaudited condensed consolidated quarterly results have not been reviewed by the Company's audit committee.

The Group has not early adopted any new and revised HKFRSs that have been issued but are not yet effective.

(a) No adjustment had been made to the basic earnings per share amounts presented for the three months ended and nine months ended 31 December 2017 and for the three months ended 31 December 2016 as the conversion of the outstanding share options during the period had an anti-dilutive effect on the basic earnings per share because the exercise price per share option was higher than the average share price of the Company for the period.

#### MANAGEMENT DISCUSSION AND ANALYSIS

#### Market review

For the nine months ended 31 December 2017, the three major indexes of United States continued their rose momentum and European equities have performed well. In Hong Kong, Hang Seng Index almost rose to its record high. However, the Post-IPO fund amount raised in the GEM was significant decreased in 2017 compared with 2016.

As at 31 December 2017, the Hang Seng Index closed at 29,919 representing approximately 24.0% increase as compared with 24,112 as at 31 March 2017.

#### **Business review**

#### Revenue and Investment Income

The Group's total revenue and investment income for the nine months ended 31 December 2017 was approximately HK\$38.9 million, as compared with the corresponding period in 2016 of approximately HK\$68.8 million, decreased by approximately 43.5% or approximately HK\$29.9 million.

#### **Securities and Futures Brokerage**

Revenue from Securities and Futures Brokerage represent commission and brokerage fee and other fees including interest derived from cash and margin securities or futures accounts and interest from IPO financing.

The commission and brokerage fees from securities dealings increased by approximately 18.3% from approximately HK\$5.8 million for the nine months ended 31 December 2016 to approximately HK\$6.9 million for the nine months ended 31 December 2017. The total value of transaction for the nine months ended 31 December 2017 was approximately HK\$81,450.1 million (2016: approximately HK\$71,627.5 million). As a result, income relating to clearing and settlement fees also increased by approximately 13.8% from approximately HK\$1.7 million for the nine months ended 31 December 2016 to approximately HK\$1.9 million for the nine months ended 31 December 2017.

The commission and brokerage fees on dealing in futures contracts decreased by approximately 24.3% from approximately HK\$207,000 for the nine months ended 31 December 2016 to approximately HK\$157,000 for the nine months ended 31 December 2017.

The interest income derived from cash and margin securities accounts for the nine months ended 31 December 2017 was approximately HK\$8.8 million represents a decrease of approximately 17.8% from approximately HK\$10.7 million of the corresponding period in 2016.

The other services income decreased by approximately 94.7% from approximately HK\$401,000 for the nine months ended 31 December 2016 to approximately HK\$21,000 for the nine months ended 31 December 2017.

#### Loan and Financing

The Group holds Money Lenders Licence under the Money Lenders Ordinance to engage in money lending business. CLC Finance Limited, the Company's wholly-owned subsidiary, provides loan and financing service to customers. As at 31 December 2017, CLC Finance Limited maintained the loan portfolio amounting to approximately HK\$76.0 million. The interest income derived from providing loan and finance to customers for the nine months ended 31 December 2017 was approximately HK\$12.1 million (2016: approximately HK\$13.6 million).

#### **Securities Advisory Services**

The Group holds licence under the Securities and Futures Ordinance to engage in Type 4 regulated activities — Advising on Securities. Revenue generated from this segment derived from services provided under this regulated activities.

Commission income from securities advisory services decreased by approximately 41.2% from HK\$1.7 million for the nine months ended 31 December 2016 to HK\$1.0 million for the nine months ended 31 December 2017.

#### **Placing and Underwriting Business**

Under normal circumstances, the Group acts as an underwriter or a sub-underwriter or a placing agent or a sub-placing agent on best effort basis for fund-raising activities. It would take the role on underwritten basis only if it received special requests from the issuers and/or their respective placing and underwriting agents.

The placing and underwriting commission decreased by approximately 97.9% from approximately HK\$13.2 million for the nine months ended 31 December 2016 to approximately HK\$0.3 million for nine months ended 31 December 2017. The Post-IPO fund amount raised in the GEM was significant decreased in 2017 compared with 2016.

#### **Investment Holding**

The Group maintained a portfolio investments included the holding of listed equity securities, bonds, income right and film right. The Group traded equity securities listed in Hong Kong and Canada. The Group holds an income right of the photovoltaic power plant at the rooftop of a factory located at Hunan Province, the PRC to generate stable cash inflow. As at 31 December 2017, the total value of the Group investment portfolio was approximately HK\$68.4 million (31 March 2017: approximately HK\$77.6 million), including the value of portfolio of listed securities of approximately HK\$32.6 million (31 March 2017: approximately HK\$29.1 million).

During the period, the gain on trading of financial assets at fair value through profit or loss of approximately HK\$1.5 million (2016: approximately HK\$1.4 million). The net changes in fair value gain of financial assets at fair value through profit or loss for the nine months ended 31 December 2017 was approximately HK\$0.8 million, representing a decrease of approximately 94.4% from approximately HK\$15.1 million of corresponding period in 2016, mainly attributed that the Group adopted the cautious approach in making investment decision so as to obtain a balance between risk and return.

#### Financial review

The Group's revenue for the nine months ended 31 December 2017 was approximately HK\$36.6 million, representing a decrease of approximately 30.1% from approximately HK\$52.3 million of the corresponding period in 2016.

Administrative expenses for the nine months ended 31 December 2017 were approximately HK\$17.5 million (approximately HK\$21.7 million for the nine months ended 31 December 2016) representing a decrease of approximately 19.2%, mainly attributed to the decrease in commission paid for the nine months period.

Staff cost increased by approximately 5.6% from approximately HK\$4.6 million for the nine months ended 31 December 2016 to approximately HK\$4.8 million for the nine months ended 31 December 2017.

Profit attributable to the owners of the Company amounted to approximately HK\$18.7 million for the nine months ended 31 December 2017 (approximately HK\$41.6 million for the nine months ended 31 December 2016). The decrease in net profit as compared with the corresponding period in 2016, which was mainly attributed to the drop in placing and underwriting commission and net changes in fair value of financial assets at fair value through profit or loss.

Earnings per share attributable to owners of the Company was approximately HK0.85 cents for the nine months ended 31 December 2017 (approximately HK1.89 cents for the nine months ended 31 December 2016). Diluted earnings per share for the nine months ended 31 December 2017 were approximately HK0.85 cents (2016: diluted earnings per share of approximately HK1.89 cents).

#### Future plans for material investments or capital assets

As at 31 December 2017, the Group had no plans for material investments or acquisition of capital assets, but will actively pursue opportunities for investments to enhance the profitability of the Group in its ordinary course of business.

#### Outlook

Looking forward to 2018, the Group expects that Hong Kong stock market will remain volatile. The Group will leverage the knowledge and experience of our management team to seize opportunities as they arise. The Group will continue to put efforts on expanding the margin and loan financing business and securities advisory service and on satisfying the needs of our customers.

The Group aims to become a leading financial service group in Hong Kong. The Group will continue looking for any potential business opportunities to bring in new sources of income and to further increase the profitability of the Group.

#### SHARE OPTIONS SCHEMES

The Company has two share option schemes namely, the pre-IPO share option scheme (the "Pre-IPO Share Option Scheme") and the share option scheme (the "Share Option Scheme") which were adopted on 22 February 2011.

#### **Pre-IPO Share Option Scheme**

The Company has adopted the Pre-IPO Share Option Scheme on 22 February 2011 under which the Company has conditionally granted options to certain Directors, senior management and employees of the Group to purchase shares of the Company with an exercise price equal to the offer price as defined in the prospectus of the Company dated 28 February 2011.

There are no share options granted and outstanding under the Pre-IPO Share Option Scheme as at 31 December 2017.

#### **Share Option Scheme**

The Company adopted the Share Option Scheme (the "Share Option Scheme") on 22 February 2011, which was approved by the shareholders' written resolutions, is valid and effective for a period of 10 years, the remaining life of the Share Option Scheme is 3 years. It is established to attract and retain the best available personnel, to provide additional incentive to employees (full-time and part-time), directors, consultants, advisers, distributors, contractors, suppliers, agents, customers, business partners and service providers of the Group and to promote the success of the business of the Group. Pursuant to the Share Option Scheme, the Board may, at its discretion and on such terms as it may think fit, offer to grant an option to any employee (full-time or part-time), director, consultant or adviser of the Group, or any substantial shareholder of the Group, or any distributor, contractor, supplier, agent, customer, business partner or service provider of the Group. An offer for the grant of share options must be accepted within 7 days inclusive of the day on which such offer was made. The amount payable by the grantee of an option to the Company on acceptance of the offer for the grant of an option is HK\$1.

As at 31 December 2017, the total number of shares in respect of which share options may be granted under the Share Option Scheme is not permitted to exceed 110,000,000 shares, representing 5% of the total number of shares of the Company as at 31 December 2017.

Under the share option scheme, the Company may grant to directors (the "Directors") and employees of the Group and any other persons who, in the sole discretion of the Board, have contributed or will contribute to the Group which options granted shall be immediately vested. The maximum number of shares to be issued upon exercise of all outstanding options granted and yet to be exercised under the share option scheme and any other share option scheme of the Company must not in aggregate exceed 30% of the total number of shares in issue from time to time.

The total number of shares which may be issued upon exercise of all options to be granted under the share option scheme and any other share option scheme of the Company must not in aggregate exceed 10% of the shares in issue at the date of the passing of the relevant ordinary resolution. If any option is to be granted to connected person(s), it must be approved by independent non-executive directors or independent shareholders as the case may be.
