(a) In November 2012, the Group advanced a three-year unsecured, interest-free loan with principal amount of HK\$13,663,000 to MediNet Holdings Limited ("MediNet Holdings"), the then holding company of Well Being Dental Services Limited ("Well Being"), Medinet Services Limited ("Medinet Services") and Medinet Health Centre Limited ("Medinet Health Centre") of which Mr. Chan Chi Wai, Nelson ("Mr. Chan") was the ultimate owner and the controlling shareholder (the "Controlling Shareholder"). The interest-free loan was initially measured at its fair value of HK\$12,410,000 at an effective interest rate of 3.25% per annum and subsequently carried at amortised cost using effective interest method. The fair value adjustment of HK\$1,253,000 at initial recognition of the interest-free loan were recognised in equity as deemed distribution to shareholder. The loan has been settled during the year ended 31 March 2016.

### 1. GENERAL

The Company was incorporated in the Cayman Islands as an exempted company and registered in the Cayman Islands with limited liability under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands on 20 August 2015. The shares of the Company have been listed on GEM of the Stock Exchange since 31 May 2016. The addresses of the registered office of the Company is Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman, KY1-1111, Cayman Islands and the principal place of business of the Company is at 16/F., 101 King's Road, North Point, Hong Kong. The Company's immediate and ultimate holding company is Medinet International Limited, a company incorporated in the British Virgin Islands which is controlled by the Controlling Shareholder.

The Company is an investment holding company and its subsidiaries are principally engaged in the provision of dental solutions and dental services and medical solutions and medical services.

The unaudited condensed consolidated financial statements are presented in Hong Kong dollars ("**HK\$**"), which is also the functional currency of the Company.

## 2. BASIS OF PREPARATION AND APPLICATION OF NEW AND AMENDMENTS TO HONG KONG FINANCIAL REPORTING STANDARDS ("HKFRSs")

The unaudited condensed consolidated financial statements of the Group for the three-month period ended 30 June 2019 and 2018 have been prepared in accordance with HKFRSs issued by the Hong Kong Institute of Certified Public Accountants (the "**HKICPA**") and the disclosure requirements of the GEM Listing Rules.

The basis of preparation and accounting policies adopted in preparing these unaudited condensed consolidated financial statements are consistent with those adopted in the preparation of the Group's audited consolidated financial statements for the year ended 31 March 2019, except for the adoption of the amendments to HKFRSs that have become effective for its accounting period beginning on 1 April 2019.

The unaudited condensed consolidated financial statement have been prepared on the historical cost basis except for certain financial instruments that are measured at fair values at the ended of each reporting period. Historical cost is generally based on the fair value of the consideration given in exchange for good and services.

In the current period, the Group has adopted all the new and amendments to HKFRSs issued by the HKICPA that are relevant to its operations and effective for its accounting period beginning on 1 April 2019. HKFRSs comprise HKFRS and HKAS and Interpretations. The adoption of these new and amendments HKFRSs did not result in significant changes to the Group's accounting policies, presentation of the Group's financial statements and amounts reported for the current period and prior years, except for the adoption of HKFRS16 "Leases" as set out below.

#### Leases

# HKFRS 16 was issued in May 2016 and is effective for annual periods beginning on or after 1 January 2019

HKFRS 16 introduces a single lessee accounting model and requires a lessee to recognise assets and liabilities for all leases with a term of more than twelve months, unless the underlying asset is of low value. A lessee is required to recognise a right-of-use asset representing its right to use the underlying leased asset and a lease liability representing its obligation to make lease payments. A lessee measures right-of-use assets similarly to other non-financial assets (such as property, plant and equipment) and lease liabilities similarly to other financial liabilities. As a consequence, a lessee recognises depreciation of the right-of-use asset and interest on the lease liability, and also classifies cash repayments of the lease liability into a principal portion and an interest portion.

HKFRS 16 substantially carries forward the lessor accounting requirements of the superseded HKAS 17. Accordingly, a lessor continues to classify its leases as operating leases or finance leases, and to account for those two types of leases differently.

The Group has reviewed the impact of HKFRS 16 on all its contracts that are, or that contain leases and has adopted HKFRS 16 with effect from 1 April 2019. The Group has opted for the modified retrospective application permitted by HKFRS 16 upon adoption of the new standard. Accordingly, the standard has been applied for the period beginning on 1 April 2019 (i.e. the initial application period). Modified retrospective application requires the recognition of the cumulative impact of adoption of HKFRS 16 on all contracts as at 1 April 2019 in equity.

Modified retrospective application of HKFRS 16 also requires the Group to recognise a lease liability at the date of initial application for leases previously classified as an operating lease under the superseded HKAS 17 measured at the present value of the remaining lease payments, discounted using the Group's incremental borrowing rate at the date of initial application. As a practical expedient under HKFRS 16, the Group has not reassessed whether a contract is, or contains, a lease at the date of initial application. Instead, the Group applied HKFRS 16 to contracts that were previously identified as leases applying HKAS 17 Leases and HK(IFRIC)-Int 4 Determining whether an Arrangement contains a Lease, and did not apply HKFRS 16 to contracts that were not previously identified as containing a lease applying HKAS 17 and HK(IFRIC)-Int 4. The Group has applied a single discount rate to a portfolio of leases with reasonably similar characteristics for determination of present value of the remaining lease payments. The right-of-use assets have been recognised, on a lease-by-lease basis, at respective carrying amounts as if HKFRS 16 had been applied since the commencement date, but discounted using the Group's incremental borrowing rate of approximately 5.13% at the date of initial application.

At inception of a contract, the Group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

On 21 March 2018, the Hong Kong Legislative Council passed The Inland Revenue (Amendment) (No. 7) Bill 2017 (the "**Bill**") which introduced the two-tiered profits tax rates regime. The Bill was signed into law on 28 March 2018 and was gazetted on the following day. Under the two-tiered profits tax rates regime, the first HK\$2 million of profits of the qualifying group entity will be taxed at 8.25%, and profits above HK\$2 million will be taxed at 16.5%. The profits of group entities in Hong Kong not qualifying for the two-tiered profits tax rates regime will continue to be taxed at the flat rate of 16.5%.

Accordingly, the Hong Kong Profits Tax is calculated at 8.25% on the first HK\$2 million of the estimated assessable profits and at 16.5% on the estimated assessable profits above HK\$2 million.

#### **BUSINESS REVIEW AND OUTLOOK**

The Group is one of the corporate healthcare solutions providers in Hong Kong for more than 20 years. We are principally engaged in the provision of medical and dental solutions to corporates and insurance companies through customised and different combination of medical and/or dental services. Currently, we operate two MediNet Centres, seven dental clinics and one DNA genetic laboratory centre in Hong Kong. In addition, the Group also established one dental clinic in Shenzhen (the "**Shenzhen Dental Clinic**") in June 2018 in order to develop dental business in the People's Republic of China (the "**PRC**").

Besides, the Group changed the proposed use of proceeds from the listing of the Company's shares on GEM (the "**Listing**") to acquire the dental business (the "**Acquired Business**") held by Master Clever Limited in July 2018, a company which is principally engaged in the business of operation of dental clinics for the provision of dental services including invisalign treatment, implant surgery, teeth whitening etc. Therefore, the Acquired Business boosted the revenue of dental services to self-paid patients for the three months ended 30 June 2019.

The Group's revenue significantly increased by approximately 67.0% from approximately HK\$23.6 million for the three months ended 30 June 2018 to approximately HK\$39.4 million for the three months ended 30 June 2019 and net loss for the period also improved from approximately HK\$3.7 million for the three months ended 30 June 2019. As the Shenzhen Dental Clinic is still at its early stage of development, there has been profit erosion but we are confident that the PRC business will perform well and will be able to generate returns in the future.

Going forward, our management team will further strengthen our efforts in the PRC business and foster our core business of the provision of medical and dental solutions and services in Hong Kong. We will not only continue to streamline our operation flow and manpower to achieve the 3Es (i.e. economy, efficiency and effectiveness) but also maximise the interest of our shareholders.

### **FINANCIAL REVIEW**

#### Revenue

The Group's revenue significantly increased by approximately 67.0% from approximately HK\$23.6 million for the three months ended 30 June 2018 to approximately HK\$39.4 million for the three months ended 30 June 2019. The following table sets forth a breakdown of the Group's revenue with comparative figures:

The revenue of medical solutions to contract customers slightly decreased by approximately 5.1% from approximately HK\$13.1 million for the three months ended 30 June 2018 to approximately HK\$12.5 million for three months ended 30 June 2019, primarily due to the decrease in the number of visits by patients to our affiliated doctors and affiliated auxiliary services providers.

The revenue of medical services to self-paid patients increased by approximately 31.0% from approximately HK\$5.0 million for three months ended 30 June 2018 to approximately HK\$6.5 million for three months ended 30 June 2019 primarily due to the increase in demand from self-paid patients for certain body check up, other testing procedures and vaccination services etc.

The revenue of dental solutions to contract customers increased by approximately 7.9% from approximately HK\$1.4 million for three months ended 30 June 2018 to approximately HK\$1.5 million for three months ended 30 June 2019, primarily due to the increase in the number of contract customers and individuals for dental solutions.

In particular, the revenue of dental services to self-paid patients increased significantly by approximately 361.8% from approximately HK\$4.1 million for three months ended 30 June 2018 to approximately HK\$18.9 million for three months ended 30 June 2019, which was primarily due to revenue generated from the Acquired Business and the establishment of the Shenzhen Dental Clinic.

#### **Other income**

Other income decreased by approximately 36.4% from approximately HK\$489,000 for the three months ended 30 June 2018 to approximately HK\$311,000 for the three months ended 30 June 2019, primarily due to a decrease interest income on loan receivables which were redeemed in July 2018 and bank interest income.

#### **Other losses**

Other losses decreased from approximately HK\$132,000 for the three months ended 30 June 2018 to nil, primarily due to the loss on write-off of fixed assets in April 2018.

### Medical and dental professional services expenses

Medical and dental professional services expenses primarily comprises fees paid to (i) affiliated doctors and affiliated auxiliary services providers rendered through our MediNet Network; (ii) external dentists engaged by the Group; (iii) laboratories services; and (iv) the Group's doctors and dentist.

The Group's medical and dental professional services expenses increased by approximately 51.0% from approximately HK\$11.4 million for the three months ended 30 June 2018 to approximately HK\$17.2 million for the three months ended 30 June 2019 which was primarily due to the increase in aggregate amount paid to external and internal dentists of the Acquired Business and laboratories which was in line with the increase in demand from self-paid patient for certain body checkups and testing procedures.

#### **Staff cost**

Staff cost increased by approximately 26.0% from approximately HK\$8.1 million for the three months ended 30 June 2018 to approximately HK\$10.2 million for the three months ended 30 June 2019. The increase was mainly attributable by (i) annual increase in salaries for the staff; and (ii) the staff cost paid to the Acquired Business and the Shenzhen Dental Clinic.

#### **Depreciation and amortisation**

Depreciation and amortisation increased from approximately HK\$570,000 for the three months ended 30 June 2018 to approximately HK\$4.4 million for the three months ended 30 June 2019 primarily due to (i) consolidation of depreciation expense of the Acquired Business; (ii) adoption of new accounting standard HKFRS 16; and (iii) amortisation of the right to use trade name and customer who will continue to visit dental clinic for the dental services of the Acquired Business.

#### Cost of medical and dental supplies

Cost of medical and dental supplies significantly increased by approximately 435.0% from approximately HK\$817,000 for the three months ended 30 June 2018 to approximately HK\$4.4 million for the three months ended 30 June 2019, which was principally due to the increase in the amount of other medical and dental consumable such as drugs and medicine, vaccination and invisalign clear-aligner treatment for the provision of medical services and dental services to self-paid patients. Such increase was generally in line with the increase in revenue from medical services and dental services to self-paid patients.

#### **Rental expenses**

Due to the adoption of HKFRS 16 "Leases" effective from the annual periods beginning on 1 April 2019, the Group did not record rental expenses for the three months ended 30 June 2019. The Group has recorded depreciation of right-of-use assets and interest on lease abilities amount to approximately HK\$3.1 million and 145,000 respectively for the three months ended 30 June 2019. Rental expenses of the Group for the three months ended 30 June 2018 was approximately HK\$2.7 million.

#### **Other expenses**

Other expenses increase by approximately 25.1% from approximately HK\$4.1 million for the three months ended 30 June 2018 to approximately HK\$5.2 million for the three months ended 30 June 2019, which was mainly due to the consolidation of other expenses of the Acquired Business and increase in cost of other general administrative and professional expenses.

#### Income tax expense

Income tax expense for the Group approximately nil for both three months ended 30 June 2018 and 2019 as there was no tax assessable income during both periods.

#### Loss and total comprehensive expense for the period

Due to the combined effect of the factors mentioned above, the Group recorded a loss and total comprehensive expense for the three months ended 30 June 2019 for approximately HK\$1.6 million which decreased by approximately HK\$2.1 million as compared with loss for the period of approximately HK\$3.7 million in the three months ended 30 June 2018.

The loss was primarily attributable to the combined effect of (i) the significant increase in revenue of approximately HK\$15.8 million for the three months ended 30 June 2019 which was offset by additional costs incurred on the development of the PRC market which mainly comprises staff costs, operating costs and administrative costs from the Shenzhen Dental Clinic; (ii) annual increase in salaries for the staff; and (iii) increase in costs of other general administrative and professional expenses.
