#### **FINANCIAL HIGHLIGHTS**

## NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

#### 1. CORPORATE INFORMATION

The Company was incorporated as an exempted company with limited liability in the Cayman Islands on 19 October 2015 and its shares have been listed on the GEM of the Stock Exchange by way of placing and public offer of shares (the "Share Offer") on 2 December 2016 (the "Listing"). The Company's registered office and the principal place of business are at Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman, KY1-1111, Cayman Islands and Shop 203, Kin Sang Commercial Centre, Kin Sang Estate, Tuen Mun, New Territories, Hong Kong, respectively.

In the opinion of the directors of the Company, the ultimate controlling parties of the Group are Mr. Cheung Lick Keung and his brother Mr. Cheung Luk Sun, who collectively control the Company through shares of the Company held by Digital Achiever Limited and Golden Dust Holdings Limited, companies incorporated in the British Virgin Islands which are wholly owned by Mr. Cheung and Mr. Cheung Luk Sun respectively.

The Group is principally engaged in the provision of tutoring services in Hong Kong. The Group provides private tutoring services including primary and secondary tutoring services under the trade name of "Logic Tutorial Centre".

#### 2. BASIS OF PRESENTATION AND PREPARATION

The Company became the holding company of the companies now comprising the Group subsequent to the completion of reorganisation on 3 November 2016, the Group is regarded as a continuing entity resulting from the Reorganisation since the insertions of certain new holding companies at the top of Billion Bright Management Limited have no commercial substance and do not form a business combination. Accordingly, the consolidated financial statements have been prepared using the principles of merger accounting as if the reorganisation had occurred as of the beginning of the earliest period presented and the current group structure had always been in existence.

The consolidated statement of profit or loss and other comprehensive income and the consolidated statement of changes in equity of the Group for the period ended 30 June 2017 and 2018 include the financial performance of all companies now comprising the Group, as if the current structure had been in existence throughout the reporting periods, or since their respective dates of incorporation, where there is a shorter period.

All significant intra-group transactions and unrealised gains on transactions have been eliminated on consolidation. Unrealised losses are also eliminated unless the transactions provide evidence of an impairment of the asset transferred.

The consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual HKFRSs, Hong Kong Accounting Standards ("HKASs") and also included the applicable disclosure requirements of the Hong Kong Companies Ordinance and the applicable disclosure provisions of the Rules Governing the Listing of Securities on the GEM Board ("GEM Listing Rules").

The consolidated financial statements have been prepared on the historical cost convention. It should be noted that accounting estimates and assumptions are used in the preparation of the consolidated financial statements. Although these estimates are based on the management's best knowledge and judgement of current events and actions, actual results may ultimately differ from those estimates.

The consolidated financial statements are presented in Hong Kong dollar ("**HK\$**") which is also the functional currency of the Company. All values are rounded to the nearest thousand except when otherwise indicated.

The accounting policies adopted in preparing the unaudited condensed consolidated financial statements were consistent with those applied for the financial statements of the Group for the year ended 31 March 2019 except HKFRS 16, Leases, ("HKFRS 16") which are effective for the financial year beginning on or after 1 January 2019.

#### Impact on adoption of HKFRS 16

HKFRS 16 introduces a comprehensive model for the identification of lease arrangements and accounting treatments for both lessors and lessees. HKFRS 16 superseded HKAS 17 Leases and the related interpretations when it becomes effective. HKFRS 16 distinguishes lease and service contracts on the basis of whether an identified asset is controlled by a customer. Distinctions of operating leases and finance leases are removed for lessee accounting, and is replaced by a model where a right-of-use asset and a corresponding liability have to be recognised for all leases by lessees, except for short-term leases and leases of low value assets. The right-of-use asset is initially measured at cost and subsequently measured at cost (subject to certain exceptions) less accumulated depreciation and impairment losses, adjusted for any remeasurement of the lease liability. The lease liability is initially measured at the present value of the lease payments that are not paid at that date. Subsequently, the lease liability is adjusted for lease and interest payments, as well as the impact of lease modifications, amongst others. For the classification of cash flows, the operating lease payments of the Group are presented as operating cash flows. Upon application of HKFRS 16, lease payments in relation to lease liability have been allocated into a principal and an interest portion which is presented as financing cash flows by the Group. The Group has initially applied HKFRS 16 at 1 April 2019 using the modified retrospective approach. Under this approach, comparative information is not restated. As disclosed in the financial statements of the Group for the year ended 31 March 2019, the Group had non-cancellable operating lease commitments of approximately HK\$6.0 million at 31 March 2019. Except for HKFRS 16, the Directors do not anticipate that the application of other new and revised HKFRSs have a material impact on the Group's financial performance and financial positions. The Group has not adopted or early adopted the new and revised HKFRSs (including their consequential amendments) which are relevant to the Group that have been issued but are not yet effective in the preparation of these unaudited condensed consolidated results.

The condensed consolidated financial statements have not been audited by the auditors of the Company but have been reviewed by the audit committee of the Company.

#### REVENUE AND OTHER INCOME

Revenue from the Group's principal activities, which is also the Group's turnover, represents the income from provision of tutoring services. Revenue and other income are analysed as follows:

The Company is an investment holding company and the principal place of the Group's operation is in Hong Kong. For the purpose of segment information disclosures under HKFRS 8, the Group regarded Hong Kong as its place of domicile. All the Group's revenue and non-current assets are principally attributable to Hong Kong, being the single geographical region. During the six months ended 30 September 2019, there was no single external customer that contributed 10% or more of the Group's total revenue from external customers (2018: Nil).

Hong Kong profits tax has been provided at the rate of 16.5% on the estimated assessable profit during the six months ended 30 September 2018 and 2019.

#### MANAGEMENT DISCUSSION AND ANALYSIS

#### **Business Review**

#### **Tutorial Business**

During the six months ended 30 September 2019, the Group kept focus mainly on its principal business in relation to the provision of tutoring services to secondary school students and primary school students in Hong Kong. During the six months ended 30 September 2019, the income from tutorial business decreased by 1.7% comparing to that of the same period last year. 29.2% (2018: 27.6%) of income from tutorial business generated from primary school tutoring services and 70.8% (2018: 72.4%) of income from tutorial business generated from secondary school tutoring services. The increasing contribution from income of tutorial business generated from primary school tutoring services was mainly due to the increasing number of primary school student in Hong Kong. Currently, we are operating 12 tutorial centres.

#### Franchise Business

The income from franchise program was approximately HK\$63,000 for the six months ended 30 September 2019. As at 30 September 2019, we have franchise centres covering Kowloon and the New Territories

#### **Outlook**

Moving forward, the Group will continuously allocate more resources to primary school tutoring services due to the increasing demand. Meanwhile, the Group will also maintain its competitive advantages in secondary school tutoring services to cope with the growth in number of secondary school students in the near future. We believe that our franchise program will increase our geographic coverage and hence will continue to engage more new franchisees.

The management expects competition in tutoring services will still be very keen and the economy of Hong Kong will be uncertain. Our experienced management team will continue to look for suitable opportunities to invest in education sector including but not limited to tutoring businesses in Hong Kong to maintain the competitiveness of the Group and provide high quality education to students.

#### **Financial Review**

#### Revenue

For the six months ended 30 September 2019, the Group recorded total revenue of approximately HK\$17.1 million, representing a decrease of approximately 1.3% as compared to approximately HK\$17.3 million for the six months ended 30 September 2018. The increase was mainly due to the decrease of approximately HK\$0.5 million or 3.9% in revenue generated from secondary school tutoring services which was offset by the increase of approximately HK\$0.2 million or 4.1% in revenue generated from primary school tutoring services. Meanwhile, the franchise business also contributed HK\$63,000 to the revenue.

#### **Depreciation expenses**

Depreciation of property, plant and equipment comprises depreciation for right-of-use asset, leasehold improvement and other equipment. Depreciation of property, plant and equipment increased by approximately HK\$3.9 million from approximately HK\$0.7 million for the six months ended 30 September 2018 to approximately HK\$4.6 million for the six months ended 30 September 2019, which was mainly due to the recognition of right-of-use asset upon the adoption of HKFRS 16 for the financial period beginning on 1 April 2019

#### Employee benefit expenses

Employee benefit expenses mainly consist of wages and salaries, pension costs and other benefits to the staff and the Directors. Employee benefit expenses increased by 34.8% from approximately HK\$8.1 million for the six months ended 30 September 2018 to HK\$10.9 million for the six months ended 30 September 2019, which was primarily resulted from increased in number of staff for better services and increase in staff benefits for retention.

#### Operating lease expenses

The operating lease expense comprises rental expenses of tutorial centres. For the period ended 30 September 2019, the decrease of operating lease expense was mainly due to the adoption of HKFRS 16 for the financial period beginning on 1 April 2019.

#### Net profit and net profit margin

The Group recorded a loss attributable to owners of the Company amounted to approximately HK\$1.4 million for the six months ended 30 September 2019 (2018: profit of HK\$1.4 million). Such turnaround was primarily due to the increase in employee benefit expenses as compared to the same period of previous financial year. As a result, net profit margin becomes –8.4% for the six months ended 30 September 2019 (2018: 8.0%).

#### Cash and cash equivalents

As at 30 September 2019, the cash and cash equivalents amounted to approximately HK\$30.0 million. The decrease comparing to the balance as at 31 March 2019 was mainly due to the purchase of property, plant and equipment of approximately HK\$9.0 million.

#### **Contingent liabilities**

As at 30 September 2019, the Group did not have any significant contingent liabilities.

The Board believes that the vesting of the roles of chairman and chief executive officer in Mr. Cheung is beneficial to the business operations and management of the Group and will provide a strong and consistent leadership to the Group. In addition, due to the presence of three independent non-executive Directors, the Board considers that no one individual has unfettered power of decision. Accordingly, the Company has not segregated the roles of its chairman and chief-executive officer as required by Code Provision A.2.1 of Appendix 15 to the GEM Listing Rules.

#### **AUDIT COMMITTEE**

The Audit Committee was established with written terms of reference in compliance with Rule 5.28 to 5.33 of the GEM Listing Rules pursuant to a resolution of the Directors passed on 3 November 2016. The primary duties of the audit committee are mainly to make recommendations to the Board on the appointment and removal of the external auditors, review the financial statements and material advice in respect of financial reporting and oversee the internal control procedures of the Company.
