CHARACTERISTICS OF THE GEM OF THE STOCK EXCHANGE OF HONG KONG LIMITED (THE “STOCK EXCHANGE”)

GEM has been positioned as a market designed to accommodate small and mid-sized companies to which a higher investment risk may be attached than other companies listed on the Stock Exchange. NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

For the three months ended 30 September 2019

1. GENERAL INFORMATION

The Company was incorporated in the Cayman Islands as an exempted company with limited liability on 22 September 2015 and its shares are listed on the Growth Enterprise Market (“**GEM**”) of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) on 30 March 2016. The headquarter and principal place of business of the Company in Hong Kong is located at Unit D, 3/F., Freder Centre, 3 Mok Chong Street, Tokwawan, Kowloon, Hong Kong.

The principal activity of the Company is investment holding. The Group’s principal activities are the provision of property construction services in Hong Kong.

The unaudited condensed consolidated financial statements of the Group for the Relevant Period are presented in Hong Kong dollars (“**HK\$**”), which is the same functional currency of the Company.

2. BASIS OF PREPARATION

The unaudited condensed consolidated financial statements of the Group for the Relevant Period have been prepared in accordance with accounting principles generally accepted in Hong Kong and comply with Hong Kong Financial Reporting Standards (“**HKFRSs**”) issued by Hong Kong Institute of Certified Public Accountants (the “**HKICPA**”) and the applicable disclosure requirements of the GEM Listing Rules and the Hong Kong Companies Ordinance.

In the Reporting Period, the Group has adopted new or revised HKFRSs issued by the HKICPA which are relevant to Group’s operations and effective for the Group’s financial statements for accounting period beginning on or after 1 July 2017. The adoption has no significant changes on the Group’s reported results and the financial position of the Group for the current or prior accounting periods. The Group has not applied any new or revised HKFRSs that is not yet effective for the Reporting Period. For those which are not yet effective and have not been early adopted, the Group is in the process of assessing their impact on the Group’s results and financial position.

These unaudited condensed consolidated financial statements have been reviewed by the audit committee of the Company.

Except as described below, the accounting policies and methods of computation used in the condensed consolidated financial statements for the three months ended 30 September 2019 are the same as those followed in the preparation of the Group's annual financial statements for the year ended 30 June 2019.

Equity-settled share-based payment transactions

Equity-settled share-based payments to employees and others providing similar services are measured at the fair value of the equity instruments at the grant date.

The fair value determined at the grant date of the equity-settled share-based payments is expensed on a straightline basis over the vesting period, based on the Group's estimate of equity instruments that will eventually vest, with a corresponding increase in equity (share option reserve).

At the end of the reporting period, the Company revises its estimates of the number of options that are expected to ultimately vest. The impact of the revision of the estimates during the vesting period, if any, is recognized in profit or loss such that the cumulative expense reflects the revised estimates, with a corresponding adjustment to share options reserve.

For share options that vest immediately at the date of grant, the fair value of share options granted is expensed immediately to profit or loss. When share options are exercised, the amount previously recognised in share option reserve will be transferred to share premium. When share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to retained earnings.

Equity-settled share-based payment transactions with parties other than employees are measured at the fair value of the goods or services rendered, except where that fair value cannot be estimated reliably, in which case they are measured at the fair value of the equity instruments granted, measured at the date the entity obtains the goods or the counterparty renders the services.

3. REVENUE

Revenue represents the fair value of amounts received and receivable for services rendered by the Group to external customers, less discount. Information reported to the Company's executive Directors, being the chief operating decision maker, for the purposes of resource allocation and assessment of segment performance focuses on types of services provided.

No diluted earnings per Share was presented as there were no potential ordinary Shares in issue during the periods under review.

MANAGEMENT DISCUSSION AND ANALYSIS

FINANCIAL REVIEW

Revenue

The Group's revenue decreased from approximately HK\$124.9 million for the three months ended 30 September 2018 to approximately HK\$85.4 million for the Relevant Period, representing a decrease of approximately 31.6%. Such decrease was partly due to the disposal of a subsidiary on 14 February 2019 and partly due to a drop of construction orders being taken up during the period.

Cost of Sales

The Group's cost of sales decreased from approximately HK\$110.7 million for the three months ended 30 September 2018 to approximately HK\$78.4 million for the Relevant Period, representing a decrease of approximately 29.2%. Such decrease was partly due to the disposal of a subsidiary on 14 February 2019 and partly due to a drop of construction orders being taken up during the period.

Gross Profit

Gross profit of the Group decreased by approximately 50.7% from approximately HK\$14.2 million for the three months ended 30 September 2018 to approximately HK\$7.0 million for the Relevant Period. The decrease in gross profit and gross profit margin was partly due to the disposal of subsidiary on 14 February 2019 and partly due to a drop of construction order being taken up during the period. The gross profit margin of those projects during the Relevant Period contributed a lower gross profit margin than last year.

Other Income

The Group's other income amounted to approximately HK\$73,000 and approximately HK\$180,000 for the three months ended 30 September 2018 and 2019 respectively. The increase was mainly due to an increase in financial guarantee income for the Relevant Period.

Administrative Expenses

Administrative expenses of the Group decreased by approximately 42.0% from approximately HK\$10.0 million for the three months ended 30 September 2018 to approximately HK\$5.8 million for the Relevant Period. The decrease was mainly due to the disposal of a subsidiary on 14 February 2019.

Income Tax Expense

Income tax expense for the Group decreased by approximately 68.4% from approximately HK\$975,000 for the three months ended 30 September 2018 to approximately HK\$308,000 for the Relevant Period. The decrease was mainly due to the effect of decrease in profit for the Relevant Period.

Profit and Total Comprehensive Income for the Period Attributable to the Owners of the Company

Profit and total comprehensive income for the period attributable to the owners of the Company decreased by approximately 65.6% from approximately HK\$3.2 million for the three months ended 30 September 2018 to approximately HK\$1.1 million for the Relevant Period. Such decrease was primarily attributable to the decrease in gross profit as discussed above for the Relevant Period.

BUSINESS REVIEW AND OUTLOOK

The Group is principally engaged in general building works and specialised building works in Hong Kong. The Group takes up the building works by tendering on project basis.

The general building works undertaken by the Group refer to the construction works performed by the Group at construction sites for residential buildings, commercial buildings, industrial buildings and general superstructure erection, and also include (i) erection of architectural superstructures, and (ii) renovation, fitting out, alteration and addition works. The Group also undertakes specialised building works, which comprise demolition, site formation and foundation works.

In the current riot in Hong Kong, the Directors hold a prudence view in the property market in Hong Kong, which will significantly affect the business of the Group.

The Directors will not take risks to take up some non-profitable building works contracts and will pursue a business strategy plan which involves identifying and taking up projects with reasonable yield. On the other hand, the Directors will evaluate and balance the risks and returns for each potential investment opportunity so as to broaden the business scope and to maximize the returns for the shareholders. On 8 August 2019, we have entered into a joint venture to carrying out the business of the development and gardening of land in Sai Kung, New Territories, Hong Kong, which could provide an opportunity for the Group to integrate its operation from property construction service to development of land and operating leisure paradise. Looking forward, we will continue to explore new business and investment opportunities that may broaden the business scope of the Group for diversification of risk and also may generate additional return to the shareholders of the Group.

During the Relevant Period, neither the Company nor any of its subsidiaries has purchased, sold or redeemed any of the Company's listed securities.

CORPORATE GOVERNANCE CODE

The Company's corporate governance practices are based on the principles and code provisions as set out in the Corporate Governance Code and Corporate Governance Report (the "**CG Code**") in Appendix 15 of the GEM Listing Rules.

The Company had not complied with Provision A.2.1 of the Corporate Governance Code as set out in Appendix 15 of the GEM Listing Rules as Mr. Kwok Tung Kwok ("**Mr. Kwok**") was both the Chairman and Chief Executive Officer of the Company. Mr. Kwok has resigned as the Chief Executive Officer of the Company with effect from 9 August 2019 in order to comply with the relevant provision and Mr. Ko Chun Hay Kelvin ("**Mr. Ko**") has been appointed as the Chief Executive Officer of the Company with effect from 9 August 2019 and will remain as an executive Director of the Company.

Save as disclosed, during the Relevant Period, the Company has complied with the applicable code provisions of the Corporate Governance Code (the "**CG Code**") as set out in Appendix 15 of the GEM Listing Rules.

CODE OF CONDUCT REGARDING SECURITIES TRANSACTIONS BY DIRECTORS

The Group has adopted a code of provisions of conduct regarding securities transactions by the Directors (the "**Code of Conduct**") on terms no less exacting than the required standards of dealings concerning securities transactions by the Directors as set out in Rules 5.48 to 5.67 of the GEM Listing Rules. Having made specific enquiries with the Directors, all Directors have confirmed that they have complied with the required standards set out in the Code of Conduct during the Relevant Period.

DIVIDEND

The Board did not recommend the payment of an interim dividend for the Relevant Period (2018: Nil).

SHARE OPTION SCHEME

The shareholders of the Company approved and adopted the Share Option Scheme by way of written resolutions on 9 March 2016. 36,100,000 share options were outstanding as at 30 September 2019.
