Characteristics of GEM of The Stock Exchange of Hong Kong Limited (the "Exchange")

GEM has been positioned as a market designed to accommodate small and mid-sized companies to which a high investment risk may be attached than other companies listed on the Exchange. Prospective investors should be aware of the potential risks of investing in such companies and should make the decision to invest only after due and careful consideration.

Given that the companies listed on GEM are generally small and mid-sized companies, there is a risk that securities traded on GEM may be more susceptible to high market volatility than securities traded on the Main Board and no assurance is given that there will be a liquid market in the securities traded on GEM.

香港聯合交易所有限公司(「聯交所」) GEM的特色

GEM的定位,乃為中小型公司提供一個上市的市場,此等公司相比起其他在主板上市的公司帶有較高投資風險。有意投資的人士應了解投資於該等公司的潛在風險,並應經過審慎周詳的考慮後方作出投資決定。

由於GEM上市的公司普遍為中小型公司,在GEM買賣的證券可能會較在主板買賣的證券承受較大的市場波動風險,同時無法保證在GEM買賣的證券會有高流通量的市場。



Mr. Lau Hon Kwong, Vincent, aged 56, is an Executive Director, Chief Executive Officer and one of the founders of the group. He is responsible for overall strategic planning and management of the group. With over 33 years of experience in the executive management, he was engaged in China trade before founding the group. Mr. Lau graduated from The University of Hong Kong with a first class honours Degree of Bachelor of Science in Mechanical Engineering. He holds a number of invention patents and has led many research and development projects under the funding schemes of the Innovation Technology Commission of Hong Kong Government. He is the industrial advisors to the Engineering Departments of The City University of Hong Kong and The University of Hong Kong.

Mr. Cheng Kwok Hung, aged 57, is an Executive Director and one of the founders of the group. He is responsible for technical management and research and development (R&D). Management of the group has continued to utilise our professional and committed workforce and financial resources to achieve maximum return to our shareholders.

Business Review

We are in times of sadness and difficulty. Our founding member Dr. Lee Peng Fei, Allen ("Dr. Lee"), an independent non-executive director of the company, chairman of the audit committee, remuneration committee and nomination committee of the company, passed away on 15 May 2020. It is our deepest sorrow and regret for Dr. Lee's passing and losing a valuable member of the board. Dr. Lee was a man of highest integrity and honesty, he was sincere, farsighted and a good example for people. He has made total commitment to the establishment of core values and good governance of the company since his joining us in 2000. We express our deepest gratitude for the efforts and contribution made by Dr. Lee to the company, and we shall miss him and his lifelong contribution to society!

The COVID-19 pandemic has been causing fatal damages to Hong Kong and the world. To support the fight against it and better protect the lives of people of Hong Kong, we are developing an advanced technological solution for the detection/diagnosis/surveillance of COVID-19 and the reduction of the risk of its infection and spread in our communities. We aim to adopt and integrate various information and communication technologies, sensors and wireless technologies, informatics software development and big data analytics, together with our R&D outcome product, mobilized high capacity lithium battery system, which can provide zero local emission clean power for high temperature steam cleansing and dry ice blasting for public facilities so as to enhance the public health mechanism.

During the year, we were awarded with a number of new contracts and orders by clients. The orders covered the supply of hardware and software and the provision of professional services to build up or enhance their application systems.

業務回顧

我們正經歷哀痛和困難的時刻。本公司創始成員,獨立非執行董事、兼審核委員會、薪酬委員會及提名委員會主席李鵬飛博士(「李博士」)於二零二零年五月十五日與世長辭。我們對於李博士的離世及失去這位備受尊敬的董事會成員深表痛惜!李博士正直誠實、待人真摯、提攜後輩、胸襟廣闊、高瞻遠足,是為人的好榜樣。自二零零零年加入本公司至今,一直致力為本集團建立核心價值和良好管治作出重大貢獻,我們向李博士致以最崇高的謝意!我們永遠懷念他和他服務公司及畢生貢獻社會的愛港心!

「2019冠狀病毒病」全球流行對香港及世界造成致命衝擊和傷害。為了支援對抗疫情和保護香港市民的生命和健康,我們正積極開發先進的科技解決方案用以檢測、診斷、監視「2019冠狀病毒病」,和降低其感染和在社區傳播的風險。我們旨在採用及集成各種信息技術、傳感器技術、信息軟件和大數據分析,加上我們的研發成果產品,移動式高容量鋰電池系統,使用該系統為公共環境和設施提供零排放清潔能源的高量蒸汽清洗和乾冰噴破應用,以增強公共衛生機制。

年內,我們從客戶群獲取多份新合約。合約包括提供硬件、軟件及相關的專業服務以建設或擴容現有智能系統應 用平臺。

We continued to deliver the self-service payment kiosks for public hospitals and clinics of the Hospital Authority. The kiosks were launched and put into usage to effectively enhance the public service. We also provided professional services for the Leisure and Cultural Services Department to launch the city's third self-service library station at the Tai Wai MTR Station in February 2020, offering users round-the-clock public library services with enhanced convenience and accessibility. We were very pleased to complete the delivery of this smartcity system and applications and serve the general public.

我們繼續為「醫院管理局」轄下所有公營醫院及診所交付自助繳費服務站。自助繳費服務站投入服務能有效地加強公共服務。於二零二零年二月,我們為「康樂及文化事務署」在港鐵大圍站推出第三個自助圖書站,為市民提供全天候、更便利及無障礙的公共圖書借還服務。我們深感高興為客戶及公眾實現智慧城市的公共服務。

We successfully designed, built and implemented a One-Megawatt hour lithium battery system to support the off-grid energy consumption of nearly 10,000 sets of on-street parking meters of the Transport Department under the Contract for Management, Operation and Maintenance of existing Parking Meter System. By end of March 2020, the adoption of rechargeable lithium battery packs saved the landfill disposal of more than 200,000 pieces of D-size alkaline battery cell. We estimate that total 400,000 pieces of D-size alkaline battery cell can be saved every year. The servicing mileages of environmental vehicle fleet established for the contract exceeded 190,000 km by end of March 2020. The environment and people of Hong Kong have been benefit through the zero local emission of air pollutants and greenhouse gases, sustainability is one of ITE's core values, we shall strive for a better Hong Kong and a better world.

根據現有泊車咪錶收費系統的管理、營運及維護合約,我們成功設計、建造並實施了一個一兆瓦時的可充放鋰電池應用系統,以支援「運輸署」近一萬套泊車咪錶的離網耗能。截至二零年三月底,採用可充放鋰電池組已節省了超過二十萬顆D型鹼性電池的廢置處理。我們估計每年可以節省約四十萬顆D型鹼性電池的耗量及廢置處理。截至二零二零年三月底,為該合約建立的電動車隊的服務里程已超過十九萬公里。本地空氣污染物和溫室氣體的排放得以減低使香港的環境及市民受益。可持續發展是本集團的核心價值之一,我們定會為更美好香港和世界而努力。

Future Prospect

Since our establishment, we have been focusing on our core business and technologies, we continue to devote our efforts and resources for the long term growth of the group building on our *Innovation, Technology and Excellency*; three words which best explain ITE.

All members performed professionally under the corporate vision, mission and core values. Every year, new intellectual assets are created, accumulated and protected, and the range of professional services continues to expand to meet the fast growing needs of the changing world. We have firmly maintained our position as the pure rider to provide innovative solutions to our clients.

展望

本集團成立至今,我們的目標及承諾仍然堅定不移,持續 專注核心業務及致力創新,全力落實長遠發展的目標,正 如集團的名稱「ITE」以「**創新、科技、優才**」清晰表述了企 業的座右銘。

專業的管理團隊帶領集團所有成員堅守企業宗旨、目標及 核心價值。年復年,不斷加強建立及累積自主知識資產, 為新增速的市場提供最高端的專業產品和服務。我們堅守 市場定位 - 提供多功能應用方案的專業領航者。

Despite that a trade deal was signed between China and the United States of America, the Sino-US conflicts have not ended, but getting worse rather. Considering the political instability in Hong Kong and the impact of COVID-19 pandemic, the directors are not optimistic towards the outlook. It is unknown to us when and how the recovery will take place. While maintaining our spirits, commitments and efforts, the directors shall take very prudent measures in operating and developing our businesses.

儘管中國與美國已簽署了首階段貿易協議,但中美衝突並未結束,反而愈演愈烈。考慮到香港的政治動盪及「2019冠狀病毒病」全球流行的影響,董事們對前景並不樂觀。我們不知道何時以及如何得以恢復。在保持我們的承擔和努力的同時,董事們在經營及發展業務時將採取非常審慎的措施。

Key Risks and Uncertainties

The group's insurance may be insufficient to cover all losses associated with its business operations. The group maintains insurance policies against loss or damage to its office and business interruption, public liability and employees' compensation. The insurance coverage may be insufficient to cover all the risks associated with the group's business and operations in the future. In the case of an uninsured loss or a loss in excess of insured limit, including those caused by natural disasters and other events beyond the group's control, the group may be required to pay for losses, damages and liabilities out of its own funds, which could materially and adversely affect its business, financial condition and results of operations. Even if the insurance coverage is adequate to cover its direct losses, the group may need to be responsible for the indirect losses. Furthermore, claim records of the group may affect the premiums which insurance companies charge in the future.

Despite of the above, the group considers that the current insurance coverage is sufficient for its existing operation scale and the group will review its insurance policies from time to time.

Compliance with Laws and Regulations

As far as the board of directors of the company and management are aware, the group has complied in material respects with the relevant laws and regulations that have a significant impact on the business and operation of the group. During the year, there was no material breach of or non-compliance with the applicable laws and regulations by the group.

主要風險及不確定

本集團的保險可能不足以涵蓋所有與其業務營運有關的損失。本集團為其辦事處及因業務中斷而引致的損害、公眾責任及僱員補償投購保險。保險的涵蓋範圍未來可能不足以涵蓋與本集團的業務及營運有關的所有風險。倘出現未獲承保損失或損失超出承保限額(包括該等由自然災害及其他超出本集團控制範圍之外的事件所導致的損失),本集團可能需要透過其自身資金支付損失、損害賠償及負債,而這或會對其業務、財務狀況及經營業績造成重大不利影響。即使保險涵蓋範圍足以涵蓋其直接損失,本集團可能需要負責間接虧損。此外,本集團的申索紀錄可能會影響保險公司日後所收取的保費。

儘管上述,本集團認為當前保險範圍足以應付其現有業務 規模及本集團將會不時檢討保險政策。

遵守法例及規則

就董事會及管理層所知,本集團已於各重大方面遵守對本 集團業務及營運有重大影響的相關法律及規則。於年內, 本集團並無重大違反或未有遵守適用法律及規則。

Financial Performance

For the year ended 31 March 2020, the group recorded a revenue of approximately HK\$44 million, representing an increase of 79% over last year. Profits for the year attributable to owners of the company for the year ended 31 March 2020 was approximately HK\$1 million as compared to that of loss attributable to owners of the company of approximately HK\$3.5 million for last year.

Segmental Information

During the year, the group recorded an increase in revenue for about 79% when compared with last year and the group's gross profit margin slightly decreased from 30% to 29%.

The service revenue generated from core business, i.e. the provision of the smartcard systems, RFID and information technology ("IT") services and related sales, was HK\$35,204,827 (2019: HK\$14,465,650) which significantly increased by 143%. On the other hand, the income from maintenance services decreased by 11% to HK\$9,140,379 (2019: HK\$10,325,713).

The group's administrative expenses increased by 14% to HK\$11,917,737 (2019: HK\$10,421,775). Included in administrative expenses, the related share-based payment expense amounted to HK\$Nil (2019: HK\$567,000) was fully recognized during the year. In addition, the research and development cost and associated sponsorship was significant increased by 54% to HK\$2,648,888 (2019: HK\$1,718,897). Expenditure on research and development activities was totally expensed in profit or loss during the year.

During the year, the group's finance cost was HK\$858,465 (2019: HK\$510,059) which related to interest on loans from related parties and finance charges on lease liabilities.

財務表現

截至二零二零年三月三十一日止年度,本集團錄得收益約 為44,000,000港元,較去年增加79%。截至二零二零年三 月三十一日止年度的本公司擁有人應佔溢利約為1,000,000 港元,比對去年度應佔虧損約為3,500,000港元。

分部資訊

年內,本集團錄得收益較去年增加79%,而本集團邊際毛利率由30%輕微下跌至29%。

本集團的核心業務收入,即:提供智能卡系統、射頻識別系統及資訊科技服務及其相關銷售,比去年大幅增加143%至35,204,827港元(二零一九年:14,465,650港元),而在保養收入方面則下跌11%至9,140,379港元(二零一九年:10,325,713港元)。

本集團行政費用增加14%至11,917,737港元(二零一九年:10,421,775港元),行政費用包括為數零港元(二零一九年:567,000港元)以股份為基礎付款開支於年內以予確認。此外,研發成本及相關資助大幅增加54%至2,648,888港元(二零一九年:1,718,897港元),而研發開支乃於年內產生時在損益確認為開支。

年內,本集團的財務費用為858,465港元(二零一九年: 510,059港元),此仍由於關連人士借款的利息及租賃負債 的財務費用。

管理層討論及分析

Liquidity and Financial Resources

The group generally financed its operations with its internally generated cash flows and loans from related parties. At 31 March 2020, the group have loans from related parties amounted to HK\$8,800,000 (2019: HK\$11,600,000) and these loans bear interest at fixed rate of 5% (2019: 8.8%) per annum, are unsecured and repayable on demand. At 31 March 2020, the current ratio of the group was 1.59 (2019: 1.60) while the liquidity ratio was 1.49 (2019: 1.52).

The group continues to adopt a conservative approach in its treasury policy. The group strives to reduce exposure to credit risk by performing ongoing credit evaluations of the financial condition of its customers. Besides, the group's liquidity and financing arrangements are also reviewed regularly.

Taking into consideration the stringent cost control and the existing financial resources available to the group, it is believed that the group should have adequate financial resources to meet its operation, development requirements and investments in the future.

Gearing Ratio

At 31 March 2020, the gearing ratio of the group, which is calculated as the ratio of total borrowings to total equity, was 0.68 (2019: 0.97).

Treasury Policy

The group has adopted a prudent financial management approach towards its treasury policies and thus maintained a healthy liquidity position throughout the period under review. The group strives to reduce exposure to credit risk by performing ongoing credit assessments and evaluations of the financial status of its customers. To manage liquidity risk, the board closely monitors the group's liquidity position to ensure that the liquidity structure of the group's assets, liabilities and other commitments can meet its funding requirements from time to time.

資金流動性及財務資源

本集團主要以內部產生的現金流量以及關連人士借款應付其營運所需。於二零二零年三月三十一日,本集團有為數8,800,000港元(二零一九年:11,600,000港元)的關連人士借款,此借款乃無抵押、利息以5%(二零一九年:8.8%)年利率計算及應要求償還。本集團於二零二零年三月三十一日的流動比率為1.59(二零一九年:1.60),而流動現金比率則為1.49(二零一九年:1.52)。

本集團繼續採取審慎庫務政策。本集團不斷為各客戶的財政狀況進行信貸評估,致力減低所承擔的信貸風險。此外,本集團亦會定期檢討流動資金及融資安排。

於考慮嚴格成本控制及本集團現有可動用的財務資源後,本集團相信具備充裕的財務資源以應付日後的營運、發展 及投資所需。

資產負債比率

本集團的資產負債比率乃指借貸總額除以總權益的百分比。於二零二零年三月三十一日,本集團的資產負債比率為0.68(二零一九年:0.97)。

庫務政策

本集團已對其庫務政策採取審慎的財務管理方針,故在整個回顧期內維持健康的流動資金狀況。本集團致力透過進行持續的信貸評估及評估其客戶的財務狀況以降低信貸風險。為管理流動資金風險,董事會緊密監察本集團的流動資金狀況以確保本集團的資產、負債及其他承擔的流動資金結構可應付其不時的資金需求。

Significant Investments

The group had no significant investments during the year under review.

Material Acquisitions or Disposals of Subsidiaries and Affiliated Companies

During the year under review, the group had no acquisitions and disposals of subsidiaries and affiliated companies.

Employment Information

The group recognises that its staff is one of the group's most important assets. Aiming at providing competitive salary packages, the group adjusts employees' salary level in close association with the performance, qualifications and experience of individual staff as well as labour market conditions. In addition to the regular remuneration, discretionary bonus and share options may be awarded to eligible employees with reference to individual performance and the group's business performance.

The group enjoys good relations with its staff and has not experienced any disruption of operations due to major labour disputes. In addition to the remuneration as mentioned above, the group also provides fringe benefits which comply with the relevant laws and regulations of the PRC and Hong Kong including contributions to the Social Security Scheme in the PRC and the Mandatory Provident Fund Scheme in Hong Kong. Besides, the group also provides on-going training programmes for its employees to keep them abreast of the latest market trends and new technologies.

At 31 March 2020, the group had 90 (2019: 114) full-time employees, of which 90 (2019: 112) are based in Hong Kong and the rest are in Macao. Staff costs, including directors' remuneration, was approximately HK\$26 million (2019: HK\$17 million) for the year ended 31 March 2020.

僱員資料

本集團認為,員工為本集團最重要的資產。本集團的整體 目標旨在提供優厚的薪金待遇,僱員薪酬水平將按個別員 工的工作表現、學歷、經驗以及勞動市場狀況作出調整。 除基本待遇外,本集團亦會評估個別員工的工作表現及參 考本集團的業務表現向合資格僱員發放酌情花紅及授出購 股權。

本集團一向維持良好融洽的勞資關係,從未經歷任何影響業務運作的重大勞資糾紛。除上述的薪酬待遇外,本集團亦按照中國內地及香港有關法例及法規提供其他僱員福利,包括中國內地的社會保障計劃供款及香港強制性公積金計劃供款。此外,本集團亦為僱員提供持續培訓計劃,協助他們緊貼市場的最新動態及新科技。

本集團於二零二零年三月三十一日僱有90名(二零一九年:114名)全職僱員,其中包括90名(二零一九年:112名)為香港僱員,其餘則為澳門僱員。截至二零二零年三月三十一日止年度,包括董事酬金在內的僱員成本約為26,000,000港元(二零一九年:17,000,000港元)。

Charges on Group Assets

At 31 March 2020, US\$1,476,749 (equivalent to HK\$11,518,641) (2019: HK\$11,540,203) time deposit was pledged to a bank to secure certain banking facilities of a wholly-owned subsidiary of the company.

Future Plans for Material Investments

The group did not have any plans for material investment and acquisition of material capital assets as at 31 March 2020.

Exposure to Fluctuations in Exchange Rates and Related Hedges

The group's assets, liabilities, revenues and expenses are mainly denominated in HK\$, United States dollars ("US\$"), Japanese Yen ("JPY"), Macao Patacas ("MOP") and Renminbi ("RMB"). The exchange rates between HK\$, US\$, JPY, MOP and RMB have been very steady for the past few years. During the year, the group generally used the receipts from customers to pay its suppliers and meet its capital requirements. They are denominated in the local currency of the place in which the subsidiaries operate. The group does not currently engage in hedging to manage possible exchange rate risk as the group considers the cost associated with such hedging arrangements would exceed the benefits. However, management will continue to monitor the possible exposure to exchange rate risk and will take such measures as it deems prudent.

Contingent Liability

At 31 March 2020, the company did not have any contingent liability.

本集團的資產、負債、收益及開支主要以港元、美元、日元、澳門幣及人民幣為單位。港元、美元、日元、澳門幣及人民幣的匯率在過去數年表現均十分穩定。年內,本集團將一般所收客戶款項用以支付供應商及資本開支。該等收支均以附屬公司經營所在地的貨幣進行。由於本集團認為對沖安排的成本高於利益,因此本集團目前並無採取對沖措施控制潛在的匯率風險。然而,管理層會採取審慎態度,不斷監察有關情況並且在有需要時採取相應措施。

The board ensures that effective self-regulatory practices exist to protect the interests of the shareholders of the company.

The company has applied the principles and complied with all the code provisions as set out in the Corporate Governance Code (the "Code") contained in Appendix 15 of the Rules Governing the Listing of Securities on the GEM of The Stock Exchange of Hong Kong Limited (the "GEM Listing Rules") throughout the year ended 31 March 2020, save for the deviations discussed below.

Under the code provision A.2.1 stipulates that the roles of chairman and chief executive officer should be separated and should not be performed by the same individual. The division of responsibilities between the chairman and chief executive officer should be clearly established and set out in writing.

守則條文A.2.1規定主席與行政總裁的角色應有區分,並不應由一人同時兼任。主席與行政總裁之間的職責分工須清晰訂明並以書面形式列載。

Mr. Lau Hon Kwong, Vincent is both the chairman and chief executive officer of the company who is responsible for managing the board and the group's business. Mr. Lau has been both chairman and chief executive officer of the company since its incorporation. The board considers that, with the present board structure and scope of business of the group, there is no imminent need to separate the roles into two individuals as Mr. Lau is perfectly capable of distinguishing the priority of these roles in which he has been acting. However, the board will continue to review the effectiveness of the group's corporate governance structure to assess whether the separation of the positions of chairman and chief executive officer is necessary.

劉漢光先生為本公司主席兼行政總裁,負責管理董事會及本集團業務。劉先生自本公司註冊成立以來即一直擔任本公司主席兼行政總裁。董事會考慮到現有董事會的架構及本集團的業務範疇,暫時沒有迫切需要改變現狀,認為劉先生同時間擔當兩個角色,有足夠能力作出優先次序,履行任務。但是,董事會會不斷地檢討本集團企業管治架構的成效,以評估是否有分開主席與行政總裁角色的需要。

Under the code provision A.4.1 stipulates that non-executive directors should be appointed for a specific term, subject to re-election. However, the non-executive directors do not have a specific term of appointment, but are subject to rotation in accordance with the articles of association of the company. As such, the company considers that sufficient measures have been taken to serve the purpose of the code provision A.4.1 of the Code.

The company has not arranged any insurance coverage for the directors' liabilities in respect of any potential legal actions against the directors. Given the nature of the company's business, directors believe that the occurring of legal actions against the directors is very slight, and the company still can achieve excellent corporate government through various management and monitoring mechanism so as to reduce such risks, such as periodic review on the effectiveness of internal control system, clear division of duties and providing training for staffs and the management. The board will review, on a regular basis, the necessity to arrange insurance cover for potential legal actions against the directors.

Having made specific enquiry of all directors, the directors have complied with such code of conduct and the required standard of dealings throughout the year ended 31 March 2020.

Board of Directors

Board Composition

The board which currently comprises three executive directors and two independent non-executive directors, is responsible for the overall strategic planning and business development of the group. Details of the directors are set in the section "Biographical Details of Directors and Senior Management" of this report. All directors give sufficient time and attention to the affairs of the group. To the best knowledge of the board, there is no financial, business and family relationship among the members of the board except that Mr. Liu Hoi Wah is the younger brother of Mr. Lau Hon Kwong, Vincent.

The board should regularly review the contribution required from a director to perform his responsibilities to the company, and whether the director is spending sufficient time performing them.

董事會須定期檢討董事履行對本公司的責任所作出的貢獻及有否投入足夠的時間。

Independent Non-executive Directors

The independent non-executive director, Mr. Kam Hau Choi, Anthony, has been serving the board as independent non-executive director for more than nine years and has consistently demonstrated his willingness to exercise independent judgments and provide objective challenges to management. He has actively participated in board meetings and board committee meetings held during the year and has shown himself able to give constructive and independent advice to the board over significant issues. Therefore, the board considers that he remains independent, notwithstanding the length of his tenure as independent non-executive director.

All independent non-executive directors, do not have any business or significant financial interests with the group and each of them have confirmed their independence to the group pursuant to Rule 5.09 of the GEM Listing Rules. Based on the above-mentioned, the board considers that all independent non-executive directors are independent as required under the GEM Listing Rules.

Following the passing of Dr. Lee Peng Fei, Allen on 15 May 2020, the company has only two independent non-executive directors and two audit committee members which fall below the minimum number of three independent non-executive directors and three audit committee members as required under Rules 5.05 and 5.28 of the GEM Listing Rules respectively. In this regard, the company will use its best endeavor to find a suitable candidate to fill the vacancy as soon as practicable and will make further announcement upon appointment of an additional independent non-executive director and audit committee member in accordance with the GEM Listing Rules.

Board Diversity Policy

The Board has adopted the board diversity policy with a view to achieve a sustainable and balanced development of the group. In designing the Board's composition, board diversity has been considered from various aspects, including but not limited to gender, age, cultural and educational background, ethnicity, professional experience, skills, knowledge and length of service. All appointments to the board will be based on meritocracy, and candidates will be considered against objective criteria, having due regard for the benefits of diversity on the board. This diversity policy is reviewed annually by the nomination committee of the company, and where appropriate, revisions will be made with the approval from the board.

董事會多元化政策

Execution of daily operational matters is delegated to management.

All other schedules and the relevant information of each board and committee meeting are generally made available to directors or committee members at least three days in advance.

Chairman and Chief Executive Officer

The Code stipulates that the roles of chairman and chief executive officer should be separated and should not be performed by the same individual. The company did not segregate the roles of the chairman and chief executive officer. The role of the chief executive officer was performed by Mr. Lau Hon Kwong, Vincent, who was the then existing chairman of the company during the year under review. Apart from the reason of such deviation mentioned above, the board also believes that vesting the roles of both chairman and chief executive officer in the same person provides the company with strong and consistent leadership, and allows for effective and efficient planning and implementation of business decisions and strategies.

The board will periodically review the merits and demerits of such management structure and will adopt such appropriate measures as may be necessary in the future taking into consideration of the nature and extent of the group's operation.

Audit Committee

The company has established an audit committee with written terms of reference in compliance with Rules 5.28 to 5.33 of the GEM Listing Rules. The audit committee comprises two independent non-executive directors, Mr. Kam Hau Choi, Anthony (being the chairman of the audit committee) and Mr. Wong Wang Fat, Andrew. As mentioned above, following the passing of Dr. Lee Peng Fei, Allen, the number of audit committee member has fall below the minimum number as required under Rule 5.28 of the GEM Listing Rules and the company will find a suitable candidate to fill the vacancy as soon as practicable.

The primary duties of the audit committee are to review the company's annual report and accounts, half-yearly report and quarterly reports and to provide advices and comments thereon to the board. The audit committee meets at least four times a year with management to review the accounting principles and practices adopted by the group and to discuss auditing, financial reporting matters, internal control and also risk management system. The principal terms of reference includes, inter alia, its relationship with the company's external auditor, review of the company's financial information and oversight of the financial reporting system and internal control procedures of the company.

During the year ended 31 March 2020, four audit committee meetings were held. The group's financial statements for the year ended 31 March 2020 have been reviewed by the audit committee, who is of the opinion that such statements comply with the applicable accounting standards, the GEM Listing Rules and legal requirements, and that adequate disclosures had been made.

審核委員會

根據GEM上市規則第5.28條至5.33條的規定,本公司已定明職權範圍成立了審核委員會。審核委員會由兩名獨立非執行董事,即闞孝財先生(為審核委員會主席)及黃宏發先生組成。就以上提及,隨著李鵬飛博士辭世,審核委員會成員人數少過GEM上市規則第5.28條的最少成員人數的規定,本公司將盡最大努力盡快物色適當人選以填補空缺。

審核委員會主要負責審議本公司的年報及賬目、中期業績報告及季度業績報告,以及就此向董事會提供意見及建議。審核委員會每年至少舉行四次會議,與管理層一起審議本集團所採納的會計準則及常規,並商討審核、財務申報事宜、內部監控及風險管理系統。審核委員會的主要守則條文包括,監督本公司與外聘核數師的關係,除審閱公司具體財務資料外,並檢討公司整體財務報告系統及內部監控程序。

Remuneration Committee

The company established a remuneration committee with written terms of reference in compliance with the Code. The roles and functions of the remuneration committee include the determination of the specific remuneration packages of all executive directors and senior management of the company, including benefits in kind, pension rights and compensation payments, such as any compensation payable for loss or termination of their office or appointment, and make recommendations to the board of the remuneration of non-executive directors. Members of the remuneration committee include Mr. Kam Hau Choi, Anthony, Mr. Wong Wang Fat, Andrew and Mr. Lau Hon Kwong, Vincent, with Mr. Wong Wang Fat, Andrew as chairman. A majority of the votes in the remuneration committee are exercisable by independent non-executive directors. No director will be involved in any discussion in connection with his own remuneration.

The remuneration committee schedules meet at least once a year. During the year, one remuneration committee meeting was held to review the remuneration packages of executive directors and the directors' fees of the independent non-executive directors.

Nomination Committee

The company established a nomination committee with written terms of reference in compliance with the Code. Members of the nomination committee include Mr. Kam Hau Choi, Anthony, Mr. Wong Wang Fat, Andrew and Mr. Lau Hon Kwong, Vincent, with Mr. Wong Wang Fat, Andrew as chairman.

The nomination committee shall meet before the annual general meeting of the company, or at other times as required by the chairman of the nomination committee.

The roles and functions of the nomination committee include the appointment and removal of directors, reviews the background, experience, qualification, general market conditions and the company's articles of association in selecting and recommending candidates for directorship.

薪酬委員會

Dividend Policy

The company has adopted a dividend policy, pursuant to which the company gives priority to distributing dividend in cash and shares its profits with its shareholders. The dividend payout ratio shall be determined or recommended, as appropriate, by the board at its absolute discretion after taking into account the company's financial results, future prospects and other factors, and subject to:

- the articles of association of the company;
- the applicable restrictions and requirements under the laws of the Cayman Islands;
- any banking or other funding covenants by which the company is bound from time to time;
- the investment and operating requirements of the company; and
- any other factors that have material impact on the company.

Internal Control and Risk Management

The board is responsible for the establishment, maintenance and review of the group's risk management and internal control system. To facilities the effectiveness and efficiency of operations and to ensure compliance with relevant laws and regulations, the group emphasizes on the importance of a sound internal control system which is also indispensable for mitigating the group's risk exposures. A sound and effective internal control system is designed for (i) safeguarding the interests of shareholders; (ii) safeguarding assets of the group against misappropriation; (iii) ensuring proper maintenance of accounting records for the provision of reliable financial information; and (iv) ensuring compliance with the relevant laws, regulations, and internal policies. Such system of internal control is designed to provide reasonable, but not absolute, assurance against material misstatement or loss and to manage and eliminate risks of failure in operational systems and fulfilment of the business objectives.

The internal control policies and procedures mainly cover areas of finance, operations and compliance. The company shall conduct an annual review of the internal control policies and procedures to assess its effectiveness and shall make recommendations to the board if any significant areas of concern are identified.

During the year, the board, through the audit committee, has assessed the effectiveness of the internal control system of the group including financial, operational and compliance controls and risk management functions and has considered the adequacy of resources, staff qualifications and experience, training programmes, and budget of the group's accounting and financial reporting function. The board is satisfied that, the present system of internal control is effective. The group does not have an internal audit function and does not see the need to have one.

The group's risk management and internal control systems are designed to manage rather than eliminate the risk of failure to achieve business objectives, and can only provide reasonable but not absolute assurance against material misstatement or loss. The board has the overall responsibility to maintain the adequacies of resources, staff qualifications and experience training programs and budget of accounting and financial reporting function and the board concluded that the group's risk management and internal control systems were in place and effective.

Nothing has come to its attention to cause the audit committee to believe that the non-audit services provided by the external auditors affect their independence, objectivity and effectiveness in the audit process in accordance with applicable standard.

For the year ended 31 March 2020, the fee payable to the auditors in respect of audit services amounted to HK\$399,000 while the fee payable to the auditors in respect of non-audit services relating to the taxation amounted to HK\$34,900.

Shareholders' Rights

Procedures for Shareholders to Convene an Extraordinary General Meeting and to Put Forward Proposal

There are no provisions allowing shareholders to propose new resolutions at the general meetings under the Cayman Islands Companies Law (2012 Revision). However, shareholders are requested to follow article 64 of the Articles of Association of the company, general meetings shall be convened on the written requisition of any one or more members holding at the date of deposit of the requisition not less than one-tenth of the paid up capital of the company carrying the right of voting at general meetings of the company shall at all times have the right, by written requisition to the board or the secretary of the company, to require an extraordinary general meeting to be called by the board for the transaction of any business specified in such requisition; and such meeting shall be held within two (2) months after the deposit of such requisition. If within twenty-one (21) days of such deposit the board fails to proceed to convene such meeting the requisition(s) himself (themselves) may do so in the same manner, and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the board shall be reimbursed to the requisitionist(s) by the company.

Procedures for Shareholders to Propose a Person for Election as a Director

The provisions for a shareholder to propose a person for election as a director of the company are laid down in article 113 of the company's articles of association. No person other than a director retiring at the meeting shall, unless recommended by the board for election, be eligible for election to the office of director at any general meeting unless a notice in writing of the intention to propose such person for election as a director, signed by a shareholder (other than the person to be proposed for election as a director) duly qualified to attend and vote at the meeting for which such notice is given, and a notice in writing signed by such person of his willingness to be elected shall have been lodged at the head office or at the Registration Office. The minimum length of the period during which such notices are given shall be at least seven (7) days and the period for lodgement of such notices shall commence no earlier than the day after the dispatch of the notice of the general meeting appointed for such election and end no later than seven (7) days prior to the date of such general meeting.

Procedures for Sending Enquiries to the Board

For putting forward any enquiries to the board, shareholders may send written enquiries to the company. Shareholders may send their enquiries or requests in respect of their rights to the company's principal place of business in Hong Kong.

Communication with Shareholders

The board is committed to maintaining an ongoing and transparent communication with all shareholders. The directors host annual general meeting each year to meet the shareholders and answer their enquiries. The company uses various communication channels, such as publication of annual and quarterly reports, press announcements and circulars, to update the shareholders on the group's business developments and financial performance. We procured and deployed five units of electric van to reduce as much vehicle emissions as possible. As there are no available zero emission vehicle models for the rest of the vehicle feet, the group can only make new environmental vehicle replacement in the later stage.

We regularly inspect our vehicle fleet to ensure that any damaged exhaust pipe is immediately repaired or replaced. Better fleet utilization through vehicle-sharing is also strongly encouraged.

Electricity consumption is a contribution to our greenhouse gases emission and energy footprints. The group adopts a number of energy-saving initiatives and efficiency practices to enhance the awareness for greenhouse gases emission reduction and energy saving, including:

- installing LED lighting and air-conditioning system with "Grade 1" energy label;
- encouraging employees to turn off the computers and information communication technology ("ICT") devices when not in use;
- setting office machines such as copiers and display monitors to turn-off mode automatically after office hour;

- encouraging employees to make the best use of the ICT facilities so as to avoid unnecessary travel arrangement.

We are also committed to using all kinds of resources including water efficiently and conservatively. Notwithstanding our office uses public tap water shared by the building, we are still endeavoring to change employees' mindset to gear towards environmental protection.

 Hazardous and Non-Hazardous Waste Management

The group is committed as ever to conserving precious resources by taking eco-friendly measures to reduce disposal of hazardous and non-hazardous wastes throughout our operation.

We acknowledge the fact that wasted electrical and electronic equipment are the fastest growing waste materials in the world. To alleviate the problem, we aim to increase the lifespan of each computer by upgrading the hardware or software. At the same time, we promote the concept of replacing the particular depleted computer components instead of the whole computer. Reducing the replenishment rate of the computer components is not our only objective, we also send all depleted computer components to the licensed recycling collectors to lessen the environmental impact associated with electronic manufacturing from raw materials, as well as to reduce hazardous and toxic substances handled during disposal.

We continue to develop and deploy sustainable energy solutions and services for our clients, rechargeable energy products and systems had been launched and deployed for CMOM to reduce the amount of alkaline battery chemical wastes produced.

The group continuously monitors and reviews the performance and effectiveness of our appliances, replacing any out-date or inefficient systems with up-to-date energy saving technology. We have encouraged paperless workflow such as electronic document storage, material sharing and reduced administrative documentation. When using paper, employees are encouraged to use double-sided paper, black and white or recycled papers when printing or photocopying documents. It considerably improves operational efficiency while creating a paperless operation system.

Aspect A3: The Environment and Natural Resources

Regarding the operation of the group, we are not aware of any significant impacts of activities on the environment and natural resources. With the implementation of green office measures, we strive to minimize impacts on the environment and natural resources. The group will continue to implement environment-friendly practices within the operation in order to enhance sustainability.

We are one of the sponsors for The Hong Kong Polytechnic University Students' Union Chinese Orchestra ("HKPUSUCO"). HKPUSUCO was established in 1973 and is one of the oldest and largest Chinese music groups in Hong Kong's tertiary institutions. There are now about 100 members. HKPUSUCO adheres to the promotion of Chinese Music as well as the purpose of the popularization of it. The HKPUSUCO provides the Chinese musical instruments training, engagement of Chinese music performances and the opportunities for public to appreciate the performances. The Chinese Music concerts, ensembles and exchange are held, and supported by music lovers each time.

Colleagues and friends of us continued to support social caring activities. We participated in the "Charity Walk 2020 - Take a Step, Save a Life!" of Suicide Prevention Services ("SPS"), this annual featured event was scheduled to be held in Tai Tam Country Park on Saturday, 15 February 2020 to achieve the fund-raising target. Due to the outbreak of the COVID-19 epidemic, the Charity Walk was cancelled. All donations will be used in SPS services for serving people of ages in Hong Kong who are suicidal, in despair or emotionally distressed by befriending them, and offering services to help them to regain control of their emotions and find the will to carry on.

We have been participating in ORBIS Pin Campaign since 2006. Our colleagues wore the Pins on 10 October, 2019 to embrace ORBIS's mission in support of World Health Organization's World Sight Day. Established in 1982, ORBIS is working to eradicate preventable blindness in impoverished nations worldwide. Long-term eye care programs that increase local surgical skills, facilities and eye health awareness have helped restore sight to over 6.8 million needlessly blind people to date.

We were also awarded the "Caring Company Logo" by The Hong Kong Council of Social Welfare for more than ten years.

During the year, we welcomed more than twenty interns joining the group. They came from The Hong Kong Polytechnic University, The City University of Hong Kong, The Chinese University of Hong Kong, Royal Melbourne Institute of Technology, Hong Kong Shue Yan University and Vocational Training Council with different disciplines ranging from computing, electronic, information, accounting, electrical and mechanical engineering. We have been supporting internship program for university undergraduates since 2006 assisting more than 180 students to gain solid experience and knowledge in their fields through taking actual work responsibilities.

We have been collaborating with the key universities and institutes in Hong Kong since our incorporation. Donations were also made as encouragement to the universities in the pursuit of greater excellence. We are honored to be the Principal Members of the City University of Hong Kong Foundation.

Health and Safety

We are in compliance with the Occupational Safety and Health Ordinance by ensuring that all employees are working in a safe environment. We develop and adopt health and safety policies, including prohibition of smoking in workplace, abuse of alcohol and drugs, identification and prevention of risks and hazards in working area, and follow-up actions for accidents or personal injuries. Such policies are set out in our Employee Handbook for our employees to comply with. We also update the health and safety policies from time to time to ensure that the policies are best fit to our business.

First-aid kits and fire-fighting devices and equipment are provided and easily identified in the premises for case of injuries and emergencies.

Fire protection system that best fits our needs for simplicity, reliability and ease of maintenance is established. We appoint a registered fire service contractor to carry out the annual works or the provision of or improvement on fire service installations and equipment. Numbers of fire extinguishers for water and carbon dioxide, fire sand and fire blanket, emergency lighting and exit sign have been installed and tested by the fire service contractor annually. We conduct fire drills and use of equipment every year.

During the year, we achieved zero work-related fatalities and lost 243 working mandays (2019: 62) due to work injury.

Training and Job Rotation

As the demand for skills and talent specific to our businesses continues to increase, competition poses the risk of employee turnover. We address this risk by providing our employees with training opportunities and competitive benefits, creating loyalty while cultivating their professional development.

Every new joiner will be provided with proper orientation training and mentoring in order to help them adapt to the new working environment affirmatively and quickly. Continuous trainings are also committed by us in different ways including on-the-job training, comprehensive training for specific skill development and professional training for relevant employees. Each department is also responsible for setting and developing their own training programmes not only to meet the specific business requirements, but also to build up the on-going skills and career development of our staff. Job rotation opportunity is given to help advance personal development and facilitate employee substitutions. Both the management and employee work together to identify the department and position suitable for a job rotation.

Labour Standards

We comply with all relevant laws and regulations that have significant impacts on us relating to the prevention of use of child and forced labour. We do not accept any forms of forced labour service. We also prohibit employing child labour at any working place under any circumstances. We inspect applicant's documents and qualifications strictly during the recruitment process to ensure that all relevant laws in respect thereof are complied with.

Employees sign written confirmation to (i) confirm that all intellectual property rights created or made during their employment shall be vested in the group; and (ii) agree not to use or disclose the confidential information without authorization or approval.

Anti-corruption

We establish a strong internal control to institute a vigorous enforcement regime against corruption and fraud. Strong anti-corruption and anti-fraud culture is a vital part of the overall governance framework of the us. We are committed to mobilize resources to safeguard the assets and ultimate interests of our shareholders.

ESG risks within our supply chain are addressed through strict procurement processes and contractual requirements. We maintain a list of preferred suppliers so as to ensure reliable and effective delivery of the products and services we require.

As at 31 March 2020, trade receivables and contract assets were significant to the group, amounted to an aggregate total of HK\$8,060,418, represented 25% of the total assets of the group.

In addition, the group's accounting policy for impairment was based on a forward-looking expected credit loss ("ECL") approach.

The provision matrix measurement of ECL requires the application of significant management judgement. Management considers specific factors such as historical observed default rates, forecast economic conditions and the age of the balances. Management uses this information to calibrate the matrix to determine the amount of impairment.

This area would be focused on because it requires a high level of management judgement and the amounts involved are material.

1 General information

ITE (Holdings) Limited (the "company") is incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law of the Cayman Islands. The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands. The address of the principal place of business of the company and its operating subsidiaries is Units C & D, 1st Floor, Por Yen Building, 478 Castle Peak Road, Kowloon, Hong Kong.

The company's shares are listed on the GEM of The Stock Exchange of Hong Kong Limited (the "Exchange").

The consolidated financial statements for the year ended 31 March 2020 comprise the company and its subsidiaries (collectively referred to as the "group").

The company is an investment holding company. The principal activities of its subsidiaries are set out in note 34.

2 Significant accounting policies

(a) Statement of compliance

These consolidated financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. These consolidated financial statements also comply with the applicable disclosure provisions of the Rules Governing the Listing of Securities on the GEM of the Exchange (the "GEM Listing Rules").

(a) 合規聲明

此等綜合財務報表乃根據所適用的香港財務報告準則編製。此統稱詞彙包括香港會計師公會頒佈的所有適用的個別香港財務報告準則、香港會計準則及詮釋、香港公認會計原則及香港公司條例的披露規定。此等綜合財務報表亦符合聯交所《GEM證券上市規則》(「GEM上市規則」)的適用披露條文。

(a) Statement of compliance (continued)

The HKICPA has issued certain new and revised HKFRSs that are first effective or available for early adoption for the current accounting period of the group. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the group for the current and prior accounting periods reflected in the consolidated financial statements.

A summary of the significant accounting policies adopted by the group is set out below.

(b) Basis of preparation of the consolidated financial statements

The measurement basis used in the preparation of the consolidated financial statements is the historical cost basis except that financial assets at fair value through profit or loss are stated at their fair values as explained in accounting policy set out in note 2(k).

The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), except where indicated otherwise, which is also the functional currency of the company.

The preparation of consolidated financial statements in conformity with HKFRSs requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgements about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

(a) 合規聲明(續)

香港會計師公會已頒佈若干新訂及經修訂的香港財務報告準則,並於本集團的本期會計期間首次生效或可供提早採納。附註3提供有關首次應用有關發展所引致的會計政策變動的資料,惟只限於有關本集團於綜合財務報表內所反映本會計期間及以前會計期間者。

本集團採用的重大會計政策概要載列如下。

(b) 綜合財務報表的編製準則

除透過損益按公允值處理的金融資產以公允值列賬外(其詳細於會計政策附註2(k)),本綜合財務報表均以歷史成本為編製基準。

除非另有説明,否則綜合財務報表均以港元(亦即本公司的實用貨幣)的單位列報。

所編製符合香港財務報告準則的綜合財務報表,要求管理層就可影響政策應用以資產、負債、收入及開支的呈報金額作出判斷、估計及假設。有關估計及相關假設乃根據過往經驗,以及多項在此情況下相信屬合理的其他因素而作出,有關結果構成對未能在其他資料來源顯示的資產及負債的賬面作出判斷的基礎。實際結果可能與有關估計有所不同。

(b) Basis of preparation of the consolidated financial statements (continued)

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgements made by management in the application of HKFRSs that have significant effect on these consolidated financial statements and major sources of estimation uncertainty are discussed in note 36.

(c) Subsidiaries

Subsidiaries are entities controlled by the group. The group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the group has power, only substantive rights (held by the group and other parties) are considered.

An investment in a subsidiary is consolidated into the consolidated financial statements from the date that control commences until the date that control ceases. Intra-group balances and transactions and any unrealised profits arising from intra-group transactions are eliminated in full in preparing the consolidated financial statements. Unrealised losses resulting from intra-group transactions are eliminated in the same way as unrealised gains but only to the extent that there is no evidence of impairment.

In the company's statement of financial position, an investment in a subsidiary is stated at cost less impairment losses (see note 2(l) (ii)). The results of subsidiaries are accounted for by the company on the basis of dividend received or receivable.

(c) 附屬公司

附屬公司乃本集團控制的實體。本集團可控制一實體,通過參予該實體從而享有不同回報的權利或風險及運用其控制權以影響回報金額。當考慮本集團是否有控制權是指持有主要權益(本集團及其他人士持有)。

附屬公司於投資獲擁有控制權日期起被合併入綜合 財務報表,直至該控制權終止時結束。集團內部往 來的結餘和交易及其產生的任何未變現溢利,均在 編製綜合財務報表內全數抵銷。在無出現減值的情 況下,集團內部交易所產生的未變現虧損,會按與 未變現收益相同的方法抵銷。

本公司的財務狀況表內,於附屬公司的投資按成本減去減值虧損列賬(見附註2(I)(ii))。附屬公司的業績乃由本公司按已收或應收股息列賬。

(d) Associate

An associate is an entity in which the group or company has significant influence, but not control or joint control, over its management, including participation in the financial and operating policy decisions.

An investment in an associate is accounted for in the consolidated financial statements under the equity method. Under the equity method, the investment is initially recorded at cost, adjusted for any excess of the group's share of the acquisition-date fair values of the associate's identifiable net assets over the cost of the investment (if any). Thereafter, the investment is adjusted for the post acquisition change in the group's share of the associate's net assets and any impairment loss relating to the investment (see note 2(l)(ii)). Any acquisition-date excess over costs, the group's share of the post-acquisition, post tax results of the associate and any impairment losses for the year are recognised in profit or loss, whereas the group's share of post-acquisition post tax items of the investee's other comprehensive income is included in the group's other comprehensive income in the consolidated statement of profit or loss and other comprehensive income.

When the group's share of losses exceeds its interest in the associate, the group's interest is reduced to nil and recognition of further losses is discontinued except to the extent that the group has incurred legal or constructive obligations or made payments on behalf of the associate. For this purpose, the groups' interest in the associate is the carrying amount of the investment under the equity method together with the group's long-term interests that in substance form part of the group's net investment in the associate.

Unrealised profits and losses resulting from transactions between the group and its associate are eliminated to the extent of the group's interest in the associate, except where unrealised losses provide evidence of an impairment of the asset transferred, in which case they are recognised immediately in profit or loss.

(d) 聯營公司

當本集團所佔虧損超出聯營公司權益,本集團的權益將減至零,除非本集團有法定或建設性義務或代替其支付,其未來虧損將不再確認。為此,本集團的權益以權益法及本集團的長遠利益作為事實根據,於本集團淨聯營投資以其投資賬面值列賬。

(e) Goodwill

Goodwill represents the excess of

- (i) the aggregate of the fair value of the consideration transferred, the amount of any non-controlling interest in the acquiree and the fair value of the group's previously held equity interest in the acquiree; over
- (ii) the net fair value of the acquiree's identifiable assets and liabilities measured as at the acquisition date.

When (ii) is greater than (i), then this excess is recognised immediately in profit or loss as a gain on a bargain purchase.

Goodwill is stated at cost less accumulated impairment losses. Goodwill arising on a business combination is allocated to each cash-generating unit, or groups of cash generating units, that is expected to benefit from the synergies of the combination and is tested annually for impairment (see note 2(I)(ii)).

On disposal of a cash-generating unit during the year, any attributable amount of purchased goodwill is included in the calculation of the profit or loss on disposal.

(f) Property, plant and equipment

Property, plant and equipment are stated in the consolidated statement of financial position at cost less accumulated depreciation and impairment losses (see note 2(l)(ii)).

At inception of a contract, the group assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

At the lease commencement date, the group recognises a right-of-use asset and a lease liability, except for short-term leases that have a lease term of 12 months or less and leases of low-value assets. When the group enters into a lease in respect of a low-value asset, the group decides whether to capitalise the lease on a lease-by-lease basis. The lease payments associated with those leases which are not capitalised are recognised as an expense on a systematic basis over the lease term.

Where the lease is capitalised, the lease liability is initially recognised at the present value of the lease payments payable over the lease term, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, using a relevant incremental borrowing rate. After initial recognition, the lease liability is measured at amortised cost and interest expense is calculated using the effective interest method. Variable lease payments that do not depend on an index or rate are not included in the measurement of the lease liability and hence are charged to profit or loss in the accounting period in which they are incurred.

The right-of-use asset recognised when a lease is capitalised is initially measured at cost, which comprises the initial amount of the lease liability plus any lease payments made at or before the commencement date, and any initial direct costs incurred. Where applicable, the cost of the right-of-use assets also includes an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, discounted to their present value, less any lease incentives received. The right-of-use asset is subsequently stated at cost less accumulated depreciation and impairment losses (see notes 2(f) and 2(l)(iii)).

Where the group acquired the use of assets under finance leases, the amounts representing the fair value of the leased asset, or, if lower, the present value of the minimum lease payments, of such assets were recognised as property, plant and equipment and the corresponding liabilities, net of finance charges, were recorded as obligations under finance leases. Depreciation was provided at rates which wrote off the cost or valuation of the assets over the term of the relevant lease or, where it was likely the group would obtain ownership of the asset, the life of the asset, as set out in note 2(f). Impairment losses were accounted for in accordance with the accounting policy as set out in note 2(l) (ii). Finance charges implicit in the lease payments were charged to profit or loss over the period of the leases so as to produce an approximately constant periodic rate of charge on the remaining balance of the obligations for each accounting period.

Where the group had the use of assets held under operating leases, payments made under the leases were charged to profit or loss in equal instalments over the accounting periods covered by the lease term, except where an alternative basis was more representative of the pattern of benefits to be derived from the leased asset. Lease incentives received were recognised in profit or loss as an integral part of the aggregate net lease payments made.

(h) Inventories

Inventories are carried at the lower of cost and net realisable value.

Cost is calculated using the first-in, first-out cost formula and comprises all costs of purchase, costs of conversion and other costs incurred in bringing the inventories to their present location and condition.

Net realisable value is the estimated selling price in the ordinary course of business less the estimated costs of completion and the estimated costs necessary to make the sale.

When inventories are sold, the carrying amount of those inventories is recognised as an expense in the period in which the related revenue is recognised. The amount of any write-down of inventories to net realisable value and all losses of inventories are recognised as an expense in the period the write-down or loss occurs. The amount of any reversal of any write-down of inventories is recognised as a reduction in the amount of inventories recognised as an expense in the period in which the reversal occurs.

(i) Trade and other receivables

A receivable is recognised when the group has an unconditional right to receive consideration. A right to receive consideration is unconditional if only the passage of time is required before payment of that consideration is due. If revenue has been recognised before the group has an unconditional right to receive consideration, the amount is presented as a contract asset (see note 2(j)).

Receivables are stated at amortised cost using the effective interest method less allowance for credit losses (see note 2(l)(i)).

(i) Contract assets and contract liabilities

A contract asset is recognised when the group recognises revenue (see note 2(u)) before being unconditionally entitled to the consideration under the payment terms set out in the contract. Contract assets are assessed for expected credit losses ("ECLs") in accordance with the policy set out in note 2(l)(i) and are reclassified to receivables when the right to the consideration has become unconditional (see note 2(i)).

A contract liability is recognised when the customer pays consideration before the group recognises the related revenue (see note 2(u)). A contract liability would also be recognised if the group has an unconditional right to receive consideration before the group recognises the related revenue. In such cases, a corresponding receivable would also be recognised (see note 2(i)).

For a single contract with the customer, either a net contract asset or a net contract liability is presented. For multiple contracts, contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

(k) Financial assets at fair value through profit or loss

Financial assets at fair value through profit or loss ("FVTPL") are either investments classified as held for trading or designated as at fair value through profit or loss upon initial recognition. These investments are subsequently measured at fair value. Gains or losses arising from changes in fair value of these investments are recognised in profit or loss.

(I) Credit losses and impairment of assets

(i) Credit losses from financial instruments and contract assets

The group recognises a loss allowance for ECLs on the following items:

- financial assets measured at amortised cost (including cash and cash equivalents, pledged bank deposits, amount due from an associate and trade and other receivables); and
- contract assets as defined in HKFRS 15 (see note 2(j));

Measurement of ECLs

ECLs are a probability-weighted estimate of credit losses. Credit losses are measured as the present value of all expected cash shortfalls (i.e. the difference between the cash flows due to the group in accordance with the contract and the cash flows that the group expects to receive).

The expected cash shortfalls are discounted using the following discount rate where the effect of discounting is material:

 fixed-rate financial assets, trade and other receivables and contract assets: effective interest rate determined at initial recognition or an approximation thereof.

The maximum period considered when estimating ECLs is the maximum contractual period over which the group is exposed to credit risk.

In measuring ECLs, the group takes into account reasonable and supportable information that is available without undue cost or effort. This includes information about past events, current conditions and forecasts of future economic conditions.

Measurement of ECLs (continued)

ECLs are measured on either of the following bases:

- 12-month ECLs: these are losses that are expected to result from possible default events within the 12 months after the reporting date; and
- lifetime ECLs: these are losses that are expected to result from all possible default events over the expected lives of the items to which the ECL model applies.

Loss allowances for trade receivables and contract assets are always measured at an amount equal to lifetime ECLs. ECLs on these financial assets are estimated using a provision matrix based on the group's historical credit loss experience, adjusted for factors that are specific to the debtors and an assessment of both the current and forecast general economic conditions at the reporting date.

For all other financial assets, the group recognises a loss allowance equal to 12-month ECLs unless there has been a significant increase in credit risk of the financial instrument since initial recognition, in which case the loss allowance is measured at an amount equal to lifetime ECLs.

Significant increase in credit risk

In assessing whether the credit risk of a financial instrument has increased significantly since initial recognition, the group compares the risk of default occurring on the financial instrument assessed at the reporting date with that assessed at the date of initial recognition. In making this reassessment, the group considers that a default event occurs when the borrower is unlikely to pay its credit obligations to the group in full, without recourse by the group to actions such as realising security (if any is held). The group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly since initial recognition:

- failure to make payments of principal or interest on their contractually due dates;
- an actual or expected significant deterioration in a financial instrument's external or internal credit rating (if available);
- an actual or expected significant deterioration in the operating results of the debtor; and
- existing or forecast changes in the technological, market, economic or legal environment that have a significant adverse effect on the debtor's ability to meet its obligation to the group.

Significant increase in credit risk (continued)

Depending on the nature of the financial instruments, the assessment of a significant increase in credit risk is performed on either an individual basis or a collective basis. When the assessment is performed on a collective basis, the financial instruments are grouped based on shared credit risk characteristics, such as past due status and credit risk ratings.

ECLs are remeasured at each reporting date to reflect changes in the financial instrument's credit risk since initial recognition. Any change in the ECL amount is recognised as an impairment gain or loss in profit or loss. The group recognises an impairment gain or loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

Basis of calculation of interest income

Interest income recognised in accordance with note 2(u)(vi) is calculated based on the gross carrying amount of the financial asset unless the financial asset is credit-impaired, in which case interest income is calculated based on the amortised cost (i.e. the gross carrying amount less loss allowance) of the financial asset.

At each reporting date, the group assesses whether a financial asset is credit-impaired. A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of the financial asset have occurred.

Basis of calculation of interest income (continued)

Evidence that a financial asset is credit-impaired includes the following observable events:

- significant financial difficulties of the debtor;

- significant changes in the technological, market, economic or legal environment that have an adverse effect on the debtor; or
- the disappearance of an active market for a security because of financial difficulties of the issuer.

Write-off policy

The gross carrying amount of a financial asset or contract asset is written off (either partially or in full) to the extent that there is no realistic prospect of recovery. This is generally the case when the group determines that the debtor does not have assets or sources of income that could generate sufficient cash flows to repay the amounts subject to the write-off.

Subsequent recoveries of an asset that was previously written off are recognised as a reversal of impairment in profit or loss in the period in which the recovery occurs.

Calculation of recoverable amount

In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of time value of money and the risks specific to the asset. Where an asset does not generate cash inflows largely independent of those from other assets, the recoverable amount is determined for the smallest group of assets that generates cash inflows independently (i.e. a cash-generating unit).

An impairment loss is recognised in profit or loss if the carrying amount of an asset, or the cash-generating unit to which it belongs, exceeds its recoverable amount. Impairment losses recognised in respect of cash-generating units are allocated first to reduce the carrying amount of any goodwill allocated to the cash-generating unit (or group of units) and then, to reduce the carrying amount of the other assets in the unit (or group of units) on a pro rata basis, except that the carrying value of an asset will not be reduced below its individual fair value less costs of disposal (if measurable) or value in use (if determinable).

Reversals of impairment losses

In respect of assets other than goodwill, an impairment loss is reversed if there has been a favourable change in the estimates used to determine the recoverable amount. An impairment loss in respect of goodwill is not reversed.

A reversal of an impairment loss is limited to the asset's carrying amount that would have been determined had no impairment loss been recognised in prior years. Reversals of impairment losses are credited to profit or loss in the year in which the reversals are recognised.

(m) Income tax

Income tax for the year comprises current tax and movements in deferred tax assets and liabilities. Current tax and movements in deferred tax assets and liabilities are recognised in profit or loss except to the extent that they relate to items recognised in other comprehensive income or directly in equity, in which case the relevant amounts of tax are recognised in other comprehensive income or equity, respectively.

Current tax is the expected tax payable on the taxable income for the year, using tax rates enacted or substantively enacted at the end of the reporting period, and any adjustment to tax payable in respect of previous years.

Deferred tax assets and liabilities arise from deductible and taxable temporary differences respectively, being the differences between the carrying amounts of assets and liabilities for financial reporting purposes and their tax bases. Deferred tax assets also arise from unused tax losses and unused tax credits.

Apart from certain limited exceptions, all deferred tax liabilities, and all deferred tax assets to the extent that it is probable that future taxable profits will be available against which the asset can be utilised, are recognised. Future taxable profits that may support the recognition of deferred tax assets arising from deductible temporary differences include those that will arise from the reversal of existing taxable temporary differences, provided those differences relate to the same taxation authority and the same taxable entity, and are expected to reverse either in the same period as the expected reversal of the deductible temporary difference or in periods into which a tax loss arising from the deferred tax asset can be carried back or forward. The same criteria are adopted when determining whether existing taxable temporary differences support the recognition of deferred tax assets arising from unused tax losses and credits, that is, those differences are taken into account if they relate to the same taxation authority and the same taxable entity, and are expected to reverse in a period, or periods, in which the tax loss or credit can be utilised.

The limited exceptions to recognition of deferred tax assets and liabilities are those temporary differences arising from goodwill not deductible for tax purposes, the initial recognition of assets or liabilities that affect neither accounting nor taxable profit (provided they are not part of a business combination), and temporary differences relating to investments in subsidiaries to the extent that, in the case of taxable differences, the group controls the timing of the reversal and it is probable that the differences will not reverse in the foreseeable future, or in the case of deductible differences, unless it is probable that they will reverse in the future.

The amount of deferred tax recognised is measured based on the expected manner of realisation or settlement of the carrying amount of the assets and liabilities, using tax rates enacted or substantively enacted at the end of the reporting period. Deferred tax assets and liabilities are not discounted.

The carrying amount of a deferred tax asset is reviewed at the end of each reporting period and is reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the related tax benefit to be utilised. Any such reduction is reversed to the extent that it becomes probable that sufficient taxable profits will be available.

Additional income taxes that arise from the distribution of dividends are recognised when the liability to pay the related dividends is recognised.

Current tax balances and deferred tax balances, and movements therein, are presented separately from each other and are not offset. Current tax assets are offset against current tax liabilities, and deferred tax assets against deferred tax liabilities, if the company or the group has the legally enforceable right to set off current tax assets against current tax liabilities and the following additional conditions are met:

- in the case of current tax assets and liabilities, the group or the company intends either to settle on a net basis, or to realise the asset and settle the liability simultaneously; or
- in the case of deferred tax assets and liabilities, if they relate to income taxes levied by the same taxation authority on either:
 - the same taxable entity; or
 - different taxable entities, which, in each future period in which significant amounts of deferred tax liabilities or assets are expected to be settled or recovered, intend to realise the current tax assets and settle the current tax liabilities on a net basis or realise and settle simultaneously.

(n) Cash and cash equivalents

Cash and cash equivalents comprise cash at bank and on hand, demand deposits with banks and other financial institutions, and short-term, highly liquid investments that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, having been within three months of maturity at acquisition. Cash and cash equivalents are assessed for ECLs in accordance with the policy set out in note 2(l) (i)

(o) Trade and other payables

Trade and other payables are initially recognised at fair value. Except for financial guarantee liabilities measured in accordance with note 2(r)(i), trade and other payables are subsequently stated at amortised cost unless the effect of discounting would be immaterial, in which case they are stated at cost.

(p) Share capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of new shares or options are shown in equity as a deduction, net of tax, from the proceeds.

(q) Interest-bearing borrowings

Interest-bearing borrowings are measured initially at fair value less transaction costs. Subsequent to initial recognition, interest-bearing borrowings are stated at amortised cost using the effective interest method. Interest expense is recognised in accordance with the group's accounting policy for borrowing costs (see note 2(t)).

(r) Financial guarantees issued, provisions and contingent liabilities

(i) Financial guarantees issued

Financial guarantees are contracts that require the issuer (i.e. the guarantor) to make specified payments to reimburse the beneficiary of the guarantee (the "holder") for a loss the holder incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument.

Possible obligations, whose existence will only be confirmed by the occurrence or non-occurrence of one or more future events are also disclosed as contingent liabilities unless the probability of outflow of economic benefits is remote.

Foreign currency transactions during the year are translated at the foreign exchange rates ruling at the transaction dates. Monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at the end of the reporting period. Exchange gains and losses are recognised in profit or loss.

Non-monetary assets and liabilities that are measured in terms of historical cost in a foreign currency are translated using the foreign exchange rates ruling at the transaction dates. Non-monetary assets and liabilities denominated in foreign currencies that are stated at fair value are translated using the foreign exchange rates ruling at the dates the fair value was measured.

The results of foreign operations are translated into HK\$ at the exchange rates approximating the foreign exchange rates ruling at the dates of the transactions. Items of statement of financial positions are translated into HK\$ at the closing foreign exchange rates ruling at the end of the reporting period. The resulting exchange differences are recognised in other comprehensive income and accumulated separately in equity in the exchange reserve.

On disposal of a foreign operation, the cumulative amount of the exchange differences relating to that foreign operation is reclassified from equity to profit or loss when the profit or loss on disposal is recognised.

(t) Borrowing costs

Borrowing costs that are directly attributable to the acquisition, construction or production of an asset which necessarily takes a substantial period of time to get ready for its intended use or sale are capitalised as part of the cost of that asset. Other borrowing costs are expensed in the period in which they are incurred.

(u) Revenue and other revenue

Income is classified by the group as revenue when it arises from the sale of goods, the provision of services or the use by others of the group's assets under leases in the ordinary course of the group's business.

Revenue is recognised when control over a product or service is transferred to the customer at the amount of promised consideration to which the group is expected to be entitled, excluding those amounts collected on behalf of third parties. Revenue excludes value added tax or other sales taxes and is after deduction of any trade discounts.

Further details of the group's revenue and other revenue recognition policies are as follows:

(i) Service revenue

Service revenue comprises revenue from smartcard systems, radio frequency identification ("RFID"), information technology ("IT") and related service contracts.

When the outcome of a service contract can be reasonably measured, revenue from the contract is recognised progressively over time using the cost-to-cost method, based on the proportion of the actual costs incurred relative to the estimated total costs.

The likelihood of the group earning contractual bonuses for early completion or suffering contractual penalties for late completion are taken into account in making these estimates, such that revenue is only recognised to the extent that it is highly probably that a significant reversal in the amount of cumulative revenue recognised will not occur.

When the outcome of the service contract cannot be reasonably measured, revenue is recognised only to the extent of contract costs incurred that are expected to be recovered.

Income from maintenance and management services is recognised on a straight-line basis over the term of the maintenance and management services contracts.

Income received or receivable in respect of maintenance services which have not been completed on or before the end of the reporting period are shown in the consolidated statement of financial position as deferred maintenance income.

Revenue is recognised at a point in time the control of the goods has transferred and when the customer takes possession of and accepts the products.

(iv) Government sponsorship income

Government sponsorship income is recognised when the group complies with the conditions attaching to the sponsorship and the income is received.

Dividend income from listed investments is recognised when the share price of the investment goes ex-dividend.

Interest income is recognised as it accrues using the effective interest method. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the financial asset (see note 2(l) (i)).

Salaries, annual bonuses, paid annual leave, contributions to defined contribution retirement plans and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees. Where payment or settlement is deferred and the effect would be material, these amounts are stated at their present values.

(ii) Termination benefits

Termination benefits are recognised when, and only when, the group demonstrably commits itself to terminate employment or to provide benefits as a result of voluntary redundancy by having a detailed formal plan which is without realistic possibility of withdrawal.

For share options granted under the 2011 Scheme per note 28, the fair value of share options granted to employees is recognised as an employee cost with a corresponding increase in a share option reserve within equity. HKFRS 16. Leases

HKFRS 16 replaces HKAS 17, Leases, and the related interpretations, HK(IFRIC) 4, Determining whether an arrangement contains a lease, HK(SIC) 15, Operating leases – incentives, and HK(SIC) 27, Evaluating the substance of transactions involving the legal form of a lease. It introduces a single accounting model for lessees, which requires a lessee to recognise a right-of-use asset and a lease liability for all leases, except for leases that have a lease term of 12 months or less ("short-term leases") and leases of low-value assets. The lessor accounting requirements are brought forward from HKAS 17 substantially unchanged.

HKFRS 16 also introduces additional qualitative and quantitative disclosure requirements which aim to enable users of the financial statements to assess the effect that leases have on the financial position, financial performance and cash flows of an entity.

The group has initially applied HKFRS 16 as from 1 April 2019. The group has elected to use the modified retrospective approach and has therefore recognised the cumulative effect of initial application as an adjustment to the opening balance of equity at 1 April 2019. Comparative information has not been restated and continues to be reported under HKAS 17.

Further details of the nature and effect of the changes to previous accounting policies and the transition options applied are set out below:

(i) New definition of a lease

The change in the definition of a lease mainly relates to the concept of control. HKFRS 16 defines a lease on the basis of whether a customer controls the use of an identified asset for a period of time, which may be determined by a defined amount of use. Control is conveyed where the customer has both the right to direct the use of the identified asset and to obtain substantially all of the economic benefits from that use.

香港財務報告準則第16亦引入額外定性及定量披露 規定,旨在令財務報表使用者得以評估租賃對實體 財務狀況、財務業績及現金流量的影響。

本集團已自二零一九年四月一日起首次應用香港財務報告準則第16號。本集團已選用經修訂追溯法,並因而確認首次應用的累積影響作為對於二零一九年四月一日權益期初結餘的調整。比較資料未被重列且繼續根據香港會計準則第17號呈報。

(i) New definition of a lease (continued)

The group applies the new definition of a lease in HKFRS 16 only to contracts that were entered into or changed on or after 1 April 2019. For contracts entered into before 1 April 2019, the group has used the transitional practical expedient to grandfather the previous assessment of which existing arrangements are or contain leases. Accordingly, contracts that were previously assessed as leases under HKAS 17 continue to be accounted for as leases under HKFRS 16 and contracts previously assessed as non-lease service arrangements continue to be accounted for as executory contracts.

(ii) Lessee accounting and transitional impact

HKFRS 16 eliminates the requirement for a lessee to classify leases as either operating leases or finance leases, as was previously required by HKAS 17. Instead, the group is required to capitalise all leases when it is the lessee, including leases previously classified as operating leases under HKAS 17, other than those short-term leases and leases of low-value assets which are exempt. As far as the group is concerned, these newly capitalised leases are primarily in related to property, plant and equipment as disclosed in note 31. For an explanation of how the group applies lessee accounting, see note 2(g).

At the date of transition to HKFRS 16 (i.e. 1 April 2019), the group determined the length of the remaining lease terms and measured the lease liabilities for the leases previously classified as operating leases at the present value of the remaining lease payments, discounted using the relevant incremental borrowing rates at 1 April 2019. The weighted average of the incremental borrowing rates used for determination of the present value of the remaining lease payments was 4%.

(iii) Impact on financial result and cash flows of the group

After the initial recognition of right-of-use assets and lease liabilities as at 1 April 2019, the group as a lessee is required to recognise interest expense accrued on the outstanding balance of the lease liability, and the depreciation of the right-of-use asset, instead of the previous policy of recognising rental expenses incurred under operating leases on a straight-line basis over the lease term. 27 Employee retirement benefits

The group operates a Mandatory Provident Fund Scheme (the "MPF scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance for employees employed under the jurisdiction of the Hong Kong Employment Ordinance and not previously covered by the defined benefit retirement plan. The MPF scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF scheme, the employer and its employees are each required to make contributions to the plan at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000. Contributions to the plan vest immediately.

The subsidiary operating in the PRC is required to participate in a defined contribution retirement scheme, organised by relevant government authorities for the staff in the PRC. The subsidiary is required to make contributions to the retirement scheme at specified rates of the basic salary of its employees in the PRC.

The group's retirement scheme contributions charged to profit or loss for the year were HK\$953,840 (2019: HK\$537,013).

28 Share option scheme

The company operates the 2011 Scheme for the purpose of providing incentives and rewards to eligible participants who contribute to the success of the group's operations. Eligible participants of the 2011 Scheme include the company's directors, including independent non-executive directors, other employees of the group, suppliers of goods or services to the group, customers of the group, advisers and consultants, etc. The 2011 Scheme became effective on 8 August 2011 and, unless otherwise cancelled or amended, will remain in force for 10 years from that date.

The application of the share premium account is governed by the company's Articles of Association and the Companies Law of the Cayman Islands, which provides that the share premium account may be applied in making distributions or paying dividends to members, provided that immediately following the date on which distribution or dividend is proposed to be paid, the company will be able to pay its debts as they fall due in the ordinary course of business. The share premium may also be distributed in the form of fully paid bonus shares.

(ii) Merger reserve

The group's merger reserve represents the excess of the aggregate of the nominal value of the share capital of the subsidiaries acquired pursuant to the group reorganisation completed on 18 November 2000 on the nominal value of the share capital of the company issued in exchange therefor.

(iii) Exchange reserve

The exchange reserve comprises all foreign exchange differences arising from the translation of the financial statements of foreign operations. The reserve is dealt with in accordance with the accounting policies set out in note 2(s).

(iv) Share option reserve

This reserve represents the fair value of the actual or estimated number of unexercised share options granted to eligible persons, including any director, employee, consultant or advisor of the company and its subsidiaries or any associate of the company, recognised in accordance with the accounting policies in note 2(v) (iii).

(c) Distributability of reserves

At 31 March 2020 and 2019, none of the reserves of the company is available for distribution to owners of the company, except for the reserve as stated in note 29(b)(i).

(d) Capital management

The group's primary objectives when managing capital are to safeguard the group's ability to continue as a going concern, so that it can continue to provide returns for owners and benefits for other stakeholders, by pricing products and services commensurately with the level of risk and by securing access to finance at a reasonable cost.

The group actively and regularly reviews and manages its capital structure to maintain a balance between the higher owner returns and the advantages and security afforded by a sound capital position, and makes adjustments to the capital structure in light of changes in economic conditions.

The group monitors its capital structure on the basis of a net debt-to-adjusted capital ratio. For this purpose, the group defines net debt as total debt (which includes loans from related parties, lease liabilities and trade and other payables) plus unaccrued proposed dividends, less cash and cash equivalents and pledged deposits. Adjusted capital comprises all components of equity less unaccrued proposed dividends.

During the year, the group's strategy, which was unchanged from 2019, was to maintain the net debt-to-adjusted capital ratio below 50%. In order to maintain or adjust the ratio, the group may adjust the amount of dividends to be paid to owners, issue new shares, return capital to owners, raise new debt financing or sell assets to reduce debt.

Exposure to credit, liquidity, interest rate and currency risks arises in the normal course of the group's business. These risks are limited by the group's financial management policies and practices described below.

(a) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in a financial loss to the group. The group's credit risk is primarily attributable to cash at banks, trade receivables and contract assets. The group's exposure to credit risk arising from cash and cash equivalents is limited because the counterparties are banks of good credit-rating for which the group considers to have low credit risk.

Trade receivables and contract assets

The group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry or country in which the customers operate and therefore significant concentrations of credit risk primarily arise when the group has significant exposure to individual customers. At the end of the reporting period, 57% (2019: 59%) and 84% (2019: 90%) of the total trade receivables and contract assets was due from the group's largest customer and the five largest customers respectively.

Individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customer's past history of making payments when due and current ability to pay, and take into account information specific to the customer as well as pertaining to the economic environment in which the customer operates. Trade receivables are generally due within 30 to 45 days from the date of billing. Negotiated on a case-by-case basis, the credit terms granted to certain customers could be up to three months. Normally, the group does not obtain collateral from customers.

The group measures loss allowances for trade receivables and contract assets at an amount equal to lifetime ECLs, which is calculated using a provision matrix. As the group's historical credit loss experience does not indicate significantly different loss patterns for different customer segments, the loss allowance based on past due status is not further distinguished between the group's different customer bases.

The directors of the company have considered the credit risk of trade receivables and contract assets and note that there was no actual loss nor significant past due experience over the past 5 years, including periods of unfavourable economic conditions. The directors consider the aggregate risks arising from the possibility of credit loss on trade receivables and contract assets are not significant and no allowance for credit losses were made as at 31 March 2020 and 2019.

(b) Liquidity risk

The group's policy is to maintain sufficient cash and cash equivalents or have available funding through an adequate amount of committed annual credit facilities from banks to meet its commitments over the next year in accordance with its strategic plan. In the opinion of the directors of the company, the group expects to have adequate sources of funding to finance the group and manage the liquidity position.

(c) Interest rate risk

The group's interest rate risk arises primarily from its loans payable and lease liabilities, which are at fixed rate, expose the group to fair value interest risk. The group does not use financial derivatives to hedge against the interest rate risk.

The group's significant interest-bearing assets are bank deposits. The group's interest income is dependent on changes in market interest rates and will not have significant adverse impact on the group's financial position.

A reasonably possible change of 100 basis points in interest rates would have no significant impact on the group's financial performance and equity for both current and prior year.

36 Accounting estimates and judgements

The management had made the following estimates and assumptions in the process of applying the group's accounting policies, which are described in note 2, that have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities as discussed below.

(a) Revenue and profit recognition

As explained in policy note 2(u), revenue from service contracts are recognised over time. The revenue and profit recognition on uncompleted projects is dependent on estimating the total outcome of the contract, as well as the work done to date. Based on the group's recent experience and the nature of the service activities undertaken by the group, the group has made estimates of the point at which it considered the work was sufficiently advanced such that the outcome of the contract can be reasonably measured. Until this point is reached the related contract assets disclosed in note 25(a) do not include profit which the group might eventually realise from the work done to date. In addition, actual outcomes in terms of total cost or revenue may be higher or lower than estimated at the end of the reporting period, which would affect the revenue and profit recognised in future years as an adjustment to the amounts recorded to date.

(b) Property, plant and equipment and depreciation

The group determines the estimated useful lives and related depreciation charges for the group's property, plant and equipment. This estimate is based on the historical experience of the actual useful lives of property, plant and equipment of a similar nature and function.

(c) Provision for expected credit losses of trade receivables and contract assets

The group uses a provision of matrix to calculate ECLs for trade receivables and contract assets. The provision rates are based on days past due for groupings of various debtors that have similar loss patterns. The provision matrix is based on management's estimate of the lifetime expected credit losses to be incurred, which is estimated by taking into account the credit loss experience, ageing of overdue trade receivables, customers' repayment history and customers' financial position and an assessment of both the current and forecast general economic conditions, all of which involve a significant degree of management judgement.

(c) Provision for expected credit losses of trade receivables and contract assets (continued)

The provision of ECLs is sensitive to changes in circumstances and involves the forecast of general economic conditions. The information about the ECLs and the group's trade receivables and contract assets are disclosed in notes 17 and 25(a) respectively. If the financial condition of the customers or the forecast economic conditions were to deteriorate, actual loss allowance would be higher than estimated.

(d) Write-down of inventories

Write-down of inventories is made based on the ageing and estimated net realisable value of inventories. The assessment of the write-down amount involves judgement and estimates. Where the actual outcome in future is different from the original estimate, such difference will impact the carrying value of inventories and the write-down amount charge/reverse in the period in which such estimate has been changed.

(e) Deferred tax

Estimating the amount for deferred tax assets arising from tax losses requires a process that involves forecasting future years' taxable income and assessing the group's ability to utilise tax benefits through future earnings. Where the actual future profits generated are more or less than expected, a recognition or reversal of the deferred tax assets may arise, which would be recognised in profit or loss for the period in which such a recognition or reversal takes place. While the current operations indicate that the unused tax losses cannot be utilised in the future, any changes in assumptions, estimates and tax regulations can affect the recoverability of this unrecognised deferred tax asset.

(c) 貿易應收款項及合約資產的預期信 貸虧損撥備(續)
