# NOTES TO THE CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

#### 1. General Information

OOH Holdings Limited (the "**Company**") was incorporated in the Cayman Islands on 28 June 2016 as an exempted company with limited liability under the Companies Law, Cap 22 (Law 3 of 1961, as revised and consolidated) of the Cayman Islands and its shares had been listed on GEM of The Stock Exchange of Hong Kong Limited (the "**Stock Exchange**") since 5 January 2017. The address of its registered office is located at Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman, KY1-1111, Cayman Islands and its principal place of business is located at Suite A5, 9/F, Jumbo Industrial Building, 189 Wai Yip Street, Kwun Tong, Kowloon, Hong Kong.

The principal activity of the Company (together with its subsidiaries as the "**Group**") is investment holding. The Group is principally engaged in the provision of advertising display services.

### 2. Basis of Preparation

The unaudited condensed consolidated financial statements of the Group for the three months period ended 30 June 2020 have not been audited by the Company's auditor, but have been reviewed by the audit committee of the Company. They have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("**HKFRSs**"), Hong Kong Accounting Standards ("**HKASs**") and Interpretations (hereinafter collectively referred to as the "**HKFRS**") issued by the Hong Kong Institute of Certified Public Accountants ("**HKICPA**") and the disclosure requirements of the Hong Kong Companies Ordinance. In addition, the unaudited condensed consolidated financial statements also comply with the applicable disclosure requirements under the GEM Listing Rules.

The unaudited condensed consolidated financial statements are presented in Hong Kong Dollars ("**HK\$**"), which is the same as the functional currency of the Company.

### 3. Adoption of HKFRSs

#### Adoption of new or revised HKFRSs - effective from 1 April 2020

In the current period, the Group has applied the following amendments to HKFRSs issued by the HKICPA which are mandatory effective for the annual period beginning on or after 1 January 2020 for the preparation of the Group's unaudited condensed consolidated financial statements.

#### Amendments to HKFRS 3 — Definition of a Business

The amendments clarify that a business must include, as a minimum, an input and a substantive process that together significantly contribute to the ability to create outputs, together with providing extensive guidance on what is meant by a "substantive process".

Additionally, the amendments remove the assessment of whether market participants are capable of replacing any missing inputs or processes and continuing to produce outputs, whilst narrowing the definition of "outputs" and a "business" to focus on returns from selling goods and services to customers, rather than on cost reductions.

An optional concentration test has also been added that permits a simplified assessment of whether an acquired set of activities and assets is not a business.

#### Amendments to HKAS 1 and HKAS 8 - Definition of Material

The amendments clarify the definition and explanation of "material", aligning the definition across all HKFRS Standards and the Conceptual Framework, and incorporating supporting requirements in HKAS 1 into the definition.

## Amendments to HKFRS 9, HKAS 39 and HKFRS 7 — Interest Rate Benchmark Reform

The amendments modify some specific hedge accounting requirements to provide relief from potential effects of the uncertainties caused by interest rate benchmark reform. In addition, the amendments require companies to provide additional information to investors about their hedging relationships which are directly affected by these uncertainties.

## Amendments to HKFRS 10 and HKAS 28 – Sale or Contribution of Assets between an Investor and its Associate or Joint Venture

The amendments clarify the extent of gains or losses to be recognised when an entity sells or contributes assets to its associate or joint venture. When the transaction involves a business the gain or loss is recognised in full, conversely when the transaction involves assets that do not constitute a business the gain or loss is recognised only to the extent of the unrelated investors' interests in the joint venture or associate.

#### Amendments to HKFRS 16 - COVID-19 - Related Rent Concessions

The amendment exempts lessees from having to consider individual lease contracts to determine whether rent concessions occurring as a direct consequence of the COVID-19 pandemic are lease modifications and allows lessees to account for such rent concessions as if they were not lease modifications.

The Group is not yet in a position to state whether these new pronouncements will result in substantial changes to the Group's accounting policies and consolidated financial statements.

#### **Segment Information**

An operating segment is a component of the Group that is engaged in business activities from which the Group may earn revenue and incur expenses, and is defined on the basis of the internal management reporting information that is provided to and regularly reviewed by the executive directors in order to allocate resources and assess performance of the segment.

The executive directors considered the business from the perspective of advertising platforms available, and determined that the Group has the following reportable operating segments:

- Provision of advertising display services over the transportation media platforms ("Transportation Business");
- Provision of advertising display services over the healthcare media platforms ("Healthcare Business");
- Provision of advertising display services over the digital and online media platforms ("Digital Media Business");
- Provision of advertising display services over the self-pickup lockers platforms ("Logistic Advertising Business"); and

 Sales of Mizimamei branded food and beverage products in Hong Kong ("Food and Beverage Business").

#### Segment revenue and results

Segment revenue below represents revenue from external customers. There was no inter-segment revenue during the reporting periods. The chief operating decision makers assess the performance of the operating segments mainly based on revenue and gross profit of each operating segment. Corporate and other unallocated expenses include selling expenses, administrative expenses and other expenses which are common costs incurred for the operating segments as a whole and therefore they are not included in the measure of the segments' performance that is used by the chief operating decision makers as a basis for the allocation of resources and assessment of segment performance. Other income and gains, net, finance costs and income tax expense are also not allocated to individual operating segment.

There were no segment assets and liabilities information provided to the chief operating decision makers.

The Group companies incorporated in the Cayman Islands and the British Virgin Islands are taxexempted as no business is carried out in the Cayman Islands and the British Virgin Islands under the laws of the Cayman Islands and the British Virgin Islands respectively.

Hong Kong Profits Tax is calculated at 8.25% on the first HK\$2 million of estimated assessable profits and at 16.5% for the portion of the estimated assessable profits above HK\$2 million for the three months period ended 30 June 2020 and 2019.

No deferred tax has been recognized as there were no material temporary differences for the three months period ended 30 June 2020 and 2019.

The weighted average of 720,000,000 ordinary shares for the three months period ended 30 June 2020 and 2019 were same as the number of ordinary shares of the Company in issue throughout the period.

Diluted loss per share was the same as the basic loss per share as the Group had no potential dilutive ordinary shares during the three months period ended 30 June 2020 and 2019.

Basic and diluted loss per share was HK\$0.04 cents for the three months period ended 30 June 2020 (2019: loss of HK\$0.13 cents).

#### 9. Dividend

The Board does not recommend a payment of an interim dividend for the three months period ended 30 June 2020 (for the three months period ended 30 June 2019: Nil).

## **MANAGEMENT DISCUSSION AND ANALYSIS**

## **Business Review**

The Group continued its principal business in the provision of out-of-home advertising spaces and services to its customers, which comprise end users aiming to promote their brands, products or services, and advertising agents acting for such advertisers. We also offer our customers design and production, advertisement logistics, installation and dismantling services on the different advertising platforms.

During the period under review, minibus advertising, being the Group's principal business, recorded an increase in gross profit margin from 32.8% for the three months period ended 30 June 2019 to 36.3% for that of 2020. Although the business environment was seriously affected by the outbreak of COVID-19, the Group has grasped the opportunity to negotiate concessions on license fee during the difficult period of time. Apart from concessions on license fee, the Group has also taken the opportunity to review and eliminate the exclusive advertising spaces with unsatisfactory performance so as to maximize the margin of that segment.

As disclosed in the Company's annual report for the year ended 31 March 2020, the provision of esports event management services ("**Digital Event Management Business**") has been terminated on 31 May 2019 due to the business restructuring of the principal operating the esports event management facilities in Taiwan.

While Digital Media Business has not generated any revenue for the three months period ended 30 June 2020, the Group considers the segment has good prospects. The Group will restructure and reallocate operational and human resources from our traditional outdoor media to the digital media segment. The Group will continue to explore and recruit the right candidates to lead Digital Media Business.

On the other hand, the Group's retail outlet of Mizimamei branded food and beverage products has commenced business in August 2019. Undoubtedly, Food and Beverage Business was seriously affected by the outbreak of COVID-19. Our retail outlet targets take away orders and does not offer dine-in service so even the Hong Kong government has strengthened control on the number of customers in the restaurants and to prohibit dine-in service at a certain period of time, the Group's retail outlet of Mizimamei branded food and beverage products maintained a steady growth in revenue since its grand opening. The Group will continue to use its unsold outdoor media assets to promote the Mizimamei branded food and beverage products. With the increased demands on take away orders, the Group will continue to cooperate with take away service vendors and online ordering applications to cater the customer's demand.

## **Financial Review**

#### Revenue

Total revenue of the Group decreased by 30.1% from approximately HK\$17.9 million for the three months period ended 30 June 2019 to approximately HK\$12.5 million for that of 2020. Such decrease was mainly due to (i) the decrease of revenue generated from Digital Event Management Business which has been terminated on 31 May 2019; and (ii) the decrease of revenue generated from Digital Media Business.

Revenue generated from minibus advertising decreased by 4.9% from approximately HK\$12.4 million for the three months period ended 30 June 2019 to approximately HK\$11.8 million for that of 2020. Revenue generated from Logistic Advertising Business remained insignificant and decreased from approximately HK\$0.2 million for the three months period ended 30 June 2019 to approximately HK\$0.1 million for that of 2020. Revenue generated from the provision of other types of advertising services (for example advertising spaces in other out-of-home media formats) decreased by HK\$0.2 million for the three months period ended 30 June 2020 as compared to that of 2019. Such decrease was mainly due to the fact that the business environment was seriously impacted by the outbreak of COVID-19 that advertisers were tight in budget. Some advertisers requested to cancel the advertising contracts or to shift the advertising budget to a later period when the business environment is recovered. The Group shall continue to monitor the business environment and make necessary adjustments to cater the challenging environment.

No revenue was generated from Digital Media Business during the period under review as compared to a revenue of approximately HK\$2.2 million for the three months period ended 30 June 2019 due to the resignation of the sales directors responsible for that segment. The Group has been looking for the right candidates to lead the development of this segment.

Revenue generated from private hospital and clinics remained insignificant and decreased from approximately HK\$0.2 million for the three months period ended 30 June 2019 to approximately HK\$0.1 million for that of 2020.

Revenue generated from Food and Beverage Business was approximately HK\$0.2 million during the period under review. No revenue for this segment was recorded for the three months period ended 30 June 2019 as the business only commenced in August 2019.

Due to the termination of Digital Event Management Business in May 2019, there was no revenue contribution from Digital Event Management Business during the period under review.

### **Cost of Sales and Gross Profit Margin**

Cost of sales decreased by 35.9% from approximately HK\$12.9 million for the three months period ended 30 June 2019 to approximately HK\$8.2 million for that of 2020. The decrease was mainly due to (i) the decrease in cost of sales for Digital Media Business and Digital Event Management Business which recorded no revenue during the period under review; (ii) the decrease of license fee in the minibus advertising due to the license fee concessions during the outbreak of COVID-19; and (iii) the increase of the Group's in-house printing facilities which led to the decrease of printing and production cost of our minibus advertising business.

The gross profit margin increased by 5.9 percentage points from approximately 28.2% for the three months period ended 30 June 2019 to approximately 34.1% for that of 2020, which was mainly due to the increase in gross profit margin of minibus advertising from approximately 32.8% for the three months period ended 30 June 2019 to approximately 36.3% for that of 2020 due to the decrease of license fee in the minibus advertising as a result of the license fee concessions during the outbreak of COVID-19 and the Group's effort in trimming down the exclusive advertising spaces with unsatisfactory performance.

#### Selling Expenses

Selling expenses decreased from approximately HK\$2.9 million for the three months period ended 30 June 2019 to approximately HK\$1.4 million for that of 2020 due to (i) the decrease of overseas travelling expenses and marketing expenses in relation to the outbreak of COVID-19 that overseas travelling was avoided and business activities has been put on halt; and (ii) the decrease of commission paid to our sales team for Digital Media Business.

## **Administrative Expenses**

Administrative expenses increased from approximately HK\$3.5 million for the three months period ended 30 June 2019 to approximately HK\$3.8 million for that of 2020. The increase was mainly due to an increase of consultancy fee of approximately HK\$0.3 million.

## **Finance Costs**

Finance costs was decreased from approximately HK\$0.6 million for the three months period ended 30 June 2019 to approximately HK\$0.4 million for that of 2020.

## Loss Attributable to Owners of the Company

As a result, we recorded loss attributable to owners of the Company of approximately HK\$0.3 million for the three months period ended 30 June 2020 as compared to approximately HK\$1 million for that of 2019.

## Outlook

Despite sharing a border with mainland China, where the first COVID-19 cases were reported, Hong Kong kept its infection numbers down and was able to avoid the extreme lockdown measures introduced in parts of China, Europe and the US in early 2020. In recent weeks, Hong Kong has been hit by not even a second, but a third, wave of infections. The Hong Kong government has warned its hospital system could face collapse, and it had recorded high number of new infections since early of July 2020.

Undoubtedly, the third wave of the pandemic outbreak has once again brought negative impact to our local economy. We have received requests from advertisers asking for discounts during the pandemic period and also requests for delaying payment for the time being. Pursuant to the urge of Hong Kong government, the Group has adopted a sensible approach to alleviate our clients in need. For instance, we offered new packages to our clients by allowing them to shift the advertising budgets to their preferred period and also a reasonable rent concession period on pre-emptive basis after the end of the contracted advertising period if the advertising space is still vacant or pending for another new advertising campaign. On the other hand, the Group shall also continue our strategy to negotiate concessions from our suppliers including but not limited to minibus operators, production units and also landlords of our office facilities.

It is obvious that the novel coronavirus may not go away and we will have to learn to live with it and adapt to the new normal. Apart from striving to develop new media platforms to strengthen our competitive edge while improving our traditional transportation business to perfection, the Group shall implement corporate social responsibilities measures including but not limited to work from home policy, provide surgical masks and hand sanitizers, flexible working hours etc. to protect our employees who are the most valuable assets of the Group.

## **Compliance with the Corporate Governance Code**

The Company is committed to achieving a high standard of corporate governance to safeguard the interests of the shareholders and enhance its corporate value. The Company's corporate governance practices are based on the principles and code provisions as set out in the Corporate Governance Code in Appendix 15 to the GEM Listing Rules (the "**CG Code**").

Throughout the three months period ended 30 June 2020, to the best knowledge of the Board, the Company had complied with the code provisions in the CG Code, save for the deviation from the code provision A.2.1 of the CG Code, as explained below:

Pursuant to the code provision A.2.1 of the CG Code, the roles of chairman and chief executive should be separate and should not be performed by the same individual. The division of responsibilities between the chairman and chief executive should be clearly established and set out in writing. Ms. Chau currently holds both positions. In view of her experience and familiarity with the business operations of the Group, the Board considers that the roles of the Chairlady and Chief Executive Officer being performed by Ms. Chau would be appropriate to maintain the efficiency in the overall strategic planning, management and business development of the Group. The Board with the corporate governance committee of the Board will continue to review the Group's corporate governance policies and compliance with the CG Code each financial year.

## **Audit Committee**

The Company established the audit committee of the Board (the "Audit Committee") with written terms of reference in compliance with Rules 5.28 and 5.29 of the GEM Listing Rules and the code provisions C.3.3 and C.3.7 of the CG Code. The Audit Committee consists of all the three independent non-executive Directors being Ms. AU Shui Ming Anna, Mr. LIANG Man Kit Jerry and Mr. LAM Yau Fung Curt. Ms. AU Shui Ming Anna serves as the chairlady of the Audit Committee who has appropriate professional qualifications and experience as required by the GEM Listing Rules. The primary responsibilities of the Audit Committee include but without limitation the following: (i) assisting the Board in providing an independent view of the effectiveness of the Group's financial reporting system, internal control and risk management systems; (ii) overseeing the audit process; and (iii) performing other duties and responsibilities as assigned by the Board.

The Audit Committee has discussed and reviewed the unaudited condensed consolidated financial statements of the Group for the three months period ended 30 June 2020 and this report.
