# NOTES TO THE CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

### 1. GENERAL INFORMATION

The Company was incorporated in the Cayman Islands as an exempted company with limited liability and its shares were listed on GEM of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) on 5 September 2018.

The Company is an investment holding company. The Company and its subsidiaries (collectively referred to as the “Group”) are principally involved in the provision of freight forwarding and related logistics services and provision of warehousing and related value-added services.

The condensed consolidated financial statements are presented in Hong Kong dollar (“HK dollar” or “HK\$”), which is also as the functional currency of the Company.

### 2. BASIS OF PREPARATION

The condensed consolidated financial statements have been prepared on the historical cost basis.

The condensed consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standard (“HKFRSs”) issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”) as well as with the applicable disclosure requirements of Chapter 18 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “GEM Listing Rules”).

Other than changes in accounting policies resulting from the application of new and amendments to HKFRSs, the accounting policies and methods of computation used in the condensed consolidated financial statements for the three months ended 30 June 2020 are the same as those followed in the preparation of the Group’s consolidated financial statements for the year ended 31 March 2020.

### 1. 一般資料

本公司為於開曼群島註冊成立的獲豁免有限公司，其股份於二零一八年九月五日在香港聯合交易所有限公司（「聯交所」）GEM上市。

本公司為投資控股公司。本公司及其附屬公司（統稱為「本集團」）主要從事提供貨運代理及相關物流服務以及提供倉儲及相關增值服務。

簡明綜合財務報表以港元（「港元」）呈列，港元亦為本公司的功能貨幣。

### 2. 編製基準

簡明綜合財務報表乃根據歷史成本基準編製而成。

簡明綜合財務報表乃根據香港會計師公會（「香港會計師公會」）頒佈的香港財務報告準則（「香港財務報告準則」）及香港聯合交易所有限公司GEM證券上市規則（「GEM上市規則」）第十八章之適用披露規定編製。

除因應用新訂及經修訂香港財務報告準則而產生的會計政策變動外，截至二零二零年六月三十日止三個月的簡明綜合財務報表所採用的會計政策及計算方法與編製本集團截至二零二零年三月三十一日止年度的綜合財務報表所遵循者相同。

On 21 March 2018, the Hong Kong Legislative Council passed The Inland Revenue (Amendment) (No. 7) Bill 2017 (the "Bill") which introduced the two-tiered profits tax rates regime. The Bill was signed into law on 28 March 2018 and was gazetted on the following day. Under the two-tiered profits tax rates regime, the first HK\$2 million of profits of the qualifying group entity will be taxed at 8.25%, and profits above HK\$2 million will be taxed at 16.5%. The profits of group entities in Hong Kong not qualifying for the two-tiered profits tax rates regime will continue to be taxed at the flat rate of 16.5%.

Accordingly, the Hong Kong Profits Tax is calculated at 8.25% on the first HK\$2 million of the estimated assessable profits and at 16.5% on the estimated assessable profits above HK\$2 million.

Under the Law of the PRC on Enterprise Income Tax (the "EIT Law") and Implementation Regulation of the EIT Law, the tax rate of the PRC subsidiary is 25% for the period ended 30 June 2020.

Under the Income Tax Act of the Taiwan area, the corporate income tax rate of the Group's Taiwan branch is 20%.

# MANAGEMENT DISCUSSION AND ANALYSIS

### BUSINESS REVIEW AND OUTLOOK

Wan Leader International Limited (the “Company”) is a company which provides logistics services in and to customers mostly located in Hong Kong, the People’s Republic of China (the “PRC”) and Taiwan, with cargo destinations covering the United States of America (“USA”), Europe, Asia and other regions. The shares (the “Shares”) of the Company are listed on GEM of the Stock Exchange of Hong Kong Limited (“Stock Exchange”).

The services of the Company and its subsidiaries (the “Group”) mainly include (a) the provision of freight forwarding and related logistics services, which include reselling cargo space the Group purchases from airlines, airlines’ general sales agent(s), shipping liners and other freight forwarders to direct shippers or respective freight forwarders, which act on behalf of their shipper customers and eventually deliver the goods to the destinations; and (b) the provision of warehousing and related value-added services, which include labelling services, packaging services and security screening services.

Despite the global volatile and challenging environment in 2020, the Group made encouraging progress during the three months ended 30 June 2020 (the “Review Period”), which has been reflected in its financial results. The Group’s total revenue increased by approximately 97.0% to approximately HK\$84.5 million in the Review Period, compared with approximately HK\$42.9 million in the three months ended 30 June 2019 (the “Previous Period”). Gross profit increased by approximately 211.1% to approximately HK\$11.2 million in the Review Period, compared with HK\$3.6 million in the Previous Period. The Group turned around a net loss of approximately HK\$4.4 million in the Previous Period to a net profit of approximately HK\$4.5 million in the Review Period.

Benefiting from the opportunities of the increased demand in air cargo space amid the COVID-19 pandemic, the Group successfully secured air cargo spaces at compatible prices for its customers. The Group’s extensive network of airlines and other forwarders was able to meet the demands of its customers, particularly, the shipping of epidemic prevention supplies.

### 業務回顧及展望

萬勵達國際有限公司(「本公司」)於香港、中華人民共和國(「中國」)及台灣向大部分位處該三地的客戶提供物流服務的公司，貨運目的地覆蓋美利堅合眾國(「美國」)、歐洲、亞洲以及其他地區。本公司股份(「股份」)於香港聯合交易所有限公司(「聯交所」)GEM上市。

本公司及其附屬公司(「本集團」)的服務主要包括(a)提供貨運代理及相關物流服務，當中包括轉售本集團向航空公司、航空公司的總銷售代理、海運公司及其他貨運代理商所購買的貨運艙位予直接託運人或代表其託運人客戶行事，並最終將貨物送抵目的地的各自貨運代理商；及(b)提供倉儲及相關增值服務，當中包括標籤服務、封裝服務及安檢服務。

儘管二零二零年全球動盪及營商環境困難重重，本集團截至二零二零年六月三十日止三個月(「回顧期間」)取得令人鼓舞的成績，其已於財務業績中反映。於回顧期間，本集團的總收入增加約97.0%至約84.5百萬港元，而截至二零一九年六月三十日止三個月(「過往期間」)則為約42.9百萬港元。毛利於回顧期間增加約211.1%至約11.2百萬港元，而過往期間則為約3.6百萬港元。本集團由過往期間淨虧損約4.4百萬港元轉為回顧期間純利4.5百萬港元。

本集團受惠於COVID-19疫情期間空運艙位需求殷切的機會，成功幫助客戶以適宜的價格取得空運艙位。本集團與航空公司及其他貨運代理的廣泛網絡能夠滿足客戶需求，尤其是運送防疫用品。

The sound financial performance also demonstrates the Group's strong capability to execute business strategies and its business operation as well as the strength of its recently added security screening services. In the past couple of years, the Group invested heavily in the security screening facilities through expanding the storage area and enhancing the leasehold improvement of its warehouse. The security screening services were welcomed by the Group's customers, and resulted in a rapid increase in the transaction volume of the security screening services during the Review Period. The Group believes that the security screening services market has a high potential to be further developed.

Looking towards the future, the Group is cautious yet optimistic towards its business and development. The Group has implemented cost-control and operational efficiency measures and has explored other business collaboration opportunities in the market in order to maximise the profitability of the Group. One key area for the Group's business development is river sand shipping services in Southeast Asia. The Group has already extended its networking in identifying suitable service providers for charter sand ships. Up to the date of this report, the Group has already completed a number of transactions of delivering sand from Malaysia to the PRC. The Group hopes that the river sand shipping business can provide a stable stream of income to the Group in the future.

Due to the COVID-19 pandemic, it is estimated that there would be keen competition for air cargo space as passenger flight services have been largely suspended around the globe. The Group anticipates that the cost of air cargo space will fluctuate rapidly in the market. To maintain the profitability of the Group, the Group generally would not enter into any long term commitments with its customers, which would fix the selling price of air cargo space.

To control the cost and enhance its service quality, the Group entered into new agreements with two large local suppliers for providing drayage, transportation and palletisation services. The Group will adopt other cost cutting measures through the selection of suppliers and sub-contractors.

穩健的財務業績亦證明本集團執行業務戰略及業務運營的強大能力以及近期新增的安檢服務的實力。在過去兩年，本集團通過擴大倉儲面積以及加強租賃改良工程，對安檢設備作出重大投資。安檢服務深受本集團客戶歡迎，故安檢服務於回顧期間的交易量顯著增長。本集團相信安檢服務市場有很大潛力可進一步發展。

展望未來，本集團對業務及發展抱持審慎而樂觀的態度。本集團已實施成本控制效率措施，並在市場上探索其他業務的合作機會，藉此盡可能提高本集團的盈利能力。本集團業務發展的一個關鍵領域是東南亞的河沙船運服務。本集團已擴大其網絡以物色與運沙船出租有關的合適服務供應商。截至本報告日期，本集團已完成多項河沙由馬來西亞送抵中國的交易。本集團希望河沙船運業務能在未來為本集團提供穩定的收入來源。

鑒於COVID-19疫情，預期空運艙位競爭將會因全球客機航班服務受到嚴重耽誤而加劇。本集團預期空運艙位成本將在市場上劇烈波動。為維持本集團的盈利能力，本集團一般不會與客戶訂立任何有關固定空運艙位銷售價格的長期承諾。

為控制成本及提升服務質素，本集團與兩間本地大型供應商訂立新協議以提供運輸、交通及貨盤運輸服務。本集團將採取其他成本削減措施，如篩選供應商及分包商。

### FINANCIAL REVIEW

#### Revenue

The Group's revenue was primarily derived from (i) air freight forwarding and related logistics services; (ii) sea freight forwarding and related logistics services; and (iii) warehousing and related value-added services.

Total revenue of the Group significantly increased by approximately 97.0% from approximately HK\$42.9 million for the Previous Period to approximately HK\$84.5 million for the Review Period.

Revenue generated from air freight forwarding and related logistics services for the Review Period amounted to approximately HK\$70.0 million (Previous Period: approximately HK\$35.2 million), accounting for approximately 82.8% of the Group's total revenue (Previous Period: approximately 82.1%). The revenue from this segment remained as the major source of revenue of the Group. The Taipei branch commenced business in October 2019 and contributed a significant portion of revenue to the air freight forwarding and related logistics services during the Review Period.

Revenue generated from sea freight forwarding and related logistics services for the Review Period amounted to approximately HK\$3.7million (Previous Period: approximately HK\$1.5 million), accounting for approximately 4.4% of the Group's total revenue (Previous Period: approximately 3.5%). Most of the Group's customers from this segment are direct shippers. The revenue from sea freight forwarding and related logistics services during the Review Period increased significantly due to the resumption of the river sand shipment (the delivery of river sand for its customer from overseas to the PRC).

Revenue generated from warehousing and related value-added services for the Review Period amounted to approximately HK\$10.8 million (Previous Period: approximately HK\$6.2 million), accounting for approximately 12.8% of the Group's total revenue (Previous Period: approximately 14.4%). The revenue from this segment increased as (i) the Group offered security screening services during the Review Period (which were not available in the Previous Period); (ii) the Group was engaged for a few special projects in connection to palletisation services during the Review Period; and (iii) a long-term existing customer placed more orders to the Group.

#### 財務回顧

#### 收益

本集團的收益主要來自(i)空運代理及相關物流服務；(ii)海運代理及相關物流服務；及(iii)倉儲及相關增值服務。

本集團的總收益由過往期間的約42.9百萬港元大幅增加約97.0%至回顧期間的約84.5百萬港元。

空運代理及相關物流服務於回顧期間產生的收益約為70.0百萬港元(過往期間：約35.2百萬港元)，佔本集團總收益約82.8%(過往期間：約82.1%)。此分部的收益仍為本集團的主要收益來源。台北分支辦事處於二零一九年十月開始營運，並於回顧期間為航空貨運代理及相關物流服務帶來重大收益。

海運代理及相關物流服務於回顧期間產生的收益約為3.7百萬港元(過往期間：約1.5百萬港元)，佔本集團總收益約4.4%(過往期間：約3.5%)。本集團於此分部的大部分客戶為直接託運人。由於恢復河沙運輸(為其客戶將河沙從海外送抵中國)，海運代理及相關物流服務於回顧期間的收益大幅上升。

倉儲及相關增值服務於回顧期間產生的收益約為10.8百萬港元(過往期間：約6.2百萬港元)，佔本集團總收益約12.8%(過往期間：約14.4%)。由於(i)本集團於回顧期間提供安檢服務(過往期間並無提供安檢服務)；(ii)本集團於回顧期間接獲多個貨盤運輸服務有關的特別項目；及(iii)一名長期現有客戶向本集團下達更多訂單，導致此分部的收益有所增加。

#### Cost of services and gross profit

The Group's cost of services increased by approximately 86.5% from approximately HK\$39.3 million for the Previous Period to approximately HK\$73.3 million for the Review Period. This increase was mainly attributable to the (i) increases in the acquisition costs of air cargo spaces due to the increases in unit costs and limited supply in air cargo spaces and (ii) increase in the subcontracting charges paid to suppliers for warehousing and related value-added services.

The Group's gross profit increased by approximately 211.1% from approximately HK\$3.6 million for the Previous Period to approximately HK\$11.2 million for the Review Period. Gross profit margin increased from approximately 8.4% for the Previous Period to approximately 13.3% for the Review Period. Such increases were mainly due to the increases in gross profit and gross profit margin from the air freight forwarding and related logistics services and the warehousing and related value-added services. The gross profit margin from warehousing and related value-added services increased during the Review Period mainly because (i) the security screening services brought in additional revenue to the Group; (ii) special projects were obtained from an existing customer for palletisation services; and (iii) the transaction volume from a long-term customer increased. As for air freight forwarding and related logistics services, the main reasons for the increase in gross profit margin were due to (i) the increase in the overall selling prices of air cargo spaces, which resulted from the limited supply of air cargo spaces, coupled with surging demand from customers during the Review Period, such that the Group could command higher selling prices which ultimately improved the gross profit of the freight-forwarding and related services segment; and (ii) cessation of charter flight services which were of lower profit margin.

#### Other income

Other income included bank interest income from fixed deposits and other interest income from refundable rental deposits. The Group had two (Previous Period: two) fixed deposits with banks during the Review Period.

The Group also applied for the Employment Support Scheme launched by the Hong Kong Government and HK\$1.3 million (Previous Period: none) of grants were obtained during the Review Period.

#### 服務成本及毛利

本集團服務成本由過往期間的約39.3百萬港元增加約86.5%至回顧期間的約73.3百萬港元。該增幅乃主要由於(i)單位成本增加及空運艙位的供應有限而導致空運艙位的採購成本有所增加及(ii)付予提供倉儲及相關增值服務的供應商的分包費用上升。

本集團毛利由過往期間的約3.6百萬港元增加約211.1%至回顧期間的約11.2百萬港元。毛利率由過往期間的約8.4%增加至回顧期間的約13.3%。該增幅乃主要由於空運代理及相關物流服務以及倉儲及相關增值服務的毛利及毛利率增加所致。倉儲及相關增值服務的毛利率於回顧期間上升，主要因為(i)安檢服務為本集團帶來額外收入；(ii)從現有客戶獲得貨盤運輸服務的特別項目；及(iii)來自一名長期客戶的交易量增加。至於空運代理及相關物流服務的毛利率上升，主要因為(i)回顧期間空運艙位的供應有限加上客戶需求大幅上升導致空運艙位的整體售價上升，故本集團可提出更高的售價，最終使貨運代理及相關物流服務的毛利有所提升；及(ii)終止利潤率較低的包機服務。

#### 其他收入

其他收入包括定期存款的銀行利息收入及可退回租賃按金的其他利息收入。本集團於回顧期間擁有兩筆(過往期間：兩筆)銀行定期存款。

本集團亦已申請由香港政府推出的「保就業計劃」並於回顧期間獲得1.3百萬港元(過往期間：無)的資助款項。

#### Other gains and losses

Other gains and losses included foreign exchange (loss) gain and gain on disposals of property, plant and equipment. The Group recorded a net losses in other gains and losses during the Review Period, which was primarily attributable to the foreign exchange loss. The Group recorded a foreign exchange loss of approximately HK\$152,000 during the Review Period (for the Previous Period, a foreign exchange gain of approximately HK\$15,000). As the Group received payments from some of its major customers in United States Dollars ("USD"), the Group suffered from the depreciation in USD.

#### Marketing expenses

Marketing expenses mainly included the costs of business development and soliciting new customers. The Group's marketing expenses increased slightly as the Taipei branch incurred costs in promoting its business in Taiwan.

#### Administrative expenses

The Group's administrative expenses increased to approximately HK\$7.0 million for the Review Period from approximately HK\$6.7 million for the Previous Period. Such expenses mainly included staff costs and benefits, audit fees, legal and professional fees, depreciation, utilities and other expenses. The increase was mainly due to the combined effect of (i) legal and compliance costs, professional fee and printing charges increased by approximately HK\$0.2 million; (ii) increase in staff costs from approximately HK\$3.5 million for the Previous Period to approximately HK\$3.8 million during the Review Period, as a result of additional headcounts, particularly for the Taipei branch which was set up in July 2019; and (iii) the decrease in the amortisation of intangible asset of approximately HK\$0.2 million.

#### Other expenses

During the Review Period, the Group did not incur such expenses (Previous Period: HK\$362,000, representing professional fee paid).

#### 其他收益及虧損

其他收益及虧損包括外匯(虧損)收益及出售物業、廠房及設備的收益。本集團的其他收益及虧損於回顧期間錄得淨虧損，主要由於外匯虧損。本集團於回顧期間錄得外匯虧損約152,000港元(過往期間：外匯收益約15,000港元)所致。由於本集團從部分主要客戶以美元(「美元」)收取款項，故本集團蒙受美元減值。

#### 營銷開支

營銷開支主要包括業務發展及招攬新客戶的成本。由於台北分支辦事處於台灣推廣業務中產生成本，故本集團的營銷開支輕微增加。

#### 行政開支

本集團的行政開支由過往期間的約6.7百萬港元增加至回顧期間的約7.0百萬港元。有關開支主要包括員工成本及福利、審核費用、法律及專業費用、折舊、公共設施及其他開支。有關增幅乃主要由於以下各項的綜合影響所致：(i)法律及合規成本、專業費用以及印刷費用增加約0.2百萬港元；(ii)員工成本因增聘人手(尤其是於二零一九年七月設立的台北分支辦事處)而由過往期間的約3.5百萬港元增加至回顧期間的約3.8百萬港元；及(iii)無形資產攤銷減少約0.2百萬港元。

#### 其他開支

於回顧期間，本集團並無產生有關開支(過往期間：362,000港元，為已付專業費用)。

#### Impairment losses recognised on trade receivables under expected credit loss model, net of reversal

Under the Hong Kong Financial Reporting Standard 9 “Financial Instruments”, the management assesses the measurement of expected credit losses (“ECL”) in relation to trade receivables and uses individually assessed provision matrix to calculate ECL. During the Review Period, a reversal of an amount of HK\$0.6 million (Previous Period: HK\$0.3 million) was recognised while additional HK\$30,000 (Previous Period: HK\$49,000) was further provided from new financial assets originated.

#### Finance costs

Finance costs for the Review Period represented interest expenses on lease liabilities. Finance costs increased from approximately HK\$110,000 for the Previous Period to approximately HK\$118,000 for the Review Period.

#### Income tax credit

The Group’s income tax credit primarily included provisions for Hong Kong profits tax and deferred income tax expenses. A profit before taxation of approximately HK\$4.4 million for the Review Period was recorded while income tax credit of approximately HK\$41,000 (Previous Period: income tax credit of approximately HK\$77,000) was recorded for the Review Period as there was deferred tax impact on the property, plant and equipment, the provision for bad debts and unused tax losses.

The Group had sufficient unused tax losses brought forward to set off the assessable income obtained during the Review Period. As such, there was no income tax expenses incurred during the Review Period.

根據香港財務報告準則第9號「金融工具」，管理層評估與貿易應收款項有關的預期信貸虧損(「預期信貸虧損」)之計量以及使用個別評估的撥備矩陣計算預期信貸虧損。於回顧期間，已確認撥回0.6百萬港元(過往期間：0.3百萬港元)，並就源生的新金融資產進一步計提額外撥備30,000港元(過往期間：49,000港元)。

#### 融資成本

回顧期間的融資成本為租賃負債的利息開支。融資成本由過往期間的約110,000港元增加至回顧期間的約118,000港元。

#### 所得稅抵免

本集團的所得稅抵免主要包括香港利得稅撥備及遞延所得稅開支。回顧期間錄得除稅前溢利約4.4百萬港元，而鑒於遞延稅項對物業、廠房及設備、壞賬撥備以及未使用稅項虧損造成的影響，回顧期間錄得所得稅抵免約41,000港元(過往期間：所得稅抵免約77,000港元)。

本集團擁有充足未使用稅項虧損用作抵銷於回顧期間獲得的應課稅收入。因此，回顧期間並無產生所得稅開支。

#### Profit (loss) for the period

The Group recorded a profit before taxation of approximately HK\$4.4 million for the Review Period, compared to a loss before taxation of approximately HK\$4.5 million for the Previous Period. The profit was mainly due to the effects of (i) increase in the gross profit of the Group of approximately HK\$7.6 million; and (ii) government subsidies of approximately HK\$1.3 million received during the Review Period.

#### Dividends

The Directors do not recommend the payment of quarterly dividend for the Review Period (for the Previous Period: nil).
