CHAIRMAN'S STATEMENT

主席報告

Dear Shareholders,

On behalf of the board of Directors (the "Board") of the Company, it is my pleasure to present the audited financial statements of the Group for the year ended 31 December 2020.

Review and results

The Group is principally engaged as a subcontractor for the provision of supply, installation and fitting-out services of mechanical ventilation and air-conditioning ("MVAC") system for various types of private and public building projects including infrastructural, commercial and residential building projects in Hong Kong and Macau.

2020 was an exceptional year. It presented both challenges and opportunities to the Group. Amidst the outbreak of the pandemic and the devastation it brought, in 2020, we achieved milestone development in the Group's business. The Group was awarded two projects with highest initial contract sum exceeding HK\$88 million and HK\$159 million respectively in Hong Kong. While the competition in the MVAC system service industry remained fierce, our achievement would not have been possible without the devotion and professionalism of our management team and employees, as well as the unwavering support of our customers, suppliers and other business partners.

The total revenue of the Group increased by approximately HK\$30.7 million or 16.1% from approximately HK\$190.5 million for the year ended 31 December 2019 to approximately HK\$221.2 million for the year ended 31 December 2020. The Group's profit for the year increased by approximately HK\$1.3 million from approximately HK\$21.3 million for the year ended 31 December 2019 to approximately HK\$22.6 million for the year ended 31 December 2020.

In 2020, the Company also submitted an application for a transfer of listing from GEM to the Main Board of the Stock Exchange. We are hopeful that upon successful transfer to the Main Board, this will further enhance the corporate profile of the Group, strengthen its recognition among public investors and customers of tile Company, create more business opportunities to the Group and will be beneficial to the Group's future growth. We believe the said application is in the overall interest of the Company and the shareholders of the Company.

本人欣然代表本公司董事會（「董事會」）呈報截至二零二零年十二月三十一日止年度本集團的經審核財務報表。

回顧及業績

本集團主要以分包商的身份在香港及澳門提供各類私人及公共樓宇項目（包括基建、商業及住宅樓宇項目）的機械通風及空調系統（「機械通風及空調系統」）供應、安裝及裝修服務。

二零二零年是難能可貴的年度，對本集團而言，也是危中有機的年度。疫情爆發為世界帶來嚴重衝擊，但本集團業務的發展依然在二零二零年邁向新里程。本集團於香港獲授兩項新項目，初始合約金額最高分別逾88百萬港元及159百萬港元。機械通風及空調系統服務行業的競爭依然激烈，若無缺管理團隊的專一精誠與專業態度，以及客戶、供應商和其他業務夥伴對我們的支持始終如一，我們難以達此成就。

本集團的總收益由截至二零一九年十二月三十一日止年度的約190.5百萬港元增加約30.7百萬港元或16.1%至截至二零二零年十二月三十一日止年度的約221.2百萬港元。本集團的年內溢利由截至二零一九年十二月三十一日止年度的約21.3百萬港元增加約1.3百萬港元至截至二零二零年十二月三十一日止年度的約22.6百萬港元。

於二零二零年，本公司亦已提交由聯交所GEM轉到主板上市的申請。我們深信，成功轉至主板後，將進一步提升本集團的企業形象，加強其在公眾投資者及本公司客戶之間的認受性，為本集團創造更多商機，有利於本集團的未來發展。我們相信是項申請符合本公司及其股東的整體利益。

MANAGEMENT DISCUSSION AND ANALYSIS

Business Review and Outlook

The Group is principally engaged as a subcontractor for the provision of supply, installation and fitting-out services of MVAC system for various types of private and public building projects including infrastructural, commercial and residential building projects in Hong Kong and Macau.

Since the outbreak of the novel coronavirus (COVID-19) in early 2020, the pandemic has continued to generate unprecedented disruptions in business operations on a global scale. Despite the market downturn, and the suffering from temporary suspension of construction works in February and March 2020 leading to a decrease in the amount of work recognised during the first quarter of 2020 for the Group, the Group has remained resilient and recorded an increase in revenue for the year ended 31 December 2020 as compared to the year ended 31 December 2019. In particular, during the second half of 2020, amongst the new projects awarded to the Group, two new projects with an initial contract sum exceeding HK\$88 million and HK\$159 million respectively marked a new business milestone in the development of the Group for being the largest contracts in terms of contract sum the Group has ever been awarded in Hong Kong. The Group will continue to regularly and closely monitor the progress of its on-going projects and will continue to identify suitable tender opportunities and submit tenders for potential projects to maximize the Group's profits and return to its shareholders.

管理層討論及分析

業務回顧及展望

本集團主要以分包商的身份在香港及澳門提供各類私人及公共樓宇項目(包括基建、商業及住宅樓宇項目)的機械通風及空調系統供應、安裝及裝修服務。

自新型冠狀病毒(COVID-19)於二零二零年年初爆發，疫情持續導致全球的業務運營受到前所未見的干擾。儘管市場不景氣，以及於二零二零年二月和三月暫時中止建築工程使本集團於二零二零年第一季度確認的工程金額減少，本集團仍具備承壓能力，且於截至二零二零年十二月三十一日止年度錄得的收益較截至二零一九年十二月三十一日止年度有所增長。具體而言，於二零二零年下半年，本集團獲授的新項目當中，兩個新項目的初始合約金額分別超過88百萬港元及159百萬港元，而以合約金額計算，此乃屬於本集團在香港獲授的最大合約，標誌著本集團業務發展的新里程碑。本集團將繼續定期密切監察在建項目的進度，亦會繼續物色合適投標機會，並就潛在項目作出投標，以盡量提高本集團的利潤及股東回報。

Further, as disclosed in the announcement of the Company dated 23 July 2020, the work of a project with a contract sum of over MOP170 million (the “Affected Project”) was suspended since 31 July 2020. The revenue contribution of the Affected Project in the second half of year 2020 was impacted as a result of the delay in completion accordingly. As at the date of this report, the work for the Affected Project is still pending further instruction or notice from the customer. Other than the Affected Project, the work of all other on-going projects of the Group are progressing as scheduled and the pipeline of projects of the Group remains sufficient. While it is unclear how much longer the COVID-19 pandemic may last and the extent of impact on the local and global economy, the Group will continue to pay attention to the situation of the pandemic and assess its impact on the operations and financial performance of the Group, and will make further announcement(s) as and when appropriate.

On the corporate development front, the Company submitted an application for a transfer of listing from GEM to the Main Board of the Stock Exchange (the “Proposed Transfer of Listing”) on 14 May 2020 and the said application was renewed on 23 November 2020, details of which have been set out in the announcements of the Company published on the respective dates.

Looking forward, the Board remains confident in the core competencies and prospect of the Group, and is committed in creating long-term value to the shareholders of the Company.

此外，誠如本公司日期為二零二零年七月二十三日的公佈所披露，一個合約金額超過170百萬澳門幣的項目（「受影響項目」），自二零二零年七月三十一日起暫停施工。受影響項目於二零二零年下半年的收益貢獻因延遲竣工而遭受影響。於本報告日期，受影響項目的工程仍有待客戶的進一步指示或通知。除受影響項目外，本集團所有其他在建項目的工程均按計劃進行，本集團的項目儲備仍然充足。儘管目前難以掌握COVID-19疫情持續的時間，以及其對本地及全球經濟的影響幅度，惟本集團將繼續留意疫情狀況，同時評估其對本集團運營及財務表現的影響，並在適當時作進一步公佈。

企業發展方面，本公司已於二零二零年五月十四日遞交申請，擬由聯交所GEM轉至主板上市（「建議轉板上市」），而上述申請已於二零二零年十一月二十三日重續，有關詳情載於本公司於相關日期刊發的公佈。

展望未來，董事會對本集團的核心實力及前景仍然抱有信心，且致力為本公司股東締造長遠價值。

Financial Review

Revenue

Our revenue increased from approximately HK\$190.5 million for the year ended 31 December 2019 to approximately HK\$221.2 million for the year ended 31 December 2020, representing an increase of approximately 16.1%. In particular, while the Group recorded (i) an increase in revenue of approximately HK\$52.6 million from new projects (in particular two new projects located at Chek Lap Kok which collectively contributed to an increase in revenue of approximately HK\$47.3 million); and (ii) an increase in revenue of approximately HK\$134.0 million due to the increase in the amount of work under our existing projects as compared with the year ended 31 December 2019 (in particular, another project located at Chek Lap Kok and a project located at Freguesia da Sé in Macau), the aforesaid increments were offset by (i) a decrease in revenue of approximately HK\$39.8 million resulting from the completion of certain projects during the year ended 31 December 2020; and (ii) a decrease in revenue of approximately HK\$116.1 million due to the decrease in the amount of work under our existing projects as compared with the year ended 31 December 2019 (in particular, two projects located at Shatin and Taipa in Macau together accounted for a decrease in revenue of approximately HK\$79.0 million).

Cost of Sales

Our cost of sales increased from approximately HK\$145.2 million for the year ended 31 December 2019 to approximately HK\$179.6 million for the year ended 31 December 2020, representing an increase of approximately 23.7% which was in line with the increase in our revenue for the year ended 31 December 2020.

財務回顧

收益

收益由截至二零一九年十二月三十一日止年度約190.5百萬港元增加至截至二零二零年十二月三十一日止年度約221.2百萬港元，增幅約16.1%。具體而言，本集團已錄得(i)來自新項目的收益增加約52.6百萬港元，尤其是位於赤鱘角的兩個新項目，合共帶來收益增幅約47.3百萬港元；及(ii)我們在現有項目下工程金額較截至二零一九年十二月三十一日止年度增加，尤其是位於赤鱘角的另一個項目及位於澳門大堂區的項目，令收益增加約134.0百萬港元，惟上述增長因下列各項而抵銷：(i)於截至二零二零年十二月三十一日止年度若干項目完成導致收益減少約39.8百萬港元；及(ii)我們在現有項目下工程金額較截至二零一九年十二月三十一日止年度減少，尤其是位於沙田及澳門氹仔的兩個項目，合共佔收益減少約79.0百萬港元，令收益下跌約116.1百萬港元。

銷售成本

銷售成本由截至二零一九年十二月三十一日止年度約145.2百萬港元增加至截至二零二零年十二月三十一日止年度約179.6百萬港元，增幅約23.7%，與截至二零二零年十二月三十一日止年度收益的增幅一致。

管理層討論及分析**Gross Profit and Gross Profit Margin**

Our gross profit decreased by approximately 7.7% from approximately HK\$45.2 million for the year ended 31 December 2019 to approximately HK\$41.7 million for the year ended 31 December 2020. The decrease in our gross profit was primarily due to the decrease in our gross profit margin from approximately 23.8% for the year ended 31 December 2019 to approximately 18.8% for the year ended 31 December 2020. The decrease in our gross profit margin was mainly attributable to the decrease in the amount of our works in the project located at Shatin (under which the Group could charge a higher premium due to a tight construction schedule imposed by the customer) and another project located at Taipa in Macau (under which the Group charged a higher premium due to variation orders performed by the Group during year ended 31 December 2019). Contribution from projects located at Shatin and Taipa in Macau to the Group's total revenue have decreased from 40.5% and 8.6% respectively for the year ended 31 December 2019 to 6.5% and 0.08% respectively for the year ended 31 December 2020.

Administrative Expenses

Our administrative expenses decreased by approximately HK\$2.2 million, or approximately 12.6%, from approximately HK\$17.5 million for the year ended 31 December 2019 to approximately HK\$15.3 million for the year ended 31 December 2020, mainly attributable to the decrease in the staff costs such as the Directors' remuneration.

In view of the economic downturn in the second half 2020 which was mainly due to the successive waves of COVID-19, the Group has adopted various measures to strengthen its cost control to maintain its competitiveness in the market. After comprehensive assessment, our Executive Directors, namely Mr. Chung Chi Keung ("Mr. Chung") and Ms. Lai Suk Fan, agreed to reduce their remuneration as one of the temporary cost control measures.

毛利及毛利率

毛利由截至二零一九年十二月三十一日止年度約45.2百萬港元減少約7.7%至截至二零二零年十二月三十一日止年度約41.7百萬港元。毛利減少主要由於毛利率由截至二零一九年十二月三十一日止年度約23.8%減少至截至二零二零年十二月三十一日止年度約18.8%。毛利率下降主要由於位於沙田的項目(由於客戶要求的施工進度緊迫,本集團可就此收取較高溢價)及另一個位於澳門氹仔的項目(由於本集團於截至二零一九年十二月三十一日止年度執行的工程變更指令,本集團可就此收取較高溢價)的工程金額減少。位於沙田及澳門氹仔的項目對本集團總收益的貢獻分別由截至二零一九年十二月三十一日止年度的40.5%及8.6%下降至截至二零二零年十二月三十一日止年度的6.5%及0.08%。

行政開支

行政開支由截至二零一九年十二月三十一日止年度約17.5百萬港元減少約2.2百萬港元或約12.6%至截至二零二零年十二月三十一日止年度約15.3百萬港元,主要由於員工成本(如董事薪酬)減少。

二零二零年下半年的經濟出現衰退,主要由於COVID-19疫情接連爆發,有鑒於此,本集團已採取多項措施,以加強控制成本及維持其市場競爭力。經作出全面評估後,執行董事鍾志強先生(「鍾先生」)及黎淑芬女士同意下調彼等的薪酬,作為控制成本的臨時措施之一。

管理層討論及分析**Expenses in Relation to the Transfer of Listing**

During the year ended 31 December 2020, our Group recognised non-recurring professional service fees of approximately HK\$4.4 million in connection with the Proposed Transfer of Listing. No such expense was recognised for the year ended 31 December 2019.

Income Tax Expense

Income tax expense for the Group decreased by approximately 36.7% from approximately HK\$4.9 million for the year ended 31 December 2019 to approximately HK\$3.1 million for the year ended 31 December 2020. The decrease was mainly due to the increase in other income not subject to tax.

Profit for the Year

As a result of the foregoing, our profit for the year recorded a modest increase by approximately HK\$1.3 million from approximately HK\$21.3 million for the year ended 31 December 2019 to approximately HK\$22.6 million for the year ended 31 December 2020. Excluding the one-off expenses incurred during the year ended 31 December 2020 for the Proposed Transfer of Listing, our adjusted profit increased by approximately HK\$5.7 million or approximately 26.8% from approximately HK\$21.3 million for the year ended 31 December 2019 to approximately HK\$27.0 million for the year ended 31 December 2020.

Liquidity and Financial Resources

As at 31 December 2020, the Group had total assets of approximately HK\$216.6 million (2019: approximately HK\$140.7 million), which is financed by total liabilities and shareholders' equity (comprising share capital and reserves) of approximately HK\$91.8 million (2019: approximately HK\$38.6 million) and approximately HK\$124.8 million (2019: approximately HK\$102.1 million), respectively.

轉板上市開支

於截至二零二零年十二月三十一日止年度，本集團就建議轉板上市確認非經常性的專業服務費用約4.4百萬港元。於截至二零一九年十二月三十一日止年度概無確認有關費用。

所得稅開支

本集團的所得稅開支由截至二零一九年十二月三十一日止年度約4.9百萬港元減少約36.7%至截至二零二零年十二月三十一日止年度約3.1百萬港元。該減少主要是由於其他毋須課稅收入增加所致。

年內溢利

由於前文所述，年內溢利錄得由截至二零一九年十二月三十一日止年度約21.3百萬港元適度增加約1.3百萬港元至截至二零二零年十二月三十一日止年度約22.6百萬港元。撇除於截至二零二零年十二月三十一日止年度因建議轉板上市而產生的一次性開支，經調整溢利由截至二零一九年十二月三十一日止年度約21.3百萬港元增加約5.7百萬港元或約26.8%至截至二零二零年十二月三十一日止年度約27.0百萬港元。

流動資金及財務資源

The total interest-bearing borrowings (including bank borrowings and bank overdrafts) of the Group increased from approximately HK\$6.5 million as at 31 December 2019 to approximately HK\$38.2 million as at 31 December 2020 which was mainly attributable to the drawdown of revolving loans and bank overdrafts, partially offset by the repayment of a bank borrowing. Current ratio decreased from 3.7 times as at 31 December 2019 to approximately 2.3 times as at 31 December 2020.

The Group's borrowing and bank balances are mainly denominated in Hong Kong dollars and there was no significant exposure to foreign exchange rate fluctuations during the year.

The Group's gearing ratio, which is calculated by dividing the total interest-bearing borrowings and lease liabilities by total equity at the year-end date, increased from approximately 7.1% as at 31 December 2019 to approximately 31.7% as at 31 December 2020, primarily due to (i) the increase in the total interest-bearing borrowings which was due to the drawdown of revolving loans and bank overdrafts during the year; and (ii) the increase in total equity resulting from the increase in retained earnings attributable to recording a net profit for the year ended 31 December 2020.

Principal Risks and Uncertainties

Other than the potential impact of the COVID-19 pandemic on the local and global economy and the operation and financial performance of the Group as mentioned under the paragraph headed "Management Discussion and Analysis — Business Review and Outlook" above, the management considers that the followings are the principal risks and uncertainties faced by the Group:

- (i) the business of the Group relies on successful tenders and any failure of the Group to secure tender contracts would affect the operations and financial results of the Group;
- (ii) erroneous or inaccurate estimation of project duration and the costs involved for the determination of tender price may adversely affect the profitability and financial performance of the Group;

Relationship with customers, suppliers, subcontractors and employees**Customers**

The Group's customers mainly include main contractors and subcontractors of various types of building projects including infrastructural, commercial and residential building projects in Hong Kong and Macau. The Group has maintained business relationship with the top customers for a period ranging from approximately 2 years to over 10 years. The Directors believe the Group has established good relationship with its customers and receives invitations from the repeat customers to submit tenders from time to time.

Suppliers and Subcontractors

During the year ended 31 December 2020, the suppliers and subcontractors of the Group included (i) suppliers of air-conditioning equipment and materials; (ii) suppliers of processing services on the Group's equipment and materials; (iii) machinery rental service providers; and (iv) subcontractors engaged by the Group to perform the site works. The Group engaged the suppliers and subcontractors on a regular basis.

While engaging subcontractors, the Group selects the subcontractors for a project by taking into account their availability of resources and manpower, experience, track record, service quality, safety performance, timeliness of delivery, reputation and fee quotations.

The Group did not encounter any material difficulty in sourcing equipment and materials and services from our suppliers or assigning subcontractors during the year ended 31 December 2020.

Employees

The Group respects its employees and endeavours to provide better working conditions for its employees. We offer competitive remuneration and a fair, flexible and transparent recruitment process to attract and retain talents and promotes equal opportunities among employees. Further details can also be found in section headed "Environmental, Social and Governance Report" of this annual report.

Capital Structure

The shares of the Company (the "Shares") were successfully listed on GEM of the Stock Exchange on 27 February 2018 (the "Listing"). Immediately upon Listing, the total issued share capital of the Company was HK\$5,740,000 divided into 574,000,000 Shares of par value of HK\$0.01 each. There has been no change in the capital structure of the Group since then. The share capital of the Group comprises only ordinary shares.

As at 31 December 2020, the Group employed a total of 527 (31 December 2019: 170) employees, of whom 458 (31 December 2019: 116) were labour workers nominated by subcontractors. The increase in the number of employees was mainly attributable to the increase of labour workers nominated by subcontractors in respect of a new project located at Chek Lap Kok which was commenced and completed in 2020. The relevant cost of employing the labour workers nominated by subcontractors was classified as subcontracting charges and the staff costs, including Directors' emoluments, of the Group were approximately HK\$23.7 million for the year ended 31 December 2020 (2019: approximately HK\$24.3 million).

The Group promotes individuals based on their performance and development potential in the positions held. In order to attract and retain high quality staff, competitive remuneration package is offered to employees (with reference to market norms and individual employees' performance, qualification and experience). On top of basic salaries, bonuses may be paid with reference to the Group's performance as well as individual's performance. Other staff benefits include provision of retirement benefits, medical benefits and sponsorship of training courses.

Events after the Reporting Period

No significant events have taken place subsequent to 31 December 2020 and up to the date of this report.

The Directors and the management of the Group recognise the importance of sound corporate governance to the long-term success and continuing development of the Group. Therefore, the Board is committed to upholding good corporate standards and procedures, so as to enhance the accountability system and transparency of the Group, protect the interests of the Company's stakeholders and create value for shareholders of the Company.

The Company's corporate governance practices are based on the principles and code provisions as set out in the Corporate Governance Code and Corporate Governance Report (the "CG Code") as set out in Appendix 15 of the GEM Listing Rules. Throughout the year ended 31 December 2020 (the "Relevant Period"), the Company has adopted and complied with, where applicable, the CG Code to ensure that the Group's business activities and decision making processes are regulated in a proper and prudent manner, except for Code Provision A.2.1 of the CG Code.

Pursuant to Code Provision A.2.1 of the CG Code, the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. Mr. Chung is currently the chairman of the Board and the chief executive officer of the Company, responsible for formulating the overall business strategies and overseeing the business and operation of the Group. Considering that Mr. Chung has been responsible for the overall management and operation of the Group since its inception, the Board believes that it is in the best interest of the Group to have Mr. Chung taking up both roles for effective management and business development.

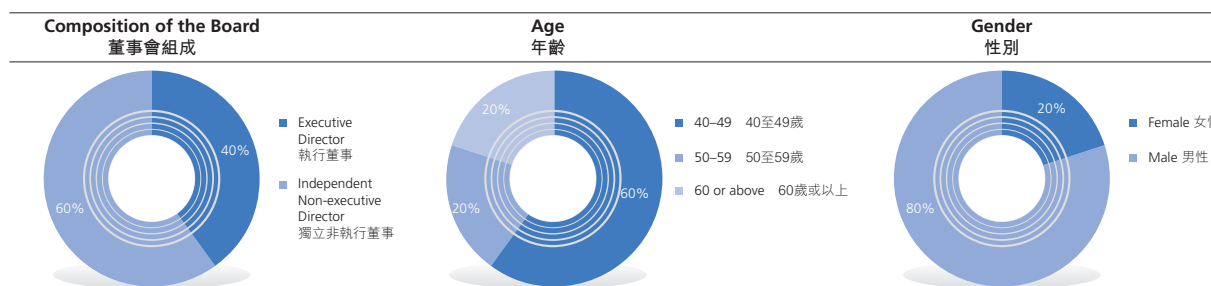

Terms of Appointment and Re-election of Directors

Each of the executive Directors have entered into a service agreement, and each of the INEDs signed a letter of appointment with, the Company. Both the said service agreements and letters of appointment are for a term of three years from 27 February 2018, being the date on which the Shares are listed on GEM, subject to further renewal and re-election in accordance with amended and restated Articles of Association of the Company, as amended from time to time, (the "Articles") and termination in accordance with their respective terms. The service agreement of each executive Director and the letter of appointment of each INED have been renewed for another term of 3 years since 27 February 2021 on the same terms and conditions.

Pursuant to Article 16.18 of the Articles, one-third of the Directors shall retire from office by rotation at each AGM of the Company and every Director shall be subject to retirement by rotation at least every three years. However, a retiring Director shall be eligible for re-election. Any Director who is appointed by the Board to fill a casual vacancy and any Director appointed by the Board as an addition to the existing Board shall hold office only until the next following general meeting of the Company and shall be eligible for re-election at that meeting pursuant to Article 16.2 of the Articles.

As such, Ms. Lai Suk Fun and Mr. Choy Hiu Fai Eric will retire from office as Directors and, being eligible, will offer themselves for re-election at the forthcoming AGM of the Company which is scheduled to be held on Tuesday, 8 June 2021 in accordance with the Articles and relevant code provision under the CG Code.

Audit Committee

The Audit Committee currently consists of three members, namely Mr. Choy Hiu Fai Eric, Mr. Lei For and Mr. Lai Wai Ming, all of whom are our INEDs. Mr. Choy Hiu Fai Eric is the chairman of the Audit Committee, who holds the appropriate professional qualifications as required under Rules 5.05(2) and 5.28 of the GEM Listing Rules.

The primary duties of the Audit Committee are to make recommendations to the Board on the appointment or re-appointment and removal of external auditor; review financial statements/information of the Company and judgments in respect of financial reporting; oversee the effectiveness of the procedures of the internal control procedures and risk management of the Group; and review the Company's compliance with the CG Code and disclosure in the Corporate Governance Report.

This includes Mr. Lei For who is the chairman of the Nomination Committee and Mr. Lai Wai Ming, both of whom are our INEDs, and our executive Director, Mr. Chung.

The primary duties of the Nomination Committee are to review the structure, size and composition of the Board annually by reference to the factors as set out in the Diversity Policy, identify individuals suitably qualified to become Board members; assess independence of independent non-executive Directors and make recommendations to the Board on matters relating to the appointment and re-appointment of Directors with reference to the Nomination Policy.

To enhance the nomination process for a director candidate, a Nomination Policy was adopted as a guidance on the selection process and board succession planning. The Nomination Committee utilises various methods for identifying director candidates, including recommendations from the Board members, management, and professional search firms and may review of resume and job history, conduct personal interviews and verification of professional and personal references or perform the background checks, etc. On evaluation of the director candidates including incumbents and candidates nominated by the Shareholders, the Board and the Nomination Committee will take into account whether a candidate has the qualifications, skills and experience, gender diversity, etc. that can add to and complement the range of skills, experience and background of the existing Directors and may consider the following qualifications are at a minimum to be required of a director candidate in recommending to the Board potential new Director, or the continued service of existing Director:

The Board also acknowledges its responsibility for the risk management and internal control systems and discharges its responsibilities to oversee management in design, implementation and monitoring of the risk management and internal control system and its effectiveness. As delegated by the Board, the Audit Committee will review of the Company's financial controls, risk management and internal control system and its effectiveness and report to the Board on a regular basis and at least annually.

The Group also established a set of risk management policies and measures. The Group's risk management process starts with identifying the major risks associated with its business, industry and market in the ordinary course of business. The Board and senior management are responsible for identifying the analysing the risk associated with their respective function, preparing and measuring risk mitigation plans and reporting the status of risk management. More information about the principal risks and uncertainties faced by the Group can be found on pages 12 to 13 of this annual report.

The Group has maintained internal control guidance covering the Group's operation processes relating to subcontract, purchase and expenditure and human resources, etc. and overseen their operations by the senior management. In view of the size and business nature of the Group, the Company does not establish a standalone internal audit function but has engaged an external independent consultant to review and assess our internal control systems (including financial, operational and management systems, compliance and governance matters) during the Relevant Period. No material internal control deficiency was identified by the external consultant and the Group's management had worked with the external consultant to enhance the Group's internal control system.

During the Relevant Period, the Audit Committee, has conducted a review of the effectiveness of the risk management and internal control system of the Group. The external internal control consultant also reported to the Audit Committee on their factual findings and recommendation for improvements on our internal control systems over the abovementioned processes and procedures.

The Group has implemented the necessary internal control measures based on the recommendation of the external internal control consultant. The external internal control consultant confirmed such modified and new internal control procedures are satisfactorily implemented upon the conduct of follow-up review. The Audit Committee was satisfied and considers that the Group's risk management and internal control procedures are sufficient to meet the Company's needs in its current business environment and in terms of practicability.

The Company has adopted a Dividend Policy as a guidance on the payment of the dividend. In deciding whether to propose a dividend and in determining the dividend amount, the Board would take into account the Group's results of operations, earnings performance, cashflows, financial condition, future prospects, as well as statutory and regulatory restrictions on the payment of dividends, and other factors that the Board may consider relevant. And the Board will review from time to time for determination on proposed dividend with the above factors taken into account, there can be no assurance that dividends will be declared or paid in any particular amount for any given period.

EXTERNAL AUDITOR

PricewaterhouseCoopers is the external auditor of the Company which was appointed by the Board on 13 December 2019.

The Audit Committee is responsible for making recommendation to the Board on the resignation, appointment or re-appointment and removal of the external auditor, which is subject to the approval by the Board and/or at the general meetings of the Company by its shareholders. The Audit Committee would consider various factors including the independence, experience and qualification of auditor, their fee, terms of engagement and staffing plan for recommendation to the Board for the appointment or re-appointment of the auditor of the Company.

About This Report

The objective of this Environmental, Social and Governance (“ESG”) Report is to highlight the Group’s ESG performance for the purpose of assisting all stakeholders in understanding the Group’s ESG concepts and practices in achieving sustainable development for the future.

The Report complies with the disclosure requirements set out in the ESG Reporting Guide as described in Appendix 20 of the GEM Listing Rules. An assessment on the applicability and materiality of the relevant key performance indicators (“KPIs”) under the ESG Reporting Guide had been conducted.

Governance on ESG Aspects

The Board has overall responsibility for the Group’s ESG strategy and reporting. The Board is responsible for evaluating and determining the Group’s ESG-related risks, and ensuring that appropriate and effective ESG risk management and internal control systems are in place. Our management are delegated with the responsibility of coordinating the implementation of the Group’s environment, employment and service quality assurance policies.

ESG Management Approach

The Board leads and provides direction to management by instituting ESG policies and initiatives, supervising their implementation and monitoring ESG performance. The Board continues to explore ways to further strengthen the ESG governance of the Group. The Board reviews ESG affairs regularly, including environmental protection, employment and labour practices, operating practices, and community investment, and implements appropriate measures to enhance the ESG performance of the Group.

Environmental

The Group does not have any factory operations nor engage in any operations that have a substantial effect on the environment, aside from consumption of resources by the office administrative operations. Nevertheless, the Group pays due consideration and effort towards compliance with applicable laws and regulations in Hong Kong and Macau, and actively cooperates with the main contractor in meeting the environmental protection requirements. The majority of the work of the Group is conducted through its sub-contractors, whereby as part of the project delivery, apart from confirming construction quality, the project team will also monitor the environmental performance of its subcontractors. One of the measures includes regularly check to ensure that environmental protection requirements imposed upon various parties, including the main contractor, the construction site, and the Group, are met.

Emissions management

As a subcontractor for the provision of supply, installation and fitting-out services of MVAC systems for buildings in Hong Kong and Macau, the installation activity does not cause any material emissions or pollutions generated from the Company's operations at construction sites.

In order to minimise the production of air pollutants by motor vehicles, the Group promotes the use of public transport and car-pooling.

環境

除了辦公室行政作業的資源消耗外，本集團並無任何廠房營運，亦無從事任何對環境造成重大影響的業務。儘管如此，本集團作出周詳考慮並致力遵守香港及澳門的適用法律及法規，同時積極與總承建商合作遵守環境保護規定。本集團大部分工程經由其分包商進行，而作為項目交付一部分，除了確認建築工程品質外，項目團隊亦會監督其分包商的環保表現。其中一項措施包括定期檢查以確保各方（包括總承建商、地盤及本集團）被施加的環保規定得以遵守。

排放管理

作為在香港及澳門提供樓宇機械通風及空調系統的供應、安裝及裝修服務的分包商，安裝活動並無導致本公司於建築地盤的業務產生任何重大排放或污染。

為減低汽車所產生的空氣污染物，本集團鼓勵使用公共交通及共乘。

During the reporting period, the Group did not encounter any non-compliance issue about emission that would have a significant impact on the environment.

Hazardous and non-hazardous waste

The major source of waste comes from construction works, whereby the Group abides by the regulations imposed by the main contractor and the respective site. The staff and work team follow onsite regulations on waste disposal and would always inquire with the project management team when any difficulties are encountered. The project team would also ensure compliance with the applicable provisions of the Waste Disposal Ordinance (Chapter 359 of the Laws of Hong Kong) and its subsidiary regulations, particularly the Waste Disposal (Charges for Disposal of Construction Waste) and the Waste Disposal (Chemical Waste) (General) Regulations.

Although the operation does not involve handling hazardous waste directly, we also establish policies and guidelines for both our staff and our sub-contractors, for example, hazardous waste is stored separately in special containers before collected by licenced chemical waste collector.

於報告期間，本集團並無遇到任何有關排放量的不合規事宜，以致對環境造成重大影響。

有害及無害廢棄物

廢棄物的主要來源來自建築工程，而本集團已遵守總承建商及相關地盤實施的規定。員工及施工團隊遵循現場廢棄物處置規定，並時常在遇到困難時向項目管理團隊查詢。項目團隊亦會確保遵守《廢物處置條例》(香港法例第359章)適用條文及其附屬規例，尤其是《廢物處置(建築廢物處置收費)規例》及《廢物處置(化學廢物)(一般)規例》。

儘管營運並無涉及直接處理有害廢棄物，我們亦為員工及分包商制定政策及指引，如有害廢棄物在持牌化學廢棄物收集商前來收集前，須獨立存放於特別容器內。

Waste production was mainly attributed to the discarded packaging materials and domestic wastes of office. Therefore, the waste disposed is immaterial and non-hazardous. During the reporting period, the Group did not notice any material non-compliance issue about waste disposal.

Use of resources

Driven by the belief in maintaining sustainability, the Group strives to ensure efficient use of resources, including energy, materials and auxiliary materials. It is the group's policy that material ordered is 'just right' for the intended project, and the Group endeavours to employ excess material to reduce wastage. In view of the pandemic, the office administration had maximized the office's air circulation by opening the windows instead of relying on the air-conditioning system. And as part of the effort to improve the standard of hygiene, cleaning effort had been escalated. As a result, electricity consumption was reduced by approximately 27% this year, along with a noticeable increase in water consumption. Increased paper and petrol usage were as a result of increased business activities. Going forward, the administration would focus on ensuring resources wastage is at a minimum.

廢棄物的產生主要來自辦公室已廢棄的包裝物料及家居廢棄物。因此，所拋棄廢棄物屬微量及無害。於報告期間，本集團並不知悉任何有關處置廢棄物的重大不合規事宜。

資源使用

本集團堅決維持可持續發展，致力確保有效使用資源，包括能源、物料及附屬物料。本集團制定政策確保訂購的物料剛好用作擬定項目，本集團亦致力運用多餘物料以減少浪費。鑑於疫情，辦公室行政部門通過打開窗戶而非依靠空調系統盡量增加辦公室的空氣流通。作為改善衛生標準的工作一環，本集團已加強清潔工作。因此，今年的耗電量減少約27%，耗水量亦顯著增加。商業活動增加以致紙張及汽油用量增加。展望未來，行政部門將專注於確保資源浪費盡量減至最低。

The Group has implemented following schemes to reduce consumption of energy and natural resources:

- encourage duplex printing and reuse single side printed paper;
- idle electrical appliances are switched off;
- regular maintenance and repair for electrical appliances to lower energy waste;
- reduce the use of disposable and non-recyclable products and
- regular maintenance and inspection of company vehicles.

Environmental and natural resources

There are several environmental concerns that are of particular relevance, affecting the materials and services used by the Group, such as, air conditioning, refrigeration and heat pump technologies which are increasingly switching to more environmentally friendly refrigerant gases with lower ozone depletion potential and lower global warming potential. The Group is determined to stay abreast of development in resources and technologies benefitting the environment with the higher requirements being imposed on MVAC equipment and installation process. In delivering the works, the project team would ensure that all services are conducted in an environmentally responsible manner and ensure strict adherence to the applicable laws in Hong Kong and Macau, such as the Noise Control Ordinance (Chapter 40 of the Laws of Hong Kong).

Several other specific regulations directly related to the operations, including the requirement of using lead-free solders for copper pipes at freshwater Inside Services are specified in the standard as stipulated in the Waterworks Regulations. Another regulation example that the Group complies with is the VOC regulation imposed by the Environmental Protection Department. VOCs (volatile organic compounds) are found in a wide variety of everyday products such as solvent-based paints/coatings, adhesives, sealants, printing inks, many consumer products, organic solvents and petroleum products.

- 減少使用即棄及不可回收的產品；及

環境及天然資源

多項環境問題尤其息息相關，其影響本集團所用物料及服務，例如空調、冷藏及熱泵技術正漸轉為更加環保的製冷氣體，以降低臭氧破壞潛勢及全球暖化潛勢。本集團堅決緊貼有利環境的資源及技術發展，並對機械通風及空調設備及安裝程序施加的更高要求。於交付工程時，項目團隊會確保所有服務按環保負責的方式進行，並確保嚴格遵守香港及澳門的適用法律，例如《噪音管制條例》（香港法例第40章）。

另有多項特殊規定與營運直接相關，包括規定淡水銅管使用無鉛焊料。內部水管須符合《水務設施規例》所規定的標準。其他本集團遵守的規定例如是環境保護署實施的揮發性有機化合物規例。很多日常用品都含有VOC（揮發性有機化合物），例如溶劑漆料／塗料、黏合劑、密封劑、印墨、多種消費品、有機溶劑及石油產品等。

The Group promotes equal opportunity and opposes any form of discrimination in the hiring process. Personal attributes like race, religion, nationality, age or gender are not considered in the hiring process. Besides discrimination, any act of sexual harassment is also strictly prohibited. As at 31 December 2020, the Group had 5 (2019: 5) directors and 522 (2019: 165) employees, including 458 (2019: 116) labour workers nominated by sub-contractors. Compensation and dismissal

The Group offers competitive remuneration to attract and retain talented staff members. Remuneration packages are reviewed periodically to ensure consistency with employment market. Laws and regulations on minimum wage and statutory social benefits are required to be followed. Dismissal is required to comply with employment laws and regulations, and to follow the internal policies and procedures, including policy on prevention of dismissal purely on employees' gender, marital status, pregnancy, disability, age or family status.

During the reporting period, the Group was not aware of any material non-compliance relating to compensation and dismissal, recruitment and promotion, working hours, rest periods, equal opportunity, diversity or discrimination.

Health and safety

The Group is committed to strict compliance with all relevant health and safety legislation. Although the works carried out by the Group and its sub-contractors do not involve heavy machinery or manual handling of hazardous materials, the staff teams are exposed to relatively higher health and safety risks. The project management team is committed to conducting on-going risk assessments to identify and manage these risks, with the objectives of achieving the goal of zero accidents.

In most cases, the main contractor or the management of the construction site would already have developed and deployed to the staff teams sets of site safety plan and instructions and requires compliance by all subcontractors. Management of the Group works to ensure that the subcontractors strictly observe these safety plans and directives. Safety instructions for different operations are well-communicated to the employees. In accordance with the safety requirements of the Labour Department and the main contractor, we provide the site staff with qualified safety equipment, including safety helmets, goggles and other necessary safety precautions to ensure the occupational safety of the staff. Personal protective equipment specific to the type of work being performed is made available and distributed. The site foremen are responsible for ensuring proper use and maintenance of the equipment. The Group extends the considerations and assessments to the subcontractors and the project team maintains close communication to provide the staff and subcontractors with the latest safety information.

平等機會、多元化及反歧視

Management will continue to maintain constant communication with field operation. Going forward, the Group will reinforce the effort to strive towards the ultimate objective of zero accident and zero injury rate during operations. The Group was not subject to any material administrative penalties or fines for any breach of laws or regulations relating to the provision of a safe working environment or the protection of employees against occupational hazards during the reporting period.

Development and training

The Group is devoted to creating a learning culture among the teams, so as to enable the staff in developing their career and enabling them to reach their goals. The Group therefore from time to time arranges the teams to attend external training, such as the BIM induction course, ISO 26000 Guidance on Social Responsibility course, and the Corporate Social Capital in Practice workshop. Training is also provided to management with the aims to maintain and enhance the technical knowledge and professional skills possessed. Training for staff in construction site mainly includes safety precaution in the construction industry and case study of accidents happened before.

The Group strictly prohibits the use of forced and child labour. The Group complies with relevant regulations and laws to safeguard the rights of our employees, and will not tolerate labour exploitation. During the recruitment process, we verify the age of applicants and the practice is extended to the workers hired by our sub-contractors. The Group prevents hiring child labour by conducting an identification check of every new employee. Without exception, during the year ended 31 December 2020, the Group was not aware of any material non-compliance with laws and regulations regarding child labour and forced labour.

Supply chain management

The materials used by the Group are mainly pipes and other fittings. To fulfil the Group's responsibility to society, guideline regarding environmental protections have been set and constantly reviewed by management. The guideline includes disposal of wastes and sewage, uses of chemicals and minimize pollutions that may be caused. All works and materials used by sub-contractors have to comply with the policy.

Sub-contractors are assessed continuously based on performances, time of completion and services provided during the retention period of the project. Suppliers are assessed continuously based on delivery time, quality of materials and after-sales services. To ensure the delivery of materials, geographical region of the supplier is also concerned. As at 31 December 2020, the Group had 212 qualified materials suppliers and 82 qualified sub-contractors.

During the year, no major complaints on the quality of materials used and the performance of works have been received.

勞工標準

The Group is responsible to the main contractor for the works the Group had completed and had not encountered any product recall issues or quality issue. Wing Fung HK has been accredited with ISO 9001: 2008 for its quality management system since 2013. The Group implements a series of quality control measures to ensure the quality of works:

- Trainings are provided to our project management teams and our subcontracted workers to ensure their understanding of, and compliance with, our quality standards;
- Onsite inspections and rectification are carried out at each construction site. Immediate rectification measures would be taken if any quality control issues are identified. Upon rectification, we re-inspect the quality control issues to ensure that such issues have been resolved; and
- We require sub-contractors to fully abide by our quality control measures when performing work for our construction projects.

The Group did not receive any significant complaints relating to our services provided and works due to safety and health reasons during the year ended 31 December 2020. Furthermore, the Group was not aware of any incidents of non-compliance with laws and regulations that bring significant impact to the Group concerning health and safety advertising and labelling relating to products and privacy matters relating to customers.

Reported incidents will be thoroughly investigated and any misconducts would result in disciplinary actions.

CORPORATE REORGANISATION

The Company was incorporated in the Cayman Islands as an exempted company with limited liability on 29 September 2016 under the Companies Law, Chapter 22 (Law 3 of 1961, as consolidated and revised) (the “Companies Law”) of the Cayman Islands.

The companies now comprising the Group underwent a reorganisation (the “Reorganisation”) to rationalise the structure of the Group in preparation for the Listing. Pursuant to the Reorganisation, the Company became the holding company of the subsidiaries now comprising the Group. Further details of the Reorganisation are set out in the section headed “History, Development and Reorganisation” in the Prospectus. The Shares were listed on the GEM of the Stock Exchange on 27 February 2018 (the “Listing Date”).

PRINCIPAL ACTIVITIES AND BUSINESS REVIEW

The principal activity of the Company is investment holding. The Group is principally engaged as a subcontractor for the provision of supply, installation and fitting-out services of MVAC systems for buildings in Hong Kong and Macau. The projects of the Group can generally be categorized into private sector projects and public sector projects. A list of the subsidiaries of the Company and details of their principal activities of are set out in note 28 to the consolidated financial statements. There were no significant changes to the Group’s principal activities during the year.

All Directors are also subject to retirement by rotation at least once every three years pursuant to the requirements of the Articles and the applicable Listing Rules. The service agreement of each executive Director and the letter of appointment of each INED have been renewed for another term of 3 years since 27 February 2021 on the same terms and conditions.

Save as disclosed above, none of the Directors proposed for re-election at the forthcoming AGM has or is proposed to have any service contracts with the Company or any of its subsidiaries which is not determinable by the Group within one year without payment of compensation, other than the statutory compensation.

Any Director appointed pursuant to Article 16.2 or Article 16.3 shall not be taken into account in determining which Directors are to retire by rotation. A retiring Director shall retain office until the close of the meeting at which he retires and shall be eligible for re-election thereat. The Company at any annual general meeting at which any Directors retire may fill the vacated office by electing a like number of persons to be Directors.

Pursuant to Article 16.2 of the Articles, the Board shall have the power from time to time and at any time to appoint any person as a Director either to fill a casual vacancy or as an addition to the Board. Any Director so appointed shall hold office only until the next following general meeting of the Company and shall then be eligible for re-election at that meeting. Further, according to Article 16.3 of the Articles, the Company may from time to time in general meeting by ordinary resolution increase or reduce the number of Directors but so that the number of Directors shall not be less than two. Subject to the provisions of these Articles and the Companies Law of the Cayman Islands, the Company may by ordinary resolution elect any person to be a Director either to fill a casual vacancy or as an addition to the existing Directors. Any Director so appointed shall hold office only until the next following general meeting of the Company and shall then be eligible for re-election.

In accordance with Article 16.18 of the Articles, Ms. Lai Suk Fan and Mr. Choy Hiu Fai Eric shall retire by rotation at the forthcoming AGM and, being eligible, offer themselves for re-election at the forthcoming AGM.

In addition, contract value may also be subject to changes due to variations of works, claims or disputes with customers.

1 General information

Wing Fung Group Asia Limited (the “Company”) was incorporated in the Cayman Islands on 29 September 2016 as an exempted company with limited liability under Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The address of the Company’s registered office is PO Box 309, Uglund House, Grand Cayman, KY1-1104, Cayman Islands and the principal place of business of Unit 13 & 14, 9th Floor, Worldwide Industrial Centre, 43–47 Shan Mei Street, Fotan, the New Territories, Hong Kong was valid until 31 December 2020. The new principal place of business is Unit D, 21st Floor, Tower B, Billion Centre, 1 Wang Kwong Road, Kowloon Bay, Kowloon, Hong Kong, effective from 1 January 2021.

The Company is an investment holding company and its subsidiaries (together, the “Group”) are principally engaged in the provision of supply, installation and fitting-out services of mechanical ventilation and air-conditioning (“MVAC”) system for buildings. The Company’s immediate and ultimate holding company is Wing Fung Capital Limited, a private company incorporated in the British Virgin Islands (the “BVI”).

The consolidated financial statements are presented in Hong Kong dollars (“HK\$”), which is the functional currency of the Company.

The Company listed its shares on GEM of The Stock Exchange of Hong Kong Limited on 27 February 2018 (the “Listing”).

2 Summary of significant accounting policies

The principal accounting policies applied in the preparation of these consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

2.3 Foreign currency translation

(i) Functional and presentation currency

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates ('the functional currency'). The consolidated financial statements are presented in HK\$, which is the Company's functional and presentation currency.

(ii) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are generally recognised in profit or loss.

Investments in subsidiaries are accounted for at cost less impairment. Cost includes direct attributable costs of investment. The results of subsidiaries are accounted by the Company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets.

2.5 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision maker. The chief operating decision maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the executive directors of the Company who make strategic decisions. Details refer to Note 5 of the financial statements.

Plant and equipment are stated at historical cost less accumulated depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to profit or loss during the reporting period in which they are incurred.

Depreciation is calculated using the straight-line method to allocate their cost to their residual values over their estimated useful lives or, as follows:

Motor vehicles	4 to 5 years

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 2.7).

Other assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Non-financial assets that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

2.8 Financial assets

(i) Classification

The Group classifies its financial assets to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

Financial assets at amortised costs are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. If collection of the amounts is expected in one year or less they are classified as current assets. If not, they are presented as non-current assets. The Group's financial assets at amortised cost comprise of trade receivables, other receivables and deposits, pledged and restricted bank deposits and cash and cash equivalents.

(ii) Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

(iii) Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at fair value through profit or loss are expensed in profit or loss.

Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. A gain or loss on a debt investment that is subsequently measured at amortised cost and is not part of a hedging relationship is recognised in profit or loss when the asset is derecognised or impaired. Interest income from these financial assets is included in other income using the effective interest method.

(iv) Impairment

The Group assesses on a forward-looking basis the expected credit losses associated with its debt instruments carried at amortised cost. The impairment methodology applied depends on whether there has been significant increase in credit risk.

For trade receivables and contract assets, the Group applied the simplified approach permitted under HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

For other receivables and deposits, it is measured at either 12-month expected credit losses or lifetime expected loss, depending on whether there has been a significant increase in credit risk since initial recognition. If a significant increase in credit risk of a receivable has occurred since initial recognition, then impairment is measured as lifetime expected credit losses.

For cash and cash equivalents and pledged and restricted bank deposits, it is also subject to impairment requirements under HKFRS 9, yet the impairment loss is immaterial because the Group only transacts with reputable international financial institutions with high credit ratings assigned by international credit-rating agencies.

(v) Write-off policy

The Group writes off a financial asset when there is information indicating that the counterparty is in severe financial difficulty and there is no realistic prospect of recovery, for example, when the counterparty has been placed under liquidation or has entered into bankruptcy proceedings, or in the case of trade receivables, when the amounts are over three years past due, whichever occurs sooner. Financial assets written off may still be subject to enforcement activities under the Group's recovery procedures, taking into account legal advice where appropriate. A write-off constitutes a derecognition event. Any subsequent recoveries are recognised in profit or loss.

Financial assets and liabilities are offset and the net amount is reported in the statement of financial position where the Group or group entities currently has a legally enforceable right to offset the recognised amounts, and there is an intention to settle on a net basis or realise the asset and settle the liability simultaneously.

2.10 Trade receivables

Trade receivables are amounts due from customers for goods sold or services performed in the ordinary course of business. They are generally due for settlement within 30 days to 45 days and therefore all classified as current.

Trade receivables are recognised initially at the amount of consideration that is unconditional unless they contain significant financing components, when they are recognised at fair value. The Group holds the trade receivables with the objective of collecting the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method.

2.11 Cash and cash equivalents

For the purpose of presentation in the consolidated statement of cash flows, cash and cash equivalents include cash on hand and deposits held at call with financial institutions with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities in the statement of financial position.

Pledged bank deposits are separately presented from cash and cash equivalents.

2.13 Share capital

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new share or options are shown in equity as a deduction, net of tax, from the proceeds.

2.14 Trade and other payables

Trade payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers. Trade payables and other payables are classified as current liabilities if payment is due within one year or less (or in the normal operating cycle of the business if longer). If not, they are presented as non-current liabilities.

Trade and other payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

2.15 Borrowings

Borrowings are initially recognised at fair value, net of transaction costs incurred. Borrowings are subsequently measured at amortised cost. Any difference between the proceeds (net of transaction costs) and the redemption amount is recognised in profit or loss over the period of the borrowings using the effective interest method.

In this case, the fee is deferred until the draw-down occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a prepayment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liabilities for at least 12 months after the reporting period.

2.16 Current and deferred income tax

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred income tax assets and liabilities attributable to temporary differences and to unused tax losses.

(i) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting period in the countries where the Company and its subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

However, deferred income tax liabilities are not recognised if they arise from the initial recognition of goodwill. Deferred income tax is also not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantially enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred income tax assets are recognised only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred income tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in foreign operations where the company is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

Provisions for legal claims, service warranties and make good obligations are recognised when the Group has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation and the amount can be reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole.

The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

2.18 Revenue recognition*Revenue from contracts with customers*

A performance obligation represents a good or service (or a bundle of goods or services) that is distinct or a series of distinct goods or services that are substantially the same. Control is transferred over time and revenue is recognised over time by reference to the progress towards complete satisfaction of the relevant performance obligation if one of the following criteria is met:

- the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- the Group's performance creates and enhances an asset that the customer controls as the Group performs; or
- the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

Over time revenue recognition: measurement of progress towards complete satisfaction of a performance obligation

The progress towards complete satisfaction of a performance obligation is measured based on output method, which is to recognise revenue on the basis of direct measurements of the value of the goods or services transferred to the customer to date relative to the remaining goods or services promised under the contract, that best depict the Group's performance in transferring control of goods or services.

(b) Short-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the service. All short term employee benefits are recognised as an expense unless another HKFRS requires or permits the inclusion of the benefit in the cost of an asset. A liability is recognised in respect for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

(c) Termination benefits

Termination benefits are recognised at the earlier of when the Group can no longer withdraw the offer of those benefits and when the Group recognises restructuring costs involving the payment of termination.

(d) Bonus plans

The Group recognises a liability and an expense for bonuses based on a formula that takes into consideration the profit attributable to the Company's shareholder. The Group recognises a provision where contractually obliged or where there is a past practice that has created a constructive obligation.

Leases are recognised as right-of-use assets and corresponding liabilities at the date at which the leased asset is available for use by the Group.

Contracts may contain both lease and non-lease components. The Group allocates the consideration in the contract to the lease and non-lease components based on their relative stand-alone prices. However, for leases of property for which the Group is a lessee, it has elected not to separate lease and non-lease components and instead accounts for these as a single lease component.

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable;
- variable lease payments that are based on an index or a rate, initially measured using the index or rate as at the commencement date;
- amounts expected to be payable by the Group under residual value guarantees;
- the exercise price of a purchase option if the Group is reasonably certain to exercise that option; and
- payments of penalties for terminating the lease, if the lease term reflects the Group exercising that option.

Lease payments to be made under reasonably certain extension options are also included in the measurement of the liabilities.

The lease payments are discounted using the interest rate implicit in the lease. If that rate cannot be readily determined, which is generally the case for leases in the Group, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset of similar value to the right-of-use asset in a similar economic environment with similar terms, security and conditions.

To determine the incremental borrowing rate, the Group:

- where possible, uses recent third-party financing received by the individual lessee as a starting point, adjusted to reflect changes in financing conditions since third party financing was received;
- uses a build-up approach that starts with a risk-free interest rate adjusted for credit risk for leases held by the Group, which does not have recent third party financing; and
- makes adjustments specific to the lease, e.g. term, country, currency and security.

Lease payments are allocated between principal and finance cost. The finance cost is charged to profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liabilities for each period.

Right-of-use assets are generally depreciated over the shorter of the asset's useful life and the lease term on a straight-line basis. Payments associated with short-term leases of equipment and vehicles and all leases of low-value assets are recognised on a straight-line basis as an expense in profit or loss. Short-term leases are leases with a lease term of 12 months or less.

2.21 Dividend distribution

Dividend distributions to the Company's shareholders are recognised as a liability in the Group's consolidated financial statements in the period in which the dividends are approved by the Company's shareholders or directors, where appropriate.

2.22 Government grants

Grants from the government are recognised at their fair value where there is a reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

Government grants relating to costs are deferred and recognised in the profit or loss over the period necessary to match them with the costs that they are intended to compensate.

3 Financial risk management**3.1 Financial risk factors**

The Group's activities expose it to a variety of financial risks: interest rate risk, currency risk, credit risk and liquidity risk. The Group's overall risk management approach focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

(a) Market risk*(i) Interest rate risk*

The Group's cash flow interest rate risk relates primarily to variable-rate bank balances and restricted bank deposits as disclosed in Note 18 and bank borrowings as disclosed in Note 21 due to the fluctuation of the prevailing market interest rate. The Group is also exposed to fair value interest rate risk in relation to the Group's fixed-rate pledged bank deposits as disclosed in Note 18. The Group's cash flow interest rate risk is mainly concentrated on the fluctuation of interest rates on bank balances and Hong Kong Prime Rate quoted by the lending bank arising from the Group's Hong Kong dollar denominated borrowings. The Group aims at keeping borrowings at variable rates. The Group currently does not have a policy on hedging interest rate risk. However, the management monitors interest rate exposure and will consider hedging significant interest rate risk should the need arise.

本集團業務承受各種財務風險：利率風險、貨幣風險、信貸風險及流動資金風險。本集團整體的風險管理方式乃集中於不可預測的金融市場，並尋求降低對本集團財務表現的潛在負面影響。

本集團的現金流量利率風險主要指附註18所披露的浮息銀行結餘及受限制銀行存款和附註21披露的銀行借款因現行市場利率波動而引致的風險。本集團亦面臨有關本集團固定利率已抵押銀行存款的公平值利率風險（於附註18披露）。本集團的現金流利率風險主要集中於源於本集團港元計值借貸的銀行結餘利率及借款銀行所報香港最優惠利率波動。本集團的目標為維持以可變利率獲得借貸。本集團現時並無利率風險對沖政策。然而，管理層監察利率風險並於必要時考慮對沖重大利率風險。

The sensitivity analysis below has been determined based on the exposure to interest rates for variable-rate bank borrowings. The analysis is prepared assuming the amount of liability outstanding at each reporting period end was outstanding for the whole year. A 100 basis point increase or decrease is used which represents management's assessment of the reasonably possible change in interest rates. If interest rates had been 100 basis points (2019: 100 basis points) higher/lower and all other variables were held constant, the Group's profit for the year ended 31 December 2020 would decrease/increase by HK\$319,000 (2019: decrease/increase by HK\$54,000).

No sensitivity analysis has been prepared for the exposure to interest rate risk on the Group's bank balances and restricted bank deposits as the directors of the Company consider that the exposure is minimal.

The Group's exposure to currency risk mainly arises from the fluctuation of HK\$ against the functional currency of a subsidiary of the Company that has adopted MOP as functional currency and has foreign currency denominated monetary assets denominated in HK\$. The management closely monitors foreign exchange exposure to mitigate the foreign currency risk. As MOP is pegged to HK\$, the Group's foreign currency risk exposure is not considered to be significant.

(b) Credit risk

Credit risk of the Group mainly arises from trade receivables, contract assets, other receivables and deposits, pledged and restricted bank deposits, cash and cash equivalents. The carrying amounts of these balances except cash on hand in the consolidated statement of financial position represent the Group's maximum exposure to credit risk in relation to its financial assets.

Cash and cash equivalents and pledged and restricted bank deposits

The majority of the Group's bank balances are placed in financial institutions which are independently rated with high credit ratings. Management does not expect any losses from non-performance by these financial institutions as they have no default history in the past.

本集團的貨幣風險主要源於港元兌本集團附屬公司功能貨幣的波動，該附屬公司已採納澳門幣為功能貨幣且持有以港元計值的外幣計值貨幣資產。管理層緊密監察外匯風險以減少外幣風險。由於澳門幣與港元掛鈎，本集團的外幣風險被視為並不重大。

(b) 信貸風險

本集團之信貸風險主要來自貿易應收款項、合約資產、其他應收款項及按金、已抵押及受限制銀行存款、現金及現金等價物。綜合財務狀況表內該等結餘(手頭現金除外)的賬面值代表本集團就其金融資產所承受的最高信貸風險。

現金及現金等價物及已抵押及受限制銀行存款

本集團大部分銀行結餘存放於獲獨立評級的高信貸評級的金融機構。由於該等金融機構過往並無違約記錄，故管理層預期我們不會因該等機構不履行責任而蒙受任何損失。

Other receivables and deposits are also subject to the impairment requirements under HKFRS 9. It is measured as either 12-month expected credit losses or lifetime expected credit loss, depending on whether there has been a significant increase in credit risk since initial recognition. If a significant increase in credit risk of a receivable has occurred since initial recognition, impairment is measured as lifetime expected credit losses. The Group also take into account forward-looking information in the impairment of the other receivables and deposits. As at 31 December 2020 and 2019, the identified impairment loss for other receivables and deposits is assessed to be minimal.

Trade receivables and contract assets

For trade receivables and contract assets, the Group applies the HKFRS 9 simplified approach to measuring expected credit losses which uses a lifetime expected credit loss allowance for all trade receivables and contract assets without financing components.

Ultimate responsibility for liquidity risk management rests with the directors of the Company, who have built an appropriate liquidity risk management framework for the management of the Group's short, medium and long-term funding and liquidity management requirements. Bank borrowings with a repayment on demand clause are included in the "on demand or less than 1 year" time band in the above maturity analysis. As at 31 December 2020, the aggregate undiscounted principal amounts of bank borrowings and overdrafts amounted to approximately HK\$38,465,000 (2019: HK\$6,623,000). Taking into account the Group's financial position, the directors do not believe that it is probable that the bank will exercise its discretionary right to demand immediate repayment. The directors believe that such bank borrowings and overdrafts will be repaid in one year (2019: one year) after the end of the reporting period in accordance with the scheduled repayment dates set out in the bank borrowing agreements.

3.2 Capital risk management

The Group manages capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to the shareholders through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior year.

The gearing ratio increased from approximately 7.1% as at 31 December 2019 to approximately 31.7% as at 31 December 2020, primarily due to the increase in the total interest-bearing borrowings which was due to the drawdown of revolving loans and bank overdrafts during the year and the increase in total equity resulting from the increase in retained earnings attributable to recording a net profit for the year ended 31 December 2020.

The directors of the Company review the capital structure on a regular basis. As part of this review, the directors of the Company consider the cost of the risk associated with each class of capital. Based on recommendations of the directors of the Company, the Group will balance its overall capital structure through the payment of dividends, new share issues as well as the issue of new debts or repayment of existing debts.

4 Critical accounting estimates and judgements

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below:

(a) Construction contracts

Management measures the progress towards completion of the Group's performance obligations based on output method, which is to recognise revenue on the basis of measuring the progress of each performance obligation satisfied over time by reference to the value of construction works completed to date as a portion of the total contract value of the relevant construction contracts. The management's estimate of revenue and the progress of construction works requires significant judgement and has a significant impact on the amount and timing of revenue recognised.

Management periodically measures the value of the construction works completed for each construction project based on results as certified by external surveyors or evaluated by internal project managers and estimates the value of works completed but yet to be certified at the end of each reporting period. Management estimated the value of uncertified works based on surveys carried out by internal project managers and revisited with reference to certification subsequently performed by external surveyors. Management's estimation of the value of the works may also be subject to changes due to variations of works, claims or disputes with customers. The Group regularly reviews and revises the estimation of construction contract progresses whenever there is any change in circumstances.

(b) Impairment of trade receivables and contract assets

The Group follows the guidance of HKFRS 9 to determine the expected credit loss for trade receivables and contract assets. Significant judgement is exercised on the assessment of the lifetime expected credit losses for the trade receivables and contract assets (i.e. ECL assessment). For the ECL assessment, trade receivables have been assessed based on credit risk characteristics of the customers with reference to a wide range of factors such as default rates of customers, aging profile of overdue balances, the repayment and default histories of different customers, on-going business relationship with the relevant customers and forward-looking information that affecting the customers' ability to repay the outstanding balances. At every reporting date, the expected credit losses are reassessed and changes in the forward-looking information are considered. Details of the assumptions and inputs used are discussed in Note 3.
