References are made to the announcement of Loco Hong Kong Holdings Limited (the “**Company**”) dated 12 August 2021 in relation to the placing of new shares under general mandate (the “**Announcement**”). Unless otherwise stated, capitalised terms used herein shall bear the same meanings as defined in the Announcement.

COMPLETION OF PLACING OF NEW SHARES UNDER GENERAL MANDATE

The Board is pleased to announce that all conditions to the Placing Agreement have been fulfilled and completion of the Placing took place on 19 August 2021. A total of 138,234,000 Placing Shares have been successfully placed by the Placing Agent to not less than six Places at Placing Price of HK\$0.2 per Placing Share pursuant to the terms and conditions of the Placing Agreement, representing (i) 20% of the issued share capital of the Company immediately before the Placing; and (ii) approximately 16.67% of the issued share capital of the Company as enlarged by the allotment and issue of the Placing Shares immediately upon completion of the Placing.

To the best of the Directors' knowledge, information and belief, having made all reasonable enquiries, the Placees and their respective ultimate beneficial owners (if any) are professional, institutional, or other investors who are third parties independent of the Company and its connected persons, and none of the Placees is a substantial shareholder (as defined under the GEM Listing Rules) of the Company upon completion of the Placing. The net proceeds (after deducting the placing commission and other related expenses and professional fees) from the Placing of 138,234,000 Placing Shares amounted to approximately HK\$27,286,800. The Company intends to apply such net proceeds from the Placing for the trading of precious metals, which is the principal business activity of the Company, and for general working capital as well.
