NOTES:

1. ORGANISATION AND OPERATIONS

The Company was established as a state-owned enterprise in the People's Republic of China (the "PRC") in 1989. On 29 December 1995, under the relevant provisions of the Company Law of the PRC, the Company was re-organized from a state-owned enterprise to a limited liability company. On 16 August 1996, with the approval of the Economic Restructuring Commission of Jilin Province, the Company was further converted into a joint stock limited company. On 20 April 1999, the Company made a bonus issue from capitalisation of retained profits at the proportion of one bonus share for every two existing shares. The Company's H shares were listed on GEM of The Stock Exchange of Hong Kong Limited on 24 May 2001.

The Group is principally engaged in the manufacture and distribution of Chinese medicines and pharmaceutical products in the PRC under the brand names of Changlong and Shendi.

2. BASIS OF PREPARATION

The unaudited quarterly financial statements of the Group have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and interpretations issued by Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance.

The accounting policies adopted in preparing the unaudited consolidated results for the nine months and three months ended 30 September 2021 are consistent with those followed in the preparation of the Group's annual financial statements for the year ended 31 December 2020.

The condensed consolidated results for the nine months and three months ended 30 September 2021 are unaudited and have been reviewed by the audit committee of the Company.

3. TURNOVER AND REVENUE

The Group's turnover comprises the invoiced value of merchandise sold net of value added tax and after allowances for returns and discounts.

4. SEGMENTAL INFORMATION

The Group has only one business segment which is in the manufacture and distribution of biochemical medicines in the PRC. For the nine months ended 30 September 2021, turnover of the Group is generated entirely from sales in the PRC and all identifiable assets of the Group are located in PRC. Accordingly, no business or geographical segmental analysis is prepared for the period.

The PRC income tax is computed according to the relevant laws and regulations in the PRC. The applicable income tax rate was 15% (2020: 15%).

The Group did not have any significant unprovided deferred taxation for the nine months and three months ended 30 September 2021 (2020: Nil).

6. EARNINGS PER SHARE

The calculation of basic earnings per share for the nine months and three months ended 30 September 2021 is based on the unaudited profit attributable to equity holders of approximately RMB96,969,000 and RMB47,992,000 respectively (2020: RMB83,027,000 and RMB31,341,000) and on the weighted average of 560,250,000 and 560,250,000 (2020: 560,250,000 and 560,250,000) shares in issue during the two period ended 30 September 2021 respectively.

There is no diluted earnings per share because there were no dilutive potential shares in existence during the relevant periods.

7. DIVIDENDS

The Board does not recommend the payment of an interim dividend for the nine months ended 30 September 2021 (2020: Nil).

BUSINESS REVIEW AND PROSPECTS

OPERATING RESULTS

For the nine months ended 30 September 2021, the Group recorded a turnover of approximately RMB473,661,000, representing an increase by 7.5% from RMB440,471,000 during the corresponding period in 2020. Profit attributable to shareholders for the nine months ended 30 September 2021 was RMB96,969,000, representing an increase by 16.8% from RMB83,027,000 during the corresponding period in 2020.

The gross profit margin for the period ended 30 September 2021 was approximately 80.14%, representing a 4.85% decrease as compared to that of 84.99% for the same period last year.

The selling expense as a percentage of turnover was 45.3% in 2021. This represented a decrease from 45.9% when compared to the same period last year. The decrease in selling expenses was due to a decrease in the advertising and promotional expenses. General and administrative expenses decrease from RMB101,222,000 to RMB60,497,000 for the same period in 2021.

BUSINESS REVIEW

Production Facilities

During the year, the Company upgraded the plant and ground of the No. 1 pre-treatment and extraction workshop and No. 3 solid dosage pills production workshop, and purchased new equipment to improve production capacity and meet market demand.

During the year, No. 2 small-volume injection workshop, No. 3 small-volume injection workshop, the oral liquid workshop and No. 2 bulk drug workshop were newly built for the research and development and production of generic drugs, and 16 varieties are expected to be developed. The Company's product mix has continued to expand, its research and development capabilities and market competitiveness have also improved.

LIQUIDITY AND FINANCIAL RESOURCES

The Group has maintained a sound financial position during this period. For the nine months ended 30 September 2021, the Group's primary source of funds was cash from the operating activities. As at 30 September 2021, the Group had cash and bank balances and consolidated net asset value of approximately RMB809,265,000 and RMB1,442,451,000 respectively.

For the nine months ended 30 September 2021, the Group mainly generated revenue and incurred costs in Hong Kong dollars and Renminbi. The Directors consider the impact on foreign exchange exposure of the Group is minimal.

GEARING RATIO

As at 30 September 2021, the Group had short-term bank borrowings of RMB Nil and a gearing ratio of 0%. The calculation of the gearing ratio was based on the short-term bank loans and shareholders' equity as at 30 September 2021.

FUTURE PROSPECTS

Looking ahead, the management believed that Hai Kun Shen Xi capsule has reached maturity in the market and this medicine has taken over the Compound Huonaoshu capsule as our best selling product.

The Directors also would like to take this opportunity to express their gratitude to the management and staff for their dedication and contribution to the Group, and to thank our fellow business partners and equity holders for their continuing support. The Directors will endeavor to explore every potential opportunity for business growth, creating a promising future and successful results in the years ahead.

COMPETING INTEREST

During the period under review, none of the Directors, the management shareholders, the significant shareholders or the substantial shareholders (as defined in the GEM Listing Rules) of the Company had any interest in a business which competes or may compete with the business of the Group.

CODE OF CONDUCT REGARDING SECURITIES TRANSACTIONS BY DIRECTORS

During the nine months ended 30 September 2021, the Company has adopted a code of conduct regarding securities transactions by directors on terms no less than the required standard of dealings as set out in Rules 5.48 to 5.67 of the GEM Listing Rules. The Company has also made specific enquiry of all Directors and the Company was not aware of any non-compliance with the required standard of dealings and its code of conduct regarding securities transactions by Directors.

BOARD PRACTICES AND PROCEDURES

During the period under review, the Company had not fully complied with the board practices and procedures as set out in Rule 5.34 of the GEM Listing Rules in respect of the Code on Corporate Governance Practices (the "CCGP"). The main deviations from the code provision set out in the CCGP were as follows:

Under the code provision A.2.1, the roles of chairman and chief executive officer should be separate and should not be performed by the same individual. Mr. Zhang Hong assumes the role of both the chairman and the chief executive officer of the Company. The Board is of the view that this has not compromised accountability and independent decision making for the following reasons:

- the Audit Committee composes exclusively of independent non-executive directors;
- the independent directors have free and direct access to the Company's external auditors and independent professional advice when considered necessary.

Mr. Zhang Hong, the chairman, is a substantial shareholder of the Company and has considerable industry experience. He is motivated to contribute to the growth and profitability of the Group. The Board is of the view that it is in the best interests of the Group to have an executive chairman so that the Board can have the benefit of a chairman who is knowledgeable about the business of the Group and is most capable to guide discussions and brief the Board in a timely manner on pertinent issues and developments to facilitate open dialogue between the Board and the management.

AUDIT COMMITTEE

The Company set up an audit committee (the "Committee") on 24 May 2001 with written terms of reference in compliance with the requirements as set out in Rules 5.28 and 5.29 of the GEM Listing Rules. The primary duties of the Committee are to review and provide supervision over the financial reporting procedures and internal control system of the Group.

The committee has reviewed with the management the accounting principles and practices adopted by the Group and discussed internal controls and financial reporting matters, including a review of the unaudited results of the Group for the period ended 30 September 2021.

PURCHASE, REDEMPTION OR SALE OF LISTED SECURITIES

During the nine months ended 30 September 2021, neither the Company nor its subsidiaries purchased, sold or redeemed any of the Company's listed shares.
