# NOTES TO THE CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

## 簡明綜合財務報表附註

### 1. CORPORATE INFORMATION

Grand T G Gold Holdings Limited (the “**Company**”) was incorporated in the Cayman Islands as an exempted company with limited liability under the Companies Law, Cap 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. Its principal place of business in Hong Kong is Room A–B, 8th Floor, Centre Mark II, 305–313 Queen’s Road Central, Sheung Wan, Hong Kong. The Company’s shares are listed on the GEM of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The principal places of the business of the Company are in The People’s Republic of China (“**PRC**”) and Hong Kong. The principal activity of the Company is investment holding. Its subsidiaries (together with the Company collectively referred to as the “**Group**” hereinafter) are principally engaged in gold exploration, mining and mineral processing.

The unaudited condensed consolidated financial statements are presented in Hong Kong dollars (“**HK\$**”), and the functional currency of the Company is HK\$, with values rounded to the nearest thousand. The functional currency of the Group’s only operating subsidiary Tungguan Taizhou Mining Company Limited (“**Taizhou Mining**”) is Renminbi (“**RMB**”).

### 2. BASIS OF PREPARATION

The unaudited interim condensed consolidated financial statements for the six months ended 30 September 2021 have been prepared in compliance with Hong Kong Accounting Standard (“**HKAS**”) 34 “Interim financial reporting” issued by the Hong Kong Institute of Certified Public Accountants (the “**HKICPA**”) and the Rules Governing the Listing of Securities on the GEM of the Stock Exchange (the “**GEM Listing Rules**”).

### 1. 公司資料

大唐滄金控股有限公司(「**本公司**」)根據開曼群島法例第22章公司法(一九六一年法律第3章, 經綜合及修訂)在開曼群島註冊成立為一間獲豁免有限公司。其香港主要營業地點為香港上環皇后大道中305–313號永業中心8樓A-B室。本公司股份在香港聯合交易所有限公司(「**聯交所**」)GEM上市。

本公司的主要營業地點為中華人民共和國(「**中國**」)及香港。本公司之主要業務為投資控股。其附屬公司(連同本公司於下文統稱為「**本集團**」)之主要業務為黃金勘探、開採及礦物加工。

未經審核簡明綜合財務報表以港元(「**港元**」)呈列, 及本公司之功能貨幣為港元, 若干價值已四捨五入至最接近千位數。本集團唯一營運附屬公司滄關縣太洲礦業有限責任公司(「**太洲礦業**」)的功能貨幣為人民幣(「**人民幣**」)。

### 2. 編製基準

截至二零二一年九月三十日止六個月之未經審核中期簡明綜合財務報表乃遵照香港會計師公會(「**香港會計師公會**」)頒佈之香港會計準則(「**香港會計準則**」)第34號「中期財務報告」以及聯交所GEM證券上市規則(「**GEM上市規則**」)而編製。

### 2. BASIS OF PREPARATION (Continued)

The preparation of the unaudited condensed consolidated financial statements in conformity with HKAS 34 requires management to make judgements, estimates and assumptions that affect the application of policies and reported amounts of assets and liabilities, income and expenses on a period-to-date basis. Actual results may differ from these estimates.

The unaudited condensed consolidated financial statements should be read in conjunction with the Group's annual financial statements for the year ended 31 March 2021 ("2021 Annual Report"). The Group's policies on financial risk management were set out in the financial statements included in the Company's 2021 Annual Report and there have been no significant changes in the financial risk management policies for the six months ended 30 September 2021.

The unaudited condensed consolidated financial statements have been prepared under the historical cost convention, as modified by the revaluation of certain financial instruments which are carried at fair value.

The accounting policies and methods of computation used in the unaudited condensed consolidated financial statements for the six months ended 30 September 2021 are the same as those followed in the preparation of the Group's annual financial statements for the year ended 31 March 2021.

### 2. 編製基準(續)

根據香港會計準則第34號編製未經審核簡明綜合財務報表需管理層作出判斷、估計及假設，該等判斷、估計及假設會影響期初至今所採用政策及資產與負債之呈報金額、收入及開支。實際結果可能有別於該等估計。

未經審核簡明綜合財務報表應與本集團截至二零二一年三月三十一日止年度之年度財務報表(「二零二一年年報」)一併閱讀。本集團有關財務風險管理之政策乃載於本公司之二零二一年年報所載之財務報表及截至二零二一年九月三十日止六個月之財務風險管理政策並無重大變動。

未經審核簡明綜合財務報表已按歷史成本方法編製，並根據若干按公平值計量之財務工具之重新估值作出修訂。

截至二零二一年九月三十日止六個月之未經審核簡明綜合財務報表所用之會計政策及計算方法與編製本集團截至二零二一年三月三十一日止年度之年度財務報表所遵循者相同。

### 2. BASIS OF PREPARATION (Continued)

The Group had incurred loss after tax of approximately HK\$4.1 million for the six months ended 30 September 2021 (six months ended 30 September 2020: loss after tax of approximately HK\$9.3 million) and had net current liabilities of approximately HK\$190.0 million as at 30 September 2021 (31 March 2020: net current liabilities of HK\$169.1 million). As at 30 September 2021, the Group's liabilities included convertible bonds with principal amount of approximately HK\$30.1 million (31 March 2021: HK\$30.1 million) which is repayable in 2022.

As disclosed in the announcement of the Company issued on 22 August 2018, the Company has been served a writ of summons together with an indorsement of claim, claiming the repayment of the principal sum of HK\$30,095,357 together with the interest incurred thereon under a series of convertible bonds (the “**Convertible Bonds**”) issued by the Company to Leung Heung Ying (“**Mr. Leung**”) pursuant to a conditional subscription agreement (the “**Subscription Agreement**”) dated 17 July 2017 entered into between the Company and J. Thomson Asset Investment Limited (“**J. Thomson**”). To the best of the knowledge of the Company, J. Thomson is wholly and beneficially owned by Mr. Leung. The legal proceeding (the “**Action**”) is still ongoing up to the date of this report. As at the date of this report, the Company had entered into an agreement (the “**Repurchase Agreement**”) with Mr. Leung in relation to the repurchase of all of the outstanding Convertible Bonds. Pursuant to the Repurchase Agreement, the Company shall, upon completion of the Repurchase Agreement, firstly apply part of the net proceeds from the Rights Issue (“**Net Proceeds**”) to repay to Mr. Leung the principal of the Convertible Bonds in full and also such amount of outstanding interest of the Convertible Bonds accrued up to and including the completion date of the Repurchase Agreement before the Company can apply any amount of the Net Proceeds for other purposes. Mr. Leung had undertaken to the Company not to object to the Capital Reorganisation and the Rights Issue nor to exercise the conversion rights attached to the Convertible Bonds prior to completion or termination of the Repurchase Agreement, whichever date is the earlier.

### 2. 編製基準(續)

Notwithstanding the above conditions, the financial statements were prepared based on the assumption that the Group can be operated as a going concern having taken into consideration the arrangements which include, but not limited to, the following measures:

- (i) management will continue to control the operating costs and pay extra efforts to increase revenue with an aim to attain better operating cash flows;

# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論及分析

### BUSINESS REVIEW

The principal activity of the Company is investment holding. Its subsidiaries are principally engaged in gold exploration, mining and mineral processing with gold concentrate as its product.

### FINANCIAL REVIEW

#### Revenue

For the six months ended 30 September 2021 (the “**Reporting Period**”), the Group’s revenue was approximately HK\$51.7 million, representing an increase of approximately 12.7% from approximately HK\$45.9 million as compared with that of the corresponding period last year.

#### Gross profit and gross profit margin

During the Reporting Period, the Group’s gross profit was approximately HK\$15.1 million, representing an increase of approximately 13.4% from approximately HK\$13.3 million as compared with that of the corresponding period last year. During the Reporting Period, the Group’s overall gross profit margin was approximately 29.2% (six months ended 30 September 2020: 29.01%).

#### Selling and distribution expenses

During the Reporting Period, the Group’s selling and distribution expenses were approximately HK\$1.6 million, representing an decrease of approximately 38.5% from approximately HK\$2.6 million as compared with that of the corresponding period last year.

### 業務回顧

# MANAGEMENT DISCUSSION AND ANALYSIS

### Administrative and other expenses

During the Reporting Period, the Group's administrative and other expenses were approximately HK\$9.5 million, representing a decrease of approximately 23.2% from approximately HK\$12.4 million as compared with that of the corresponding period last year, which mainly due to decrease in staff costs.

### Loss for the Reporting Period

Unaudited consolidated loss of the Company amounted to approximately HK\$4.1 million for the Reporting Period, representing a decrease of approximately 59.1% from approximately HK\$9.3 million as compared with that of the corresponding period last year. The decrease in net loss is mainly derived to the drop in administrative cost and selling and distribution expenses as a result of costs control measured of the Company.

As a result of the above factors, the Group recorded an unaudited net loss attributable to equity holders of the Company approximately HK\$5.2 million (six months ended 30 September 2020: approximately HK\$9.0 million).

### Loss per share

Basic loss per share was approximately HK cents 0.35 for the Reporting Period (six months ended 30 September 2020: approximately HK cents 0.60).

### Dividend

The Board does not recommend the payment of an interim dividend for the six months ended 30 September 2021 (six months ended 30 September 2020: nil).

### Liquidity, financial resources and funding

As at 30 September 2021, the Group had cash and cash equivalents amounted to approximately HK\$10.1 million (31 March 2021: approximately HK\$5.9 million) and net current liabilities amounted to approximately HK\$190.0 million (31 March 2021: approximately HK\$169.1 million) whereas inventories of the Group amounted to approximately HK\$2.2 million (31 March 2021: approximately HK\$7.0 million).

As at 30 September 2021, the current ratio is approximately 0.14 (31 March 2021: approximately 0.19).

As at 30 September 2021, the Group's gearing ratio was approximately 0.51 (31 March 2021: approximately 0.52), calculated based on total borrowings over total assets.

### Borrowings

Borrowings information of the Group is set out in note 12 to the unaudited condensed consolidated financial statements.

### Charge on the Group's assets

As at 30 September 2021, the Group's interest-bearing borrowings were secured by its rights of payments from its customers.

### Treasury policies

The Group's monetary assets and transactions are principally denominated in HK\$ and RMB. Foreign exchange risk arises from future commercial transactions and recognised assets and liabilities.

The Group adopted a conservative treasury policy with most of the bank deposits being kept in HK\$ or RMB, or in the local currencies of the operating subsidiaries to minimise exposure to foreign exchange risk. The Group monitors and maintains a sufficient level of cash and cash equivalents to finance the Group's operations and mitigate the effects of fluctuation in cash flows. Management reviews and monitors the Group's working capital requirements regularly.

#### Segment information

The Group's segmental information is set out in note 3 to the unaudited condensed consolidated financial statements.

#### Exposure to exchange risks

Since the Group's borrowings and its source of income are primarily denominated in the respective group companies' functional currency which are mainly in HK\$ or RMB, the exposure to foreign exchange rate fluctuations is minimal.

#### Capital structure

As at 30 September 2020, the Company's issued share capital was HK\$89,806,929.624 which were divided into 1,496,782,160 shares of HK\$0.06 each.

#### Capital commitment

As at 30 September 2021, the Group did not have any significant capital commitments (31 March 2021: nil).

#### Convertible bonds

On 17 July 2017, the Company issued the Convertible Bonds with an aggregate principal amount of HK\$30,095,357 to Mr. Leung, the beneficial owner of J. Thomson, under the Subscription Agreement. The subscription monies payable by J. Thomson for the Convertible Bonds was settled by way of set off against the debt due by the Company to J. Thomson.

The initial conversion price of the Convertible Bonds was HK\$0.02 per share. Upon full exercise of the Convertible Bonds, 1,504,767,850 new ordinary shares of the Company will be issued and the shareholding of Mr. Ma Qianzhou, the substantial shareholder of the Company, will be diluted from approximately 13.41% to 12.57% of the total number of issued shares of the Company.

The Company had been served a writ of summons together with an indorsement of claim, claiming the repayment of the principal sum of HK\$30,095,357 together with the interest incurred thereon under the Convertible Bonds. For further details, please refer to the announcement of the Company dated 22 August 2018. The action is ongoing up to the date of this report.

As at the date of this report, the Company had entered into the Repurchase Agreement with Leung. For details, please refer to pages 12 and 13 of this report.

### **Significant investment, material acquisition and disposal of subsidiaries and affiliated companies, and future plans for material investments or capital assets**

The Group did not have any significant investment, material acquisition and disposal of subsidiaries and affiliated companies throughout the Reporting Period.

In addition, the Company is now focusing on developing and strengthening its existing business and will explore investment opportunities in order to broaden the income stream of the Group, enrich its reserves and resources, enhance the profitability of the Group and eventually bring a fruitful return to the shareholders of the Group.

#### Employees and remuneration policies

As at 30 September 2021, the Group had 65 employees (31 March 2020: 65) situated mainly in the PRC and Hong Kong. The Group's emoluments policies are formulated based on industry practices and performance of individual employees. For the six months ended 30 September 2021, the total staff costs (including directors' emoluments) amounted to approximately HK\$4.8 million (six months ended 30 September 2020: HK\$5.8 million). During the Reporting Period, no share option had been granted by the Company. Details of employees' remuneration are set out in note 6 to the unaudited condensed consolidated financial statements.

## MINERAL EXPLORATION, MINE DEVELOPMENT AND ORE MINING ACTIVITIES

#### Mineral Exploration and Mine Development

During the Reporting Period, Taizhou Mining completed certain mining development projects, including the excavation of approximately 3,737 meters of various tunnels, excavation of approximately 299 meters of slope supporting, excavation of approximately 448 meters of ore chute as well as excavation of approximately 1,121 meters for track laying and ditches.

During the Reporting Period, the Group's total expenditure for the mine development and mineral exploration amounted to approximately HK\$28.3 million.

#### Ore Mining

During the Reporting Period, the aggregate expenditure on the ore mining operation of the Group was approximately HK\$13.6 million.

### PROSPECT

Looking forward to the end of 2021 fiscal year, in the backdrop of the economy uncertainties by the impact of Novel Coronavirus outbreak and the China-US trade dispute increased tightening on mine operation regulations, its enhanced ecologic and environmental protection policies enforcement and other macroeconomic and policy factors, the Group is expected to face a number of challenges for the remaining of 2021. The Group will continue with utmost effort in fending off legal challenges, minimizing disturbances caused to the Company and moving into execution of the business development plan and growth of business. The Company will continue working hard to improve the Company's asset scale and quality as well as financial performance over time. In addition to organic growth from the company existing business, the Group will look for new potential growth opportunities in a very diligent manner through merger and acquisition, business integration and expansion in order to improve the profitability of the Group and the returns to the shareholders.

### 展望

The primary duties of the Audit Committee are to review the financial information of the Company, oversee the financial reporting process, risk management and internal control systems of the Group, maintain an appropriate relationship with the Company's auditors and provide advice and comments to the Board.

The Audit Committee has reviewed the unaudited condensed consolidated financial statements of the Company for the six months ended 30 September 2021 and is of the view that such results complied with the applicable accounting standards, the requirements under the GEM Listing Rules and other applicable legal requirements, and that adequate disclosures had been made.

### 3. Purchase, Sale or Redemption of Company's Listed Securities

During the Reporting Period, neither the Company nor any of its subsidiaries has purchased or sold any of its listed securities.

The Company strives to attain and maintain the highest standard of corporate governance as it believes that effective corporate governance practices are fundamental to enhancing its corporate value and safeguarding shareholder interests.

The principles of corporate governance adopted by the Group emphasize a quality board, sound internal control, transparency and accountability to all its shareholders.

The Company has adopted the code provisions (the “**Code Provision(s)**”) set out in the Corporate Governance Code and Corporate Governance Report (the “**Code**”) set out in Appendix 15 to the GEM Listing Rules and the Company had complied with all Code Provisions as set out in the Code in the Reporting Period, except for the following deviation:

#### *Code Provision A.2.1*

Code Provision A.2.1 of the Code stipulates that the roles of the chairman and the chief executive should be separate and should not be performed by the same individual.

### SHARE OPTION SCHEME

The following is a summary of the principal terms of the Share Option Scheme approved and adopted by resolutions of the shareholders at the extraordinary general meeting held on 27 September, 2021.

#### (1) Who may join?

(i) Any non-executive director including independent non-executive director of the Group or any entity in which the Group holds 30% or more of its equity interest (the “Invested Entity”); (ii) employee(s) (whether full time or part time employee(s), including any executive director but not any non-executive director) of the Group any Invested Entity; (iii) any supplier of goods or services to any member of the Group or any Invested Entity; (iv) any customer of the Group or any Invested Entity; (v) any consultant, adviser, agent and contractor engaged by the Group or any Invested Entity; and (vi) any shareholder of any member of the Group or any Invested Entity or any holder of any securities issued by any member of the Group or any Invested Entity, provided that the Board shall have absolute discretion to determine whether one falls within the aforesaid categories (collectively, the “Participants”).

#### (2) Purpose

The purpose of the Share Option Scheme is to provide incentives or rewards to Participants thereunder for their contribution to the Group and/or to enable the Group to recruit and retain high-calibre employees and attract human resources that are valuable to the Group and any Invested Entity.

#### (1) 參與人士

#### (2) 目的

購股權計劃旨在向計劃項下參與人士提供激勵或回報，以表彰彼等對本集團的貢獻，及/或令本集團能夠招聘或挽留高素質僱員並吸引對本集團及任何投資實體有價值的人力資源。

### (3) Maximum number of shares subject to the share options

The Shares which may be issued upon exercise of all right to subscribe for Shares (the “Options”) to be granted under the Share Option Scheme and other share option schemes of the Company (and to which the provisions of Chapter 23 of the GEM Listing Rules are applicable) shall not exceed 149,678,216 Shares (representing 10% of the aggregate of the Shares in issue as at the date of approval of the Share Option Scheme on 27 September, 2021 (the “Scheme Mandate Limit”).

The overall limit on the number of shares which shall be issued upon exercise of all outstanding options granted, and yet to be exercised, under the Share Option Scheme, and other share option schemes of our Company (and to which the provisions of Chapter 23 of the GEM Listing Rules are applicable), shall not exceed 30% of the Shares in issue from time to time (“Scheme Limit”).

### (4) Maximum entitlement of each Participant

The maximum number of Shares issued and to be issued upon exercise of the Options granted to each Participant (including both exercised, cancelled and outstanding Options) in any 12-month period shall not exceed 1% of the total number of shares in issue. Any further grant of Options to any Participant must be separately approved by the shareholders in general meeting with such Participant and his associates abstaining from voting.

### (5) Option period

The period within which the shares shall be taken up under an Option shall be a period to be notified by the Board to each grantee of the Option at the time of making an offer, which shall be determined by the Board in its absolute discretion at the date of grant of the relevant Option, but such period shall not expire later than 10 years from the date of grant of the relevant Option.

### (3) 購股權涉及的最大股份數目

**(6) Minimum period for which an option must be held before it can be exercised**

The minimum period, if any, for which an Option must be held before it can be exercised shall be determined by the Board at its absolute discretion and notified by the Board to each grantee of the Option at the time of making an offer. Unless the Directors otherwise determined and stated in the offer of the grant of Options to a Participant, there is no minimum period for which an Option granted under the Share Option Scheme must be held before it can be exercised.

**(7) Payment on acceptance of Option offer**

An Option shall remain open for acceptance by the Participant concerned for a period of 28 days exclusive of the date on which the offer is made to the Participant. HK\$1.00 is payable by the grantee of the Option to the Company on acceptance of the offer of the Option.

**(8) Subscription price**

The subscription price shall be such price determined by the Board at its absolute discretion and notified to the Participant in the offer at the time of the offer, and shall be no less than the highest of:

- (a) the closing price of the Shares as stated in the daily quotations sheet issued by the Stock Exchange on the date of grant of the relevant Option, which shall be a business day;
- (b) the average closing price of the Shares as stated in the daily quotations sheets issued by the Stock Exchange for the five business days immediately preceding the date of grant of the relevant Option; and
- (c) the nominal value of a Share on the date of grant of the relevant Option.

#### Proposed Capital Reorganisation and Rights Issue

##### *Capital Reorganisation*

On 2 November 2021, the Company announced that it proposes (i) to implement the capital reorganisation (the “**Capital Reorganisation**”) which would involve the reduction of the issued share capital of the Company by reducing the par value of each then issued Share from HK\$0.06 to HK\$0.001 by cancelling the paid up share capital to the extent of HK\$0.059 per then issued Share, so that following such reduction, each then issued Share with a par value of HK\$0.06 in the share capital of the Company shall become one adjusted Share (the “**Adjusted Share**”) with a par value of HK\$0.001 each and the subdivision of authorised but unissued shares of the Company of HK\$0.06 par value each into sixty (60) authorised but unissued Adjusted Shares.

##### *Rights Issue*

On 2 November 2021, the Company proposed, subject to the Capital Reorganisation becoming effective, to implement the rights issue (the “**Rights Issue**”) on the basis of three (3) rights Shares (the “**Rights Share(s)**”) for every one (1) Adjusted Share at the Subscription Price of HK\$0.035 per Rights Share, to raise up to approximately HK\$157.2 million before expenses (assuming no change in the issued share capital of the Company) by way of the rights issuing up to 4,490,346,480 Rights Shares to those qualifying Shareholders.

The Board proposed to change the board lot size for trading on the Stock Exchange from 24,000 Shares to 96,000 Adjusted Shares upon the Capital Reorganisation and Rights Issue becoming effective.
