According to the relevant laws in the PRC, the subsidiaries in the PRC are required to transfer at least 10% of its net profit after taxation, as determined under the relevant accounting principles and financial regulations applicable to enterprises established in the PRC, to a non-distributable reserve fund until the reserve balance reaches 50% of its registered capital. The transfer to this reserve must be made before the distribution of a dividend to owners. Such reserve fund can be used to offset the previous years' losses, if any, and is non-distributable other than upon liquidation.

Notes to the Condensed Consolidated Financial Statements

For the nine months ended 31 December 2021

1. **GENERAL INFORMATION**

The Company was incorporated in the Cayman Islands as an exempted company with limited liability on 2 January 2018 under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands and its shares (the "Shares") have been listed on GEM of the Stock Exchange on 20 April 2020 (the "Listing"). The addresses of the Company's registered office and principal place of business in Hong Kong are Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman KY1-1111, Cayman Islands and Unit 1613-1615, Level 16, Tower 1 Metroplaza, 223 Hing Fong Road, Kwai Fong, Hong Kong, respectively.

The controlling shareholder of the Company is 3C Holding Limited, a company incorporated in the British Virgin Islands, and is owned as to 95% and 5% by Mr. Chan Le Bon ("Mr. LB Chan") and Mr. Chan Yu, respectively.

The principal activity of the Company is investment holding. The principal activities of the Group are the provision of air cargo terminal operation services, transportation services and warehousing and other value-added services in Hong Kong and the PRC.

The condensed consolidated financial statements are presented in Hong Kong dollars ("HK\$"), which is also the functional currency of the Company.

BASIS OF PREPARATION 2.

The quarterly financial information has been prepared in accordance with the applicable disclosure requirements of Chapter 18 of the GEM Listing Rules. The guarterly financial information does not include all the information required for a complete set of financial statements prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") issued by Hong Kong Institute of Certified Public Accountants ("HKICPA") and should be read in conjunction with the Group's annual consolidated financial statements for the year ended 31 March 2021 (the "2021 Financial Statements"). The principal accounting policies applied in preparing this quarterly financial information are set out in note 3 to the 2021 Financial Statements.



In the current period, the Group has adopted all the new and revised HKFRSs issued by the HKICPA that are relevant to its operations and effective for its accounting year beginning on 1 April 2021. HKFRSs comprise Hong Kong Financial Reporting Standards; Hong Kong Accounting Standards ("HKAS"); and Interpretations. The adoption of these new and revised HKFRSs did not result in significant changes to the Group's accounting policies, presentation of the Group's financial statements and amounts reported for the current period and prior years. The Group has not applied the new HKFRSs that have been issued but are not yet effective. The Group has already commenced an assessment of the impact of these new HKFRSs but is not yet in a position to state whether these new HKFRSs would have a material impact on its results of operations and financial position.

4. **REVENUE**

Revenue represents the amounts received and receivable for services provided in the normal course of business.

No diluted earning/(loss) per Share for both periods was presented as there were no potential ordinary Shares in issue.

DIVIDENDS 8.

No dividends were paid, declared or proposed during the nine months ended 31 December 2021 (2020: Nil). The Directors resolved not to pay an interim dividend for the nine months ended 31 December 2021 (2020: Nil).

Management Discussion and Analysis

BUSINESS REVIEW AND PROSPECTS

The Group is an established air cargo ground handling services provider in Hong Kong. Our air cargo ground handling services principally cover (i) air cargo terminal operation; (ii) transportation; and (iii) warehousing and other value-added services. We utilise our full suite of services to deliver integrated solutions to global express carriers, air cargo terminal operators, freight forwarders and corporates domestically and regionally. The Group has over 20 years of experience in the air cargo ground handling services industry with our headquarter located in Hong Kong.

The COVID-19 pandemic continues to affect the business activities, transportation and life around the world. The recent outbreak of the fifth wave of the COVID-19 pandemic in Hong Kong and the continuous implementation of global travelling restriction measures are still affecting the norm of the global logistic business, including the dramatic cut of airfreight and the implementation of stringent anti-epidemic precaution on cross-border transport workers, all of these had adversely affected the previous economic recovery and it is expected that the economic recovery will slow down inevitably.

During the nine months ended 31 December 2021, the Group continued to implement its growing strategies and was actively seeking for new business opportunities. Our air freight container freight station warehouse (the "Air Freight CFS Warehouse") in Hutchison Logistics Centre and the warehouse located in ATL Logistics Centre, both situated in the center hub of Hong Kong logistics business, Kwai Chung, improved our logistics capability in providing one-stop logistics services including local transportation, warehousing and cargos-screening services to handle the strong demand for cargos-screening services from our existing customers and potential customers.

Looking forward, the Group will continue to monitor the development of the COVID-19 pandemic and will continue to utilise our existing industry knowledge to expand our core strengths and target to explore more business opportunities, with higher profit margin, and also continue to exercise careful cost control measures to strengthen our competitiveness in the logistics industry.

FINANCIAL REVIEW

Revenue

Our overall revenue increased by approximately HK\$49.9 million or 17.7% from approximately HK\$281.5 million for the nine months ended 31 December 2020 to approximately HK\$331.4 million for the nine months ended 31 December 2021. Such increase was mainly due to the increase in revenue generated from the provision of warehousing and other value-added services by approximately HK\$38.6 million or 53.2% to approximately HK\$111.1 million for the nine months ended 31 December 2021 as compared to that of approximately HK\$72.6 million for the nine months ended 31 December 2020. Such increase was primarily benefited from the business generated from the expanded operations of our Air Freight CFS Warehouse and our warehouse located in ALT Logistics Centre during the nine months ended 31 December 2021.

Other income

Other income decreased by approximately HK\$0.4 million or 22.2% to approximately HK\$1.4 million for the nine months ended 31 December 2021 as compared to that of approximately HK\$1.8 million for the nine months ended 31 December 2020. Other income for the nine months ended 31 December 2021 mainly represented the subsidies received from the "Pilot Subsidy Scheme for Third-party Logistics Service Providers", launched by the Hong Kong Government on encouraging the adoption of technology by the logistics sector for enhancing efficiency and productivity of approximately HK\$0.5 million. Whereas, other income for the nine months ended 31 December 2020 mainly represented the "One-off Subsidy" received from the Anti-epidemic Fund established by the Hong Kong Government, which provided financial support to the transport trades in view of the severe impact of the COVID-19, which amounted to approximately HK\$1.4 million.

Other gains and losses

Other gains and losses mainly represented the exchange gain and loss. Our Group recorded a net loss in other gains and losses of approximately HK\$0.2 million and HK\$0.5 million for the nine months ended 31 December 2021 and 2020, respectively.



Employee benefits expenses

Employee benefits expenses consisted primarily of wages and salaries, retirement benefits scheme contributions and other allowances and benefits. The employee benefits expenses increased by approximately HK\$8.4 million or 26.3% from approximately HK\$32.0 million for the nine months ended 31 December 2020 to approximately HK\$40.5 million for the nine months ended 31 December 2021. Such increase was mainly due to (i) the general increase in average wages; (ii) the increase in headcount for providing warehousing and other value-added services; and (iii) there was government grants received under the Employment Support Scheme of approximately HK\$6.1 million for the nine months ended 31 December 2020 to offset the employee benefits expenses, which was absent for the nine months ended 31 December 2021.

Dispatch labour costs

The dispatch labour costs represented the amount paid to our dispatched work agencies for the provision of our air cargo ground handling and warehousing services. It increased by approximately HK\$12.3 million or 14.6% to approximately HK\$96.5 million for the nine months ended 31 December 2021 as compared to that of approximately HK\$84.2 million for the nine months ended 31 December 2020, which was mainly driven by the increase in need of manpower for the expanded operations of our Air Freight CFS Warehouse and our warehouse located in ALT Logistics Centre to maintain the daily operation of our warehousing and X-ray screening services to serve our new customers.

Depreciation of property, plant and equipment and right-of-use assets

For the nine months ended 31 December 2021, the depreciation of property, plant and equipment and right-of-use assets amounted to approximately HK\$15.5 million, representing an increase of approximately HK\$4.2 million or 36.5% as compared to that of approximately HK\$11.4 million for the nine months ended 31 December 2020. Such increase was mainly due to the increase in depreciation of right-of-use of our warehouse located in ATL Logistics Centre, forklift and the X-ray screening machine.

Transportation costs

Transportation costs increased by approximately HK\$23.9 million or 18.3% to approximately HK\$154.5 million for the nine months ended 31 December 2021 as compared to that of approximately HK\$130.6 million for the nine months ended 31 December 2020. Such increase was mainly due to the increased service fees paid to external transportation service providers for the warehousing and other value-added services business.

Other expenses

Our other expenses mainly included utilities expenses, insurance, legal and other professional fees and other miscellaneous operating expenses. It decreased by approximately HK\$3.2 million or 31.1% to approximately HK\$ 7.1 million for the nine months ended 31 December 2021 as compared to that of approximately HK\$10.3 million for the nine months ended 31 December 2020, which was mainly due to the decrease in one off legal and other professional fees including sundry expenses charged by various professional parties during the period.

Finance costs

Our finance costs increased by approximately HK\$0.4 million or 24.1% to approximately HK\$1.8 million for the nine months ended 31 December 2021 as compared to that of approximately HK\$1.5 million for the nine months ended 31 December 2020. Such increase was primarily due to the increase in interest paid for bank borrowings.

Income tax credit

There was no assessable profit for the nine months ended 31 December 2021 and 2020.



Profit/(loss) for the period

For the nine months ended 31 December 2021, our Group recorded a net loss of approximately HK\$0.1 million (2020: HK\$0.7 million). Excluding the effect of government subsidies received during the nine months ended 31 December 2020, being approximately HK\$6.1 million from the COVID-19 Anti-epidemic Fund under the Employment Support Scheme and approximately HK\$1.4 million from the One-off Subsidy for Good Vehicles, the loss has decreased by approximately HK\$8.1 million or 98.5% from approximately HK\$8.2 million for the nine months ended 31 December 2020 to approximately HK\$0.1 million for the nine months ended 31 December 2021.

The decrease in net loss for the nine months ended 31 December 2021 was mainly due to the expanded operations of our Air Freight CFS Warehouse and the warehouse located in ATL Logistics Centre which led to an increase in revenue generated from the warehousing and other value-added services as compared to that for the nine months ended 31 December 2020.

Use of proceeds from the Listing

Based on the offer price of HK\$0.5 per offer share, the net proceeds from the Listing, after deducting the underwriting commission and other estimated expenses, amounted to approximately HK\$17.8 million. The Group intended to apply such net proceeds in accordance with the purposes as set out in the section headed "Future Plans and Use of Proceeds" in the Prospectus. During the nine months ended 31 December 2021, the Group has applied the net proceeds as follows:

- (ii) The Shares are owned by 3C Holding Limited. The entire issued share capital of 3C Holding Limited is owned as to 95% by Mr. LB Chan and as to 5% by Mr. Chan Yu, respectively. By virtue of the SFO, Mr. LB Chan is deemed to be interested in such number of Shares held by 3C Holding Limited.
- (iii) Diligent City Limited owns approximately 6.2% of the entire issued share capital of the Company. By virtue of the SFO, Mr. William Choy is deemed to be interested in such number of Shares held by Diligent City Limited as Mr. William Choy owns 100% of Diligent City Limited.
