# CHAIRMAN'S STATEMENT

## 主席報告

Dear Shareholders,

On behalf of the board (the "Board") of directors (the "Director(s)") of Royal Century Resources Holdings Limited (the "Company"), I present the annual results of the Company and its subsidiaries (collectively, the "Group") for the year ended 31 March 2022.

### OVERVIEW

Hong Kong has been influenced by the COVID-19 pandemic for more than two years since the outbreak of the COVID-19 in early 2020. The Group's operations for the year ended 31 March 2022 has been affected as from the delay and postponement of certain projects in progress and the impact on the consumption by the customers due to the measures in response to the COVID-19 pandemic and the increasingly keen competition in industry. Accordingly, the operating results of the Group for the year has been affected due to the unfavourable business environment surrounding the operation of the Group.

The Group recorded a turnover of approximately HK\$57.7 million for the year ended 31 March 2022, representing approximately 13.6% decrease as compared with last corresponding year, and with a loss of approximately HK\$21.1 million, of which approximately HK\$6.2million was derived from allowances for expected credit loss on loan and trade receivables, impairment of intangible assets and change in fair value of investment property which are non-cash items.

The Group has successfully bid for new projects and explored for new customers during the year. The Group continued to work for a contractor for the term contracts in relation to the provision of the public housing refurbishment and maintenance subcontracting services. The aggregate turnover from the design, fitting out and engineering services was decreased from approximately HK\$36.8 million for the previous year to approximately HK\$33.8 million for the current year. The revenue from design, fitting out and engineering services for the current year was affected by the sentiment of the end customers in planning of design and fitting out activities resulting from the erratic development of the COVID-19 pandemic.

The income from leasing of construction equipment amounted to approximately HK\$13.3 million for the current year, representing an increase of approximately 54.7% when compared with approximately HK\$8.6 million for last year. The Group expects the leasing of construction equipment will be a sustainable income stream to the Group provided that the COVID-19 pandemic is stabilised. Nevertheless, as certain projects have been completed or near to be completed in the fourth quarter and there was delay and postponement of commencement of certain new projects due to the impact of COVID-19 and the slowdown of the economy, a drop of the rental income is expected in the coming quarter.

本人謹代表仁德資源控股有限公司（「本公司」）董事（「董事」）會（「董事會」）提呈本公司及其附屬公司（統稱為「本集團」）截至二零二二年三月三十一日止年度之全年業績。

### 概覽

自2020年初爆發COVID-19以來，香港已受COVID-19大流行影響超過兩年。由於若干項目的延遲和延期以及應對COVID-19大流行所推行之若干持續措施影響最終客戶之消費，以及日益激烈的行業競爭，本集團截至二零二二年三月三十一日止年度的業務因而受到影響。因此，由於受周邊不利的營商環境圍繞本集團，本集團於本年內的整體經營業績因而受到影響。

於截至二零二二年三月三十一日止年度，本集團錄得收入約為57,700,000港元，相當於較去年減少約13.6%及虧損約21,100,000港元，其中約6,200,000港元來自借款及貿易應收款項預期信貸虧損撥備、無形資產的減值及投資物業公平值變動，為非現金項目。

於本年內，本集團成功投得新項目及開拓新客戶。本集團繼續就公屋翻新及維修分包服務的定期合約提供服務與承包商。來自設計、裝修及工程服務的總營業額由去年約36,800,000港元減少至本年度約33,800,000港元。本年度設計、裝修及工程服務的收入受到因COVID-19大流行之不穩定發展引至最終客戶就計劃設計及裝修事宜之低迷心態影響。

租賃建築設備的本年收入約為13,300,000港元，較去年收入約為8,600,000港元增加約54.7%。假若COVID-19大流行持續穩定，本集團預計建築設備租賃將成為本集團的可持續收入來源。然而，隨著若干項目於第四季度完成或接近完成以及若干項目因COVID-19和經濟放緩的影響而延遲和推遲開展，租金收入於來季度預期有所下調。

# CHAIRMAN'S STATEMENT

## 主席報告

The turnover attributed from the sourcing and merchandising of fine and rare wines business amounting to approximately HK\$10.0 million for the year, representing a decrease of approximately 51.5% when compared with last year's turnover of approximately HK\$20.6 million. Such decrease was mainly due to fewer orders from the existing customers during the year as a result of the continuous measures in response to the COVID-19 pandemic such as restriction of social gathering and the operations of food and beverage facilities that affects the consumption by the end customers. The reallocation of the Group's resources which focuses on the design, fitting out and engineering services and the leasing of construction equipment businesses also attributes to such decrease.

### FUTURE PROSPECTS

The Group is optimistic towards the recovery of the economic condition in Hong Kong from the COVID-19 pandemic in the years to come. The Group will continue to strive for the contracts of both the design, fitting out and engineering services business and the leasing of construction equipment business for the year ahead. The Group has successfully negotiated with the current contractor to renew for a 3-year term contract in respect of the public housing sub-contracting works and has been awarded works for one more public housing estate.

As the Group has secured term contracts with the contractor for the refurbishment, maintenance and improvement services in relation to the public housing, the Group expects such term contracts will attribute steady and recurring income to the Group. The Group is in the process of further negotiation with the contractor for new term contracts and also seek for new contractors of both private sector and public sector projects. With the exploration of the term contracts, the Group believes there will be opportunity to provide further services in the public sector works.

Besides the design, fitting out and engineering services business, the Group has also secured contracts for both existing and new customers in relation to the leasing of construction equipment. The Group believes once the economic condition in Hong Kong has been recovered from the COVID-19 pandemic, the demand for the scaffolding equipment will be increased and more contracts/orders will be expected to secure and conclude in the near future.

The Group has continued to focus on the development of its core business and utilise its available resources to further engagement in its existing business sector. The Group, at the same time, will continue to explore other investment opportunities and development in order to broaden its revenue base and further develop into a conglomerate.

年內，來自美酒採購及銷售業務的營業額約為10,000,000港元，較去年的營業額約為20,600,000港元減少約51.5%。該減少主要由於年內就COVID-19大流行所推行之若干持續措施包括社交聚會限制及飲食處所之營運限制而影響最終客戶之消費，以及本集團重配資源以專注於設計、裝修及工程服務業務及租賃建築設備業務所引致。

### 未來前景

本集團就香港的經濟狀況將在未來幾年從COVID-19大流行恢復，抱有樂觀期望。來年，本集團將繼續爭取設計、裝修及工程服務業務及建築設備租賃業務的合約。本集團已與現行承辦商完成商談續訂一為期三年之公共房屋分判工程之定期合約，並獲取新增一公共屋邨之工程。

由於本集團已與承建商就公共房屋的翻新、保養及改善服務訂立定期合約，本集團預期該等定期合約為本集團帶來穩定及經常性收入。本集團正與承建商進一步商討新的定期合約，並尋找私營及公營項目的新承建商。隨著對定期合約的開拓發展，本集團相信將有機會為公共部門工程提供進一步服務。

除設計、裝修及工程服務業務外，本集團亦為現有及新客戶就建築設備租賃取得合約。本集團相信，一旦香港的經濟狀況從COVID-19大流行中恢復，對支架設備的需求將會增加，預計在不久將來將獲得更多合約／訂單。

本集團繼續專注於發展其核心業務，並利用其可用資源進一步涉足其現有業務領域。同時，本集團將繼續開拓其他投資機會及發展，以擴大其收入基礎並進一步發展為綜合企業。

The decrease of the Group's total revenue was mainly due to a drop in the sales of fine and rare wines from approximately HK\$20.6 million for the year ended 31 March 2021 to approximately HK\$10.0 million for the year ended 31 March 2022. The decrease was mainly due to fewer orders from the existing customers during the year as a result of the continuous measures in response to the COVID-19 pandemic such as restriction of social gathering and the operations of food and beverage facilities that affects the consumption by the end customers. The reallocation of the Group's resources which focuses on the design, fitting out and engineering services and the leasing of construction equipment businesses also attributes to such decrease.

The revenue generated from the design, fitting out and engineering services business for the year ended 31 March 2022 amounted to approximately HK\$33.8 million, representing a drop of approximately HK\$3.0 million when compared with the revenue for the year ended 31 March 2021 of approximately HK\$36.8 million.

The revenue arising from the leasing of construction equipment business was increased from approximately HK\$8.6 million for the year ended 31 March 2021 to approximately HK\$13.3 million for the year ended 31 March 2022, representing an increment of approximately HK\$4.7 million or 54.7%. Such increment was mainly due to the expansion of the business and the increase in the lease out quantity of scaffolding equipment following the additional investment to cater for the growth and development of this segment during the third and fourth quarters of last year.

The revenue from the provision of financial services was slightly decreased by \$0.2 million as compared with the last year, which was mainly due to the decrease in loan interest income at lower interest rate.

### Gross profit for the year

For the year ended 31 March 2022, the Group recorded a gross profit of approximately HK\$9.9 million (2021: approximately HK\$11.7 million), representing a decrease of approximately 15.4%. Gross profit by types of segments is as follows:

本集團總收益下降主要由於美酒銷售從截至二零二一年三月三十一日止年度約20,600,000港元下跌至二零二二年三月三十一日止年度約10,000,000港元。該減少主要由於於年內就COVID-19大流行所推行之若干持續措施包括社交聚會限制及飲食處所之營運限制而影響最終客戶之消費，以及本集團重配資源以專注於設計、裝修及工程服務業務及租賃建築設備業務所引致。

截至二零二二年三月三十一日止年度，設計、裝修及工程服務業務產生的收入約為33,800,000港元，較截至二零二一年三月三十一日止年度約為36,800,000港元的收入減少約3,000,000港元。

租賃建築設備業務產生的收益由截至二零二一年三月三十一日止年度約8,600,000港元增加至二零二二年三月三十一日止年度約13,300,000港元，即增加約4,700,000港元或上升約54.7%。該增加主要是由於去年第三季度及第四季度此業務之擴展及增加投入通架設備以配合此業務分部的增長及發展，以使租出通架設備數量有所增加。

提供金融服務之收益較去年輕微減少200,000港元，主要是由於較低利率的貸款利息收入減少所致。

# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論及分析

The decrease in the Group's gross profit of approximately HK\$1.8 million was mainly attributed to a drop in the gross profit from the design, fitting out and engineering services business when compared with that of the last year. Although the Group managed to maintain an overall gross profit margin at the similar level of approximately 17.2% and 17.5% respectively for the current year and the last year, there was a decrease in gross profit generated due to the fierce competition in the industry and the depressed situation of the local economy resulting from the erratic development of the COVID-19 pandemic, which in turn, led to a contraction of design and fitting out activities.

### Loss for the year

During the year ended 31 March 2022, although the Group has a gross profit of approximately HK\$9.9 million (2021: HK\$11.7 million), the Group recorded a loss before tax of approximately HK\$20.9 million (2021: HK\$20.9 million), which is at the similar level of last year. Loss for the year was approximately HK\$21.1 million (2021: HK\$19.4 million). The increase in loss for the year of approximately HK\$1.7 million was mainly attributable to the recognition of a deferred tax expense of approximately HK\$0.1 million for the year while there was a deferred tax credit of approximately HK\$1.5 million for the last year.

Included in the loss for the year was allowance for ECL on trade receivables for the year amounting to approximately HK\$4.4 million, which mainly represents an impairment loss provided for the receivable from one of the leasing equipment customer which was in the process of liquidation.

Apart from the allowance for ECL on trade receivables of approximately HK\$4.4 million, there are other losses of approximately HK\$1.9 million in aggregate in relation to the decrease in fair value of investment property, impairment of intangible assets and allowance for ECL of loan and interest receivables and contract assets.

本集團之毛利減少約1,800,000港元主要由設計、裝修及工程服務業務的毛利較去年下降所致。雖然，本集團於本年度及去年度竭力保持整體毛利率於相約水平分別為約17.2%及約17.5%，由於面對激烈的行業競爭以及COVID-19大流行之不穩定發展引至本地經濟之低迷狀況，以致設計及裝修活動有所收縮，因而產生的毛利有所下跌。

### 本年度虧損

於截至二零二二年三月三十一日止年度，雖然本集團之毛利約為9,900,000港元（二零二一年：約11,700,000港元），本集團錄得除稅前虧損約為20,900,000港元（二零二一年：約20,900,000港元）與去年持平。本年度虧損約為21,100,000港元（二零二一年：19,400,000港元）。年內虧損增加約1,700,000港元，主要由於本年度確認遞延稅項開支約100,000港元而去年則為遞延稅項抵免約1,500,000港元。

本年度虧損包括本年度貿易應收款項預期信貸虧損撥備約4,400,000港元，主要就一建築設備租賃客戶正進行清盤中因而其未清付款項計提虧損準備。

除貿易應收款項預期信貸虧損撥備約4,400,000港元外，其他虧損來自投資物業公平值減少、以及應收貸款及利息及合約資產預期信貸虧損撥備合計約1,900,000港元。

### BUSINESS REVIEW AND PROSPECTS

#### Design, fitting out and engineering services business

During the year ended 31 March 2022, included in the Group's revenue for the design, fitting out and engineering services was revenue from the provision of public housing maintenance, improvement and vacant flat refurbishment works and services amounted to approximately HK\$15.8 million, representing approximately 46.6% of the segment revenue for the current year. The public housing estates works was commenced since October 2020 which attributed approximately HK\$6.7 million to the Group's revenue for the year ended 31 March 2021. The said HK\$15.8 million revenue for the current year represents a growth of approximately 135.8% when compared with the corresponding revenue for the last year. The Group expects the revenue from the provision of public housing maintenance, improvement and vacant flat refurbishment works and services to have a steady growth and maintains a sustainable stream of income to the Group in the long run. The Group has been actively coordinating and negotiating with the current contractor as well as other contractors for the new term contracts in order to enlarge the Group's operations therefrom. The Group has successfully negotiated with the current contractor to renew the term contract and been awarded for one more public housing estate in respect of vacant flat refurbishment works and services. The Group is optimistic to secure further public housing estates works and services.

Besides, the Group continues to establish and maintain business relationship with existing customers for the provision of design, fitting out and engineering services. The Group has been invited by contractors/customers to submit tenders and has proactively negotiated with the customers for fitting out and engineering service projects. However, due to the fierce industry competition and the depressed situation of the local economy resulting from the erratic development of the COVID-19 pandemic which affects the sentiment of the end customers in planning of design and fitting out activities, the contracts/projects awarded during the year were with lower contract sum when compared with last year. This accounted for a drop in the revenue for the design, fitting out and engineering services business during the year.

The Group will continue to seek for the potential contractors (both private sector works and public housing projects) and to coordinate/negotiate with the existing contractors for further contracts as well as developing the business network with the existing contractors in the aim of building up the Group's brand and goodwill. The Group expects such exploration and strategy will further broaden and strengthen the income stream and the sustainable development of the design, fitting out and engineering services business with maximization of return of the shareholders and the value of the Group.

### 業務回顧及前景

#### 設計、裝修及工程服務業務

截至二零二二年三月三十一日止年度，本集團的設計、裝修及工程服務收益包括來自提供公共房屋維修、改善及空置單位翻新工程及服務的收入約為15,800,000港元，佔本年度分部收益約46.6%。公共屋邨工程乃自二零二零年十月起開始，並於截至二零二一年三月三十一日止年度為本集團提供約6,700,000港元的收益。本年度所述之約15,800,000港元收益與去年相應收益比較，反映約135.8%增長。本集團預期來自提供公屋維修、改善和空置單位翻新工程及服務的收益將成為本集團長期穩定增長和可持續的收入來源。本集團正積極與現有承建商及其他承建商就新定期合約進行協調及磋商，以擴展本集團此等業務。本集團已與現行承辦商完成商談定期合約續約，並獲取新增一公共屋邨之空置單位翻新工程及服務。本集團就獲得更多公共屋邨工程及服務持樂觀態度。

此外，本集團持續與現有客戶建立及維持業務關係，以提供設計、裝修及工程服務。本集團獲承建商／客戶邀請遞交標書，並積極與客戶洽談裝修及工程服務項目。然而，由於激烈同業競爭以及COVID-19大流行之不穩定發展引至本地經濟之低迷狀況而影響最終客戶就計劃設計及裝修事宜之心態，本年度所獲得之合約／項目較去年合約總額較少。因此，設計、裝修及工程服務業務收益有所下降。

本集團將繼續拓展潛在承建商（包括私營機構工程及公共房屋項目），並與現有承建商協調／協商更多項目，以及發展與現有承建商的業務網絡，以建立本集團的品牌和商譽。本集團預期該等拓展及策略將進一步擴寬及加強設計、裝修及工程服務業務的收入來源及可持續發展，以實現股東回報及本集團價值的最大化。

### Leasing of construction equipment business

The Group has continued to build and pursuit business relationship with its existing customers and is able to explore new customers and conclusion of projects.

During the current year, the Group concluded with a contractor of a public tunnel infrastructure project initially for about 21 months whereby the Group provided the scaffolding equipment for the provision of installation services. However, due to certain material revisions and amendments on the design and construction works, the Group was unable to reach agreement with the contractor and the contract was terminated in January 2022.

Apart from the termination of the project as mentioned above, due to the erratic development of the COVID-19 pandemic and the uncertainty of the local economic situation, progress of certain construction projects have been delayed, resulting with the decrease in lease out rate of the Group's scaffolding equipment during the last quarter of the year. The management has been proactively negotiating with the customers for new projects aiming to maintain the lease out rate of the scaffolding equipment. The Group is in negotiation with certain contractors to provide scaffolding equipments and expects the orders will be concluded in the near future. The scaffolding equipment will be expected to deliver to the working sites by phases starting from the early second quarter of the coming year.

Looking forward, with the branding recognition of the Group's leasing of construction equipment business and the enlargement of its operation scale, the management expects the rental income therefrom would have steady growth once the COVID-19 pandemic is stabilised. The management is confident that the leasing of construction equipment will be a major business segment attributable to the success of the Group in the coming years.

### Sourcing and merchandising of fine and rare wines

The Group has developed and maintained a stable business relationship with the customers and the suppliers. The Group has been negotiating with the existing customers for recurring orders from the customers. The Group is also exploring for new suppliers and sources of wines. The Group is proactively negotiating with the existing customers and seeking for new customers for new orders.

### 租賃建築設備業務

本集團繼續與其現有客戶建立及尋求業務關係，並開拓新客戶及訂立項目。

於本年度，本集團與一家公共隧道基建項目的承建商訂立原為期約二十一個月之項目合約，本集團提供通架設備以供安裝服務。然而，由於設計和施工工程的某些重大修改和修訂，本集團未能與承建商達成協議，合約已於二零二二年一月終止。

除上述有關項目的終止外，由於COVID-19大流行的不穩定發展和本地經濟狀況的不確定性，若干建設工程項目進度被推遲，以至本集團通架設備的出租率於本年度最後一季有所下降。管理層一直積極與客戶協商新項目，旨在將通架設備的出租率保持。本集團現正與若干承建商商談提供通架設備，並預期於可見將來訂定訂單。預期於來年第二季度初開始分階段送運通架設備至工程地點。

展望未來，隨著本集團建築設備租賃業務的品牌知名度和經營規模的擴大，管理層預期當COVID-19大流行情況穩定由此產生的租金收入將會穩定的增長。管理層相信建築設備租賃將成為本集團未來幾年成功的主要業務板塊。

### 美酒營銷

本集團已與客戶及供應商發展並維持穩定的業務關係。本集團持續商談客戶的定期訂單。本集團亦開拓酒類產品的新供應商及來源。本集團正積極與現有客戶及尋找新客戶商討新訂單。

### Financial services business

The Group continues to adopt a prudent management approach to carry out the financial services business in order to minimize its credit risk exposure while proactively exploring and seeking for high creditworthiness customers to ensure a healthy development in its money lending, securities advisory services, securities dealing and brokerage services and assets management services business.

The Group's money lending business maintains a loan portfolio with principal amount of approximately the same level throughout the years. The Group has provided expected credit loss on the loan portfolio based on the historical information about counterparty default rate, latest status of these loans and the latest available information about the borrowers.

Certain commission income was also recognised from the introducing brokerage services during the year.

### LIQUIDITY AND FINANCIAL RESOURCES

During the year, the Group financed its operations through equity fund raising and by its internal resources.

As at 31 March 2022, the Group had net current assets of approximately HK\$14.0 million (2021: HK\$25.0 million), including cash and bank balances of approximately HK\$6.2 million (2021: HK\$16.7 million).

The current ratio, being the ratio of current assets to current liabilities, was approximately 1.7 times as at 31 March 2022 (2021: 2.4 times). The decrease in the current ratio during the year ended 31 March 2022 was mainly attributable to the decrease in cash and bank balances for financing the Group's operation during the year.

### CAPITAL STRUCTURE AND GEARING

The capital structure of the Company comprised ordinary shares only. There was no movement in the share capital of the Company during the year ended 31 March 2022. Total equity attributable to owners of the Company amounted to approximately HK\$72.4 million as at 31 March 2022 (31 March 2021: HK\$93.5 million).

As at 31 March 2022, the Group's only borrowings comprised of lease liabilities of approximately HK\$15.4 million (2021: HK\$13.6 million). The Group's gearing ratio, calculated by dividing total borrowings by total equity, was approximately 21.3% (2021: 14.5%). The increase in the gearing ratio during the year ended 31 March 2022 was mainly attributable to (i) the recognition of new lease liabilities as the Company entered into a sub-deed of lease in respect of the sub-leasing arrangement of the office premises and (ii) there was a drop of the shareholder's equity during the year.

### 金融服務業務

本集團繼續採納審慎的信貸風險管理策略營運金融服務業務，以減低此業務之信貸風險及積極開拓及尋找高信譽之顧客以確保其放債，就證券提供意見，證券交易及經紀服務，資產管理服務業務健康發展。

本集團的放債業務於多年來維持貸款組合之本金額於相約水平之本金額。本集團根據該等貸款的相關方違約率的過往資訊、最新狀況以及有關借款人的最新可得信息，計提貸款組合的預期信貸虧損撥備。

於本年度，本集團亦從介紹經紀服務確認佣金收入。

### 流動資金及財務資源

於本年內，本集團透過集資及以其內部資源撥付其營運。

於二零二二年三月三十一日，本集團之流動資產淨值約為14,000,000港元（二零二一年：25,000,000港元），當中包括現金及銀行結餘約6,200,000港元（二零二一年：16,700,000港元）。

於二零二二年三月三十一日，流動比率（即流動資產除以流動負債之比率）約為1.7倍（二零二一年：2.4倍）。於截至二零二二年三月三十一日止年度流動比率下降是由於本年度內撥付本集團營運開支而現金及銀行結餘減少所致。

### 資本架構與負債比率

本公司之資本架構僅由普通股組成。截至二零二二年三月三十一日止年度本公司之資本並無變動。於二零二一年三月三十一日，本公司擁有人應佔權益總額約為72,400,000港元（二零二一年三月三十一日：93,500,000港元）。

於二零二二年三月三十一日，本集團之主要借貸為租賃負債約15,400,000港元（二零二一年：13,600,000港元）。本集團之負債比率（按借貸總額除權益總額計算）約為21.3%（二零二一年：14.5%）。於截至二零二二年三月三十一日止年度負債比率上升是由於(i)本公司於本年度內就辦公室物業分租安排簽訂分租契據而確認新租賃負債及(ii)本年度內股東權益下降所致。

### USE OF PROCEEDS FROM RIGHTS ISSUE

Reference is made to the announcements of the Company dated 28 August 2020, 3 September 2020, 22 October 2020, 16 November 2020, 17 November 2020, 18 December 2020 and 28 December 2020, circular dated 24 October 2020 and listing document dated 30 November 2020 in relation to the rights issue.

On 28 August 2020, the Company proposed (i) to implement a share consolidation (the “Share Consolidation”) on the basis that every ten issued existing shares of the Company be consolidated into one consolidated share (the “Consolidated Share”) and (ii) to raise approximately HK\$31.4 million before expenses by way of a rights issue (the “Rights Issue”) of 104,520,000 rights shares (the “Rights Shares”) at a subscription price of HK\$0.30 per Rights Share on the basis of two Rights Shares for every one Consolidated Share held by the qualifying shareholders on the record date.

On 28 August 2020, the Company further entered into a placing agreement, pursuant to which, the placing agent conditionally agreed to procure placee(s) (the “Rights Issue Placing”) to subscribe for the unsubscribed Rights Shares and the non-qualifying shareholders unsold Rights Shares at a placing price of not less than the subscription price of HK\$0.30 per Rights Share. The closing price per share of the Company on that date was HK\$0.04 per share (equivalent to HK\$0.40 per Consolidated Share).

The Rights Issue and the Rights Issue Placing were approved by the shareholders at an extraordinary general meeting on 16 November 2020 and were completed on 29 December 2020. The net proceeds of the Rights Issue and the Rights Issue Placing was estimated at approximately HK\$29.4 million (equivalent to approximately HK\$0.29 per Rights Share). The Company intended to use all the net proceeds for purchase of construction equipment and for the Group’s operating, administrative and general expenses.

### 供股所得款項用途

謹提述本公司日期為二零二零年八月二十八日、二零二零年九月三日、二零二零年十月二十二日、二零二零年十一月十六日、二零二零年十一月十七日、二零二零年十二月十八日及二零二零年十二月二十八日之公告，日期為二零二零年十月二十四日之通函及日期為二零二零年十一月三十日之上市文件，內容有關之供股。

於二零二零年八月二十八日，本公司建議(i)進行股份合併，基準為本公司每十股已發行現有股份將合併為一股合併股份(「合併股份」)(「股份合併」)及(ii)通過按認購價(「供股」)每股供股股份0.30港元向合資格股東發行104,520,000股供股股份(「供股股份」)，藉以籌集所得款項總額約31,400,000港元(扣除開支前)，基準為於記錄日期每持有一股合併股份獲發兩股供股股份。

於二零二零年八月二十八日，本公司進一步訂立配售協議，據此，配售代理有條件同意促成承配人認購不獲認購供股股份及不合資格股東未售出供股股份按配股價不低於每股供股認購價0.30港元(「供股配售」)。本公司當天收市價為每股0.04港元(相當於每股合併股0.40港元)。

供股及供股配售已於二零二零年十一月十六日之股東特別大會上獲得股東批准，並於二零二零年十二月二十九日完成。供股及供股配售所得款項淨額預期約為29,400,000港元(相當於每股供股股份約0.29港元)。本公司擬將所得款項淨額用於購買建築設備及用作本集團之營運、行政及一般開支。

### DIVIDEND

The Directors do not recommend the payment of any dividend for the year ended 31 March 2022.

### FOREIGN EXCHANGE EXPOSURE

The operations of the Group are mainly conducted in Hong Kong dollar ("HK\$") and Renminbi ("RMB") and its revenue, expenses, assets, liabilities and borrowings are principally denominated in HK\$ and RMB.

The Group does not enter into any instruments on the foreign exchange exposure. The Group will closely monitor exchange rate movement and will take appropriate activities to reduce the exchange risk.

### CHARGES ON THE GROUP'S ASSETS

As at 31 March 2022 and 2021, the Group did not pledge any of its assets.

### SIGNIFICANT ACQUISITION AND DISPOSAL

Save for the recognition of a right-of-use asset of approximately HK\$6 million in respect of the sub-leasing arrangement of the office premises, there has been no significant acquisition and disposal of assets or subsidiaries of the Group during the year ended 31 March 2022.

### CONTINGENT LIABILITIES

As at 31 March 2022, the Group did not have any significant contingent liabilities.

### COMMITMENTS

Details of the commitments of the Group as at 31 March 2022 are set out in note 37 to the consolidated financial statements.

### EMPLOYEES AND REMUNERATION POLICIES

As at 31 March 2022, the Group employed 37 (2021: 43) employees. The Group continues to maintain and upgrade the capabilities of its workforce by providing them with adequate and regular training. The Group remunerates its Directors and employees mainly based on industry practices and individual's performance and experience. On top of regular remuneration, discretionary bonus and share options may be granted to eligible staff by reference to the Group's performance as well as individual's performance.

Total remuneration for the year ended 31 March 2022 (including emoluments and salaries to staff and Directors and MPF contributions) was approximately HK\$12.5 million (2021: HK\$12.6 million). There was no material fluctuation in the remuneration during the current year.

### PRINCIPAL RISKS AND UNCERTAINTIES

The Group's financial condition, results of operations, businesses and prospects would be affected by a number of risks and uncertainties including business risks, operational risks and financial management risks.

The key business and operations risk exposure by the Group are summarized as follows:

#### The COVID-19 pandemic

The COVID-19 pandemic may bring adverse impact on our construction sites and construction works. We have implemented the following hygiene and safety related measures:

- requesting staff and workers to wear surgical masks both at office and works sites;
- requesting staff and workers to present negative COVID-19 test results conducted within the past 7 to 14 days when entering the works site;
- monitoring the stock of personal protective equipment (including but not limited to surgical masks and hand sanitizer) for our employees;
- conducting mandatory body temperature check before entering works sites and random body temperature check at works sites during the day;
- requesting staff and workers to maintain personal hygiene and those who have respiratory symptoms shall be refrained from working and be asked to seek medical advice promptly;
- requesting staff and workers not to travel to those areas severely affected by COVID-19 unless necessary, and those who return from the affected areas shall be quarantined for 7 to 14 days and be asked to fill in the health check form;
- placing health educational materials on COVID-19 at prominent areas of our office and works sites;
- if any staff or workers are requested by the Department of Health to be quarantined or have been confirmed to have contracted COVID-19, their respective department or project management team will be informed and requested to keep on record. The affected staff or worker (the "Affected Personnel") will be refrained from working immediately and any other staff or workers who has close contact with the Affected Personnel shall also be quarantined for 7 to 14 days; and
- encouraging staff and workers to participate the COVID-19 Vaccination Programme implemented by the Government of the HKSAR.

### 主要風險及不確定因素

本集團之財務狀況、營運業績、業務及前景受多項風險及不確定因素影響，包括業務風險、營運風險及財務管理風險。

本集團所面對的主要業務及營運風險概列如下：

#### COVID-19大流行

COVID-19大流行可能會對我們的建築地盤及建築工程帶來不利影響。我們已經實施了以下衛生和安全相關措施：

- 要求員工和工人在辦公室和工作場所佩戴外科口罩；
- 要求員工及工人在進入工作場所時出示過去7至14天內進行的COVID-19測試的陰性結果；
- 監測僱員的個人防護設備（包括但不限於外科口罩和洗手液）的庫存情況；
- 在進入工作場所前進行強制性體溫檢查，並在白天在工作場所進行隨機體溫檢查；
- 要求員工和工人保持個人衛生，有呼吸道症狀者應避免工作，並要求及時就醫；
- 要求工作人員和工人除非必要，否則不要前往受COVID-19嚴重影響的地區，從受影響地區返回的人員應隔離7至14天，並須填寫健康檢查表；
- 在辦公室和工作場所的醒目位置放置COVID-19的健康教育資料；
- 如有員工或工人被衛生署要求隔離或證實感染COVID-19，其所屬部門或項目管理團隊會獲通知，並要求他們記錄在案，受影響的員工或工人（「受影響人士」）應立即停止工作，與受影響人士有密切接觸的其他員工或工人亦會被隔離7至14天；及
- 鼓勵員工和工人參與香港特別行政區政府推行的COVID-19疫苗接種計劃。

Mr. Chan holds a bachelor degree with honours in Business Administration and a master of science degree with distinction in Corporate Governance and Directorship. He is a fellow of The Hong Kong Institute of Certified Public Accountants, The Association of Chartered Certified Accountants and The Institute of Chartered Accountants in England and Wales. He is a practising certified public accountant and has extensive experience in financial management, corporate development, corporate finance and corporate governance.

Mr. Chan is currently an executive director and the chief executive officer of Hong Kong ChaoShang Group Limited (Stock code: 2322). ### CORPORATE GOVERNANCE PRACTICES

The Board considers that incorporating the elements of good corporate governance in the management structures and internal control procedures of the Group could balance the interests of the shareholders, customers and employees of the Company. The Board has adopted the principles and the code provisions of the Corporate Governance Code (the “CG Code”) contained in Appendix 15 of the Rules (the “GEM Listing Rules”) Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “Stock Exchange”) to ensure that business activities and decision making processes are regulated in a proper and prudent manner. In accordance with the requirements of the GEM Listing Rules, the Company has established an audit committee, a remuneration committee, a nomination committee and a compliance committee with specific written terms of reference. During the year ended 31 March 2022, the Company has complied with the CG Code as set out in Appendix 15 to the GEM Listing Rules.

The Company has put in place internal policies to ensure the compliance and has adopted and complied with the code provisions set out in the CG Code during the year except for the following deviation from the Code provisions:

- Code provision A.2.1 stipulated that the roles of chairman and chief executive should be separate and should not be performed by the same individual. The post of chief executive of the Company has remained vacant since 21 February 2020 and as at the date of this report. The duties of chief executive have been performed by other executive Directors. As there is a clear division of responsibilities of each Director, the vacancy of the post of chief executive did not have any material impact on the operations of the Group. Nevertheless, the Board will review the current structure from time to time and if a candidate with suitable knowledge, skill and experience is identified, the Board will make an appointment to fill the post of chief executive as appropriate.

### Directors' Appointment, Re-election and Removal

Under the code provision A.4.1 of the CG Code, each of the executive Directors, the non-executive Director and independent non-executive Directors has entered into a service contract or letter of appointment with the Company for an initial term of two or three years and such term shall be governed by the articles of association and/or other relevant regulatory requirements unless terminated by either party giving at least three months' notice in writing.

In compliance with the code provision A.4.2 of the CG Code, all directors appointed to fill a casual vacancy should be subject to election by shareholders at the first general meeting after appointment. By virtue of article 113 of the articles of association of the Company, the Board may appoint any person as an additional Director or to fill a casual vacancy, provided that any person so appointed shall hold office only until the conclusion of the next following general meeting of the Company (in the case of filling a casual vacancy) or until the next following annual general meeting of the Company (in the case of an addition to the Board), and shall then be eligible for re-election.

Where the number of Directors is not three or a number divisible by three, the number of Directors to retire will be the number which is nearest to but not less than one-third of the total number of Directors. If there are less than three Directors, they shall all retire. The Directors to retire by rotation will be those Directors who have been Directors longest in office since they were last elected, or appointed by the Members (as the case may be). Every retiring Director shall be eligible for re-election.

### Independent Non-executive Directors

The Company has three independent non-executive Directors to comply with Rule 5.05 of the GEM Listing Rules. Furthermore, among the three independent non-executive Directors, Mr. Chan Chiu Hung Alex has appropriate professional qualifications or accounting or related financial management expertise as required by Rule 5.05(2) of the GEM Listing Rules. In accordance to Rule 5.09 of the GEM Listing Rules, the Company has received from each of its independent non-executive Directors the written confirmation of his independence. The Company, based on such confirmation, considers Mr. Chan Chiu Hung Alex, Mr. Wu Zhao and Mr. Lam Cheok Va to be independent.

### Delegation of Powers

The Board delegates day-to-day operations of the Group to executive Directors and management of the Company with department heads responsible for different aspects of the business/functions, while reserving certain key matters in making strategic decision for its approval. When the Board delegates aspects of its management and administration functions to management, it gives clear directions as to the powers of management, in particular, with respect to the circumstances where management need to report back and obtain prior approval from the Board before making decisions or entering into any commitments on behalf of the Company.

### Continuing Professional Development

According to the code provision A.6.5 of the CG Code, all directors shall participate in continuous professional development to develop and refresh their knowledge and skills to ensure their contribution to the Board remains informed and relevant. The Company would arrange and/or introduce some Director's training courses for the Directors to develop and explore their knowledge and skills.

Each newly appointed Director receives comprehensive, formal and tailored induction on the first occasion of his appointment, so as to ensure that he has appropriate understanding of the business and operations of the Company and that he is fully aware of his responsibilities and obligations under the GEM Listing Rules and relevant regulatory requirements. The Directors are continually updated on the legal and regulatory developments, as well as business and market changes, to facilitate the discharge of their responsibilities.

All Directors during the reporting period have participated in continuous professional development to develop and refresh their knowledge and skills through suitable trainings. The participation in such trainings is to ensure that their contributions to the Board remains informed and relevant.

### Directors' and Officers' Liabilities

The Company has arranged for appropriate insurance covering the liabilities in respect of legal action against the Directors that may arise out in the corporate activities which has been complied with the CG Code. The insurance coverage is reviewed on an annual basis.

### Remuneration Policy for Directors and Senior Management

The remuneration payable to the employees includes salaries and allowances. The Group's remuneration policies are formulated based on the performance of individual employees and are reviewed regularly. Subject to the Group's profitability, the Group may also provide a discretionary bonus to employees as an incentive for their contribution to the Group. The primary goal of the remuneration policy with regard to the remuneration package of the executive Directors is to enable the Group to retain and motivate the executive Directors by linking their compensation with performance as measured against corporate objectives achieved. The executive Directors are entitled to the remuneration packages including basic salaries and discretionary bonuses.

The share option scheme of the Company (the "Share Option Scheme") was adopted by sole Shareholder by way of written resolution on 30 June 2014. The terms of the Share Option Scheme are in accordance with the provisions of Chapter 23 of the GEM Listing Rules. The purpose of the Share Option Scheme is to provide (i) employees of the Group (whether full-time or part-time); (ii) directors (including executive directors, non-executive directors and independent non-executive directors (where applicable)) of the Group; (iii) substantial shareholders of each member of the Group and (iv) associates of directors or substantial shareholders of the Group of which includes any of the abovementioned persons (together, the "Participants" and each, a "Participant") with an opportunity to obtain an equity interest in the Company, thus linking their interest with the interests of the Group and thereby providing them with an incentive to work better for the interests of the Group.

The Company believes that by offering the Participants a shareholding stake in the Company, the interests of the Participants and the Company become aligning and thereby the Participants have additional incentives to improve the Company's performance.

Pursuant to Code Provision E.1.5 of the CG Code, details of the annual remuneration of the members of the senior management by band for the year ended 31 March 2022 are as follows:

For effective monitoring, external independent professionals will be engaged to conduct reviews of our internal control system and its implementation and effectiveness on an annual basis, and if considered necessary by compliance committee, at frequency as it considered appropriate.

The Board is responsible for establishing the Group's internal control framework, covering all material controls including financial, operational and compliance controls, as well as risk management functions of different systems. Review has been carried out in a systematic approach based on the risk assessments of the operations and controls. The Board considers that the key areas of the Group's internal control systems are reasonably implemented.

During the year under review, the Board, through the Audit Committee, has conducted a review, via an appointed professional firm to perform internal audit function, on the effectiveness of the risk management and internal control systems of the Group, covering financial, operational and risk management aspects. The systems were considered effective and adequate.

The Group adopts a complete process style of risk management in a functional bottom up manner, including risk identification, assessment, evaluation and treatment. The functional areas across the Group provide input of risks with treatments, which are appraised and maintained. The risk management system, as well as the internal control system, are continuous, proactive and systematic processes.

With the implementation of internal audit function, the effectiveness of the risk management and internal control systems is reviewed by conducting internal audit assignments. Recommendations for major observations of control weaknesses from the audits will be provided, so as to resolve material internal control defects.

### Dividend Policy

The Board has adopted and established a set of dividend policy (the "Dividend Policy"). The Company currently does not have a pre-determined dividend payout ratio. Any declaration, payment and amount of dividend in the future are subject to the Board's discretion having regard to the Group's future financial performance and earnings, capital requirement and surplus, general financial conditions and other factors as the Board may consider relevant.

The Company uses a number of formal communications channel to account to shareholders and investors for the performance of the Company. These include (i) the publication of quarterly, interim and annual reports; (ii) the annual general meeting or extraordinary general meeting providing a forum for shareholders to raise comments and exchanging views with the Board; (iii) updated key information of the Group available on the websites of the Stock Exchange and the Company; (iv) the Company's website offering communication channel between the Company and its shareholders and investors; and (v) the Company's share registrars in Hong Kong serving the shareholders in respect of all share registration matters.

The Company aims to provide its shareholders and investors with high standards of disclosure and financial transparency. The Board is committed to provide clear, detailed, timely manner and on a regular basis information of the Group to shareholders through the publication of quarterly, interim and annual reports and/or dispatching circulars, notices, and other announcements.

The Company strives to take into consideration its shareholders' views and inputs, and address shareholders' concerns. Shareholders are encouraged to attend the annual general meeting for which at least 20 clear business days' notice shall be given. The chairman of the Board as well as chairmen of the Audit Committee, the Nomination Committee, the Remuneration Committee and the Compliance Committee, or in their absence, the Directors are available to answer shareholders' questions on the Group's businesses at the meeting. To comply with code provision E.1.2 of the CG Code, the management will ensure the external auditor to attend the annual general meeting to answer questions about the conduct of the audit, the preparation and content of the auditor's report, the accounting policies and auditor independence.

All shareholders have statutory rights to call for extraordinary general meetings and put forward agenda items for consideration by shareholders. According to section 566 of the Companies Ordinance, The directors are required to call a general meeting if the company has received requests to do so from members of the company representing at least 5% of the total voting rights of all the members having a right to vote at general meetings. A request (a) must state the general nature of the business to be dealt with at the meeting; and (b) may include the text of a resolution that may properly be moved and is intended to be moved at the meeting.

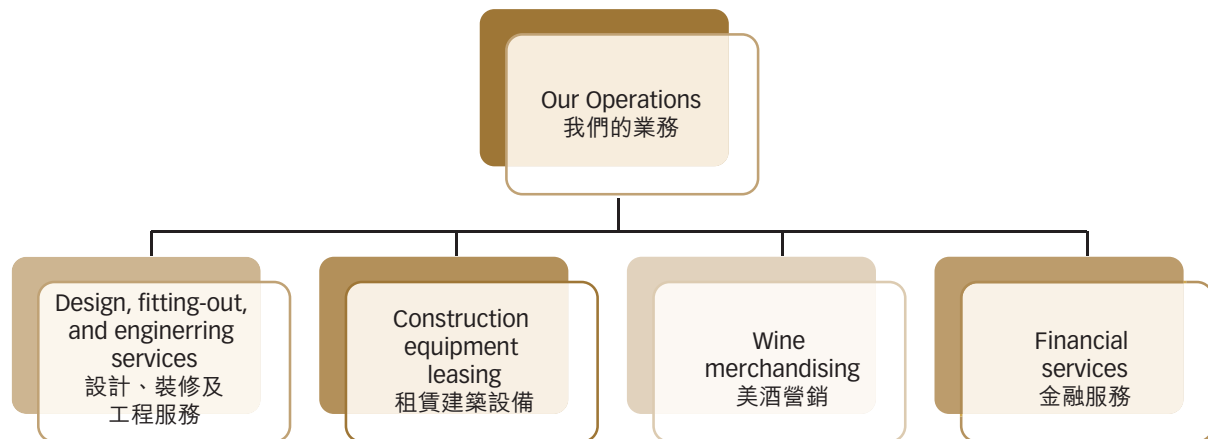

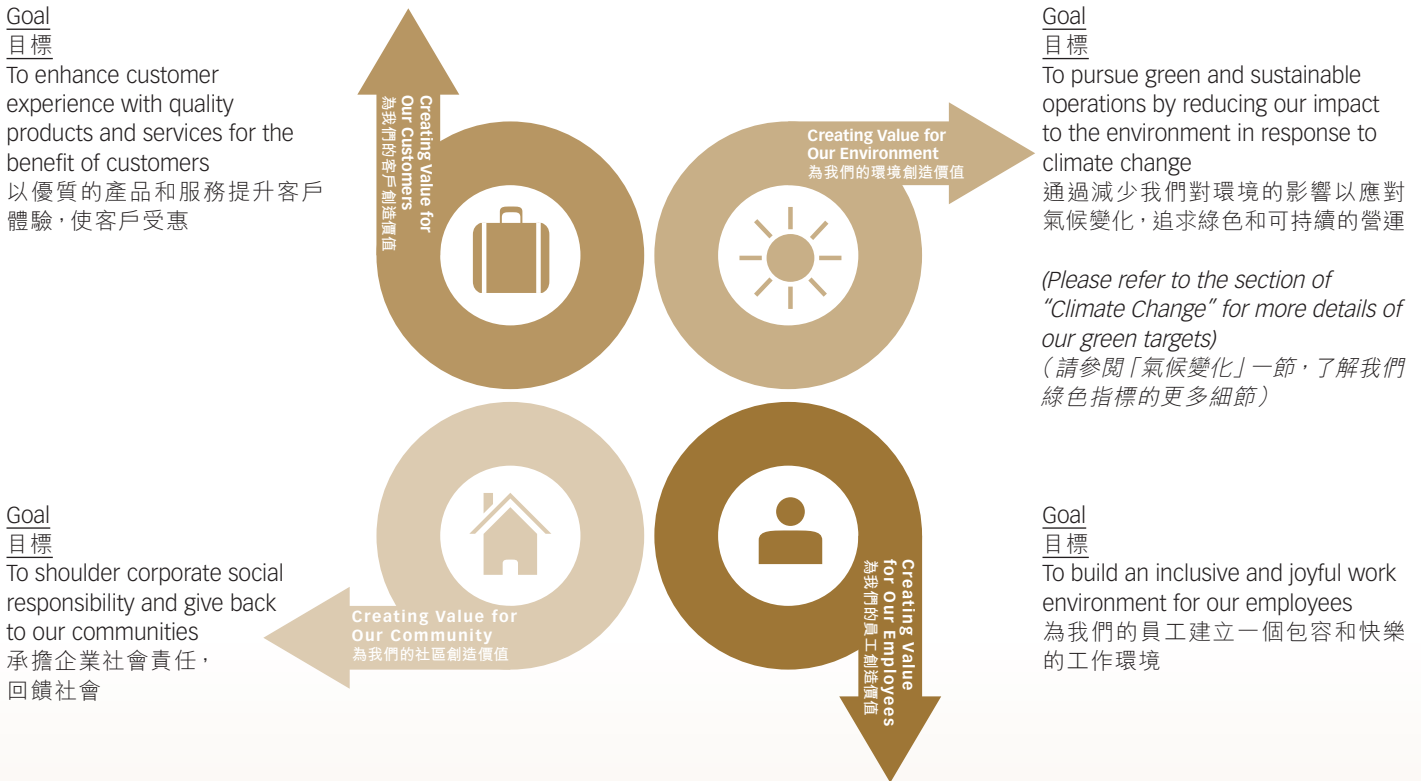

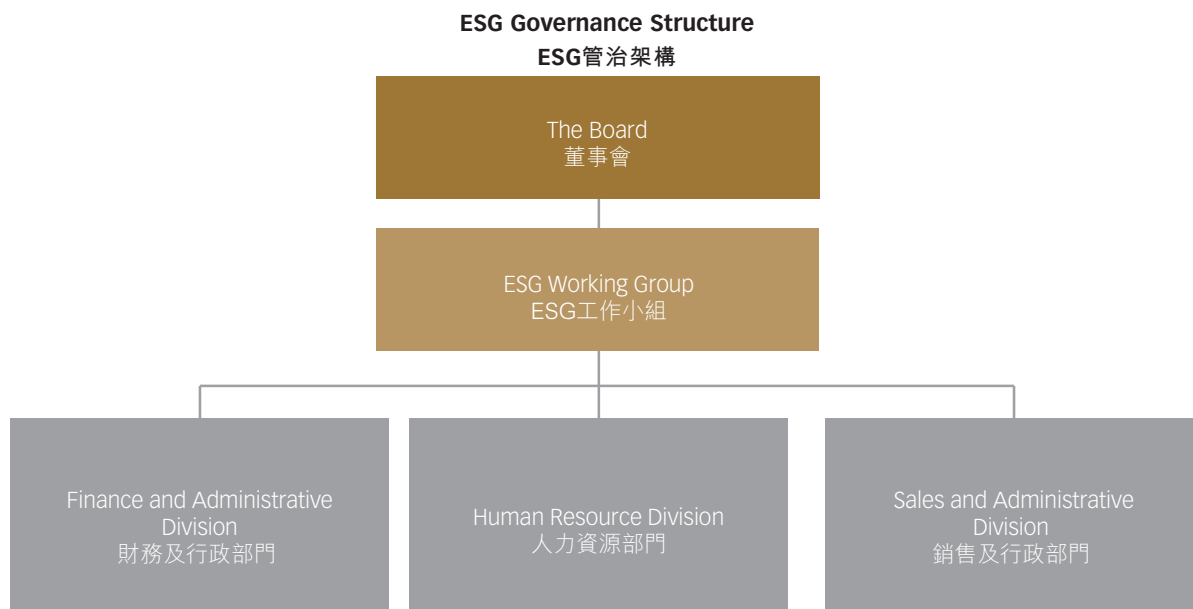

### Materiality Assessment

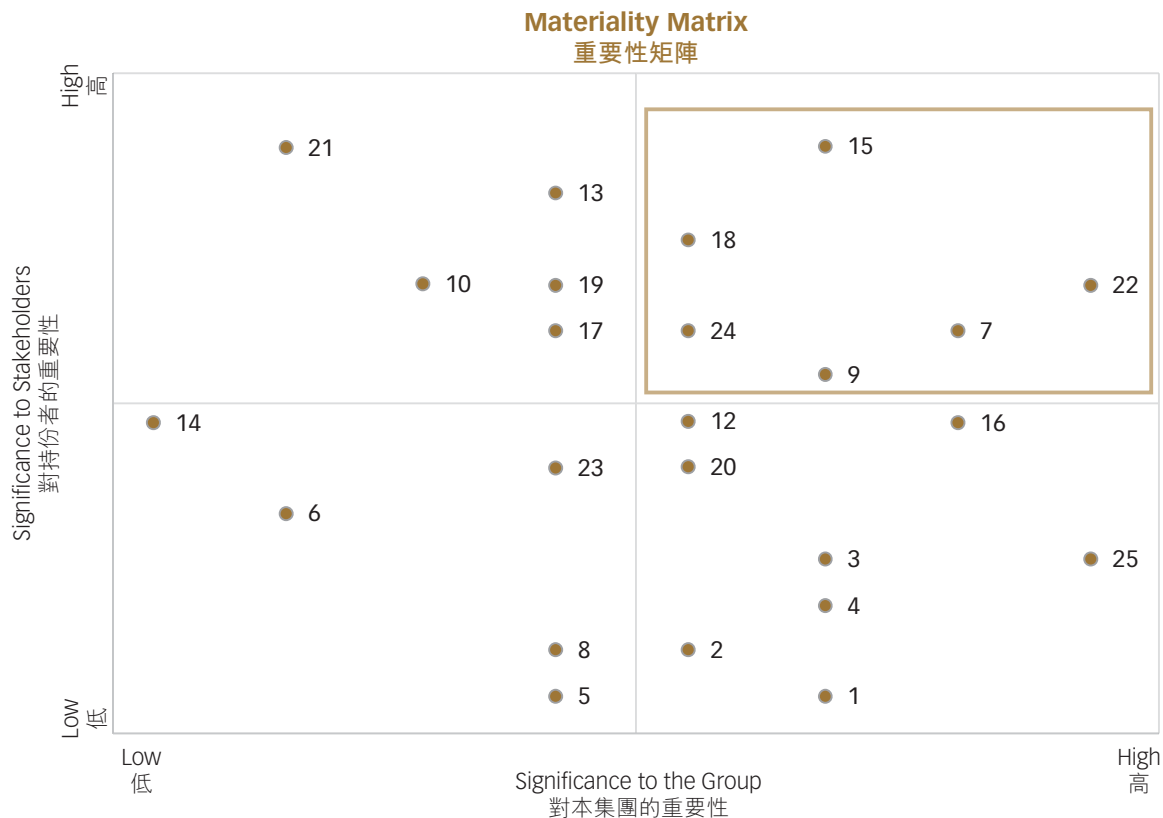

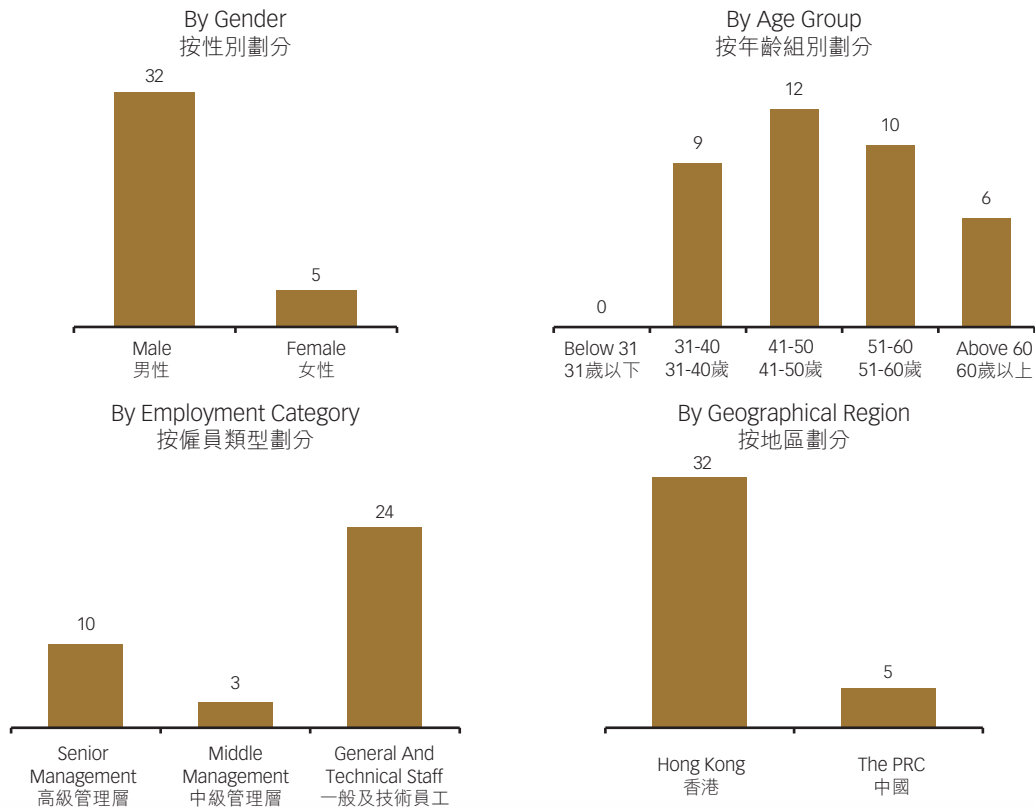

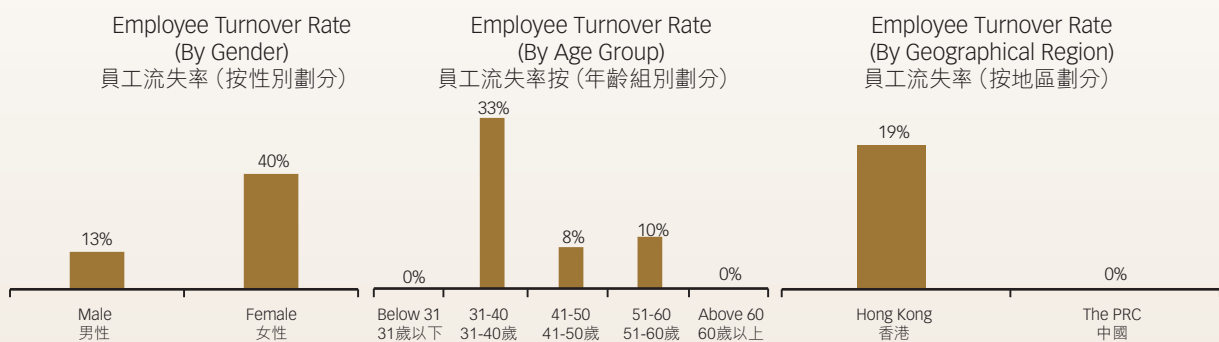

### Employee Rights and Welfare

We aim to enhance the wellbeing of our employees and protect their rights. We uphold the principle of equal opportunities and adopt zero-tolerance towards any kind of discrimination related to race, nationality, ethnic origin, religion, sex, or marital status. During our recruitment process, we provide equal opportunity to and consider the right candidates based on their appropriate experiences, skills, competencies and qualifications for a particular position. We provide equal opportunity of access to appropriate training and development based on identified business and individual needs.

To safeguard the rights of our staff and foster employee welfare, we have in place fair and comprehensive human resources policies relating to compensation and dismissal, recruitment and promotion, development and training, working hours, rest periods, benefits and welfare, and which are set out in our Staff Handbook.

### Attracting and Retaining Talents

Talent acquisition is crucial to the Group's long-term success and competitiveness. To attract and retain employees with loyalty, passion and desired skillsets, we provide competitive remuneration package and benefits to our staff. We continuously monitor market practices and receive feedback from our staff on salary compensation to ensure that the salary package provided is in line with the market standards. Staff appraisal is conducted annually to provide our staff with sufficient opportunities for advancement and help them to improve and grow. The staff appraisal result forms the basis for determining employees' salary, discretionary bonus and promotion opportunities.

### Occupational Health and Safety

The Group regards safety as the first priority in our business as we have the responsibility to safeguard the health and safety of our people, subcontractors and the public, where appropriate, in the daily operations. As such, various occupational health and safety measures and relevant procedures are implemented for our staff in offices and construction sites. The Group also strictly complies with applicable laws and regulations in relation to health and safety in Hong Kong and in the PRC, including but not limited to:

During the Reporting Period, there were no recorded cases of serious work-related injuries. The total lost days due to work injury were 0 days. No work-related fatality has been recorded for the past three years including the Reporting Period.

### Construction Health and Safety

To promote health and safety at construction sites, safety policies, working procedures, plans and measures are set out in the safety manual for our design, fitting-out and engineering services business. The safety manual is distributed to all workers and the person-in-charge of the subcontractors to ensure that they understand all safety standards. Workers are required to follow all safety rules and regulations set out in the safety manual, such as wearing safety helmet at all times and preventing unauthorised use of lifting construction equipment. To reduce risks of safety hazards, workers are required to acquire permits for specialised work of high safety risks.

### 吸引和挽留人才

To ensure proper implementation of safety measures, safety inspections are conducted on a regular basis at our construction sites with follow-up actions, when appropriate. We have in place an emergency plan to allow workers to respond quickly and properly in the event of safety incidents.

We raise awareness of workers on occupational health and safety through various safety promotion programmes and activities. We also evaluate the safety performance of sub-contractors to ensure that they are in compliance with all applicable laws and regulations and safety standards.

### Office Health and Safety

To provide a safe and healthy working environment to our employees, smoking is prohibited in our office operations. We also arranged our staff from office operations to take part in fire safety training to raise awareness and strengthen capabilities in coping with emergency situations during the Reporting Period.

### Response to the COVID-19

To prevent outbreak of the COVID-19 pandemic, we have set up the COVID-19 emergency response unit to monitor the pandemic situations and ensure strict compliance with government guidelines and policies. During the Reporting Period, we implemented various pandemic prevention measures in offices and work sites, including but not limited to:

- Requiring all staff and visitors to check their body temperature before entering the office;
- Providing hand sanitizers at the reception counter for hand hygiene;
- Providing face masks for all staff and requiring them to wear in the office and at worksites;
- Promoting regular and thorough hand washing habit to our staff;
- Encouraging social distancing practices;
- Avoiding face-to-face meetings and using web-based or phone conference meeting instead; and
- Avoiding unnecessary travel to affected regions. Upon returning from the affected regions, staff are required to self-isolate for 14 days.

### Development and Training

Employees' growth and development is beneficial to the Group's long-term development and sustainability. To help our staff grow together with the Group, we provide them with various vocational and job-related trainings to help them equip with the skills and knowledge required for their positions. To support our employees in acquiring professional qualifications and skills beneficial to their work, we sponsor our staff to take professional courses, seminars, workshops and conferences. During the Reporting Period, training programmes were arranged covering topics on regulatory compliance updates, anti-corruption, anti-money laundering, sustainability, COVID-19 and fire safety, etc.

The percentage of employee trained and average training hours completed per employee by gender and employment category during the Reporting Period are as follows:

### Labour Standards

The Group upholds high labour standards, and prohibits child or forced labour as it violates human rights and the protocol of international labour conventions. We ensure strict compliance with the applicable laws and regulations including but not limited to the Employment Ordinance in Hong Kong, and the Labour Law and Labour Contract Law in the PRC.

To prevent the occurrence of child or forced labour of any kind, we conduct checking on the applicant's identity documents to prevent underaged hires. We would strictly follow the employment contracts and would not prejudice the employment relationship in any way between the employees and the Group, such as detaining a deposit, forcing to work against their will under any kind of threat. Our staff has the right to terminate the employment contract as long as it is in compliance with the relevant laws and the Group policies. Once child or forced labour is identified, we will report to the authorities, and the employment would be terminated. During the Reporting Period, we were not aware of any material non-compliance with the laws and regulations relating to child and forced labour.

### 勞工準則

### Product and Service Quality

To assure the quality of our fitting-out projects, we have in place a well-established quality management system. In each project, a project controller is assigned to monitor the progress and ensure the quality of the project. We also monitor the production progress of furnishings and fittings used in our projects to ensure satisfaction. Inspections are carried out to ensure that safety and design specifications are followed and implemented during the production process.

At the execution phase of our project works, we constantly check our designs against the constraints to ensure the feasibility of the works. During the working process, we continuously monitor the progress to ensure that the expectations and requirements of our customers are met. At the completion stage, we conduct final checking with our customers to ensure all works are completed in accordance with the design specifications and the customers' requirements. Warranty period from one month to one year is offered to our customers to ensure completion and satisfaction.

For our construction equipment leasing business, we conduct third-party testing on the safety of our equipment by qualified test centres. We also perform regular and proper maintenance on our construction equipment to ensure its quality and safety. After testing, test reports are provided to customers to assure the quality of our products. We also provide guidance to our customers on the proper and safe use of our construction equipment upon their request.

To ensure quality for our wine products, we conduct regular inspection of products we received against quality standards. Once non-conformity is identified, we report it to the wine vendors to further discuss the arrangement for product recall or other remedial actions. In addition, we will provide training and clear instructions to our employees and ensure that the receiver is of age when receiving the alcohol package. If the receiver's age cannot be ascertained and there is doubt about his age, no delivery would be made.

For our financial services business, we ensure that we provide high-quality agency and money lending services. As a licensed money lender and a securities broker, we are operating under the Money Lenders Ordinance ("MLO") and the Securities and Futures Ordinance ("SFO"). To protect the interest of our customers, we require our employees to abide by all forms, procedures and requirements in our standard procedures as prescribed under the provisions of the MLO and SFO when providing financial services. We ensure that all product features, terms and conditions and any associated risks are clearly communicated to our customers, allowing them to be well-informed about all necessary information before making decisions.

### 產品及服務質素

為了保證我們裝修項目的質素，我們建立了一個完善的質量管理體系。在每個項目中，均有一名項目主管負責監督項目的進展並確保項目的質素。我們亦監測項目中使用的家具和配件的生產進度，以確保滿意度。我們進行檢查，以確保在生產過程中遵循和實施安全和設計規範。

在項目工程的執行階段，我們不斷根據限制條件對我們的設計進行檢查，以確保工程的可行性。在工作過程中，我們不斷監測進度，確保滿足客戶的期望和要求。在完工階段，我們與客戶進行最後的檢查，以確保所有工程都按照設計規範和客戶的要求完成。我們向客戶提供一個月到一年的保修期，以確保完工和滿意度。

對於我們的建築設備租賃業務，我們委託合資格的測試中心對設備的安全性進行第三方測試。我們對建築設備進行定期和適當的維護，以確保其質素和安全。測試後，我們提供測試報告給客戶，以保證我們產品的質素。我們根據客戶的要求，向他們提供關於正確和安全地使用我們的建築設備的指導。

為了確保我們的美酒產品的質素，我們依照質素規格對收到的產品進行定期檢查。一旦發現不符合要求的產品，我們會向美酒商家報告，以進一步討論產品召回或其他補救措施的安排。而且，我們會為員工提供培訓和明確指示，並確保收貨人在收到酒類送遞時符合法定年齡。如未能確認收貨人的年齡及對其年齡有懷疑，送遞人員應拒絕有關送遞。

至於我們的金融服務業務，我們確保提供高質素的代理和放款服務。作為一個持牌放債人和證券經紀人，我們根據《放債人條例》（「MLO」）和《證券及期貨條例》（「SFO」）運作。為了保護客戶的利益，我們要求我們的員工在提供金融服務時，必須遵守MLO和SFO規定的標準程序中的所有形式、程序以及要求。我們確保所有產品的特點、條款和條件以及任何相關的風險都清楚地傳達給我們的客戶，讓他們在做決定之前充分了解所有必要的信息。

As a responsible money lender, we provide memorandums to clients to remind borrowers of the repayment details and ensure that debt collection is conducted in a lawful manner.

### Customer Feedback

We value opinions and feedback from our customers, as they help us improve our product and service quality. Customer feedback is collected through various channels, including email, post and fax etc.. All customer complaints received will be reported to responsible staff for follow-up actions and rectification. To enhance customer satisfaction, guidelines are provided to staff on handling customer feedback and enquiries in a professional manner.

During the Reporting Period, we did not receive any material complaints related to products and services. There were no products sold or shipped subject to recalls for safety and health reasons.

### Data Protection and Intellectual Property Rights

As our operations involve collection of customer information, we take the responsibility for safeguarding data privacy of our customers. Our financial services business strictly follows regulations and practices related to data privacy as set out by the regulatory authorities, such as the The Stock Exchange, the Hong Kong Monetary Authority and the Securities and Futures Commission. When handling clients' data, we strictly follow applicable laws and regulations and provide internal guidelines on the proper collection, use, management and protection of data and information. Security measures are adopted to protect customer data against unauthorised or accidental access, processing or erasure.

Rules regarding protection of intellectual property rights are clearly set out in the Staff Handbook. All staff are required to pay close attention to the Group's proprietary information, customer's information as well as individual's personal data. Any document or written material provided by the Group must not be removed, passed on, copied or disclosed to third parties without approval by the Group.

### Advertising and Labelling

We ensure that our advertising material are absence of misleading or false information.

As a responsible wine merchandiser, we ensure that intoxicating liquor must not be sold or supplied to a minor in the course of business as stipulated by local laws and display a sign containing the related prescribed notice in both Chinese and English on our online stores in a reasonably legible manner.

作為一個負責任的放債人，我們向客戶提供備忘錄，以提醒借款人的還款細節，並確保以合法的方式進行收債。

### 客戶反饋

我們重視客戶的意見和反饋，因為它們有助於我們提高產品和服務質量。我們通過各種渠道收集客戶反饋，包括電郵、郵寄和傳真等。所有收到的客戶投訴都會報告給負責的員工，以便採取後續行動和進行糾正。為提高客戶滿意度，我們向員工提供了關於以專業方式處理客戶反饋和查詢的指引。

在報告期間，我們沒有收到任何與產品和服務有關的重大投訴，亦沒有因安全和健康原因而須回收已售或已運送的產品。

### 數據保護與知識產權

由於我們的業務涉及收集客戶的信息，我們有責任保護客戶的私隱。我們的金融服務業務嚴格遵守監管機構（如香港聯交所、香港金融管理局，以及證券及期貨事務監察委員會）制定的有關數據私隱的法規和慣例。在處理客戶的數據時，我們嚴格遵守適用的法律和法規，並提供有關正確地收集、使用、管理和保護數據和資料的內部指引。我們採取安全措施來保護客戶數據，防止未經授權或意外的訪問、處理或刪除。

員工手冊中明確規定了有關知識產權保護的規則。所有員工都需要密切關注本集團的專有資訊、客戶信息以及個人資料。本集團提供的任何文件或書面材料，未經批准不得刪除、傳遞、複製或披露給第三方。

### 廣告與標籤

我們確保我們的廣告不存在誤導性或虛假信息。

作為一個負責任的美酒營銷商，我們確保在當地法律規定下，在業務過程中不得向未成年人售賣或供應令人醺醉的酒類，並在我們的網店上以合理清晰的方式展示包含相關訂明通知的中英文通知的告示。

### Supply Chain Management

We attach great importance to the quality and performance of our suppliers including subcontractors. To ensure high-quality suppliers are selected and engaged, we choose our suppliers and subcontractors based on a set of selection criteria, including product quality, safety, productivity, ability to comply with the relevant laws and regulations, services quality, and cost effectiveness, etc. For our wine merchandising business, we select wine merchants with good reputation, high ratings, reliable supplies and good trading histories. We also take into the consideration the socially and environmentally responsible performance of our subcontractors and suppliers. To promote environmentally preferable products and services when selecting suppliers, we give priority to local suppliers and contractors to reduce carbon footprint in the transportation process. We also prioritise use of energy-efficient equipment such as LED and encourage them to opt for products with fewer packaging materials to reduce unnecessary waste. During the Reporting Period, we had a total of 96 suppliers including subcontractors. 91 of them are located in Hong Kong, 3 in the PRC, 1 in Taiwan and 1 in Singapore. All suppliers including subcontractors were implemented the practices relating to engaging suppliers during the Reporting Period.

To ensure that suppliers and subcontractors uphold high standards, we conduct supplier assessment on a regular basis. Suppliers and subcontractors who fail to meet our expectations related to labour practices, health and safety standards and integrity will face termination of business relationships. An ESG-related risk assessment has been conducted to identify environmental and social risks along the supply chain. The supply chain risks and control measures are carefully monitored, evaluated and managed by the Board and ESG Working Group on a regular basis.

### Anti-Corruption

The Group requires its staff to uphold high standards of business ethics and integrity at all times. All of our directors and staff in Hong Kong are required to comply with the Prevention of Bribery Ordinance (Hong Kong) (the "POB Ordinance"), and our staff in Mainland China are required to abide by relevant laws and regulations including but not limited to the Criminal Law of the PRC. During the Reporting Period, we were not aware of any material non-compliance with the relevant laws and regulations relating to bribery, extortion, fraud and money laundering. There were no concluded legal cases regarding corrupt practices brought against the Group or its employees during the Reporting Period.

### 供應鏈管理

我們非常重視我們的供應商包括分包商的質素和表現。為了確保選擇和聘用高質素的供應商，我們根據一系列的標準來選擇我們的供應商和分包商，包括質素、安全、生產力、遵守相關法律和法規的能力、服務質素以及成本效益等。對於我們的美酒營銷業務，我們選擇具有良好聲譽、高評級、可靠供應以及良好貿易歷史的美酒商家。我們還考慮到我們的分包商和供應商的社會和環境責任表現。在選擇供應商時，為了促使多用環保產品和服務，我們優先選擇當地供應商和承包商，以減少運輸過程中的碳足跡。我們還優先考慮採購LED等節能設備，並鼓勵供應商選擇包裝材料較少的產品，以減少不必要的浪費。在報告期間，我們總共有96家供應商，包括分包商，其中91家位於香港，3家位於中國，1家位於台灣以及1家位於星加坡。在報告期間，包括分包商在內的所有供應商都實施了與聘用供應商有關的慣例。

為了確保供應商和分包商堅持高標準，我們定期進行供應商評估。如果供應商和分包商不能滿足我們在勞工慣例、健康與安全標準以及誠信方面的期望，將面臨終止業務關係。我們進行了ESG相關的風險評估，以識別供應鏈上的環境和社會風險。董事會和ESG工作小組定期對供應鏈風險和控制措施進行仔細監測、評估以及管理。

### 反貪污

本集團要求其員工在任何時候都要堅持高標準的商業道德和誠信。我們在香港的所有董事和員工都必須遵守香港《防止賄賂條例》（《防止賄賂條例》），而我們在中國大陸的員工則必須遵守相關法律和法規，包括但不限於中國的《中華人民共和國刑法》。在報告期間，我們不知悉在有關賄賂、勒索、欺詐和洗黑錢的法律和法規方面，有任何重大不合規的情況。在報告期間沒有針對本集團或其僱員提出並已審結的貪污訴訟案件。

We prohibit transfer of benefits between our employees and other related parties. Guided by our internal policies and procedures, all directors and staff shall not provide or obtain any gifts or benefits from clients, suppliers or any person with business dealings with the Group. Our Staff Handbook and Code of Conduct also clearly outline that employee shall not accept advantages and gifts from our business partners.

To raise awareness on anti-corruption, anti-corruption training has been provided to directors and employees with an access to relevant anti-corruption training materials from the Independent Commission Against Corruption ("ICAC").

### Whistleblowing Policy

To encourage employees to report any suspected misconduct, we have established various whistle-blowing channels. If employees are aware of any suspicious acts and malpractices, they are encouraged to report to the senior management of the Group through email. All whistle-blowers' identities and reported cases are treated in confidence and reported cases would be appropriately handled in a fair manner.

### Anti-Money Laundering

The Group is aware of risk of money laundering practices in its financial services business. To prevent such practices, we strictly comply with all applicable anti-money laundering laws and regulations including but not limited to the Anti-Money Laundering ("AML") and Counter-Terrorist Financing ("CTF") Ordinance and the Guideline on Compliance of Anti-Money Laundering and Counter-Terrorist Financing Requirements for Licensed Money Lenders.

To mitigate the risk of money laundering and terrorist financing, we have established a series of internal policies and procedures. We adopt a risk-based approach and conduct comprehensive customer due diligence, risk assessment, regular review of customers' information, record keeping, identifying suspicious money laundering behaviours and reporting of suspicions transactions. To ensure effective implementation of the AML and CTF system, AML training is provided to all new employees. We also organise regular training to existing staff to allow them to keep abreast of the latest regulatory requirements and guidelines.

為了提高反貪污意識，我們為董事和員工提供了反貪污培訓，並可參閱廉政公署（「ICAC」）相關的反貪污培訓材料。

### 舉報政策

為鼓勵員工舉報任何可疑的不當行為，我們建立了各種舉報渠道。如果員工發現任何可疑的行為和不當行為，我們鼓勵他們通過電郵向本集團的高級管理層舉報。所有舉報人的身份和舉報的案件都會被保密，而舉報的案件會得到公正的妥善處理。

### 反洗黑錢

本集團意識到其金融服務業務中可能存在洗黑錢行為的風險。為防止此類行為，我們嚴格遵守所有適用的反洗黑錢法律和法規，包括但不限於《打擊洗錢及恐怖分子資金籌集條例》以及《持牌放債人遵從打擊洗錢及恐怖分子資金籌集規定的指引》。

為了減少洗黑錢和恐怖主義融資的風險，我們建立了一系列的內部政策和程序。我們採用基於風險的方法，進行全面的客戶盡職調查、風險評估、定期審查客戶信息、保存記錄、識別可疑的洗黑錢行為以及報告可疑的交易。為確保有效實施反洗黑錢和反恐融資系統，我們為所有新員工提供反洗黑錢培訓。我們還為現有員工組織定期培訓，使他們能夠掌握最新的監管要求和準則。

We endeavour to operate in an environmentally conscious manner to promote environmental responsibility and address climate change issues. Policies and procedures are formulated to guide employees on enhancing efficient use of resources, proper handling of emissions and cultivating green habits in workplaces.

我們努力以環保的方式經營業務，以履行環境責任和應對氣候變化議題。我們制定了政策和程序，指導員工加強資源的有效利用，妥當地處理排放物，在工作場所培養環保習慣。

### Climate Change

Currently, climate change is one of the most pressing environmental concerns in the world. Various extreme weather events, such as heatwaves, flooding, and droughts, may have an impact on our business operations. An ESG-related risk assessment has been conducted to identify potential climate-related risks and the impacts on the operations. The climate-related risks and control measures are carefully monitored, evaluated and managed by the Board and ESG Working Group on a regular basis.

To mitigate climate-related risks, relevant control measures are formulated and implemented in our business operations. Our employees are guided by the staff handbook which has clearly outlined the flexible work arrangements under typhoon and rainstorm signals. We maintain close communication with the building management company of our office, pay close attention to weather warnings and implement necessary response measures to cope with adverse weather conditions such as typhoons or rainstorms.

Workers with outdoor job duties at construction sites might suffer from illness such as heat stroke under extreme hot days, while tropical cyclones and heavy rainstorms could potentially lead to disruptions at construction sites. To respond, we have formulated guidelines and provided necessary precautionary measures for workers to effectively cope with adverse weather conditions. Work schedule would also be properly adjusted to ensure workers have sufficient rest and ensure their wellbeing.

Further, we remain vigilant concerning upcoming regulatory changes and potential risks posed by climate change and will endeavor to identify opportunities for increasing efficiency and reducing carbon emissions.

### 氣候變化

目前，氣候變化是世界上最迫切的環境議題之一。各種極端天氣事件，如熱浪、洪水和乾旱，可能對我們的業務營運產生影響。我們已經進行了ESG相關的風險評估，以識別潛在的氣候相關風險及其對業務的影響。董事會和ESG工作小組定期對與氣候相關的風險和控制措施進行詳細的監測、評估及管理。

為了減緩氣候相關的風險，我們制定了相關的控制措施，並在業務營運中實施。員工手冊明確列出了颱風和暴雨信號下的靈活工作安排，並向我們的員工提供指引。我們與辦公場所的物業管理公司保持密切溝通，密切關注天氣預警，並採取必要的應對措施，以應對颱風或暴雨等惡劣天氣。





在建築工地從事戶外工作的員工可能在極端炎熱的天氣下會出現中暑等病症，而熱帶氣旋和暴雨則有可能影響建築工地的營運。為了應對這種情況，我們已經制定了指南，並為員工提供必要的預防措施，以有效地應對惡劣的天氣狀況。我們也會適當調整工作日程，以確保員工有足夠的休息，並保障他們的福祉。

此外，我們對即將到來的監管要求變化以及氣候變化帶來的潛在風險保持警惕，並將努力尋找提高效率 and 減少碳排放的機會。

### Energy, Air and Greenhouse Gas Emissions

Major sources of our energy, air and GHG emissions are purchased electricity consumed for daily office operations and fuel consumption of company vehicles, including unleaded petrol and diesel. To raise employees’ awareness on environmental protection, we have formulated energy saving policies and procedures in our staff handbook and continuously encourage our employees to conserve energy. In our office operation, we have adopted various green practices to help reduce energy usage and greenhouse gas emissions. Examples of such practices are:

- Setting air-conditioners at certain designated temperature to optimise energy use efficiency;
- Switching off unnecessary use of computers, lighting, air conditioners and other equipment after office hour or when not in use; and
- Combining offices of the fitting-out and engineering operations with our headquarter office to further reduce energy consumption.

### 能源、廢氣和溫室氣體排放

我們的能源、廢氣和溫室氣體排放的主要來源是日常辦公所消耗的外購電力以及公司車輛的燃料消耗，包括無鉛汽油和柴油。為了提高員工的環保意識，我們在員工手冊中制定了節能政策和程序，不斷鼓勵員工節約能源。在我們的辦公室營運中，我們採取了各種綠色措施，以幫助減少能源使用和溫室氣體排放。這些措施的例子有：

- 將空調設置在指定的溫度，以優化能源使用效率；
- 在下班後或不使用設備時，關閉不必要的電腦、照明、空調和其他設備；以及
- 將設計、裝修及工程服務業務的辦公室與我們總部的辦公室合併，以進一步減少能源消耗。

With regard to our design, fitting-out and engineering services, dust and volatile organic compound ("VOC") are usually produced as one of the air emissions during the construction and demolition processes. Our employees and subcontractors are required to manage air emissions properly and minimise dust emission during our construction work. A series of measures are implemented to control air emissions and improve air quality:

- Adopting low-dust techniques and equipment to collect construction dust; and
- Ensuring VOC-containing materials are kept in air-tight containers to prevent air pollution.

We also put considerable efforts in reducing excessive amount of air emissions and GHG emissions from our vehicles and forklift trucks, including but not limited to:

- Conducting proper maintenance and services to improve combustion efficiency of fuel; and
- Constantly monitoring fuel consumption and mileage usage of vehicles to further improve our environmental performance.

### Waste Management

Due to our business nature, our waste generations are mainly waste paper and other office general waste from office operations and also construction waste from our design, fitting-out and engineering services business. We do not generate a significant amount of hazardous waste in our operation.

A series of measures and procedures are in place to ensure the construction waste from our fitting-out projects is managed in an environmentally responsible manner. We collect, sort, and arrange for either licensed waste collecting service providers or our subcontractors to transport the construction waste to government waste disposal facilities to handle and dispose appropriately and legally of construction waste. We also recycle construction waste as much as possible, and re-use the useful residual materials in other projects before disposing of the construction waste.

就我們的設計、裝修及工程服務而言，灰塵和揮發性有機化合物（「VOC」）通常是在建築和拆卸過程中產生的空氣排放物之一。我們的員工和分包商被要求妥善管理廢氣排放，並在施工過程中盡量減少灰塵排放。我們採取了一系列的措施控制廢氣排放和改善空氣質量：

- 採用低粉塵技術和設備來收集施工粉塵；以及
- 確保含VOC的材料保存在密閉的容器中，以防止空氣污染。

我們同時致力減少我們的車輛和叉車的過量廢氣排放和溫室氣體排放，包括但不限於：

- 進行適當的維護和服務以提高燃料的燃燒效率；以及
- 恒常監測車輛的燃料消耗和里程使用，以進一步改善我們的環境表現。

### 廢棄物管理

基於我們的業務性質，我們產生的廢棄物主要是辦公室營運產生的廢紙和其他一般辦公室廢棄物，以及我們的設計、裝修及工程服務業務產生的建築廢物。我們在營運中沒有產生大量的危險廢棄物。

我們採取了一系列的措施和程序，以確保我們的裝修項目產生的建築廢物能夠以對環境負責的方式進行管理。我們收集、分類，並安排持牌廢棄物收集服務商或我們的分包商將建築廢物運送到政府廢棄物處理設施，以適當和合法地處理建築廢物。我們還盡可能地回收建築廢物，並在處理建築廢物之前將有用的剩餘材料重新用於其他項目。

Whereas for office general waste, the waste is collected, handled and disposed of by a professional cleaning company appointed by the building property management company of our office operations. Meanwhile, we continue to implement different waste reduction measures in office operations, including but not limited to:

- Promoting online communication to avoid using papers;
- Encouraging employees to adopt double-sided printing to reduce paper consumption;
- Placing recycling boxes next to printers and fax machines in offices to collect and reuse paper for printing draft documents; and
- Arranging printing suppliers to collect used printer toner cartridges for recycling to reduce waste.

### Water Conservation

Our source of domestic water comes from local water suppliers, and we did not encounter any issue in sourcing water that was fit for purpose during the Reporting Period. We consume insignificant amount of water for purposes of drinking, toilet flushing and office cleaning in our daily operations; however, we are still mindful of reducing water use and improving water efficiency. We constantly raise awareness on water conservation and encourage our employees to develop habit of water saving, such as posting water conservation notices at the prominent places to remind employees of proper water usage.

### Minimising Environmental Impacts

The Group is dedicated to preserving natural resources and reducing the impact of our business activities on the environment. Although timber is often one of the natural resources used in our design, fitting-out and engineering services business, we actively recommend our customers to opt for eco-friendly alternatives to reduce the consumption of timber and save natural resources.

### Responsible Use of Packaging Materials

In our wine merchandising business, we do not consume a significant amount of packaging materials as we mainly use the original incoming packaging provided by the wineries and deliver our wines directly from our wine storage warehouse to our customers. This would conserve use of resources and avoid excessive and unnecessary use of packaging materials.

而對於辦公室的一般廢棄物，則由我們辦公室營運的物業管理公司指定的專業清潔公司來收集、處理和處置。同時，我們繼續在辦公室營運中實施不同的減少廢棄物措施，包括但不限於：

- 提倡網上溝通，避免使用紙張；
- 鼓勵員工採用雙面打印，以減少紙張消耗；
- 在辦公室的打印機和傳真機旁邊放置回收箱，以收集和重複使用打印草稿文件的紙張；以及
- 安排打印供應商收集用過的打印機碳粉盒進行回收，以減少浪費。

### 節約水資源

我們的生活用水來自於當地的水供應商。於報告期間，我們在求取適用水源方面沒有遇到任何問題。我們在日常營運中用於飲用、沖廁和清潔辦公室的耗水量並不重大。然而，我們仍然關注減少用水量和提高用水效率。我們不斷提高節水意識，鼓勵員工養成節水的習慣，例如在顯眼的地方張貼節水通知，提醒員工正確用水。

### 盡量減少對環境的影響

本集團致力於保護天然資源和減少我們的業務活動對環境的影響。雖然木材通常是我們設計、裝修及工程服務業務中使用的自然資源之一，但我們積極建議客戶選擇環保的替代品，以減少木材的消耗，節約天然資源。

### 負責任地使用包裝材料

在我們的美酒營銷業務中，我們沒有消耗大量的包裝材料，因為我們主要使用酒莊提供的原始進貨包裝，並將美酒直接從我們的美酒儲存倉庫送遞給我們的客戶。這將節約使用資源，避免過度和不必要地使用包裝材料。

### Noise Management

In respect of noise control in our worksites, construction operations are carried out according to the permitted work hours as specified in relevant laws and regulations. During the construction process, we use specialised equipment to ensure the noise does not exceed specified thresholds and affect the surrounding environment.

### 噪音管理

The board (the “Board”) of directors (the “Director(s)”) of Royal Century Resources Holdings Limited (the “Company”, together with its subsidiaries, the “Group”) is pleased to present this annual report together with the audited consolidated financial statements of the Group for the year ended 31 March 2022.

### PRINCIPAL ACTIVITIES AND BUSINESS REVIEW

The principal activity of the Company is investment holding and its subsidiaries are principally engaged in (i) provision of design, fitting out and engineering, and procurement of furnishings and related products services, (ii) leasing of construction equipment and provision of related installation services, (iii) sourcing and merchandising of fine and rare wines and (iv) provision of financial services.

Particulars of the Company’s principal subsidiaries are set out in note 38 to the consolidated financial statements.

### SHARE OPTION SCHEME

The share option scheme enables the Company to grant options to any full time or part time employee of the Company or any member of the Group (the "Eligible Participant(s)") as incentives or rewards for their contributions to the Group. The Company conditionally adopted a share option scheme (the "Scheme") on 30 June 2014 whereby the Board are authorised, at their absolute discretion and subject to the terms of the Scheme, to grant options to subscribe for the shares (the "Shares") of the Company to the Eligible Participant. The Scheme will be valid and effective for a period of ten years commencing from the date of adoption of the Scheme.

Upon acceptance of an option to subscribe for Shares granted pursuant to the Scheme (the "Option"), the Eligible Participant shall pay HK\$1.00 to the Company by way of consideration for the grant. The Option will be offered for acceptance for a period of 21 days from the date on which the Option is granted. The subscription price for the Shares subject to Options will be a price determined by the Board and notified to each participant and shall not be less than the highest of: (i) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date of grant of the Options, which must be a day on which trading of the Shares take place on the Stock Exchange (the "Trading Day"); and (ii) the average closing price of the Shares as stated in the Stock Exchange's daily quotations sheets for the 5 Trading Days immediately preceding the date of grant of the Options.

The Company shall be entitled to issue options, provided that the total number of Shares which may issue upon exercise of all options to be granted under the Scheme does not exceed 10% of the Shares in issue on the Listing Date. The Company may at any time refresh such limit, subject to the shareholders' approval and the issue of a circular in compliance with the GEM Listing Rules, provided that the total number of Shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under all the share option schemes of the Company does not exceed 30% of the Shares in issued at the time. An option may be exercised in accordance with the terms of the Scheme at any time during a period as the Board may determine which shall not exceed ten years from the date of grant subject to the provisions of early termination thereof.

As at 31 March 2022, the total number of the Shares available for issue under the Scheme is 3,000,000 Shares (as adjusted for the Share Consolidation on 18 November 2021), representing 1.91% of the issued Shares (the "Scheme Mandate Limit") of the aggregate number of Shares in issue immediately upon completion of the listing of the Shares on 18 July 2014 (as adjusted for the Share Consolidation on 18 November 2021) and representing 1.91% of the issued Shares as at 31 March 2022.

### 1. GENERAL INFORMATION

Royal Century Resources Holdings Limited (the "Company") was incorporated in Hong Kong as a company with limited liability and its shares are listed on GEM of The Stock Exchange of Hong Kong Limited (the "Stock Exchange"). The address of the registered office and principal place of business of the Company is disclosed in the corporate information section of the annual report.

The Company is an investment holding company. The Company and its subsidiaries (together the "Group") are principally engaged in:

- (i) provision of design, fitting out and engineering and procurement of furnishings and related products services;
- (ii) leasing of construction equipment and provision of related installation services;
- (iii) sourcing and merchandising of fine and rare wines; and
- (iv) provision of financial services.

The consolidated financial statements are presented in thousands ("HK\$'000") of Hong Kong dollars ("HK\$"), unless otherwise stated, which is also the functional currency of the Company and its Hong Kong subsidiaries.

### 2. ADOPTION OF NEW/REVISED HONG KONG FINANCIAL REPORTING STANDARDS ("HKFRSs")

The amendments address issues that might affect financial reporting when a company replaces the old interest rate benchmark with an alternative benchmark rate as a result of the interest rate benchmark reform (the “Reform”). The amendments complement those issued in November 2019 and relate to:

- changes to contractual cash flows – a company will not have to derecognise or adjust the carrying amount of financial instruments for changes required by the Reform, but will instead update the effective interest rate to reflect the change to the alternative benchmark rate;
- hedge accounting – a company will not have to discontinue its hedge accounting solely because it makes changes required by the Reform, if the hedge meets other hedge accounting criteria; and
- disclosures – a company will be required to disclose information about new risks arising from the Reform and how it manages the transition to alternative benchmark rates.

#### Amendments to HKFRS 16: COVID-19-Related Rent Concessions Beyond 30 June 2021

The amendments exempt lessees from having to consider individual lease contracts to determine whether rent concessions occurring as a direct consequence of the COVID-19 pandemic are lease modifications and allow lessees to account for such rent concessions as if they were not lease modifications. It applies to COVID-19-related rent concessions that reduce lease payments due on or before 30 June 2022. The amendments do not affect lessors.

The adoption of the above amendments does not have any significant impact on the consolidated financial statements.

- 披露 – 企業將須披露有關改革產生之新風險及其如何管理過渡至替代基準利率之資料。

#### 香港財務報告準則第16號之修訂：於二零二一年六月三十日後與2019冠狀病毒病相關之租金減免

根據該等修訂，承租人於釐定直接因2019冠狀病毒病引起的租金減免是否為租賃修訂時，可豁免逐份租約考慮，且獲准將有關租金減免當作非租賃修訂入賬。該等修訂適用於使二零二二年六月三十日或之前到期的租賃付款減少並與2019冠狀病毒病相關的租金減免。出租人不受該等修訂影響。

採納上述修訂對綜合財務報表並無任何重大影響。

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA, accounting principles generally accepted in Hong Kong and the Companies Ordinance. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on GEM of the Stock Exchange (the "GEM Listing Rules").

The consolidated financial statements have been prepared on a basis consistent with the accounting policies adopted in the consolidated financial statements for the year ended 31 March 2021 except for the adoption of the new/revised HKFRSs in note 2 to the consolidated financial statements that are relevant to the Group and effective from the current year.

The consolidated financial statements have been prepared on the historical cost basis except for investment property that is measured at fair value as explained in the accounting policies set out below.

A summary of the principal accounting policies adopted by the Group is set out below.

#### Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company (i.e. its subsidiaries). If a subsidiary prepares its financial statements using accounting policies other than those adopted in the consolidated financial statements for like transactions and events in similar circumstances, appropriate adjustments are made to that subsidiary's financial statements in preparing the consolidated financial statements to ensure conformity with the Group's accounting policies.

Control is achieved where the Group has: (i) the power over the investee; (ii) exposure, or rights, to variable returns from its involvement with the investee; and (iii) the ability to use its power over the investee to affect the amount of the Group's returns. When the Group has less than a majority of the voting rights of an investee, power over the investee may be obtained through: (i) a contractual arrangement with other vote holders; (ii) rights arising from other contractual arrangements; (iii) the Group's voting rights and potential voting rights; or (iv) a combination of the above, based on all relevant facts and circumstances.

The Company reassess whether it controls an investee if facts and circumstances indicate that there are changes to one or more of these elements of control stated above. Consolidation of a subsidiary begins when the Group obtains control of the subsidiary and ceases when the Group loses control of the subsidiary.

Income and expenses of subsidiaries are included in the consolidated statement of profit or loss and other comprehensive income from the date the Group gains control until the date when the Group ceases to control the subsidiary.

All intra-group assets and liabilities, profits or loss, income, expenses and cash flows relating to transactions between entities of the Group are eliminated in full on consolidation.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest determined at the date when control is lost and (ii) the carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests at the date when control is lost. The amounts previously recognised in other comprehensive income in relation to the disposed subsidiary are accounted for on the same basis as would be required if the parent had directly disposed of the related assets or liabilities. Any investment retained in the former subsidiary and any amounts owed by or to the former subsidiary are accounted for as a financial asset, associate, joint venture or others as appropriate from the date when control is lost.

#### Allocation of total comprehensive income

Profit or loss and each component of other comprehensive income of subsidiaries are attributed to the owners of the Company and the non-controlling interest. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interest even if this results in the non-controlling interests having a deficit balance.

#### Business combinations

The Group applies the acquisition method to account for business combinations except for business combinations under common control. The consideration transferred for the acquisition of a subsidiary is the fair values of the assets transferred, the liabilities incurred and the equity interests issued by the Group. The consideration transferred includes the fair value of any asset or liability resulting from a contingent consideration arrangement. Identifiable assets acquired and liabilities and contingent liabilities assumed in a business combination are measured initially at their fair values at the acquisition date.

The Group recognises any non-controlling interest in the acquiree on an acquisition-by-acquisition basis. Non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of the entity's net assets in the event of liquidation are measured at either fair value or the present ownership interests' proportionate share in the recognised amounts of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at their acquisition date fair value, unless another measurement basis is required by HKFRS.

Acquisition-related costs are expensed as incurred.

If the business combination is achieved in stages, the carrying amount of the acquirer's previously held equity interest in the acquiree is re-measured to fair value at the acquisition date; any gains or losses arising from such re-measurement are recognised in profit and loss.

Any contingent consideration to be transferred by the Group is recognised at fair value at the acquisition date. Subsequent changes to the fair value of the contingent consideration that is deemed to be an asset or a liability is recognised in accordance with HKFRS 9 either in profit and loss or as a change to other comprehensive income. Contingent consideration that is classified as equity is not remeasured, and its subsequent settlement is accounted for within equity.

#### Goodwill

The excess of the consideration transferred, the amount of any non-controlling interest in the acquiree and the fair value of any previous equity interest in the acquiree at the acquisition date over the fair value of the identifiable net assets acquired is recorded as goodwill. If the total of consideration transferred, non-controlling interest recognised and previously held interest measured is less than the fair value of the net assets of the subsidiary acquired in the case of a bargain purchase, the difference is recognised directly in profit or loss.

For the purpose of impairment testing, goodwill acquired in a business combination is allocated to each of the cash-generating units ("CGUs"), or groups of CGUs, that is expected to benefit from the synergies of the combination. Each unit or group of units to which the goodwill is allocated represents the lowest level within the entity at which the goodwill is monitored for internal management purposes. Goodwill is monitored at the operating segment level.

Goodwill impairment reviews are undertaken annually or more frequently if events or changes in circumstances indicate a potential impairment. The carrying amount of the CGU containing the goodwill is compared to the recoverable amount, which is the higher of value in use and the fair value less costs of disposal. Any impairment is recognised immediately as an expense and is not subsequently reversed.

#### Subsidiaries

In the Company's statement of financial position, which presented within these notes, investments in subsidiaries are stated at cost less impairment losses. The carrying amount of the investment is reduced to its recoverable amount on an individual basis, if it is higher than the recoverable amount. The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable.

#### Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the executive directors that makes strategic decisions.

為進行減值測試，因業務合併產生之商譽會分配至預期將受惠於合併的協同效應之各個或多組現金產生單位（「現金產生單位」）。獲分配商譽的各單位或各組單位代表就內部管理目的而對商譽進行實體內之最低層監察。商譽在本集團經營分部層面受到監察。

商譽每年進行減值覆核，或當有事件出現或情況改變顯示可能出現減值時，作出更頻密覆核。現金產生單位賬面值包括商譽與可收回金額作比較，可收回金額為使用價值與公允價值減出售成本之較高者。任何減值即時確認為開支，且其後不會撥回。

#### 附屬公司

於本公司財務狀況表內，於附屬公司之投資是按成本扣除減值虧損後入賬。倘投資的賬面價值高於可收回金額，該投資的賬面價值按個別基礎上，減至其可回收金額。附屬公司之業績由本公司按已收及應收股息基準入賬。

#### 分部報告

經營分部的呈報方式與向主要經營決策者提供內部報告的方式一致。作出策略性決定的執行董事為主要經營決策者，負責分配資源及評估經營分部表現。

*Nature of goods or services*

The nature of the goods or services provided by the Group is as follows:

- Sales of fine and rare wines

#### *Identification of performance obligations*

At contract inception, the Group assesses the goods or services promised in a contract with a customer and identifies as a performance obligation each promise to transfer to the customer either:

- (b) a series of distinct goods or services that are substantially the same and that have the same pattern of transfer to the customer.

A good or service that is promised to a customer is distinct if both of the following criteria are met:

- (b) the Group's promise to transfer the good or service to the customer is separately identifiable from other promises in the contract (i.e. the promise to transfer the good or service is distinct within the context of the contract).

##### Timing of revenue recognition

Revenue is recognised when (or as) the Group satisfies a performance obligation by transferring a promised good or service (i.e. an asset) to a customer. An asset is transferred when (or as) the customer obtains control of that asset. The Group transfers control of a good or service over time and, therefore, satisfies a performance obligation and recognises revenue over time, if one of the following criteria is met:

- (a) the customer simultaneously receives and consumes the benefits provided by the Group's performance as the Group performs;
- (b) the Group's performance creates or enhances an asset (for example, work in progress) that the customer controls as the asset is created or enhanced; or
- (c) the Group's performance does not create an asset with an alternative use to the Group and the Group has an enforceable right to payment for performance completed to date.

##### i) Sales of fine and rare wines

The Group sells fine and rare wines. Revenue from sales of fine and rare wines is recognised at a point in time when control of the products has been transferred, being when the products are delivered to the customers, and there is no unfulfilled obligation that could affect the customers' acceptance of the products. Delivery occurs when the products have been delivered to the specified location, the risks of obsolescence and loss have been transferred to the customers, and either the customers has accepted the products in accordance with the sales contract, the acceptance provisions have lapsed, or the Group has objective evidence that all criteria for acceptance have been satisfied.

##### ii) Provision of fitting out and engineering services/Provision of design and procurement of furnishing and related products services/Provision of construction equipment installation services

A contract with a customer is classified by the Group as a service contract when the contract relates to work on assets under the control of the customer and therefore the Group's activities create or enhance an asset under the customer's control.

When the outcome of a service contract can be reasonably measured, revenue from the contract is recognised over time using either the output method (i.e. based on direct measurements of the value of services delivered or measurement of work performed and the estimated total revenue for the contracts entered into by the Group) or the input method (i.e. based on the proportion of the actual inputs deployed to date as compared to the estimated total inputs), as appropriate, to measure the progress towards complete satisfaction of the performance obligation.

##### Interest income

Interest income is recognised as it accrues using the effective interest method. For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset. For credit-impaired financial assets, the effective interest rate is applied to the amortised cost (i.e. gross carrying amount net of loss allowance) of the asset.

##### Rental income

Rental income from operating leases of construction equipment and investment property is recognised when the assets are let out and on the straight-line basis over the lease term.

##### Contract assets and contract liabilities

If the Group performs by transferring goods or services to a customer before the customer pays consideration or before payment is due, the contract is presented as a contract asset, excluding any amounts presented as a receivable. Conversely, if a customer pays consideration, or the Group has a right to an amount of consideration that is unconditional, before the Group transfers a good or service to the customer, the contract is presented as a contract liability when the payment is made or the payment is due (whichever is earlier). A receivable is the Group's right to consideration that is unconditional or only the passage of time is required before payment of that consideration is due.

For a single contract or a single set of related contracts, either a net contract asset or a net contract liability is presented. Contract assets and contract liabilities of unrelated contracts are not presented on a net basis.

For some of the contracts for fitting out and engineering services, design and procurement of furnishing services businesses, the Group receives from the customer the whole or some of the contractual payments before the services are completed or when the goods are delivered (i.e. the timing of revenue recognition for such transactions). The Group recognises a contract liability until it is recognised as revenue. During that period, any significant financing components, if applicable, will be included in the contract liability and will be expensed as accrued unless the interest expense is eligible for capitalisation.

On the other hand, for some of the contracts for fitting out and engineering services, design and procurement of furnishing and related products services businesses, in accordance with the standard payment schedules, payments are not due or received from the customer until the services are completed or when the goods are delivered. However, for such transactions, revenue is recognised over time and therefore, a contract asset is recognised until it becomes a receivable or payments are received. During that period, any significant financing components, if applicable, will be included in the contract asset and recognised as interest income.

#### Leases

The Group assesses whether a contract is, or contains, a lease at inception of the contract. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

#### As lessee

The Group applies the recognition exemption to short-term leases and low-value asset leases. Lease payments associated with these leases are recognised as an expense on a straight-line basis over the lease term.

The Group has elected not to separate non-lease components from lease components, and accounts for each lease component and any associated non-lease components as a single lease component.

Amounts payable by the Group that do not give rise to a separate component are considered to be part of the total consideration that is allocated to the separately identified components of the contract.

The Group recognises a right-of-use asset and a lease liability at the commencement date of the lease.

The right-of-use asset is initially measured at cost, which comprises:

- the amount of the initial measurement of the lease liability;
- any lease payments made at or before the commencement date, less any lease incentives received;
- any initial direct costs incurred by the Group; and
- an estimate of costs to be incurred by the Group in dismantling and removing the underlying asset, restoring the site on which it is located or restoring the underlying asset to the condition required by the terms and conditions of the lease, unless those costs are incurred to produce inventories.

Subsequently, the right-of-use asset is measured at cost less any accumulated depreciation and any accumulated impairment losses and adjusted for any remeasurement of the lease liability. The lease payments included in the measurement of the lease liability comprise the following payments for the right to use the underlying asset during the lease term that are not paid at the commencement date:

- (a) fixed payments (including in-substance fixed payments), less any lease incentives receivable;

- (c) amounts expected to be payable under residual value guarantees;
- (d) exercise price of a purchase option if the Group is reasonably certain to exercise that option; and

The Group classifies each of its leases as either a finance lease or an operating lease at the inception date of the lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset. All other leases are classified as operating leases.

##### As lessor – operating lease

The Group applies the derecognition and impairment requirements in HKFRS 9 to the operating lease receivables.

A modification to an operating lease is accounted for as a new lease from the effective date of the modification, considering any prepaid or accrued lease payments relating to the original lease as part of the lease payments for the new lease.

#### Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recorded in the respective functional currency (i.e. the currency of the primary economic environment in which the entity operates) at the rates of exchanges prevailing at the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing at the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit or loss in the period in which they arise.

Exchange differences arising on the retranslation of non-monetary items carried at fair value are included in profit or loss for the period except for exchange differences arising on the retranslation of non-monetary items in respect of which gains and losses are recognised directly in other comprehensive income, in which cases, the exchange differences are also recognised directly in other comprehensive income.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. HK\$) using exchange rates prevailing at the end of each reporting period. Income and expenses items are translated at the average exchange rates for the year. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of exchange reserve.

#### Borrowing costs

Borrowing costs are recognised in profit or loss in the period in which they are incurred.

#### Provisions

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events, when it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation, and when a reliable estimate of the amount of obligation can be made. Expenditures for which a provision has been recognised are charged against the related provision in the year in which the expenditures are incurred. Provisions are reviewed at the end of each reporting period and adjusted to reflect the current best estimate. Where the effect of the time value of money is material, the amount provided is the present value of the expenditures expected to be required to settle the obligation. Where the Group expects a provision to be reimbursed, the reimbursement is recognised as a separate asset but only when the reimbursement is virtually certain.

#### Share capital

Ordinary shares are classified as equity.

#### Employee benefits

##### Defined contribution plans

The obligations for contributions to defined contribution retirement scheme in Hong Kong are recognised as an expense in profit or loss as incurred. The assets of the scheme are held separately from those of the Group in an independently administered fund.

In accordance with the rules and regulations in the People's Republic of China (the "PRC"), the employees of the Group's entities established in the PRC are required to participate in defined contribution retirement plans organised by local governments. Contributions to these plans are expensed in profit or loss as incurred and other than these monthly contributions, the Group has no further obligation for the payment of retirement benefits to its employees.

No forfeited contributions for the above plans may be used by the employer to reduce the existing level of contributions.

##### Short-term employee benefits

A liability is recognised for benefits accruing to employees in respect of wages and salaries, annual leave and sick leave in the period the related service is rendered at the undiscounted amount of the benefits expected to be paid in exchange for that service.

Liabilities recognised in respect of short-term employee benefits are measured at the undiscounted amount of the benefits expected to be paid in exchange for the related service.

#### Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before tax as reported in the consolidated statement of profit or loss and other comprehensive income because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

##### 定額供款計劃

定額供款退休計劃之供款責任於產生時在損益確認為開支。計劃資產與本集團資產分開由獨立管理基金持有。

根據中華人民共和國(「中國」)規則及規例，本集團在中國成立的實體之僱員需要參與由本地政府營辦之定額供款退休福利。該計劃的供款於產生時計入損益及除該每月供款外，本集團並無其他支付僱員退休福利之責任。

並無任何上述計劃沒收之供款供僱主扣減現時供款水平。

##### 短期僱員福利

僱員在提供相關服務期間所取得的工資、薪金、年假及病假等福利確認為負債，按預期應支付以用於交換該等服務的福利的未貼現數額計算。

就短期僱員福利確認的負債按預期應支付以用於交換相關服務的福利的未貼現數額計量。

#### 稅項

所得稅開支指即期應付稅項及遞延稅項之總和。

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates, and interests in joint ventures, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments and interests are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

遞延稅項按綜合財務報表內資產與負債賬面值與計算應課稅溢利時採用之相應稅基之間之暫時差額予以確認。所有應課稅暫時差額一般確認為遞延稅項負債。倘可能出現動用該等可扣減暫時差額之應課稅溢利，則所有可扣減暫時差額一般會確認為遞延稅項資產。倘該暫時差額乃源自商譽或一項交易（業務合併除外）中初步確認其他資產及負債而該差額並無影響應課稅溢利或會計溢利，則不會確認該等資產及負債。

除了當本集團能夠控制其暫時性差異和將不會在可預見將來沖回暫時性差異外，遞延稅項負債就投資附屬公司、合作／合資企業及聯營公司權益確認所有應課稅暫時性差異。與投資及權益相關之可扣減暫時性差異所產生之遞延稅項資產，僅於在可見將來有可能具備足夠應課稅溢利抵銷暫時性差異之利益以作回撥時，方會予以確認。

於報告期末檢討遞延稅項資產之賬面值，及減低至應課稅溢利可充分抵銷全部或部分可收回資產之程度。

遞延稅項資產及負債乃根據預期清償負債或變現資產期間應用之稅率計量，而該稅率乃根據於各報告期末已頒佈或實質上已頒佈之稅率（及稅法）釐定。

遞延稅項負債及資產之計量反映本集團於報告期末預期可收回或清償其資產及負債之賬面值之方式將遵循之稅務後果。

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively. Where current tax or deferred tax arises from the initial accounting for a business combination, the tax effect is included in the accounting for the business combination.

#### Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment losses, if any. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Repairs and maintenance are charged to profit or loss during the year in which they are incurred.

Depreciation is recognised so as to write off the cost of property, plant and equipment to their residual value, if any, using the straight line method over their estimated useful lives or depreciation rates as follows:

The estimated useful lives and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

#### 物業、機器及設備

物業、機器及設備按成本減累計折舊及累計減值虧損（如有）列賬。物業、機器及設備項目之成本包括其購買價格及令資產達到其計劃使用之工作狀況及位置之任何直接應佔成本。維修及保養在發生的當年計入當期損益。

折舊乃採用直線法按物業、機器及設備之估計可使用年期或折舊率以撇銷其成本減其剩餘價值（如有）予以確認如下：

#### Investment property

Investment property is property held by owner or lessee, to earn rentals and/or for capital appreciation.

Investment property is initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment property is measured at its fair value. Gains or losses arising from changes in the fair value of investment property are included in profit or loss for the period in which they arise. The fair value of investment property is based on a valuation by an independent valuer who holds a recognised professional qualification and has recent experience in the location and category of property being valued.

#### Intangible assets other than goodwill

Intangible assets that are acquired by the Group are stated at cost less accumulated amortisation (where the estimated useful life is finite) and impairment losses.

Amortisation of intangible assets with finite useful lives is charged to profit or loss on a straight line basis over the asset's estimated useful lives.

Intangible assets are not amortised while their useful lives are assessed to be indefinite. Any conclusion that the useful life of an intangible asset is indefinite is reviewed annually to determine whether events and circumstances continue to support the indefinite useful life assessment for that asset. If not, the change in the useful life assessment from the date of change is in accordance with the policy for amortisation of intangible assets with finite lives as set out above.

投資物業初步按成本計量，當中包括任何直接應佔開支。於初步確認後，投資物業按公平值計量。投資物業公平值變動產生之收益或虧損於產生期間計入損益。投資物業之公平值乃根據獨立估值師（其持有獲認可之專業資格並於估值物業之地點及類別方面擁有新近經驗）作出之估值計算。

#### 無形資產（商譽以外）

本集團所購無形資產按成本減累計攤銷（倘估計可使用年期為有限者）及減值虧損列賬。

具有有限可使用年期的無形資產按直線法於資產的估計可使用年期內攤銷並自損益扣除。

如無形資產的可使用年期被評估為無確定限期，則該等無形資產不會被攤銷。有關無形資產的可使用年期為無確定限期的任何結論，會每年檢討以釐定事件及情況是否繼續支持該資產的無確定限期可使用年期評估。倘不繼續支持，則可使用年期評估由無確定限期變為確定限期，並自變化的日期根據上述有確定使用年期的無形資產攤銷政策採用未來適用法處理。

#### Impairment of non-financial assets, other than goodwill

At the end of each reporting period, the Group reviews internal and external sources of information to assess whether there is any indication that its property, plant and equipment, intangible assets or right-of-use assets may be impaired or impairment loss previously recognised no longer exists or may be reduced. If any such indication exists, the recoverable amount of the asset is estimated, based on the higher of its fair value less costs of disposal and value in use. In addition, the Group tests its intangible assets that have indefinite useful lives and intangible assets that are not yet available for use for impairment by estimating their recoverable amount on an annual basis and whenever there is an indication that those assets may be impaired. Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the smallest group of assets that generates cash flows independently (i.e. cash-generating unit).

If the recoverable amount of an asset or a cash-generating unit is estimated to be less than its carrying amount, the carrying amount of the asset or cash-generating unit is reduced to its recoverable amount. Impairment loss is recognised as expense in profit or loss immediately.

A reversal of impairment loss is limited to the carrying amount of the asset or cash-generating unit that would have been determined had no impairment loss been recognised in prior years. Reversal of impairment loss is recognised as income in profit or loss immediately.

#### Cash and cash equivalents

Bank balances and cash in the consolidated statement of financial position comprise cash at banks and on hand and short-term deposits with a maturity of three months or less.

For the purpose of the consolidated statement of cash flows, cash and cash equivalents consist of cash and short-term deposits, as defined above, net of outstanding bank overdrafts.

於各報告期末，本集團審核內部及外部資料來源，以評估其物業、機器及設備、無形資產以及使用權資產是否有任何減值指標或先前已確認之減值虧損不再存在或可能減少。倘存在任何跡象，則根據其公平值減出售成本與使用價值之較高者估計資產之可收回金額。此外，本集團通過估計年度可收回金額，並在有指標顯示資產可能發生減值時，對其沒有確定使用年限的無形資產和尚不能用的無形資產進行減值測試。倘無法估計個別資產之可收回金額，則本集團估計獨立產生現金流量之最小組別資產（即現金產生單位）之可收回金額。

倘資產或現金產生單位之可收回金額估計將低於其賬面值，則資產或現金產生單位之賬面值降至其可收回金額。減值虧損即時確認為開支。

減值虧損之撥回以過往年度未確認減值虧損時原應釐定之資產或現金產生單位之賬面值為限。減值虧損之撥回即時於損益確認為收入。

#### 現金和現金等價物

綜合財務狀況表中之銀行結餘及現金包括銀行及手頭現金以及三個月或三個月內到期的短期存款。

就綜合現金流量表而言，現金及現金等價物包括現金及上文所界定之短期存款，除卻未償還銀行透支淨值。

#### Financial instruments

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instrument on a trade date basis.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

#### Financial assets

##### Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value (either through other comprehensive income, or through profit or loss); and
- those to be measured at amortised cost.

The classification depends on the entity's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value, gains and losses will either be recorded in profit or loss or other comprehensive income. For investments in equity instruments that are not held for trading, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at fair value through other comprehensive income.

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

金融資產及金融負債初步按公平值計量。收購或發行金融資產及金融負債(不包括按公平值透過損益列賬之金融資產或金融負債)直接應佔之交易成本乃於初步確認時加入或扣自金融資產或金融負債之公平值(按適用情況)。收購按公平值透過損益列賬之金融資產或金融負債直接應佔之交易成本立即於損益中確認。

#### 金融資產

##### 分類

本集團將其金融資產按以下計量類別分類：

- 其後將按公平值(計入其他全面收益或計入損益)計量；及

該分類取決於管理金融資產及現金流量合約期的業務模式。

##### Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity. If the Group neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Group continues to recognise the asset to the extent of its continuing involvement and recognises an associated liability. If the Group retains substantially all the risks and rewards of ownership of a transferred financial asset, the Group continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

##### Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset. Transaction costs of financial assets carried at fair value through profit or loss are expensed in profit or loss.

##### Debt instruments

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. There are three measurement categories into which the Group classifies its debt instruments:

- Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Interest income from these financial assets is included in finance income using the effective interest method. Any gain or loss arising on derecognition is recognised directly in profit or loss and presented in other gains/(losses) together with foreign exchange gains and losses. Impairment losses are presented as separate line item in the consolidated statement of profit or loss.

##### 確認及終止確認

金融資產之定期購入及出售於交易日確認。交易日指本集團承諾購入或出售該資產之日。本集團僅在自資產收取現金流量之合約權利屆滿或其向另一實體轉讓金融資產及資產擁有權之絕大部分風險及回報時終止確認該金融資產。倘本集團既沒有轉讓也沒有保留絕大部分風險及回報，並繼續控制已轉讓資產，本集團會繼續確認資產，惟以其繼續涉及之程度為限，並確認相關負債。倘本集團保留已轉讓金融資產擁有權之絕大部分風險及回報，本集團會繼續確認金融資產，亦就已收所得款項確認已抵押借貸。

##### 計量

##### 債務工具

債務工具之後續計量取決於本集團管理資產及資產現金流量特徵的業務模式。本集團將債務工具分為三個計量類別：

- Fair value through other comprehensive income: Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets' cash flows represent solely payments of principal and interest, are measured at fair value through other comprehensive income ("OCI"). Movements in the carrying amount are taken through OCI, except for the recognition of impairment gains or losses, interest income and foreign exchange gains and losses which are recognised in profit or loss. When the financial asset is derecognised, the cumulative gain or loss previously recognised in OCI is reclassified from equity to profit or loss and recognised in other gains/(losses). Interest income from these financial assets is included in finance income using the effective interest method. Foreign exchange gains and losses are presented in other gains/(losses) and impairment expenses are presented as separate line item in the consolidated statement of profit or loss.
- Fair value through profit or loss: Assets that do not meet the criteria for amortised cost or fair value through other comprehensive income are measured at fair value through profit or loss. A gain or loss on a debt investment that is subsequently measured at fair value through profit or loss is recognised in profit or loss and presented net within other gains/(losses) in the period in which it arises.

#### Impairment

The Group assesses on a forward looking basis the expected credit losses ("ECL") associated with its debt instruments carried at amortised cost and contract assets. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

Impairment on financial assets measured at amortised cost other than trade receivables is measured as either 12-month ECL or lifetime ECL, depending on whether there has been a significant increase in credit risk since initial recognition. If a significant increase in credit risk of a receivable has occurred since initial recognition, then impairment is measured as lifetime ECL.

- 按公平值計入其他全面收益：就持作收回合約現金流量及出售金融資產的資產而言，倘有關資產的現金流量純粹為支付本金及利息，則按公平值計入其他全面收益（「其他全面收益」）計量。賬面值變動計入其他全面收益，惟於損益確認的減值收益或虧損、利息收入及外匯收益及虧損除外。終止確認金融資產時，先於其他全面收益確認的累計收益或虧損由權益重新分類至損益及於其他收益／（虧損）確認。來自該等金融資產的利息收入按實際利率法計入財務收入。外匯收益及虧損呈列於其他收益／（虧損），減值開支則於綜合收益表中呈列為各自單行項目。

When there is a significant increase in credit risk or the proceeds receivables are not settled in accordance with the terms stipulated in the agreements, management considers these receivables as underperforming or non-performing and impairment is measured as lifetime ECL.

##### Measurement of ECL

ECL is a probability-weighted estimate of credit losses (i.e. the present value of all cash shortfalls) over the expected life of the financial instrument.

For financial assets, a credit loss is the present value of the difference between the contractual cash flows that are due to an entity under the contract and the cash flows that the entity expects to receive. For a lease receivable, the cash flows used for determining the ECL should be consistent with the cash flows used in measuring the lease receivable in accordance with HKFRS 16.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of a financial instrument while 12-month ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

Where ECL is measured on a collective basis, the financial instruments are grouped based on the following one or more shared credit risk characteristics:

- (i) past due information
- (ii) nature of instrument
- (iii) nature of collateral
- (iv) industry of debtors
- (v) geographical location of debtors
- (vi) external credit risk ratings

倘信貸風險大幅升高或應收款項未按合約條款支付，管理層將認為此類應收款項為關注級或不良級，其減值按全期預期信貸虧損計量。

##### 計量預期信貸虧損

預期信貸虧損為金融工具預期使用期限內信貸虧損之概率加權估計（即所有現金差額之現值）。

就金融資產而言，信貸虧損為根據合約應付予實體之合約現金流量與實體預期收取之現金流量之差額之現值。就租賃應收款項而言，用於確定預期信貸虧損的現金流量應與按照香港財務報告準則第16號計量租賃應收款項所使用的現金流量一致。

Loss allowance is remeasured at each reporting date to reflect changes in the financial instrument's credit risk and loss since initial recognition. The resulting changes in the loss allowance are recognised as an impairment gain or loss in profit or loss with a corresponding adjustment to the carrying amount of the financial instrument, except in the case of debt instruments measured at fair value through OCI, the loss allowance is recognised in other comprehensive income and accumulated in the fair value reserve (recycling).

*Definition of default*

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that the Group may not receive the outstanding contractual amounts in full if the financial instrument that meets any of the following criteria.

- (i) information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group); or
- (ii) there is a breach of financial covenants by the counterparty.

Irrespective of the above analysis, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

##### Assessment of significant increase in credit risk

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. In particular, the following information is taken into account in the assessment:

- the debtor's failure to make payments of principal or interest on the due dates;
- an actual or expected significant deterioration in the financial instrument's external or internal credit rating (if available);
- an actual or expected significant deterioration in the operating results of the debtor; and

*Low credit risk*

A financial instrument is determined to have low credit risk if:

- (i) it has a low risk of default;
- (ii) the borrower has a strong capacity to meet its contractual cash flow obligations in the near term; and
- (iii) adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

As detailed in note 6(b) to the consolidated financial statements, bank balances and other receivables are determined to have low credit risk.

*Simplified approach of ECL*

For trade receivables, operating lease receivables and contract assets, the Group applies a simplified approach in calculating ECL. The Group recognises a loss allowance based on lifetime ECL at each reporting date and has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

*Credit-impaired financial asset*

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired include observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower.
- (b) a breach of contract, such as a default or past due event.
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider.
- (d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation.

*Write-off*

When management considers that there is no reasonable expectation of recovery, the financial assets measured at amortised cost will be written off. The Group has a policy of writing off the gross carrying amount based on historical experience of recoveries of similar assets. However, financial assets that are written off could still be subject to enforcement activities under the Group's procedures for recovery of amounts due, taking into account legal advice if appropriate. Any subsequent recovery is recognised in profit or loss.

#### **Financial liabilities and equity instruments**

Debt and equity instruments issued by a group entity are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument.

*Other financial liabilities*

Other financial liabilities including trade and other payables and lease liabilities are subsequently measured at amortised cost, using the effective interest method.

*Effective interest method*

The effective interest method is a method of calculating the amortised cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial liability, or, where appropriate, a shorter period to the net carrying amount on initial recognition. Interest expense is recognised on an effective interest basis.

##### Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all of its liabilities. Equity instruments issued by the Company are recognised at the proceeds received, net of direct issue costs.

##### Derecognition

The Group derecognised financial liabilities when, and only when, the Group's obligations are discharged, cancelled or expire. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

#### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is calculated using the first in, first out for construction materials and weighted average method for fine and rare wines. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

#### Related parties

A related party is a person or entity that is related to the Group.

#### Fair value measurement

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use.

The Group uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs. Specifically, the Group categorises the fair value measurements into three levels, based on the characteristics of inputs, as follows:

- Level 1 – Quoted (unadjusted) market prices in active markets for identical assets or liabilities.
- Level 2 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is directly or indirectly observable.
- Level 3 – Valuation techniques for which the lowest level input that is significant to the fair value measurement is unobservable.

In the application of the Group's accounting policies, which are described in note 3 to the consolidated financial statements, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

#### Critical judgements in applying the Group's accounting policies

The following are the critical judgments, apart from those involving estimation (see below), that the directors of the Company have made in the process of applying the Group's accounting policies and that have the most significant effect on the amounts recognised in consolidated financial statements.

#### Classification of leases – as lessor

The Group classifies each of its leases as either a finance lease or an operating lease at the inception date which involves the overall assessment of whether the lease transfers substantially all the risks and rewards incidental to ownership of the underlying asset. As part of the assessment, the Group considers all the relevant factors including the contractual terms and the circumstances of the contractual parties to determine the substance of the transaction.

#### Key sources of estimation uncertainty

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

#### Revenue from contract with customers within HKFRS 15

Revenue from fitting out and engineering services and design and procurement of furnishing services is recognised over time, which is dependent on estimating the outcome of the contract, as well as the work done to date. The Group reviews and revises the estimates of contract revenue, contract costs and variation orders, prepared for each construction contract as the contract progresses. Budgeted costs are prepared by management on the basis of quotations from time to time provided by the major subcontractors, suppliers or vendors involved and the experience of management. In order to keep the budget accurate and up-to-date, management conducts periodic reviews on the budgeted costs by comparing the budgeted amounts to the actual costs incurred.

Significant judgement is required in estimating the contract revenue, contract costs and variation work which may have an impact on revenue recognised to date. In addition, actual outcomes in terms of total revenue or costs may be higher or lower than estimated at the end of the reporting period, which would affect the revenue recognised in future periods as an adjustment to the amounts recorded to date.

#### Income tax

As at 31 March 2022, no deferred tax asset has been recognised on the tax losses and deductible temporary difference of approximately HK\$128,788,000 (2021: HK\$114,495,000) and HK\$2,798,000 (2021: HK\$4,158,000) respectively due to the unpredictability of future profit streams. The realisability of the deferred tax asset mainly depends on whether sufficient future profits or taxable temporary differences will be available in the future. In cases where the actual future profits or taxable temporary differences are less or more than expected or change in facts and circumstances which result in revision of future taxable profits estimation, a material reversal or recognition of deferred tax assets may arise, which would be recognised in profit or loss for the period in which such a reversal or recognition takes place.

#### 香港財務報告準則第15號項下客戶合約收益

來自裝修及工程服務，以及設計及採購傢俱及相關產品服務的收益隨時間確認，其取決於對合約總結果的估計及迄今已進行工程。本集團於合約進行期間檢討及修訂就每一份建築合約編製的估計合約收益、合約成本及更改指示。管理層不時根據由所涉主要分包商、供應商或賣家提供的報價以及管理層的經驗編製成本預算。為保持預算準確及合時，管理層定期透過比較預算金額與實際產生的成本，檢討成本預算。

估計合約收益、合約成本及更改指示需要作出重大判斷，可能影響迄今已確認收益及溢利。此外，實際產生的收益或成本總額可能高於或低於報告期末的估計，繼而將會影響就未來期間確認的收益及溢利，作為對迄今記賬金額的調整。

#### 所得稅

截至二零二二年三月三十一日，由於未來溢利流難以預測，故就稅項虧損及可扣減暫時差額分別約128,788,000港元（二零二一年：114,495,000港元）及2,798,000港元（二零二一年：4,158,000港元）而言，並無確認遞延稅項資產。遞延稅項資產的可變現情況主要取決於日後是否有足夠的溢利或應課稅暫時差額以供動用。倘若未來產生的實際溢利低於預期或因事實和情況的變化而導致未來應納稅利潤估算的修訂，則可能產生重大遞延稅項資產撥回或確認，而該項撥回或確認將於出現撥回或確認的期間內在損益內確認。

##### Allowance for ECLs on loan and interest receivables, trade and other receivables and contract assets

The Group calculates ECLs for loan and interest receivables, trade and other receivables and contract assets based on the Group's historical default rates taking into consideration forward-looking information that is reasonable and supportable available without undue costs or effort. At each reporting date, the historical observed default rates are reassessed and changes in the forward-looking information are considered. In addition, loan and interest receivables, trade and other receivables and contract assets with significant balances and credit impaired are assessed for ECLs individually.

The allowance for ECLs is sensitive to changes in circumstances and forecast general economic conditions. The information about the ECLs and the Group's loan and interest receivables, trade and other receivables and contract assets are disclosed in note 6(b) to the consolidated financial statements. If the financial condition of the customers or the forecast economic conditions were to deteriorate, the actual loss allowance would be higher than estimated.

##### Estimated useful lives and impairment of property, plant and equipment and right-of-use assets

The Group's management determines the estimated useful lives, and related depreciation charges for its property, plant and equipment and right-of-use assets. The estimates are based on the historical experience of the actual useful lives of those assets of similar nature and functions. Management will increase the depreciation where useful lives are less than previously estimated lives. It will write off or write down technically obsolete or non-strategic assets that have been abandoned or sold. Actual economic lives may differ from estimated useful lives. Periodic review could result in a change in depreciable lives and therefore affect the depreciation charges in future periods.

In determining whether an asset is impaired or the event previously causing the impairment no longer exists, management has to assess whether an event has occurred that may affect the asset value or such event affecting the asset value has not been in existence. If any such indication exists, the recoverable amounts of the asset would be determined based on the higher of the value in use and fair value less costs of disposal, which involve significant judgements and estimates.

本集團計算應收貸款及利息、貿易及其他應收款項及合約資產的預期信貸虧損基於本集團之歷史違約率，當中考慮無需付出過多成本或精力即可獲得之合理且可支持的前瞻性資料。於各報告日期，可觀察的歷史違約率會重新被評估，並考慮前瞻性資料之變動。此外，具有大額結餘及出現信貸減值的應收貸款及利息、貿易及其他應收款項及合約資產會個別進行預期信貸虧損評估。

預期信貸虧損撥備容易受各種情況及預測一般經濟狀況變動影響。有關預期信貸虧損及本集團應收貸款及利息、貿易及其他應收款項及合約資產的資料於綜合財務報表附註6(b)披露。倘客戶的財務狀況或預測經濟狀況將惡化，則實際虧損撥備會高於估計額。

##### 物業、機器及設備以及使用權資產之可使用年期及減值

本集團管理層就本集團的物業、機器及設備及使用權資產釐定預計可使用年期，以及相關的折舊費用。該估計以具有類似性質及功能之資產的實際可使用年期的歷史經驗為基礎。當可使用年期小於先前估計時，管理層將增加折舊。其將沖銷或沖減已被放棄或出售的技術陳舊或者非戰略性資產。實際經濟壽命可能不同於預計可使用年期。定期審查可能會導致折舊年限的變化，從而影響未來期間的折舊費用。

在釐定資產是否出現減值或過往導致減值之事件是否不再存在時，管理層須評估有否出現可能影響資產價值之事件或該影響資產價值之事件是否並不存在。倘有任何該等跡象存在，則會基於使用價值與公平值減出售成本之較高者釐定資產之可收回金額，這涉及重大的判斷和估計。

##### Valuation of investment property

Investment property is carried in the consolidated statement of financial position at 31 March 2022 at its fair value of approximately HK\$26,200,000 (2021: HK\$27,000,000). The fair value was based on a valuation on this property conducted by an independent professional valuer using property valuation techniques which involve certain assumptions of market conditions. Favourable or unfavourable changes to these assumptions would result in changes in the fair value of the Group's investment property and corresponding adjustments to the amount of gain or loss reported in the consolidated statement of profit or loss and other comprehensive income.

##### Impairment of intangible assets

The Group evaluates whether intangible assets have suffered any impairment based on impairment assessment performed at least annually and whenever events or changes in circumstances indicate that the carrying amount of the intangible assets may not be recoverable, in accordance with the stated accounting policy. The recoverable amounts of the intangible assets have been determined based on the higher of the fair value less cost of disposal and value in use. These calculations require the use of estimates and judgements.

### 5. CAPITAL MANAGEMENT

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balance. The Group's overall strategies remain unchanged from prior year.

The directors of the Company review the capital structure on a continuous basis taking into account the cost of capital and the risk associated with the capital. Based on the directors' recommendation, the Group will balance its overall capital structure through payment of dividend, issuance of new shares as well as the raising of new debts or the repayment of existing debts.

The Group's major financial instruments include loan and interest receivables, trade and other receivables, cash and bank balances, trade and other payables and lease liabilities. Details of the financial instruments are disclosed in respective notes. The risks associated with these financial instruments include market risks (currency risk and interest rate risk), credit risk and liquidity risk. The policies on how to mitigate these risks are set out below. Management manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

#### Market risk

##### Currency risk

The Group has certain portion of cash and bank balances, trade and other receivables and trade and other payables denominated in currencies (such as Renminbi ("RMB"), Singapore Dollars ("SGD") and United States Dollars ("US\$")) other than the functional currency of the entity to which they relate. The Group currently does not have a foreign currency hedging policy. However, management monitors foreign exchange exposure and will consider hedging significant foreign currency exposure should the need arise. Management reviews its foreign currency exposures regularly and considers there is no significant exposure on its foreign currency risk.

##### Interest rate risk

The Group is exposed to cash flow interest rate risk in relation to bank balances with variable interest rate. The Group has no significant exposure to interest rate risk.

##### Credit risk

The Group's credit risk is primarily attributable to bank balances, loan and interest receivables, trade and other receivables and contract assets. Management has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis.

As at 31 March 2022, the Group's maximum exposure to credit risk represents the carrying amount of the respective recognised financial assets as stated in the consolidated statement of financial position.

In order to minimise credit risk, management of the Group has delegated an officer responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverability of each individual trade debt at the end of the reporting period to ensure that adequate impairment losses are made for irrecoverable amounts. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

##### Bank balances

The credit risk on bank balances is limited because the counterparties are banks with high credit ratings assigned by authorised credit-rating agencies.

##### Other receivables

The Group considers that other receivables have low credit risk based on the counterparties' strong capacity to meet its contractual cash flow obligations in the near term and low risk of default. Impairment on other receivables is measured on 12-month ECL and reflects the short maturities of the exposures.

##### 其他應收款項

基於交易對手有很強的能力履行近期的合約現金流量責任且違約風險偏低，本集團認為其他應收款項之信貸風險偏低。其他應收款項減值乃按12個月預期信貸虧損計量，反映風險為期較短。

In estimating the ECL, the Group has taken into account the historical actual credit loss experience over the past 3 years (2021: 3 years) and the financial position of the counterparties by reference to, among others, their management or audited accounts and available press information, adjusted for forward-looking factors that are specific to the debtors and general economic conditions of the industry in which the counterparties operate, in estimating the probability of default of these financial assets, as well as the loss upon default in each case.

There was no change in the estimation techniques or significant assumptions made during the year.

##### Trade receivables and contract assets

The Group applies the simplified approach to provide for lifetime ECL on trade receivables and contract assets. To measure the ECL, trade receivables and contract assets have been grouped based on shared credit risk characteristics. The Group has considered historical and available forwarding-looking information in estimating ECL.

##### Trade receivables

The Group trades only with recognised and creditworthy parties. It is the Group's policy that all customers who wish to trade on credit terms are subject to credit verification procedures. The Group normally allows average credit period ranging from 30 to 60 days (2021: 30 to 60 days) to its trade customers. The Group seeks to maintain strict control over its outstanding receivables. Overdue balances are reviewed regularly by management.

Segments assets include all assets except for corporate assets which are managed on a group basis. All liabilities are allocated to reportable segment liabilities other than unallocated head office and corporate liabilities which are managed on a group basis and certain other payables and accrued charges.

Revenues and expenses are allocated to the operating segments with reference to sales generated by those segments and the expenses incurred by those segments or which otherwise arise from the depreciation of assets attributable to those segments. The measure used for reporting segment results is profit/loss before taxation without allocation of other unallocated corporate expenses and income.

The Inland Revenue (Amendment) (No. 7) Bill 2017 which introduces the two-tiered profits tax rates regime was signed into law and gazetted in March 2018. Under the two-tiered profits tax rates regime, the first HK\$2,000,000 of profits of a qualifying group entity are taxed at 8.25% and profits above HK\$2,000,000 are taxed at 16.5%. The profits of other group entities in Hong Kong not qualifying for the two-tiered profits tax rates regime continue to be taxed at a flat rate of 16.5%.

Pursuant to the rules and regulations of the British Virgin Islands (the "BVI"), the Group is not subject to any income tax in the BVI.

No Singapore Corporate Tax has been provided as there is no estimated assessable profit for both years.

The PRC corporate income tax in respect of operations in the PRC is calculated at the applicable tax rates on the estimated assessable profits for both years based on existing legislation, interpretations and practices in respect thereof.

The investment property is leased to tenants for a term ranged from one to two years, in which the first year is non-cancellable and the second year is cancellable with a notice period of 2 months (2021: 2 months) by the tenant. The lease does not contain any renewal option. Monthly rental charges consist of fixed payments. The landlord bears the management fees and amounts charged by the government such as the rates levied on the Group.

The investment property is subject to residual value risk. The lease contract, as a result, includes a provision based on which the Group has the right to charge the tenant for any damage to the investment properties at the end of the lease. Besides, the Group has purchased insurance to protect it against any loss that may arise from accidents or physical damages of the properties.

Property rental income earned during the year was approximately HK\$870,000 (2021: HK\$834,000). The property held for rental purposes is expected to generate rental yields of 3.32% (2021: 3.09%) on an ongoing basis. The property held has committed tenants for the next year.

Lease term for warehouse is 6 years, which contains an option for both lessor and lessee to renew or terminate the lease after expiration of the lease term with three months' notice. The extension option is normally exercised because there are significant leasehold improvements while the termination option is normally not exercised. The Group seldom exercises options that were not included in the lease liabilities. The carrying amount of the SFO Licences has been included in the carrying amount of Financial services business segment CGU for impairment assessment.

The Group has appointed an independent qualified professional valuer, PVA, to perform an appraisal of the recoverable amount of the SFO Licences as at 31 March 2022. The recoverable amount of Financial services business segment CGU have been determined based on fair value less costs of disposal using the market approach, which is higher than value in use.

The key assumptions used in estimating the fair value of Financial services business segment CGU under the market approach include the comparable transactions of companies during the past 3.5 years, which the comparable companies hold either, or a combination of, SFC Type 1, Type 4 or Type 9 licences. The valuation was categorised as Level 3 fair value measurement.

The recoverable amount of Financial services business segment CGU based on the fair value less costs of disposal was approximately HK\$4,566,000 (2021: HK\$5,042,000). Accordingly, having compared with the carrying amount of Financial services business segment CGU (including the carrying amount of goodwill as mentioned in note 21 to the consolidated financial statements), impairment loss of approximately HK\$14,172,000 (2021: HK\$13,696,000) and HK\$854,000 (2021: HK\$854,000) were provided on SFO Licences and goodwill associated with Financial services business segment CGU as at 31 March 2022 respectively.

The Group has appointed an independent qualified professional valuer, PVA, to perform an appraisal of the recoverable amount of the cross-boundary vehicle licence as at 31 March 2022. The recoverable amount of the cross-boundary vehicle licence has been determined on the basis of value in use calculation. The value in use calculation uses cash flow projections covering a period of five years based on financial budgets approved by management by applying the average growth rate of 2.0% (2021: 2.4%) in market rental, the long-term average growth rate of 2.0% (2021: 2.4%) in market rental and a discount rate of 13.66% (2021: 12.84%). Cash inflows/outflows have been determined based on management's expectations for the market development.

### 32. SHARE OPTION SCHEME

A share option scheme enables the Company to grant options to any participant (the "Eligible Participant") as incentives or rewards for their contributions to the Group. The Company conditionally adopted a share option scheme (the "Share Option Scheme") on 30 June 2014 whereby the Board are authorised, at their absolute discretion and subject to the terms of the Share Option Scheme, to grant options to subscribe for the shares of the Company to the Eligible Participant. The Share Option Scheme will be valid and effective for a period of ten years commencing from the date of adoption of the Share Option Scheme.

As at 31 March 2022, the total number of shares (the "Shares") of the Company available for issue under the Scheme is 3,000,000 Shares (as adjusted for the Share Consolidation on 18 November 2020), representing 10% of the issued Shares (the "Scheme Mandate Limit") of the aggregate number of Shares in issue immediately upon completion of the listing of the Shares on 18 July 2014 (as adjusted for the Share Consolidation on 18 November 2020) and representing 1.91% of the issued Shares as at 31 March 2022.

The Company may at any time refresh such limit, subject to the shareholders' approval and the issue of a circular in compliance with the GEM Listing Rules, provided that the total number of shares which may be issued upon exercise of all outstanding options granted and yet to be exercised under all the share option schemes of the Company does not exceed 30% of the Shares in issued at the time. An option may be exercised in accordance with the terms of the Scheme at any time during a period as the Board may determine which shall not exceed ten years from the date of grant subject to the provisions of early termination thereof.

#### Defined contribution plans

The Group operates a Mandatory Provident Fund Scheme (the "MPF Scheme") for all qualifying employees in Hong Kong. The assets of the schemes are held separately from those of the Group, in funds under the control of trustees. The only obligation of the Group with respect to the MPF Scheme is to make the required contribution under the MPF Scheme. The Group contributes 5% of relevant payroll costs, capped at HK\$1,500 per month, to the MPF Scheme, in which the contribution is matched by employees.

Subsidiaries operating in the PRC are required to participate in contribution retirement schemes organised by the relevant local government authorities.
