Dear Shareholders,

On behalf of the Board of Directors (the “**Board**”) of the Company, I am pleased to present the annual report of the Company for the year ended 31 March 2022.

### Review

As a well-established contractor in the car park flooring industry in Hong Kong and Macau, we provide (i) flooring services, which involve the application of proprietary floor coating products for the purpose of providing a colorful, slip-resistance, hard wearing surface that is resistant against water and petrochemicals; (ii) ancillary services, which include specialised texture painting and waterproofing works; and (iii) others - sales of car park flooring materials. Our target segment ranges from mid to high end projects in the relevant markets.

During the year ended 31 March 2022, the revenues from Hong Kong and Macau markets were approximately HK\$105.0 million (2021: approximately HK\$108.4 million) and approximately HK\$5.5 million (2021: approximately HK\$10.5 million), respectively. While the revenue from the Hong Kong market suffered slight decline, the decreasing revenue from Macau market was due to strict precautionary and control measures taken by the Macau Government since the outbreak of the Coronavirus Disease 2019 (“**COVID-19**”) in early 2020 which have caused severe drop in number of tourists and thereby adversely affecting its major revenue from gambling tourism. In light of the general economic setback in Macau, most of main contractors and property developers have been cautious and had either postponed or suspended construction or renovation projects.

In consideration of the competition in the car park flooring market and the general economic setback, especially in Macau, caused by the COVID-19 pandemic, the Directors expect our business environment would continue to be challenging in the coming years. The Group will continue to closely monitor the situation and development of the COVID-19 pandemic and take appropriate measures when necessary.

### Looking Forward

In order to continue to generate promising returns to the shareholders of the Company and to further diversify business risks, the Directors are taking an active approach to seek alternative business opportunities in order to broaden its source of income. Meanwhile, the Group shall continue to dedicate its effort to expanding its existing business in the car park flooring and waterproofing sectors to strengthen its income stream.

尊敬的股東：

本人謹代表本公司董事會（「**董事會**」），欣然呈呈本公司截至二零二二年三月三十一日止年度的年報。

### 回顧

作為一間於香港及澳門停車場地坪鋪設行業內根基穩固的承建商，我們提供：(i)地坪鋪設服務，涉及塗裝專利地坪鋪設塗層產品，以提供色彩豐富、防滑以及具防水及不易受石油化工產品破壞特性的耐磨表面；(ii)配套服務，包括專業紋理塗裝及防水工程；及(iii)其他服務—銷售停車場地坪鋪設材料。我們的目標業務分部為相關市場之中高端項目。

截至二零二二年三月三十一日止年度，來自香港及澳門市場的收益分別約為105,000,000港元（二零二一年：約108,400,000港元）及約5,500,000港元（二零二一年：約10,500,000港元）。雖然香港市場的收益僅輕微倒退，但澳門市場的收益一直減少，此乃由於自二零二零年初爆發2019冠狀病毒病（「**2019冠狀病毒病**」）疫情以來，澳門政府採取嚴厲疫情防控措施令旅客數目大幅下跌，對澳門的主要經濟收入來源—博彩旅遊業收益造成負面影響。鑑於澳門整體經濟環境倒退，大部分總承建商及物業發展商均較為謹慎，並押後或暫停了任何建設或裝修工程項目。

考慮到停車場地坪鋪設市場的激烈競爭以及2019冠狀病毒病疫情尤其對澳門所造成的整體經濟倒退，董事預計，未來我們的營商環境將繼續充滿挑戰。本集團將繼續密切監察2019冠狀病毒病疫情的情況及發展，並於必要時採取適當措施。

### 前景

為了繼續為本公司股東帶來可觀回報，以及進一步分散業務風險，董事主動尋找另類商機，務求拓寬收入來源。與此同時，本集團將繼續致力擴大其現有的停車場地坪鋪設及防水領域的業務，以鞏固其收入來源。

### EXECUTIVE DIRECTORS

**Mr. KWONG Chi Man (鄺志文)**, aged 67, is the chairman of the Group. Mr. Kwong is mainly responsible for the leadership and management of the Board and strategic planning of the Group. Mr. Kwong was appointed as an executive Director on 30 May 2016. He is a director of all subsidiaries of the Group.

Mr. Kwong has accumulated over 40 years of experience in the construction industry. Mr. Kwong entered into the construction industry as a sole proprietor with the business registration of Kwong Man Kee Engineering in 1982. Mr. Kwong started the car park flooring business in 2003 and in 2005 undertook projects from major property developers, architects, main contractors and government bodies. In 2008, Mr. Kwong became a shareholder and director of Kwong Man Kee Engineering Limited (“KMK”) and subsequently became the sole shareholder of KMK in 2013. Mr. Kwong has accumulated over 15 years of experience in the car park flooring industry. Mr. Kwong is a fellow member of The Hong Kong Institute of Directors.

**Mr. Yip Kong Lok (葉港樂)**, aged 46, is an executive Director and chief executive officer of the Group and is principally responsible for the business development, overall management and business operations of the Group. Mr. Yip first joined the Group in November 2003 on a part time basis to promote the Group’s business. In August 2015, Mr. Yip took up the position of manager of KMK on a full time basis. Mr. Yip has accumulated over 15 years of experience in the car park flooring industry. Mr. Yip was appointed as an executive Director on 3 August 2018. He is a director of all subsidiaries of the Group except Victor Ease Limited.

Mr. Yip graduated from The University of British Columbia in May 1997 with a bachelor’s degree in civil engineering with distinction and subsequently obtained a master’s degree in engineering from the same university in May 1998. Mr. Yip is an associate of The Hong Kong Institute of Directors.

**Mr. Yip Wai Man (葉偉文)**, aged 48, is an executive Director principally responsible for supervision and management of site works, quality control and work safety. Mr. Yip WM worked in his family business in trading before joining the Group in November 2005 as a technician. He left the Group in January 2006 to rejoin his family business but returned as the technician in June 2006. In 2010, Mr. Yip WM became a site foreman of the Group and has accumulated 15 years of experience working in the Group. Mr. Yip WM was appointed as an executive Director on 13 June 2016.

鄺先生於建築業累積逾40年經驗。鄺先生於一九八二年以獨資經營者身份投身建築業，並以鄺文記工程公司作商業登記。鄺先生於二零零三年開展停車場地坪鋪設業務，並於二零零五年承辦大型地產發展商、建築師、總承建商及政府機構的項目。於二零零八年，鄺先生成為鄺文記工程有限公司（「鄺文記」）的股東及董事，其後於二零一三年成為鄺文記唯一股東。鄺先生於停車場地坪鋪設行業累積逾15年經驗。鄺先生為香港董事學會資深會員。

葉港樂先生，46歲，為本集團執行董事兼行政總裁，主要負責本集團的業務發展、整體管理及業務營運。葉先生於二零零三年十一月以兼職形式首次加入本集團，以推廣本集團業務。於二零一五年八月，葉先生出任鄺文記的全職經理。葉先生於停車場地坪鋪設行業累積逾15年經驗。葉先生於二零一八年八月三日獲委任為執行董事，並為本集團全部附屬公司（凱怡有限公司除外）的董事。

葉先生於一九九七年五月畢業於英屬哥倫比亞大學，獲頒土木工程學士學位（成績優異），其後於一九九八年五月取得同一所大學的工程碩士學位。葉先生為香港董事學會附屬會員。

葉偉文先生，48歲，為執行董事，主要負責整體工地監督及管理、品質監控及職業安全。葉偉文先生於二零零五年十一月加入本集團任技術員之前，任職於其家族經營的貿易業務。彼於二零零六年一月離開本集團並重新任職於其家族業務，其後於二零零六年六月回歸本集團擔任技術員。於二零一零年，葉偉文先生擔任本集團的工地領班，並已累計為本集團工作15年。葉偉文先生於二零一六年六月十三日獲委任為執行董事。

Ms. Yu has accumulated experience in the civil and geotechnical engineering field when she was employed from 1998 to 2005 by Greg Wong & Associates Limited, a civil and structural engineering company in Hong Kong. In 2012, Ms. Yu commenced her legal career and she was admitted as a solicitor of the High Court of Hong Kong in April 2014.

Ms. Yu obtained a bachelor's degree in civil engineering from the University of British Columbia in May 1997 and a master's degree in engineering (civil) from Cornell University (USA) in May 1998. In November 2007, Ms. Yu further completed a master's degree in engineering (industrial engineering and logistics management) from the University of Hong Kong. In December 2010, Ms. Yu obtained her Juris Doctor degree and subsequently the Postgraduate Certificate in Laws (PCLL) in July 2011, both from the Chinese University of Hong Kong.

**Mr. Law Pui Cheung (羅沛昌)**, aged 66, was appointed as an independent non-executive Director on 24 September 2016. Mr. Law has accumulated over 35 years of experience in the accountancy profession. Mr. Law began his career with Ernst and Whinney, the predecessor firm of Ernst & Young, an international accounting firm in Hong Kong. Mr. Law joined Li, Tang, Chen & Co., a practising certified public accountant firm in Hong Kong in 1989 and retired as a partner in June 2016. Mr. Law had been a practising director of Yong Zheng CPA Limited and is now the founder and chief executive officer of Marvin Law & Co., a certified public accountant firm. He is also a member of the Disciplinary Panel of the Hong Kong Institute of Certified Public Accountants and a member of the Market Misconduct Tribunal of Securities and Futures Commission.

Mr. Choi has over 30 years of experience in financial management, financial control, auditing, treasury, taxation as well as various projects regarding mergers and acquisitions and initial public offerings. During the course of his professional career, he had the opportunity to hold various senior accounting and finance positions in company listed on the Main Board of the Stock Exchange, international corporation and other well-established companies in various industries.

Mr. Choi obtained his diploma in accounting at Hong Kong Shue Yan College (now known as Hong Kong Shue Yan University) in 1990 and obtained his master's degree in management majored in accounting at Dongbei University of Finance and Economics, People's Republic of China in 2010. He has been a member of the Hong Kong Institute of Certified Public Accountants and a fellow member of the Association of Chartered Certified Accountants since 1999 and 2003, respectively.

### 高級管理層

蔡偉雄先生，58歲，於二零一七年十二月加入本集團擔任財務總監及公司秘書。彼負責本集團的整體財務管理及公司秘書事宜。彼亦在本集團業務發展方面的策略及財務規劃以及融資事宜上向管理層提供支援。

蔡先生在財務管理、財務監控、審計、庫務、稅務及多項併購及首次公開招股項目中累積超過30年經驗。在彼之職業生涯中，彼曾於聯交所主板上市公司、國際性機構及其他在不同行業深具規模的公司擔任高級會計和財務職位。

蔡先生於一九九零年獲得香港樹仁學院（現稱香港樹仁大學）會計文憑，以及於二零一零年獲得中華人民共和國東北財經大學管理學碩士學位（會計學學科（專業））。彼自一九九九年為香港會計師公會會員以及自二零零三年起為英國特許公認會計師公會資深會員。

### BUSINESS AND FINANCIAL REVIEW

The Group is principally engaged in the car park flooring industry in Hong Kong and Macau. We provide (i) flooring services, which involve the application of proprietary floor coating products for the purpose of providing a colorful, slip-resistance, hard wearing surface that is resistant against water and petrochemicals; (ii) ancillary services, which include specialised texture painting and waterproofing works; and (iii) others - sales of car park flooring materials. Our target segment ranges from mid to high end projects in the relevant markets.

During the year ended 31 March 2022, the revenues from Hong Kong and Macau markets were approximately HK\$105.0 million (2021: approximately HK\$108.4 million) and approximately HK\$5.5 million (2021: approximately HK\$10.5 million), respectively. The decreasing revenue from Macau market was mainly due to the economic setback in Macau since the outbreak of COVID-19 in early 2020. A series of precautionary and control measures taken by the Macau Government caused a severe drop in the number of tourists as well as its major source of economic revenues from the gambling tourism. Facing the poor economic conditions in Macau, most of the main contractors and property developers as well as hotels and casinos postponed or suspended their construction or renovation projects.

For the year ended 31 March 2022, the Group recorded a total revenue of approximately HK\$110.4 million, or the decrease by 7.1% as compared with approximately HK\$118.9 million for the year ended 31 March 2021. As a result of the decrease of revenue and gross profit margin, the Group's net profit substantially decreased from approximately HK\$15.4 million for the year ended 31 March 2021 to approximately HK\$7.4 million for the year ended 31 March 2022.

In February 2022, the Group acquired a 40% equity interest in Carful Group Limited (the "CGL", formerly known as Hong Kong Carful Group Limited), which is one of the Seed Fund Teams under the HK Tech 300 Programme of City University of Hong Kong, at a cash consideration of HK\$5 million. CGL is principally engaged in the provision of car-sharing platforms in Hong Kong. The Group invested in CGL with the view to maintain a sustainable growth through business diversification and to take up social responsibility by helping young talents in building up their own businesses. For the year ended 31 March 2022, the Group shared the loss of CGL of approximately HK\$188,000.

### 業務及財務回顧

本集團在香港及澳門主要從事停車場地坪鋪設行業。我們提供：(i)地坪鋪設服務，涉及塗裝專利地坪鋪設塗層產品，以提供色彩豐富、防滑以及具防水及不易受石油化工產品破壞特性的耐磨表面；(ii)配套服務，包括專業紋理塗裝及防水工程；及(iii)其他服務—銷售停車場地坪鋪設材料。我們的目標業務分部為相關市場之中高端項目。

截至二零二二年三月三十一日止年度，來自香港及澳門市場的收益分別約為105,000,000港元（二零二一年：約108,400,000港元）及約5,500,000港元（二零二一年：約10,500,000港元）。澳門市場收益減少乃主要由於澳門經濟自二零二零年初爆發2019冠狀病毒病疫情以來持續受壓。澳門政府的一系列疫情防控措施令旅客數目及澳門的主要經濟收入來源—博彩旅遊業收益大幅下跌。面對惡劣經濟環境，澳門大部分總承建商、物業發展商、酒店及賭場均押後或暫停任何建設或裝修工程項目。

截至二零二二年三月三十一日止年度，本集團錄得總收益約110,400,000港元，較截至二零二一年三月三十一日止年度約118,900,000港元減少7.1%。由於收益及毛利率減少，本集團的純利由截至二零二一年三月三十一日止年度約15,400,000港元大幅減少至截至二零二二年三月三十一日止年度約7,400,000港元。

於二零二二年二月，本集團以現金代價5,000,000港元收購駕科集團有限公司（「駕科集團」，原名為香港租車（集團）有限公司）的40%股權。駕科集團為香港城市大學「HK Tech 300」計劃下其中一個種子基金團隊，其主要業務為在香港提供汽車共享平台。本集團投資於駕科集團，務求透過業務多元化策略來維持可持續增長，以及承擔提攜後進建立個人事業的社會責任。截至二零二二年三月三十一日止年度，本集團分佔駕科集團的虧損約188,000港元。



# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論及分析

### Revenue

The revenue, which is principally generated from the provision of car park flooring services for construction projects, decreased by 7.1% from approximately HK\$118.9 million for year ended 31 March 2021 to approximately HK\$110.4 million for year ended 31 March 2022. The drop in revenue was mainly due to the significant decrease in revenue derived from the Macau market for the year ended 31 March 2022.

### Gross profit and gross profit margin

The Group's gross profit decreased by 14.5% from approximately HK\$41.8 million for the year ended 31 March 2021 to approximately HK\$35.7 million for the year ended 31 March 2022. The gross profit margin of the Group decreased from 35.1% for the year ended 31 March 2021 to 32.4% for the same period ended 31 March 2022. The decrease in gross profit was mainly caused by (i) the decrease in revenue for year ended 31 March 2022; and (ii) fewer projects with higher profit margin as compared with the year ended 31 March 2021.

### Other income and other gains, net

Other income and other gains, net of the Group significantly decreased by approximately HK\$1.1 million from approximately HK\$1.5 million for the year ended 31 March 2021 to approximately HK\$418,000 for the year ended 31 March 2022. For the year ended 31 March 2021, it primarily consisted of the subsidies provided by the Government of Hong Kong Special Administrative Region under the Employment Support Scheme. There were no such subsidies received for the year ended 31 March 2022.

### Impairment loss on trade and retention receivables and contract assets

The impairment loss on trade and retention receivables and contract assets increased by approximately HK\$326,000 from approximately HK\$2.1 million for the year ended 31 March 2021 to approximately HK\$2.4 million for the same period ended 31 March 2022.

Impairment loss is calculated under expected credit loss model with reference to the expected credit loss rates, which were determined based on the Group's internal and historical credit loss data, the days past due and the probability of default of customers, and also taking into account the forward-looking information.

### 收益

收益主要源於為建築項目提供停車場地坪鋪設服務。收益由截至二零二一年三月三十一日止年度約118,900,000港元減少7.1%至截至二零二二年三月三十一日止年度約110,400,000港元。收益下跌主要是由於澳門市場於截至二零二二年三月三十一日止年度所產生的收益大幅減少。

### 毛利及毛利率

本集團的毛利由截至二零二一年三月三十一日止年度約41,800,000港元減少14.5%至截至二零二二年三月三十一日止年度約35,700,000港元。本集團的毛利率由截至二零二一年三月三十一日止年度的35.1%下跌至截至二零二二年三月三十一日止同期的32.4%。毛利減少主要是由於(i)截至二零二二年三月三十一日止年度之收益減少；及(ii)與截至二零二一年三月三十一日止年度相比，能產生較高毛利率之項目減少。

### 其他收入及其他收益淨額

本集團的其他收入及其他收益淨額由截至二零二一年三月三十一日止年度約1,500,000港元大幅減少1,100,000港元至截至二零二二年三月三十一日止年度約418,000港元。截至二零二一年三月三十一日止年度，此項目主要來自香港特別行政區政府於保就業計劃下發放的補貼。於截至二零二二年三月三十一日止年度並無收取同類補貼。

### 應收貿易賬款及應收保留金以及合約資產的減值虧損

應收貿易賬款及應收保留金以及合約資產的減值虧損由截至二零二一年三月三十一日止年度約2,100,000港元增加約326,000港元至截至二零二二年三月三十一日止年度約2,400,000港元。

減值虧損是根據預期信貸虧損模型及參照預期信貸虧損率計算，而預期信貸虧損率是根據本集團內部及過往信貸虧損記錄、逾期日數及客戶違約概率釐定，當中亦考慮前瞻性質料。

### General and administrative expenses

General and administrative expenses of the Group increased by approximately HK\$1.4 million from approximately HK\$22.7 million for the year ended 31 March 2021 to approximately HK\$24.1 million for the year ended 31 March 2022. The increase was mainly attributable to the increase in staff salary and the increase in number of senior and experienced staff. General and administrative expenses consist primarily of staff cost, depreciation, professional fees and other general administrative expenses.

### Share of loss of an associate

Share of loss of an associate relates to the Group's 40% equity interest in an associate, CGL, for the provision of car-sharing platforms in Hong Kong. The Group's share of loss of the associate for the year ended 31 March 2022 was approximately HK\$188,000 (2021: Nil).

### Income tax expense

Income tax expense for the Group was approximately HK\$2.8 million for the year ended 31 March 2021 as compared with income tax expense of approximately HK\$1.7 million for the year ended 31 March 2022. The decrease of income tax expense was mainly attributable to the decrease in profit before income tax from approximately HK\$18.2 million for the year ended 31 March 2021 to approximately HK\$9.2 million for the year ended 31 March 2022.

### Profit for the year

As a result of the foregoing, the profit of the Group decreased from approximately HK\$15.4 million for the year ended 31 March 2021 to approximately HK\$7.4 million for the year ended 31 March 2022.

### OUTLOOK

In light of increasing operating costs, keen competition in the carpark flooring market and the general economic setback, especially in Macau, caused by the COVID-19 pandemic which may all weaken our future financial performance, the Directors expect the business environment to remain challenging in the coming years.

In order to continue to generate promising returns to the shareholders of the Company and to further diversify business risks, the Directors are taking an active approach to seek alternative business opportunities to broaden its source of income. Meanwhile, the Group will also continue to focus on expanding its existing business in the car park flooring and waterproofing sectors to strengthen its income stream.

### 一般及行政開支

本集團的一般及行政開支由截至二零二一年三月三十一日止年度約22,700,000港元增加約1,400,000港元至截至二零二二年三月三十一日止年度約24,100,000港元。有關增加主要可歸因於員工薪金及高級和經驗老到的員工人數增加。一般及行政開支主要包括員工成本、折舊、專業費用及其他一般行政開支。

### 應佔聯營公司虧損

應佔聯營公司虧損涉及一間於香港提供汽車共享平台的聯營公司，其名為駕科集團，而本集團持有其40%股權。截至二零二二年三月三十一日止年度，本集團應佔聯營公司虧損約為188,000港元（二零二一年：無）。

### 所得稅開支

本集團於截至二零二一年三月三十一日止年度的所得稅開支約為2,800,000港元，而截至二零二二年三月三十一日止年度的所得稅開支約為1,700,000港元。所得稅開支減少，主要是由於除所得稅前溢利由截至二零二一年三月三十一日止年度約18,200,000港元減少至截至二零二二年三月三十一日止年度約9,200,000港元。

### 本年度溢利

由於上文所述，本集團溢利由截至二零二一年三月三十一日止年度約15,400,000港元減少至截至二零二二年三月三十一日止年度約7,400,000港元。

### 前景

鑑於經營成本上升、停車場地坪鋪設市場競爭激烈、2019冠狀病毒病疫情尤其對澳門所造成的整體經濟倒退等因素，均可能削弱我們的未來財務表現，董事預計，營商環境於未來將依然充滿挑戰。

為了繼續為本公司股東帶來可觀回報以及進一步分散業務風險，董事主動尋找另類商機，以拓寬其收入來源。與此同時，本集團亦將繼續專注擴大其現有的停車場地坪鋪設及防水領域的業務，以鞏固其收入來源。

# MANAGEMENT DISCUSSION AND ANALYSIS

## 管理層討論及分析

### LIQUIDITY AND FINANCIAL RESOURCES

The Group maintained a healthy financial position during the year ended 31 March 2022. As at 31 March 2022, the Group had cash and cash equivalents of approximately HK\$23.9 million (2021: approximately HK\$34.6 million). The Group's current ratio was approximately 2.2 times as at 31 March 2022 compared to approximately 3.2 times at 31 March 2021.

The total interest-bearing borrowings (including bank borrowings and lease liabilities) of the Group as at 31 March 2022 were approximately HK\$15.9 million (2021: approximately HK\$10.0 million). The borrowings were secured by the Group's certain assets with carrying amount of approximately HK\$36.5 million as at 31 March 2022 (2021: approximately HK\$32.9 million).

As at 31 March 2022, the Group had total assets of approximately HK\$149.8 million (2021: approximately HK\$129.9 million) which were financed by total liabilities and total equity of approximately HK\$48.0 million (2021: approximately HK\$29.5 million) and approximately HK\$101.8 million (2021: approximately HK\$100.4 million).

The Board considers that the Group has sufficient financial resources to meet its funding requirements at all times.

### GEARING RATIO

The gearing ratio of the Group as at 31 March 2022 was approximately 13.5% (2021: approximately 9.0%).

The gearing ratio is calculated based on the total interest-bearing borrowings divided by the total capital of approximately HK\$117.8 million as at 31 March 2022 (2021: approximately HK\$110.4 million). The total capital of the Group is calculated as total equity plus total borrowings.

### 流動資金及財務資源

本集團於截至二零二二年三月三十一日止年度的財務狀況維持穩健。於二零二二年三月三十一日，本集團擁有現金及現金等價物約23,900,000港元(二零二一年：約34,600,000港元)。本集團於二零二二年三月三十一日的流動比率約為2.2倍，而於二零二一年三月三十一日則約為3.2倍。

於二零二二年三月三十一日，本集團的計息借貸總額(包括銀行借貸及租賃負債)約為15,900,000港元(二零二一年：約10,000,000港元)。該等借貸以本集團於二零二二年三月三十一日賬面值約36,500,000港元(二零二一年：約32,900,000港元)之若干資產作抵押。

於二零二二年三月三十一日，本集團的總資產約為149,800,000港元(二零二一年：約129,900,000港元)，而總負債及總權益分別約為48,000,000港元(二零二一年：約29,500,000港元)及約101,800,000港元(二零二一年：約100,400,000港元)。

董事會認為，本集團擁有充裕財政資源，足以隨時滿足資金需求。

### 資本負債比率

本集團於二零二二年三月三十一日的資本負債比率約為13.5%(二零二一年：約9.0%)。

於二零二二年三月三十一日，資本負債比率乃根據計息借貸總額除以總資本約117,800,000港元(二零二一年：約110,400,000港元)計算。本集團的總資本按總權益加總借貸計算。

### CAPITAL STRUCTURE

There has been no change in the capital structure of the Group since its shares listed on GEM on 13 October 2016. The share capital of the Company only comprises of ordinary shares.

As at 31 March 2022, the Company's issued share capital was HK\$6,000,000 and the number of its issued ordinary shares was 600,000,000 of HK\$0.01 each.

### SIGNIFICANT INVESTMENTS, MATERIAL ACQUISITIONS AND DISPOSALS OF SUBSIDIARIES, ASSOCIATES AND JOINT VENTURES

Save as disclosed in this report, there was no significant investment held by the Group nor any material acquisition or disposal of subsidiary, associate and joint venture for the year ended 31 March 2022.

### FUTURE PLANS FOR MATERIAL INVESTMENTS OR CAPITAL ASSETS

As at the date of this report, the Board does not have any plan for material investments or additions of capital assets.

### RISK OF FOREIGN EXCHANGE FLUCTUATIONS

The Group operates in Hong Kong and Macau and majority of its business transactions are denominated in Hong Kong dollars and Macau Pataca, and hence, the Group does not have any material exposure to foreign exchange rate fluctuations for the year ended 31 March 2022. The Group has not entered into any financial instruments for hedging purposes.

### TREASURY POLICY

The Group adopted a prudent financial management approach towards its treasury policies and maintained a healthy liquidity position throughout the reporting year. To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and commitments can meet its funding requirements from time to time.

### 資本架構

自二零一六年十月十三日本集團股份於GEM上市以來，本集團的資本架構並無變動。本公司的股本僅包括普通股。

於二零二二年三月三十一日，本公司的已發行股本為6,000,000港元，而其已發行普通股數目為600,000,000股，每股面值0.01港元。

### 重大投資、重大收購及出售附屬公司、聯營公司和合營企業

除本報告所披露者外，於截至二零二二年三月三十一日止年度，本集團並無持有任何重大投資，亦無進行有關附屬公司、聯營公司和合營企業之任何重大收購或出售。

### 外匯波動風險

本集團在香港及澳門經營業務，其業務交易大部分以港元及澳門元計值，因此，本集團於截至二零二二年三月三十一日止年度並無承受任何重大匯率波動風險。本集團並無訂立任何金融工具作對沖之用。

### 庫務政策

本集團在庫務政策上採納審慎的財務管理方針，並於報告年度內一直維持穩健的流動資金狀況。為管理流動資金風險，董事會密切監察本集團的流動資金狀況，以確保本集團的資產、負債及承擔的流動資金結構能符合其不時的資金需求。

### EMPLOYEES AND REMUNERATION POLICIES

As at 31 March 2022, the Group had 45 employees in total (2021: 37 employees). The employee costs of the Group (including directors' emoluments and management, administrative and operational staff costs) for the year ended 31 March 2022 were approximately HK\$19.6 million (2021: approximately HK\$16.0 million).

The Group remunerates its employees based on their performance, working experience and with reference to the prevailing market conditions. On top of basic remuneration, discretionary bonus may be granted to senior management and staff members by reference to the Group's performance as well as individual's performance. Other staff benefits include medical benefits, mandatory provident fund and sponsorship of training courses. Share options may also be granted to eligible employees as incentives or rewards for their contribution to the Group.

### COMMITMENTS AND CONTINGENT LIABILITY

As at 31 March 2022 and 2021, the Group did not have any significant contingent liabilities. As at 31 March 2022, the Group's committed lease payments were recognised as lease liabilities of approximately HK\$845,000 (2021: approximately HK\$570,000).

### 僱員及薪酬政策

於二零二二年三月三十一日，本集團共有45名僱員（二零二一年：37名僱員）。本集團截至二零二二年三月三十一日止年度之員工成本（包括董事酬金以及管理層、行政及營運員工成本）約為19,600,000港元（二零二一年：約16,000,000港元）。

本集團根據員工的表現、工作經驗並參考當時的市況制定員工薪酬。除基本薪酬外，亦可能參考本集團業績表現以及員工個人表現，向高級管理人員及職員發放酌情花紅。其他員工福利包括醫療福利、強制性公積金及培訓課程資助。合資格員工亦可能獲發購股權，作為激勵或報答其為本集團作出貢獻。

### 承擔及或然負債

於二零二二年及二零二一年三月三十一日，本集團並無任何重大或然負債。於二零二二年三月三十一日，本集團的已承諾租賃付款已確認為租賃負債約845,000港元（二零二一年：約570,000港元）。

## INTRODUCTION

Pursuant to Rule 18.44(2) of the GEM Listing Rules, the Board is pleased to present the corporate governance report of the Company for the year ended 31 March 2022.

The Company has made continued efforts to incorporate the key elements of sound corporate governance in its management structures and internal control procedures. The Company is committed to maintaining a high standard of corporate governance, the principles of which serve to uphold a high standard of ethics, transparency, responsibility and integrity in all aspects of business, and to ensure that affairs are conducted in accordance with applicable laws and regulations.

The Board believes that good and effective corporate governance practices are keys to obtaining and maintaining the trust of the shareholders of the Company (the “Shareholders”) and other stakeholders, and essential for encouraging accountability and transparency so as to sustain the success of the Group and to create long-term value for the Shareholders.

## CORPORATE GOVERNANCE PRACTICE

The Board is responsible for performing the corporate governance duties set out in the Corporate Governance Code (the “CG Code”) as set out in Appendix 15 of the GEM Listing Rules, which includes developing and reviewing the Company’s policies and practices on corporate governance, training and continuous professional development of Directors, and reviewing the Company’s compliance with the code provision in the CG Code and disclosures in this report.

The Company has complied with the principles and applicable code provisions of the CG Code for the year ended 31 March 2022.

## 緒言

### DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted Rules 5.48 to 5.67 of the GEM Listing Rules as the code of conduct for securities transactions by the Directors in respect of the Shares (the "Code of Conduct"). Having made specific enquiries to all Directors, each of them has confirmed that he/she has fully complied with the required standard of dealings set out in the Code of Conduct during the year ended 31 March 2022.

### BOARD OF DIRECTORS

The Board assumes responsibility for leadership and control of the Company, and is collectively responsible for directing and supervising the Company's affairs. The Board meets regularly for considering, reviewing and/or approving matters relating to, among others, the financial and operating performance, as well as, the overall strategies and policies of the Company. Additional meetings are held when significant events or important issues are required to be discussed and resolved.

### Responsibilities of the Directors

The Directors' responsibilities include, *inter alia*:

- To attend regular Board meetings focusing on business strategy, operational issues and financial performance;
- To review annual budgets for the Group;
- To monitor the quality, timeliness, relevance and reliability of internal and external reporting;
- To consider and approve the consolidated financial statements in quarterly, interim and annual reports, announcements and press releases of quarterly, interim and annual results;
- To focus on matters affecting the Company's overall strategic policies, finances and interest of the Shareholders;
- To consider dividend policy and dividend amount; and
- To review and monitor the corporate governance policies and practices of the Group to ensure compliance with the legal and regulatory requirements.

The Company has taken out director and officer liability insurance to cover liabilities arising from legal action against the Directors.

### 董事的證券交易

### 董事的職責

The service agreements and/or letters of appointment of the Directors are subject to termination in accordance with their respective terms. They can be renewed in accordance with the articles of association of the Company (“**Articles**”) and the applicable GEM Listing Rules.

As required under the Articles, all Directors are subject to election by the Shareholders at the Company at the first general meeting after their appointment. At every annual general meeting of the Company at least one-third of the Directors for the time being shall retire from office by rotation, provided that every Director (including those appointed for a specific term) shall be subject to retirement by rotation at least once every three years. A retiring Director shall be eligible for re-election thereat.

A staff in the finance department was assigned to perform the internal audit functions as part of her job and she reports the audit's findings to the Audit Committee. She mainly reviews and tests the control of the Group's major operational, financial, compliance and risk management based on the Group's policies. She communicates the findings, control deficiencies and remedial actions with the management and Audit Committee for improvement of the Group's internal control system.

During the year ended 31 March 2022, the Group has reviewed components of the internal control system and accounting policies and practices including (i) stock take procedures; and (ii) sales and receivable cycle by selecting certain projects for review, and the internal audit staff reported that the Group consistently complied with relevant policies and procedures. Suggestions were made to the Audit Committee and the management has implemented certain follow-up measures based on the internal audit findings.

### DIRECTORS' AND AUDITORS' RESPONSIBILITIES FOR THE CONSOLIDATED FINANCIAL STATEMENTS

All Directors acknowledge their responsibilities to prepare the Group's consolidated financial statements for the year ended 31 March 2022 to give a true and fair view of the state of affairs of the Group and of the results and cash flows for that year. The Directors continue to adopt the going concern approach in preparing the consolidated financial statements and are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern.

The responsibilities of the external auditors about their financial reporting are set out in the independent auditor's report attached to the Company's consolidated financial statements for the year ended 31 March 2022 in this report.

### AUDITOR'S REMUNERATION

For the year ended 31 March 2022, the remuneration paid or payable to PricewaterhouseCoopers (as the auditor of the Company) and its affiliate companies in respect of audit and non-audit services were HK\$1,100,000 and HK\$71,000 respectively.

### DIVIDEND POLICY

The Group has established its dividend policy in compliance with code provision F.1.1 of the CG Code, which aims to provide a transparency of the mechanism used for determination of the dividend amount and payment as well as to notify Shareholders and other persons concerned of the dividend policy of the Group. It broadly specifies the external and internal factors, including financial parameters, that shall be considered while declaring dividend and the circumstances under which the Shareholders of the Group may or may not expect dividend and how the retained earnings shall be utilized.

The Board will review and monitor the implementation of the Group's dividend policy from time to time.

### COMPANY SECRETARY

Mr. Choi Wai Hung ("Mr. Choi"), an employee of the Company, was appointed by the Board as the secretary of the Company on 15 December 2017. The biographical details of Mr. Choi are set out under the section headed "Profile of Directors and Senior Management" in this report. Mr. Choi is principally responsible for supervision of the Group's financial reporting, financial planning, treasury, financial control and company secretarial matters.

Mr. Choi had confirmed that he had taken no less than 15 hours of relevant professional training in accordance with Rule 5.15 of the GEM Listing Rules during the year ended 31 March 2022.

## SHAREHOLDERS' RIGHT

### Convening of Extraordinary General Meeting on Requisition by Shareholders

Pursuant to Article 12.3 of the Articles, the Board may, whenever it thinks fit, convene an extraordinary general meeting ("EGM"). EGMs shall also be convened on the requisition of two or more Shareholders holding, at the date of deposit of the requisition, not less than one-tenth of the paid up capital of the Company having the right of voting at general meetings. Such requisition shall be made in writing to the Board or the company secretary of the Company for the purpose of requiring an EGM to be called by the Board for the transaction of any business specified in such requisition, and such meeting shall be held within 3 months after the deposit of such requisition. If, within 21 days of such deposit, the Board fails to proceed to convene such meeting within a further 21 days, the requisitionists themselves may convene a meeting in accordance with the Articles and all reasonable expenses incurred by the requisitionist(s) as a result of the failure of the Board shall be reimbursed to the requisitionist(s) by the Company.

### Right to put enquiries to the Board

For putting forward any enquiries to the Board, Shareholders may send their written enquiries or requests in respect of their rights to the Company's principal place of business in Hong Kong.

### Procedure for shareholders to put forward proposals at shareholders' meetings

There are no provisions allowing Shareholders to move new resolutions at the general meetings of the Company under the Companies Law (Revised) of Cayman Islands. However, pursuant to the Articles, Shareholders who wish to move a resolution may by means of requisition convene an EGM following the procedures set out above.

## RELATIONS WITH SHAREHOLDERS AND INVESTORS

The Group uses several formal channels to ensure fair disclosure and comprehensive and transparent reporting of its performance and activities.

The Company's annual, interim and quarterly reports and circulars are printed and sent to all Shareholders. Announcements, reports, circulars, publications and press releases of the Company are published on the Company's website at [www.kmk.com.hk](http://www.kmk.com.hk). The Company's website disseminates corporate information and other relevant financial and non-financial information electronically on a timely basis.

### PRINCIPAL ACTIVITIES

The Company is the investment holding company of the Group. The Group is principally engaged in car park flooring industry in Hong Kong and Macau. We provide (i) flooring services, which involve the application of proprietary floor coating products for the purpose of providing a colorful, slip-resistance, hard wearing surface that is resistant against water and petrochemicals; (ii) ancillary services, which include specialised texture painting and waterproofing works; and (iii) others - sales of car park flooring materials.

For further particulars of the subsidiaries of the Group, details of which are set out in Note 30(a) to the consolidated financial statements in this report.

### BUSINESS REVIEW

For the development, performance or position of the Group's business, details are set out in the section headed "Chairman's Statement" on pages 5 to 6 and the section headed "Management Discussion and Analysis" on pages 11 to 16 of this report.

For the principal financial risks and uncertainties facing the Company, details are set out in Note 3 to the consolidated financial statements in this report.

#### (A) Environmental policies and performance

The Board is aware that addressing environmental concerns is an important issue for contributing to the continuous development of society (along with the business activities of the Company).

The Group's operation is not subject to any environmental requirements in Hong Kong, except the Dangerous Goods Ordinance (Chapter 295 of the Laws of Hong Kong) (the "Dangerous Goods Ordinance"), and that some of the works conducted by the Group are subject to environmental compliance examination under The Hong Kong Green Building Council's "BEAM Plus" scheme. The Group has established effective environmental management system in conformity with the international standard requirements, for the provision of design, construction, installation and maintenance services to the customers.

#### (A) 環境政策及表現

董事會深明應對環境問題是促進社會持續發展（以及本公司業務活動）的重要議題。

除危險品條例（香港法例第295章）（「危險品條例」）外，本集團之經營不受香港任何環保規定所限，而本集團進行之部分工程須通過香港綠色建築議會「BEAM Plus」計劃之環境合規檢查。本集團已根據國際標準規定建立有效的環境管理體系，以為客戶提供設計、施工、安裝及保養服務。

An environmental policy and manual of procedures have been effective upon listing of the shares of the Company on GEM, which demonstrate the Group's commitment to environmental protection. All staff, subcontractors and suppliers are required to diligently implement the policy and the manual, which will be reviewed regularly in light of experience, feedback from staff, business development, current regulations and legislation.

**(B) Compliance with laws and regulations**

Apart from the licensing requirement under the Dangerous Goods Ordinance, the Group is not subject to any requirement to obtain any particular approval or permit for carrying out the car park flooring business in Hong Kong. The Dangerous Goods Ordinance controls the usage, storage, manufacturing and conveyance of the dangerous goods and sets out the relevant licensing requirements in relation to these activities.

The Group's operations are mainly carried out by its subsidiaries in Hong Kong and Macau with the Company itself incorporated in the Cayman Islands.

To the best knowledge and belief of the Directors, the Group's operations in Hong Kong and Macau have complied with the applicable laws and regulations in the above jurisdictions in all material respects during the year ended 31 March 2022, and up to the date of this report.

**(C) Key relationships with employees, customers, suppliers and subcontractors**

The Directors are of the view that the Company has maintained good relationship with its employees, customers, suppliers and subcontractors. During the year ended 31 March 2022, there was no material or significant dispute between the Group and its employees, customers, suppliers and subcontractors.

董事認為，本公司與僱員、客戶、供應商及分包商保持良好的關係。截至二零二二年三月三十一日止年度，本集團與僱員、客戶、供應商和分包商之間並無重大或重要糾紛。

For the year ended 31 March 2021, a final dividend of HK1 cent per share of the Company (the “Share(s)”) was declared to the shareholders of the Company.

The Board recommended the payment of a final dividend of HK0.5 cent per share for the year ended 31 March 2022, subject to the approval of the Shareholders of the forthcoming annual general meeting on 26 August 2022 (the “AGM”).

## ANNUAL GENERAL MEETING

The Company will hold the AGM on 26 August 2022. Notice of the AGM will be published and dispatched to the Shareholders in accordance with the articles of association of the Company and the GEM Listing Rules in due course.

## CLOSURE OF REGISTER OF MEMBERS

For determining the entitlement to attend and vote at the AGM, the register of members of the Company will be closed from 23 August 2022 to 26 August 2022, both dates inclusive, during which period no transfer of shares will be effected. The Company conditionally adopted a share option scheme (the “Share Option Scheme”) on 24 September 2016 (the “Adoption Date”). The terms of the Share Option Scheme are in accordance with the provisions of Chapter 23 of the GEM Listing Rules. The following is a summary of the principal terms and conditions of the Share Option Scheme.

### (i) Purpose of the Share Option Scheme

The purpose of the Share Option Scheme is to attract and retain the best available personnel, to provide additional incentive to employees (full-time and part-time), directors, consultants, advisers, distributors, contractors, suppliers, agents, customers, business partners and services providers of the Group and to promote the success of the business of the Group.

### (i) 購股權計劃的目的

購股權計劃的目的在於吸引及留住最優秀的人員、向本集團僱員（全職及兼職）、董事、諮詢人、顧問、分銷商、承建商、供應商、代理、客戶、業務夥伴及服務提供商提供額外獎勵以及推動本集團業務創出佳績。



**(ii) Who may join and basis of eligibility**

The Board may, at its absolute discretion and on such terms as it may think fit, grant any employee (full-time or part-time), director, consultant or adviser of the Group, or any substantial shareholder of the Group, or any distributor, contractor, supplier, agent, customer, business partner or service provider of the Group, options to subscribe at a price calculated in accordance with paragraph (iii) below for such number of Shares as it may determine in accordance with the terms of the Share Option Scheme. The basis of eligibility of any participant to the grant of any option shall be determined by the Board (or as the case may be, the INEDs) from time to time on the basis of his contribution or potential contribution to the development and growth of the Group.

**(iii) Price of Shares**

The subscription price of a Share in respect of any particular option granted under the Share Option Scheme shall be a price solely determined by the Board and notified to a participant and shall be at least the highest of: (i) the closing price of the Shares as stated in the Stock Exchange's daily quotations sheet on the date of grant of the option, which must be a business day; (ii) the average of the closing prices of the Shares as stated in the Stock Exchange's daily quotations sheets for the five business days immediately preceding the date of grant of the option; and (iii) the nominal value of a Share on the date of grant of the option.

**(iv) Grant of options and acceptance of offers**

An offer for the grant of options must be accepted within seven days inclusive of the day on which such offer was made. The amount payable by the grantee of an option to the Company on acceptance of the offer for the grant of an option is HK\$1.00.

**(v) Maximum number of Shares**

1. subject to sub-paragraphs (2) and (3) below, the maximum number of Shares issuable upon exercise of all options to be granted under the Share Option Scheme and any other share option schemes of the Company as from the Adoption Date (excluding, for this purpose, Shares issuable upon exercise of options which have been granted but which have lapsed in accordance with the terms of the Share Option Scheme or any other share option schemes of the Company) must not in aggregate exceed 10% of all the Shares in issue. Therefore, the Company may grant options in respect of up to 60,000,000 Shares (or such numbers of Shares as shall result from a sub-division or a consolidation of such 60,000,000 Shares from time to time) to the participants under the Share Option Scheme.

**(ii) 參與者資格及條件**

## 1 GENERAL INFORMATION

Kwong Man Kee Group Limited (the “Company”) was incorporated in the Cayman Islands on 30 May 2016 as an exempted company with limited liability under the Companies Law, Cap. 22 (Law 3 of 1961, as consolidated and revised) of the Cayman Islands. The address of its registered office is P.O. Box 309, Ugland House, Grand Cayman, KY1-1104, Cayman Islands and its principal place of business is 21/F, The Bedford, 91-93 Bedford Road, Kowloon, Hong Kong.

The Company is an investment holding company. The Company and its subsidiaries (together, the “Group”) are principally engaged in the provision of engineering services in flooring, screeding, anti-skid surfacing, specialised texture painting and waterproofing works. The controlling shareholder of the Company is Mr. Kwong Chi Man (“Mr. Kwong”) and the parent company of the Company is Sage City Investments Limited (“Sage City”).

The consolidated financial statements are presented in Hong Kong dollars (“HK\$”), unless otherwise stated.

The Company listed its shares on GEM of The Stock Exchange of Hong Kong Limited on 13 October 2016 (the “Listing”).

## 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of the consolidated financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

### 2.1 Basis of preparation

The consolidated financial statements of the Company have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (“HKFRSs”) issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”) and disclosure requirements of the Hong Kong Companies Ordinance (Cap. 622). The consolidated financial statements have been prepared under the historical cost convention, except for investment in an insurance contract which are carried at cash surrender value.

## 1 一般資料

本公司為投資控股公司。本公司及其附屬公司(統稱「本集團»)主要從事提供地坪鋪設、地台批盪、鋪設防滑、專業紋理塗裝及防水工程方面的工程服務。本公司的控股股東為鄭志文先生(「鄭先生»)而本公司的母公司為Sage City Investments Limited(「Sage City»)。

除文義另有所指者外，綜合財務報表乃以港元(「港元»)呈列。

本公司股份於二零一六年十月十三日在香港聯合交易所有限公司GEM上市(「上市»)。

## 2 重大會計政策概要

### 2.1 編製基準

#### 2.1 Basis of preparation (Continued)

(b) *New standards and amendments to existing standards and interpretations that are not yet effective and have not been early adopted by the Group (Continued)*

The Group will adopt the new and revised standards and interpretations when they become effective.

The Amendments to HKAS 12 require companies to recognise deferred tax on transactions that, on initial recognition, give rise to equal amounts of taxable and deductible temporary differences. They will typically apply to transactions such as leases of lessees and decommissioning obligations and will require the recognition of additional deferred tax assets and liabilities. As a result, deferred taxes arising from certain right-of-use assets and lease liabilities in the Group may be recognised. The Group is assessing and quantifying the impact at the moment.

Other than the aforementioned amendment, the new accounting standard and other amendments to existing standards, improvement, interpretation and accounting guideline are not expected to have a material impact on the Group in the current or future reporting periods and on foreseeable future transactions.

#### 2.1 編製基準(續)

(b) *尚未生效且尚未由本集團提前採納之新準則及現有準則之修訂和詮釋(續)*

本集團將於新增及經修訂之準則和詮釋生效後採納有關準則和詮釋。

香港會計準則第12號的修訂要求公司對在初步確認時產生等值的應課稅與可扣減暫時差異的交易確認遞延稅項。該等修訂一般適用於承租人租賃及停用責任等交易，並且需要確認額外的遞延稅項資產及負債。因此，本集團可能確認其若干使用權資產及租賃負債所產生之遞延稅項。本集團目前正評估及衡量有關影響。

除上述修訂外，新增之會計準則及對現有之準則、改進、詮釋和會計指引所作其他修訂預期概不會於本報告期或未來報告期間對本集團產生重大影響，亦不會對可見將來的交易產生重大影響。

2.2 Subsidiaries

*Consolidation*

Subsidiaries are all entities (including a structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. Subsidiaries are consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

Intra-group transactions, balances, income and expenses on transactions between Group companies are eliminated. Profits and losses resulting from inter-company transactions that are recognised in assets are also eliminated. Accounting policies of subsidiaries have been changed where necessary to ensure consistency with the policies adopted by the Group.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated statement of financial position, consolidated statement of comprehensive income and consolidated statement of changes in equity, respectively.

The Group treats transactions with non-controlling interests that do not result in a loss of control as transactions with equity owners of the Group. A change in ownership interest results in an adjustment between the carrying amounts of the controlling and non-controlling interests to reflect their relative interests in the subsidiary. Any difference between the amount of the adjustment to non-controlling interests and any consideration paid or received is recognised in a separate reserve within equity attributable to owners of the Company.

2.2 附屬公司

*綜合賬目*

附屬公司為本集團對其具有控制權的實體(包括結構性實體)。當本集團承受或享有參與實體所得之可變回報，且有能力透過其對實體之權力影響該等回報時，則本集團控制該實體。附屬公司的賬目自控制權轉讓予本集團之日起綜合入賬，並自該控制權終止之日起停止綜合入賬。

本集團內公司之間的交易、結餘、收入及費用會予以對銷。來自集團內公司間交易的溢利及虧損(確認於資產)亦予以對銷。附屬公司的財務報表已按需要作出調整，以確保其會計政策與本集團採用的會計政策一致。

附屬公司業績及權益中的非控股權益分別於綜合財務報表、綜合全面收益表及綜合權益變動表中單獨呈列。

本集團把不會引致失去控制權的非控股權益交易視為與本集團權益持有人進行的交易。所有權權益變動導致控股股東權益與非控股權益賬面值之間的調整以反映彼等於附屬公司的相對權益。非控股權益調整數額與任何已付或已收代價之間的任何差額於本公司擁有人應佔權益中的獨立儲備內確認。

2.3 Investment in an associate

Associates are all entities over which the Group has significant influence but not control or joint control. This is generally the case where the Group holds between 20% and 50% of the voting rights. Investment in an associate is accounted for using the equity method of accounting, after initially being recognised at cost.

Under the equity method of accounting, the investment is initially recognised at cost and adjusted thereafter to recognise the Group's share of the post-acquisition profits or losses of the investee in profit or loss, and the Group's share of movements in other comprehensive income of the investee in other comprehensive income. Dividends received or receivable from the associate are recognised as a reduction in the carrying amount of the investment.

Where the Group's share of losses in an equity-accounted investment equals or exceeds its interest in the entity, including any other unsecured long-term receivables, the Group does not recognise further losses, unless it has incurred obligations or made payments on behalf of the other entity.

Unrealised gains on transactions between the Group and its associate are eliminated to the extent of the Group's interest in the associate. Unrealised losses are also eliminated unless the transaction provides evidence of an impairment of the asset transferred. Accounting policies of equity-accounted investee have been changed where necessary to ensure consistency with the policies adopted by the Group.

The carrying amount of equity-accounted investment is tested for impairment in accordance with the policy described in Note 2.9.

2.3 於聯營公司之投資

聯營公司指本集團對其有重大影響但無控制權或共同控制權的實體，一般情況下本集團擁有其20%至50%投票權。於聯營公司之投資初步按成本確認後，以權益會計法入賬。

根據權益會計法，投資初步按成本確認後再作調整，以於損益中確認本集團應佔投資對象的收購後溢利或虧損，以及於其他全面收益中確認本集團應佔投資對象的其他全面收益變動。已收或應收聯營公司的股息乃確認為投資賬面值扣減。

倘本集團於以權益入賬之投資中應佔的虧損相等於或超過其於該實體的權益(包括任何其他無抵押長期應收款項)，則本集團不會確認進一步虧損，除非其已代另一實體承擔責任或作出付款。

本集團與其聯營公司之間的交易所產生的未變現收益按本集團於該等聯營公司的權益金額抵銷。除非有關交易能證明所轉移資產出現減值，否則未變現虧損亦予以抵銷。以權益入賬之投資對象的會計政策已作出必要變更，以確保與本集團所採納之政策一致。

權益入賬投資的賬面值乃根據附註2.9所述政策進行減值測試。

**2.4 Separate financial statements**

Investments in subsidiaries are accounted for at cost less impairment. Cost includes direct attributable costs of investment. The results of subsidiaries are accounted for by the Company on the basis of dividend received and receivable.

Impairment testing of the investments in subsidiaries is required upon receiving a dividend from these investments if the dividend exceeds the total comprehensive income of the subsidiary in the period the dividend is declared or if the carrying amount of the investment in the separate financial statements exceeds the carrying amount in the consolidated financial statements of the investee's net assets including goodwill.

**2.5 Foreign currency translation**

*(a) Functional and presentation currency*

Items included in the consolidated financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional currency and the Group's presentation currency.

*(b) Transactions and balances*

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions or valuation where items are re-measured. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the statement of comprehensive income.

**2.4 獨立財務報表**

於附屬公司的投資按成本扣除減值列賬。成本包括直接應佔投資成本。附屬公司的業績乃由本公司按已收及應收股息基準入賬。

倘股息超出於宣派股息期間內附屬公司的全面收益總額，或倘獨立財務報表中投資賬面值超出投資對象於綜合財務報表所示資產淨值(包括商譽)的賬面值，則須於自該等投資收取股息時，對該等投資進行減值測試。

**2.5 外幣換算**

*(a) 功能及呈列貨幣*

本集團每個實體的綜合財務報表中所列的項目均以該實體營運所在的主要經濟環境的貨幣計量(「功能貨幣」)。綜合財務報表以港元呈列，港元為本公司的功能貨幣及本集團的呈列貨幣。

*(b) 交易及結餘*

外幣交易均按交易或估值(倘項目予以重新計量)日期的現行匯率換算為功能貨幣。因結算外幣交易及按結算日的匯率兌換以外幣計值的貨幣資產及負債而產生的匯兌損益，均於全面收益表確認。

2.5 Foreign currency translation (Continued)

(c) Group companies

The results and financial position of all the Group entities (none of which has the currency of a hyperinflationary economy) that have a functional currency different from the presentation currency are translated into the presentation currency as follows:

- (i) assets and liabilities for each statement of financial position presented are translated at the closing rate at the date of that statement of financial position;
- (ii) income and expenses for each income statement are translated at average exchange rates (unless this average is not a reasonable approximation of the cumulative effect of the rates prevailing on the transaction dates, in which case income and expenses are translated at the rate on the dates of the transactions); and
- (iii) all resulting exchange differences are recognised in other comprehensive income.

On consolidation, exchange differences arising from the translation of any net investment in foreign entities are recognised in other comprehensive income. When a foreign operation is sold or any borrowings forming part of the net investment are repaid, the associated exchange differences are reclassified to profit or loss, as part of the gain or loss on sale.

2.6 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision-maker. The chief operating decision-maker, who is responsible for allocating resources and assessing performance of the operating segments, has been identified as the directors of the Group who make strategic decisions.

2.5 外幣換算(續)

(c) 集團公司

功能貨幣與呈列貨幣不同的所有本集團實體(各實體均無極高通脹經濟地區的貨幣)的業績及財務狀況乃按以下方法換算為呈列貨幣:

- (i) 每份財務狀況表所呈列的資產及負債按該財務狀況表日的收市匯率換算;
- (ii) 每份收益表的收入及支出項目按平均匯率換算(除非該平均匯率對交易日現行匯率的累計影響並非是一個合理的接近匯率,在此情況下收入及支出乃用交易日的匯率換算);及
- (iii) 所導致的一切匯兌差額乃於其他全面收益確認。

於綜合時,換算外國實體的任何淨投資所產生的匯兌差額於其他全面收益中確認。當外國業務被出售或構成淨投資一部分的任何借款獲償還時,相關的匯兌差額將重新分類到損益,作為出售收益或虧損的一部分。

2.6 分部報告

經營分部的呈報方式與提供予主要經營決策者的內部報告的方式一致。主要經營決策者(負責分配資源及評估經營分部的表現)已被識別為本集團作出策略決定的董事。

2.7 Investment in an insurance contract

The Group invests in a key management life insurance contract. The insurance contract is initially recognised at the amount of premium paid, and subsequently measured at its cash surrender value. Changes to the cash surrender value are recognised in profit or loss and presented net within “other income and other gains, net”. In the event of death of the insured person, the surrender of the policy, or the policy matures, the investment will be derecognised and any resulting gains or losses will be recognised in profit or loss.

2.8 Property, plant and equipment

The property, plant and equipment is stated at historical cost less accumulated depreciation. Historical cost includes expenditure that is directly attributable to the acquisition of the items.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance costs are charged in the consolidated statement of comprehensive income during the financial period in which they are incurred.

Depreciation on property, plant and equipment is calculated using the straight-line method to allocate their cost over their estimated useful lives, as follows:

Buildings	30 years
Leasehold improvements	Shorter of remaining period of the lease or 3 years
Furniture and equipment	3 years
Motor vehicles	3 years

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 2.9).

Gains and losses on disposals are determined by comparing proceeds with carrying amount and are recognised in the consolidated statement of comprehensive income.

2.7 於保險合約之投資

本集團投資於一份主要管理層人壽保險合約。該保險合約初步按已付保費金額確認，其後按合約的現金退保價值計量。現金退保價值的變化於損益中確認，並於「其他收入及其他收益淨額」中呈列。倘受保人離世、保單退保或保單到期，投資將被取消確認，而任何由此產生的收益或虧損將於損益中確認。

2.8 物業、廠房及設備

物業、廠房及設備按歷史成本扣除累計折舊入賬。歷史成本包括於購置有關項目時直接應佔的開支。

後續成本只有在與該項目有關聯的未來經濟利益很可能會流入本集團，而項目的成本能可靠計量時，才計入資產的賬面值或確認為一項單獨資產（視適用情況而定）。所有其他維修保養費用在其產生的財政期間內於綜合全面收益表扣除。

物業、廠房及設備的折舊乃採用直線法按其估計可使用年期分攤其成本值而計算，情況如下：

資產的剩餘價值及可使用年期於各報告期間末均會進行檢討，並在適當情況下作出調整。

倘資產賬面值高於其估計可收回金額（附註2.9），則會立即將該資產的賬面值撇減至其可收回金額。

出售時產生的收益及虧損乃透過比較所得款項與賬面值而釐定，並於綜合全面收益表內確認。

2.9 Impairment of non-financial assets

Assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units). Non-financial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at each reporting date.

2.10 Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is determined using the first-in, first-out (FIFO) method. The cost comprises costs of purchase and other costs incurred in bringing the inventories to the construction sites to be consumed in the provision of construction services.

2.11 Financial assets

(a) Classification

The classification depends on the Group's business model for managing the financial assets and the contractual terms of the cash flows. Financial assets at amortised cost are those that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest. The Group's financial assets at amortised cost comprise of trade and retention receivables, other receivables and cash and cash equivalents.

2.9 非金融資產減值

資產會於有事件或情況變化顯示資產賬面值可能無法收回時進行減值測試。減值虧損按資產賬面金額超過其可收回金額部分確認。可收回金額為扣除銷售成本後的資產公平值與資產使用價值中的較高者。就減值評估而言，資產按基本上獨立於其他資產或資產組別之現金流入的可單獨辨認的最小現金流入產生單位(現金產生單位)予以分類。經減值的非金融資產(不包括商譽)於各報告日期檢討撥回減值的可能性。

2.10 存貨

存貨按成本與可變現淨值兩者的較低者列賬。成本乃按先入先出法釐定。成本包括購買成本以及將存貨帶往建築地盤以用作提供建築服務所產生的其他成本。

2.11 金融資產

(a) 分類

分類取決於本集團管理金融資產的業務模式及現金流量的合約條款。按攤銷成本列賬的金融資產為持有作收取合約現金流量且其現金流量僅代表本金及利息付款。本集團按攤銷成本列賬的金融資產包括應收貿易賬款及應收保留金、其他應收款項以及現金及現金等價物。

2.11 Financial assets (Continued)

(b) Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

(c) Measurement

At initial recognition, the Group measures a financial asset at its fair value plus, in the case of a financial asset not at fair value through profit or loss, transaction costs that are directly attributable to the acquisition of the financial asset.

Subsequent measurement of debt instruments depends on the Group's business model for managing the asset and the cash flow characteristics of the asset. For financial assets at amortised cost, interest income from these financial assets is included in finance income using the effective interest method. Any gain or loss arising on derecognition is recognised directly in profit or loss and presented in other gains/(losses) together with foreign exchange gains and losses. Impairment losses are presented as separate line item in the consolidated statement of comprehensive income.

(d) Impairment

The Group assesses on a forward-looking basis the expected credit losses associated with its debt instruments carried at amortised cost. The impairment methodology applied depends on whether there has been significant increase in credit risk.

For trade and retention receivables and contract assets, the Group applied the simplified approach permitted under HKFRS 9, which requires expected lifetime losses to be recognised from initial recognition of the receivables.

2.11 金融資產(續)

(b) 確認及取消確認

常規的金融資產買賣乃於交易日期予以確認，交易日期指本集團承諾買賣該資產的日期。當自金融資產收取現金流量的權利已屆滿或已轉讓且本集團已轉移擁有權的絕大部分風險及回報時，金融資產乃予以取消確認。

(c) 計量

於初步確認時，本集團按金融資產的公平值加上(如屬並非以公平值計入損益的金融資產)於收購金融資產時直接應佔的交易成本來計量金融資產。

債務工具的后續計量取決於本集團管理資產的業務模式及資產的現金流量特徵。就按攤銷成本計量之金融資產而言，該等金融資產之利息收入採用實際利率法計入財務收入。取消確認時產生的收益或虧損於損益中直接確認，並連同匯兌損益於其他收益/(虧損)內呈列。減值虧損於綜合全面收益表呈列為單獨項目。

(d) 減值

本集團按前瞻性基準評估其以攤銷成本列賬的債務工具的相關預期信貸虧損。所應用的減值方法取決於信貸風險是否顯著增加。

就應收貿易賬款及應收保留金以及合約資產而言，本集團採用香港財務報告準則第9號所允許的簡化方法，該方法規定預期使用年期虧損須自初步確認該等應收款項起確認。

2.12 Trade, retention and other receivables

Trade, retention and other receivables are amounts due from customers for services performed in the ordinary course of business. Trade receivables are recognised initially at the amount of consideration that is unconditional. The Group holds the trade receivables with the objective of collecting the contractual cash flows and therefore measures them subsequently at amortised cost using the effective interest method.

The carrying amount of the asset is reduced through the use of an allowance account, and the amount of the loss is recognised in the impairment loss on trade and retention receivables in the consolidated statement of comprehensive income. When a trade, retention and other receivable is uncollectible, it is written off against the allowance account for trade, retention and other receivables. Subsequent recoveries of amounts previously written off are credited against the impairment loss on trade and retention receivables in the consolidated statement of comprehensive income.

If collection of trade, retention and other receivables is expected in one year or less (or in the normal operating cycle of the business if longer), they are classified as current assets. If no, they are presented as non-current assets.

2.13 Cash and cash equivalents

Cash and cash equivalents include cash in hand and deposits held at call with banks with original maturities of three months or less.

2.14 Share capital

Ordinary shares are classified as equity.

Incremental costs directly attributable to the issue of new share or options are shown in equity as a deduction, net of tax, from the proceeds.

2.12 應收貿易賬款、應收保留金及其他應收款項

應收貿易賬款、應收保留金及其他應收款項為於日常業務過程中執行服務而應收客戶之款項。應收貿易賬款初步按代價的無條件金額確認。本集團以收取合約現金流量為目的持有應收貿易賬款，故其後採用實際利率法按攤銷成本計量該等應收貿易賬款。

資產之賬面值乃透過使用撥備賬戶進行抵減，而虧損金額於綜合全面收益表內的應收貿易賬款及應收保留金之減值虧損中確認。倘應收貿易賬款、應收保留金及其他應收款項不可收回，則以應收貿易賬款、應收保留金及其他應收款項的撥備賬戶撇銷。其後收回之先前已撇銷金額，則計入綜合全面收益表的應收貿易賬款及應收保留金之減值虧損內。

倘應收貿易賬款、應收保留金及其他應收款項預期於一年或以內(或倘業務正常經營週期較長，則於正常經營週期內)收回，則分類為流動資產；否則分類為非流動資產。

2.13 現金及現金等價物

現金及現金等價物包括手頭現金及原到期日為三個月或更短時間以內的銀行通知存款。

2.14 股本

普通股分類為權益。

發行新股份或購股權應佔的遞增成本乃於權益中呈列為所得款項的扣減(扣除稅項)。

2.15 Trade and other payables

Trade payables are obligations to pay for goods or services that have been acquired in the ordinary course of business from suppliers and sub-contractors. Trade payables are classified as current liabilities if payment is due within one year or less (or in the normal operating cycle of the business if longer). If not, they are presented as non-current liabilities.

Trade and other payables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method.

2.16 Borrowings

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently carried at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in the consolidated statement of comprehensive income over the period of the borrowings using the effective interest method.

Fees paid on the establishment of loan facilities are recognised as transaction costs of the loan to the extent that it is probable that some or all of the facility will be drawn down. In this case, the fee is deferred until the drawdown occurs. To the extent there is no evidence that it is probable that some or all of the facility will be drawn down, the fee is capitalised as a pre-payment for liquidity services and amortised over the period of the facility to which it relates.

Borrowings are removed from the consolidated statement of financial position when the obligation specified in the contract is discharged, cancelled or expired. The difference between the carrying amount of a financial liability that has been extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognised in profit or loss as finance costs.

Borrowings are classified as current liabilities unless the Group has an unconditional right to defer settlement of the liability for at least 12 months after the end of the reporting period.

2.15 應付貿易賬款及其他應付款項

應付貿易賬款為於日常業務過程中向供應商購買商品或服務而應支付的債務。倘款項於一年或以內(或倘業務正常經營週期較長,則於正常經營週期內)到期應付,則應付貿易賬款分類為流動負債;否則呈列為非流動負債。

應付貿易賬款及其他應付款項初步按公平值確認,其後以實際利率法按攤銷成本計量。

2.16 借貸

借貸初步以公平值(扣除所產生交易成本)確認。借貸其後以攤銷成本列賬;所得款項(扣除交易成本)與贖回價值之間的差額,乃以實際利息法於借貸期間在綜合全面收益表確認。

在有關融資將很有可能部分或全部提取的情況,就設立貸款融資支付的費用乃確認為貸款交易成本。在此情況,該費用將遞延至提取貸款發生時。在並無憑證顯示有關融資將很有可能部分或全部提取的情況,該費用將被資本化以作為流動資金服務的預付款項,並於其相關融資期間內予以攤銷。

倘合約所規定的責任獲解除、取消或屆滿,則借貸自綜合財務狀況表移除。償清或轉讓予另一方的金融負債的賬面值與已付代價(包括任何已轉讓的非現金資產或已承擔的負債)之間的差額於損益內確認為財務成本。

除非本集團有權無條件將負債延長至報告期末後最少12個月後清償,否則借貸歸類為流動負債。

2.17 Current and deferred income tax

The income tax expense for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses. Current and deferred tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or directly in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

(a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of reporting period in the countries where the Company and its subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation and establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

(b) Deferred income tax

Deferred income tax is recognised, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements. However, deferred income tax is not recognised if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the reporting date and are expected to apply when the related deferred tax asset is realised or the deferred tax liability is settled.

2.17 即期及遞延所得稅

本期間之所得稅開支為根據各司法權區適用所得稅稅率計算的本期間應課稅收入之應付稅項，並根據暫時性差異及未動用稅項虧損所導致的遞延稅項資產及負債變動進行調整。即期及遞延稅項乃於損益中確認，惟倘該等稅項與於其他全面收益或直接於權益內確認的項目有關則除外。在此情況下，該等稅項亦分別於其他全面收益內或直接於權益內確認。

(a) 即期所得稅

即期所得稅開支乃根據本公司及其附屬公司經營及產生應課稅收入的國家於報告期末已頒佈或實質上已頒佈的稅務法例計算。管理層就適用稅務法例解釋所規限的情況定期評估報稅表的狀況，並在適用情況下根據預期須向稅務機關支付的稅款作出撥備。

(b) 遞延所得稅

遞延所得稅採用負債法就資產及負債的稅基與其在財務報表中的賬面值之間的暫時差額予以確認。然而，若遞延所得稅來自於交易(不包括業務合併)中對資產或負債的初步確認，而在交易時不影響會計損益或應課稅損益，則不予確認。遞延所得稅採用在報告日期前已頒佈或實質上已頒佈，並在有關遞延稅項資產變現或遞延稅項負債結算時預期將會適用的稅率(及法例)而釐定。

(b) *Deferred income tax (Continued)*

Deferred tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

Deferred tax liabilities are provided on taxable temporary differences arising from investments in subsidiaries, except for deferred tax liability where the timing of the reversal of the temporary difference is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future.

Deferred tax assets are recognised on deductible temporary differences arising from investments in subsidiaries only to the extent that it is probable the temporary difference will reverse in the future and there is sufficient taxable profit available against which the temporary difference can be utilised.

(c) *Offsetting*

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities and when the deferred tax assets and liabilities relate to income taxes levied by the same taxation authority on either the taxable entity or different taxable entities where there is an intention to settle the balances on a net basis.

(b) *遞延所得稅(續)*

遞延稅項資產於未來應課稅溢利將有可能與可動用的暫時差異抵銷時方予確認。

遞延稅項負債乃就於附屬公司之投資所產生的應課稅暫時差異計提撥備，但此不包括本集團可以控制該暫時差異的撥回時間，且該暫時差異在可預見將來很可能不會撥回的遞延稅項負債。

遞延稅項資產乃就於附屬公司之投資所產生的可扣減暫時差異進行確認，但只限於該暫時差異很可能在將來撥回，並有充足的應課稅溢利抵銷可用的暫時差異。

(c) *抵銷*

當有法定可執行權力將即期稅項資產與即期稅務負債抵銷，且遞延稅項資產及負債涉及由同一稅務機關對該應課稅實體或不同的應課稅實體但有意以淨額基準結算所得稅結餘時，則可將遞延稅項資產與負債互相抵銷。

2.18 Provisions

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events; it is probable that an outflow of resources will be required to settle the obligation; and the amount has been reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole.

A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

2.19 Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable and represents amounts receivable for services rendered in the normal course of business.

(a) Construction contracts

Revenue from the construction services is recognised over time as the Group's performance creates or enhances an asset or work in progress that the customer controls as the asset is created or enhanced.

The Group has applied the input method in recognising the revenue from construction contracts by reference to the Group's efforts or inputs to the satisfaction on a performance obligation relative to the total expected inputs to the satisfaction of the performance obligation. Accordingly, the Group uses the "percentage-of-completion method" to determine the appropriate amount of revenue to recognise in a given period. The stage of completion is measured by reference to costs incurred to date as a percentage of total contract costs.

2.18 撥備

當本集團因過往發生的事件而須承擔現有的法律或推定責任；可能需要使用資源以履行該責任；且有關金額能可靠估計時，則會確認撥備。其概不就未來營運虧損確認撥備。

倘出現多項類似責任，則需透過資源外流以履行責任的可能性乃於考慮整體責任類別後釐定。

即使就同一類別的責任中的任何一個項目而流出資源的可能性不大，仍會確認撥備。

撥備按履行責任預期所需支出的現值，並使用能反映當前對金錢時間價值及該責任特有風險的市場評估的稅前貼現率計算。因時間流逝而增加的撥備確認為利息開支。

2.19 收益確認

收益按已收或應收代價的公平值計量，是指在正常業務過程中提供服務的應收金額。

(a) 建築合約

建築服務收益會在一段時間內隨著本集團透過履約而創建或提升客戶在資產創建或提升時所控制的資產或在建工程。

本集團已採用投入法，參考本集團就完成履約責任的付出或投入與完成履約責任預期總投入的對比來確認建築合約的收益。因此，本集團使用「完成百分比法」釐定在特定時期需確認的合適收益金額。完成階段乃參照迄今產生的成本佔合約總成本之百分比而計量。

(a) Construction contracts (Continued)

The Group considers the input method better depicts the Group's performance in transferring control of goods or services to their customers.

When the outcome of a construction contract cannot be estimated reliably, contract revenue is recognised only to the extent of contract costs incurred that are likely to be recoverable.

Variations in contract work, claims and incentive payments are included in contract revenue to the extent that may have been agreed with the customer and are capable of being reliably measured.

Estimates of revenues, costs or extent of progress toward completion are revised if circumstances change. Any resulting increases or decreases in estimated revenues or costs are reflected in profit or loss in the period in which the circumstances that give rise to the revision become known by management.

The customer pays the fixed amount based on a payment schedule. If the services rendered by the Group exceed the payment, a contract asset is recognised. If the payments exceed the services rendered, a contract liability is recognised.

All construction contracts by the Group are warranted to be free of defects for a period of one year. Expected cost for warranty repairs are accrued when necessary.

No element of financing is deemed present as payments are in accordance with the typical payment terms of the relevant industry.

(a) 建築合約(續)

本集團認為投入法能更有效描述本集團將商品或服務的控制權轉移予其客戶的表現。

若建築合約結果不能可靠估計，合約收益只按有可能收回的已產生合約成本確認。

合約工程變更、索償及獎勵款項亦計入合約收益，惟以與客戶協定及能夠可靠計量者為限。

如果情況發生變化，則會對收益、成本或完成進度的估計予以修訂。任何由此產生的估計收益或成本增加或減少均在管理層知悉引起修改的情況之期間內在損益列賬。

客戶根據付款時間表支付固定金額。倘本集團提供的服務超過付款額，則確認合約資產。倘付款超過所提供的服務，則確認為合約負債。

本集團所訂約承建之所有建築項目均獲保養一年。預期保修成本於必要時產生。

由於付款符合相關行業的典型付款條件，因此不視為存在融資因素。

2.19 Revenue recognition (Continued)

(b) Sales of goods

Revenue from the sale of goods is recognised when the control of the products has transferred, being when the products are delivered to the customer, the customer has full discretion over the channel and price to sell the products, and there is no unfulfilled obligation that could affect the customer's acceptance of the products.

A receivable is recognised when the goods are delivered as this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due. Contract liabilities are recognised when payments are received from customers in advance but the relevant performance obligation has not been performed.

2.20 Interest income

Interest income is presented as finance income where it is earned from financial assets that are held for cash management purposes. Any other interest income is included in other income.

Interest income is calculated by applying the effective interest rate to the gross carrying amount of a financial asset except for financial assets that subsequently become credit-impaired. For credit impaired financial assets, the effective interest rate is applied to the net carrying amount of the financial asset (after deduction of the loss allowance).

2.21 Employee benefits

(a) Employee leave entitlements

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the reporting date.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(b) 貨物銷售

銷售貨物的收益於產品的控制權轉移(即產品交付予客戶)、客戶可全權酌情決定銷售產品的渠道及價格,且概無未履行的責任可影響客戶接受該產品時確認。

應收款項於貨物交付時確認,乃由於因該時間點為代價僅因付款到期前所需的時間過去而成為無條件。當預收客戶付款但尚未履行相關履行責任時,則確認合約負債。

2.20 利息收入

當利息收入來自為現金管理目的而持有的金融資產,則列作財務收入。任何其他利息收入均包括在其他收入中。

利息收入乃對金融資產總賬面值採用實際利率予以計算,惟其後出現信貸減值的金融資產除外。就信貸減值金融資產而言,實際利率應用於金融資產賬面淨值(扣除虧損撥備後)。

2.21 僱員福利

(a) 僱員應享假期

僱員的年假權益在僱員應享時確認,並會就僱員截至報告日期止所提供服務而產生的年假的估計負債作出撥備。

僱員的病假及產假權益於休假時方確認。

2.21 Employee benefits (Continued)

(b) Pension obligations

The Group participates in a defined contribution plan in Hong Kong and pays contributions to privately administered pension insurance plans on a mandatory, contractual or voluntary basis. The Group has no further payment obligations once the contributions have been paid. The contributions are recognised as employee benefit expense when they are due.

(c) Bonus plan

The Group recognises a liability and an expense for bonuses based on a formula that takes into consideration the profit attributable to the Company's owners. The Group recognises a provision where contractually obliged or where there is a past practice that has created a constructive obligation.

2.22 Leases

An arrangement, comprising a transaction or a series of transactions, is or contains a lease if the Group determines that the arrangement conveys a right to control the use of an identified asset for a period of time in exchange for consideration. Such determination is made on an evaluation of the substance of the arrangement, regardless of whether the arrangements take the legal form of a lease.

The Group enters into lease agreements as a lessee with respect to certain premises, motor vehicles and equipment.

Leases are initially recognised as right-of-use assets and corresponding liabilities at the date of which the leased asset is available for use by the Group. Each lease payment is allocated between the liability and finance cost. The finance cost is charged to profit or loss over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period. The right-of-use asset is depreciated on a straight-line basis over the shorter of the asset's estimated useful life and the lease term.

2.21 僱員福利(續)

(b) 退休金責任

本集團於香港參與定額供款計劃，並以強制性、合約性或自願性方式向私人管理的退休保險計劃作出供款。一旦已作出供款，本集團並無進一步付款之責任。供款在應付時確認為僱員福利開支。

(c) 花紅計劃

本集團根據計及本公司擁有人應佔溢利的公式確認花紅的負債及開支。本集團按合約規定或過往慣例所產生的推定性責任確認撥備。

2.22 租賃

倘本集團釐定一項安排(包括一項交易或一系列交易)為轉讓一項已識別資產在一段期間內之使用控制權，以換取代價，則該項安排即為或包含租賃成分。有關決定乃根據評估該項安排之實質作出，不論該項安排是否採用租賃之法律形式。

本集團(作為承租人)就若干處所、汽車及設備訂立租賃協議。

於租賃資產可供本集團使用當日，租賃會初步確認為使用權資產及相應負債。各租賃付款在負債和財務成本之間進行分配。財務成本在租賃期內於損益扣除，以就各期間負債餘額得出固定的週期性利率。使用權資產以直線法按資產之估值可用年期及租期之較短者折舊。

2.22 Leases (Continued)

Assets and liabilities arising from a lease are initially measured on a present value basis. Lease liabilities include the net present value of the following lease payments:

- fixed payments (including in-substance fixed payments), less any lease incentives receivable;
- variable lease payment that are based on an index or a rate;
- amounts expected to be payable by the lessee under residual value guarantees;
- the exercise price of a purchase option if the lessee is reasonably certain to exercise that option;
- payments of penalties for terminating the lease, if the lease term reflects the lessee exercising that option; and
- lease payments to be made under reasonably certain extension options are also included in the measurement of lease liabilities.

The lease payments are discounted using the interest rate implicit in the lease, if that rate can be determined, or the Group's incremental borrowing rate.

Right-of-use assets are measured at cost comprising the following:

- the amount of the initial measurement of lease liabilities;
- any lease payments made at or before the commencement date, less any lease incentive received;
- any initial direct costs; and
- restoration costs, if any.

2.22 租賃(續)

租賃所產生的資產及負債初步按現值基準計量。租賃負債包括以下租賃付款的淨現值：

- 固定付款(包括實質固定付款)減任何應收租賃優惠；
- 基於指數或利率的可變租賃付款；
- 剩餘價值擔保下的承租人預期應付款項；
- 購買選擇權的行使價(倘承租人合理確定行使該選擇權)；
- 支付終止租賃的罰款(倘租期反映承租人行使權利終止租約)；及
- 根據合理確定選擇延長租期作出的租賃付款亦計入租賃負債的計量。

租賃付款採用租賃所隱含的利率予以貼現。倘無法釐定該利率，則使用本集團的增量借款利率。

使用權資產按成本計量，包括以下各項：

- 初始計量租賃負債的金額；
- 在開始日期或之前作出的任何租賃付款減任何已收租賃優惠；
- 任何初始直接成本；及
- 復原成本(如有)。

**2.22 Leases (Continued)**

Right-of-use assets are generally depreciated over the shorter of the asset's useful life and the lease term on a straight-line basis.

Payments associated with short-term leases are recognised on a straight-line basis as an expense in profit or loss. Short-term leases are leases with a lease term of 12 months or less.

**2.23 Government grants**

Government grants are recognised at their fair value when there is reasonable assurance that the grant will be received and the Group will comply with all attached conditions.

Government grants relating to costs are deferred and recognised in the combined statements of comprehensive income over the period necessary to match them with the costs that they are intended to compensate.

Government grants relating to the purchase of property, plant and equipment are included in non-current liabilities as deferred income and are credited to combined statements of comprehensive income on a straight-line basis over the expected lives of the related assets.

**2.24 Dividend distribution**

Dividend distribution to the Company's shareholders is recognised as a liability in the Company's consolidated financial statements in the period in which the dividends are approved by the Company's shareholders or directors, as appropriate.

**2.22 租賃(續)**

使用權資產一般於資產的可使用年期及租期(以較短者為準)內按直線基準予以折舊。

與短期租賃相關的付款按直線基準於損益確認為開支。短期租賃指租期為12個月或以下的租賃。

**2.23 政府補貼**

政府補貼在有合理保證會收到補貼且本集團會遵守所有附加條件時，按其公平值確認。

與成本有關之政府補貼被遞延，並在必要時期內於合併全面收益表中確認，以與其擬補償之成本相對。

與購買物業、廠房及設備有關之政府補貼作為遞延收入計入非流動負債，並在相關資產之預期使用年內以直線法計入合併全面收益表中。

**2.24 股息分派**

向本公司股東分派股息於本公司股東或董事批准股息期間之本公司綜合財務報表內確認為一項負債(如適用)。



### 3 FINANCIAL RISK MANAGEMENT

#### 3.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: foreign exchange risk, interest rate risk, credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

Management regularly manages the financial risks of the Group. Because of the simplicity of the financial structure and the current operations of the Group, no hedging activities are undertaken by management.

##### (a) Foreign exchange risk

The Group mainly operates in Hong Kong and is exposed to immaterial exchange risk from various currency exposures.

As the assets and liabilities of each company within the Group are mainly denominated in the respective company's functional currency, the directors are of the opinion that the Group's volatility of its profits against changes in exchange rates of foreign currencies would not be significant.

##### (b) Interest rate risk

The Group's interest rate risk arises from bank deposits, bank borrowings and lease liabilities. Bank borrowings issued at variable rates expose the Group to cash flow interest rate risk which is partially offset by the bank deposits. Lease liabilities issued at fixed rates expose the Group to fair value interest rate risk. The interest rate profile of bank borrowings is disclosed in Note 19. The bank deposits generate interest at the prevailing market interest rates.

As at 31 March 2022, if interest rates had been 25 basis points higher/lower with all other variables held constant, the Group's profit for the year would have increased/decreased by approximately HK\$18,000 (2021: HK\$52,000), mainly as a result of higher/lower interest income over expense on floating rate bank deposits and bank borrowings.

### 3 財務風險管理

#### 3.1 財務風險因素

本集團的業務面對不同財務風險：外匯風險、利率風險、信貸風險及流動資金風險。本集團的整體風險管理計劃集中處理金融市場的不可預測性，並尋求盡力減輕對本集團財務表現的潛在不利影響。

管理層定期管理本集團之財務風險。由於本集團的財務結構及目前營運較為簡單，故管理層並無進行任何對沖活動。

##### (a) 外匯風險

本集團主要在香港經營，並面臨各種貨幣所產生的外匯風險，有關風險並不重大。

由於本集團內各公司的資產及負債主要以各公司之功能貨幣計值，董事認為，本集團之溢利不會因外幣匯率變動而出現重大波動。

##### (b) 利率風險

本集團的利率風險來自銀行存款、銀行借貸以及租賃負債。以浮動利率計息的銀行借貸令本集團面對現金流量利率風險，而該風險部份獲銀行存款抵銷。以固定利率計息的租賃負債令本集團面對公平值利率風險。銀行借貸的利率概況於附註19披露。銀行存款按現行市場利率產生利息。

於二零二二年三月三十一日，倘利率上升／下降25個基點而所有其他變數維持不變，本集團年內溢利將增加／減少約18,000港元（二零二一年：52,000港元），主要由於浮動利率銀行存款和銀行借貸的利息收入高於／低於支出。

**3.1 Financial risk factors (Continued)**

*(c) Credit risk*

Credit risk of the Group mainly arises from trade and retention receivables, contract assets, other receivables and cash and cash equivalents. The carrying amounts of these balances except cash on hand in the consolidated statement of financial position represent the Group's maximum exposure to credit risk in relation to its financial assets.

*Cash and cash equivalents*

The majority of the Group's bank balances are placed in financial institutions which are independently rated with high credit ratings. Management does not expect any losses from non-performance by these financial institutions as they have no default history in the past.

*Other receivables*

Other receivables are also subject to the impairment requirements under HKFRS 9. It is measured as either 12-month expected credit losses or lifetime expected credit loss, depending on whether there has been a significant increase in credit risk since initial recognition. If a significant increase in credit risk of a receivable has occurred since initial recognition, impairment is measured as lifetime expected credit losses. As at 31 March 2022 and 2021, the identified impairment loss for other receivables is assessed to be minimal.

**3.1 財務風險因素(續)**

*(c) 信貸風險*

本集團的信貸風險主要源於應收貿易賬款及應收保留金、合約資產、其他應收款項以及現金及現金等價物。該等結餘(手頭現金除外)在綜合財務狀況表的賬面值代表本集團就其金融資產所承擔的最高信貸風險。

*現金及現金等價物*

本集團的大部分銀行結餘均存放在獲獨立評定為具有高信貸評級的財務機構內。由於該等財務機構過往並無違約記錄，故管理層預料不會發生因該等機構未能履約而造成的任何虧損。

*其他應收款項*

其他應收款項亦須遵守香港財務報告準則第9號的減值規定。減值按12個月預期信貸虧損或全期預期信貸虧損計量，視乎自初步確認以來信貸風險是否顯著增加。如應收款項的信貸風險自初步確認後顯著增加，則按全期預期信貸虧損計量減值。於二零二二年及二零二一年三月三十一日，其他應收款項的已確定減值虧損經評估為甚低。

###### *Trade and retention receivables and contract assets*

For trade and retention receivables and contract assets, the Group applies the HKFRS 9 simplified approach to measuring expected credit losses which uses a lifetime expected credit loss allowance for all trade and retention receivables and contract assets without financing components.

To measure the expected credit losses, trade and retention receivables have been grouped based on the shared credit risk characteristics and the days past due.

The Group divided trade and retention receivables and contract assets into two categories to measure the expected credit loss rates. Category 1 is for customers who have a relatively low credit risk and no default history. Category 2 is for customers who have a relatively higher credit risk. With different types of customers, the Group calculated the expected credit loss rates respectively.

##### (c) 信貸風險(續)

###### *應收貿易賬款及應收保留金以及合約資產*

就應收貿易賬款及應收保留金以及合約資產而言，本集團應用香港財務報告準則第9號所訂明的簡化方法計量預期信貸虧損，該方法就所有無融資成分的應收貿易賬款及應收保留金以及合約資產使用全期預期信貸虧損撥備。

為計量預期信貸虧損，應收貿易賬款及應收保留金已根據共有信貸風險特點及逾期天數進行分組。

Indicators that there is no reasonable expectation of recovery include the failure of a debtor to engage in a repayment plan with the Group. Impairment losses on trade and retention receivables and contract assets are presented as net impairment losses within operating profit. Subsequent recoveries of amounts previously written off are credited against the same line item.

##### (d) Liquidity risk

Prudent liquidity risk management implies maintaining sufficient cash and the availability of funding from external parties.

The Group's primary cash requirements have been for payments for capital expenditures, loan repayment, trade payables, other creditors, accrued liabilities and operating expenses. Accordingly, the directors are of the opinion that the Group does not have significant liquidity risk.

The table below analyses the Group's financial liabilities into relevant maturity groupings based on the remaining period at the date of the consolidated statement of financial position to the contractual maturity date. The amounts disclosed in the table are the contractual undiscounted cash flows. Fair values of balances due on demand or less than 1 year approximate their carrying balances as the impact of discounting is not significant.

#### 3.2 Capital risk management

The Group's objectives when managing capital are to safeguard the Group's ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders and to maintain an optimal capital structure to reduce the cost of capital.

In order to maintain or adjust the capital structure, the Group may adjust the amount of dividends paid to shareholders, return capital to shareholders, issue new shares or sell assets to reduce debt.

**4 CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS**

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

**(a) Construction contracts**

The Group reviews and revises the estimates of contract revenue, contract costs, variation orders and contract claims prepared for each construction contract as the contract progresses. Budgeted construction costs are prepared by the management on the basis of quotations from time to time provided by the major subcontractors, suppliers or vendors involved and the experience of the management. In order to keep the budget accurate and up-to-date, management conducts periodic reviews of the budgets of contracts by comparing the budgeted amounts to the actual amounts incurred. Such significant estimates may have an impact on the profit recognised in each year.

**(b) Impairment of trade and retention receivables and contract assets**

The Group follows the guidance of HKFRS 9 to determine when trade and retention receivables and contract assets are impaired. Significant judgement is exercised on the assessment of the risk of default and expected credit losses from each customer. In making the judgement, management considers a wide range of factors such as results of follow-up procedures, customer payment trends including subsequent payments, customers' financial positions and expected future change of credit risks, including consideration of factors such as general economy measure, changes in macro-economic indicators, etc. Details of assumptions and inputs used are discussed in Note 3.

**4 關鍵會計估計及判斷**

**(a) 建築合約**

隨著合約工程進度，本集團審查及修訂每一份建築合約之合約收益、合約成本、工程變更指令及合約索償撥備之估計。預算的建築成本由管理層參考參與之主要分包商、供應商或賣方不時提供之報價加上管理層之經驗為基礎而編製。為確保預算準確及更新，管理層對合約預算進行定期審查，比較預算金額及實際金額之差別。有關重大估計可能對於各年度內確認之溢利產生影響。

**(b) 應收貿易賬款及應收保留金以及合約資產減值**

本集團遵循香港財務報告準則第9號之指引以釐定應收貿易賬款及應收保留金以及合約資產何時出現減值。於評估各客戶的違約風險及預期信貸虧損時須作出重大判斷。於作出判斷時，管理層考慮多項因素，例如跟進程序的結果、客戶付款趨勢（包括期後付款）及客戶財務狀況以及預計信貸風險的未來變動（包括考慮一般經濟措施及宏觀經濟指標變化等因素）。所用假設和輸入數據的詳情見附註3。

#### (c) Income taxes

The Group is subject to income taxes in Hong Kong and Macau. Significant judgement is required in determining the provision for income taxes. There are certain transactions and calculations for which the ultimate tax determination is uncertain. The Group recognises liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the current and deferred tax assets and liabilities in the period in which such determination is made.

Companies within the Group in Hong Kong have participated in the Mandatory Provident Fund Scheme under the Mandatory Provident Fund Scheme Ordinance (the “MPF Scheme”), a defined contribution scheme managed by an independent trustee.

Under the MPF Scheme, each of the Group companies and its employees make monthly contributions to the scheme at a minimum of 5% of the employee’s relevant income as defined under the MPF Scheme, with the maximum mandatory contribution by each of the Group companies and its employees limited to HK\$1,500 per month, and further contributions are voluntary.

The mandatory contributions are fully and immediately vested in the employees as accrued benefits. The employees are entitled to receive their entire voluntary contributions and 100% of the Group’s employer voluntary contributions upon retirement or leaving the Group after completing one year of service.

Any forfeited voluntary contributions made by the Group are used to reduce the Group’s employer voluntary contributions. There were no forfeited contributions (by employers on behalf of employees who leave the scheme prior to vesting fully in such contributions) to offset existing contributions under the defined contribution schemes.
