Notes:

(a) Share premium

Under the Companies Law, Chapter 22 of the Cayman Islands, the funds in the share premium account of the Company are distributable to the shareholders of the Company provided that immediately following the date on which the dividend is proposed to be distributed, the Company will be in a position to pay off its debts as they fall in the ordinary course of business.

(b) Other reserve

The amount represents the difference between the nominal amount of shares issued by the Company and the aggregate amount of share capital of subsidiaries acquired under common control pursuant to the group reorganisation in preparation of the listing of the Company's shares on GEM of the Stock Exchange on 17 June 2013

(c) Contribution surplus

The amount represents the amounts due to shareholders capitalised before the listing of the Company's shares on GEM of the Stock Exchange.

(d) Exchange reserve

The exchange reserve comprises all foreign exchange differences arising from the translation of the financial statements of foreign operations.

(e) The PRC statutory reserve

Pursuant to the laws and regulations governing the PRC enterprises, PRC subsidiaries of the Group are required to allocate at least 10% of its after-tax profit but before dividend distribution to the statutory reserve until the reserve has reached 50% of their registered capital. The statutory reserve can only be used, upon approval by the relevant authority, to offset accumulated losses or increase capital.

附註:

(a) 股份溢價

根據開曼群島法例第22章公司法,本公司的 股份溢價賬的資金可供分派予本公司股東, 惟緊隨建議分派股息之日後,本公司將能清 價其日常業務過程中的到期情務。

(b) 其他儲備

該金額為本公司已發行股份的面值與根據為 籌備本公司股份於二零一三年六月十七日在 聯交所GEM上市而進行的集團重組收購共同 控制附屬公司的股本總額之間的差額。

(c) 繳入盈餘

該金額指已於本公司股份在聯交所GEM上市 前撥充資本的應付股東款項。

(d) 匯兑儲備

匯兑儲備包括換算海外業務財務報表所產生 之所有匯兑差額。

(e) 中國法定儲備

根據規管中國企業的法律及法規·本集團的中國附屬公司須將除稅後溢利(但扣除股息分派前)至少10%分配至法定儲備,直至該儲備達致其註冊資本50%。經相關機關批准後,法定儲備僅可用於抵鎖累計虧損或增加資本。

NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

For the six months ended 31 December 2022

1. GENERAL INFORMATION

The Company was incorporated as an exempted company with limited liability in the Cayman Islands on 31 May 2012. The registered office of the Company is located at Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands. The principal place of business of the Company is located at Office A, 12/F, Tower A, Capital Tower, No. 38 Wai Yip Street, Kowloon Bay, Hong Kong.

The Company had its primary listing on the GEM of the Stock Exchange on 17 June 2013. The Company's principal activity is investment holding and the principal activities of its principal subsidiaries are the provision of environmental cleaning services.

2. BASIS OF PREPARATION

The unaudited condensed consolidated financial statements have been prepared in accordance with Hong Kong Accounting Standard 34 "Interim Financial Reporting" issued by the Hong Kong Institute of Certified Public Accountants (the "HKICPA") and the applicable disclosures required by the GEM Listing Rules.

The principal accounting policies used in the unaudited condensed consolidated financial statements are consistent with those adopted in the preparation of the Group's annual financial statements for the year ended 30 June 2022.

1. 一般資料

本公司於二零一二年五月三十一日在開曼群島註冊成立為獲豁免有限公司。本公司的註冊辦事處位於Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands。本公司的主要營業地點位於香港九龍灣偉業街38號富臨中心A座12樓A室。

本公司於二零一三年六月十七日首 次在聯交所GEM上市。本公司的主 要業務為投資控股,旗下主要附屬 公司的主要業務為提供環境清潔服 務。

2. 編製基準

未經審核簡明綜合財務報表已根據 香港會計師公會(「香港會計師公 會」)頒佈之香港會計準則第34號「中 期財務報告」及GEM上市規則所規定 之適用披露而編製。

未經審核簡明綜合財務報表所用之 主要會計政策與編製本集團截至二 零二二年六月三十日止年度之年度 財務報表所採納者一致。

2. BASIS OF PREPARATION (CONTINUED)

For the purpose of preparing and presenting the financial information of the unaudited condensed consolidated financial statements, the Group has consistently adopted HKFRSs issued by the HKICPA which are effective for the Group's financial year beginning on 1 July 2022. The adoption of new/revised HKFRSs does not result in changes to the Group's accounting policies and has no material effect on the Group's financial statements. The Group has not early applied the new and revised HKFRSs that have been issued by the HKICPA but are yet to be effective on the accounting period beginning on 1 July 2022.

The Group has not applied the new and revised HKFRSs which have been issued but are not yet effective. The Group is currently in the process of making an assessment of the impact of these new and revised HKFRSs but is not yet in a position to state whether they would have a material impact on the Group's results and financial position.

The unaudited condensed consolidated financial statements have not been audited by the Company's auditors, but have been reviewed by the Company's audit committee.

2. 編製基準(績)

本集團並無應用已頒佈但尚未生效 之新訂及經修訂香港財務報告準 則。本集團現正評估該等新訂及經 修訂香港財務報告準則之影響,惟 尚未能說明該等新訂及經修訂香港 財務報告準則會否對本集團業績及 財務狀況造成重大影響。

未經審核簡明綜合財務報表並未由 本公司核數師審核,但已由本公司 審核委員會審閱。



3. SEGMENT INFORMATION

The Group determines its operating segments based on the reports reviewed by the chief operating decision maker, which are used to make strategic decisions including resources allocation and assessment of segment performance.

The segments are managed separately as each business offers different products and services and requires different business strategies. No operating segments identified by the chief operating decisionmaker have been aggregated in arriving at the reportable segments of the Group. The following summary describes the operations in each of the Group's reportable segments:

Environmental and cleaning

Provision of environmental and cleaning services in Hong Kong and the People's Republic of China (the "PRC")

Money lending

Provision of money lending business in Hong Kong and the PRC

Investments

Investments in financial assets

The chief operating decision maker assess the performance of the operating segments based on a measure of reportable segment results. This measurement basis excludes central administrative and other costs including directors' emoluments, revaluation loss on property, plant and equipment, other operating expenses and finance costs.

At 31 December 2021 and 30 June 2021, no deferred tax liabilities have been recognised in respect of tax that would be payable on the unremitted profits of the PRC subsidiaries derived since 1 January 2008 as the directors of the Company is in a position to control the dividend policies of the PRC subsidiaries and no distribution of such profits is expected to be declared from the PRC subsidiaries in the foreseeable future.

The Board does not recommend the payment of any dividend for the six months ended 31 December 2022 (six months ended 31 December 2021: HK\$Nil).

During the six months ended 31 December 2022, the Group acquired items of property, plant and equipment with aggregate cost of approximately HK\$649,000 (six months ended 31 December 2021: approximately HK\$2,308,000) and items of property, plant and equipment with aggregate carrying values of approximately HK\$414,000 were disposal of (six months ended 31 December 2021: HK\$45,000).

At 31 December 2022, the Group's land and buildings are situated in Hong Kong, held under a mediumterm leases and measured at the fair values of HK\$55,700,000 (30 June 2022: HK\$58,300,000) which have been arrived at on the basis of valuation by Royson Valuation Advisory Limited, an independent qualified professional valuer not connected with the Group, and determined using the market approach by reference to recent sales price of comparable properties on a price per square foot basis using market data which is publicly available.

At 31 December 2022, the Group had pledged its land and buildings with carrying values of HK\$55,700,000 (30 June 2022: HK\$58,300,000) to secure the bank loans (note 15) and the performance bonds issued (note 19(a)).

16. SHARE OPTION SCHEME

The Company conditionally operates a share option scheme ("Share Option Scheme") for the purpose of attract, retain and reward the eligible persons and to provide the eligible persons an incentive or reward for their contribution to the Group and by enabling such persons' contribution to further advance the interests of the Group. The Share Option Scheme was adopted on 28 May 2013 and shall be valid and effective for a period of ten years commencing from the date of adoption, after which period no further options will be offered or granted but the provisions of the Share Option Scheme shall remain in full force and effect in all other respects with respect to options granted during the life of the Share Option Scheme.

The eligible persons of the Share Option Scheme include directors, consultants or advisers and any other person who has contributed to the Group (the "Eligible Persons").

The subscription price of the share options shall be a price determined by the board of directors and shall be at least the highest of (i) the closing price per share as stated in the Stock Exchange's daily quotation sheet on the offer date; (ii) the average of the closing prices per share as stated in the Stock Exchange's daily quotation sheets for the five business days immediately preceding the offer date; or (iii) the nominal value of the share.

An offer shall remain open for acceptance by the Eligible Person concerned for such period as determined by the board of directors, being a date not later than ten business days after the offer date by which the Eligible Person must accept the offer or be deemed to have declined it, provided that no such offer shall be open for acceptance after the tenth anniversary of the date of adoption of the Share Option Scheme or after the Share Option Scheme has been terminated in accordance with the provisions of the Share Option Scheme.

As at 31 December 2022, the bank facilities of approximately HK\$12,739,000 (30 June 2022: HK\$14,320,000) granted to the Group and bankers' guarantees on performance bonds issued were pledged by:

- (i) land and buildings of HK\$51,100,000 (30 June 2022: HK\$53,700,000);
- (ii) restricted bank deposits of approximately HK\$278,000 (30 June 2022: approximately HK\$570,000); and
- (iii) corporate guarantees of the Company and wholly-owned subsidiaries.

The effective period of performance bond is based on the service period and the contract terms as specified in these environmental service contracts. The performance bonds may be claimed by customers if services rendered by the Group fail to meet the standards as specified in these environmental service contracts.

MANAGEMENT DISCUSSION AND ANALYSIS

BUSINESS OVERVIEW

Environmental and Cleaning Services

The Group is principally engaged in the provision of environmental services in Hong Kong and the PRC, which include the provision of cleaning and related services for (i) public area and office cleaning services which involve cleaning of public areas, carpets, floors, toilets, changing rooms, lifts and escalators and emptying of garbage bins at commercial buildings and their tenants, residential complexes, shopping arcades, hotels and public transport facilities such as airport, ferries, ferry terminal, cargo and logistics centre and depots; (ii) overnight kitchen cleaning services mainly at private club and hotels; (iii) external wall and window cleaning services: (iv) stonefloor maintenance and restoration services; (v) pest control and fumigation services; (vi) waste management and disposal solutions which mainly involve collection, transportation and disposal of household waste, construction waste and trade waste and sales of recyclable waste such as paper, metal and plastic waste collected during our operations: (vii) housekeeping services where we provide housekeeping services to carry out professional daily housekeeping and cleaning services at local boutique hotels, hostels and serviced apartments; (viii) secure and confidential waste destruction for commercial clients; (ix) sanitation solution for yacht; (x) cleaning and waste management solution for renovated apartment; and (xi) airline catering support services.

Money Lending Business

The Group conducted its money lending business under the money lenders licences granted by the licensing court in Hong Kong since 2017. The Group also conducted its money lending business in the PRC since 2019.

管理層討論及分析

業務概覽

環境及清潔服務

本集團的主要業務為於香港及中國提供環 境服務,包括提供下列各項清潔及相關服 務:(1)公眾地方及辦公室清潔服務,其涉 及清潔公眾地方、地氈、地板、廁所、更 衣室、升降機及自動梯,以及在商業大廈 (及其租戶)、住宅屋苑、購物商場、酒店 及公共運輸設施(如機場、渡輪、渡輪碼 頭、貨物及物流中心及車廠)等地方掏空垃 圾箱;(ii)通宵廚房清潔服務,有關服務主 要提供予私人會所及酒店;(iii)外牆及玻璃 清潔服務: (iv)石材地板保養及翻新服務; (v)滅蟲及焗霧處理服務;(vi)廢物管理及處 置解決方案,其主要涉及收集、運輸及處 置住戶廢物、建築廢物及商貿廢物及出售 在本公司業務過程中收集所得的可循環再 用廢物,例如:廢紙、金屬及塑膠;(vii)房 務服務,我們為本地精品酒店、賓館及服 務式公寓提供房務服務,每日進行專業的 房務及清潔服務; (viii)為商業客戶提供安全 及保密文件銷毀服務; (ix)為遊艇提供衛生 解決方案;(x)為翻新公寓提供清潔及廢物 管理解決方案;及(xi)航空餐飲支持服務。

放債業務

自二零一七年起,本集團獲香港牌照法庭 授予放債人牌照,據此開展放債業務。自 二零一九年起,本集團亦於中國開展放債 業務。

Investments in Financial Assets

During the period, the Group invested in financial assets classified as the financial assets at fair value through profit or loss which composed of only the shares of companies listed on the Stock Exchange.

BUSINESS REVIEW

Environmental and Cleaning Services in Hong Kong

Compared to the revenue of approximately HK\$165.5 million for the six months ended 31 December 2021, the environmental and cleaning services in Hong Kong contributed revenue of approximately HK\$178.7 million for the six months ended 31 December 2022. The increase is mainly attributable to several new services contracts in the residential sector awarded.

Results

During the six months ended 31 December 2022, the Group was granted by the HKSAR Government an one-off subsidy amounting to approximately HK\$0.8 million under the ESS for part of the monthly salaries of our employees under the environmental and cleaning services in Hong Kong which was included in the "Other income" for the period.

For the six months ended 31 December 2022, the environmental and cleaning business in Hong Kong achieved a net profit of approximately HK\$3.7 million (excluding the one-off subsidy from the ESS) as compared to the net profit of approximately HK\$3.9 million for the six months ended 31 December 2021. The decrease is mainly due to increasing manpower services costs due to intense labor supply and decline in the prices from some customers upon renewed of services contracts.

投資金融資產

業務回顧

香港環境及清潔服務

與截至二零二一年十二月三十一日止六個月的收益約165,500,000港元相比,香港環境及清潔服務於截至二零二二年十二月三十一日止六個月貢獻收益約178,700,000港元。該增加乃主要由於取得住宅分部若干新服務合約。

業績

截至二零二二年十二月三十一日止六個月,本集團獲得香港特別行政區政府授予保就業計劃項下的一次性補貼約800,000港元,以用於香港環境及清潔服務分部的僱員的部分月薪,而有關補貼計入期內「其他收入」。

截至二零二二年十二月三十一日止六個月,香港環境及清潔業務錄得純利約3,700,000港元(不包括保就業計劃的一次性補貼),而截至二零二一年十二月三十一日止六個月則錄得純利約3,900,000港元。該減少乃主要由於人力服務成本因勞動力供應緊張而增加以及部分客戶重續服務合約後價格下降。



Environmental and Cleaning Services in Shanghai, the PRC

The Shanghai Operations recorded a decrease in the revenue by approximately HK\$5.2 million to approximately HK\$9.1 million for the six months ended 31 December 2022 (2021: approximately HK\$14.3 million). And the Shanghai Operations recorded a net loss of approximately HK\$0.5 million for the six months ended 31 December 2022 as compared to the net profit of approximately HK\$2.8 million for the six months ended 31 December 2021. The significant downturn of the financial performance of the Shanghai Operations is mainly due to (i) lost of several service contracts due to fierce competition in pricing; (ii) decline in the prices and services volume from existing customers of which the businesses have been severely affected by the city-wide lockdown of Shanghai; and (iii) continuing increasing manpower services costs due to intense labor supply.

Money Lending Business

The economy in Hong Kong and the PRC have been challenging for all businesses with the prolonged Sino-US trade tensions and the worldwide spreading of COVID-19. Amid such negative factors, some of our borrowers under the money lending business have been severely affected and are in financial difficulties, and therefore have defaulted on repayment of their loans and interests on schedules. Therefore, the Group already recognized the impairment loss of approximately HK\$46.0 million (the "Impairment Loss") on part of these past due loans and interests receivables from such borrowers. Nevertheless, the Group has been taking actions, including but not limited to legal proceedings against these borrowers, to recover the loan principals, interests and all other related recovery costs incurred.

中國上海環境及清潔服務

上海業務於截至二零二二年十二月三十一日止六個月錄得收益減少約5,200,000港元至約9,100,000港元(二零二一年:約14,300,000港元)。上海業務於截至二零二年十二月三十一日止六個月錄得淨虧損約500,000港元,而截至二零二一年十二月三十一日止六個月則為淨收益約2,800,000港元。上海業務的財務表現嚴重下滑乃主要由於(i)價格競爭激烈導致失去若干服務合約;(i)現有客戶的價格及服務量下降,該等客戶的業務因上海全市封鎖而受到嚴重影響;及(ii)勞工供應緊張導致人力服務成本持續增加。

放債業務

由於中美貿易關係持續緊張及COVID-19 在全球蔓延,香港及中國經濟形勢對於所 有企業而言富有挑戰性。鑒於有關不利因 素,放債業務項下的若干借款人已受到嚴 重影響及陷入財務困難,故延遲按計劃償 還貸款及利息。因此,本集團已就部分應 收有關借款人的該等逾期貸款及利息確 認減值虧損約46,000,000港元(「減值虧 損」)。然而,本集團持續採取行動(包括但 不限於針對該等借款人提出法律訴訟)以收 回貸款本金、利息及產生的所有其他相關 收回成本。 The interest income from the money lending business for the six months ended 31 December 2022 amounted to approximately HK\$4.3 million (2021: approximately HK\$6.3 million). The decrease in the interest income is mainly due to the decrease in the average loans balance and the average loan interest rates granted during the period.

The money lending business recorded a net operating profit of approximately HK\$2.2 million for the six months ended 31 December 2022 (2021: approximately HK\$4.6 million) (excluding the Net Impairment Loss). The decrease is primarily due to the decrease in the interest income during the six months ended 31 December 2022.

Properties in Hong Kong

The market prices and sentiment of the commercial properties in Hong Kong has been gradually and slightly declining since mid of 2022. As a result, a revaluation loss of approximately HK\$1.9 million (31 December 2021: revaluation gain of approximately HK\$4.4 million) on the Group's commercial properties is recorded based on the independent valuation as at 31 December 2022.

Investments in Financial Assets

The Group's investment strategy is to review the investment portfolio continuously and make appropriate adjustments (by acquisition or disposal) according to the market situation, with an aim to generate reasonable returns. During the six months ended 31 December 2022, the Group recorded net unrealised fair value gain amounting to approximately HK\$109,000 (2021: fair value loss of approximately HK\$7,000) and net realised gain on disposals amounting to HK\$Nil (2021: HK\$30,000) from the investments in the financial assets

截至二零二二年十二月三十一日止六個月,放債業務的利息收入為約4,300,000港元(二零二一年:約6,300,000港元)。利息收入減少乃主要由於期內授出的平均貸款結餘及平均貸款利率減少。

放債業務於截至二零二二年十二月三十一日止六個月錄得經營純利約2,200,000港元(二零二一年:約4,600,000港元)(不包括減值虧損淨額)。該減少乃主要由於截至二零二二年十二月三十一日止六個月利息收入減少。

香港物業

位於香港的商業物業市場價格及信心自 二零二二年年中以來已逐步小幅下跌。 因此,根據於二零二二年十二月三十一 日的獨立估值,本集團商業物業錄得重估 虧損約1,900,000港元(二零二一年十二月 三十一日:重估收益約4,400,000港元)。

投資金融資產

本集團的投資策略為持續審閱投資組合並根據市況作出適當調整(透過收購或出售),旨在產生合理回報。截至二零二二年十二月三十一日止六個月,本集團錄得投資金融資產之未變現公平值收益淨額約109,000港元(二零二一年:公平值虧損約7,000港元)及已變現出售收益淨額零港元(二零二一年:30,000港元)。

OUTLOOK

Environmental and Cleaning Services in Hong Kong

Labor market competition in Hong Kong has intensified with the implementation of the SMW which would to be adjusted upward in May 2023. The Group is also facing higher labor turnover rate in the environmental and cleaning services industry as more labor tend to work in other less laborious industries such as the security guard service industry under the same SMW rate. To offset the increase in labor costs. the Group is striving to transfer most of the increased labor costs to our customers and implement more efficient working flows and stringent cost control procedures. The Group is closely monitoring the labor turnover rate and regularly reviews our remuneration package in order to maintain sufficient labor force and cope with the changing environment. We would continue to enhance the quality of services by providing training to our front line staff.

前景

香港環境及清潔服務

隨著實施法定最低工資(將於二零二三年五 月上調),香港勞動力市場的競爭加劇。 本集團亦正面對環保及清潔服務業的高勞 工流失率,乃由於更多勞工在相同法定最 低工資比率下傾向於其他較輕鬆的行業工 作,例如保安護衛服務業。為抵銷勞工成 本的增加,本集團力求將大部分已增加勞 工成本轉嫁予客戶並實施更有效的工作流 程及嚴格的成本控制程序。本集團密切監 控勞工流失率及定期檢討我們的薪酬計 劃,以維持充足的勞動力並應對不斷變化 的環境。我們將繼續通過向前線員工提供 培訓提高服務質量。



The economy in Hong Kong has been challenging and in extreme difficult for the businesses in the transportation and the hotel as well as the commercial sector with the worldwide spreading of COVID-19. Our customers from these sectors have been reducing their service requests and asking for the prices reduction since the second half of 2019. Both of our service income and profit margin from these sectors have seen severely affected. To mitigate such downturn effect, we would strengthen our marketing effort in hope to expand our market shares in the commercial and the residential sectors and continue to consolidate our resources to focus on high value customers to bring in additional revenue by cross-selling other cleaning and waste management services to our existing customers. We believe this strategy may not only improve our revenue per customer but also increase our profit margin as we could leverage our existing manpower to perform services at location where we already have presence. We would explore other new environmental and cleaning services to expand our service scope to enable customers to use the Group as a one-stop cleaning contractor. We would continue to streamline our operations in order to simplify and improve our operation efficiency. We believe that our success in serving different sectors will further build up the confidence for new clients to select our cleaning services in the coming future.

由於COVID-19在全球蔓延,香港經濟形勢 對於運輸及酒店行業以及商業的企業而言 富有挑戰性及異常艱難。自二零一九年下 半年以來,我們來自該等行業的客戶一直 減少其服務需求,並要求減價。我們來自 該等行業的服務收入及利潤率均受到嚴重 影響。為減輕有關衰退影響,我們將增強 營銷工作,以期擴大於商業及住宅領域的 市場份額,並繼續整合資源專注高價值客 戶,透過向現有客戶交叉銷售其他清潔及 廢物管理服務,帶來額外收益。由於我們 可以發揮現有人力優勢在我們已進駐的地 點開展服務,故此我們相信,這項策略不 單可提高來自每位客戶的收益,亦可提升 我們的利潤率。我們將探索其他新的環境 及清潔服務,以擴大我們的服務範圍,使 客戶將本集團作為一站式清潔承包商。我 們將繼續精簡我們的業務,以簡化及提升 經營效率。我們深信,我們在服務於各行 業方面的成功,將進一步為新客戶日後選 用我們的清潔服務建立信心。

Environmental and Cleaning Services in the PRC

The Shanghai Operations are not expected to be significantly improved in the coming fiscal year with the above-mentioned negative factors affecting nearly all sector of businesses in Shanghai. However, the management of the Shanghai Operations has refined its marketing strategies in order to attract more new customers to utilize our cleaning services and implemented more efficient working flows and stringent cost control procedures to reduce all unnecessary expenditures.

Money Lending Business

With the increasing threat of a downturn of the economy in Hong Kong and the PRC as a result of the above-mentioned negative factors, the Group continues its effort in strengthening its risk management policy and streamlining our existing loan portfolio mix with an aim to reduce our exposure on high risk loans. A cautious and prudent approach is the key direction of our money lending strategies that only borrowers with sound financial abilities would be considered and approved by the Group in the future.

Investments in Financial Assets

A cautious and prudent approach is continued to be the key direction of our investment strategies that only companies listed on the Stock Exchange with valuable prospects would be considered and invested by the Group in the future.

FINANCIAL REVIEW

Revenue

For the six months ended 31 December 2022, the Group reported a total revenue of approximately HK\$192.1 million (2021: approximately HK\$186.2 million), representing an increase of approximately 3.2%. The increase is mainly due to the net effect of (i) increase in the contribution of the revenue of approximately HK\$13.2 million from the environmental and cleaning services in Hong Kong as several new services contracts awarded in the residential sector; (ii) decrease in the contribution of the revenue of approximately HK\$5.2 million from the Shanghai Operations as several cleaning service contracts were lost during the period; and (iii) decrease in the interest income of approximately HK\$2.0 million from the money lending business after decrease in the average loans balances and the average loan interest rates granted by the Group during the period.

管理層將於實施投資策略時持續採取審慎 保守態度,本集團於日後僅會考慮及投資 價值可觀的聯交所上市公司。

財務回顧

收益

截至二零二二年十二月三十一日止六個月,本集團錄得總收益約192,100,000港元(二零二一年:約186,200,000港元),增加約3.2%。該增加主要由於(i)取得住宅分部若干新服務合約導致香港環境及清潔服務的收益貢獻增加約13,200,000港元:(ii)期內失去若干清潔服務合約令上海業務帶來之收益減少約5,200,000港元:及(iii)本集團於期內授出的平均貸款結餘及平均貸款利率減少後,放債業務帶來的利息收入減少約2,000,000港元的淨影響。



Selling, Marketing Expenses and Administrative Expenses

The Group's selling, marketing and administrative expenses increased by approximately HK\$3.2 million to approximately HK\$13.5 million (2021: approximately HK\$10.3 million) for six months ended 31 December 2022. The increase was mainly due to increase in the selling, marketing and administrative expenses, including but not limited to staff costs, rental expenses, entertainment expenses, advertising and promotion expenses, travelling expenses and general office expenses, of the Group's headquarters.

DIVIDEND

The Board does not recommend the payment of any dividend for the six months ended 31 December 2022.

DISCLOSURE OF ADVANCE TO ENTITIES UNDER RULE 17.22 OF THE GEM LISTING RULES

LIQUIDITY AND FINANCIAL RESOURCES

During the six months ended 31 December 2022, the Group had financed its operations and capital requirements through operating cash flows.

As at 31 December 2022, the Group had cash and cash equivalents of approximately HK\$81.3 million (30 June 2022: approximately HK\$74.8 million). The increase is mainly attributable to the cash in flows from the operating activities.

As at 31 December 2022, the Group had net current assets of approximately HK\$152.7 million (30 June 2022: approximately HK\$147.2 million) and current ratio of approximately 3.0 times (30 June 2022: approximately 2.9 times) which remain strong and healthy.

The Group monitors its capital by reference to the gearing ratio. This ratio is calculated as total interest-bearing borrowings (including lease liabilities) divided by total equity. The gearing ratio at the end of the reporting period was as follows:

As at 31 December 2022, the Group had bank deposits of approximately HK\$0.3 million (30 June 2022: approximately HK\$0.6 million) pledged to banks as security for bankers' guarantees on performance bonds issued and banking facilities granted to the Group.

As at 31 December 2022, the Group had properties with carrying values of HK\$55.7 million (30 June 2022: HK\$58.3 million) charged to the bank as security for the bank loans, bankers' guarantees on performance bonds issued and banking facilities granted to the Group.

FOREIGN EXCHANGE EXPOSURE

During the period, major portion of the Group's operations are located mainly in Hong Kong with most of the Group's transactions, assets and liabilities are denominated in Hong Kong Dollars. The Group is exposed to foreign currency risk due to the exchange rate fluctuation of RMB against HK\$ arising from the our environmental and cleaning services business and money lending business in the PRC. The results of our operations in the PRC are translated from RMB into HK\$ at the exchange rates approximating the rates ruling at the dates of the transactions while their financial items are translated from RMB into HK\$ at the closing rate ruling at the end of the reporting period, the resulted exchange differences are recognised as other comprehensive income and accumulated separately in equity in the translation reserve of the Company and will be reclassified to profit or loss until the disposal of interests in such operations. Fluctuation of RMB against HK\$ is moderate to the Group during the period. The Group will review and monitor its currency exposure from time to time, and when appropriate hedge its currency risk.

CORPORATE GOVERNANCE PRACTICES

The Board is committed to maintaining high standards of corporate governance in order to uphold the transparency of the Group and safeguard interests of the shareholders.

The Company has applied the principles and code provisions in the Corporate Governance Code and Corporate Governance Report (the "Code") as set out in Appendix 15 to the GEM Listing Rules.

In the opinion of the Board, the Company has complied with the Code and the GEM Listing Rules for the six months ended 31 December 2022 and up to the date of this report, except for the deviations of the following Codes.

- (i) Under the Code provision A.2.1, the roles of chairman and chief executive officer should be separated and should not be performed by the same individual. During the period under review and up to the date of this report, the chairman of the Board and the chief executive officer of the Company is performed by the executive Director, Mr. Yu Shaoheng. The Company considered that under the supervision of its Board and its independent non-executive Directors, a balancing mechanism existed so that the interests of the Shareholders were adequately and fairly represented. The Company considered that there was no imminent need to change the arrangement.
- (ii) The Code provision A.4.1 stipulates that all non-executive Directors should be appointed for a specific term, subject to re-election. Currently, all non-executive Directors, including the independent non-executive Directors are not appointed for a specific term. They are, however, subject to the retirement by rotation and re-election of directors in the articles of association of the Company. Since their appointment will be reviewed when they are due for re-election, the Board considers that sufficient measures have been taken to ensure that the Company's corporate governance practices are no less exacting than those set out in the Code.

- (ii) 守則條文第A.4.1條規定所有非執行 董事的委任應有指定任期,並須經 重選連任。現時,所有非執行董事 (包括獨立非執行董事)並無特定任 期,然而,彼等須根據本公司之組 織章程細則輪值告退及須經重選連 任。由於非執行董事之委任在到期 重選時將被檢討,董事會認為已採 取足夠措施以確保本公司之企業管 治常規並無較守則所載者寬鬆。
