## BUSINESS REVIEW

The Group is a local contractor in the civil engineering construction industry and is principally engaged in the provision of site formation works, road and drainage works as well as structural works in both public and private sectors in Hong Kong. The Group is an approved contractor of the government of Hong Kong Special Administrative Region (the “**Government**”), a registered general building contractor and a specialist contractor (site formation works) with the Hong Kong Buildings Department.

*Note:* The aggregate contract sum is based on a total of all contract sums stated in the initial agreements between the Group’s customers and the Group. It does not include additions and modifications due to subsequent variation orders. The final revenue recognised from a contract may differ from the contract sum initially agreed between the contracting parties.

During the period under review, the number of COVID-19 confirmed cases continued to decline. However, the prolonged outbreak of COVID-19 continues to bring uncertainties to the market and imposed negative impacts to the construction industry, including disruption to the supply chain, workforce shortages as a result of the illness and preventative quarantines, and suspension of construction works as a result of the measures imposed by the Government. In response, the management of the Group strengthened its preventive measures against COVID-19 to ensure all staff and workers were well protected against the infection of COVID-19 by providing a safe and healthy working environment. During the period under review, the Group’s construction projects were in good progress despite the margins of the projects were severely hit by the outbreak of COVID-19 with intense competition during the period under review.

# MANAGEMENT DISCUSSION AND ANALYSIS

## FINANCIAL REVIEW

### Revenue

The Group's revenue decreased by approximately HK\$161.4 million, or 68.0%, from approximately HK\$237.6 million for the nine months ended 31 December 2021 to approximately HK\$76.1 million for the nine months ended 31 December 2022. Such decrease was primarily attributable to substantial completion of projects during the period ended 31 December 2022.

### Direct Costs

Direct costs primarily consisted of subcontracting fee, direct labour cost, construction materials, petrol consumption and site overheads. Direct cost decreased by approximately HK\$154.2 million, or 67.5%, from approximately HK\$228.5 million for the nine months ended 31 December 2021 to approximately HK\$74.3 million for the nine months ended 31 December 2022. The decrease in direct costs was generally in line with the decrease in revenue.

### Gross Profit and Gross Profit Margin

The Group's gross profit decreased by approximately HK\$7.2 million, or 79.6%, from approximately HK\$9.0 million for the nine months ended 31 December 2021 to approximately HK\$1.8 million for the nine months ended 31 December 2022. Gross profit margin dropped from 3.8% for the nine months ended 31 December 2021 to 2.4% for the nine months ended 31 December 2022. Such decrease was mainly due to the increase in subcontracting charge and direct costs during the period ended 31 December 2022.

### Other Income

Other income increased significantly by approximately HK\$3.3 million, or 250.3%, from approximately HK\$1.3 million for the nine months ended 31 December 2021 to approximately HK\$4.6 million for the nine months ended 31 December 2022. Such increase was primarily attributable to the receipt of the subsidies with approximately HK\$3.0 million from the Government under the Employment Support Scheme.

### Other Gains and Losses

Other gains and losses decreased by approximately HK\$5.4 million, or 235.0%, from a gain of approximately HK\$2.3 million for the nine months ended 31 December 2021 to a loss of approximately HK\$3.1 million for the nine months ended 31 December 2022. Such decrease was primarily due to the loss on disposal of the non-current assets during the period ended 31 December 2022.

### Impairment loss under expected credit loss model, net of reversal

Impairment loss under expected credit loss model in the amount of approximately HK\$59.6 million was recognised during the period ended 31 December 2022. Such amount was attributable to the impairment of trade receivables, other receivables and contract assets during the period ended 31 December 2022.

## **Administrative Expenses**

Administrative expenses increased by approximately HK\$3.6 million or 32.3% from approximately HK\$11.1 million for the nine months ended 31 December 2021 to approximately HK\$14.7 million for the nine months ended 31 December 2022. Such increase was mainly attributable to (i) depreciation of right-of-use assets and property, plant and equipment; and (ii) increase in legal and professional fees during the period ended 31 December 2022.

## **Finance Costs**

Finance costs increased slightly by approximately HK\$6,000 or 0.2% from approximately HK\$2.8 million for the nine months ended 31 December 2021 to approximately HK\$2.8 million for the nine months ended 31 December 2022. Finance costs comprised interests on bank borrowings and lease liabilities.

## **Taxation**

Taxation expenses decreased by approximately HK\$36,000 or 100%, from approximately HK\$36,000 for the nine months ended 31 December 2021 to nil for the nine months ended 31 December 2022. Such decrease was attributable to the loss before taxation incurred for the nine months ended 31 December 2022.

As a result of the above, the Group recorded a loss approximately HK\$73.8 million for the nine months ended 31 December 2022 (for the nine months ended 31 December 2021: loss of approximately HK\$1.6 million).

## **PROSPECT**

During the period under review, the impact of the COVID-19 pandemic on the industry and economy was still uncertain. The Group experienced a relatively difficult and challenging year with competitive pricing arising from intense market competition and increase in direct costs due to the labour shortage and increase in costs of construction materials.

The Group are to implement different measures and policies to minimise the impact of the COVID-19 pandemic on the Group.

The Directors are of the view that the impact of COVID-19 pandemic will gradually subside and the Group will take appropriate measures to seek for new potential construction business opportunities and investments. The Group remains prudently optimistic about the outlook of the construction industry and will remain focus on the long-term developments. With a proven track record and strong foothold in the industry, the Group will endeavour to maintain a sustainable development in its construction business so as to maximise the return of the Company's shareholders (the "Shareholders").

## **EVENTS AFTER THE REPORTING PERIOD**

The Group had no significant events after the end of the reporting period and up to the date of this report.

# NOTES TO THE UNAUDITED CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

## 1. GENERAL

Sheung Moon Holdings Limited (the “**Company**”) was incorporated and registered in the Cayman Islands as an exempted company with limited liability on 31 May 2017 under the Companies Act, Cap 22 (Act 3 of 1961, as amended, consolidated or supplemented from time to time) of the Cayman Islands and its shares are listed on GEM of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) on 12 February 2018. The immediate holding company of the Company is Chrysler Investments Limited, which is incorporated in the British Virgin Islands (“**BVI**”) and owned by Mr. Tang Sze Wo. The address of the Company’s registered office is at Cricket Square, Hutchins Drive, PO Box 2681, Grand Cayman, KY1-1111, Cayman Islands and the address of the Company’s principal place of business is at Office D, 27/F, The Globe, No. 79 Wing Hong Street, Kowloon, Hong Kong.

The Company acts as an investment holding company and its subsidiaries are principally engaged in provision of civil engineering construction services.

The unaudited condensed consolidated financial statements are presented in Hong Kong dollars (“**HK\$**”), which is also the functional currency of the Company.

## 2. BASIS OF PREPARATION AND PRINCIPAL ACCOUNTING POLICIES

The unaudited condensed consolidated financial statement of the Group for the three months and nine months ended 31 December 2022 have been prepared in accordance with accounting policies conform with Hong Kong Financial Reporting Standards (“**HKFRSs**”) issued by the Hong Kong Institute of Certified Public Accountants (“**HKICPA**”) applicable to interim periods. However, it does not contain sufficient information to constitute an interim financial report as defined in HKFRSs.

The unaudited condensed consolidated financial statements have been prepared on the historical cost basis except for investment property, which are measured at fair values.

The adoption of the new and amendments to HKFRSs issued by the HKICPA which are applicable for the Group’s annual period beginning on 1 April 2022 has no material impact on the financial position of the Group as at 1 April 2022 and results of the Group for the nine months ended 31 December 2022.

The accounting policies and methods of computation used in the third quarterly financial information for the three months and nine months ended 31 December 2022 are the same as those applied in the preparation of the financial information of the Group for the year ended 31 March 2022 included in the annual report of the Company dated 12 August 2022.

## 3. REVENUE AND SEGMENT INFORMATION

### Revenue

Revenue represents the fair value of amounts received and receivable from the civil engineering construction services by the Group to external customers. The Group's revenue is solely derived from civil engineering construction services in Hong Kong during both periods.

(ii) *Performance obligations for contracts with customers*

The Group provides construction services to customers. Such services are recognised as a performance obligation satisfied over time as the Group creates or enhances an asset that the customer controls as the asset is created or enhanced. Revenue is recognised for these construction services based on the stage of completion of the contract using input method.

The Group's construction contracts include payment schedules which require stage payments over the construction period once certain specified milestones are reached. When the Group receives a deposit before construction commences, this will give rise to contract liabilities at the start of a contract, until the revenue recognised on the specific contract exceeds the amount of the deposit.

A contract asset, net of contract liability related to the same contract, is recognised over the period in which the construction services are performed representing the Group's right to consideration for the services performed because the rights are conditioned on the Group's future performance in achieving specified milestones. The contract assets are transferred to trade receivables when the rights become unconditional.

#### (ii) Performance obligations for contracts with customers – continued

Retention receivables, prior to expiration of defect liability period, are classified as contract assets, which ranges from one to two years from the date of the practical completion of the construction. The relevant amount of contract asset is reclassified to trade receivables when the defect liability period expires. The defect liability period serves as an assurance that the construction services performed comply with agreed upon specifications and such assurance cannot be purchased separately.

### Segment information

The executive directors of the Company, being the chief operating decision maker (“CODM”), regularly review revenue analysis by nature of business. The executive directors of the Company considered the operating activities of civil engineering construction services as a single operating segment. The operating segment has been identified on the basis of internal management reports prepared in accordance with accounting policies conform to HKFRSs, and is regularly reviewed by the CODM. The CODM reviews the overall results, assets and liabilities of the Group as a whole to make decisions about resources allocation and performance evaluation. Accordingly, no further analysis of this single operating segment is presented.

### SHARE OPTION SCHEME

The Company conditionally adopted a share option scheme (the "**Share Option Scheme**") on 24 January 2018 for the purpose of motivating the Eligible Participants (as defined below) to optimize their performance efficiency for the benefit of the Group and attracting and retaining or otherwise maintaining on-going business relationship with the Eligible Participants whose contributions are or will be beneficial to the long-term growth of the Group. "**Eligible Participants**" refer to (i) any full-time or part-time employees, executives or officers of the Company or any of its subsidiaries; or (ii) any directors (including executive, non-executive directors and independent non-executive directors) of the Company or any of its subsidiaries; or (iii) any advisers, consultants, suppliers, customers, agents and related entities to the Company or any of its subsidiaries.

The maximum number of shares of the Company (the "**Shares**") in respect of which options may be granted under the Share Option Scheme and under any other share option schemes of the Company must not in aggregate exceed 10% of the total number of Shares in issue immediately following completion of the Hong Kong public offering, being 40,000,000 Shares. The maximum number of Shares issued and to be issued upon exercise of the options granted under the Share Option Scheme to any one person (including exercised and outstanding options) in any 12-month period shall not exceed 1% of the Shares in issue from time to time.

An option may be exercised in accordance with the terms of the Share Option Scheme at any time during a period as determined by the Board and not exceeding 10 years from the date of the grant. There is no minimum period for which an option must be held before it can be exercised. However, a grantee may be required to achieve any performance targets as the Board may then specify in the grant before any options granted under the Share Option Scheme can be exercised. Upon acceptance of the option, the grantee shall pay HK\$1.00 to the Company by way of consideration for the grant. The exercise price of the options is determined by the Board in its absolute discretion and shall not be less than whichever is the highest of:

- (a) the nominal value of a Share;
- (b) the official closing price of the Shares as stated in the Stock Exchange's daily quotation sheet on the date of grant of the relevant option, which must be a day on which the Stock Exchange is open for the business of dealing in securities; and
- (c) the average of the official closing prices of the Shares as stated in the Stock Exchange's daily quotation sheet for the five business days immediately preceding the date grant of the relevant option.

The Share Option Scheme shall be valid and effective for a period of 10 years from the date of its adoption, after which no further options will be granted or offered but the provisions of the Share Option Scheme shall remain in force and effect in all other respects. All options granted prior to the termination of the Share Option Scheme and not then exercised shall continue to valid and exercisable subject to and in accordance with the Share Option Scheme.

No share options were granted, exercised, cancelled or lapsed by the Company under the Share Option Scheme during the period from 1 April 2022 to 31 December 2022 and there were no outstanding share options under the Share Option Scheme as at 31 December 2022 and up to the date of this report.

### **DIVIDENDS**

Mr. Wong Choi Chak is the chairman of the Audit Committee. The Audit Committee has reviewed the unaudited condensed consolidated financial results of the Group for the nine months ended 31 December 2022.

### **CORPORATE GOVERNANCE PRACTICES**

The Directors consider that incorporating the core elements of good corporate governance in the management structure and internal control procedures of the Group would help to balance the interest of the Shareholders, customers and employees of the Company. The Board has adopted the principles and the code provision of the Corporate Governance Code contained in Appendix 15 of the GEM Listing Rules (the “**CG Code**”) to ensure that the Group’s business activities and decision making processes are regulated in a proper and prudent manner.
