CHAIRMAN'S STATEMENT

主席報告

Dear Shareholders,

On behalf of the board of directors (the “**Board**”), I am pleased to present the annual report of Boltek Holdings Limited for the year ended 31 December 2022 (the “**Year**”).

OVERVIEW

The Company was incorporated as an exempted company with limited liability in the Cayman Islands under the Companies Law of the Cayman Islands on 18 April 2018. The address of registered office is located at Windward 3, Regatta Office Park, P.O. Box 1350, Grand Cayman KY1-1108, Cayman Islands. The principal place of business of the Company is located at 5/F, Winning Commercial Building, 46–48 Hillwood Road, Tsim Sha Tsui, Kowloon, Hong Kong.

The Company is an investment holding company. The Group is principally engaged in provision of engineering consultancy services in Hong Kong.

The Company's immediate and ultimate holding company is Waywin Investment Holding Limited (“**Waywin Investment**”), a company incorporated in the British Virgin Islands (the “**BVI**”). The ultimate controlling shareholder of the Group is Mr. Cheung Kwan Tar (“**Mr. Cheung**” or “**Controlling Shareholder**”).

The COVID-19 pandemic which began in early 2020 continued to have an impact during the financial year ended 31 December 2022. The COVID-19 pandemic has adversely impact the construction industry, which affected the negotiation of new projects and delayed the progress of existing projects of the Group. Nevertheless, the Group continued to use its best endeavor to secure the existing projects and services rendered, to maintain stable operation and to mitigate the impact of the COVID-19 pandemic. At the same time, the Group has actively negotiated and secured new projects and tenders to enhance its business performance. The Group is also looking for appropriate investment opportunities to strengthen the core business of the Group. Furthermore, the Group will focus on executing its business strategies and utilize its competitive strengths.

概覽

本公司於二零一八年四月十八日在開曼群島根據開曼群島公司法註冊成立為獲豁免有限公司。註冊辦事處地址為Windward 3, Regatta Office Park, P.O. Box 1350, Grand Cayman KY1-1108, Cayman Islands。本公司主要營業地點位於香港九龍尖沙咀山林道46–48號運通商業大廈5樓。

本公司為一家投資控股公司。本集團主要從事於香港提供工程顧問服務。

本公司的直接及最終控股公司為燊榮投資控股有限公司（「**燊榮投資**」），該公司為一家於英屬處女群島（「**英屬處女群島**」）註冊成立的公司。本集團的最終控股股東為張群達先生（「**張先生**」或「**控股股東**」）。

始於二零二零年初的COVID-19疫情於截至二零二二年十二月三十一日止財政年度持續產生影響。COVID-19疫情對建築業產生不利影響，影響本集團磋商新項目並使現有項目的進度延誤。儘管如此，本集團仍持續盡最大努力確保現有項目得以完成及提供服務，以維持穩定營運及減輕COVID-19疫情的影響。同時，本集團已積極磋商及爭取新項目及投標，以提升其業務表現。本集團亦正尋求合適的投資機會，以鞏固本集團的核心業務。此外，本集團將專注於執行其業務策略及利用其競爭優勢。

CHAIRMAN'S STATEMENT

For the Year, the Group recorded a total revenue of approximately HK\$149.3 million, representing an increase of approximately 14.9% as compared to approximately HK\$129.9 million for the year ended 31 December 2021. For the Year, the Group recorded profit attributable to equity holders of the Company of approximately HK\$20.0 million as compared to approximately HK\$20.2 million for the year ended 31 December 2021. Setting aside the COVID-19 related government subsidies, the Group's profit attributable to equity holders of the Company would have been approximately HK\$16.0 million for the Year and approximately HK\$19.9 million for the year ended 31 December 2021. The Directors are of the view that the decrease of profit attributable to equity holders of the Company was mainly due to the increase of staff cost for the Year.

PROSPECT

In view of the strong demand in the infrastructure development market and the easing of COVID-19 restrictions brought gradual relief of the economy, infrastructure developers are more actively launching new projects with aggressive financing schemes.

There has been an increasing number of project quotation invitations received by the Group from potential and current customers, and the Group has utilised the net proceeds from the Listing to expand the Group's service capacity. The Group will continue to improve our operation efficiency and profitability of our business and expand our team of professionals, which will enhance the basis of our technical capability to bid for future projects. The Group will also proactively seek opportunities to expand our customer base and our market share and undertake more building projects which will enhance value to our shareholders and stakeholders.

Based on the Group's accumulated expertise and experiences in the industry, the Directors are cautiously optimistic about the Group's business outlook.

於本年度，本集團錄得收益總額約149.3百萬港元，相當於增加約14.9%，而截至二零二一年十二月三十一日止年度約129.9百萬港元。於本年度，本集團錄得本公司權益持有人應佔溢利約20.0百萬港元，而截至二零二一年十二月三十一日止年度則約20.2百萬港元。若撇除與COVID-19相關的政府補貼，於本年度及截至二零二一年十二月三十一日止年度，本公司權益持有人應佔本集團溢利分別為約16.0百萬港元及約19.9百萬港元。董事認為，本公司權益持有人應佔溢利減少主要是由於本年度員工成本增加所致。

前景

鑒於基礎設施發展市場的強勁需求COVID-19限制的放寬使得經濟逐漸恢復，基礎設施發展商正更為有效地推出具積極融資計劃的新項目。

本集團自潛在及現有客戶接獲的項目報價邀請數目不斷增長，本集團已動用上市所得款項淨額，以擴大本集團的服務能力。本集團將繼續提升我們業務的營運效率及盈利能力並計劃擴大我們的專業人員團隊，從而提高未來項目招標技術能力的基礎。本集團亦將積極尋求機遇以擴大我們的客戶基群及市場份額，並承接更多樓宇項目，從而提高我們的股東及持份者的利益。

根據本集團於該行業累積的專業知識及經驗，董事對本集團業務前景持審慎樂觀的態度。

BUSINESS REVIEW

We are an engineering consultant in Hong Kong with a focus on the field of infrastructure developments. We have accumulated our expertise in different branches of engineering, covering (i) civil engineering mainly comprising road and structural engineering as well as geotechnical engineering; (ii) traffic engineering; and (iii) building engineering.

For the Year, the Group recorded a profit attributable to equity holders of the Company of approximately HK\$20.0 million as compared to the year ended 31 December 2021 during which the Group recorded a profit attributable to equity holders of the Company of approximately HK\$20.2 million. Setting aside the COVID-19 related government subsidies, the Group's profit attributable to equity holders of the Company would have been approximately HK\$16.0 million for the Year and approximately HK\$19.9 million for the year ended 31 December 2021. The Directors are of the view that the decrease was primarily due to the increase in staff cost.

OUTLOOK

The Group always strives to improve our operation efficiency and profitability of our business. The Group will also proactively seek opportunities to expand our customer base and our market share and undertake more projects which will enhance value to our shareholders.

FINANCIAL REVIEW

Revenue

Our revenue increased to approximately HK\$149.3 million for the Year by approximately HK\$19.4 million or 14.9%, from approximately HK\$129.9 million for the year ended 31 December 2021. This was principally due to an increase in projects awarded during the Year.

Cost of services

Our cost of services increased to approximately HK\$105.1 million for the Year by approximately HK\$20.7 million or 24.5%, from approximately HK\$84.5 million for the year ended 31 December 2021. The increase in costs was principally due to the increase in the salary and bonus of technical staff to motivate and retain our technical staff and the increase in number of technical staff.

Gross profit

During the Year, our Group's gross profit decreased to approximately HK\$44.2 million by approximately HK\$1.3 million or 2.8%, from approximately HK\$45.4 million for the year ended 31 December 2021. The decrease was mainly due to the increase in technical staff cost.

Other income and other gain

Other income and gain increased by approximately HK\$4.8 million or 384.3% from approximately HK\$1.3 million for the year ended 31 December 2021 to approximately HK\$6.1 million for the Year. The increase was mainly due to increase in the government subsidies in respect of COVID-19 in relation to the Employment Support Scheme provided by the Hong Kong government received, which amounted to approximately HK\$4.0 million for the Year and approximately HK\$0.4 million for the year ended 31 December 2021.

Administrative expenses (including reversal/(provision) of expected credit loss allowance)

Our administrative expenses (including reversal/(provision) of expected credit loss allowance) increased to approximately HK\$27.1 million for the Year, by approximately HK\$4.3 million or 18.9%, from approximately HK\$22.8 million for the year ended 31 December 2021. The increase was mainly due to increase in staff cost and staff benefit for the Year.

Income tax expense

Income tax expense decreased by approximately HK\$0.5 million or 13.9% from approximately HK\$3.6 million for the year ended 31 December 2021 to approximately HK\$3.1 million for the Year, the decrease was mainly due to the decrease in taxable profit for the Year.

To manage liquidity risk, the Board closely monitors the Group's liquidity position to ensure that the liquidity structure of the Group's assets, liabilities and other commitments can meet its funding requirements from time to time.

As at 31 December 2022, the Group did not have any contingent liabilities (2021: nil).

The Board of Directors (the “**Board**”) is the governing body ultimately responsible for the Group’s ESG strategy, management and reporting governance. With the help from the Group’s operating departments, the Board regularly identifies and manages ESG related risks and opportunities, and sets ESG strategy and objectives.

Apart from providing and analysing ESG data, department heads from the Group’s operating departments also assist in formulating relevant strategies in their respective working areas and ensure the effectiveness of policy implementation in line with those strategies and objectives endorsed by the Board. There are regular meetings between the Board and the operating department heads to discuss the ESG related issues, to review the process and implementation method of policy and evaluate the ESG-related risk, targets and strategy towards the Group. The purpose of the meetings is to provide ongoing monitoring of ESG work process and ensure the ESG strategy and objectives be consistent with business goals and meet legal requirement and stakeholders’ expectation. All ESG-related disclosure, policies, goals and targets are reviewed and endorsed by the Board, which is also tasked with ensuring the implementation and effectiveness of the risk management and internal control systems.

Emissions

To protect the environment, the Group strives to take action to reduce carbon footprint, by minimising air and greenhouse gas (“GHG”) emissions, and non-hazardous waste generation.

As a provider of engineering consultancy service, we do not produce significant amount of emission and waste. The main source of air pollutants emitted from the Group is carbon emissions resulting from the consumption of unleaded petrol, electricity and paper. Throughout the year, we used unleaded petrol for all motor vehicles. This promotes energy efficiency and provides better fuel economy.

Although emissions produced by the Group only has an insignificant impact on the environment, we are still committed to taking effective measures to promote environmental protection and the sustainable development of society, in accordance with the relevant emission laws and regulations.

Same as previous year, we maintained minimum usage of motor vehicles and electricity. We encouraged employees to travel by public transportation, which is still effective during the Year. The consumption of electricity was slightly increased due to the expansion of office area as the Group would like to uplift the quality of our working environment for employees. We have also maintained zero business air travel by encouraging staff to make use of video conferencing facilities to decrease carbon emissions arising from unnecessary business trips. Therefore, no such KPI was disclosed during the Year.

For the Year, the Group did not receive any notice of non-compliance in relation to air or GHG emissions, discharges into water and land, and generation of hazardous and non-hazardous wastes including but not limited to, such as the Air Pollution Control Ordinance (Cap. 311) and Waste Disposal Ordinance (Cap. 354).

The Group will seek to reduce GHG emissions intensity by 2% in year 2026 compared to the baseline of year 2021, by replacing the vehicles with hybrid cars in the near future.

Reducing Waste and Promoting Recycling

During the Year, we did not produce hazardous waste in our business operation. Non-hazardous waste generated by the Group is mostly paper waste. We accumulated 4.47 tonnes (2021: 5.28 tonnes) wasted paper during the Year. Except for paper containing confidential and sensitive information, we encouraged staff to use recycled paper for internal documents or drafts before it is disposed of. Although paper waste does not directly produce any hazardous substance, it can generate CO₂ indirectly when being disposed of, resulting in adverse impacts on the environment such as global warming.

如同去年，我們維持機動車輛及電力的最低使用量。我們鼓勵僱員乘坐公共交通出行，本年度仍然實行。由於本集團有意提升僱員的工作環境質量，用電量因擴大辦公面積而略有增加。我們亦通過鼓勵員工使用視頻會議設施減少不必要的商務旅行產生的碳排放，從而保持零空中商務旅行。因此，本年度並無披露相關關鍵績效指標。

於本年度，本集團並無接獲任何有關廢氣或溫室氣體排放、排放入水及土地、產生有害及無害廢物等（包括但不限於空氣污染管制條例（第311章）及廢物處置條例（第354章））的不合規通知。

本集團將尋求通過在不久的未來將車輛更換為混合動力汽車，於二零二六年將溫室氣體排放密度較二零二一年的基準降低2%。

減少廢棄物及促進回收利用

本年度，我們並無於業務營運中產生有害廢物。本集團產生的無害廢物主要為廢紙。本年度，我們累積4.47噸（二零二一年：5.28噸）的廢紙。除含有機密及敏感資料的紙張外，我們鼓勵員工在處理之前就內部文件或草稿使用再生紙。儘管廢紙並無直接產生任何有害物質，但處理廢紙會間接產生二氧化碳，從而對環境造成不利影響（例如全球變暖）。

We required employees to actively implement the Group's environmental protection measures such as using duplex printing as the default mode on all printers and using electronic means instead of printed version for internal communication purposes. We have placed a box next to all printers for collecting scrap paper to reduce unnecessary paper waste.

As the Company is already consuming as minimum paper as we can and avoids unnecessary paper waste, we considered that setting a waste reduction target is not meaningful to us.

Use of Resources

The major direct sources of energy consumption are use of electric equipment and lighting in offices. To build an environmentally-friendly working environment, we have familiarised our staff with green policy to raise their awareness of environmental protection, and set up energy-efficient practices to fully utilise resources and reduce energy consumption in our head office.

Energy Saving

The facilities that cause electricity consumption include lighting, air-conditioners, printers and computers. We have instructed our staff to switch off all the electronic devices when they leave office or when the devices are idle. Also, our office temperature is set at an environmentally-friendly level of around 25°C.

The increase of energy consumption during the Year is attributable to the expansion of office area, the purpose of which is to provide a better working environment to staff. In the future, we will make continuous efforts to fulfill the target of reducing the electricity usage intensity to around 900kWh per staff member in the coming year, maintaining the energy in minimum usage by using energy-saving lightings and electric appliance wherever feasible.

我們要求僱員積極執行本集團的環保措施，例如在所有打印機上使用雙面打印作為默認模式並使用電子方式代替印刷版本作內部溝通用途。我們在所有打印機旁放置紙盒，用於收集碎紙，以減少不必要的紙張浪費。

由於本公司已盡量減少用紙及避免不必要的紙張浪費，我們認為設定減少廢棄物的目標對我們而言並無意義。

資源使用

能源消耗的主要直接來源主要為使用電氣設備及辦公室照明。為營造環保的工作環境，我們向員工宣傳環保政策以增強其環保意識，同時制定節能措施以充分利用資源以減少總公司的能耗。

節能

造成電力消耗的設施包括照明、空調、打印機及電腦。我們要求我們的員工在離開辦公室或設備空閒時關閉所有電子設備。此外，我們的辦公室溫度設定在25°C左右的環保水平。

本年度能源消耗的增加，乃由於擴大辦公面積，目的是為員工提供更佳的工作環境。今後，我們將繼續努力，在可行的情況下，通過使用節能燈具及電器，在來年實現人均用電密度降至900千瓦時左右的目標，維持能源最低用量。

Water Management

Providing engineering consultancy services to the government and contractors does not involve any water resource consumption. Our main use of water is for sanitary purpose at certain areas in our head office. The remaining usage of water in our back office was supplied and recorded by our office property management company. We did not encounter any significant issue in sourcing water that is fit for purpose. The Group will continue to maintain low consumption and avoid unnecessary water consumption during routine operations by, for example, turning taps off tightly to avoid dripping and posting water-saving messages to remind employees of the importance of water conservation. Hence, the target for water efficiency reduction is not applicable to us.

We raise employees' awareness of environmental issues by providing them with practical tips and guidelines in order to reduce energy consumption and GHG emissions and minimise environmental impact. The Group regularly assesses the environmental risks generated from our operation, and adopts appropriate preventive measures to reduce such risks. We review the related laws and regulation from time to time to ensure that the Group is in compliance with them.

Climate Change

Climate change has become a growing public concern in recent years as it affects all things around us such as health, safety, economy and working condition. The Group has reviewed the current business operation and identified the potential risk and mitigation measures as follows.

Extreme weather conditions are getting more serious under climate change. Acute physical risks such as tropical cyclones, rainstorms, flooding, heat waves may affect our operation. Although most of our work is performed indoors, it would affect our site visit work and cause safety risks to our employees on their way travelling to work. To mitigate the risk, we set out a policy regarding working arrangements under extreme weather conditions such as black rainstorm warning, flooding and typhoon signal No. 8. Employees are only required to report for duty when the working environment is safe.

In the long run, climate-related regulations may stricter, and there may be changes in customer preferences which may, in turn, transfer the risk to us. In the face of tightening climate-related regulations, the Group needs to spend more in operations to maintain the emission or waste level or follow the regulated environmental practices for compliance purposes. Customers may consider more issues, including environmental protection, impacts on the environment and even changes in their preferences, before entering into business engagement. As a precautionary measure for this, we need to regularly perform risk analysis to determine the impacts of climate change on our operations, and the likelihood that such impacts would occur. Although no material impact is expected against the Group in the near future, we continue to monitor the regulatory market to ensure that our services comply with the regulatory requirements.

氣候變化

近年來，氣候變化已成為公眾日益關注的問題，原因是其影響我們周圍的一切，如健康、安全、經濟及工作條件。本集團已檢討目前的業務營運並識別潛在的風險及緩解措施如下。

在氣候變化下極端天氣條件變得愈發嚴重。熱帶氣旋、暴雨、洪水、熱浪等嚴重物理風險可能會影響我們的營運。儘管我們的大部分工作均在室內進行，但會影響我們的實地視察工作並對我們的僱員在上班途中造成安全風險。為減低風險，我們指定有關在極端天氣情況下(如黑色暴雨警告、洪水及八號颱風訊號)的工作安排的政策。僱員僅須在工作環境安全時才出勤。

從長遠來看，與氣候相關的法規可能會更加嚴格，客戶偏好可能會發生變化，這反而可能會將風險轉嫁予我們。面對日益嚴格的氣候相關法規，本集團需在營運方面投入更多資金以維持排放或廢棄物水平，或為合規目的遵守受監管環境慣例。客戶在參與商業活動之前，可能會考慮諸多問題，包括環境保護、對環境的影響甚至彼等偏好變化。作為預防措施，我們需定期進行風險分析，以確定氣候變化對我們業務的影響，以及發生有關影響的可能性。儘管預期在不久的將來不會對本集團造成重大影響，我們會繼續監察監管市場，以確保我們的服務符合監管要求。

EMPLOYMENT & LABOUR PRACTICES

Employment

The Group recognises that employees are a valuable asset and that we owe a lot of our success to our employees especially our in-house engineers. We have developed a comprehensive human resources framework for compensation, recruitment, appraisal, dismissal, welfare, training and development. We advocate a community spirit that thrives on mutual respect and equality, through compliance with equal opportunities legislation, such as the Sex Discrimination Ordinance, Race Discrimination Ordinance, Disability Discrimination Ordinance and Family Status Discrimination Ordinance.

To ensure diversity and equality, we have set up a fair recruitment policy for selecting suitable candidates. We assess a job applicant solely based on his/her performance, experience, qualification and skills. Candidates are considered regardless of their gender, age, race, family status, religion or disability. No tolerance has been given to child or forced labour. Instances of child labour are screened out during the formal recruitment process. In case of any child labour, forced labour or irregularities in violation of labour standards, the employment relationship will be terminated. Further investigation will be carried out to revisit the recruitment procedure and rectify "weak spots". During the Year, the Group did not have any non-compliance relating to child or forced labour prevention.

To attract more talent and retain existing employees, we take a comprehensive approach in recruitment, employment and promotion with attractive remuneration packages and benefits offered for our employees. The Group provides equal opportunities to all employees for promotion and career development. Appraisals are performed annually for employees, with appropriate salary adjustments and promotions. Employees are encouraged to express their opinions, concerns and discuss area for improvement in work process with their supervisors or the management. The Group works hard to instill a sense of unity, in case of any types of discrimination in the workplace found, we require employees to report such cases to us, and the Group will conduct investigations promptly and take follow up measures.

本集團意識到僱員為寶貴的資產，我們的成功主要歸功於僱員，尤其是我們內部的工程師。我們就薪酬、招聘、評估、解僱、福利、培訓及發展制定全面的人力資源框架。我們提倡互相尊重及平等機會的群體精神，亦遵守有關平等機會的法律，如《性別歧視條例》、《種族歧視條例》、《殘疾歧視條例》及《家庭崗位歧視條例》。

為確保多元化及平等，我們制定了招聘合適候選人的公平招聘政策。我們將完全基於職位申請人士的表現、經驗、資歷及技能對彼等進行評估。求職者不論其性別、年齡、種族、家庭狀況、宗教信仰或殘疾情況，均予以考慮。無法容忍童工或強迫勞動。於正式招聘過程中，會篩選出童工的情況。如有童工、強迫勞動或違反勞動標準的違規行為，將終止僱傭關係。開展進一步排查，重新審視招聘程式並整改「薄弱環節」。本年度，本集團在防止童工或強迫勞動方面並無任何違規情況。

為吸引更多的人才及留住現有員工，我們在招聘、僱傭及晉升方面採用綜合制度，為僱員提供具吸引力的薪酬待遇及福利。本集團為所有僱員提供晉升及職業發展的平等機會。我們每年會對員工的工作表現進行評估，而通過評估進行適當的薪資調整及晉升。鼓勵員工發表意見、所關注的問題並與彼等的主管或管理層討論工作過程中需要改進的地方。本集團努力灌輸團結意識，倘在工作場所發現任何形式的歧視，我們要求僱員向我們報告，本集團將迅速進行調查並採取後續措施。

A comprehensive framework illustrating detailed human resource management policies is included in our staff handbook. The staff handbook is updated when necessary so that employees are aware of the policies and procedures of the Group as well as the guidelines on promotion, compensation and dismissal, appraisal, training and other benefits etc. To nurturing new-generation professionals, we have an internship program for university students to train new talents for both the Group and the construction industry. The program offers university students full-time training during their summer vacation, helping them to obtain valuable work experience before they enter the labour market.

All dismissal and termination of employment are only done with lawful ground, and unfair or discriminated dismissal is prohibited. For the Year, to the best of the Group's knowledge, we did not have any instance of non-compliance in relation to compensation and dismissal, recruitment and promotion, working hours, rest periods, equal opportunities, diversity, antidiscrimination and other benefits and welfare.

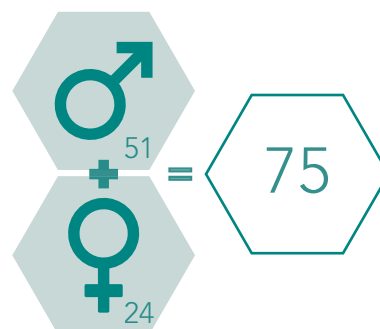
The Group strictly follows labour laws and regulations and provides a comprehensive package to employees, which offers various types of leaves to employees such as sick, marriage, bereavement and maternity leaves, in addition to statutory holidays. Threatened by the Covid-19 pandemic in recent years, employees were entitled to a day of vaccination leave allowing them the time to recuperate after vaccination, with the aim of promoting staff wellbeing and raise the sense of belonging among employees.

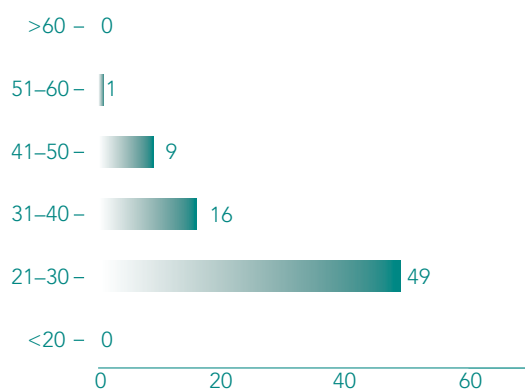

In the past several years, to reduce virus transmission risk, the Group sacrificed lunch gatherings at different festivals for staff. After the lifting of social distancing measures announced by the government at the end of this Year, the Group is pleased to resume staff gatherings in the coming year.

Apart from the statutory retirement contribution scheme, the Group has provided medical insurance with coverage to employees. To encourage employee self-development and pursuit of work-related professionalism, the Group offers education allowances for work-related training and allowance for job-related membership registration such as The Hong Kong Institution of Engineers ("HKIE").

Health and Safety

Given the nature of consultancy services, our business does not pose significant threats to employees' health or safety. However, we still took the initiative to ensure that all employees are aware of occupational health and safety issues, and encourage them to participate in job-related safety training courses provided by organisations such as the HKIE.

The Group implemented the following measures to fight against the pandemic in our offices:

- Requiring staff to adhere to the Group's office hygiene requirements including wearing face masks and washing their hands frequently;
- Temperature taking is required before access into the Group's premises; and
- Providing face masks and disinfectant products at the head office for use by staff;

Office air quality is regularly monitored by air purifiers, and the air-conditioning system is cleaned periodically. First aid boxes were made available at easily accessible locations in offices for staff emergency use. Minor injuries were properly treated at request. We encourage balanced lifestyle to maintain employee personal growth, health and wellbeing.

There were neither work injury cases nor job-related fatality in the previous three years. The Group did not receive any notice of non-compliance in relation to providing a safe working environment and protecting employees from occupational hazards during the Year.

過往數年，為降低病毒傳播風險，本集團犧牲員工在不同節日的午餐聚會。在政府於本年度年底宣佈取消社交距離措施後，本集團很高興在來年恢復員工集會。

除法定退休供款計劃外，本集團亦為僱員提供醫療保險。為鼓勵員工自我發展及追求與工作相關的專業精神，本集團為工作相關培訓提供教育津貼及與工作有關的會籍註冊津貼（例如香港工程師學會（「HKIE」））。

健康與安全

鑒於顧問服務的性質，我們的業務不會對員工的健康或安全構成重大威脅。然而，我們仍然主動確保全體僱員了解職業健康與安全問題，並鼓勵彼等參加由香港工程師學會等組織提供的與工作有關的安全培訓課程。

本集團於辦公室採取以下防疫措施：

- 要求員工遵守本集團的辦公室衛生要求，包括佩戴口罩及頻密洗手；
- 在進入本集團物業前需要量度體溫；及

Development and Training

In view of the nature of our business, human capital is treated as one of the most vital elements for the Group's long-term development. The Group offers an induction course for new staff members to familiarise them with the Group's values and code, and to ensure a smooth job onboarding process. The supervisor is responsible to provide on-job training to their sub-ordinates from time to time. Further, every year the Group would launch a variety of training programs to assist staff members in getting the latest news and knowledge about their profession. Our in-house training covers a wide range of subjects ranging from safety, communicating with stakeholders to our operations, and technical training (e.g. structures, waterworks, roadworks, site formation, traffic and geotechnical work).

We also encourage our staff to join job-related training provided by external associations: for example, the safety training course and geotechnical workshop provided by HKIE during the Year. To motivate self-reliant learning and development among employees, we offer them training sponsorships granted for courses considered relevant to their job duties.

During the year, 54% of permanent employees participated in training of 1.82 hours on average. By gender, 54% for male employees and 53% for female employees, with average training duration at 3.5 hours and 3 hours, respectively.

By career level, percentages of permanent employees participated in training for senior-, middle- and entry-level staff were 27%, 36% and 74% respectively. The average durations of training activities for each of these participated employee categories were 1.5 hour, 3.8 hours and 3.4 hours respectively.

發展及培訓

鑒於我們的業務性質，人力資本被視為本集團長遠發展的最重要因素之一。本集團為新員工提供入職課程，以讓彼等熟悉本集團的價值觀及守則以及確保彼等順利入職。主管負責不定期為下屬提供在職培訓。此外，本集團每年為員工推出各種培訓計劃，協助員工獲取有關其專業的最新資訊及知識。我們的內部培訓議題涵蓋廣泛，覆蓋安全、就我們的營運與利益相關方溝通及技術培訓（例如結構、水務工程、道路工程、場地平整、交通及岩土工程）。

我們亦鼓勵員工參加外部協會提供的與工作有關的培訓，例如香港工程師學會於年內提供的安全培訓課程及岩土工程研討會。為鼓勵僱員之間自主學習及發展，我們提供針對與彼等的工作職責相關課程的培訓贊助。

本年度，54%的長期僱員平均參加1.82小時的培訓。按性別劃分，男性僱員佔54%及女性僱員佔53%，平均培訓時長分別約為3.5小時及3小時。

按職業水平劃分，參加培訓的長期僱員中高級、中級及初級員工的佔比分別為27%、36%及74%。各僱員類別的平均培訓活動時長分別為1.5小時、3.8小時及3.4小時。

Supply Chain Management

The Group's suppliers mainly comprise subcontractors which are indispensable to our business and operations, contributing significantly to our success in the pursuit of quality excellence and crucial in enhancing our brand reputation. During the Year, there were 40 (2021: 37) subcontractors in our supply chain, over 99% (2021: all) of our suppliers and subcontractors were from Hong Kong. Most of the subcontractors provide engineering consultancy services to the Group, the remaining suppliers were responsible for our administrative supplies.

We have developed a fair and equal suppliers selection procedure. We generally select suppliers based on their expertise, qualification, scale of business, commitment to the Group and reputation. Before engaging a new subcontractor, the Group conducts background search from available sources and assessment to acquire an understanding of the supplier, with performance appraisal conducted. Suppliers and subcontractors who were previously found in violation of environmental and social related laws and regulations cannot be engaged, unless sufficient and supportive evidence show that such weaknesses has been rectified. We expect all suppliers and subcontractors to fulfil the standards of the terms of environment, quality, society, and commercial ethnics. Preference is given to those undertaking to follow our requirements and related environmental and social laws and regulation. Suppliers and subcontractors are selected for all procurement and subcontracted operations from the approved supplier and subcontractor list.

We monitor our subcontractors' performance through occasional meetings and daily deliverables (e.g. works done report). Reports received from site offices can also help us assess their work performance. Suppliers are monitored in routine service provided and goods delivered. In case any delivered services/goods found to be sub-par quality, they will be improved. Any goods procured with accreditation will be required to provide corresponding certification documents. The Group may impose penalties or terminate contracts with those suppliers and subcontractors who are involved in serious environmental pollution or social disputes such as human rights issues.

供應鏈管理

本集團的供應商主要包括分包商，分包商對我們的業務及運營不可或缺，為我們成功追求卓越品質作出重大貢獻，亦對提升我們的品牌聲譽至關重要。於本年度，我們的供應鏈有40名分包商（2021年：37名），超過99%（2021年：全部）的供應商及分包商來自香港。大部分分包商為本集團提供工程顧問服務，餘下供應商負責我們的行政用品。

我們已制定公平、平等的供應商選擇程序。我們通常根據供應商的專業知識、資質、業務規模、對本集團的承諾及聲譽選擇供應商。在聘用新的分包商之前，本集團從可得資料來源進行背景調查及評估，以了解供應商，並進行業績評估。倘供應商及分包商先前被發現違反環境和社會相關法律法規，則不得被聘用，除非有充分及支持性證據證明有關缺陷已得到糾正。我們期望所有供應商及分包商符合環境、質量、社會和商業道德方面的標準。優先考慮承諾遵守我們的要求以及相關的環境和社會法律法規的供應商。從批准的供應商和分包商名單中為所有採購和分包作業選擇供應商和分包商。

我們通過不定期的會議及日常交付（例如完工報告）監察分包商的表現。從現場辦公室收到的報告亦可幫助我們評估彼等的工作表現。供應商在提供日常服務和交付貨物方面受到監督。如發現任何交付的服務／商品質量低於標準，將予以改進。通過認證採購的任何貨物均需要提供相應的認證文件。本集團可對涉及嚴重環境污染或社會糾紛（如人權問題）的供應商及分包商實施處罰或終止合同。

Service Responsibility

Service quality is a key factor in our business operations and reputation. We maintain high standard of ethics and corporate governance in our business. Our compliance manual sets out standards covering a range of ethical issues, including anti-corruption, anti-bribery, anti-discrimination, privacy protection and data protection. Our internal control manual also sets out the operation procedures for daily work to ensure all works performed are properly reviewed and meet customers' required standard.

A complaint-handling policy has been set up as a guideline for dealing with complaints. Hotline and email address are posted on the Group's website for public consultation regarding the services we provide and the projects we are carrying out. All information published on the Group's website were carefully examined by responsible personnel. We keep an open mind in dealing with all complaints and, where a complaint is justified, ensure the resolution comes to the satisfaction of the complainant. The Group has obtained ISO9001:2015 certification in recognition of its provision of high standard quality management in the provision of engineering consultancy services.

As regards customer data privacy, the Group come across sensitive information of customers typically during the tendering stage. To obtain the consent of our customers in providing data to us, an agreement over information confidentiality is signed and appended to each contract. The agreement informs customers of our purposes of collecting their information and that the Group would restrict the use of the information to the said purposes, and would not disclose the sensitive information to any third party without the customers' consent. Additionally, a whistleblowing policy has been established, encouraging employees to raise concerns, in a confidential manner, about misconduct, malpractice or irregularities in any matters related to the Group. This can help maintain a high standard of integrity, openness, probity and accountability within the Group. In sum, the Group did not receive any complaint during the Year.

服務責任

服務質量是我們業務運營及聲譽的要素。我們在業務中維持高標準的道德和企業管治。我們的合規手冊載列涵蓋一系列道德問題的標準，包括反腐敗、反賄賂、反歧視、隱私保護和數據保護。我們的內部控制手冊亦規定日常工作的操作程序，以確保所有執行的工作均經過適當審查，並符合客戶要求的標準。

我們已制訂投訴處理政策，作為我們處理投訴的指引。本集團的網站上亦公佈熱線及電郵地址，供公眾就我們提供的服務及正在進行的項目來電諮詢。本集團網站上發佈的所有資料均由負責人員仔細審查。我們均持開放態度處理所有投訴，及倘投訴有理據，將確保解決方案能令投訴人滿意。本集團已獲得ISO9001:2015認證，以認可在提供工程顧問服務方面提供高標準的質量管理。

就客戶數據隱私而言，本集團通常會在投標階段遇到客戶的敏感資料。為取得客戶同意向我們提供數據，每份合約附有一份已簽署的有關資料保密的協議。該協議告知客戶我們收集其資料的目的，而本集團將僅就上述目的使用該資料，且未經客戶同意不會向任何第三方披露敏感資料。此外，我們亦已制定舉報政策，鼓勵僱員在保密情況下就任何與本集團有關的事宜反映彼等對不當行為、舞弊或違規行為的關注。此舉可維持本集團內部高水平的誠信、公開、廉潔及問責標準。總括而言，本集團於本年度並無接獲任何投訴。

The Group is committed to protecting intellectual rights. We protect intellectual property rights by purchasing from authorised suppliers to ensure that only licensed software is used for our business operations. In addition, we required all staff members not to infringe any third-party interests.

During the Year, the Group did not note any cases of non-compliance with laws and regulations relating to health and safety, advertising, labelling and privacy matters relating to the services provided.

Anti-corruption

To maintain a high standard of integrity, openness, probity and accountability, we comply strictly with the anti-corruption policy. Our internal control manual and compliance manual cover related matters such as conflicts of interest, privacy and confidentiality of information and prevention of bribery. The whistleblowing policy has also been applied to all employees and related third parties with business dealings with the Group, whereby they can report any misconduct, fraud or irregularities. The reported cases will be investigated with strict confidentiality under any circumstances to keep anonymity. During the Year, all newly recruited staff are briefed with the anti-corruption policy during induction training. The Group refreshes existing staff's and director's understanding of these anti-corruption principles regularly by circulating the anti-corruption training materials issued by Independent Commission Against Corruption ("ICAC").

All employees at the senior management level are required to enter into a confidentiality agreement and declaration of conflict of interest, to affirm the best interests of the Group. As at 31 December 2022, there were no legal cases or non-compliance with relevant laws and regulations relating to bribery, extortion, fraud and money laundering practices brought against the Group or the employees.

反貪污

為維持高標準的誠信、開放、廉潔及問責，我們嚴格遵守反貪污政策。我們的內部控制手冊及合規手冊均涵蓋有關利益衝突、隱私及資料保密以及防止賄賂方面的說明。全體僱員及與本集團有業務往來的相關第三方均可採用舉報政策，以舉報任何不當行為、欺詐或違規行為。舉報的案件在任何情況下進行嚴格保密調查，以保持匿名。於本年度，所有新入職員工均會在入職培訓中獲簡報反貪政策。本集團透過定期傳閱由廉政公署（「廉政公署」）刊發的反貪污培訓材料，更新現有員工及董事對該等反貪原則的理解。

就高級管理層級別的所有僱員而言，彼等均須訂立保密協議及利益衝突聲明書，以確認本集團的最佳利益。於二零二二年十二月三十一日，概無對針對本集團或員工的與賄賂、勒索、欺詐及洗錢行為相關的法律案件或不遵守相關法律法規。

COMMUNITY INVOLVEMENT

The Group is committed to being a socially responsible corporate citizen, through deep involvement in the community, giving back to society and creating shared benefits for the communities we serve.

To bring love and joy to the community, we made a money donation to The Salvation Army in the Year to support the event named Mid-Autumn Festival Appeal 2022. The donation was used to give out food, resources and mooncakes to people in need.

Children are vulnerable and are the future of community. We made a money donation to the Lifewire Run 2022 which was organised by Lifewire, a registered charitable organization in Hong Kong. Lifewire is a Hong Kong crowdfunding platform provider that specialises in helping children with medical needs by raising donations from the public. The proceeds help the registered charitable organizations pay for medical treatments for children in need, or support community projects that are related to improvement of the wellbeing of children. In addition, we also donated to Children's Cancer Foundation, which is a well-known charitable organisation dedicated to improving the quality of life for young cancer patients and their families and to helping doctors improve the survival rate of children with cancer.

However, we knew of accident involving work-related fatalities during the Year and lent a helping hand to the bereaved family in the difficult time via money donations. The donations were either given to the bereaved family directly or collected by the Construction Charity Fund and transferred to the bereaved families.

MOVING FORWARD

While striving to expand our business, we will remain committed to environmental protection, and control of emissions, energy consumption and paper waste during our routine operations, to pave the way for sustainable development. To reach a higher standard of CSR, we will continue to support the public by various means of social participation and contributions to create long-term value for the community.

為給社區帶來愛和歡樂，我們於本年度向救世軍捐款，以支持心好月圓中秋行動2022。該捐款用於向有需要的人分發食物、資源及月餅。

兒童是脆弱的群體，也是社區的未來。我們向由香港註冊慈善組織 Lifewire 組織的「愛跑•東涌呀」(Lifewire Run 2022) 捐款。Lifewire 是一家香港眾籌平台提供商，專門通過向公眾募捐來幫助有醫療需求的兒童。有關所得款項幫助註冊的慈善組織為有需要的兒童支付醫療費用，或支持與改善兒童福祉有關的社區專案。此外，我們亦向兒童癌症基金會捐款，該基金會為著名的慈善組織，致力於改善年輕癌症患者及其家人的生活品質，並幫助醫生提高癌症兒童的存活率。

在努力拓展業務的同時，我們仍致力於環境保護，通過控制日常運營中的排放、能源消耗及紙張浪費，為可持續發展奠定基礎。為提升企業社會責任標準，我們將繼續透過各種社會參與及貢獻的方式支持公眾，為社會創造長期價值。

CORPORATE GOVERNANCE PRACTICES

The Company recognises the importance of corporate transparency and accountability. The Company is committed to achieving and maintaining a high standard of corporate governance, as our Board believes that good and effective corporate governance practices are key to obtaining and maintaining the trust of the shareholders of the Company and other stakeholders, and are essential for encouraging accountability and transparency so as to sustain the success of the Group and to create long-term value for the shareholders of the Company.

The Company's corporate governance practices are based on the Corporate Governance Code (the "CG Code") contained in Appendix 15 of the GEM Listing Rules. To the best knowledge of the Board, except as disclosed herein the Company has complied with the CG Code during the Year and up to the date of this annual report.

DIRECTORS' SECURITIES TRANSACTIONS

The Company has adopted Rules 5.48 to 5.67 of the GEM Listing Rules as the code of conduct regarding directors' securities transactions by Directors in respect of the shares of the Company (the "Code of Conduct"). After specific enquires by the Company, all Directors have confirmed that they have fully complied with the required standard of dealings set out in the Code of Conduct during the Year.

BOARD OF DIRECTORS

The Company is headed by an effective Board which assumes responsibility for its leadership and control and is collectively responsible for promoting the Company's success by directing and supervising its affairs. Directors make decisions objectively in the best interests of the Company. The Board meets regularly and Board meetings are held four times a year at quarterly intervals.

CHAIRMAN AND CHIEF EXECUTIVE

Mr. Cheung Kwan Tar currently assumes the role of both chairman of the Board and chief executive officer of the Company. The Board considers that both roles being held by Mr. Cheung will provide a strong and consistent leadership to the Company which will facilitate effective planning and efficient management of the Company. Furthermore, having considered Mr. Cheung's extensive experience in the engineering industry, the relationships Mr. Cheung has built with customers and the historical development of the Group, the Board considers that it is beneficial for the Group to have Mr. Cheung continue to act as both chairman and chief executive officer of the Company. In order to maintain good corporate governance and fully comply with the code provision A.2.1 of the CG Code, the Board will regularly review the need to appoint different individuals to perform the roles of chairman and chief executive officer separately.

BOARD COMPOSITION

The Company is committed to the view that the Board should include a balanced composition of executive and non-executive Directors (including independent non-executive Directors) so that there is an independent element on the Board, which can effectively exercise independent judgement, and that non-executive Directors should be of sufficient calibre and number for their views to carry weight.

The Company has received from each independent non-executive Director an annual confirmation of his independence, and the Company considers such independent non-executive Director to be independent in accordance with the guidelines set out in Rule 5.09 of the GEM Listing Rules.

Appropriate insurance coverage in respect of legal action against the Company's Directors has been arranged by the Company.

APPOINTMENTS, RE-ELECTION AND REMOVAL

In accordance with the Articles, all the Directors are subject to retirement by rotation at least once every three years. Any new Director appointed by the Board (i) to fill a casual vacancy in the Board shall hold office only until the first general meeting of the Company following his/her appointment and shall be subject to re-election at such meeting; and (ii) as an addition to the Board shall hold office until the next following annual general meeting of the Company ("**AGM**") and shall then be eligible for re-election.

The Board is regularly provided with management update report to give a balanced and understandable assessment of the performance, position, development and prospects of the Company in sufficient detail.

The Board is also responsible for the corporate governance functions of the Group, which includes:

- To develop and review the Group's policies and practices on corporate governance;
- To review and monitor the training and continuous professional development of Directors and senior management;
- To review and monitor the Group's policies and practices on compliance with legal and regulatory requirements;
- To develop, review and monitor the code of conduct and compliance manual applicable to employees and Directors; and
- To review the Group's compliance with the CG Code and disclosure in the corporate governance report.

During the Year, the Board had reviewed and discussed the corporate governance policy of the Group and was satisfied with the effectiveness of the corporate governance policy of the Group.

The Group established the Audit Committee on 20 August 2018 with written terms of reference in compliance with Rule 5.29 of the GEM Listing Rules and paragraph C.3.3 of the CG Code. The primary duties of our Audit Committee include, among others, (a) making recommendations to our Board on the appointment, re-appointment and removal of the external auditor and approving the remuneration and terms of engagement of the external auditor; (b) reviewing our financial statements, our periodic reports and accounts and significant financial reporting judgements contained therein; and (c) reviewing our financial controls, internal control and risk management systems. Our Audit Committee comprises three independent non-executive Directors, namely Ms. Chik Wai Chun, Mr. Chan Yu Sum Sam and Mr. Chan Kai Kow Mackson. Ms. Chik Wai Chun is the chairlady of our Audit Committee.

During the Year, the Audit Committee held 4 meetings, at which it has reviewed and discussed the Company's audited consolidated financial results for the year ended 31 December 2021 and the unaudited consolidated financial results for the quarterly period ended 31 March 2022, and 30 September 2022 and the interim period ended 30 June 2022 including the accounting principles and practice adopted by the Group, the Company's compliance with the CG Code and disclosure in this Corporate Governance Report, the effectiveness of the Group's risk management and internal control systems as well as the Group's internal audit function. The Audit Committee has also recommended to the Board to consider the re-appointment of Grant Thornton Hong Kong Limited ("**Grant Thornton**") as the Company's external independent auditors at the AGM held on 6 May 2022.

The primary duties of our Nomination Committee include, among others, (a) reviewing the structure, size and composition (including the skills, knowledge and experience) of our Board at least annually and making recommendations on any proposed changes to our Board to complement our corporate strategy; (b) identifying individuals suitably qualified to become members of our Board and selecting or making recommendations to our Board on the selection of individuals nominated for directorships; (c) assessing the independence of our independent non-executive Directors; and (d) making recommendations to our Board on the appointment and succession planning for our Directors. Our Nomination Committee comprises two independent non-executive Directors, namely Mr. Chan Yu Sum Sam and Mr. Chan Kai Kow Mackson, and one executive Director, namely Mr. Cheung Kwan Tar. Mr. Cheung is the chairman of our Nomination Committee.

The policy for the nomination of Directors, including the nomination procedure and process, are to invite nominations from Board members or Nomination Committee members. After undertaking adequate due diligence in respect of any such nominee, the Nomination Committee makes recommendations for the Board's consideration and approval. In the context of re-appointment of any existing member(s) of the Board, the Nomination Committee makes recommendations to the Board for its consideration and recommendation, for the proposed candidates to stand for re-election at a general meeting.

All Board appointments are based on merit, and candidates are considered against objective criteria, having due regard for the benefits of diversity on the Board.

The Nomination Committee has reviewed the Board Diversity Policy to ensure its effectiveness and considered that the Group achieved the objectives of its Board Diversity Policy for the Year.

Remuneration Committee

The Group established the Remuneration Committee on 20 August 2018 with written terms of reference in compliance with Rule 5.35 of the GEM Listing Rules and paragraph B.1.2 of the CG Code. The primary duties of our Remuneration Committee, under the principle that no Director or any of his associates should be involved in deciding his own remuneration include, among others, making recommendations to our Board on (a) our remuneration policy and structure for all of our Directors and senior management; (b) the establishment of a formal and transparent procedure for developing remuneration policies; (c) the remuneration packages of our executive Directors and senior management, including benefits in kind, pension rights and compensation payments, including any compensation payable for loss or termination of their offices or appointments; and (d) the remuneration of our non-executive Directors. Our Remuneration Committee comprises two independent non-executive Directors, namely Mr. Chan Yu Sum Sam and Mr. Chan Kai Kow Macksion and one executive Director namely Mr. Cheung Kwan Tar. Mr. Chan Yu Sum Sam is the chairman of our Remuneration Committee.

During the Year, the Remuneration Committee held 2 meetings, during which it reviewed and considered the specific remuneration packages and discretionary bonus of the executive Directors.

Each newly appointed Director receives a formal, comprehensive and tailored induction on the first occasion of his appointment to ensure that he has a proper understanding of the Company's operations and business and is fully aware of a director's responsibilities under applicable statutes and common law, the GEM Listing Rules, legal and other regulatory requirements and the Company's business and governance policies. The Company will from time to time provide briefings to all Directors to develop and refresh their knowledge and skills relating to their duties and responsibilities.

All Directors are also encouraged to attend relevant training courses at the Company's expense and they are requested to provide the Company with their training records. According to the training records maintained by the Company, all Directors, namely Mr. Cheung Kwan Tar, Mr. Ng Pak Hung, Mr. Chan Yu Sum Sam, Mr. Chan Kai Kow Mackson and Ms. Chik Wai Chun had attended training sessions on obligations, duties and responsibilities of directors during the Year.

- The external independent auditor is responsible for auditing and attesting to Group financial statements and report to the management of the Company from time to time on any weakness in controls which come to their attention; the Board and Audit Committee oversee the respective work of management and external auditors to ensure the management has discharged its duty in respect of having an effective internal control procedures.

During the Year, the Board had engaged an external consultant, CT Partners Consultants Limited, to conduct a review of the effectiveness of the internal control system which covered certain procedures in material controls, including financial, operational and compliance controls and risk management functions of the Group. The Board considered the risk management and internal controls systems of the Group to be adequate and effective for the Year.

SHAREHOLDERS' RIGHTS

Procedures for Convening General Meetings by Shareholders

Pursuant to the Articles, and the applicable legislation and regulation, in particular the GEM Listing Rules (as amended from time to time), the Board may, whenever it thinks fit, convene an extraordinary general meeting ("EGM"). EGMs shall also be convened on the requisition of one or more shareholders holding, at the date of deposit of requisition, not less than one-tenth of the paid up capital of the Company carrying the right of voting at general meetings. Such requisition shall be made in writing to the Board or the company secretary of the Company for the purpose of requiring an EGM to be called by the Board for the transaction of any business specified in such requisition.

The written requisition must state the purposes of the meeting, signed by the requisitionist(s) and deposit it to the Board or the company secretary of the Company by mail at 5/F, Winning Commercial Building, 46-48 Hillwood Road, Tsim Sha Tsui, Kowloon, Hong Kong to require an EGM to be called by the Board for the transaction of any business specified in such requisition. Such requisition should specify clearly the name of the eligible shareholder(s) concerned, his/her/their shareholding, the reason(s) to convene an EGM and the details of the business(es) proposed to be transacted in the EGM, and must be signed by the eligible shareholder(s) concerned together with a sum of money reasonably sufficient to meet the Company's expenses in serving the notice of the resolution and circulating the statement submitted by shareholders concerned in accordance with the statutory requirements to all the registered shareholders.

Each of the independent non-executive Directors has entered into an appointment letter with the Company for an initial term of three years commencing from the Listing Date, which may be terminated by either party giving no less than one month's written notice served by either party on the other.

The term of service of a Director is subject to retirement by rotation of Directors as set out in the Articles.

Save as disclosed above, none of the Directors who are proposed to be re-elected at the forthcoming AGM has entered into a service contract or an appointment letter with our Company or any of our subsidiaries (other than contracts or appointment letters expiring or determinable by the employer within one year without the payment of compensation (other than statutory compensation)).

1. GENERAL INFORMATION

Boltek Holdings Limited (the “**Company**”) was incorporated as an exempted company with limited liability in the Cayman Islands under the Companies Law of the Cayman Islands on 18 April 2018. The Company’s shares are listed on the GEM of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) on 13 September 2018. There is a change of addresses of its registered office effective from 16 December 2022 from Clifton House, 75 Fort Street, P.O. Box 1350, Grand Cayman KY1-1108, Cayman Islands to Windward 3, Regatta Office Park, PO Box 1350, Grand Cayman KY1-1108, Cayman Islands and its addresses of the principal place of business is 5/F, Winning Commercial Building, 46–48 Hillwood Road, Tsim Sha Tsui, Kowloon, Hong Kong.

The Company, which is an investment holding company, and its subsidiaries (collectively referred as the “**Group**”) are principally engaged in provision of engineering design and consultancy services in Hong Kong and investment holding.

The Company’s immediate and ultimate holding company is Waywin Investment Holding Limited (“**Waywin Investment**”), a company incorporated in the British Virgin Islands (the “**BVI**”). The ultimate controlling shareholder of the Group is Mr. Cheung Kwan Tar (“**Controlling Shareholder**”).

The consolidated financial statements for the year ended 31 December 2022 were approved for issue by the board of directors on 27 March 2023.

2.1 Basis of presentation

These annual consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards (“HKFRSs”), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”) and the accounting principles generally accepted in Hong Kong.

The consolidated financial statements also comply with the applicable disclosure requirements of the Hong Kong Companies Ordinance (“CO”) and the applicable disclosure requirements of the Rules Governing the Listing of Securities on the GEM of the Stock Exchange (“Listing Rules”).

The significant accounting policies that have been used in the preparation of these consolidated financial statements are summarised below. These policies have been consistently applied to all the years presented, unless otherwise stated. The adoption of new or amended HKFRSs and the impacts on the Group’s consolidated financial statements, if any, are disclosed in Note 3.

The consolidated financial statements have been prepared under the historical cost basis.

The consolidated financial statements are presented in Hong Kong dollars (“HK\$” or “HKD”), which is also the functional currency of the Company and its subsidiaries, and all values are rounded to the nearest thousand (HK\$’000), except where otherwise indicated.

除另有指示者外，綜合財務報表以港元（「港元」），亦為本公司及其附屬公司之功能貨幣呈列，及所有數值均已約整至最接近千位（千港元）。

It should be noted that accounting estimates and assumptions are used in preparation of the consolidated financial statements. Although these estimates are based on management's best knowledge and judgement of current events and actions, actual results may ultimately differ from those estimates. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated financial statements are disclosed in Note 4.

2.2 Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries made up to 31 December each year.

Subsidiaries are entities controlled by the Group. The Group controls an entity when the Group is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. When assessing whether the Group has power over the entity, only substantive rights relating to the entity (held by the Group and others) are considered.

The Group includes the income and expenses of a subsidiary in the consolidated financial statements from the date it gains control until the date when the Group ceases to control the subsidiary.

Intra-group transactions, balances and unrealised gains and losses on transactions between the members of the Group are eliminated in preparing the consolidated financial statements. Amounts reported in the financial statements of subsidiaries have been adjusted where necessary to ensure consistency with the accounting policies adopted by the Group.

附屬公司為受本集團控制的實體。當本集團因參與該實體而承擔可變回報的風險或享有可變回報的權利，並有能力透過其對該實體的權力影響此等回報時，本集團即控制該實體。評估本集團是否擁有對該實體的權力時，僅考慮本集團及其他方所持有關該實體的實質權利。

本集團自取得附屬公司控制權之日起將附屬公司的收入及開支列入綜合財務報表，直至本集團不再擁有附屬公司控制權之日為止。

在編製綜合財務報表時，集團內公司間交易、結餘及本集團成員公司之間交易的未變現收益及虧損會對銷。附屬公司財務報表中呈報的金額已作出必要調整，以確保與本集團採納的會計政策一致。

Changes in the Group's interests in subsidiaries that do not result in a loss of control are accounted for as equity transactions, whereby adjustments are made to the amounts of controlling interests within consolidated equity to reflect the change in relative interests, but no adjustments are made to goodwill and no gain or loss is recognised.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests. Where certain assets of the subsidiary are measured at revalued amounts or fair values and the related cumulative gain or loss has been recognised in other comprehensive income and accumulated in equity, the amounts previously recognised in other comprehensive income and accumulated in equity are accounted for as if the Company had directly disposed of the related assets (i.e., reclassified to profit or loss or transferred directly to retained profits). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKFRS 9 "Financial Instruments" or, when applicable, the cost on initial recognition of an investment in an associate or a joint venture.

In the Company's statement of financial position, subsidiary is carried at cost less any impairment loss unless the subsidiary is held for sale or included in a disposal group. Cost also includes direct attributable costs of investment.

The result of subsidiary is accounted for by the Company on the basis of dividends received and receivable at the reporting date. All dividends whether received out of the investee's pre or post-acquisition profits are recognised in the Company's profit or loss.

本集團於附屬公司的權益變動(不會導致失去控制權)作為權益交易入賬,而對綜合權益中的控制權益金額進行調整以反映相關利益的變動,但不對商譽進行調整,亦不確認收益或虧損。

當本集團失去對附屬公司的控制權時,出售損益按(i)已收代價的公平值總額及任何保留權益的公平值與(ii)附屬公司的資產(包括商譽)及負債以及任何非控股權益的過往賬面值之間的差額計算。倘附屬公司的若干資產按重估金額或公平值計量,且相關累計收益或虧損已於其他全面收益中確認及於權益中累計,則過往已於其他全面收益中確認及於權益中累計的金額將猶如本公司已直接出售相關資產而入賬(即重新分類為損益或直接轉撥為保留盈利)。任何於失去控制權之日於前附屬公司獲保留投資的公平值被視為根據香港財務報告準則第9號「金融工具」進行後續會計初始確認時的公平值或對一間聯營公司或合營企業進行投資初始確認時的成本(如適用)。

在本公司的財務狀況表中,附屬公司按成本減任何減值虧損列賬,除非該附屬公司持作出售或計入處置組別中。成本亦包括直接應佔投資成本。

附屬公司的業績由本公司按報告日期已收及應收股息入賬。所有股息均於本公司的損益確認,而無論是從被投資方的收購前或收購後的溢利中收取。

2.3 Joint arrangement

A joint operation is a joint arrangement whereby the parties that have joint control of the arrangement have rights to the assets, and obligations for the liabilities, relating to the joint arrangement. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require unanimous consent of the parties sharing control.

The Group accounts for the assets, liabilities, revenues and expenses relating to its interest in a joint operation in accordance with the HKFRSs applicable to the particular assets, liabilities, revenues and expenses.

When the Group's entity transacts with a joint operation in which the Group's entity is a joint operator (such as a sale or contribution of assets), the Group is considered to be conducting the transaction with the other parties to the joint operation, and gains and losses resulting from the transactions are recognised in the Group's consolidated financial statements only to the extent of the other parties' interests in the joint operation.

When the Group's entity transacts with a joint operation in which the Group's entity is a joint operator, the Group does not recognise its share of the gains and losses until it resells those assets to a third party.

2.3 合營安排

合營業務指一項合營安排，對安排擁有共同控制權之訂約方據此對合營安排之資產享有權利及負債負有責任。共同控制是指按照合約約定對某項安排所共有之控制權，共同控制僅在當相關活動要求共同享有控制權之各方作出一致同意之決定時存在。

根據特定資產、負債、收入及開支適用之香港財務報告準則，本集團將與其於合營業務之權益有關之資產、負債、收入及開支入賬。

當本集團實體與合營業務進行交易（如出售或注入資產）而本集團實體為合作經營方，本集團被視為與合營業務之其他各方進行交易，及因交易而產生之盈利及虧損於本集團之綜合財務報表確認，惟以其他各方於合營業務之權益為限。

當本集團實體與合營業務進行交易而本集團實體為合作經營方，本集團不會確認其攤佔之盈利及虧損，直至重售該資產予第三方為止。

2.4 Foreign currency translation

The consolidated financial statements are presented in Hong Kong Dollars (HK\$), which is also the functional currency of the Company.

In the individual financial statement of the consolidated entities, foreign currency transactions are translated into the functional currency of the individual entity using the exchange rates prevailing at the dates of the transactions. At the reporting date, monetary assets and liabilities denominated in foreign currencies are translated at the foreign exchange rates ruling at that date. Foreign exchange gains and losses resulting from the settlement of such transactions and from the reporting date retranslation of monetary assets and liabilities are recognised in profit or loss.

Non-monetary items carried at fair value that are denominated in foreign currencies are retranslated at the rates prevailing on the date when the fair value was determined. Non-monetary items that are measured in terms of historical cost in a foreign currency are not retranslated (i.e. only translated using the exchange rates at the transaction date). When a fair value gain or loss on a non-monetary item is recognised in profit or loss, any exchange component of that gain or loss is also recognised in profit or loss. When a fair value gain or loss on a non-monetary item is recognised in other comprehensive income, any exchange component of that gain or loss is also recognised in other comprehensive income.

綜合財務報告乃以港元(港元)計值，港元亦為本公司的功能貨幣。

於綜合實體的獨立財務報表中，外幣交易乃按交易當日的匯率換算為個別實體的功能貨幣。於報告日期，以外幣計值的貨幣資產及負債按該日通行的匯率換算。因結算該等交易及於報告日期重新換算的貨幣資產及負債所產生的外匯損益於損益中確認。

按公平值以外幣計值的非貨幣項目按釐定公平值當日的匯率重新換算。以外幣計值並按歷史成本計量的非貨幣項目不會重新換算(即僅按交易日的匯率換算)。倘非貨幣項目之公平值損益於損益內確認，則該損益之匯兌部份亦於損益內確認。倘非貨幣項目之公平值損益於其他全面收益內確認，則該損益之匯兌部份亦於其他全面收益內確認。

2.5 Property, plant and equipment

Property, plant and equipment (other than cost of right-of-use assets as described in Note 2.10) are stated at cost less accumulated depreciation and impairment losses. Cost includes expenditure that is directly attributable to the acquisition of the asset. Depreciation commences when the assets are ready for their intended use.

Depreciation is provided to write off the cost of assets less their residual values over their estimated useful lives, using the straight-line method, at the following rates per annum:

Leasehold improvements	Over the term of lease or 25%, whichever is shorter
Furniture and fixtures	20%
Computer equipment	25%
Motor vehicles	25%

Accounting policy for depreciation of right-of-use assets is set out in Note 2.10.

The assets' residual values, depreciation methods and useful lives are reviewed, and adjusted if appropriate, at each reporting date.

The gain or loss arising on retirement or disposal is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. The carrying amount of the replaced part is derecognised. All other costs, such as repairs and maintenance are charged to profit or loss during the financial period in which they are incurred.

其後成本僅在項目相關的未來經濟利益將會流入本集團及能夠可靠計量項目成本時，方會在適當情況下計入資產賬面值或確認為獨立資產。更換部分的賬面值終止確認。維修及保養等所有其他成本，均於產生的財政期間自損益扣除。

Financial assets and financial liabilities are recognised when the Group becomes a party to the contractual provisions of the financial instrument.

A financial liability is derecognised when it is extinguished, discharged, cancelled or expires.

Except for those trade receivables that do not contain a significant financing component and are measured at the transaction price in accordance with HKFRS 15, all financial assets are initially measured at fair value, in case of a financial asset not at fair value through profit or loss ("FVTPL"), plus transaction costs that are directly attributable to the acquisition of the financial asset.

Financial assets, other than those designated and effective as hedging instruments, are classified into amortised cost.

The classification is determined by both:

- the entity's business model for managing the financial asset; and
- the contractual cash flow characteristics of the financial asset.

All income and expenses relating to financial assets that are recognised in profit or loss are presented within finance costs or other income, except for ECL of trade receivables.

Financial assets are measured at amortised cost if the assets meet the following conditions (and are not designated as FVTPL):

- the contractual terms of the financial assets give rise to cash flows that are solely payments of principal and interest on the principal amount outstanding.

After initial recognition, these are measured at amortised cost using the effective interest method. Interest income from these financial assets is included in other income in profit or loss. Discounting is omitted where the effect of discounting is immaterial. The Group's cash and bank balances and trade and other receivables (excluding prepayments) and deposits under non-current asset fall into this category of financial instruments.

The Group's financial liabilities include trade and other payables, lease liabilities and amounts due to directors.

Financial liabilities (other than lease liabilities) are initially measured at fair value, and, where applicable, adjusted for transaction costs unless the Group designated a financial liability at FVTPL.

2.7 Impairment of financial assets and contract assets

HKFRS 9's impairment requirements use more forward-looking information to recognise ECL – the “ECL model”. Instruments within the scope included loans and other debt-type financial assets measured at amortised cost, trade receivables, contract assets recognised and measured under HKFRS 15.

The Group considers a broader range of information when assessing credit risk and measuring ECL, including past events, current conditions, reasonable and supportable forecasts that affect the expected collectability of the future cash flows of the instrument.

In applying this forward-looking approach, a distinction is made between:

- financial instruments that have not deteriorated significantly in credit quality since initial recognition or that have low credit risk (“**Stage 1**”); and
- financial instruments that have deteriorated significantly in credit quality since initial recognition and whose credit risk is not low (“**Stage 2**”).

2.7 金融資產及合約資產減值

香港財務報告準則第9號的減值規定採用更具前瞻性的資料確認預期信貸虧損—「預期信貸虧損模式」。屬此新規定範疇內之工具包括按攤銷成本計量之貸款及其他債務種類金融資產、貿易應收款項及根據香港財務報告準則第15號計量的合約資產。

於評估信貸風險及計量預期信貸虧損時，本集團考量更為廣泛的資料，包括過往事件、現時狀況以及可影響有關工具未來現金流量預期可收回性之有合理據的預測。

“Stage 3” would cover financial assets that have objective evidence of impairment at the reporting date.

“12-month ECL” are recognised for the Stage 1 category while “lifetime ECL” are recognised for the Stage 2 category.

Measurement of the ECL is determined by a probability-weighted estimate of credit losses over the expected life of the financial instrument.

Trade receivables and contract assets

For trade receivables and contract assets, the Group applies a simplified approach in calculating ECL and recognises a loss allowance based on lifetime ECL at each reporting date. These are the expected shortfalls in contractual cash flows, considering the potential for default at any point during the life of the financial assets. In calculating the ECL, the Group has established a provision matrix that is based on its historical credit loss experience and external indicators, adjusted for forward-looking factors specific to the debtors and the economic environment.

To measure the ECL, trade receivables and contract assets have been grouped based on shared credit risk characteristics and the days past due. The contract assets relate to unbilled work in progress and have substantially the same risk characteristics as the trade receivables for the same types of contracts. The Group has therefore concluded that the ECL rates for trade receivables are a reasonable approximation of the loss rates for the contract assets.

預期信貸虧損之計量乃按概率加權估計於金融工具預計存續期之信貸虧損釐定。

貿易應收款項及合約資產

就貿易應收款項及合約資產，本集團採用簡化法計算預期信貸虧損，並於各報告日期根據存續期內預期信貸虧損確認虧損撥備。考慮到金融資產有效期內任何時候違約的可能性，預期合約現金流量存在不足情況。在計算預期信貸虧損時，本集團已建立一個基於其歷史信貸虧損經驗和外部指標的撥備矩陣，並根據債務人和經濟環境特定的前瞻性因素進行調整。

為計量預期信貸虧損，貿易應收款項及合約資產已按共同信貸風險特徵及逾期日數分類。合約資產涉及未開票據在建工程，且與同類合約的貿易應收款項具有大致相同的風險特徵。因此，本集團認為，貿易應收款項的預期信貸虧損率與合約資產虧損率合理相若。

Other financial assets measured at amortised cost

The Group measures the loss allowance for other receivables equal to 12-month ECL, unless when there has been a significant increase in credit risk since initial recognition, the Group recognises lifetime ECL. The assessment of whether lifetime ECL should be recognised is based on significant increase in the likelihood or risk of default occurring since initial recognition.

In assessing whether the credit risk has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial assets at the reporting date with the risk of default occurring on the financial assets at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort.

In particular, the following information is taken into account when assessing whether credit risk has increased significantly:

- an actual or expected significant deterioration in the financial instrument's external (if available) or internal credit rating;
- significant deterioration in external market indicators of credit risk, e.g. a significant increase in the credit spread, the credit default swap prices for the debtor;

本集團計量其他應收款項的虧損撥備金等於12個月的預期信貸虧損，除非自初始確認後信貸風險大幅增加，本集團確認存續期內預期信貸虧損。是否應確認存續期內預期信貸虧損的評估是基於自初始確認以來發生違約的風險的可能性有否顯著增加。

在評估自初始確認後信貸風險是否顯著增加時，本集團將報告日期金融資產發生違約的風險與初始確認日期金融資產違約風險進行比較。在進行評估時，本集團會考慮合理且可支持的定量和定性信息，包括在無需過多的成本或努力即可獲得的歷史經驗和前瞻性信息。

- existing or forecast adverse changes in regulatory, business, financial, economic conditions, or technological environment that are expected to cause a significant decrease in the debtor's ability to meet its debt obligations; and
- an actual or expected significant deterioration in the operating results of the debtor.

Irrespective of the outcome of the above assessment, the Group presumes that the credit risk has increased significantly since initial recognition when contractual payments are more than 60 days past due, unless the Group has reasonable and supportable information that demonstrates otherwise.

Despite the foregoing, the Group assumes that the credit risk on a debt instrument has not increased significantly since initial recognition if the debt instrument is determined to have low credit risk at the end of each reporting period. A debt instrument is determined to have low credit risk if it has a low risk of default, the borrower has strong capacity to meet its contractual cash flow obligations in the near term and adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfill its contractual cash flow obligations.

For internal credit risk management, the Group considers an event of default occurs when information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collateral held by the Group).

Detailed analysis of the ECL assessment of trade receivables, contract assets and other financial assets measured at amortised cost are set out in Note 28.3.

無論上述評估結果如何，本集團假定合約付款逾期超過60日時，信貸風險自初始確認以來已大幅增加，除非本集團有合理及可靠資料證明可予收回則當別論。

不論上述各項，倘債務工具釐定為於各報告期末的信貸風險偏低，則本集團假設債務工具的信貸風險自初始確認以來並無大幅增加。倘具有低違約風險、借款人擁有雄厚實力，可於短期內履行其合約現金流量責任，以及經濟及業務狀況的長期不利變動可能但未必會削弱借款人履行其合約現金流量責任的能力，則債務工具被釐定為信貸風險偏低。

就內部信貸風險管理而言，本集團認為，當內部制訂或從外部來源取得的資料顯示債務人不大可能悉數向債權人（包括本集團）還款（未計及本集團所持任何抵押品）時，即發生違約事件。

Property, plant and equipment (including right-of-use assets) and the Company's interest in a subsidiary are subject to impairment testing. They are tested for impairment whenever there are indications that the asset's carrying amount may not be recoverable.

An impairment loss is recognised as an expense immediately for the amount by which the asset's carrying amount exceeds its recoverable amount. Recoverable amount is the higher of fair value, reflecting market conditions less costs of disposal, and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessment of time value of money and the risk specific to the asset.

For the purposes of assessing impairment, where an asset does not generate cash inflows largely independent from those from other assets, the recoverable amount is determined for the smallest group of assets that generate cash inflows independently (i.e. a cash-generating unit). As a result, some assets are tested individually for impairment and some are tested at cash-generating unit level.

Impairment losses recognised for cash-generating units is charged pro rata to the assets in the cash-generating unit, except that the carrying value of an asset will not be reduced below its individual fair value less cost of disposal, or value in use, if determinable.

An impairment loss is reversed if there has been a favourable change in the estimates used to determine the asset's recoverable amount and only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation, if no impairment loss had been recognised.

減值虧損按資產之賬面值超出其可收回金額之差額，即時確認為開支。可收回金額為反映市況之公平值減銷售成本與使用價值兩者之較高者。評估使用價值時，估計未來現金流量採用稅前折現率折現至其現值，以反映現時市場對金錢時間值及有關資產特有風險之評估。

為評估減值，倘資產產生之現金流入並無大致上獨立於其他資產產生的現金流入時，可收回金額則按可獨立產生現金流入之最少資產組合(即現金產生單位)釐定。因此，部分資產個別進行減值測試，另有部分按現金產生單位測試。

就現金產生單位確認的減值虧損按比例計入現金產生單位的資產，惟資產的賬面值不會減少至低於個別公平值減出售成本或使用價值(如能確定)。

倘用於釐定資產可收回款額之估計出現有利變動時，則撥回減值虧損，惟以資產賬面值不得高於並無確認減值虧損時原應釐定之賬面值(扣除折舊)為限。

Cash and cash equivalents include cash at bank and in hand and demand deposits with banks with original maturities of three months or less that are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value.

2.10 Leases

Definition of a lease and the Group as a lessee

At inception of a contract, the Group considers whether a contract is, or contains a lease. A lease is defined as a contract, or part of a contract, that conveys the right to use an identified asset (the underlying asset) for a period of time in exchange for consideration'. To apply this definition, the Group assesses whether the contract meets three key evaluations which are whether:

- the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Group;
- the Group has the right to obtain substantially all of the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract; and
- the Group has the right to direct the use of the identified asset throughout the period of use. The Group assess whether it has the right to direct 'how and for what purpose' the asset is used throughout the period of use.

For contracts that contains a lease component and one or more additional lease or non-lease components, the Group allocates the consideration in the contract to each lease and non-lease component on the basis of their relative stand-alone prices.

於合約開始時，本集團會考慮該合約是否為或包含一項租賃。租賃的定義為「一份合約或合約的一部分賦予他人有一段時間內使用已識別資產（相關資產）的權力，以換取代價」。為符合此定義，本集團評估合約是否符合以下三項關鍵評估因素：

- 合約是否包含已識別資產，即該資產在合約中可明確識別，或在資產可供本集團使用時以隱含指定方式識別；
- 本集團有權在整個使用期內取得使用已識別資產的絕大部分經濟利益，並認為其權利符合合約界定範圍；及
- 本集團有權在整個使用期內指定已識別資產的用途。本集團評估其是否有權指定該資產在整個使用期內的使用「方式及目的」。

對於包含租賃部分及一個或以上額外租賃或非租賃部分的合約，本集團按相對獨立價格將合約中訂明的代價分配至各租賃及非租賃部分。

Measurement and recognition of leases as a lessee

At lease commencement date, the Group recognises a right-of-use asset and a lease liability on the consolidated statement of financial position. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Group, an estimate of any costs to dismantle and remove the underlying asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any lease incentives received).

The Group depreciates the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term unless the Group is reasonably certain to obtain ownership at the end of the lease term. The Group also assesses the right-of-use asset for impairment when such indicator exists.

At the commencement date, the Group measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Group's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in-substance fixed payments) less any lease incentives receivable, variable payments based on an index or rate, and amounts expected to be payable under a residual value guarantee. The lease payments also include the exercise price of a purchase option reasonably certain to be exercised by the Group and payment of penalties for terminating a lease, if the lease term reflects the Group exercising the option to terminate.

Subsequent to initial measurement, the liability will be reduced for lease payments made and increased for interest cost on the lease liability. It is remeasured to reflect any reassessment or lease modification, or if there are changes in in-substance fixed payments. When the lease is remeasured, the corresponding adjustment is reflected in the right-of-use asset, or profit and loss if the right-of-use asset is already reduced to zero.

On the consolidated statement of financial position, right-of-used assets have been included in "property, plant and equipment", the same line as it presents the underlying assets of the same nature that it owns.

Refundable rental deposits paid are accounted for under HKFRS 9 and initially measured at fair value. Adjustments to fair value at initial recognition are considered as additional lease payments and included in the cost of right-of-use assets.

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, and it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate of the amount of the obligation can be made. Where the time value of money is material, provisions are stated at the present value of the expenditure expected to settle the obligation.

All provisions are reviewed at each reporting date and adjusted to reflect the current best estimate.

An onerous contract exists when the Group has a contract under which the unavoidable costs of meeting the obligations under the contract exceed the economic benefits expected to be received from the contract. Provisions for onerous contracts are measured at the present value of the lower of the expected cost of terminating the contract and the net cost of continuing with the contract.

2.12 Share capital

Ordinary shares are classified as equity. Share capital is determined using the nominal value of shares that have been issued. Any transaction costs associated with the issuing of shares (net of any related income tax benefit) are deducted from share premium to the extent they are incremental cost directly attributable to the equity transaction.

Revenue is recognised to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the Group expects to be entitled in exchange for those goods or services. Specifically, the Group uses a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation

The Group recognises revenue when (or as) a performance obligation is satisfied, i.e. when “control” of the goods or services underlying the particular performance obligation is transferred to customers.

Control of the asset may be transferred over time or at a point in time. Control of the asset is transferred over time if:

- (i) the customer simultaneously receives and consumes the benefits provided by the Group’s performance as the Group performs;
- (ii) the Group’s performance creates or enhances an asset (for example work in progress) that the customer controls as the asset is created or enhanced; or

If the control of the asset transfers over time, revenue is recognised over the period of the contract by reference to the progress towards complete satisfaction of that performance obligation. Otherwise, revenue is recognised at a point in time when the customer obtains control of the asset.

(a) Engineering design and consultancy service

Revenue from engineering design and consultancy service contracts is recognised progressively based on the contract costs incurred to date as a percentage of total forecast costs to depict the transfer of control of the goods or services to the customer. The Group recognises revenue over time only if it can reasonably measure its progress toward complete satisfaction of the performance obligation.

Incremental cost of obtaining a contract is capitalised if the Group expects to recover those costs, unless the amortisation period for such costs would be one year or less. Costs that will be incurred regardless of whether the contract is obtained are expensed as they are incurred.

The Group presents a contract liability or a contract asset in the consolidated statement of financial position when either party to the contract has performed. The Group performs by transferring goods or services to the customer, and the customer performs by paying consideration to the Group. Any unconditional rights to consideration are presented separately as "Trade and other receivables".

Contract liabilities are obligations to transfer goods or services to a customer for which the Group has received consideration, or for which an amount of consideration is due from the customer.

Contract assets are rights to consideration in exchange for goods or services that the Group has transferred to a customer when that right is conditional on something other than the passage of time.

For a single contract with the customer, either a net contract asset or a net contract liability of unrelated contracts are not presented on a net basis.

Other service revenue are recognised in the period when services are rendered.

(b) Interest income

Interest income is recognised on a time proportion basis using the effective interest method. For financial assets measured at amortised cost that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the asset.

2.14 Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. When the grant relates to an expense item, it is recognised as income on a systematic basis over the periods that the costs, which it is intended to compensate, are expensed.

Government grants relating to income is presented in gross under "other income" in the consolidated statement of profit or loss and other comprehensive income.

Retirement benefits

Retirement benefits to employees are provided through defined contribution plans.

The Group operates a defined contribution retirement benefit plan under the Mandatory Provident Fund Schemes Ordinance, for all of its employees who are eligible to participate in the MPF Scheme. Contributions are made based on 5% (2021: 5%) of the employee's basic salaries with a cap of HK\$1,500 per month. The assets of the plan are held separately from those of the Group, in funds under the control of trustees. The company's contributions to the MPF Scheme will be obtained by employees in accordance with statutory requirements and plan terms. Where there are employees who leave the MPF Scheme prior to vesting fully in the contributions, the amount payable by the Group to the MPF Scheme in the future will be reduced by the amount of the MPF Scheme that has been forfeited.

Contributions are recognised as an expense in profit or loss as employees render services during the year. The Group's obligations under these plans are limited to the fixed percentage contributions payable.

Short-term employee benefits

Employee entitlements to annual leave are recognised when they accrue to employees. A provision is made for the estimated liability for annual leave as a result of services rendered by employees up to the reporting date.

Non-accumulating compensated absences such as sick leave and maternity leave are not recognised until the time of leave.

Long service payment

Certain of the Group's employees have completed the required number of years of service to the Group in order to be eligible for long service payment under the Hong Kong Employment Ordinance in the event of the termination of their employment. The Group is liable to make such payment in the event that such a termination of employment meets the circumstances specified in the Hong Kong Employment Ordinance.

The long service payment liabilities are the present value of long service payment obligation less the entitlements accrued under the Group's defined contribution retirement benefit plans that is attributable to contributions made by the Group.

2.16 Accounting for income taxes

Income tax comprises current tax and deferred tax.

Current income tax assets and/or liabilities comprise those obligations to, or claims from, fiscal authorities relating to the current or prior reporting period, that are unpaid at the reporting date. They are calculated according to the tax rates and tax laws applicable to the fiscal periods to which they relate, based on the taxable profit for the year. All changes to current tax assets or liabilities are recognised as a component of tax expense in profit or loss.

Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are recognised for all deductible temporary differences, tax losses available to be carried forward as well as other unused tax credits, to the extent that it is probable that taxable profit, including existing taxable temporary differences, will be available against which the deductible temporary differences, unused tax losses and unused tax credits can be utilised.

Deferred tax assets and liabilities are not recognised if the temporary difference arises from goodwill or from initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither taxable nor accounting profit or loss.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries, except where the Group is able to control the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

Deferred tax is calculated, without discounting, at tax rates that are expected to apply in the period the liability is settled or the asset realised, provided they are enacted or substantively enacted at the reporting date.

Changes in deferred tax assets or liabilities are recognised in profit or loss, or in other comprehensive income or directly in equity if they relate to items that are charged or credited to other comprehensive income or directly in equity.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below:

4.1 Revenue from contracts for engineering design and consultancy services

As further explained in Note 2.13 to the consolidated financial statements, revenue recognition on provision of engineering design and consultancy services is dependent on the estimation of the progress of the satisfaction of performance obligation of a service contract over time. Based on the Group's past experience and the nature of the contract activities undertaken by the Group, the Group makes estimates of the point at which it considers the work is sufficiently advanced such that the costs to complete and the revenue can be reliably estimated. Actual outcome in terms of total contract costs and/or revenue may be higher or lower than those estimated at the end of each reporting period, which would affect the revenue and profit recognised in future years.

Significant judgement is required to estimate the total contract costs and the recoverable variation works that will affect whether any provision is required for foreseeable losses. The estimates are made based on past experience and knowledge of the project management.

Details of the revenue, contract balances and provision for an onerous contract are disclosed in Note 5, Note 17 and Note 19 respectively.

4.2 Estimation for impairment of trade and other receivables (excluding prepayments) and contract assets

The Group makes allowances on trade and other receivables (excluding prepayments) and contract assets to ECL based on assumptions about risk of default and ECL rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on the Group's past history, existing market conditions as well as forward-looking estimates at the end of each reporting period as set out in Note 2.7.

Details of the trade and other receivables and contract assets are disclosed in Note 16 and Note 17, respectively.

4.3 Determination of the lease term in lease contracts and discount rate

In determining the lease term, management considers all facts and circumstances that create an economic incentive to exercise an extension options, or not exercise a termination option. Factors considered include:

- contractual terms and conditions for the optional periods compared with market rates (e.g. whether the amount of payments in the optional periods is below the market rates);
- the extent of leasehold improvements undertaken by the Group;
- costs relating to termination of the lease (e.g. relocation costs, costs of identifying another underlying asset suitable for the Group's needs).

Extension options (or periods after termination options) are only included in the lease term if the lease is reasonably certain to be extended (or not terminated), which in turn affect the carrying amounts of lease liabilities and corresponding right-of-use assets.

In determining the discount rate, the Group is required to exercise considerable judgement in relation to determining the discount rate taking into account the nature of the underlying assets and the terms and conditions of the leases, at both the commencement date and effective date of the modification.

4.4 Determination of joint arrangement

The directors of the Company performed an assessment of whether the Group has joint control over the Group's joint arrangement. Pursuant to the respective contractual agreement regarding each of the joint arrangement, all major decisions and the decisions regarding the relevant activities of the joint arrangement require the unanimous consent of all parties to the arrangement. Accordingly, the directors of the Company concluded that the Group has joint control over the joint arrangement.

The directors of the Company also assessed whether these joint arrangement is joint operations or joint ventures under HKFRS 11 "Joint Arrangements". After considering the rights and obligations of parties to the joint arrangement with reference to the structure, the legal form of the arrangements, the contractual terms agreed by the parties in the arrangements, and the relevant facts and circumstances, the directors of the Company concluded that all of the Group's joint arrangement should be classified as joint operation under HKFRS 11 as the relevant joint arrangement document specify that the parties to the joint arrangement have rights to the assets and obligations to the liabilities relating to the joint arrangement. The Group's exposure to credit risk mainly arises from granting credit to customers in the ordinary course of its operations. The Group's maximum exposure to credit risk on recognised financial assets and contract assets is limited to the carrying amount at end of each reporting period.

In respect of trade and other receivables and contract assets, individual credit evaluations are performed on all customers and counterparties. These evaluations focus on the counterparty's financial position, past history of making payments and take into account information specific to the counterparty as well as pertaining to the economic environment in which the counterparty operates. Monitoring procedures have been implemented to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of trade and other receivable and contract asset balance as a group basis at the end of each reporting period to ensure adequate impairment losses are made for irrecoverable amounts based on shared credit risk characteristics and the days past due.

At 31 December 2022, the Group has concentration of credit risk as 13% and 33% (2021: 13% and 39%), of the total trade and other receivables (Note 28.1) were due from the Group's largest trade debtor and five largest trade debtors respectively. The aggregate amounts of trade and other receivables from these trade debtors amounted to HK\$5,728,000 and HK\$14,239,000 (2021: HK\$5,802,000 and HK\$17,491,000) of the Group's total trade and other receivables at 31 December 2022.

28.3 信貸風險

信貸風險指金融工具的對手方未能根據金融工具的條款履行其責任及對本集團造成財務虧損的風險。本集團所面對的信貸風險主要來自於其日常業務過程中向客戶授出信貸。本集團就已確認金融資產及合約資產而面臨之最大信貸風險限述於各報告期末之賬面值。

就貿易及其他應收款項及合約資產而言，需要對所有客戶及對手方進行個別信貸評估。該等評估專注於對手方之財務狀況、過往付款記錄，並考慮對手方之特定資料以及與對手方經營相關的經濟環境。本集團已實施監控程式來確保採取進一步行動收回逾期債務。此外，本集團於各報告期末按組別審閱貿易及其他應收款項及合約資產結餘之可收回金額，以確保根據共有信貸風險特徵及逾期天數對不可收回金額作出充足減值虧損。

於二零二二年十二月三十一日，由於應收本集團最大貿易債務人及五大貿易債務人的款項分別為貿易及其他應收款項(附註28.1)總額的13%及33%(二零二一年：13%及39%)，故本集團信貸風險集中。於二零二二年十二月三十一日，應收該等貿易債務人的貿易及其他應收款項總額分別為本集團貿易及其他應收款項總額的5,728,000港元及14,239,000港元(二零二一年：5,802,000港元及17,491,000港元)。

The Group considers the probability of default upon initial recognition of asset and whether there has been a significant increase in credit risk on an ongoing basis throughout each reporting period. To assess whether there is a significant increase in credit risk, the Group compares the risk of a default occurring on the asset as at the reporting date with the risk of default as at the date of initial recognition. It considers available reasonable and supportive forward-looking information. Internal credit rating, actual or expected significant adverse changes in business, financial or economic conditions that are expected to cause a significant change to the borrower's ability to meet its obligations, actual or expected significant changes in the operating results of the borrower and significant changes in the expected performance and behaviour of the borrower including changes in the payment status of borrowers in the Group and changes in the operating results of the borrower are indicators to be incorporated.

The Group accounts for its credit risk by appropriately providing for ECL on a timely basis. In calculating the ECL rates, the Group considers historical elements and forward-looking elements.

(i) Trade receivables and contract assets

The Group applies the simplified approach to providing for ECL prescribed by HKFRS 9, which permits the use of the lifetime ECL provision for all trade receivables and contract assets.

The Group uses provision matrix to calculate ECL for trade receivables and contract assets. To measure the ECL, trade receivables and contract assets have been grouped based on shared credit risk characteristics and the days past due. The contract assets relate to work completed but not billed at the reporting date and have substantially the same risk characteristics as the trade receivables for the same types of contracts. The Group has therefore concluded that the ECL rates for trade receivables are a reasonable approximation of the loss rates for the contract assets.

The provision matrix is determined based on the Group's historical settlement experience of the debtors that have similar loss pattern and are adjusted for forward-looking information that is available without undue cost or effort. The Group has identified the gross domestic product in Hong Kong to be the most relevant factors, and accordingly adjusts the historical loss rates based on expected changes in these factors. The ECL allowance increased from HK\$1,479,000 to HK\$1,754,000 (2021: HK\$1,769,000 to HK\$1,479,000) mainly due to the faster repayment turnover days of the outstanding trade receivables.

本集團採用撥備矩陣計算貿易應收款項及合約資產之預期信貸虧損。為計量預期信貸虧損，貿易應收款項及合約資產已根據共同信貸風險特徵及逾期天數進行分組。合約資產與於報告日期已完成但尚未開票之工程有關，並與同類合約的貿易應收款項具有大致相同的風險特徵。因此，本集團認為貿易應收款項之預期信貸虧損比率與合約資產之虧損比率合理相若。

撥備矩陣乃根據本集團對具有類似虧損模式的債務人的歷史結算經驗而釐定，並就毋須付出過多成本或精力即可獲得的前瞻性資料作出調整。本集團已識別出香港之本地生產總值為最相關因素，並已根據該等因素之預期變動相應調整過往虧損比率。預期信貸虧損撥備由1,479,000港元增加至1,754,000港元(二零二一年：1,769,000港元至1,479,000港元)，主要由於未償還貿易應收款項的還款週轉天數增加。

28.4 Liquidity risk

Liquidity risk relates to the risk that the Group will not be able to meet its obligations associated with its financial liabilities that are settled by delivering cash or another financial asset. The Group is exposed to liquidity risk in respect of settlement of trade and other payables, lease liabilities and amounts due to directors, and also in respect of its cash flow management. The Group's objective is to maintain an appropriate level of liquid assets and committed lines of funding to meet its liquidity requirements in the short and longer term.

Management monitors the cash flow forecasts of the Group in meeting its liabilities.

The analysis set out the remaining contractual maturity based on undiscounted cash flow of the Group's financial liabilities at the reporting date.

29. CAPITAL MANAGEMENT

The Group's capital management objectives are to ensure the Group's ability to continue as a going concern and to maintain capital structure in order to minimise the costs of capital, support its business and maximise shareholders' value.

The Group actively and regularly reviews its capital structure and makes adjustments in light of changes in economic conditions. The Group monitors its capital structure on the basis of the debt to equity ratio. For this purpose, debt is defined as borrowings net of cash and bank balance. In order to maintain or adjust the ratio, the Group may adjust the amount of dividends paid to shareholders, share buyback, issue new shares and raise new debts.

As at 31 December 2022 and 2021, the debt to equity ratio was not presented as the Group had no borrowings.

30. MAJOR NON-CASH TRANSACTIONS

During the year ended 31 December 2022, the Group entered into certain lease contracts related to premises which are not existing as at 31 December 2021, in which additions to right-of-use assets and lease liabilities amounting to HK\$2,143,000 (2021: HK\$6,882,000) was recognised at the lease commencement date.

During the year ended 31 December 2022, the non-current deposits for purchase of property, plant and equipment of HK\$Nil (2021: HK\$111,000) was recognised as property, plant and equipment upon completion of development and ready for use.
