MANAGEMENT DISCUSSION AND ANALYSIS

GENERAL

During the three months ended 31 March 2023 (the "Period"), the Company and its subsidiaries (collectively the "Group") was principally engaged in (i) brokerage business in futures and options products being traded in Hong Kong and overseas markets, together with the stock options and securities being traded in the Stock Exchange and margin financing business and (ii) money lending business.

OPERATION REVIEW

In the first quarter of 2023, the brokerage business of the Group has not yet recovered to the management target, and the commission revenue was still lower than the commission revenue earned in the fourth quarter of 2022. One of the key reasons for such decreasing trend was the brokerage commission income from the partnership with the Hong Kong SFC licensed institutional client could not reach the original target due to market conditions and the acceptance of future and options products by the customers of the institutional client.

The management will work with the institutional client and offer more seminars and materials to promote the business. The management believed that it could encourage more clients to trade in future and options products and hence increase the brokerage revenue of the Group. For the money lending business, it continued to generate stable interest income during the Period.

FINANCIAL REVIEW

During the Period, the Group recorded a total revenue of approximately HK\$1.5 million, representing a slight decrease of approximately HK\$0.1 million from approximately HK\$1.6 million recorded in the three months ended 31 March 2022 (the "Corresponding Period"). Loss for the Period of approximately HK\$1.7 million was recorded, as compared to the loss of approximately HK\$3.7 million for the Corresponding Period.

Salaries and other benefits remained stable compared to Corresponding Period and the total expense was approximately HK\$1.6 million during the Period.

MANAGEMENT DISCUSSION AND ANALYSIS (CONTINUED)

Other operating and administrative expenses decreased by approximately HK\$2.7 million or approximately 65.8% compared to the Corresponding Period mainly due to the decrease of one-off sundry expenses relating to relocation of office by approximately HK\$1.4 million for the Corresponding Period and decrease in depreciation expenses of right-of-use assets by approximately HK\$0.7 million during the Period

OUTLOOK

As all the compulsory quarantine arrangements have been lifted and the travellers from the PRC could come to Hong Kong and open accounts with us, it is expected that the commission revenue will be increased in the coming quarters. The management expects that more new customers, together with the increase in commission income from the institutional client mentioned earlier, could boost the financial performance of the Group in the second half of 2023.

1 CORPORATE INFORMATION

Excalibur Global Financial Holdings Limited (the "Company") was incorporated in Cayman Islands on 13 July 2016 as an exempted company with limited liability under the Companies Law (2011 Revision) (as consolidated and revised) of the Cayman Islands. Its ultimate controlling parties are Mr. Poon Kwok Wah Allan, who is also the Chairman and Chief Executive Officer of the Company and Mr. Chan Ying Leung, the former executive Director of the Company. The addresses of the registered office and principal place of business of the Company are disclosed in the corporate information section in this report.

The Company and its subsidiaries (together, the "Group") mainly provide brokerage services for futures, securities and options traded on the exchanges in Hong Kong, the United States, Japan, Singapore and the United Kingdom. The Group also provides margin financing business and money lending business.

2 BASIS OF PREPARATION AND ACCOUNTING POLICIES

These unaudited condensed consolidated results have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards ("HKFRSs"), which collective term includes all applicable individual Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards and Interpretations issued by the Hong Kong Institute of Certified Public Accountants and accounting principles generally accepted in Hong Kong. These unaudited condensed consolidated results also comply with the applicable disclosure provisions of the GEM Listing Rules and the disclosure requirements of the Hong Kong Companies Ordinance. These unaudited condensed consolidated results have been prepared under historical cost convention except for certain financial instruments which are measured at fair value. The unaudited condensed consolidated results are presented in Hong Kong dollar ("HK\$") and all values are rounded to the nearest thousand except when otherwise indicated.

The principal accounting policies applied in the preparation of the unaudited condensed consolidated results are consistent with those adopted in the preparation of the annual consolidated financial statements of the Group for the year ended 31 December 2022.

The application of the new or revised HKFRSs in the current period has had no material effect on the amounts reported in the unaudited condensed consolidated quarterly financial information and/or disclosures set out in the unaudited condensed consolidated quarterly financial information.

The quarterly results are unaudited but have been reviewed by the audit committee of the Company.

3 REVENUE

The principal activities of the Group are futures and options, stock options and securities broking, margin financing business and money lending business.

Revenue represents the brokerage commission from futures and options, stock options and securities broking, also interest income arising from margin loan financing and money lending business.

SHARE OPTION SCHEME

The Company has adopted a share option scheme on 19 December 2017 (the "Scheme") as approved by a written resolution of all shareholders of the Company passed on 19 December 2017. No share option has been granted under the Scheme since its adoption and up to the date of this report.

DIRECTORS' RIGHT TO ACQUIRE SHARES OR DEBENTURES

Other than as disclosed in the paragraph headed "Share Option Scheme" in this report, at no time during the three months ended 31 March 2023 was the Company or any of its subsidiaries a party to any arrangement to enable the Directors or chief executive of the Company (including their spouses or children under 18 years of age) to have any right to subscribe for securities of the Company or any of its associated corporations as defined in the SFO or to acquire benefits by means of acquisition of shares in, or debentures of, the Company or any other body corporate.

DIRECTORS' INTEREST IN COMPETING BUSINESS

During the three months ended 31 March 2023, none of the Directors or the Controlling Shareholders or their respective close associates (as defined in the GEM Listing Rules) of the Company had an interest in a business which competed with or might compete with the business of the Group.

CORPORATE GOVERNANCE PRACTICES

The Board is committed to achieving good corporate governance standards. The Board believes that good corporate governance standards are essential in providing a framework for the Group to safeguard the interests of the shareholders of the Company, enhance corporate value, formulate its business strategies and policies, and enhance its transparency and accountability.

The Company has applied the principles and practices as set out in the Corporate Governance Code (the "CG Code") contained in Appendix 15 to the GEM Listing Rules and has adopted the CG Code as the code to govern the Company's corporate governance practices.

During the three months ended 31 March 2023, the Company has complied with the applicable code provisions as set out in the CG Code except for the deviation from code provision C.2.1 which stipulates that the roles of chairman and chief executive should be separate and should not be performed by the same individual. The division of responsibilities between the chairman and chief executive should be clearly established and set out in writing.

Mr. Poon Kwok Wah Allan is the Chairman and the Chief Executive Officer of the Company and is responsible for the overall strategic planning, business development and operational management of the Group. In view of Mr. Poon Kwok Wah Allan has joined the Group in September 2000 as the general manager of Excalibur Global Financial Group Limited (駿溢環球金融集團有限公司) (formerly known as Home Great Investment Limited (亨偉投資有限公司), Excalibur Futures Limited (加利保期貨有限公司), and Excalibur Futures Limited (駿溢期貨有限公司)), the key operating subsidiary of the Company, the Board believes that it is in the best interest of the Group to have Mr. Poon Kwok Wah Allan to take up both roles for effective management and business development of the Group. Therefore, the Directors consider that the deviation from the code provision C.2.1 of the CG Code is appropriate in such circumstance.

The Company will periodically review and improve its corporate governance practices with reference to the latest development of corporate governance.

CODE OF CONDUCT REGARDING SECURITIES TRANSACTIONS

The Company has adopted the Required Standard of Dealings as the code for securities transactions by the Directors on the guidelines as set out in Rules 5.48 to 5.67 of the GEM Listing Rules. Further, the Company had made specific enquiry with all Directors and each of them has confirmed his/her compliance with the Required Standard of Dealings during the three months ended 31 March 2023.

The Company has also adopted written guidelines as the code for securities transactions by relevant employees of the Group who are likely to possess inside information in relation to the Company or its securities based on the Required Standard of Dealings as set out in Rules 5.48 to 5.67 of the GEM Listing Rules. No incidence of non-compliance of this code by the relevant employees was noted by the Company.

PURCHASE, SALE OR REDEMPTION OF LISTED SECURITIES

There was no purchase, sale or redemption of listed securities of the Company by the Company or any of its subsidiaries during the three months ended 31 March 2023.

AUDIT COMMITTEE

The Company has established its audit committee (the "Audit Committee") with written terms of reference in compliance with Rule 5.28 of the GEM Listing Rules and code provision D.3.3 of the CG Code. The primary duties of the Audit Committee are to review the Company's annual report and accounts, interim report and quarterly reports and to provide advices and comments thereon to the Board. The Audit Committee will also be responsible for reviewing and supervising the Company's financial reporting, risk management and internal control systems. The Audit Committee comprises three independent non-executive Directors, namely Mr. Chin Kam Cheung (chairman of the Audit Committee), Mr. Lam Ka Tai and Mr. Siu Miu Man, M.H.. Mr. Chin Kam Cheung possesses the appropriate professional accounting qualifications and related financial management expertise as required in Rule 5.05(2) of the GEM Listing Rules.

The Group's unaudited results for the three months ended 31 March 2023 have been reviewed by the Audit Committee which was of the opinion that the preparation of such results complied with the applicable accounting standards, the GEM Listing Rules and legal requirements and that adequate disclosures have been made.
