主席報告 CHAIRMAN'S STATEMENT

尊敬的列位股東:

本人謹代表訊智海國際控股有限公司(「本公司」,連同其附屬公司統稱「本集團」)董事(「董事」)會「董事會」)欣然向本公司股東(「股東」)提呈本集團截至二零二三年十二月三十一日止年度之年報。

於二零二三年,本集團錄得收入約152,100,000 港元(二零二二年:約368,200,000港元);純利約6,600,000港元(二零二二年:約5,100,000港元),金額增加約30.7%。

於二零二三年,本集團制定了多元化業務分類戰略規劃,專注於發展維修及服務支援分類。此舉旨在避免過度集中於單一業務分類及其相關風險。我們相信,通過擴大我們的服務範圍,我們可提升本集團的整體財務表現,並從維修及服務支援分類相對較高的利潤率回報中獲益。

此外,我們注意到,由於價格實惠及環保,世界各地的人們越來越傾向於使用經翻新IT產品。大量調查及研究表明,過去數年,人們對經翻新IT產品的需求一直在穩步增長。此消費行為的轉變與我們對可持續發展及避免IT產品過度浪費的承諾一致。通過提供經翻新IT產品作為可行的替代品,我們為減少電子廢棄物及促進循環經濟作出了貢獻。

基於我們對循環經濟的承諾,本集團正積極物色投資「循環經濟」業務分類的商機,包括為第三方IT產品(包括計算機、通信及消費者電子產品(「**3C產品**」))提供售後服務以再生產原材料。該擴張不僅使我們的收入來源多元化,亦有助於電子廢棄物的可持續管理。本集團管理層認為,於不久的將來,「綠色科技」貿易將成為一項熱門話題,而我們的目標為將本集團打造成此新興市場的領導者。

展望未來,我們對未來的機遇及挑戰持樂觀態度。在 努力為股東創造長期價值的同時,我們對可持續發展 及循環經濟的承諾仍將是我們營運的核心。

最後,本人謹代表董事會對股東及業務夥伴的信任及 支持表示衷心感謝。本人亦謹此向本公司各級管理人 員及盡忠職守的員工表示敬意,感謝彼等多年來作出 的寶貴貢獻及辛勤努力。

On behalf of the board (the "Board") of directors (the "Director(s)") of CircuTech International Holdings Limited (the "Company", together with its subsidiaries, collectively the "Group"), I am pleased to present to the shareholders of the Company (the "Shareholder(s)") the annual report of the Group for the year ended 31 December 2023.

In 2023, the Group recorded revenue amounted to approximately HK\$152.1 million (2022: approximately HK\$368.2 million); net profit of approximately HK\$6.6 million (2022: approximately HK\$5.1 million), representing an approximately 30.7% increase in amount.

During the year 2023, the Group has made strategic plan to diversify our business segments and focus on developing the repairs and service support segment. This move was aimed at avoiding overconcentration on a single business segment and its associated risks. We believe that by expanding our service offerings, we can enhance the overall financial performance of the Group and benefit from the relatively high-profit margin returns in the repairs and service support segment.

Furthermore, we have observed a growing trend among people worldwide who now prefer using refurbished IT products due to their affordability and environmental friendliness. Numerous studies and researches revealed that the demand for refurbished IT products has been steadily increasing over the past years. This shift in consumer behavior aligns with our commitment to sustainability and the avoidance of excess wastage of IT products. By offering refurbished IT products as a viable alternative, we contribute to the reduction of electronic waste and promote a circular economy.

In line with our commitment to the circular economy, the Group is actively exploring business opportunities to invest in the "Circular Economy" business segment, from providing after-sales services for third-party IT products, including computers, communications, and consumer electronics (the "3C Products") to reproduce raw materials. This expansion will not only diversify our revenue streams but also contribute to the sustainable management of electronic waste. The management of the Group believes that the trade of "Green Technology" will be a hot topic in the near future, and we aim to position the Group as a leading player in this emerging market.

Looking ahead, we are optimistic about the opportunities and challenges that lie ahead. Our commitment to sustainability and the circular economy will remain at the core of our operations as we strive to create long-term value for our Shareholders.

Last but not least, on behalf of the Board, I would like to express my sincere gratitude to the Shareholders and business partners for their trust and support. I would also like to salute the managers at all levels and dedicated staff of the Company for their invaluable contributions and diligent efforts throughout the years.

管理層討論及分析 MANAGEMENT DISCUSSION AND ANALYSIS

業務回顧

本集團經營兩個業務分類,即銷售及分銷IT產品以及 提供IT產品的維修及其他服務支援。

銷售及分銷IT產品

本集團之核心業務分類為銷售及分銷IT產品,包括分銷知名第三方IT產品及帶有我們的自有品牌名稱之視像監控系統。第三方IT產品主要是二手及經翻新的部件,透過在我們建立良久的批發網絡(涵蓋北美、亞洲及澳洲)分銷。

於二零二三年,全球二手IT產品市場需求及供應均大幅增長。越來越多消費者選擇更實惠及環保的經翻新IT產品。此外,對循環經濟及可持續發展的高度重視導致近年來對經翻新產品的認識增強。因此,消費者更加熟悉選擇二手設備的優勢並了解到它們的諸多好處。

銷售及分銷視像監控系統競爭激烈,尤其是,本集團 在定價、所提供的服務範圍及資訊技術方面,直接及 間接地與全球大型供應商競爭。

本集團擁有若干優勢,可與其他全球分銷商有效地進行競爭。該等優勢包括其管理團隊的專業知識及良好的往績,以及其與全球知名企業富士康科技集團(其與多家國際品牌有強大業務聯繫)的關係。為優化其財務表現,本集團將堅持透過改善存貨周轉天數及降低存貨風險管理其呆滯營運資金,最終旨在縮短現金周轉週期。

於本年度,本集團持續評估及重新評估其業務模式, 致力於提高效率及達致較高利潤率。此外,本集團將 保持警惕,密切監察市場狀況,使其能夠根據需要對 其策略及營運作出必要調整。

BUSINESS REVIEW

The Group operates in two business segments, namely, the sales and distribution of IT products and the provision of repairs and other service support of IT products.

Sales and distribution of IT products

The core business segment of the Group is sales and distribution of IT products. It includes distribution of renowned third-party IT products and video surveillance systems carrying our own brand name. The third-party IT products are mainly used and refurbished units that are distributed through our well-established wholesale network covering North America, Asia and Australia.

The global secondary IT products market experienced a significant increase in both demand and supply in 2023. A growing number of consumers opted for refurbished IT products, which are more affordable and environmentally friendly. Additionally, the heightened focus on the circular economy and sustainability led to the increased awareness of refurbished products in recent years. As a result, consumers became more familiar with the advantages of choosing preowned devices and were exposed to their numerous benefits.

The sales and distribution of video surveillance systems is highly competitive, in particular, the Group directly and indirectly competes with large global vendors in form of pricing, range of services provided and information technology.

The Group possesses several advantages that enable it to effectively compete with other global distributors. These advantages include the expertise and proven track record of its management team, as well as its affiliation with the Foxconn Technology Group, a widely recognised and globally respected entity that maintains strong business relationships with numerous international brands. To optimise its financial performance, the Group will persist in managing its tied-up working capital by enhancing inventory turnover days and mitigating inventory risk, ultimately aiming to shorten the cash conversion cycle.

Throughout the year, the Group engaged in a continuous evaluation and reassessment of its business model, striving to enhance efficiency and achieve a higher profit margin. Furthermore, the Group remains vigilant in closely monitoring market conditions, enabling it to make necessary adjustments to its strategies and operations as required.

業務回顧(續)

提供IT產品的維修及其他服務支援

於二零二三年,本集團制定了多元化業務分類戰略規劃,專注於發展維修及服務支援分類。本集團為第三方IT產品及帶有我們的自有品牌名稱的視像監控產品提供全方位的售後維護服務。

於本年度,本集團就外包其維修業務工作流程與本公司控股股東訂立一份服務框架協議(屬於持續關連交易),包括但不限於電子產品(包括但不限於手提電話、手提電話顯示屏及藍牙耳機)之維修及增值服務,包括檢查、維修、組裝、測試、包裝、倉儲、物流、相關報關服務及採購所需材料。該安排可擴大本集團維修服務業務的範圍及增加其收入來源。詳情請參閱本報告第26至28頁所載董事會報告「持續關連交易」一節。

按業務線劃分之分類資料

截至二零二三年十二月三十一日止年度,銷售及分銷IT產品之收入繼續為最大的收入來源,佔本集團總收入約87.4%(二零二二年:約97.1%)。銷售及分銷IT產品之收入乃源自銷售及分銷第三方IT產品及帶有我們的自有品牌名稱之視像監控產品。

BUSINESS REVIEW (continued)

Provision of repairs and other service support of IT products

During the year 2023, the Group has made strategic plan to diversify our business segments and focus on developing the repairs and service support segment. The Group provide full range of after-sales maintenance services for third-party IT products as well as video surveillance products with our own brand name.

During the year, the Group entered into a service framework agreement (which constitutes a continuing connected transaction) with the Company's controlling shareholder for outsourcing its repair business workflow, including but not limited to maintenance and value-added services (including checking, maintenance, assembly, testing, packaging, warehousing, logistic, related custom declaration services and sourcing of required material) for electronic products (including but not limited to mobile phone, mobile phone display, and Bluetooth earpieces). This arrangement can broaden the range of the Group's repair services business and increase its revenue sources. Please refer to the section headed "CONTINUING CONNECTED TRANSACTIONS" included in the Directors' Report set out on page 26 to 28 of this report for details.

Segment information by business line

During the year ended 31 December 2023, the revenue from sales and distribution of IT products continued to be the largest source of income which accounted for approximately 87.4% (2022: approximately 97.1%) of the total revenue of the Group. Revenue from sales and distribution of IT products is generated from sales and distribution of third-party IT products and video surveillance products carrying our own brand name.

維修及服務支援的收入由截至二零二二年十二月三十一日止年度之約10,815,000港元增至截至二零二三年十二月三十一日止年度之約19,133,000港元。該分類收入增加乃主要由於帶有我們的自有品牌名稱的視像監控產品以外的電子產品服務支援擴展所致。

The revenue generated from repairs and service support increased from approximately HK\$10,815,000 for the year ended 31 December 2022 to approximately HK\$19,133,000 for the year ended 31 December 2023. The increase in revenue from this segment was mainly due to the expanded service support of electronic products in addition to video surveillance products carrying our own brand name.

截至二零二三年十二月三十一日止年度,香港、日本及美國在各自對本集團收入貢獻方面成為本集團三大市場。香港市場為最大市場,於截至二零二三年十二月三十一日止年度佔本集團總收入約73.5%(二零二二年:約10.5%)。截至二零二三年十二月三十一日止年度,日本市場佔本集團總收入約17.3%(二零二二年:約1.9%),而美國市場佔本集團總收入約4.0%(二零二二年:約56.3%)。澳洲市場於年內保持相對穩定,於截至二零二三年十二月三十一日止年度佔本集團總收入約3.7%(二零二二年:約1.9%)。台灣及荷蘭市場的發展有大幅變動,於截至二零二三年十二月三十一日止年度佔本集團總收入分別約0.0%及0.0%(二零二二年:約20.1%及8.5%)。收入組成變動乃由於各所在地區IT產品的供求情況引致之產品組合變動所致。

產品開發

憑藉管理團隊在國際分銷方面的經驗,本集團已進一步擴大其於多個司法權區之消費者電子產品供應,完善其現有業務範圍。3C產品主要是二手及經翻新的部件。本集團透過其國際分銷渠道於售後循環經濟中延長3C產品的使用年期。

During the year ended 31 December 2023, Hong Kong, Japan and the United States became the top three markets of the Group in terms of their respective contribution to the revenue of the Group. The Hong Kong market was the largest market and contributed approximately 73.5% (2022: approximately 10.5%) of the Group's total revenue for the year ended 31 December 2023. The Japan market contributed approximately 17.3% (2022; approximately 1.9%) and the United States market contributed approximately 4.0% (2022: approximately 56.3%) of the Group's total revenue for the year ended 31 December 2023. The Australia market remained relatively steadily during the year and contributed approximately 3.7% (2022: approximately 1.9%) of the Group's total revenue for the year ended 31 December 2023. There was a significant change in market development in Taiwan and Netherlands markets, which contributed approximately 0.0% and 0.0% respectively (2022: approximately 20.1% and 8.5%) of the Group's total revenue for the year ended 31 December 2023. The change in the composition of the revenue was due to the change of product mix driven by the demand and supply of the IT products in each of the geographical location.

PRODUCT DEVELOPMENT

Building upon the experience of the management team in international distribution, the Group has further expanded its consumer electronics product offering in multi-jurisdictions that are complementary to its current business offering. 3C Products are mainly used and refurbished units. Through the Group's international distribution channels, the Group extends the 3C Products useful life in the post-sales circular economy.

產品開發(續)

本集團亦已推出若干新產品,包括車牌識別系統的配件(包括顯示幕、照明燈及各種支架)、具有物體跟蹤功能的30倍變焦高速球及現有中央報警監控系統的升級版。

有關本集團之業務風險

本集團未必能緊貼視像監控行業技術轉變以保持競 爭力

本集團持續投資研發以發展升級及開發新產品,以維持本集團之市場競爭優勢。本集團之表現取決於本集團發展其現有產品升級及開發新產品之能力,而此乃由本集團開發緊貼最新行業技術趨勢之技術研究工作及本集團及時招募具備相關技能之人員而釐定。有關產品規格之新興及未來技術轉變對本集團的研發計劃或技術水平之影響無法預測。

此外,我們的競爭對手可能會開發質素及/或價格優於我們之技術及產品。未能順應技術發展及維持或提升我們的業內競爭力或維持我們的客戶基礎,可能導致利潤率降低及市場份額流失,而我們的財務表現及盈利能力可能受到不利影響。

本集團的保險可能不足以涵蓋所有與其業務營運有 關之損失

本集團為其辦事處及因業務中斷而引致的損失或損害、公眾責任及僱員補償投購保險。保險的涵蓋範圍未來可能不足以涵蓋與本集團的業務及營運有關包之所有風險。倘出現未獲承保損失或損失超出承保限額(包括該等由自然災害及其他超出本集團控制範圍之外的事件所導致之損失),本集團可能需要透過其自身資金支付損失、損害賠償及負債,而這或會對其當務、財務狀況及經營業績造成重大不利影響。即使保險涵蓋範圍足以涵蓋其直接損失,本集團可能需要負責間接虧損。此外,本集團之申索記錄可能會影響保險公司日後所收取的保費。

儘管上述,本集團認為當前保險範圍足以應付其現有 業務規模及本集團將會不時檢討保險政策。

The Group also launched several new products, including accessories for license plate recognition system including display boards, lighting and various mountings, 30x zoom high speed dome with object tracking capabilities and upgrades of the existing central alarm surveillance systems.

BUSINESS RISK RELATING TO THE GROUP

The Group may not be able to keep up with technological changes in the video surveillance industry in order to remain competitive

The Group has continuously invested in research and development to develop updates and new products in order to maintain the Group's competitive edge in the market. The performance of the Group depends on the Group's ability to develop updates to its existing products and to develop new products, which in turn is determined by the Group's research efforts to develop technologies which keep up with the latest technological trends in the industry and the Group's timely recruitment of personnel with the relevant skills. The effect of emerging and future technological changes in relation to product specifications to the Group's research and development plans or the level of technologies is unpredictable.

In addition, our competitors may develop technologies and products that are superior to ours in terms of quality and/or price. Failure to respond to the technological developments and maintain or enhance our competitiveness within the industry or maintain our customer base may result in decrease in profit margins and loss of market share, and our financial performance and profitability may be adversely affected.

The Group's insurance may be insufficient to cover all losses associated with its business operations

The Group maintains insurance policies against loss or damage to its office and business interruption, public liability and employees' compensation. The insurance coverage may be insufficient to cover all the risks associated with the Group's business and operations in the future. In the case of an uninsured loss or a loss in excess of insured limit, including those caused by natural disasters and other events beyond the Group's control, the Group may be required to pay for losses, damages and liabilities out of its own funds, which could materially and adversely affect its business, financial conditions and results of operations. Even if the insurance coverage is adequate to cover its direct losses, the Group may need to be responsible for the indirect losses. Furthermore, claim records of the Group may affect the premiums which insurance companies charge in the future.

Despite of the above, the Group considers that the current insurance coverage is sufficient for its existing operation scale and the Group will review its insurance policies from time to time.

MANAGEMENT DISCUSSION AND ANALYSIS

業務前景

本集團的業務包括兩個不同的業務分類,即銷售及分銷IT產品以及提供維修及其他服務以支援IT產品。本集團以戰略性及有條理的方式,有計劃地加強及鞏固其維修及服務支援分類,旨在提升盈利能力及所用資本回報率。

同時,本集團調整其銷售及分銷分類的業務模式,專 注於分銷毛利率較高的IT產品,提高整體流動性。

展望未來,本集團管理層擬分配額外資源以進一步發展本集團維修及服務支援分類。此外,本集團將積極探索「循環經濟」領域內的合適投資機會,履行我們對可持續發展及負責任的商業行為的承諾,鞏固「綠色科技」。

財務回顧

收入

本集團主要從事兩個業務分類,即(i)銷售及分銷IT產品;及(ii)維修及服務支援。截至二零二三年十二月三十一日止年度,本集團總收入約為152,137,000港元,較截至二零二二年十二月三十一日止年度約368,160,000港元減少約58.7%。收入減少乃主要由於調整業務模式(如上文「業務回顧」一段所述)後銷售及分銷分類的分類收入下降所致。

銷售成本

銷售成本之主要部分為存貨成本。與業務量減少一致,截至二零二三年十二月三十一日止年度之銷售成本較截至二零二二年十二月三十一日止年度約341,591,000港元減少約59.5%至約138,346,000港元。淨存貨撥備撥回(計入銷售成本)約為200,000港元,而於截至二零二二年十二月三十一日止年度淨存貨撥備約46,000港元,說明年內滯銷存貨有所減少。

BUSINESS OUTLOOK

The Group's operations encompass two distinct business segments, namely, the sales and distribution of IT products and the provision of repairs and other services to support IT products. With a strategic and methodical approach, the Group executed a planned process to enhance and fortify its repairs and service support segment, aiming to improve profitability and the return on capital employed.

Simultaneously, the Group made adjustments to its business model for the sales and distribution segment, focusing on distributing IT products with higher gross margins to enhance overall liquidity.

Looking ahead, the management of the Group intends to allocate additional resources to further develop the repairs and service support segment of the Group. Additionally, the Group will actively explore suitable investment opportunities within the realm of the "Circular Economy," aligning with our commitment to sustainability and responsible business practices to foster "Green Technology".

FINANCIAL REVIEW

Revenue

The Group mainly engages in two business segments, namely, (i) sales and distribution of IT products; and (ii) repairs and service support. The Group's total revenue amounted to approximately HK\$152,137,000 for the year ended 31 December 2023, representing a decrease of approximately 58.7% as compared to that of approximately HK\$368,160,000 for the year ended 31 December 2022. The decrease in revenue was mainly due to the drop in segment revenue of the sales and distribution segment following the adjusted business model as explained in the paragraph headed "Business Review" above.

Cost of sales

A major component of the cost of sales was the cost of inventories. In line with the decrease in business volume, the cost of sales for the year ended 31 December 2023 decreased to approximately HK\$138,346,000, representing a decrease of approximately 59.5%, as compared to that of approximately HK\$341,591,000 for the year ended 31 December 2022. There was a net reversal of provision of inventories (included in the cost of sales) amounting to approximately HK\$200,000 as compared to a net inventory provision of approximately HK\$46,000 for the year ended 31 December 2022 to account for the decrease in slow-moving inventories during the year.

財務回顧(續)

毛利及毛利率

截至二零二三年十二月三十一日止年度,毛利減少約12,778,000港元至約13,791,000港元(二零二二年:約26,569,000港元),與業務量減少一致。整體毛利率由截至二零二二年十二月三十一日止年度的約7.2%增加至截至二零二三年十二月三十一日止年度的約9.1%。整體毛利率增加乃主要由於維修及服務支援分類增長,較銷售及分銷分類的毛利率更高所致。

銷售及分銷成本

年內,本集團設法將其銷售及分銷成本削減約69.8%。截至二零二三年十二月三十一日止年度,銷售及分銷成本減至約1,665,000港元(二零二二年:約5,518,000港元)。銷售及分銷成本主要部分為員工成本、二手設備回收及數據擦除成本以及倉儲費用。於本年度,本集團重新設計銷售及分銷業務模式,以提高效率並節省員工成本、設備回收及數據擦除成本。

行政費用

截至二零二三年十二月三十一日止年度,行政費用由約14,559,000港元減少約8.9%至約13,265,000港元。 憑藉營運效率的提高及嚴格的財務政策,本集團能夠將其行政費用保持在合理較低水平。

年內純利

儘管總收入減少,但本集團於本年度產生更多的利潤。由於營運效率提高及銷售及分銷開支及行政費用減少以及使用權益法入賬之應佔一間聯營公司純利增加,截至二零二三年十二月三十一日止年度,本集團錄得純利約6,615,000港元,較截至二零二二年十二月三十一日止年度的約5,061,000港元增加約30.7%或1,554,000港元。

於二零二三年,每股基本盈利增至約25.14港仙,而二零二二年約為21.60港仙。

存貨及應收賬款

於二零二三年十二月三十一日,存貨水平降至約562,000港元(二零二二年十二月三十一日:約1,563,000港元)。存貨結餘大幅減少乃由於將存貨周轉天數調低以加強存貨管理,有助於釋放投資資本並減少倉儲成本。本集團將持續監控存貨水平及降低存貨風險,旨在縮短現金周轉週期。

FINANCIAL REVIEW (continued)

Gross profit and gross profit margin

Gross profit decreased by approximately HK\$12,778,000 to approximately HK\$13,791,000 for the year ended 31 December 2023 (2022: approximately HK\$26,569,000), which was in line with the decrease in business volume. The overall gross profit margin increased from approximately 7.2% for the year ended 31 December 2022 to approximately 9.1% for the year ended 31 December 2023. The increase in overall gross margin was mainly due to the growth in repairs and service support segment which generates better gross profit margin than the sales and distribution segment.

Selling and distribution costs

The Group managed to cut its selling and distribution costs by approximately 69.8% for the year. Selling and distribution costs decreased to approximately HK\$1,665,000 for the year ended 31 December 2023 (2022: approximately HK\$5,518,000). A major component of the selling and distribution costs was staff costs, take-back and data wiping cost for used devices and warehousing charges. During the year, the Group has re-designed its business model for the sales and distribution business to improve efficiency and to save staff costs and devices take-back and data wiping cost.

Administrative expenses

During the year ended 31 December 2023, administrative expenses decreased by approximately 8.9% from approximately HK\$14,559,000 to approximately HK\$13,265,000. With improvements in operating efficiencies and rigorous financial policy, the Group has been able to keep its administrative expenses reasonably low.

Net profit for the year

Despite the decrease in total revenue, the Group generated more profit during the year. The Group recorded a net profit of approximately HK\$6,615,000 for the year ended 31 December 2023, representing an increase of approximately 30.7% or HK\$1,554,000 when compared to approximately HK\$5,061,000 recorded during the year ended 31 December 2022 as a result of the improved operation efficiency and decrease in selling and distribution expenses and administrative expenses as well as the increase in share of net profit of an associate accounted for using the equity method.

Basic earnings per share increased to approximately HK25.14 cents in 2023, compared with approximately HK21.60 cents in 2022.

Inventories and trade receivables

As at 31 December 2023, the inventory level decreased to approximately HK\$562,000 (31 December 2022: approximately HK\$1,563,000). The significant reduction in inventory balance was attributable to strengthened inventory management through reducing the inventory turnover days, which helps to release investment capital and reduces warehousing costs. The Group will continue to monitor the inventory level and reduce the inventory risk, with an aim to shorten the cash conversion cycle.

於二零二三年十二月三十一日,應收賬款大幅增加至約26,789,000港元(二零二二年十二月三十一日:約6,656,000港元)。應收賬款增加乃由於本集團向還款紀錄良好的忠實客戶提供額外的信貸額度。於本年度內,本集團的客戶維持良好信貸記錄,故並無確認重大應收賬款減值。

主要財務表現

選擇於本年報內呈列上述財務數據,是因為其對本集 團本財政年度及/或過往財政年度之綜合財務報表 構成重大財務影響,其變動可能顯著影響收入及溢 利。本集團認為透過呈列該等財務數據之變動可有效 說明本集團本年度之財務表現。

股息

Inventories and trade receivables (continued)

Trade receivables increased significantly to approximately HK\$26,789,000 as at 31 December 2023 (31 December 2022: approximately HK\$6,656,000). Such increase in trade receivables was attributable to the additional credit limits granted to the Group's loyal customers after proven sound repayment record. During the year, customers of the Group maintain good credit history and no material impairment of trade receivables is recognised.

Key financial performance

The above financial data were chosen to be presented in this annual report as they constitute a material financial impact on the consolidated financial statements of the Group for the current financial year and/or the previous financial year, that a change of which could affect the revenue and profit conspicuously. It is believed that the Group can effectively explain the financial performance of the Group for the year by presenting the changes of these financial data.

DIVIDENDS

The Board does not recommend the payment of a final dividend for the year ended 31 December 2023 (2022: Nil).

DIVIDEND POLICY

The Company does not have a policy to distribute dividends in a fixed amount or based on a fixed payment ratio. The Company's dividend policy is to consider, the following factors before declaring or recommending dividends:

- the general financial condition of the Group;
- the Group's actual and future operations and liquidity position;
- the Group's expected working capital requirements and future expansion plans:
- the Group's debt to equity ratios and the debt level;
- the restrictions on payment of dividends that may be imposed by the Group's lenders (if any);
- the retained earnings and distributable reserves of the Company and each of the members of the Group;
- the general market conditions; and
- any other factors that the Board deems appropriate.

Declaration of dividend by the Company is also subject to any restrictions under the laws of Cayman Islands, the memorandum and articles of association of the Company and any applicable laws, rules and regulations.

僱員薪酬乃根據個人職責與表現而定,亦已計及現行市場水平以確保競爭力。本集團向全體僱員提供之其他附帶福利包括醫療保險、退休福利及酌情花紅。

本集團為員工職業發展提供培訓計劃,使僱員得到更好的培訓及高效工作,有利於本集團的長遠發展。培訓計劃根據目標和目的分為兩類:內部培訓及外部培訓。例如,需要處理應謹慎處置的IT產品的僱員會參加有關危險品條例的外部培訓計劃。就內部培訓而言,本公司於香港辦公室定期舉辦團隊建設活動及研討會,以增強團隊精神。本集團透過為僱員提供在工作天內參與持續專業發展及培訓課程及培訓資助支持員工培訓計劃。

本公司於二零一六年十一月十一日之股東週年大會 上批准及採納一項購股權計劃。

流動資金、財政資源及資本負債率

截至二零二三年十二月三十一日止年度,本集團以內部產生之資源為其日常營運撥付資金。於二零二三年十二月三十一日,本集團流動資產淨值約為136,060,000港元(二零二二年十二月三十一日:約142,332,000港元)及現金及現金等價物為約104,485,000港元(二零二二年十二月三十一日:約138,122,000港元)。於二零二三年十二月三十一日,本集團並無未償還借款。

於二零二三年十二月三十一日,資本負債率(按本集團總債務除總權益之基準計算)約為4.2%(二零二二年:約8.6%)。

EMPLOYEE AND REMUNERATION POLICY

As of 31 December 2023, the Group employed 18 (31 December 2022: 17) employees in Hong Kong and 14 (31 December 2022: 15) employees in the China and overseas offices. The staff costs of the Group, including Directors' emoluments, employees' salaries and commissions, retirement benefit scheme contributions and other benefits amounted to approximately HK\$11,373,000 for the year ended 31 December 2023 (2022: approximately HK\$12,605,000).

Employees are remunerated in accordance with individual's responsibility and performance, also taking into account the prevailing market rates to ensure competitiveness. Other fringe benefits such as medical insurance, retirement benefits and discretionary bonus are offered to all employees.

The Group provides training programmes for staff professional development so that the employees are better equipped and work efficiently which are favourable to the long-term development of the Group. Training programmes are classified into two types based on target and purpose: internal training and external training. For example, external training programmes related to Dangerous Goods Regulations are attended by our employees who need to deal with those IT products that should be handled with care. Whereas for internal training, the Company organises team building activities and workshops regularly in the Hong Kong office in order to enhance team spirit. The Group supports staff training programmes by offering employees to attend continuing professional development and training courses during working days and training sponsorship.

A share option scheme was approved and adopted at the annual general meeting of the Company on 11 November 2016.

LIQUIDITY, FINANCIAL RESOURCES AND GEARING RATIO

During the year ended 31 December 2023, the Group financed its daily operations with internally generated resources. As at 31 December 2023, the Group had net current assets of approximately HK\$136,060,000 (31 December 2022: approximately HK\$142,332,000) and cash and cash equivalents of approximately HK\$104,485,000 (31 December 2022: approximately HK\$138,122,000). The Group had no borrowings outstanding as at 31 December 2023.

As at 31 December 2023, the gearing ratio, which is calculated on the basis of total debts over total equity of the Group, was approximately 4.2% (2022: approximately 8.6%).

截至二零二三年十二月三十一日止年度,本集團持有 4Square Return GmbH (「4Square」) 21%的股權,於 綜合財務狀況表被分類為本集團於一間聯營公司之權益。如本公司二零一八年六月四日的公告所披露,本集團以代價1,600,000歐元 (相當於約14,508,000港元) 收購4Square 2股股份,佔4Square全部已發行股本21%權益。截至二零二三年十二月三十一日,本集團所持4Square權益的賬面值約為9,670,000港元,約 佔本集團截至二零二三年十二月三十一日的綜合資產總額5.9%。4Square主要從事合規諮詢及提供收集及回收服務等業務。儘管4Square於二零二三財年並無宣派股息,本集團截至二零二三年十二月三十一日止年度的綜合財務報表已入賬溢利約1,593,000港元(即本集團應佔4Square業績)。詳情請參閱綜合財務報表附註12。

本集團管理層將通過密切監察投資表現及結果,勤勉 監控投資回報並進行全面分析。本集團管理層旨在確 保資源的最佳分配及作出符合本集團目標與發展軌 跡的投資戰略。

CAPITAL STRUCTURE

As at 31 December 2023, the Company had an authorised share capital of HK\$80,000,000 divided into 400,000,000 shares of a par value of HK\$0.20 each, of which 23,433,783 shares of the Company (the "Share(s)") were in issue. No convertible securities, options, warrants or similar rights by the Company or its subsidiaries were outstanding during the year.

The Group did not have any borrowings during the year ended 31 December 2023.

SIGNIFICANT INVESTMENT

During the year ended 31 December 2023, the Group held 21% interest in 4Square Return GmbH ("4Square"), which was classified as the Group's interest in an associate in the consolidated statement of financial position. As disclosed in the announcement of the Company dated 4 June 2018, the Group acquired 2 shares in 4Square which represent 21% of the entire issued share capital of 4Square at a consideration of EUR1,600,000 (equivalent to approximately HK\$14,508,000). The carrying amount of the Group's interest in 4Square was approximately HK\$9,670,000 as at 31 December 2023, which represents approximately 5.9% of the total consolidated assets of the Group as at 31 December 2023. 4Square is principally engaged in businesses including compliance consulting and the provision of take back services etc. While no dividend was declared by 4Square during FY2023, a profit of approximately HK\$1,593,000 representing the Group's share of results of 4Square was recorded in the consolidated financial statements of the Group for the year ended 31 December 2023. For further details, please refer to note 12 to the consolidated financial statements.

The management of the Group will diligently monitor and conduct thorough analyses of the return on investment by closely observing the performance and outcomes of the investments. The management of the Group aims to ensure optimal allocation of resources and make investment strategy that align with the Group's objectives and growth trajectory.

Save as disclosed, the Group did not hold any significant investments during the year ended 31 December 2023.

MATERIAL ACQUISITIONS AND DISPOSALS OF SUBSIDIARIES, ASSOCIATES AND JOINT VENTURES

The Group did not make any material acquisitions and disposals of subsidiaries, associates and joint ventures for the year ended 31 December 2023.

FUTURE PLAN FOR MATERIAL INVESTMENTS OR CAPITAL ASSETS

To continue executing its investment plan of augmenting its international distribution and fulfilment capabilities, the Group may, depending on circumstances and market conditions, consider the need for fundraising and/or financing from time to time in order to strengthen its human resources, plant and equipment and working capital. This will enable the Group to not only serve the distribution and fulfilment requirements of its own products, but also acquire the capabilities to support strategic third-party business partners with innovative revenue models with a view to delivering enhanced value to the Shareholders.

In addition, to accelerate the Group's capabilities to offer innovative revenue models in relation to IT hardware distribution and fulfilment support, the Board may contemplate selective strategic investments by means of stock and/or cash when suitable opportunities arise.

FOREIGN EXCHANGE EXPOSURE

The Group mainly operates in Hong Kong, Japan, Australia, Taiwan, US and Europe with most of the transactions settled in HK\$, United States dollars ("USD") and Euro. The Group is exposed to foreign exchange risk from various currencies, primarily with respect to USD and Euro. The management of the Group has formulated a policy to manage the foreign exchange risk against the functional currencies of the Group. It mainly includes managing the foreign exchange risk by performing regular reviews of the Group's net foreign exchange exposures and would consider the use of foreign exchange contracts to manage foreign exchange risks, where appropriate. The Group did not enter into any foreign currency derivative financial instruments for the year ended 31 December 2023. The Group did not use any financial instruments for hedging purposes during the year ended 31 December 2023 (2022: Nil).

CONTINGENT LIABILITIES

As of 31 December 2023, the Group did not have any material contingent liabilities (31 December 2022: Nil).

The annual caps of the Services Framework Agreement (the "Service Caps") for the financial years ended 31 December 2020, 2021 and 2022 are HK\$55,000,000, HK\$61,000,000 and HK\$67,000,000, respectively.

Based on the applicable size tests performed with respect to the Service Caps under the Service Framework Agreement, as all of the applicable percentage ratios in respect of the Services Caps are higher than 5% and more than HK\$10,000,000 on an annual basis, the Service Transactions are subject to the reporting, annual review, announcement and independent Shareholders' approval requirements under Chapter 20 of the GEM Listing Rules. Based on the applicable size tests performed with respect to the Sale Caps under the Sale Framework Agreement, as the highest applicable percentage ratio in respect of the Sale Caps are more than 5% but less than 25% and the Sale Caps are less than HK\$10,000,000 on an annual basis, the Sale Transactions are only subject to the reporting, annual review and announcement requirements but is exempt from the independent Shareholders' approval requirement under Chapter 20 of the GEM Listing Rules.

Service Agreement

On 28 April 2023, the Company entered into a service framework agreement (the "Service Agreement") with Hon Hai for outsourcing its repair business workflow, including but not limited to maintenance and value-added services (including checking, maintenance, assembly, testing, packaging, warehousing, logistic, related custom declaration services and sourcing of required material) for electronic products (including but not limited to mobile phone, mobile phone display, and Bluetooth earpieces) (the "Transactions of Services") for a term from 28 April 2023 to 31 December 2025. The annual caps of the Service Agreement (the "Caps") for the financial years ended 31 December 2023, 2024 and 2025 are HK\$8,500,000, HK\$8,900,000 and HK\$9,300,000, respectively.

Based on the applicable size tests performed with respect to the Caps under the Service Agreement, as the highest applicable percentage ratio in respect of the Caps are more than 5% but less than 25% and the Caps are less than HK\$10,000,000 on an annual basis, the Transactions of Services are only subject to the reporting, annual review and announcement requirements but is exempt from the independent Shareholders' approval requirement under Chapter 20 of the GEM Listing Rules.

The Board and senior management of the Company commit to achieve a high standard of corporate governance, to maintain good corporate governance practice for improvement of accountability and transparency in operations and to strengthen the internal control and risk management systems from time to time so as to protect the rights of the Shareholders and enhance Shareholder value. This Corporate Governance Report helps the Shareholders to understand and evaluate the corporate governance practices of the Company.

Appendix 15 (renamed as Appendix C1 with effect from 31 December 2023) to the GEM Listing Rules sets out the principles of good corporate governance. During the year ended 31 December 2023, the Company has complied with the code provisions set out in Part 2 of the CG Code save for deviations from code provisions C.1.6 and F.2.2 as Mr. Kao Chao Yang (non-executive Director), Mr. Li Robin Kit Ling (independent non-executive Director) and Mr. Miao Benny Hua-ben (independent non-executive Director) were not able to attend the annual general meeting on 12 May 2023 due to prior business commitment. The Board and the Management

The Board is responsible for the overall leadership of the Group, overseeing the Group's strategic decisions and monitoring the business and performance of the Group. During the year, the Board has reviewed and approved the annual results of the Group for the year ended 31 December 2022, quarterly results of the Group for three months ended 31 March 2023, interim results of the Group for six months ended 30 June 2023 and quarterly results of the Group for nine months ended 30 September 2023. It has also reviewed and approved for the changes in Directors and chairman of the Board and the Company Secretary and process agent of the Company; and the Group's continuing connected transactions during the year. The chairman is primarily responsible for providing leadership to the Board and the Chief Executive Officer is primarily responsible for overseeing and leading the day-to-day operation with the assistance of senior management. The roles of chairman and chief executive officer are separate and performed by different persons to ensure balance of power and authority. During the year, the chairman of the Board held a meeting with the independent non-executive Directors without the presence of other Directors on 14 April 2023. An updated list of Directors is published on the websites of the Company and the Stock Exchange.

Representation of Independent Non-executive Directors

In compliance with Rule 5.05(1) and (2) of the GEM Listing Rules, the Company has appointed three independent non-executive Directors and at least one of them possesses the appropriate professional qualifications or accounting or related financial management expertise. The culture of openness at the Board facilitates effective communication and contribution of the Directors. Independent non-executive Directors represent not less than one-third of the Board and provide independent views and opinions to the Board in decision making. The independent non-executive Directors are invited to serve on various committees of the Company as detailed above. The independent non-executive Directors are expressly identified in all corporate communications pursuant to code provision B.1.1 of the CG Code.

The independent non-executive Directors play a significant role in the Board as they bring an impartial view on the Group's strategies, performance and control, as well as ensure that the interests of all Shareholders are considered. All independent non-executive Directors possess appropriate academic, professional qualifications or related financial management experience. None of the independent non-executive Directors held any other offices in the Company or any of its subsidiaries or is interested in any Shares.

The Nomination Committee is primarily responsible for identifying and nominating, for approval by the Board, suitably qualified candidates to become members of the Board as additional Directors or to fill casual vacancies.

The Company has adopted a Director nomination policy (the "Director Nomination Policy") in accordance with the CG Code. The Director Nomination Policy sets out the selection criteria and process in relation to nomination and appointment of the Directors and the considerations for the Board succession planning and aims to ensure that the Board has a balance of skills, experience and diversity of perspectives appropriate to the requirements of the Company's business.

The Nomination Committee identifies candidates for directorship from various channels, including but not limited to internal promotion, referral by management of the Group and external recruitment agents. The Nomination Committee may also receive nomination of candidates for election as Director(s) from Shareholder(s).

After the candidates are identified, the Nomination Committee will consider the biographical information of the candidates and evaluate the candidates based on certain criteria and make recommendation to the Board accordingly.

A range of factors are taken into consideration to identify a suitably qualified candidate. These include:-

- character and integrity of the candidate;
- educational background, qualifications (including professional qualifications),
 knowledge and experience of the candidate which are relevant to the business and operation of the Group;
- time commitment of the candidate to the Group, taking into consideration the other duties of the candidates; and
- the Board diversity policy of the Company.

The Nomination Committee shall also monitor and review the implementation of the Director Nomination Policy, as appropriate from time to time, and will report to the Board annually. During the year, the Nomination Committee has reviewed the Director Nomination Policy and considered it effective.

The Company recognises and embraces the benefits of having a diverse Board to the quality of its performance. The Board diversity policy sets out some guidelines for the composition of the Board in order to achieve diversity in the Board. The Company aims to have a diverse Board composition measurable by objective criteria, including gender, age, length of service in the Group, educational background and professional qualifications. Given the nature of the business of the Group, the Company considers that it is beneficial for the Board to have some members with experience and qualification in the information technology industry, in addition to members with financial and legal qualification.

The Board recognises the benefits of gender diversity. It has at least one female representation on the Board since 2016. While the Board considers that gender diversity may bring more diversified views at Board level, gender is not the only factor to be taken into account in considering appointment to the member of the Board. The Director's appointment is made on merits after considering a number of factors including the educational background, professional experience, skills and knowledge of the candidate. Hence, the Board does not set any particular targets on the minimum number of female representation at the Board. The Board and the Nomination Committee will closely monitor and review from time to time the composition of the Board, identify suitable female candidates from senior management and will take into account the Board diversity policy including gender diversity in considering appointment to the member of the Board with an aim to maintaining female representation at the Board.

As at 31 December 2023, gender ratio is approximately 22 (male):10 (female) in workforce and approximately 7 (male):1 (female) in senior management which is regarded by the Board as satisfactory and in line with the industry of that the Group operates its businesses in. The Company has not set any objectives for gender ratio in workforce or in senior management. Appointment is primarily made on merits of the candidate after considering a number of factors including the educational background, professional experience, skills and knowledge of the candidate. The Group shall further strengthen the gender diversity in the workforce in the future where appropriate.

The Company will continue to use its best efforts to maintain a diverse Board measurable by objectives which are appropriate to the needs of the Company's business. Appointment to the member of the Board will be based on merit and contribution a candidate may bring to the Board, having due regards for the benefits of diversity on the Board.

During the year, the Nomination Committee has reviewed the membership, structure and composition of the Board according to the Board diversity policy of the Company, and is of the opinion that the structure of the Board is reasonable, gender diversity has been achieved in respect of the Board and the experiences and skills of the Directors in various aspects and fields can enable the Company to maintain high standard of operation.

Term of Appointment and Rotation

The current Directors (including independent non-executive Directors) are appointed for an initial term of one year and should continue thereafter unless and until terminated by either party by giving to the other not less than three months' notice in writing. Please refer to the paragraph headed "Directors' Letters of Appointment" of the Directors' Report for details on the service contracts/letters of appointment of Directors who served the Company during the year ended 31 December 2023.

Article 84(1) of the articles of association of the Company provides that at each annual general meeting one-third of the Directors for the time being (or, if their number is not a multiple of three (3), the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at an annual general meeting at least once every three years. Accordingly, Mr. Han Chun-Wei, Mr. Li Robin Kit Ling and Mr. Miao Benny Hua-ben will retire from office by rotation at the forthcoming annual general meeting. They, being eligible, will offer themselves for re-election pursuant to Article 84(2) of the articles of association of the Company.

The Nomination Committee has also recommended to the Board that the above-mentioned Directors are eligible for re-election, upon evaluating the respective Director against the selection criteria mentioned above and the independence of Mr. Li Robin Kit Ling and Mr. Miao Benny Hua-ben.

The Directors have participated in continuous professional development by attending training courses or reading relevant materials on the topics related to corporate governance and regulations, roles, functions, duties and responsibilities of directors as well as the latest amendments to the GEM Listing Rules.

To assist the Board in discharging its duties, the Board is supported by three Board committees, namely the audit committee of the Company (the "Audit Committee"), the Remuneration Committee and the Nomination Committee. The terms of reference for the abovementioned committees are published on the websites of the Stock Exchange and the Company.

The Audit Committee

The Audit Committee has adopted written terms of reference in compliance with code provisions D.3.3 and D.3.7 of the CG Code.

During the year ended 31 December 2023, members of the Audit Committee were Mr. Li Robin Kit Ling (chairman), Mr. Yeung Wai Hung Peter and Mr. Miao Benny Hua-ben, all of whom are independent non-executive Directors. At the discretion of the Audit Committee, executive Directors and/or senior management personnel overseeing the Group's finance may be invited to attend meetings of the Audit Committee. The Audit Committee normally meets two times a year and also meets the external auditors twice without the presence of the executive Directors. The Audit Committee held four meetings during the year.

The duties of the Audit Committee include, among other things, reviewing and monitoring the financial and internal control systems, risk management system, audit plan and relationship with external auditors, arrangements to enable employees of the Company to raise, in confidence, concerns about possible improprieties in financial reporting, and internal control or other matters of the Company. The Audit Committee is responsible for reviewing the truth and fairness of the Company's financial statements, annual report, interim report and quarterly reports, discusses with the external auditors the nature and scope of audit before the audit commences as well as the findings and recommendations raised by the auditors during and after completion of the audit. The Audit Committee conducts an assessment, at least annually, of the effectiveness of the Group's internal control and financial controls system, risk management system, scope of work and appointment of external auditors and arrangements for employees to raise concerns about possible improprieties. This allows the Board to monitor the Group's overall financial position and to protect its assets. The chairman of the Audit Committee summarises activities of the Audit Committee, highlights issues arising therefrom, and prepares recommendations for reporting to the Board after each meeting.

The external auditors perform independent statutory audit on the Group's financial statements and as part of the audit engagement, report to the Audit Committee any significant deficiencies (if any) in the Group's internal control system which might come to their attention during the course of audit.

The primary duties of the Nomination Committee are to implement the Company's Board diversity policy by reviewing the composition of the Board, identifying suitable candidates for the appointment and re-election of Directors, assessing the independence of independent non-executive Directors and monitoring the succession planning of Directors.

During the year, the Nomination Committee evaluated the appointment of Mr. Chang Chuan-Wang as a non-executive Director on 14 April 2023 and the Directors standing for re-election at the annual general meeting of the Company held on 12 May 2023 against the selection criteria mentioned in the paragraph headed "Nomination and Board Diversity" above and made recommendations to the Board on the same, and assessed the independence of the independent non-executive Directors.

Upon the Company's specific enquiry, each of the Directors has confirmed that during his/her tenure as Director for the year ended 31 December 2023, he/she had fully complied with the required standard of dealings and there was no event of noncompliance.

The Board is responsible for performing the functions set out in code provision A.2.1 of the CG Code.

The Board has reviewed the Company's corporate governance policies and practices, continuous professional development of the Directors, the Company's policies and practices on compliance with legal and regulatory requirements, the Company's compliance of the GEM Listing Rules, and the Company's compliance with the CG Code and disclosure in the Corporate Governance Report.

RISK MANAGEMENT AND INTERNAL CONTROL

The Board has overall responsibility for the design, implementation, monitoring and review of the Group's risk management, and internal control systems to ensure their effectiveness and efficiency. The objective of internal control is to safeguard the Company's assets and ensure its accounting records are properly maintained, so that all the financial information is accurate and reliable. The Group has adopted a series of internal control policies and procedures designed to provide reasonable assurance for achieving the objectives including effective and efficient operations, reliable financial reporting and compliance with applicable laws and regulations. All employees are committed to continually enhancing the risk management measures to ensure that these measures work in line with the growth of the Group's business strategies and are integrated into day-to-day operation of the business. The Board together with the Audit Committee annually review its risk management and internal control system.

The objectives of the risk management and internal control of the Group include:

- establishing and constantly improving the risk management and internal control system;
- ensuring the Group's risk management and internal control in compliance with the GEM Listing Rules requirements;
- implementing the top-down approach and bottom-up approach that covers every aspect of the business; and
- managing rather than eliminating the risk of failure to achieve business objectives and providing reasonable and not absolute assurance against material misstatement or loss.

In order to continually improve the Group's internal control and risk management system, the Group has established an ongoing process for identifying, evaluating and managing the significant risks faced by the Group. The key procedures that the Group has established and implemented are summarised as follows:

- segregating duties and functions of the respective operational departments of the Group;
- reviewing systems and procedures to identify, measure, manage and control risks; and
- updating the staff handbook, internal control manual and compliance manual where there are changes to business environment or regulatory guidelines.

The Board, by the top-down approach, has a particular focus on determining the nature and extent of significant risks it is willing to take in achieving the business strategies of the Group.

Each department of the Group is responsible for identifying its own risks and designing, implementing and monitoring the relevant risk management and internal control systems. The process involves the maintenance of staff handbook, internal control manual and compliance manual setting out the particulars of material risks together with the control measures as reported by significant departments of the Group. This bottom-up approach is integrated into day-to-day operation and complements the top-down strategic view by identifying the principal risks and ensuring the significant risks to be considered by the Board in determining the risk appetite and the adequacy of resources, staff qualifications and experience, training programmes and budget of the Company's accounting and financial reporting function. Such risks would include, amongst others, material risks relating to the environment, society and governance.



The Board conducted a review of the effectiveness of the risk management and internal control systems during the year under review, based on the advice received from Premier Advisory Services Limited, an independent internal control consultant, and the Audit Committee. The review covered the effectiveness of the Group's risk management and internal control system including financial, operational and compliance controls for the financial year.

The Board discussed with the Audit Committee on major findings and control issues. The Board considered that the Group has implemented appropriate procedures safeguarding the Group's assets and ensure its accounting records are properly maintained and in compliance of the relevant laws and regulations. In addition, the Board also considered the adequacy of resources, staff qualifications and experience, training programmes and budget of the Group's accounting and financial reporting function.

內部審核

企業管治守則之守則條文第D.2.5條規定發行人應設立內部審核職能。

本集團並無內部審計部門進行內部審核。於年內,董事會對本集團狀況進行檢討,認為鑒於本集團規模相對較小,於本集團設立內部審計部門不具成本效益。內部審計部門通常負責分析及獨立評估本集團風險管理及內部監控系統是否充分有效。儘管本集團並無設立內部審計部門,董事會聽取晉悅諮詢服務有限公司(獨立內部控制顧問)所及審核委員會意見履行審核職能。有關董事會檢討風險管理及內部監控系統詳情,請參閱上文各段。

董事會將每年檢討過去一年風險管理及內部監控系統之執行情況及有效性。經於年內檢討風險管理及內部監控系統,董事會認為其對本集團而言屬有效及充分。

反貪污政策及舉報政策

本集團信奉公平及誠信的商業交易,不容忍其任何業務經營中的貪污、賄賂、洗錢及其他欺詐活動。本集團嚴格遵守相關規例及法例,如《防止賄賂條例》(香港法例第201章)及《打擊洗錢及恐怖分子資金籌集條例》(香港法例第615章)。

在僱傭合約中,本集團要求員工嚴格遵守商業道德準則。如有利益衝突,需要及時向本集團管理層匯報。參與業務營運及代表本公司的專業形象的員工,嚴禁利用商機取得個人利益或好處。不同的服務合約金額,須由不同級別的管理人員審批。

於截至二零二三年十二月三十一日止年度,本集團概不知悉任何違反有關賄賂、勒索、欺詐及洗錢的法律及法規,因而對本集團構成重大影響的事件。

本集團已採納舉報政策以鼓勵及令僱員及與本集團 交易之人士可向本集團提出其重要關注事宜。該政策 令僱員於發現有關財務申報、合規及其他失職等可能 出現的不當行為後第一時間以適當方式向審核委員 會提出真誠關注,而不必擔心遭受報復。

Internal Audit

Code provision D.2.5 of the CG Code provides that the issuer should have an internal audit function.

The Group does not have an internal audit department for performing internal audit. During the year, the Board reviewed the situation of the Group and considered that setting up an internal audit department within the Group is not cost-effective given the relative small size of the Group. An internal audit function generally carries out the analysis and independent appraisal of the adequacy and effectiveness of the Group's risk management and internal control systems. Despite the absence of such a department within the Group, the internal audit function is performed by the Board with the advice from Premier Advisory Services Limited, an independent internal control consultant, and the Audit Committee. Please refer to the paragraphs above on the Board's review of the Risk Management and Internal Control Systems for details.

The Board would review the implementation and effectiveness of the risk management and internal control systems over the past year on an annual basis. Having reviewed the risk management and internal control systems during the year, the Board considers they are effective and adequate for the Group.

ANTI-CORRUPTION POLICY AND WHISTLEBLOWING POLICY

The Group believes in fairness and honesty in business dealing and does not tolerate corruption, bribery, money laundering and other fraudulent activities in connection with any of its business operations. The Group strictly adheres to relevant regulations and laws, such as the Prevention of Bribery Ordinance (Cap. 201 of the Laws of Hong Kong) and the Anti-money Laundering and Counter-terrorist Financing Ordinance (Cap. 615 of the Laws of Hong Kong).

The Group requires employees to strictly conform to the code of business ethics as stipulated in the employment contracts. Cases of conflict of interest must be reported to the Group's management. Employees who engage in business operations and represent the Company's professional image are strictly prohibited from using business opportunities for personal interest or benefit. Service contracts in different amounts are required to be examined and approved by different levels of management.

For the year ended 31 December 2023, the Group was not aware of any cases of non-compliance with laws and regulations that have a significant impact on the Group in relation to bribery, extortion, fraud, and money laundering.

The Group has adopted a whistleblowing policy to encourage and enable employees and those who deal with the Group to raise serious concerns within the Group. The policy allows employees to raise genuine concerns about possible improprieties in financial reporting, compliance, and other malpractice, at the earliest opportunity and in an appropriate way with Audit Committee, without fear of reprisal.

董事確悉其就編製本公司截至二零二三年十二月三十一日止年度之綜合財務報表之責任。董事負責監督編製本公司財務報表以確保該等財務報表真實而公平地反映本公司事務狀況。董事並不知悉任何有關可能導致本公司持續經營能力受重大質疑之事件或情況之重大不明朗因素。因此,董事於編製綜合財務報表時繼續採納持續經營法。

本公司核數師知悉其須就報告期間綜合財務報表承 擔獨立核數師報告之申報責任。

The Company has formulated and established the procedures and internal controls for the handling and dissemination inside information. The Company has adopted a code of conduct for dealing in securities of the Company by the Directors in accordance with Rules 5.46 to 5.67 of the GEM Listing Rules. Other employees of the Group who are likely to be in possession of inside information of the Company are also subject to similar dealing restrictions. 

環境

本集團致力以可持續及負責任之方式營運,並更加重視環境、社會及管治考慮,以確保長期繁榮。

排放物

本集團明白本身作為負責任企業之角色,旨在盡量減少營運對環境之影響,同時透過制訂環境及社會政策並採取當中之措施促進財務增長。

儘管本集團業務並無任何大規模排放或對環境造成重大影響,但我們仍然致力於節約及保護環境,因此我們採取一系列措施實現該項目標。雖然本集團本身的營運不會對環境構成重大影響,但任何產生有害廢棄物之工序(如製造IT產品之過程)均外判予授權經銷商進行妥善處理。本集團之溫室氣體排放主要來自於使用照明系統、空調及辦公設備所消耗之電力。本集團將繼續積極監察並管理所有業務營運對環境之影響,盡量減少排放。

由於本集團已在其業務營運中考慮環境之可持續發展,故此本集團管理層定期監察其環境表現。例如,購買前考慮所用之物料及設備是否對環境有害及是否能夠有效節省能源。此外,本集團亦預設辦公室溫及空調系統之使用時間,以減少能源消耗及碳排放。我們亦鼓勵僱員採用虛擬會議,在可行之情況下避免商務差旅。本集團在業務營運中並無工業或車輛使用,因此我們並無發現固定及移動燃燒排放之紀錄。本集團之主要溫室氣體(「溫室氣體」)排放類別為辦公用電,其因生產所購電力間接產生溫室氣體排放。

ENVIRONMENT

The Group is devoted to operating in a sustainable and responsible manner, and places greater emphasis on ESG considerations to ensure long-term prosperity.

Emissions

The Group understands its role as responsible enterprise and aims at minimising the impact of its operation on the environment while facilitating its financial growth by establishing the environmental and social policies and adopting the measures therein.

Despite the fact that the Group is engaged in business without any mass emissions or significant impact to the environment, we remain committed to conserving and protecting the environment, and as such, we have implemented a series of measures to achieve this goal. While the Group's own operations do not have a significant impact on the environment, any process that generate hazardous waste, such as the manufacturing of IT products, are outsourced to authorized dealers for proper handling. The Group's GHG emissions are mainly attributed to the consumption of electricity from using the lighting system, airconditioning, and office equipment. The Group will continue to actively monitor and manage the environmental effect of all operations striving to minimise its emissions to the greatest extent possible.

Since the Group has taken into consideration of environmental sustainability in its business operations, the management of the Group monitors its environmental performance regularly. For example, the environmental harmfulness and the capacity of energy-saving of materials and equipment used are considered prior to purchase. Furthermore, at the Group's offices, the indoor temperature and the running time of air-conditioning system are preset to reduce energy consumption and carbon emissions. We also encourage employees to make use of virtual meetings and conferences to avoid business travel whenever applicable. The Group has no industry or vehicle usage in the operation of our business therefore we have noted no record of stationary and mobile combustion emission. The major type of greenhouse gas ("GHG") emissions of the Group is consumption of electricity for office use, which produced indirect GHG emissions resulting from the generation of purchased electricity.

廢棄物管理

本集團僅在日常辦公室運作中產生生活廢棄物、紙張等無害固體廢棄物。由於本集團產生之無害廢棄物較少,均由物業管理部門收集處理,因此無法取得相關關鍵績效指標(「關鍵績效指標」)。為減少無害廢棄物之數量,本集團委聘清潔承包商處理敏感紙本文件之回收。廢紙、塑料瓶及鋁罐將分類收集,放入辦公室指定之回收箱內。

由於辦公室用紙量會加重對林業資源的負擔,本集團 已積極提倡以下「減少使用、物盡其用及循環再造」政 策,以推廣節約用紙:

減少使用:鼓勵員工閱讀電子文件取代打印文件或雙面打印以實行無紙化辦公。

物盡其用:在打印機及影印機旁邊放置收集單面廢紙的盒子,鼓勵員工使用單面廢紙作草稿打印。使用過的紙盒亦會留作儲物用途。

循環再造:收集打印機及影印機使用過的墨水盒和碳粉盒,以循環利用。除節約用紙措施外,我們亦使用KHAN-NA紙張(獨特的可持續纖維),從而緩解全球變暖。

Waste Management

The Group only generate non-hazardous solid wastes such as domestic wastes and paper in daily office operations. As the Group produces insignificant number of non-hazardous wastes, they are collected and processed by the property management, hence the related Key Performance Indicators ("KPI") are unavailable. In order to reduce the number of non-hazardous wastes, the Group engages a cleaning contractor to handle recycling of sensitive paper documents. Paper wastes, plastic bottles and aluminium cans would be collected separately by putting them in the designated recycle boxes in offices.

As paper usage in the office would impose burden on forestry resources, the Group has actively promoted the "Reduce, Reuse and Recycle" policy to promote paper conservation as follows:

Reduce: encourages staff to read electronic files instead of printing out documents or printing on both sides to create a paperless office.

Reuse: installs boxes next to printers and photocopying machines to collect used single-sided papers, encourages employees to use these papers for draft print out. Reuses paper boxes for storage purposes.

Recycle: used ink and toner cartridges of printers and photocopying machines are collected for recycling. Other than saving paper measures, we also use KHAN-NA paper, a unique model of sustainable fibre, which mitigates global warming.

資源使用

基於本集團的業務性質,本集團辦公室的能源消耗、 用電量及耗水量並未高度倚賴能源消耗及水資源。由 於我們於香港辦公室的耗水量微乎其微並由樓宇管 理處管理,故無法擷取耗水量數據,亦無法披露相關 關鍵績效指標。由於耗水量微乎其微,故並無設定用 水效率目標。我們於報告期間在尋找符合目標的水源 方面並無任何問題。

本集團保護自然資源並致力創建著重環保的工作氛圍。本集團透過節約用電、鼓勵循環利用辦公用品及於其營運的過程中使用著重環保的設備及工具,努力降低對環境的影響。

空調系統維持在25攝氏度,亦予以定時,致使其將於非辦公時間內自動關閉。盡可能使用自然光,並在不使用時關閉照明及電氣設備。辦公用品消耗管理方面,本集團鼓勵員工盡可能使用電子文檔方式處理文件。如必需使用紙張,除打印正規文件及重要機密文件外,建議採用雙面打印。此外,我們已於辦公室安裝視頻會議系統,藉以減少商務差旅產生的排放及提高溝通效率。

Use of Resources

Due to the Group's business nature, the energy, power, and water utilisation of the Group's offices do not rely heavily on energy consumption nor water resources. Since our water consumption in the Hong Kong office is minimal and managed by the building management, therefore the data for water consumption cannot be retrieved and the disclosure for the related KPI is unavailable. As water consumption has been minimal, no water efficiency target has been set. We did not have any issues in sourcing water fit for purpose during the Reporting Period.

The Group is committed to building an environmentally friendly working atmosphere that conserves natural resources. The Group strives to minimise environmental impact by saving electricity, encouraging recycling of office supplies, and using environmentally friendly equipment and tools in its operations.

The air-conditioning system is maintained at 25 degrees Celsius. Additionally, a timer is set to automatically switch off the system during non-office hours. Deploy natural light as much as possible and switch off lighting and electrical devices when not in use. For office consumables consumption management, the Group encourages its employees to handle documents electronically. When the use of paper is necessary, double-sided printing is suggested except the printing for formal and confidential documents. In addition, video-conference systems have been installed in our offices to reduce business travel emissions and increase communication efficiency.

Comprehensive recruitment procedures are required to be performed to check and verify the age of a job applicant before the Group hires him/her. The procedures require a job applicant to present their valid proof of identity to ensure that they have reached the legal working age and are eligible to work in certain countries. Important details such as job duties, locations and working hours of the staff are also set out clearly in the employment contract to protect their rights and interests and forced labour is strictly prohibited. Applicant who is suspected to have false academic qualifications and working experience will not be employed. In addition, the Group is committed its staff with a safe, healthy, comfortable working environment with labour protection, reasonable remuneration, working hours and various welfare.

During the Reporting Period, the Group was not aware of any cases of non-compliance with laws and regulations that have a significant impact on the Group in relation to preventing child and forced labour.

Health and Safety

The Group follows the guidelines from the labour departments of regional subsidiaries to set up the occupational health and safety measures of the Group. Our operations fully comply with applicable laws and regulations such as the Occupational Safety and Health Ordinance (Chapter 509), Employees' Compensation Ordinance (Chapter 282), Laws of Hong Kong; the Occupational Safety and Health Act of Taiwan and the Health; and the Work Health and Safety Act 2011 of Australia.

In addition, safety procedures are established for potentially hazardous work, internal guidelines are included in the Group's employee handbook to improve their awareness of workplace safety. Employees who have health and safety concerns or identify potential hazards should contact their department head or the senior human resources officer. All employees are provided with necessary protective equipment and are covered by medical insurance.

The Group has maintained a healthy and safe working environment and recorded none of reported lost days due to work-related injuries and there were no work-related fatalities during each of the past three years (including the Reporting Period). For the year ended 31 December 2023, the Group is not aware of any non-compliance with the relevant health and safety laws and regulations that have a significant impact on the Group.

For example, external training programmes related to Dangerous Goods Regulations are attended by our employees who need to deal with those IT products that should be handled with care. Whereas for internal training, the Company organises leadership and management skills as well as team building activities and workshops regularly in the Hong Kong office to enhance team spirit. The Group supports staff training programmes by offering employees to attend continuing professional development and training courses during working days and training sponsorship. Product Responsibility

The Group aims to achieve the highest possible standard with all the products and services provided. The Group has established relevant policies which cover service quality guarantee, safety, fair advertising, and after-sale services to ensure that relevant measures comply with the laws and regulations.

The Group pays close attention to the quality and safety of its products and services. During the Reporting Period, there were no products or shipped subject to be recalled for safety and health reasons and the Group did not receive any complaints or requests to terminate the relationship due to poor quality and safety. If a complaint should arise, the Group will immediately assess the complaint and conduct an internal investigation into the matter to identify the source of the issue. The Group has a close connection with customers. If customers are not satisfied with the quality and safety of the services, the Group will arrange sufficient channels and staff to support customers' communication and provide solutions as soon as possible.

As innovation and new ideas are the key elements of IT products, and the routine work of the Group always involves the intellectual property rights of customers, suppliers, and the Group, therefore protection of intellectual property rights is extremely important. Protective clauses are included in the contracts signed with both customers and suppliers to safeguard intellectual property rights. The Group also reviews every operational contract to ensure that the contract safeguards the intellectual property rights of the parties. To adhere to the Group's intellectual property policy, it is mandatory to acknowledge all source materials used in presentations or written documents, including written, and refrains from using any ideas, products, or goods without proper authorisation.

To ensure the information and data of our clients are always under secure protection, the Group requires technical specialists to sign confidentiality agreements. All employees are required to keep any such client data that may be disclosed to them or learned by them confidential. We are also committed to protecting the privacy of our employees, subcontractors and clients in accordance with our code of practice states in our Employee Handbook and relevant regulations, such as the Personal Data (Privacy) Ordinance (Chapter 486), Laws of Hong Kong.

Anti-corruption

We believe in fairness and honesty in business dealing and we do not tolerate corruption, bribery, money laundering and other fraudulent activities in connection with any of our business operations. The Group strictly adhere to relevant regulations and laws, such as the Prevention of Bribery Ordinance (Chapter 201), the Anti-Money Laundering and Counter-Terrorist Financing Ordinance (Chapter 615), Laws of Hong Kong.

The Group requires employees to strictly conform to the code of business ethics as stipulated in the employment contracts and Employee Handbook. 於二零一八年七月十九日, 貴集團收購4Square Return GmbH(「**4Square**」)之21%股權,且 貴集團有權獲得於二零二三年收購4Square之餘下股權之認購期權及授予4Square其他股東權利於 貴集團在認購期權屆滿後三個月內未行使認購期權的情況下向 貴集團購回4Square之21%股權之購回期權(「**收購事項**」)。

於4Square之總投資成本為14,508,000港元。作為回報, 貴集團於收購日期有權獲得4Square之21%股權及一份認購期權及購回期權。

於收購日期, 貴集團於綜合財務狀況表內將於 4Square (作為一間聯營公司) 之投資6,569,000港元及公平值7,939,000港元之認購期權及購回期 權確認為衍生金融工具。

管理層基於外聘估值師編製之獨立估值報告評估 認購期權及購回期權於年結日之公平值。

由於該等期權於年結日之公平值所使用之管理層 判斷(包括該聯營公司之收入增長率及貼現率)屬 重大,我們將該事項識別為關鍵審計事項。

These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

Valuation of derivative financial instrument in relation to the associate

Refer to Notes 3.3, 4(b) and 17 to the consolidated financial statements

On 19 July 2018, the Group acquired 21% equity interest of 4Square Return GmbH ("**4Square**") and the Group was entitled to a call option to acquire the remaining equity interest of 4Square in 2023 and a buy-back option that entitled the other shareholders of 4Square to buy back 21% equity interest in 4Square from the Group if the Group does not exercise the call option within three months after call option expires (the "**Acquisition**").

The total cost of the investment in 4Square was HK\$14,508,000. In return, the Group is entitled to 21% of equity interest in 4Square and a call option and buy-back option at the date of the acquisition.

The Group recognised the investment in 4Square as an associate amounted to HK\$6,569,000 and the call option and buy-back option at a fair value of HK\$7,939,000 as derivative financial instruments in the consolidated statement of financial position at the date of acquisition.

Management performed the assessment of the fair value of the call option and buy-back option at year end based on an independent valuation report prepared by an external valuer.

We identified this matter as a key audit matter because of the significance management judgement used in the fair value of the options at year end including the revenue growth rate of the associate and the discount rate.

- We evaluated the competence, capabilities and objectivity of the independent external valuer;
- We assessed the appropriateness of the valuation methodology and the underlying assumptions adopted by management in determining the fair value of the call option and buy-back option with the involvement of our in house valuation expert; and
- We evaluated the key assumptions used based on our understanding of the business of the associate and by comparing the market available data.

CircuTech International Holdings Limited (the "Company") and its subsidiaries (together, the "Group") is principally engaged in the sales and distribution of IT products, and the provision of repairs and other service support of IT products.

The Company is a limited liability company incorporated in the Cayman Islands. The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman, KY1-1111, Cayman Islands.

The Company has its primary listing on GEM of the Stock Exchange.

These consolidated financial statements are presented in Hong Kong dollars ("**HK\$**"), unless otherwise stated.

2 SUMMARY OF MATERIAL ACCOUNTING POLICIES

This note provides a list of the material accounting policies adopted in the preparation of these consolidated financial statements. These policies have been consistently applied to all the years presented, unless otherwise stated. These consolidated financial statements are for the Group consisting of CircuTech International Holdings Limited and its subsidiaries.

2.1 Basis of preparation

(i) Statement of compliance

These consolidated financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations (hereinafter collectively referred to as the "HKFRSs") as issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and the disclosure requirements of the Hong Kong Companies Ordinance. In addition, these consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on GEM of the Stock Exchange.

Accrued benefits derived from employers' mandatory MPF contributions cannot be used to offset the LSP/SP in respect of the employment period after the Transition Date.

The pre-transition LSP/SP is calculated using the last month's salary immediately preceding the Transition Date, instead of using the salary of employment termination date.

Due to the complexities of the accounting for the offsetting of accrued benefits derived from an employer's MPF contributions and its LSP obligation and the accounting for offsetting mechanism could become material in light of the Abolitionm, the HKICPA published 'Accounting implications of the abolition of the MPF-LSP offsetting mechanism in Hong Kong (the "Guidance") in July 2023 to provide guidance to account for the offsetting mechanism and the Abolition. The HKICPA concluded that there are two acceptable accounting approaches, for the offsetting mechanism being:

Approach 1: Account for the amount expected to be offset as a deemed employee contribution towards that employee's LSP benefits in terms of HKAS 19.93(a)

Approach 2: Account for the employer MPF contributions and the offsetting mechanism as a funding mechanism for the LSP obligation

Since there is no specific guidance in HKAS 19 on the accounting of the interaction between the employer MPF contributions and entity's LSP obligation, the Group developed its own accounting policy on the offsetting mechanism in prior years. The Abolition has been considered and accounted for following the Group's accounting policy on the offsetting mechanism in 2022.

In prior years, the Group's LSP liability before the expected offsetting under the MPF-LSP offsetting mechanism was insignificant. After the Guidance is published which provides additional guidance on accounting for the offsetting mechanism, the Group has changed the accounting policy to account for the offsetting mechanism to Approach 1 indicated in the Guidance, to better reflect the substance that the employers' mandatory MPF contributions are deemed contributions by employee towards the LSP benefits. This is because the amount of LSP that an employer has to pay is net of the offsetable accrued benefits, but such offsetable accrued benefits have already been vested with the employees. In effect, an employee is required to use his own money (the vested MPF benefits) to fund a portion of his own LSP benefits. As such, the offsetable accrued benefits are regarded as a deemed employee contribution to the LSP benefits.

The Group has applied this voluntary change in accounting policy retrospectively.

Amendments to HKAS 7 and HKFRS 7, Supplier Finance Arrangements

The amendments clarify the characteristics of supplier finance arrangements and require additional disclosure of such arrangements. The disclosure requirements in the amendments are intended to assist users of financial statements in understanding the effects of supplier finance arrangements on an entity's liabilities, cash flows and exposure to liquidity risk. Early adoption is permitted, but will need to be disclosed.

The Directors do not anticipate that the application of these amendments in the future will have a material impact on the consolidated financial statements.

Amendments to HKFRS 16, Lease Liability in a Sale and Leaseback

The amendments to HKFRS 16 specify the requirements that a seller-lessee uses in measuring the lease liability arising in a sale and leaseback transaction to ensure the seller-lessee does not recognise any amount of the gain or loss that relates to the right of use it retains. The amendments are effective for annual periods beginning on or after 1 January 2024 and shall be applied retrospectively to sale and leaseback transactions entered into after the date of initial application of HKFRS 16 (i.e. 1 January 2019). Earlier application is permitted.

The amendments clarify with situations where there is a sale or contribution of assets between an investor and its associate or joint venture. When the transaction with an associate or joint venture that is accounted for using the equity method, any gains or losses resulting from the loss of control of a subsidiary that does not contain a business are recognised in the profit or loss only to the extent of the unrelated investors' interests in that associate or joint venture. Similarly, any gains or losses resulting from the remeasurement of retained interest in any former subsidiary (that has become an associate or a joint venture) to fair value are recognised in the profit or loss only to the extent of the unrelated investors' interests in the new associate or joint venture.

2.3 編製綜合賬目之原則

2.3.1 附屬公司及非控股權益

附屬公司指本集團擁有控制權的所有實體(包括結構實體)。當本集團承受或享有參與實體所得之可變數,且有能力透過其主導實體業務之權力影響該等回報時,則本集團控制該實體。附屬公司自控制權轉移至本集團之日起開始完全綜合入賬。

在本公司的財務狀況表中,對附屬公司的投資按成本減減值虧損(如有)計量。附屬公司的業績由本公司根據已收及應收股息入賬。

於附屬公司之業績及權益之非控股權益分別單獨呈列於綜合全面收益 表、權益變動表及財務狀況表。

2.3.2 聯營公司

聯營公司指本集團對其有重大影響但無控制權或共同控制權的實體,一般附帶擁有其20%至50%投票權。於聯營公司的投資於初步按成本確認後以權益會計法入賬(見下文附註2.3.3)。

2.3.3 權益法

根據權益會計法,投資初步按成本確認,其後進行調整以於損益確認本集團應佔投資對象收購後溢利或虧損,並於其他全面收益確認本集團應佔投資對象其他全面收益的變動。已收或應收聯營公司的股息確認為投資賬面值扣減。

權益入賬投資之賬面值乃根據附註 2.6所述政策進行減值測試。

2.3 Principles of consolidation

2.3.1 Subsidiaries and non-controlling interest

Subsidiaries are all entities (including structured entities) over which the Group has control. The Group controls an entity when the Group is exposed to, or has rights to, variable returns from its involvement with the entity and has the ability to affect those returns through its power to direct the activities of the entity. Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

In the Company's Statement of Financial Position, investments in subsidiaries are measured at cost less impairment loss, if any. The result of the subsidiaries are accounted for by the Company on the basis of dividends received and receivables.

Non-controlling interests in the results and equity of subsidiaries are shown separately in the consolidated statement of comprehensive income, statement of changes in equity and statement of financial position respectively.

2.3.2 Associate

Associate is an entity over which the Group has significant influence but not control or joint control. This is generally the case where the Group holds between 20% and 50% of the voting rights. Investment in an associate is accounted for using the equity method of accounting (see Note 2.3.3 below), after initially being recognised at cost.

2.3.3 Equity method

Under the equity method of accounting, the investment is initially recognised at cost and adjusted thereafter to recognise the Group's share of the post-acquisition profits or losses of the investee in profit or loss, and the Group's share of movements in other comprehensive income of the investee in other comprehensive income. Dividends received or receivable from an associate are recognised as a reduction in the carrying amount of the investment.

The carrying amount of equity-accounted investments is tested for impairment in accordance with the policy described in Note 2.6.

(a) 功能及呈列貨幣

本集團內各實體綜合財務報表內的項目,均以該實體經營業務之主要經濟環境之貨幣(「功能貨幣」)計量。綜合財務報表以港元列賬,其為本公司之功能及呈列貨幣。

(b) 交易及結餘

外幣交易以交易當日之匯率換算為功能貨幣。結算該等交易及按年末 匯率換算以外幣計值之貨幣資產及 負債所產生之匯兌收益及虧損一般 於損益內確認。倘彼等歸屬於境外 業務投資淨額的一部分,則於權益 號延。

2.4 Foreign currency translation

(a) Functional and presentation currency

Items included in the consolidated financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in HK\$, which is the Company's functional and presentation currency.

(b) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are generally recognised in profit or loss. They are deferred in equity if they are attributable to part of the net investment in a foreign operation.

Foreign exchange gains and losses that relate to borrowings are presented in profit or loss, within "finance costs". All other foreign exchange gains and losses are presented in profit or loss on a net basis within "administrative expenses".

Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was determined. Translation differences on assets and liabilities carried at fair value are reported as part of the fair value gain or loss. For example, translation differences on non-monetary assets and liabilities such as derivative financial instruments are recognised in profit or loss as part of the fair value gain or loss and translation differences on non-monetary assets such as financial assets at fair value through other comprehensive income ("FVOCI") are recognised in other comprehensive income.

2.5 Property, plant and equipment

Property, plant and equipment are stated at acquisition cost less accumulated depreciation and impairment loss, if any. Depreciation is calculated using the straight-line method to allocate their cost or revalued amounts, net of their residual values, over their estimated useful lives or, in the case of leasehold improvements, the shorter lease term as follows:

Leasehold improvements3 to 5 yearsFurniture and fixtures5 yearsOffice equipment3 to 5 yearsMachinery5 years

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount (Note 2.6).

2.6 Impairment of non-financial assets

Property, plant and equipment, right-of-use assets and interest in an associate are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less costs of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets ("cash-generating units"). Nonfinancial assets other than goodwill that suffered an impairment are reviewed for possible reversal of the impairment at the end of each reporting period.

2.7.1 分類

本集團將其金融資產劃分為以下計 量類別:

- 其後將按透過損益按公平值 列值計量者(見2.8),

分類取決於本集團管理金融資產之 業務模式及現金流量之合約條款。

就按透過其他全面收益按公平值列值之資產而言,收益及虧損將計入其他全面收益。就並非持作買賣之權益工具投資而言,其將取決於本集團是否於最初確認時行使不可撤銷選擇權,以將權益投資入賬為透過其他全面收益按公平值列值。

本集團於及僅於管理該等資產之業 務模式改變時,方會重新分類債務 投資。

2.7.2 確認及終止確認

常規購入及出售的金融資產於交易日期(即本集團承諾買賣該資產之日期)予以確認。倘從金融資產收取現金流量之權利已到期或經已轉讓,而本集團已將其擁有權之絕大部分風險及回報轉讓時,則會終止確認金融資產。

2.7.3 計量

於初步確認時,本集團按金融資產 之公平值加直接歸屬於收購金融資 產之交易成本計量該項金融資產。

於確定具有嵌入衍生工具之金融資產之現金流量是否僅為支付本金及利息時,需從金融資產之整體進行考慮。

2.7.1 Classification

The Group classifies its financial assets in the following measurement categories:

- those to be measured subsequently at fair value through profit or loss (see 2.8),
- those to be measured subsequently at fair value through OCI, and
- those to be measured at amortised cost (see 2.9),

The classification depends on the Group's business model for managing the financial assets and the contractual terms of the cash flows.

For assets measured at fair value through OCI, gains and losses will be recorded in OCI. For investments in equity instruments that are not held for trading, this will depend on whether the Group has made an irrevocable election at the time of initial recognition to account for the equity investment at FVOCI.

The Group reclassifies debt investments when and only when its business model for managing those assets changes.

2.7.2 Recognition and derecognition

Regular way purchases and sales of financial assets are recognised on trade-date, the date on which the Group commits to purchase or sell the asset. Financial assets are derecognised when the rights to receive cash flows from the financial assets have expired or have been transferred and the Group has transferred substantially all the risks and rewards of ownership.

2.7.3 Measurement

At initial recognition, the Group measures a financial asset at its fair value plus transaction costs that are directly attributable to the acquisition of the financial asset.

Financial assets with embedded derivatives are considered in their entirety when determining whether their cash flows are solely payment of principal and interest.

權益工具

本集團後續按公平值計量所有權益 投資。倘本集團管理層選擇於其他 全面收益呈列權益投資之公平值收 益及虧損,終止確認投資後概無至 續重新分類公平值收益及虧損至 益。當本集團收取付款的權利確之 時,該等投資之股息繼續於損益至 時,該等投資之股息繼續於損益至 收益按公平值列值計量之權益投 之減值虧損(及減值虧損撥回)並無 與公平值之其他變動分開列報。

2.7.4 減值

本集團按前瞻性基準評估與按攤銷 成本列賬之債務工具有關之預期信 貸虧損。應用之減值方法取決於信 貸風險是否大幅增加。

就應收賬款而言,本集團採用香港財務報告準則第9號金融工具(「香港財務報告準則第9號」)允許的簡化方法,規定自初步確認應收款起確認全期預期虧損,進一步詳情見附註3.1(b)。

Debt instruments

The Group classifies its debt instruments as follows:

Amortised cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest are measured at amortised cost. Interest income from these financial assets is included in finance income using the effective interest rate method. Any gain or loss arising on derecognition is recognised directly in profit or loss and presented in other gains/(losses) together with foreign exchange gains and losses. Impairment losses are presented as separate line item in the statement of profit or loss.

Equity instruments

The Group subsequently measures all equity investment at fair value. Where the Group's management has elected to present fair value gains and losses on equity investment in OCI, there is no subsequent reclassification of fair value gains and losses to profit or loss following the derecognition of the investment. Dividends from such investments continue to be recognised in profit or loss as other income when the Group's right to receive payments is established. Impairment losses (and reversal of impairment losses) on equity investment measured at FVOCI are not reported separately from other changes in fair value.

2.7.4 Impairment

The Group assesses on a forward looking basis the expected credit losses associated with its debt instruments carried at amortised cost. The impairment methodology applied depends on whether there has been a significant increase in credit risk.

For trade receivables, the Group applies the simplified approach permitted by HKFRS 9 Financial Instruments ("HKFRS 9"), which requires expected lifetime losses to be recognised from initial recognition of the receivables, see Note 3.1(b) for further details.

2.7.4 減值(續)

在釐定自初步確認以來金融資產的 信貸風險是否顯著增加及估計預期 信貸虧損時,本集團會考慮無需付 出過多成本或努力便能取得的合理 及有理據的相關資料。這包括根據 本集團的過往經驗及已知信貸評估 作出的定量及定性資料分析,並包 括前瞻性資料。

倘金融資產逾期超過30天,本集團 假設該金融資產的信貸風險已顯著 增加。

當債務人不大可能在本集團並無追索權採取變現抵押(如持有)等行動的情況下向本集團悉數支付其信貸義務;或金融資產逾期超過90天,本集團認為該金融資產出現違約。

2.8 衍生工具

衍生工具於衍生工具合約訂立當日按公 平值初步確認,其後於各報告期末重新計 量至公平值。任何不符合對沖會計處理的 衍生工具之公平值變動即時於損益確認。

2.9 應收賬款

應收賬款指於正常業務過程中出售貨品或提供服務之應收客戶款項。應收賬款一般應於15至45日內結清,因此,其獲分類為流動。

應收賬款初步按公平值確認,隨後使用實際利率法按攤銷成本減應收賬款減值撥備計量。有關本集團應收賬款之入賬資料及本集團減值政策之描述,見附註2.7。

When determining whether the credit risk of a financial asset has increased significantly since initial recognition and when estimating ECL, the Group considers reasonable and supportable information that is relevant and available without undue cost or effort. This includes both quantitative and qualitative information analysis, based on the Group's historical experience and informed credit assessment and including forward-looking information.

The Group assumes that the credit risk on a financial asset has increased significantly if it is more than 30 days past due.

The Group considers a financial asset to be in default when the debtor is unlikely to pay its credit obligations to the Group in full, without recourse by the Group to action such as realising security (if any is held); or the financial asset is more than 90 days past due.

2.8 Derivatives

Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently remeasured to their fair value at the end of each reporting period. Changes in the fair value of any derivative instrument that does not qualify for hedge accounting are recognised immediately in profit or loss.

2.9 Trade receivables

Trade receivables are amounts due from customers for goods sold or services performed in the ordinary course of business. Trade receivables are generally due for settlement ranging from 15 to 45 days and therefore are all classified as current.

Trade receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment of trade receivables. See Note 2.7 for further information about the Group's accounting for trade receivables and for a description of the Group's impairment policies.

就呈列現金流量表而言,現金及現金等價物包括手頭現金、金融機構活期存款、原到期日為三個月或以下且隨時可轉換為確定金額現金及價值變動風險不重大的其他短期高流動性投資。

2.11 應付賬款及其他應付款

該等金額指於財政年度結束前提供予本 集團之貨品及服務之尚未支付負債。該等 金額為無抵押且一般於確認後30日內支 付。除非款項並非於報告期後12個月內到 期,否則應付賬款及其他應付款乃呈列為 流動負債。其初步按公平值確認及隨後使 用實際利率法按攤銷成本計量。

收益或虧損於終止確認負債時透過攤銷 過程於損益中確認。

2.12 即期及遞延所得稅

本期間之所得稅開支或抵免指就本期間 應課稅收入按各司法權區之適用所得稅 稅率支付之稅項(就暫時性差額及未動用 稅項虧損應佔之遞延稅項資產及負債變 動作出調整)。

(a) 即期所得稅

即期所得稅支出根據本公司附屬公司營運所在及產生應課稅收入的國家於報告期末已頒佈或實質頒佈的稅務法例計算。管理層就適用稅務法例受詮釋所規限的情況定期評估報稅表的狀況,並在適用情況下根據預期須向稅務機關支付的稅款設定撥備。

2.10 Cash and cash equivalents

For the purpose of presentation in the statement of cash flows, cash and cash equivalents includes cash on hand, deposits held at call with financial institutions, other short-term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

2.11 Trade and other pavables

These amounts represent liabilities for goods and services provided to the Group prior to the end of financial year which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition. Trade and other payables are presented as current liabilities unless payment is not due within 12 months after the reporting period. They are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method.

Gains or losses are recognised in profit or loss when the liabilities are derecognised as well as through the amortisation process.

2.12 Current and deferred income tax

The income tax expense or credit for the period is the tax payable on the current period's taxable income based on the applicable income tax rate for each jurisdiction adjusted by changes in deferred tax assets and liabilities attributable to temporary differences and to unused tax losses.

(a) Current income tax

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the end of the reporting period in the countries where the Company's subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation. It establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

(b) Deferred income tax

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantially enacted by the end of the reporting period and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred tax assets are recognised only if it is probable that future taxable amounts will be available to utilise those temporary differences and losses.

Deferred tax liabilities and assets are not recognised for temporary differences between the carrying amount and tax bases of investments in foreign operations where the Company is able to control the timing of the reversal of the temporary differences and it is probable that the differences will not reverse in the foreseeable future.

2.13 Employee benefits

(a) Short-term obligations

Liabilities for wages and salaries, including non-monetary benefits and accumulating sick leave that are expected to be settled wholly within 12 months after the end of the period in which the employees render the related service are recognised in respect of employees' services up to the end of the reporting period and are measured at the amounts expected to be paid when the liabilities are settled. The liabilities are presented as current employee benefit obligations in the statement of financial position.

(b) 退休金責任

界定供款計劃為本集團須向獨立實體支付固定供款之退休金計劃。倘基金之資產於本期間或過往期間並不足以向所有僱員支付與僱員服務有關之福利,則本集團概無任何法律或推定責任支付額外供款。

對於界定供款計劃,本集團以強制性、合約性或自願性方式向公開或私人管理之退休保險計劃供款。本集團作出供款後,即無進一步付款責任。供款於到期時確認為僱員福利開支。預付供款確認為資產,惟以退回現金或可扣減日後付款金額為限。

(c) 花紅計劃

本集團按照計及本公司股東應佔溢 利的公式,在作出若干調整後,就 花紅確認責任及支出。本集團會於 有合約責任或根據過往慣例構成推 定責任時確認撥備。

(d) 離職福利

離職福利於本集團在正常退休日期前終止僱用,或當僱員接受自擁護人會與 遭散以換取此等福利時支付。離和 國於以下日期之較早者確認等福利 福利:(a)本集團無法撤回該等福利 時;及(b)本集團就介乎香港職利 時;37號範圍且涉及支付離職可 運動自願遺散的情況下,之 經過 利乃根據預期接納該要約 到內根據預期接納該要超過十二 目到期支付的福利乃貼現至現值。

(b) Pension obligations

A defined contribution plan is a pension plan under which the Group pays fixed contributions into a separate entity. The Group has no legal or constructive obligations to pay further contributions if the fund does not hold sufficient assets to pay all employees the benefits relating to employee service in the current and prior periods.

For defined contribution plans, the Group pays contributions to publicly or privately administered pension insurance plans on a mandatory, contractual or voluntary basis. The Group has no further payment obligations once the contributions have been paid. The contributions are recognised as employee benefit expense when they are due. Prepaid contributions are recognised as an asset to the extent that a cash refund or a reduction in the future payments is available.

(c) Bonus plan

The Group recognises a liability and an expense for bonuses based on a formula that takes into consideration the profit attributable to the Company's shareholders after certain adjustments. The Group recognises a provision where contractually obliged or where there is a past practice that has created a constructive obligation.

(d) Termination benefits

Termination benefits are payable when employment is terminated by the Group before the normal retirement date, or when an employee accepts voluntary redundancy in exchange for these benefits. The Group recognises termination benefits at the earlier of the following dates: (a) when the Group can no longer withdraw the offer of those benefits; and (b) when the Group recognises costs for a restructuring that is within the scope of HKAS 37 and involves the payment of termination benefits. In the case of an offer made to encourage voluntary redundancy, the termination benefits are measured based on the number of employees expected to accept the offer. Benefits falling due more than 12 months after the end of the reporting period are discounted to present value.

(f) 僱員福利-界定福利計劃

《香港僱傭條例》(「條例」) 項下的長 期服務金被歸類為界定福利計劃。 條例項下合資格僱員在條例規定的 若干情況下有權獲得長期服務金。 對僱主並無法律上的資金要求,本 集團亦無任何安排以清償其日後 的付款責任。本集團的長期服務金 承擔按以下方式計量:長期服務金 承擔總額,採用預測單位信貸法估 算,以到期日與負債條款相近且以 港元(長期服務金承擔的貨幣)計值 的優質公司債券(或政府債券,倘 該等優質公司債券並無深度市場) 的市場收益率貼現為現值;減去負 服務成本。根據條例及強積金計劃 條例,本集團可以本集團強積金供 款之累算權益抵銷本集團的長期服 務金承擔。本集團將該等強積金供 款視為僱員對長期服務金權益的供 款,本質屬於負服務成本。該等視 作供款乃按強積金供款的預期投資 回報率估算,然後採用與長期服務 金承擔總額相同的歸因方法將其歸 入服務期。

(e) Defined contribution schemes

Mandatory provident fund scheme set up and operated under the Mandatory Provident Fund Schemes Ordinance, Cap. 485 ('the MPF Schemes Ordinance') is categorised as a defined contribution plan. Contributions to defined contribution plan are charged to the consolidated statement of comprehensive income when the related services are recognized.

(f) Employee benefits - Defined benefit schemes

Long service payment under the Hong Kong Employment Ordinance ('the Ordinance') is categorised as a defined benefit plan. Employees qualified under the Ordinance are entitled to LSP in certain circumstances specified in the Ordinance. There are no legal funding requirements on employers and the Group does not have any arrangement in place to settle its payment obligation in the future. The Group's obligation to LSP is measured at: Gross LSP obligation which is estimated using the projected unit credit method discounted to its present value using market yields available on high quality corporate bonds (or government bonds if there is no deep market in such high quality corporate bonds) that have maturity dates approximating to the terms of the liabilities and are denominated in Hong Kong Dollars which is the currency of the LSP obligations: less negative service costs. Under the Ordinance and the MFP Schemes Ordinance, the Group can offset the accrued benefits derived from the Group's MPF contributions against the Group's LSP obligations. The Group regards these MPF contributions are deemed contributions by employees towards the LSP benefits. The nature is negative service costs. These deemed contributions are estimated by applying an expected investment return rate on the MPF contributions and then attributed to periods of service using the same attribution method for gross LSP obligation.

Service costs are recognised in profit or loss, and include current and past service costs (including result from a plan amendment).

Interest expense is recognised in profit or loss, and is calculated by applying the discount rate used to measure the LSP obligation at the beginning of the annual period to the balance of the LSP obligation, considering the effects of benefit payments during the period.

Remeasurements of the LSP obligation, including actuarial gains and losses, are recognised in other comprehensive income.

2.14 Share-based payments

Share-based compensation benefits are provided to employees via the "2016 Option Scheme". Information relating to this scheme is set out in Note 25.

Employee options

The fair value of options granted under the 2016 Option Scheme is recognised as an employee benefits expense with a corresponding increase in equity. The total amount to be expensed is determined by reference to the fair value of the options granted:

- including any market performance conditions (e.g. the entity's share price),
- excluding the impact of any service and non-market performance vesting conditions (e.g. profitability, sales growth targets and remaining an employee of the entity over a specified time period), and
- including the impact of any non-vesting conditions (e.g. the requirement for employees to save or holdings shares for a specific period of time).

The total expense is recognised over the vesting period, which is the period over which all of the specified vesting conditions are to be satisfied. At the end of each period, the entity revises its estimates of the number of options that are expected to vest based on the non-market vesting and service conditions. It recognises the impact of the revision to original estimates, if any, in profit or loss, with a corresponding adjustment to equity.

Social security contributions payable in connection with an option grant are considered an integral part of the grant itself and the charges are treated as cash-settled transactions.

When the options are exercised, appropriate amount of shares are transferred to the employee. The proceeds received net of any directly attributable transaction costs are credited directly to equity.

2.15 Provisions

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation and the amount can be reliably estimated. Provisions are not recognised for future operating losses.

Where there are a number of similar obligations, the likelihood that an outflow will be required in settlement is determined by considering the class of obligations as a whole. A provision is recognised even if the likelihood of an outflow with respect to any one item included in the same class of obligations may be small.

Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

倘本集團於有關貨品或服務轉移予 客戶前控制指定貨品或服務,則本 集團為委託人。

2.16 Revenue recognition

(a) Sale and distribution of IT products

Revenue from the sales and distribution of products is recognised at a point in time when control of the products has transferred, being at the point the products are delivered to and have been accepted, and there is no unfulfilled obligation that could affect the customer's acceptance of the products. There is only one performance obligation. Delivery occurs when the products have been shipped to the specified location or picked up by the customer in warehouse, the risks of obsolescence and loss have been transferred to the customer, and either the customer has accepted the products in accordance with the sales contract, the acceptance provisions have lapsed, or the Group has objective evidence that all criteria for acceptance have been satisfied.

Revenue from these sales is recognised based on the price specified in the contract, net of discounts, returns and value added taxes.

A receivable is recognised when the products are delivered and the customers have accepted the products, as this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due.

Principal versus agent

When another party is involved in providing goods or services to a customer, the Group determines whether the nature of its promise is a performance obligation to provide the specified goods or services itself (i.e. the Group is a principal) or to arrange for those goods or services to be provided by the other party (i.e. the Group is an agent).

The Group is a principal if it controls the specified good or service before that good or service is transferred to a customer.

(b) 提供維修及服務支援

本集團提供IT產品之維修、維護及 支援服務。本集團已釐定,於服務 支援之客戶合約中僅有一項履約責 任。就提供服務而言,由於本集團 認為客戶同時收取及使用福利,收 入乃於服務提供予客戶之會計期間 隨時間確認。

(c) 經營租賃之租金收入

經營租賃之租金收入乃按租賃年期 以直線法確認。當本集團向租戶提 供減免時,減免成本在租賃年期按 直線法確認為租金收入的減少額。

(d) 利息收入

利息收入就未償還本金按適用利率 以時間基準累算。

Principal versus agent (continued)

The Group is an agent if its performance obligation is to arrange for the provision of the specified good or service by another party. In this case, the Group does not control the specified good or service provided by another party before that good or service is transferred to the customer. When the Group acts as an agent, it recognises revenue in the amount of any fee or commission to which it expects to be entitled in exchange for arranging for the specified goods or services to be provided by the other party.

(b) Rendering of repairs and service support

The Group provides repair, maintenance and support services for IT products. The Group has determined that for contracts with customers under services support, there is only one performance obligation. For the provision of services, revenue is recognised over time in the accounting period in which the services are rendered to customers as the Group determined that the customer receives and uses the benefits simultaneously.

(c) Rental income under operating leases

Rental income from operating leases is recognised on a straight-line basis over the lease term. When the Group provides incentives to its tenants, the cost of the incentives is recognised over the lease term, on a straight-line basis, as a reduction of rental income.

(d) Interest income

Interest income is accrued on a time basis on the principal outstanding at the applicable interest rate.

使用權資產

使用權資產應按成本確認並將包括:(i)租 賃負債之初步計量金額(見下文有關租賃 負債入賬之會計政策);(ii)於開始日期期 之前作出之任何租賃付款減任何已收取 之租賃獎勵;(iii)承租人產生之任何初步直 接成本及(iv)承租人在租賃條款及條件 定之情況下拆除及移除相關資產時將產 生之估計成本,除非該等成本乃因生產 生之估計成本,除非該等成本乃因生產 隻而產生則另當別論。本集團應用成本 資而產生則另當別論。本據國本模式,本集 團按成本減任何累計折舊及任何減值 損計量使用權資產,並就租賃負債之任何 重新計量作出調整。

租賃負債

租賃負債按並非於租賃開始日期支付之 租賃付款之現值確認。倘租賃隱含之利率 可輕易釐定,則租賃付款採用該利率貼 現。倘該利率無法輕易釐定,本集團採用 其增量借款利率。

Accounting as a lessee

All leases are required to be capitalised in the statement of financial position as right-of-use assets and lease liabilities, but accounting policy choices exist for an entity to choose not to capitalise (i) leases which are short-term leases and/or (ii) leases for which the underlying asset is of low-value. The Group has elected not to recognise right-of-use assets and lease liabilities for low-value assets and leases for which at the commencement date have a lease term less than 12 months. The lease payments associated with those leases have been expensed on straight-line basis over the lease term.

Right-of-use asset

The right-of-use asset should be recognised at cost and would comprise: (i) the amount of the initial measurement of the lease liability (see below for the accounting policy to account for lease liability); (ii) any lease payments made at or before the commencement date, less any lease incentives received; (iii) any initial direct costs incurred by the lessee and (iv) an estimate of costs to be incurred by the lessee in dismantling and removing the underlying asset to the condition required by the terms and conditions of the lease, unless those costs are incurred to produce inventories. The Group measures the right-of-use assets applying a cost model. Under the cost model, the Group measures the right-to-use at cost, less any accumulated depreciation and any impairment losses, and adjusted for any remeasurement of lease liability.

Lease liability

The lease liability is recognised at the present value of the lease payments that are not paid at the date of commencement of the lease. The lease payments are discounted using the interest rate implicit in the lease, if that rate can be readily determined. If that rate cannot be readily determined, the Group uses the Group's incremental borrowing rate.

當租賃條款將租賃資產擁有權之絕大部 分風險及回報轉讓予承租人時,租賃分類 為融資租賃。所有其他租賃均分類為經營 租賃。

經營租賃之租金收入乃按相關租賃年期 以直線法於損益內確認。協商及安排經營 租賃時產生之初步直接成本乃加至租賃 資產之賬面值,並按租期以直線法確認為 一項開支。

並非原租賃條款及條件之一部分之任何 租賃代價範圍變動入賬列作租賃修改。本 集團自實際修改當日起將經營租賃之修 改入賬列作一項新租賃,並按剩餘租賃年 期以直線法或其他系統基準確認餘下租 賃付款為收入。

The following payments for the right-to-use on the underlying asset during the lease term that are not paid at the commencement date of the lease are considered to be lease payments: (i) fixed payments less any lease incentives receivable; (ii) variable lease payments that depend on an index or a rate, initially measured using the index or rate as at commencement date; (iii) amounts expected to be payable by the lessee under residual value guarantees; (iv) the exercise price of a purchase option if the lessee is reasonably certain to exercise that option; and (v) payments of penalties for terminating the lease, if the lease term reflects the lessee exercising an option to terminate the lease.

Subsequent to the commencement date, the Group measures the lease liability by: (i) increasing the carrying amount to reflect interest on the lease liability; (ii) reducing the carrying amount to reflect the lease payments made; and (iii) remeasuring the carrying amount to reflect any reassessment or lease modifications, or to reflect revised in-substance fixed lease payments.

Accounting as a lessor

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership of the leased assets to the lessee. All other leases are classified as operating leases.

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised as an expense on the straight-line basis over the lease term.

Any changes in the scope of the consideration for a lease that was not part of the original terms and conditions of the lease are accounted for as lease modifications. The Group accounts for a modification to an operating lease as a new lease from the effective date of the modification, recognising the remaining lease payments as income on a either a straight-line basis or another systematic basis over the remaining lease term.

Current year profit and loss information has been included where relevant to add further context. The Group's risk management is carried out by a central treasury department ("Group Treasury") under policies approved by the board of directors. Group Treasury identifies, evaluates and mitigates financial risks in close co-operation with the Group's operating units. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

Foreign exchange risk arises from future commercial transactions, recognised assets and liabilities denominated in a currency that is not a functional currency of the relevant group entities. The Group currently does not have a foreign currency hedging policy and has not used any forward contracts, currency borrowings or other means to hedge its foreign currency exposure. The Group manages its foreign currency risk by closely monitoring the movement of the foreign currency rates.

The Group applies the simplified approach to provide for expected credit losses prescribed by HKFRS 9, which permits the use of the lifetime expected credit loss provision for impairment of all trade receivables. To measure the expected credit losses, trade receivables have been grouped based on shared credit risk characteristics. The Group has performed historical analysis and identified the key economic variables impacting credit risk and expected credit loss. It considers available reasonable and supportive forwarding-looking information.

Majority of the Group's revenue is received from individual customers in relation to IT products sold and are transacted in cash or credit. The Group's trade receivables arise from sales of IT products to the customers.

As at 31 December 2023, the top three debtors and the largest debtor accounted for approximately 90.4% and 43.0% (2022: 89.5% and 76.1%), of the Group's trade receivables balance. In view of the history of business dealings with the debtors and the sound collection history of the receivables due from them, management believes that there is no material credit risk inherent in the Group's outstanding receivable balance due from these debtors saved for the debtor related to the impaired trade receivable disclosed in the below. Management makes periodic assessment on the provision for impairment of the trade and other receivables based on background and reputation of the customers, historical payment records, past experience, the length of overdue period, the financial strength of the debtors and whether there are any disputes with the debtors. The directors consider that the Group's expected loss rate to be low and no provision for impairment of trade receivables was made as of 31 December 2023 and 2022.

Trade receivables are written off when there is no reasonable expectation of recovery. Indicators that there is no reasonable expectation of recovery include, amongst others, the failure of a debtor to engage in a repayment plan with the Group, and a failure to make contractual payments for a period of greater than 120 days past due.

As at 31 December 2023 and 2022, the Group has assessed that the expected loss rate for other receivables was immaterial. Thus no loss allowance for other receivables was recognised.

The Group maintains its own treasury function to monitor the current and expected liquidity requirements and aims to maintain flexibility by keeping sufficient cash and cash equivalents generated from operations. At the end of the reporting period, the Group held cash and cash equivalents and trade receivables, respectively, that are expected to readily generate cash inflows for managing liquidity risk.

The table below analyses the Group's non-derivative financial liabilities into relevant maturity groupings based on the remaining period at the consolidated balance sheet date to the contractual maturity date. The amounts disclosed in the table are the contractual undiscounted cash flows. Balances due within 12 months equal their carrying balances as the impact of discounting is not significant.

• 交易對方之特定風險 調整(包括有關信貸違 約率之假設)乃由本集 團內部信貸風險管理 小組釐定之信貸風險 等級得出。 Risk adjustments specific to the counterparties (including assumptions about credit default rates) are derived from credit risk gradings determined by the Group's internal credit risk management group.

• 非上市股本證券之年 度收入增長率及最終 增長率乃根據類似公 司之市場資料估計。 Annual revenue growth rate and terminal growth rate for unlisted equity securities are estimated based on market information for similar types of companies.

第3層公平值之變動於各報告 期末於管理層及財務部進行 半年估值討論時予以分析。 作為有關討論之一部分,財 務部呈列解釋公平值變動之 原因之報告。 Changes in level 3 fair values are analysed at the end of each reporting period during the half-yearly valuation discussion between the management and the finance department. As part of this discussion, the finance department presents a report that explains the reason for the fair value movements.

(a) 估計可使用年期及剩餘價值

本集團釐定其物業、廠房及設備之估計可使用年期、剩餘價值及相關折舊費用。估計乃根據類似性質及功能之物業、廠房及設備之實際可使用年期之過往經驗作出。倘可使用年期少於過往估計之年期,會下數十一次過往估計之年期,會與估計可使用年期有異;而實際經濟則或會與估計可使用年期有異;而實際經濟則或會與估計剩餘價值有異。定期審閱或會導致可折舊之年期及剩餘價值出現變動,而未來期間之折舊開支亦會因而出現變動。

(b) 估計透過其他全面收益按公平值列值之 金融資產及衍生金融工具之公平值

並非於活躍市場買賣之金融工具之公平 值乃使用估值技術釐定。本集團憑藉其 判斷選擇各種方法並作出主要基於各報 告期末存在之市況之假設。所用主要假設 及變動對該等假設之影響之詳情見附註 3.3(a)。

4 CRITICAL ESTIMATES AND JUDGEMENTS

The preparation of financial statements requires the use of accounting estimates which, by definition, will seldom equal the actual results. Management also needs to exercise judgement in applying the Group's accounting policies.

Estimates and judgements are continually evaluated. They are based on historical experience and other factors, including expectations of future events that may have a financial impact on the Group and that are believed to be reasonable under the circumstances.

(a) Estimated useful lives and residual value

The Group determines the estimated useful lives, residual values and related depreciation charges for its property, plant and equipment. This estimate is based on the historical experience of the actual useful lives of property, plant and equipment of similar nature and functions. The Group will increase the depreciation charge prospectively where useful lives are less than previously estimated lives. Actual economic lives may differ from estimated useful lives; actual residual values may differ from estimated residual values. Periodic review could result in a change in depreciable lives and residual values and therefore depreciation expense in the future periods.

(b) Estimation of fair value of financial assets at FVOCI and derivative financial instruments

The fair values of financial instrument that are not traded in an active market is determined using valuation techniques. The Group uses its judgement to select a variety of methods and make assumptions that are mainly based on market conditions existing at the end of each reporting period. For details of the key assumptions used and the impact of changes to these assumptions see Note 3.3(a).

(c) 所得稅

(d) 存貨減值

存貨乃以成本與可變現淨值兩者之較低者計值。倘有客觀證據顯示存貨成本可能無法收回,則將存貨成本撒減至可變現淨值。倘該等存貨老化及損壞、全部或部分陳舊或售價下跌,則存貨成本可能無法收回。倘銷售產生之估計成本增加,則存貨成本亦可能無法收回。撒減至損益之金額為存貨之賬面值與可變現淨值之差額。釐定存貨可否收回時須作出重大判斷。於作出此項判斷時,本集團評估(其中包括)透過各種方式收回款項之時間及程度。

(c) Income taxes

Significant judgement is required in determining the provision for income taxes. There are transactions and calculations during the ordinary course of business for which the ultimate tax treatment is subject to judgement. If the Group considers it is probable that these judgements will result in different tax positions, the most likely amounts of the outcome will be estimated and adjustments to the income tax expense and income tax liabilities will be made accordingly.

Deferred income tax assets relating to certain deductible temporary differences and tax losses are recognised when management considers it is likely that future taxable profits will be available against which the temporary differences or tax losses can be utilised. When the expectations are different from the original estimates, such differences will impact the recognition of deferred income tax assets and income tax charges in the period in which such estimates have been changed.

(d) Impairment of inventories

Inventories are carried at the lower of cost and net realisable value. The cost of inventories is written down to net realisable value when there is an objective evidence that the cost of inventories may not be recoverable. The cost of inventories may not be recoverable if those inventories are aged and damaged, if they have become wholly or partially obsolete, or if their selling prices have declined. The cost of inventories may also not be recoverable if the estimated costs to be incurred to make the sales have increased. The amount written off to profit or loss is the difference between the carrying value and net realisable value of the inventories. In determining whether the inventories can be recoverable, significant judgement is required. In making this judgement, the Group evaluates, among other factors, the duration and extent by all means to which the amount will be recovered.

(e) Impairment of interest in an associate

Interest in an associate is reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. The recoverable amounts have been determined based on value-in-use calculations or fair value less costs to sell. These calculations require the use of judgements and estimates.

Management judgement is required in the area of asset impairment particularly in assessing: (i) whether an event has occurred that may indicate that the related asset values may not be recoverable; (ii) whether the carrying value of asset can be supported by its recoverable amount, being the higher of fair value less costs to sell and the net present value of future cash flows which are estimated based upon the continued use of the asset in the business: and (iii) the appropriate key assumptions to be applied in preparing cash flow projections including whether these cash flow projections are discounted using an appropriate rate. Changing the assumptions selected by management in assessing impairment, including the discount rates or the growth rate assumptions in the cash flow projections, could materially affect the net present value used in the impairment test and as a result affect the Group's reported financial condition and results of operations. If there is a significant adverse change in the projected performance and resulting future cash flow projections, it may be necessary to take an impairment charge to the consolidated statement of comprehensive income.

Interest income from bank deposits, interest on lease liabilities and corporate expenses are not allocated to each segments, as these types of activities are driven by the central treasury function, which manages the cash position of the Group.

- Mandatory Provident Fund Scheme (the "MPF Scheme") under the Hong Kong Mandatory Provident Fund Schemes Ordinance
- LSP under the Hong Kong Employment Ordinance.

The MPF Scheme is a defined contribution retirement plan administered by independent trustees. Under the MPF Scheme, the employer and its employees are each required to make contributions to the scheme at the lower of 5% of the employees' relevant income or HK\$1,500 each month.

The Group's net obligation in respect of LSP calculated by estimating the amount of future benefit that employees have earned in the current and prior periods and discounting that amount.

For LSP obligations, the estimated amount of future benefit is determined after deducting the negative service cost arising from the accrued benefits derived from the Group's MPF contributions that have been vested with employees, which are deemed to be contributions from the relevant employees. Net interest expense for the period is determined by applying the discount rate used to measure the defined benefit obligation at the beginning of the reporting period to the then net defined benefit liability, taking into account any changes in the net defined benefit liability during the period. Net interest expense and other expenses related to defined benefit plans are recognised in profit or loss in note 28.

收購事項概要

於二零一八年六月四日,本集團訂立買賣協議,向獨立人士收購4Square Return GmbH (「**4Square**」) 已發行股本之21%權益,現金代價為1,600,000歐元(相當於約14,508,000港元)。作為回報,本集團於收購日期有權獲得(i)4Square之21%股權,成本為6,569,000港元及(ii)一份認購期權及購回期權,公平值約為7,939,000港元。該項交易於二零一八年七月十九日完成。

認購期權致令本集團於行使期內按根據股東協議所載條款釐定之行使價收購4Square之所有餘下股份。行使期乃由4Square於德國截至二零二三年十二月三十一日止年度之經審核綜合財務報表發佈日期起直至其後六個月之營業日當日(「認購期權期間」)。倘本集團於認購期權期間屆滿前並未行使認購期權,則4Square其他現有股東可自認購期權期間屆滿三個月以內購回本集團所持4Square的所有股份,代價為1,600,000歐元。根據香港財務報告準則第9號,認購期權及購回期權視作透過損益按公平值列值之單一複合衍生金融工具。

The associate is principally engaged in compliance consulting, the provision of sales and marketing services, collecting and take back services, asset remarketing services, recycling, commodities aggregation and trading, certified waste electrical and electronic equipment disassembly, and metals separation and concentration, in particular, in the information technology, telecommunications and electronics industries.

Summary of acquisition

On 4 June 2018, the Group entered into a sale and purchase agreement to acquire 21% of the issued share capital of 4Square Return GmbH ("**4Square**") from independent parties by cash consideration of EUR1,600,000 (equivalent to approximately HK\$14,508,000). In return, the Group is entitled to (i) 21% of equity interest in 4Square at a cost of HK\$6,569,000 and (ii) a call option and buy-back option at fair value of approximately HK\$7,939,000 at the date of the acquisition. The transaction was completed on 19 July 2018.

The call option allows the Group to acquire all the remaining shares of 4Square in the exercise period at an exercise price determined in accordance with the terms set out in shareholders' agreement. The exercise period is from the date that the audited consolidated financial statements of 4Square for year ended 31 December 2023 are filed in Germany until the Business Day that falls six months thereafter ("Call Option Period"). If the Group does not exercise the call option before the expiry of Call Option Period, the other 4Square existing shareholders may buy-back all of the shares in the 4Square held by the Group within three months from the expiry of the Call Option Period for the consideration of EUR1,600,000. The call option and buy-back option were treated as a single component derivative financial instrument at fair value through profit and loss under HKFRS 9.

於截至二零二三年十二月三十一日止年度錄得 溢利約1,593,000港元(二零二二年:約292,000 港元)(即本集團應佔聯營公司業績)。

於二零二一年十一月八日,本集團訂立一份補充協議,以將認購期權期間延長至二零二三年十二月三十一日,而認購期權價格將按照扣除4Square的利息、稅項、折舊及攤銷前盈利之5倍減二零一九年、二零二零年、二零二一年及二零二二年經審核綜合財務報表所載4Square之純利總額計算。除上述外,股東協議之所有其他條款維持不變。

於二零二三年十二月三十一日,4Square之可收回金額由本公司董事根據公平值減處置成本的計算方法並參考旗艦資產評估顧問有限公司進行之專業估值而釐定。該計算使用以聯營公司管理層批准涵蓋五年期(二零二二年:五年期)的財務預算為基礎的現金流量預測。五年期(二零二二年:五年期)以上的現金流量使用穩定增長率2%(二零二二年:2.3%)推算,而該增長率乃根據相關行業增長率得出,且並無超出聯營公司經營所在業務的平均長期增長率。計算中採用的稅後貼現率為14.4%(二零二二年:15.50%)。

董事認為2023年,4Square開發新的回收業務,並成功與主要客戶重新制定業務條款,從而改善財務盈利能力,扭轉減值。於二零二三年十二月三十一日,根據上述評估,4Square之賬面值(扣除減值前)低於(二零二二年:高於)其可收回金額9,670,000港元(二零二二年:6,053,000港元)。因此,計入於一間聯營公司之權益之商譽減值虧損撥回約1,639,000港元(二零二二年:減值虧損約275,000港元)於損益內確認,最高金額不超過之前已確認金額。

The excess of the cost of investment over the Group's share of the net fair value of the identifiable assets and liabilities of 4Square at the date of acquisition was recognised as goodwill and included the interest in an associate.

A profit of approximately HK\$1,593,000 representing the Group's share of results of the associate was recorded for the year ended 31 December 2023 (2022: approximately HK\$292,000).

On 8 November 2021, the Group entered into a supplemental agreement to extend the Call Option Period to 31 December 2023 and the call option price will be based on 5 times the earnings before interest, taxes, depreciation and amortisation of the 4 Square minus the aggregate amount by which the net profit of the 4Square as set out in the 2019, 2020, 2021, 2022 audited consolidated financial statements. Save for the above, all other terms of the shareholders's agreement remain unchanged.

At 31 December 2023, the recoverable amount of 4Square was determined by the directors of the Company based on fair value less cost of disposal calculations with reference to a professional valuation performed by Flagship Appraisals and Consulting Limited. The calculation used cash flow projection based on the financial budget approved by management of associate covering a five-year period (2022: five-year period). The cash flows beyond the five-year period (2022: five-year period) are extrapolated using a steady growth rate of 2% (2022: 2.3%), which is based on the relevant industry growth rate and does not exceed the average long-term growth rate for the business in which the associates operate. The after-tax discount rate adopted in the calculation is 14.4% (2022: 15.50%).

In the opinion of the Directors, during 2023, 4Square has developed new recycling business and successfully re-modelled business terms with its major customers resulting improvement in financial profitability which led to a reversal of impairment. As at 31 December 2023, the carrying amount of 4Square, before impairment, is lower (2022: higher) than its recoverable amount of HK\$9,670,000 (2022: HK\$6,053,000) based on the above assessment. Accordingly, a reversal of impairment loss, up to the amount previously recognised, in interest in an associate of approximately HK\$1,639,000 (2022: impairment loss of approximately HK\$275,000) was recognised in profit or loss.

Share Option Scheme adopted on 11 November 2016 (the "2016 Option Scheme")

Pursuant to a resolution passed on 11 November 2016, the 2016 Option Scheme was adopted to recognise and motivate the contribution of the eligible participants and to provide incentives and help the Company in retaining its existing employees and recruiting additional employees for a term of ten years. The Board of the Company may at its discretion grant options to any employees, including Executive and Non-executive Directors, consultants, advisers, substantial shareholders, distributors, agents, contractors, suppliers, customers, business partners and service providers of the Group to subscribe for shares in the Company.

The total number of shares in respect of which options may be granted under the 2016 Option Scheme is not permitted to exceed 10% of the shares of the Company in issue at any point in time. The number of shares issued and to be issued in respect of which options granted and may be granted to any individual in any one year is not permitted to exceed 1% of the shares of the Company in issue at any point in time, without prior approval from the Company's shareholders. Options granted to substantial shareholders or independent non-executive directors in excess of 0.1% of the Company's share capital or with a value in excess of HK\$5,000,000 must be approved in advance by the Company's shareholders.

Option may be granted at a consideration of HK\$1 and should be accepted within seven days from the date of grant. Options may be exercised at any time during the period as the Board may determine which shall not exceed ten years from the date of grant. The subscription price is determined by the Board and shall not be less than the highest of (i) the closing price of the shares of the Company as stated in the Daily Quotation Sheet on the date of grant, which must be a trading day; (ii) the average closing price of the shares of the Company as stated in the Daily Quotation Sheets for the five trading days immediately preceding the date of grant; or (iii) the nominal value of the Company's share.

No share options were granted since the date of adoption of the 2016 Option Scheme.

- 僱員因裁員或嚴重不當行為以外的原因 被解僱

長期服務金福利乃參考僱員最後一個月的全月薪金(上限為22,500港元)及服務年資釐定。每名合資格僱員的長期服務金福利上限為390,000港元。本集團根據強制性公積金計劃就該僱員作出的強制性供款所產生的累算權益可用作抵銷長期服務金福利。

根據香港法例第485章《強制性公積金計劃條例》,本集團作為僱主,須按僱員月薪的5%(上限為1,500港元)作出強制性強積金供款。本集團向獨立的受託人作出供款。強積金計劃具有界定供款計劃屬性。

於二零二二年六月,《二零二二年僱傭及退休計劃法例(抵銷安排)(修訂)條例》已頒佈。修訂條例取消以僱主強制性強積金供款之累算權益抵銷長期服務金之安排。其後,香港特區政府已宣佈,取消安排將於二零二五年五月一日生效。

以下主要變動將自轉制日起生效:

- 一 僱主強制性強積金供款所產生的累算權益不可用作抵銷於轉制日後受僱期間之長期服務金。
- 轉制前之長期服務金以緊接轉制日前最後一個月的薪金計算,而並非以終止受僱 日期之最後一個月的薪金計算。

28 LONG SERVICES PAYMENT LIABILITIES

Under Employment Ordinance, Cap.57, an employee who has been employed under a continuous contract for not less than 5 years of service is eligible for long service payments under the following circumstances:

- The employee resigns at age of 65 or above;
- The employee dies during employment;
- The employee resigns on ground of ill health;
- The fixed term employment contract expires without being renewed:
- The employee is dismissed which is not because of redundancy or serious misconduct

The LSP benefit is determined with reference to the employee's last full month's salary (capped at HK\$22,500) and number of years of service. The LSP benefit is capped at HK\$390,000 for each eligible employee. The accrued benefits derived from the Group's mandatory contributions under the mandatory provident fund scheme in respect of that employee can be used to offset the LSP benefit.

Under the Mandatory Provident Fund Schemes Ordinance, Cap. 485, the Group, as an employer, is required to make mandatory MPF contribution at 5% of the employee's monthly salary (capped at HK\$1,500). The Group makes the contribution to separate trustees. MPF scheme has attributes of a defined contribution plan.

In June 2022, Employment and Retirement Schemes Legislation (Offsetting Arrangement) (Amendment) Ordinance 2022 was enacted. The Amendment Ordinance abolishes the use of the accrued benefits derived from employers' mandatory MPF contributions to offset LSP. Subsequently, the Government of HKSAR announced that the Abolition will take effect on 1 May 2025.

The following key changes will take effect since the Transition Date:

- Accrued benefits derived from employers' mandatory MPF contributions cannot be used to offset the LSP in respect of the employment period after the Transition Date.
- The pre-transition LSP is calculated using the last month's salary immediately preceding the Transition Date, instead of using the last month's salary of employment termination date.

The accounting for the Group's LSP obligation, MPF contribution and the MPF-LSP offsetting is detailed in notes 2.2(b), 2.13(e) and 2.13(f).
