Such growth is mainly attributable to the steady and continual growth in revenue of the Company from the trading of metal, the metal supply chain and the area of commodity trading core businesses of the Group in Hong Kong, the mainland People's Republic of China and internationally from approximately HK\$8.44 billion for the Corresponding Period to an estimated revenue in just half a year of over HK\$10.0 billion for the Period as well as the result of the Group's active cost control and optimization.

As the Company is still in the process of finalising the interim results of the Group for the Period (the "Interim Results"), the information contained in this announcement is only based on the preliminary assessment on the information currently available to the management of the Company which have not been audited or reviewed by the auditors or the audit committee of the Company, and therefore may be subject to adjustment.
