## BIOGRAPHICAL DETAILS OF DIRECTORS

Romain Bausch, aged 47, was appointed a Non-Executive Director and served as the Deputy Chairman of the Board of the Company between 15th January, 1999 to 31st December, 2000. He is currently Chairman of the Board. He is the Director General and the Chairman of the Management Committee of Société Européenne des Satellites S.A. ("SES"). He started his career in the Luxembourg civil service. After subsequent promotions, he became General Administrator of the Ministry of Finance. He occupied key positions in the banking and media sectors and spent a five-year term as a Director and Vice Chairman of SES. He graduated with a Master of Arts degree in Economics (specialisation in business administration) from the University of Nancy (France).

**Mi Zengxin**, aged 50, was appointed a Non-Executive Director of the Company on 28th February, 2001. He is an Executive Director and Vice President of China International Trust and Investment Corporation ("CITIC"). Prior to his appointment to the present position, he was the Chief Executive Officer of Citisteel Inc. in the United States from 1992 to 1997. He joined CITIC in 1985 and holds a Master of Science degree.

**Peter Jackson**, aged 52, has been the Chief Executive Officer of the Company since May 1996, having served in that position with Asia Satellite Telecommunications Company Limited ("ASTCL") (a subsidiary of the Company) since July 1993 prior to the listing of the Company. Prior to his appointment as the Chief Executive Officer in 1996, he was employed by Cable and Wireless plc where he held engineering, marketing and management positions and was responsible for several satellite telecommunications ventures.

**William Wade**, aged 44, has been the Deputy Chief Executive Officer of the Company since May 1996, having served in that position with ASTCL since April 1994 prior to the listing of the Company. He has over 16 years' experience in the satellite and cable television industry. He speaks Mandarin Chinese and holds a Bachelor of Arts (Honours) degree in Communications from the University of Utah and a Master of International Management degree from the American Graduate School of International Management (Thunderbird).

**Professor Edward Chen**, C.B.E., J.P., aged 56, has been an Independent Non-Executive Director of the Company since May 1996. He was educated at Hong Kong University (Bachelor of Arts, Master of Social Science) and Oxford University (Doctor of Philosophy), and is currently the President of Lingnan University in Hong Kong. He was a member of the Executive Council of Hong Kong, 1992-97 and Chairman of the Consumer Council, 1991-97. He is now Chairman of the Veterinary Surgeons Board and a Director of the First Pacific Company.

**Ding Yu Cheng**, aged 35, was appointed a Non-Executive Director of the Company on 15th January, 1999.
