本公司董事會謹向股東提呈董事會報告及本公 司及其附屬公司(「本集團」)截至二零零零年十 二月三十一日止年度經審核之財務報告。

#### 主要業務

本公司之主要業務為物業出租、土地和物業開 發、物業投資及管理、餐飲業、經營酒店及百 貨業。附屬公司之主要業務是在中國北京進行 物業發展及投資。

本集團截至二零零零年十二月三十一日止年 度,按香港普遍採納之會計準則編制之營業額 及經營溢利/(虧損)貢獻,根據主要業務及市 場分析,載於財務報表附註四。

#### 業績及利潤分配

本集團截至二零零零年十二月三十一日止年 度,按香港普遍採納之會計準則之業績及於該 日之財務狀況載於年報第五十六頁至第六 十頁。

#### 股息

董事會建議派發截至二零零零年十二月三十一 日止年度末期股息,每股人民幣2.5仙,合共 人民幣46,675,000元。 The Board of Directors is pleased to present to the shareholders their report together with the audited accounts of the Company and its subsidiaries (the "Group") for the year ended 31st December, 2000.

#### **Principal Activities**

The Company is principally engaged in property leasing, land and property development, property investment and management, provision of food and beverage services as well as the operation of a hotel and a department store. The subsidiaries are mainly engaged in property development and investment in Beijing, the PRC.

For the year ended 31st December, 2000, the Group's turnover and contribution to operating profit/(loss), by principal activities and markets prepared under accounting principles generally accepted in Hong Kong, are set out in note 4 to the accounts.

### **Results and Profit Distribution**

The results of the Group for the year ended 31st December, 2000, prepared under accounting principles generally accepted in Hong Kong and its financial position as at that date are set out on pages 56 to 60 of the annual report.

#### Dividend

The Board of Directors recommends the payment of a final dividend of Rmb2.5 cents per share for the year ended 31st December, 2000, totalling Rmb46,675,000.

#### 主要股東持股情況

### 發行H股募集所得資金運用情況

#### Substantial Shareholders' Shareholding

Note: Under the SDI Ordinance, Chow Tai Fook Enterprises Limited, New World Development Company Limited and Solar Leader Limited directly and indirectly own interests in North Light Ltd. and are deemed to be interested in the H shares in which North Light Ltd. is interested. North Light Ltd. is a wholly-owned subsidiary of Solar Leader Limited, which in turn is a wholly owned subsidiary of New World Development Company Limited. Chow Tai Fook Enterprises Limited owns more than 1/3 of the issued share capital of New World Development Company Limited.

Save as disclosed above, the Board of Directors is not aware of any other substantial shareholders required to be recorded in the register maintained under Section 16(1) of SDI Ordinance.

### **Use of Proceeds of H Share Issue**

The Company issued H shares in May 1997. The H shares commenced trading on The Stock Exchange of Hong Kong Limited on 14th May, 1997. The net proceeds of the issue (after deducting expenses) amounted to approximately Rmb1,730,440,000.

The net proceeds have been utilised in accordance with the section headed "Use of Proceeds" in the Company's prospectus dated 6th 一欄所述,截至二零零零年九月三十日止本集 團募股資金運用情況如下:

- (c) 用以減輕負債及作為營運資金使用,共 計金額為人民幣444,210,000元。

截至二零零零年九月三十日,本集團前次募集 資金已全部使用完畢。

#### 委托存款及逾期定期存款

截至二零零零年十二月三十一日,本集團並無 任何委托存款放於中國金融機構,本集團之所 有現金存款現均存放在中國之商業銀行,並符 合適用之法例及規則。本公司並未遇到銀行存 款到期而未能取回的情況。

## 僱員退休福利計劃

本集團之僱員退休福利計劃載於財務報表附 註八。 May, 1997. As at 30th September, 2000, the net proceeds were utilised as follows:

- a. Approximately Rmb231,370,000 were used to upgrade the Group's existing investment properties.
- b. Approximately Rmb1,054,860,000 were used in the development of the Group's existing development properties and in projects such as Green Garden, Hui Xin Apartment, Hui Xin Office and Olympic Village Reserve Area Lots C and D.
- c. Approximately Rmb444,210,000 were used to reduce the Group's borrowing and as working capital.

As at 30th September, 2000, all the net proceeds from the previous issue have been fully utilised.

#### **Designated Deposits and Due Fixed Deposits**

As at 31st December 2000, the Group had no designated deposits that were placed with financial institutions in the PRC. All of the Group's cash deposits are placed with commercial banks in the PRC and are in compliance with relevant laws and regulations. The Group has not experienced any incident of not being able to withdraw bank deposits when due.
