- (1) As at 31 December 2000, the Company had a total of 244,863 shareholders, of which 238,704 were A share shareholders and 6,159 were H share shareholders.
- (2) Shareholding of the Ten Largest Shareholders as at 31 December 2000:
- A: Magang (Group) Holding Company Limited, originally named as Maanshan Magang Holding Company (the "Holding"), held 4,081,480,000 A shares of the Company, representing an increase of 2,500,000 shares from the previous year, of which 4,034,560,000 shares A share were held on behalf of the State (representing approximately 62.5% of the total share capital of the Company) and also 46,920,000 were legal person A shares. The legal representative is Mr. Gu Jianguo.

Scope of operations: mining and sorting of mineral products; construction engineering design; construction; property development; integrated technology service; domestic trading; food and beverages; production services; mechanical and electrical equipment manufacturing; and metal products.

B: HKSCC Nominees Limited held 1,532,640,000 H shares, representing approximately 23.74% of the total share capital of the Company, and its shareholding in the Company has increased by 13,010,000 shares over last year.
