

EXECUTIVE DIRECTORS

Mr. LOK Fai, aged 48, is the Chairman and Managing Director of the Group and is responsible for the overall strategy and development of the Group. Mr. Lok is a pharmaceutical engineer and had been the honorary lecturer at the Shandong University in the PRC. He has been the Chairman and Managing Director of Guangdong Apollo (Group) Co. Ltd., ("Apollo"), the principal subsidiary of the Company, since its establishment in 1988. Prior to founding the Group, Mr. Lok accumulated over 17 years of experience in corporate development in a state-owned manufacturing enterprise.

Mr. TSEUNG Wai Lok, aged 52, is a Deputy General Manager of the Group mainly responsible for administration and business development. Mr. Tseung is a pharmaceutical engineer.
