# Mr. XU Tie Feng

Aged 46, is President of the Group. Mr. Xu was the former Chairman of Guangdong Kelon (Rongsheng) Group Company Limited , Party Secretary of Rongqi rural town and the Governor of Ronggui, "the rural town of the PRC with the strongest economy" after Rongqi was merged with Guizhou. Since 1984, Mr. Xu was responsible for supervising the economic development of Rongqi, during which he helped develop various reputable corporations and brands including Kelon, Rongsheng, Guan Hua Feed Industry, Guangdong Medi-world Otsuka Pharmaceutical and Song Ben Industrial. He was a major driving force behind the listing of Kelon's H shares on the Hong Kong Stock Exchange and A shares on the Shenzhen Stock Exchange in 1996 and 1999 respectively. He joined the Group in June 2000 as President.

### Mr. QU Yun Bo

Aged 38, a Master in Management Engineering, the Group's Vice President of Sales and Marketing. He was the founder of Pilot Marketing Company Limited. He has published over 100 titles on marketing and management, and is widely respected by marketing professionals in China. He has organized training for more than ten thousand PRC marketing personnel and was marketing consultant to over 30 well-known enterprises in the PRC, including domestic appliance corporations like Kelon, Midea, Little Swan, TCL and Panda. Mr. Qu joined the Group in March 2000 and is responsible for managing the Group's sales and marketing functions.

### **Ms Carol YU**

Aged 39, is the Group's Vice President and Company Secretary. Ms Yu was formerly a partner at Arthur Andersen & Co, Certified Public Accountants, one of the Big Five international audit firms. As the General Manager of a PRC joint-venture accounting firm established between Arthur Andersen and the Ministry of Finance, she stationed in Beijing and took charge of numerous audit engagements relating to H-share listings. In 1995, she joined Donaldson, Lufkin & Jenrette Securities Corporation ("DLJ"), one of the largest investment banks in the US, as their Executive Director in Asia, heading up DLJ's corporate finance practice in the PRC. Ms Yu joined Kelon in December 2000 and is responsible for the Group's overall financial management.

Aged 64, a senior economist, is a non-executive director of the Group. Mr. Li graduated from the Industrial Economics Faculty of Beijing People's University of China in 1962. He was the Director of the Quality Management Bureau under the State Economic and Trade Commission and the Deputy Director of the State Bureau of Technical Supervision. He is currently the Chairman of the China Association for Quality Inspection and the Vice-Chairman of the China Quality Management Association and China National Consumer's Association. He contributed tremendous amount of care and assistance to Kelon's technological upgrade and brand-building.
