Executive Directors

Mr. Hong Zhi Ming, aged 59, holds a university degree in chemical engineering and is a senior engineer. Mr. Hong is the Chairman of the Company and has served the Group since its establishment. He has 36 years' experience in crude oil refining, chemical engineering and business and management and administration. He is responsible for the Group's overall strategy, planning, development and management. Mr. Hong is currently the President of GPC, and the Deputy Chairman of the Guangdong Province Association of Entrepreneurs, and the Deputy Chairman of the Guangzhou City Science, Technology Association and the Member of Finance and Economic Committee of Guangdong People's Congress.

Mr. Dai Zhao Ming, aged 35, holds a master's degree in mathematics and is a senior economist. Mr. Dai has served the Group since the end of 1994. He has over ten years' experience in the trading of crude oil and petroleum products, corporate planning and administration and economic analysis.
