Executive Directors

Mr. Glenn Wai Cheung Chan, *Chairman and Managing Director Aged 67*

Mr. Chan worked for the Hong Kong Government for more than 10 years during which time he was responsible for food and hygiene technology in the then Urban Services Department. In 1972, he left the public sector and joined a catering group in Hong Kong. Approximately two years later, he co-founded the Group. Mr. Chan is also the Chairman of SHHL. He is the spouse of Mrs. Catherine King Chan, the father of Mr. Joseph Ka Lai Chan and Mr. Raymond Ka Shun Chan.

Mrs. Catherine King Chan *Aged 67*

Mrs. Chan is the co-founder of the Group and assists the Managing Director in the overall management and control of the Group. She is also a non-executive director of SHHL. Mrs. Chan is the spouse of Mr. Glenn Wai Cheung Chan, the mother of Mr. Joseph Ka Lai Chan and Mr. Raymond Ka Shun Chan.

Mr. Joseph Ka Lai Chan *Aged 35*

Mr. Chan graduated from the McGill University in Canada with a degree in chemical engineering. He joined the Group as deputy project manager in 1990 and was appointed a director in 1996. He is also a non-executive director of SHHL. Mr. Chan is responsible for the co-ordination of new shop opening and shop renovations for the restaurant operation.
