### **Executive Directors**

Mr Chang Chung Wa, Eddie, aged 39, is the chairman of the Company and a co-founder of the Group. He founded the Group in May 1991. He is responsible for the Group's overall strategic planning, management, business development, new product strategy and formulating the sales and marketing strategies of the Group. He has over 17 years' experience in and in-depth knowledge in various aspects of the PC industry.
