REPORT OF THE DIRECTORS

The directors have pleasure in submitting their annual report together with the audited accounts for the year ended 31st March, 2001.

PRINCIPAL ACTIVITIES

The principal activities of the Company are the manufacture and sale of garments and rental of properties. The principal activities and other particulars of the subsidiaries are set out on page 54.

The analysis of the principal activities and geographical locations of the operations of the Company and its subsidiaries during the financial year are set out in note 3 on the accounts.

ACCOUNTS

The profit of the Group for the year ended 31st March, 2001 and the state of the Company's and the Group's affairs as at that date are set out in the accounts on pages 17 to 55.

An interim dividend of HK3 cents (2000: HK2 cents) per share was paid on 16th January, 2001. The directors now recommend the payment of a final dividend of HK10 cents (2000: HK10 cents) per share in respect of the year ended 31st March, 2001.

FIXED ASSETS

Details of additions to and other movements of fixed assets during the year are set out in note 13 on the accounts.

INVESTMENT PROPERTIES

Particulars of the Group's investment properties are set out in note 13 on the accounts.

BANK LOANS AND OTHER BORROWINGS

Particulars of bank loans and other borrowings of the Group and the Company at 31st March, 2001 are set out in notes 24 and 25 on the accounts.

No interest was capitalised by the Group during the year (2000: HK\$Nil).

CHARITABLE DONATIONS

Donations made by the Group during the year amounted to HK\$79,000 (2000: HK\$405,000).

MAJOR CUSTOMERS AND SUPPLIERS

During the year, the Group's sales to the largest customer and to the five largest customers accounted for 19% and 39% of the Group's sales respectively. The aggregate amount of purchases attributable to the Group's five largest suppliers represented less than 30% of the Group's total purchases. None of the directors, their associates or any shareholder of the Company (which to the knowledge of the directors own more than 5% of the Company's issued share capital) had any interest (as defined in the Listing Rules) in the Group's five largest customers and suppliers.

DIRECTORS

The present directors of the Company are listed on page 2.

In accordance with provisions of Articles 95 and 104 of the Company's Articles of Association, Messrs Chan Wing Fui Peter, Chan Wing To, Chan Wing Sun Samuel and Takashi Inoue, retire by rotation and, being eligible, offer themselves for re-election.

DIRECTORS' SERVICE CONTRACTS

No director proposed for re-election at the forthcoming annual general meeting has an unexpired service contract which is not determinable by the Company or any of its subsidiaries within one year without payment of compensation, other than normal statutory obligations.

No contract of significance to which the Company or any of its subsidiaries was a party in which a director of the Company had a material interest, subsisted at the end of the year or at any time during the year.

ARRANGEMENT TO PURCHASE SHARES

Except as disclosed below, at no time during the year was the Company or any of its subsidiaries a party to any arrangement to enable the directors of the Company or any of their spouses or children under 18 years of age to acquire benefits by means of the acquisition of shares in or debentures of the Company or any other body corporate.

Pursuant to an ordinary resolution passed on 13th May, 1994, the directors authorised the grant of options at nominal consideration for an aggregate of 14,065,000 shares of HK\$0.50 each of the Company under the Company's share option scheme to certain directors and employees of the Company and its subsidiaries, at an exercise price of HK\$2 per share. The options are exercisable in the period from 1st October, 1994 to 31st December, 2001. During the year, no share options were exercised.

The above repurchased shares were cancelled and accordingly the issued share capital of the Company was reduced by the nominal value of these shares. An amount of HK\$354,000 representing the premium on the aforesaid repurchases was charged against retained profits. In addition, pursuant to section 49H of the Hong Kong Companies Ordinance, an amount equivalent to the par value of the shares cancelled of HK\$235,000 was transferred from the retained profits to the capital redemption reserve. The repurchases were made because the directors were of the opinion that the repurchases would enhance the earnings per share of the Company.

Same as disclosed above, at no time during the year was there any purchase, sale or redemption by the Company, or any of its subsidiaries, of the Company's shares.

RETIREMENT SCHEME

COMPLIANCE WITH THE CODE OF BEST PRACTICE

The Company has complied with the Code of Best Practice as set out by The Stock Exchange of Hong Kong Limited in Appendix 14 to the Listing Rules throughout the year, except that the non-executive directors of the Company were not appointed for a specific term but are subject to rotation in Annual General Meeting pursuant to Articles 95 and 104 of the Company's Articles of Association.

AUDIT COMMITTEE

To comply with the revised Code of Best Practice as set out in Appendix 14 of the Listing Rules of The Stock Exchange of Hong Kong Limited, the Company set up an audit committee (the "Committee") with written terms of reference, for the purpose of reviewing and providing supervision on the financial reporting process and internal control of the Group. The Committee comprises two independent non-executive directors.

AUDITORS

KPMG retire and, being eligible, offer themselves for re-appointment. A resolution for the re-appointment of KPMG as auditors of the Company is to be proposed at the forthcoming Annual General Meeting.
