# PRINCIPAL ACTIVITIES

The Company acts as an investment holding company. Its subsidiaries are principally engaged in the manufacture and sale of accessories for photographic, electrical and multimedia products and act as property holding companies.

## **RESULTS AND APPROPRIATIONS**

The directors recommend the payment of a final dividend of 2 cents per share to the shareholders of the Company whose names appear on the register of members on 23rd August, 2001.

In accordance with Clauses 86(2) and 87 of the Company's Bye-laws, Mr. Cheng Chun Kit and Mr. Richardson, David Alexander retire and Mr. Cheng Chun Kit, being eligible, offer himself for re-election in the forthcoming annual general meeting. Mr. Richardson, David Alexander shall not offer himself for re-election.

None of the directors proposed for re-election at the forthcoming annual general meeting has a service contract which is not determinable by the Group within one year without payment of compensation (other than statutory compensation).

The term of office of each non-executive director is the period up to his retirement by rotation in accordance with the Company's Bye-laws.

*Note:* These shares are held by Honeyard Corporation. The entire issued share capital of Honeyard Corporation is held by The Honeyard Trust, a discretionary trust of which the family members of Ms. Chan Oi Ling, Maria Olimpia are discretionary beneficiaries.



In addition to the above, each of Ms. Chan Oi Ling, Maria Olimpia and Mr. Lam Yu Ho, Daniel holds 500,000 non-voting deferred shares in Mascotte Investments Limited, a subsidiary of the Company. Honeyard Corporation holds one non-voting deferred share in Newland Kingdom Limited, a subsidiary of the Company.

### (ii) Share option scheme

The Company has a share option scheme (the "Scheme") to enable the directors of the Company to grant options to eligible employees, including executive directors, of the Company and its subsidiaries to subscribe for shares in the Company. Details of the Scheme are set out in note 24 to the financial statements.

The directors had personal interests in share options to subscribe for ordinary share of HK\$0.10 each in the share capital of the Company at an initial subscription price of HK\$0.241 per share, exercisable from 16th August, 1998 to 15th August, 2001 as follows:

## ARRANGEMENT TO PURCHASE SHARES OR DEBENTURES

Save as disclosed above, at no time during the year was the Company or any of its subsidiaries a party to any arrangements to enable the directors of the Company to acquire benefits by means of the acquisition of shares in, or debentures of, the Company or any other body corporate. In addition, none of the directors, or their spouses or children under the age of 18 had any right to subscribe for the securities of the Company or had exercised any such right during the year.

## MAJOR CUSTOMERS AND SUPPLIERS

For the year ended 31st March, 2001, the aggregate amount of turnover attributable to the Group's five largest customers accounted for approximately 28.4 per cent. of the Group's total turnover and the amount of turnover attributable to the Group's largest customer was approximately 13.8 per cent. of the Group's total turnover. The aggregate amount of purchases attributable to the Group's five largest suppliers accounted for approximately 42.2 per cent. of the Group's total purchases and the amount of purchases attributable to the Group's total purchases.

None of the directors, their associates or any shareholders (which to the knowledge of the directors owns more than 5 per cent. of the Company's issued share capital) has any interest in any of the Group's five largest customers or suppliers.
