


**MEMBERS OF THE GROUP'S STATUS IN THE APPROVED LISTS OF CONTRACTORS OR SUPPLIERS OF GOVERNMENT BODIES**
**本集團成員公司在政府機構「認可承造商或供應商名冊」之概況**

It is a statutory requirement in Hong Kong that contractors carrying out electrical installation, improvement or maintenance work must be registered as "registered electrical contractors" under the Electricity (Registration) Regulations. To be eligible to tender for electrical engineering works contracted out by, or for the supply of electrical equipment and materials to, the Government, the contractor or supplier must have been admitted to the approved lists of contractors for the relevant type of works or the relevant lists of suppliers for the relevant type of equipment or materials maintained by the relevant government body at the time of the making of the tender. As at the date of this Report, members of the Group have been admitted to the following lists:
