# **BOARD OF DIRECTORS**

#### **Executive Directors**

Mr. LEUNG Chung Ping, aged 36, joined the Group in February 1997 and was appointed the Chief Executive Officer of the Company last year. Mr. Leung holds a bachelor degree of Science and an MBA degree from the University of Southern California.
