Pursuant to the register of the shareholders as provided by the HKSCC Nominees Limited, the H Shares were held on behalf of various clients' accounts. There were three clients who were interested in more than 10% of the total issued H share capital of the Company. However, none of them was interested in more than 5% of the total issued share capital of the Company.

Tianjin Municipal Investment Company Limited ("TMICL") holds 839,020,000 shares in the Company, representing 63.08% of the Company's share capital and is the Company's largest shareholder ("Controlling Shareholder"). The legal representative of TMICL is Mr Sun Zenyin. TMICL's principal activities are the development, construction and management of city infrastructure projects and auxiliary services, development and operation of city infrastructure, import of technology and equipment for city construction works, promotion for capital investment and project development and construction management (in accordance with the State regulations for specific projects and operations) in city road infrastructure. During the period, TMICL had not pledged any of the Company's shares.
