## 執行董事

鄭小燕女士,現年四十九歲,任職本集團已達二十六年,負責本集團之市場推廣及企業策略發展事宜。彼在珠寶首飾設計、產品發展,生產及市場推廣本集團之出口業務方面累積三十年經驗。鄭女士為陳聖澤先生之妻子。

李佳先生,現年五十一歲,彼於一 九九四年加入本集團,負責財務及 企業發展事宜。李先生於加入本集 團前,曾在香港另一間珠寶首飾集 團工作十四年,擔任行政總裁一職。

### **EXECUTIVE DIRECTORS**

Mr. Chan Sing Chuk, Charles, JP, aged 56, is the Chairman and founder of the Group. Mr. Chan has over 41 years of working experience in the jewellery industry. He is responsible for the strategic planning, corporate development and investment for the Group. Mr. Chan is currently the Chairman of the Hong Kong Jewellery and Jade Manufacturers Association. He is also the Executive Committee Member of the Diamond Federation of Hong Kong, China. Mr. Chan has been a member of Jewellery Advisory Committee of the Hong Kong Trade Development Council since 1989. He is also a member of the China Trade Advisory Committee of the Hong Kong Trade Development Council since 1998. In the year of 2000, Mr. Chan was invited to be a Director of the Hong Kong Tuberculosis, Chest & Heart Diseases Association. And later he was also appointed as a member at the Hospital Governing Committee for Ruttonjee & Tang Shiu Kin Hospitals.

Madam Cheng Siu Yin, Shirley, aged 49, has been with the Group for 26 years and is responsible for marketing and corporate policy development of the Group. ## 高級管理人員

鄭乃仁先生,現年五十六歲,為本公司之全資附屬公司恒和珠寶首飾廠有限公司董事。鄭先生任職本集團已達二十六年,在珠寶首飾零售、出口銷售及寶石採購方面累積逾二十年經驗。彼持有寶石鑑證師學位。鄭先生現時負責本集團之寶石採購及在中國之商業事務。

於本財政年度內,本集團大部份管理及行政事務均由上述本公司及其附屬公司之執行董事提供,而僅身為本公司或其附屬公司董事之本集團僱員始視作高級管理人員之一份子。

Prior to joining the Group, Mr. Cheung has 29 years' experience in diamond cutting and polishing industry. He was appointed as an executive director of the Company on 1st June, 2001.

#### NON-EXECUTIVE DIRECTORS

Mr. Choy Jee Hong, Anthony, aged 60, is a professional accountant. Mr. Choy served the Group from 1990 to 1993. Mr. Choy became a non-executive director in 1993. He now works in Singapore as a management consultant.
