

## BIOGRAPHICAL DETAILS OF DIRECTORS

**Romain Bausch**, aged 48, is currently Chairman of the Board. He was appointed a Non-Executive Director and the Deputy Chairman of the Board of the Company between 15th January, 1999 to 31st December, 2000. He is the President and CEO of SES GLOBAL S.A. He started his career in the Luxembourg civil service. After subsequent promotions, he became General Administrator of the Ministry of Finance. He occupied key positions in the banking and media sectors and spent a five-year term as a Director and Vice Chairman of SES. He graduated with a Master of Arts degree in economics (specialisation in business administration) from University of Nancy (France).

**Mi Zengxin**, aged 51, was appointed a Non-Executive Director of the Company on 28th February, 2001. He is an Executive Director and Vice President of China International Trust and Investment Corporation (“CITIC”). Prior to his appointment to the present position, he was the Chief Executive Officer of Citisteel USA Inc. in the United States from 1992 to 1997. He joined CITIC in 1985 and holds a Master of Science degree.

**Peter Jackson**, aged 53, has been the Chief Executive Officer of the Company since May 1996, having served in that position with AsiaSat since July 1993 prior to the listing of the Company. He has over 23 years’ experience in the telecommunications field. Prior to his appointment as the Chief Executive Officer in 1996, he had been employed by Cable & Wireless plc where he held engineering, marketing and management positions and was responsible for several satellite telecommunications ventures.

**William Wade**, aged 45, has been the Deputy Chief Executive Officer of the Company since May 1996, having served in that position with AsiaSat since April 1994 prior to the listing of the Company. He has over 17 years’ experience in the satellite and cable television industry. He speaks Mandarin Chinese and holds a Bachelor of Arts (Honours) degree in Communications from the University of Utah and a Masters of International Management degree from Thunderbird (the American Graduate School of International Management).

**Robert Bednarek**, aged 44 was appointed a Non-Executive Director of the Company on 14th March, 2002. He is an Executive Vice-President Corporate Development and a member of the Executive Committee of SES GLOBAL S.A. Prior to joining SES GLOBAL, he was the Executive Vice-President and Chief Technology Officer of PanAmSat Corporation. He graduated with a Bachelor of Science degree in Electronic Engineering from the University of Florida.

**Professor Edward Chen**, C.B.E., J.P., aged 57, has been an Independent Non-Executive Director of the Company since May 1996. He was educated at Hong Kong University (Bachelor of Arts, Master of Social Science) and Oxford University (Doctor of Philosophy) and is currently the President of Lingnan University in Hong Kong. He was a member of the Executive Council of Hong Kong, 1992-97 and Chairman of the Consumer Council, 1991-97. He is now Chairman of the Press Council, a Director of the First Pacific Company (Hong Kong), and a Trustee of Eaton Vance Management Funds (Boston).

## BIOGRAPHICAL DETAILS OF DIRECTORS

**Ding Yu Cheng**, aged 36, was appointed a Non-Executive Director of the Company on 15th January, 1999. He is the Assistant President of CITIC Securities Company Limited which engages in securities and investment banking business. CITIC Securities Company Limited is a subsidiary of CITIC. He holds a Master of Business Administration degree from the University of Pittsburg.

**Robert Fullerton**, aged 70, has been an Independent Non-Executive Director of the Company since May 1996. He was the Chairman and Chief Executive Officer of Canadian Imperial Bank of Commerce until his retirement in 1992, and is now a director of its Board. He is also a director of a number of Canadian and multi-national companies and medical, cultural and educational entities.

**Ju Weimin**, aged 39, was appointed a Non-Executive Director of the Company on 12th October, 1998. He is the Chief Accountant of CITIC. He is also a Director of CITIC Ka Wah Bank Limited, a licensed bank in Hong Kong and a Director of Shortridge Limited which engages in investment, trading and joint ventures in China and Hong Kong. Shortridge Limited is a wholly-owned subsidiary of CITIC.

**Li Tong Zhou**, aged 62, has been a Non-Executive Director of the Company since May 1996. He is the Chief of the Planning Department of CITIC and the President of Macau Cement Manufacturing Company Limited.

**Jürgen Schulte**, aged 58, was appointed a Non-Executive Director of the Company on 15th January, 1999. He is the Chief Financial Officer of SES GLOBAL S.A. He joined SES in 1991 in that position having worked previously for General Electric (USA) in various financial management positions in both the United States and Europe. He graduated with a degree in Business Administration from the University of Münster (Germany).

**Vernon Smith**, aged 41, was appointed a Non-Executive Director of the Company on 15th June, 2000. He is the Vice President, Services Development, at SES GLOBAL. He joined SES in 1998 after founding Prism Media Consultants, LLC and development positions with DirecTV International. He graduated with a Master of Science degree in Aeronautics and Astronautics from the University of Washington and a Master of Business Administration degree from the Wharton School at the University of Pennsylvania.

**Robert Sze**, aged 61, has been an Independent Non-Executive Director of the Company since May 1996. He is a fellow of the Institute of Chartered Accountants in England and Wales and the Hong Kong Society of Accountants and was a partner in an international firm of accountants with which he practised for over 20 years. He is a non-executive director of a number of Hong Kong listed companies. He is also a member of the Shanghai Committee of the Chinese People's Political Consultative Conference.
