

## EXECUTIVE DIRECTOR

*Mr. FUNG Ka Pun (alias K. B. Fung)*, 56, appointed as the Chairman of the Company on 28 June 1995, is responsible for the Group's overall policy making. On 3 April 2001, Mr. Fung was made Executive Co-Chairman of the Company. Mr. Fung is also the Founder and Chairman of Goodwill International (Holdings) Limited, a substantial shareholder of the Company. He has over 26 years of experience in finance, broking, securities trading and corporate finance. *Mr. WONG Sin Just*, 36, appointed as the Chief Executive Officer of the Company on 20 April 2000, was made Executive Co-Chairman and Acting Chief Executive Officer of the Company on 3 April 2001. Mr. Wong possesses over 11 years of investment banking and finance experience and has held positions with a number of premier international investment banks. Prior to establishing e2-Capital Limited (subsequently renamed as OpenOffering Capital Limited), Mr. Wong was the Managing Director and the Head of Equity Capital Markets at BNP Prime Peregrine Securities Limited. Mr. Wong holds a Bachelor Degree in Engineering from Imperial College, University of London and is a member of the Association of Chartered Accountants, England and Wales.
