- (iii) Shareholders or their proxies shall produce their identity documents when attending the meeting.
- (iv) The register of shareholders of the Company will be closed from Friday, 17th May, 2002 to Tuesday, 18th June, 2002 (both dates inclusive), during which period no transfer of shares will be registered.

- (vii) The final dividend for the year ended 31st December, 2001 is expected to be paid on or before Friday, 28th June, 2002 to the shareholders whose names appear on the register of shareholders on Friday, 24th May, 2002.
- (viii) In order to qualify for the final dividend mentioned above, holders of H shares whose transfers have not been registered shall deposit the transfers together with the relevant share certificates, at Hong Kong Registrars Limited, the Company's H Share Registrars, not later than 4:00 p.m. on Thursday, 16th May, 2002.
