

## **EXECUTIVE DIRECTORS**

**Mr Qian Yong Wei**, aged 39, was appointed as an Executive Director of the Company on 15 September 1998 and is the Chairman and the Chief Executive Officer of the Company. Mr Qian graduated with a MBA in management from the China Europe International Business School, Shanghai, the People's Republic of China (the "PRC"). Since 1993, Mr Qian has been responsible for the investment and property management in the PRC for Shanghai Wan Tai Group Co., Ltd and its subsidiaries. Prior to 1992, Mr Qian had held positions in business management, planning and development. He is also the Chairman of Universal Union Limited and China Wan Tai Group Limited, holding companies of the Group.

**Mr Wei Wu**, aged 36, was appointed as an Executive Director of the Company on 25 February 2002. Mr. Wei is educated at the Graduate School of Zhejiang University, the PRC and studies a master degree in International Management in the USA. He was once the Vice President in Operations in Sichuan Commodity Exchange (四川商品交易所) and the Manager in the Commerce Department of Shenzhen Non-Ferrous Metals Future Exchange (深圳有色金屬期貨聯合交易所), the PRC. He is currently the Chairman of Pearl Oriental Holdings Limited.

**Mr He Hui Min**, aged 45, was appointed as an Executive Director of the Company on 1 March 2001. Mr He graduated from The Shanghai Institute of Tourism in 1982 and was then sent to Brisbane, Australia by the PRC Government to study hotel management. In 1993, he completed a business and management course in Maryland College, USA. Mr He had been general manager of various luxury hotels in the PRC for a considerable period of time. In 1998, Mr He was appointed as an assistant to the Chief Executive Officer of Wan Tai Group Limited and general manager of Shanghai Taigu Apartment Service & Management Co., Ltd. Currently, he is also a director of Universal Union Limited and China Wan Tai Group Limited, holding companies of the Group.

**Ms Xu Zhe Cheng**, aged 31, spouse of Mr Qian, was appointed as an Executive Director of the Company on 15 September 1998. Ms Xu graduated from the Shanghai Academy of Theatrical Studies in 1992 and has worked in management positions with Sino-foreign trading businesses in the PRC. Ms Xu has experience and expertise in marketing and sales of property projects in the PRC. She is a director of China Wan Tai Group Limited, holding company of the Group.

**Mr Ren Jun Tao**, aged 51, was appointed as an Executive Director of the Company on 21 November 2001. Mr Ren graduated from Shanghai Television University in 1985 and then received professional training in management and marketing in Shanghai Science and Technology University as well as Shanghai Industrial Management Training Center. In 1995, he was graded as a Senior Economist. Mr. Ren had been Chief Economist and director of factory in big and medium state-owned enterprises. He is now the President of Shanghai Wan Tai Group and the Managing Director of Shanghai Wan Tai (Group) Co., Ltd..
