### EXECUTIVE DIRECTORS

**Mr. Yung Yeung**, aged 45, was appointed director of the Company on 23rd November, 1998, and was elected by the board of directors of the Company as Chairman of the Group on 6th May, 1999. Mr. Yeung has been Chairman of the board of directors, President and Chief Executive Officer of Brilliance China Automotive Holdings Limited (“Brilliance”) since 1992 and is also Chairman of the board of directors of Shenyang JinBei Passenger Vehicle Manufacturing Company, Limited (“Shenyang Automotive”).
