EXECUTIVE DIRECTORS

Mr. LIANG Jiang, aged 49, was appointed the Chairman of the Company in January 2002. Mr. Liang graduated from South China Normal University and obtained a Master's degree in Business Management from Asia International Open University (Macau). He worked in the municipal government of Foshan and Zhan Jiang in Guangdong Province. He acted as the administrative head of Gao Ming County, secretary of Gao Ming County Party Committee and secretary of Gao Ming Municipal Party Committee of Guangdong Province. During the period from October 1997 to March 2000, he acted as the chairman of Guangdong Real Estate (Holdings) Limited. Prior to joining the Company, he acted as the chairman of Guangdong Assets Management Limited and the chairman of Guangdong Alliance Limited. He is currently a director of GDH Limited.

Mr. LI Li, aged 46, was appointed the Executive Vice Chairman of the Company in May 2000. Between 1986 and 1998, Mr. Li worked in Guangdong Foreign Economic Relations and Trade Committee. He was appointed a deputy director of the Economic and Trade Administration Office of the Committee in 1995. Since 1998, Mr. Li has acted as the general manager of Nam Yue Food Stuff & Aquatics Co., Limited and director and president of Macau Wholesale Market Nam Yue, Ltd. He is currently a director and general manager of both companies.

Mr. CHEN Lizhong, aged 47, was appointed an Executive Director and General Manager of the Company in December 2000. He is an accountant in the PRC and holds a Master's degree in Business Management. Mr. Chen joined Guangdong Dongshen Water Supply Bureau (the "Bureau") in 1975. He acted as the general manager of Shenzhen City Dongshen Industrial Development Holding Company between 1994 to 2000 and vice bureau head of the Bureau between 1996 to 2000. He is also a vice president of Shenzhen Economics Society.

Ms. WOO Ching Yee, aged 43, joined the Company as the Financial Controller in March 2001 and was appointed as an Executive Director of the Company in September 2001. Prior to joining the Company, Ms. Woo had held senior financial positions with a number of private and public-listed companies in Hong Kong. She possesses extensive financial management experience from her prior positions. Ms Woo is an Associate Member of the Hong Kong Society of Accountants and a Fellow of the Association of Chartered Certified Accountants. She also holds a Master's degree in Business Management.

NON-EXECUTIVE DIRECTORS

Mr. WU Wai Chung, Michael, aged 52, was appointed as a Non-executive Director of the Company in April 2001.
