Executive Directors

Mr. Li Peiying, 52, was appointed the chairman of the board of Directors in October 1999. He is a graduate of the Graduate School of the Institute of Social Sciences of China in finance and banking. Mr. Li has over 30 years of experience in civil aviation safety and airport management. From 1986 to 1989, he was the deputy head of the public security department of the Civil Aviation Beijing Administrative Bureau. From 1989 to October 1999, he was the head of the public security division and deputy general manager of Beijing Capital International Airport ("Parent Company"). He is currently the president of Parent Company.

Mr. Wang Zhanbin, 45, was appointed a Director and the general manager of the Company in October 1999. He is a senior engineer and has a MBA degree from Tsinghua University. During 1987 to 1995, he was the deputy head and then head of the China Airport Planning, Design and Research Institute of CAAC. Non-executive Directors

Mr. Fang Youxin, 57, was appointed a non-executive Director in October 1999. He is a senior economist, and is a graduate of the Guiyang Teachers Training College in Russian Language. Mr. Fang has over 30 years of experience in civil aviation transportation and airport management. From 1985 to 1988, he was the assistant director of Civil Aviation Beijing Administrative Bureau. From 1988 to 1993, he was a deputy general manager of Parent Company. From 1993 to November 1999, he was the general manager of Parent Company. Since November 1999, he has been the chairman of the board of Parent Company.

Mr. Alain Falque, 60, was appointed a non-executive Director in June 2000. Mr. Falque is the chairman of ADP Management, and is also the vice president of strategy and commercial policy at Aeroports de Paris. He was qualified as a solicitor of the Supreme Court of Hong Kong in 1975 and has since been qualified as a solicitor of the Supreme Court of England & Wales, a solicitor and a barrister of the Supreme Court of Victoria in Australia, a solicitor and an advocate of the Singapore Supreme Court, a notary Public and an authorized attesting officer of the PRC. He was appointed and served as a member of the Legislative Council of Hong Kong from 1991 to 1995, the chairman of the Committee for Protection of Wages on Insolvency in 1992, the chairman of the Hong Kong Institute of Directors in 1995 and a Justice of the Peace in 1996. He is currently holding more than twenty positions of social services. At present, apart from being a senior partner and practicing solicitor of P.C. Woo & Co., Mr. Cheng is also serving as an independent non-executive director of various companies listed on the Hong Kong Stock Exchange.
