## **Directors**

Details of the Directors are as follows:

**Mr Tang Kuan Chien,** aged 57, is responsible for the day to day management and operations of the Group. He joined the Group in August 1995 as President and has over 26 years of working experience in the plastics industry in Taiwan, Hong Kong and the PRC. He was appointed as Chairman on 18 December 1998.

**Mr Yiu Wing Ngok, Steve**, aged 55, who joined in 1992 as a director of the Group, is an experienced banker, having held various senior positions in banking and financial institutions for over 20 years.
