Executive Directors

Mr. Chiu Tao, aged 46, was appointed as an executive director of the Company on 18 November 1997 and was then appointed as a non-executive director of the Company on 9 February 2001. On 12 June 2002, he was redesignated as an executive director and the Chairman of the Company.
