The Group has a solid business partnership with Fuji Japan as the sole authorised distributor for Fuji products in Hong Kong and Macau since 1968, and in China since 1980

Through its Fujifilm Digital Imaging and Fujifilm Image Service outlets, the Group has established an extensive distribution network in China, Hong Kong and Macau, which includes importers and distributors in mainland China. In July 2001, the Group acquired Fotomax Holdings and extended its network from the wholesale to the retail level. Fotomax is a leading operator of retail chain stores that provide photographic processing services in Hong Kong.

In addition to photographic products, the Group distributes video and cassette tapes, medical imaging systems and information systems products. In May 2002, the Group was appointed as the authorized distributor of Fuji Graphic Arts Products in China, Hong Kong and Macau.

In China, the Group operates two joint venture companies in Beijing and Zhuhai, and two wholly-owned enterprises in Hainan and Sichuan. It also has representative offices in Guangzhou, Shanghai, Beijing and Chengdu. These provide the infrastructure to support the growth of the distribution network through training, coordination and marketing.

China-Hongkong Photo Products Holdings Limited was incorporated in Bermuda on 6 July 1994 and listed on the Stock Exchange of Hong Kong on 19 September 1994. The Group is held by the public (38.8%) and by its founder, the Sun family (61.2%) through Searich Group Limited, Fine Products Limited and Dago Corporation.

集團與日本富士保持穩固而持久的商業夥伴關係,自一九六八年以來一直為日本 富士在香港及澳門的唯一可經銷商,並自一九八〇年起一直為日本富士在中國的唯 一認可經銷商。現時,富士產品的銷售額佔集團主要營業額。

集團透過富士數碼激光沖印及富士影像服務計劃在中國、香港及澳門建立了廣泛的分銷網絡。集團的廣泛分銷網絡亦包括國內進口商和經銷商。二〇〇一年七月, 集團購入快圖美控股有限公司,將分銷網絡的業務擴展至零售層面。快圖美是目前 香港最具規模的影像服務連鎖店。

除分銷照相器材外,集團還兼售錄影帶、錄音帶、醫療影像系統和儲存媒體。 二〇〇二年五月,集團獲授予富士印刷制品在中國大陸、香港及澳門的分銷權。 在中國,集團經營在北京、珠海的兩間合營公司以及在海南和四川的兩間獨資 公司,並在廣州、上海、北京及成都設立代表辦事處。這些企業提供培訓、協調及 市場推廣服務,是支持集團在中國擴展分銷網絡的基石。

中港照相器材集團有限公司於一九九四年七月六日在百慕達註冊成立,並於同年 九月十九日在香港聯合交易所上市。集團百分之三十八點八股權由公眾持有,而其 餘百分之六十一點二則由創辦人孫氏家族透過 Searich Group Limited, Fine Products Limited 及 Dago Corporation 所擁有。
