- 於二零零零年八月,本公司與ASIMC0 第八投資公司("ASIMC0 VIII")簽定 股權轉讓合同,由本公司出資12,500,000 美元購買由ASIMC0 VIII持有北京三環亞 太啤酒有限公司("北京三環公司")的 54%股權。此股權轉讓已於二零零一年 三月獲有關政府部門批準。
- 於二零零零年八月,本公司與ASIMC0 第一投資公司("ASIMC0 I")及青島啤 酒香港貿易有限公司("青島香港公 司")簽定股權轉讓合同,由本公司與 青島香港公司分別出資6,010,000美元 及3,990,000美元購買由ASIMC0 I持 有北京亞洲雙合盛五星啤酒有限公司 的37.64%及25%股權。上述股權轉讓 已於二零零一年三月獲有關政府部門 批準。
- 於二零零一年六月,本公司與福建酒廠(新加坡)私人有限公司("福建酒廠")簽定股權轉讓合同,由本公司出資85,000,000元購買由福建酒廠持有51%股權的第一家(福建)啤酒有限公司,並改名爲青島啤酒(福州)有限公司。
- 於二零零一年十一月,本公司與香港 富利運投資有限公司("富利運")簽 定股權轉讓協議。根據該協議,本公司 以現金5,000,000元及轉移本公司賬 上約23,000,000元的其它應收賬款換 取隨州市啤酒廠之90%股權,並改名爲 青島啤酒(隨州)有限公司。

Comparing with the financial statements of the prior year, the scope of consolidation has increased as a result of the following acquisitions/ establishment of new subsidiaries:

- In August 2000, the Company reached an equity transfer agreement with ASIMCO The Eighth Investment Company ("ASIMCO VIII"). Pursuant to the agreement, the Company paid USD12,500,000 to acquire a 54% equity interest in Beijing Three Ring Asia Pacific Beer Company Limited ("Beijing Three Ring") owned by ASIMCO VIII. The equity transfer was approved by the relevant government authorities in March 2001.
- In August 2000, the Company reached an equity transfer agreement with ASIMCO The First Investment Company ("ASIMCO I") and Tsingtao Brewery (Hong Kong) Trading Company Limited ("HK Company"). Pursuant to the agreement, the Company and HK Company were to contribute USD6,010, 000 and USD3,990,000, respectively to acquire 37.64% and 25% equity interests in Beijing Asia Shuang He Sheng Five Star Beer Company Limited owned by ASIMCO I. The equity transfer was approved by the relevant government authorities in March 2001.
 - In June 2001, the Company entered into an equity transfer agreement with Fujian Brewery (Singapore) Private Company ("Fujian Brewery"). Pursuant to the agreement, the Company paid RMB85,000,000 to acquire a 51% equity interest in Di Yi Jia (Fujian) Brewery Company ("Fujian Company"). The name of Fujian Company was changed to Tsingtao Brewery (Fuzhou) Company Limited ("Fuzhou Company").
- In November 2001, the Company entered into an equity transfer agreement with Hong Kong Fu Li Yun Investment Company Limited("Fu Li Yun").
 Pursuant to the agreement, the Company paid a cash consideration of RMB5,000,000 and transferred the entitlement to certain "other receivable" balances of the Company at a net book value of RMB23,000,000 in exchange for a 90% equity interest in Suizhou Brewery Company Limited, the name of which was changed to Tsingtao Brewery (Suizhou) Company Limited.
