The Company will continue to own the remaining 29% equity interest in Beijing Three Ring. Further to the approval by the Ministry of Foreign Economic and Trade Committee in Beijing, the PRC, the legal status of Beijing Three Ring will be changed from a domestic limited liability company to a Sino-foreign equity joint venture and it will be entitled to the relevant preferential policies granted to enterprises with foreign investments. Before the end of 2001, EVG renegotiated with the Company for delaying the payment of the consideration of the transfer. Both parties then agreed that the rights and obligations of EVG's 25% equity ownership in Beijing Three Ring will be borne by the Company before the settlement. As a result, the Company continued to consolidate 54% of its equity interests in Beijing Three Ring in the 2001 financial statements.
