b. In the current year, there were changes in equity interests of the following subsidiaries:

(i)In March, June and July 2001, the Company entered into three agreements with three minority shareholders of Tsingtao Brewery Xian Co., Ltd., ("Xian Company"), namely Huazhong (Asia) Company Limited, Xian Hans Beverage Company Limited and Xian International Trust & Investment Company Limited, to acquire an additional 19.78% shareholding in Xian Company by cash considerations of RMB26,242,000, RMB11,840,000 and RMB16,945, 000(RMB 55,027,000 in aggregate) paid to the three minority shareholders, respectively. As a result ,the Company's ownership in that subsidiary increased to 76.1%.

(ii)In May 2001, the Company entered into an agreement with China Railway Construction Company Railway Transportation Division, a minority shareholder of Tsingtao Brewery (Chenzhou) Co, Ltd. Pursuant to the agreement, the Company injected additional capital of RMB56, 650,000 in cash to the subsidiary and capitalised the capital reserve of that subsidiary of RMB2, 624,100 as additional capital contribution. As a result, the Company's ownership in the subsidiary increased from 70% to 88.8% (see also (iv) below) and the share capital of the subsidiary increased from RMB10, 728,956 to RMB70, 003,056.

(iii)In July 2001, the Company entered into an equity transfer agreement with the minority shareholder of Tsingtao Brewery Weinan Company Limited ("Weinan Company") to acquire an additional 28% equity interest in Weinan Company at a cash consideration of RMB14,000,000.

(iv)In November 2001, the Company transferred its equity interests in the following subsidiaries to Tsingtao Huanan Holding Company Limited, a 95% owned subsidiary of the Company, at a consideration amounting to RMB257, 828,000, which is equal to the carrying amounts of these investments recorded in the books of the Company (according to PRC GAAP). (v)於二零零一年十一月,本公司與EVG 公司簽署股權轉讓議, 由EVG公司以支付 現金5,787,000美元爲代價受讓取得本公 司在北京三環公司中擁有的25%股權,本 公司在北京三環公司中繼續擁有29%股 權,經北京市對外經濟貿易委員會批準, 北京三環公司之件質經此轉讓后由内資 有限責任公司重新變更爲中外合資經營 企業、將享受國家對於外商投資企業的 相關優惠政策。其后,EVG公司向本公司 提出延緩支付股權轉讓價款的請求,雙 方協商同意在EVG 公司付清全部轉讓價 款之前、該股權由本公司受托經營管理 並行使相應的股東權利,因此,本公司依 然以54%股權合併方式並入北京三環二 零零一年度的財務報表。

(v)In November 2001, the Company entered into an equity transfer agreement with EVG Co., Ltd. ("EVG") pursuant to which EVG will pay a cash consideration of US\$5,787,000 to acquire 25% equity interest in Beijing Three Ring owned by the Company. The Company will continue to own the remaining 29% equity interest in Beijing Three Ring. Further to the approval by the Ministry of Foreign Economic and Trade Committee in Beijing, the PRC, the legal status of Beijing Three Ring will be changed from a domestic limited liability company to a Sino-foreign equity joint venture and it will be entitled to the relevant preferential policies granted to enterprises with foreign investments. Before the end of 2001, EVG renegotiated with the Company for delaying the payment of the consideration of the transfer. Both parties then agreed that the rights and obligations of EVG's 25% equity ownership in Beijing Three Ring will be borne by the Company before the settlement. As a result, the Company continued to consolidate 54% of its equity interests in Beijing Three Ring in the 2001 financial statements.
