

FIVE YEARS' FINANCIAL SUMMARY

A summary of the published results and of the assets, liabilities and minority interests of the Group, as prepared on the basis described in notes 1 and 2 below and extracted from the audited financial statements and reclassified as appropriate, is set out below. Certain amounts in the five year financial summary have been adjusted to take into account the effects of the revision in Hong Kong Statement of Standard Accounting Practice ("SSAP") 9 "Events after the balance sheet date" affecting dividends. The effect of this revised SSAP is that a prior year adjustment has been made to reclassify the proposed final dividend of HK\$8,400,000 for the year ended 31 May 2000, which was recognised as a current liability at that year end, to the proposed final dividend reserve account within the capital and reserves section of the balance sheet. The result of this has been to reduce both the Company's and the Group's current liabilities and increase the reserves previously reported as at 31 May 2000 by HK\$8,400,000.
